# IS DARK POLITICAL MONEY HELPING YES ON MEASURE HR?

dark money refers to spending to influence elections where the

On October 31, 2022, an unknown group called CITIZENS FOR BETTER GOVERNMENT, ID No. 1315443, filed a required campaign finance report with the City of Sierra Madre. The group distributed campaign literature in October, advocating a Yes on HR vote and is believed to be responsible for circulating a video advocating YES on HR on social media.

Filed in in late October, and the disclosures or lack therof were troubling. Initially, there was only a filing of the organizations' Independent Expenditures Report, and it contained normal campaign expenses such as video and media design and mailer and postage expense. There was only one donor, Sierra Madre Resident Gary Hood who on the first report donated \$8,000, not as an individual, but as an 'other'. (The contributor code choices are: Individual, Committee, Other, Political Party or Small Campaign Committee.). No other contributors were on the report.

The second report contributors included Hood who donated \$7,600 additional dollars again as an 'other' and two puzzling contributions from PAC+ with a San Francisco address. Their donations were \$5,000 and .01. (That is not a typo, the second contribution was a penny).

Upon further research, it was noted that CITI-ZENS FOR A BETTER GOVERN-MENT has an ID No. which points to an address in Norwalk.

> The PAC+ ID No. has addresses in Washington, D.C. and San Francisco. The groups are both listed as recipient committees with no clear ties to Sierra Madre.

> Mr. Hood spoke with the Mountain Views News and indicated that the \$15,600 was donated from his personal funds. He was not clear as to why the report listed him as 'Other' rather than 'Individual', nor was there a clear explanation of what the PAC+ connection was to Sierra Madre.

> The local YES on HR PAC is registered with the city and is officially known as PROTECT SIERRA MADRE – STOP THE HOUSING PROJECT. It is organized by local residents and the contributors listed are all local.

The same amount of disclosure is true for the group opposing the measure, "NO ON HR, SI-ERRA MADRE NEIGHBORS FOR FAIRNESS, A COALITION OF LOCAL RESIDENTS, TAX-PAYERS, AND MATER DOLO-ROSA PASSIONIST RETREAT CENTER; COMMITTEE MAJOR FUNDING FROM NEW URBAN WEST". That group fully disclos-

The origins of CFBG and their interest in Measure HR on the other hand is not clear other than the fact that as of the October filings, the only Sierra Madre connection is Hood and his \$15,600 contribution.

There has been no disclosure of where the \$5,000.01 dollars originated because upon review of PAC+ records there is nothing in their filings to date to indicate that money was actually given to CFBG or the source. PAC+ has contributions listed in a previous filing with money received from another Recipient Committee named Powerpac.org Voter Fund, a Sponsored Committee of Powerpac.org ID No. 1353459. There are no apparent Sierra Madre connections to

Both are categorized as recipient committees that receive contributions of \$2,000 or more per year for political purposes. This includes candidate controlled committees; committees primarily formed to support or oppose candidates or ballot measures; political party committees; and other general purpose committees (generally formed to support or oppose more than one candidate or ballot mea-sure). The lack of information regarding their contributions makes them dark.

however their positions opposing HR are obvious. The contributors are transparent and leaves no unanswered questions. The same can be said for the YES on HR Pac, whose contributors are entirely local residents.

What is the history, identity and purpose of Citizens For Better Government, who formed it and why is Yes on Measure HR important to them? Without any information on where the money comes from, the contributions are dark and of concern to many residents of Sierra Madre.

A deceitful claim and a far cry from, "whatever they want." In their written "One-Two Punch" misinformation paper, they claim that HR "Allows Mater Dolorosa to continue 'NON-CONDITIONAL USE PERMIT' which the city will undoubtedly grant." In the first place, there is no such thing as a "nonconditional use permit!" They do not exist and never have. potentially violates both the Fifth Amendment (Takings) and First Amendment (Freedom of Religion). While many will say "their lawyer claims otherwise," let's not lose sight of the fact that every courtroom proceeding has two lawyers that each claim the other lawyer is wrong. One can believe whichever lawyer they want to but in the end, Sierra Madre's taxpayers will be the big losers, being forced to pay their hard earned tax dollars in legal fees.

Sierra Madre has a history of excessive legal fees resulting from land use and property rights violations. Only a few years ago, Sierra Madre was sued by the owners of 1 Carter for \$30 million because of land use and property rights violations. The Sierra Madre taxpayers were forced to pay hundreds of thousands of dollars to défend a City Council decision only to later have the City Council réverse their own decision in order to drop the suit. Remember back several years ago Sierra Madre spent \$500,000 to defend a voter passed initiative in the landmark case Friends of Sierra Madre v. City of Sierra Madre. This case was also a land use and property rights violation. Sierra Madre just can't afford any more of these unnecessary and costly legal battles. We have serious infrastructure repairs that are needed.

For generations the Passionists have been wonderful neighbors to all of Sierra Madre and perfect stewards of their property. They have been generous providers for many Sierra Madreans, never asking for anything in return. For decades they have provided housing for various Sierra Madre residents that may have otherwise become homeless. Their outreach programs are too numerous to mention and they never have brought attention to their generosity. They have been victims of vile, hateful, and shameful comments by HR supporters only because they need to sell a portion of their property in order to maintain their mission and purpose.

Let's not let the selfishness of a few residents force Sierra Madre into a downward spiral of unnecessary wasteful litigation. Ask yourself, "If the yes-on HR group finds it necessary to intentionally spread false information, lie, deceive the public, and harass vulnerable senior citizens and many others, is this a group worthy of your trust and your vote?





# Supervisors Extend \$50K Reward in Murdered **Altadena Preschooler**

The Los Angeles County Board of Supervisors unanimously approved a motion Tuesday by Supervisor Kathryn Barger to extend the \$50,000 reward offered for information leading to the arrest of the person responsible for the murder of four-year-old Salvador Esparza

The young boy was shot while standing on the porch of a home in unincorporated Altadena on July 5, 2016.

"This shooting violently and tragically ended the life of an innocent little boy," said Supervisor Kathryn Barger. "Six months ago, I doubled the reward amount offered from \$25,000 to \$50,000. I am extending the reward because I have faith that someone will have the courage to do the right thing. Help us identify the perpetrator who robbed Salvador of his future and left a hole in his family's heart. Justice for the Esparza family must be served."

Pasadena Mayor Victor M. Gordo urged the community to do their part, "Chavita Esparza would be 10 years old today had he not been murdered in July of 2016," Mayor Gordo said. "I am grateful to Supervisor Barger



Here is an excerpt from a column that I did years ago, "Do you ever go to a place and have such a wonderful experience, that it reminds you of a great date that you can't get out of your mind? # EXPOSING THE CALIFORNIA DEPARTMENT OF FISH AND WILDLIFE'S COLOSSAL FAILURE

As we all have come to know, Sierra Madre's residential areas, elementary schools, and the downtown area have become California's hotspot for bear activity and the most dangerous city in California for bear attacks, suffering more bear attacks on humans in the last few years than any other city in California. Daily bear encounters in Sierra Madre are, according to the California Department of Fish and Wildlife (CDFW), now considered "routine." of time, Sierra Madreans were directed to contact the Pasadena Humane Society (PHS) to report all bear encounters and that PHS would forward the report to the CDFW. Consider for a moment, according to a search of California Department of Fish and Game records, during the 20 year period between 1975 and 1995, the entire State of California reported 7 bear attacks. That's 7 attacks in a 20 year period over an area of 164,000 square miles. Now contrast that with the last 6 years in Sierra Madre's 3 square miles that has suffered 4 bear attacks and bear encounters greater than the CDFW's ability or willingness to control them. Additionally, according to reports by both CBS Sacramento and CNN, in 2021, California experienced two home break-ins. While one might question the accuracy of these reports, Sierra Madre Canyon often sees more than that in a single day so either both CNN and CBS are not doing their homework or someone is not giving accurate data to the public.

So what exactly has happened in the last 10 years that has resulted in the dangerous increase in the urbanized bear population that now plagues Sierra Madre and the nearby Foothill communities? In a nutshell, it is a result of gross negligence by the California Department of Fish and Wildlife, The California Fish and Game Commission, the California State Legislature, and a two decade practice of failed and negligent wildlife management practices without adequate oversight.

In order to gain a better understanding, one needs to take a close look at the Department's management practices, changes in wildlife management philosophies, neglected goals, changes that were contrary to the Department's and Commission's established goals, and the results of 24 years of the their mismanagement.

In 1998, the California Department of Fish and Game identified and reported a steady increase in the black bear population and therefore published their "Black Bear Management Plan." In 2000, two years later, the Department reviewed and updated their bear policies. For the next 22 years, however, as the Department recognized a steady increase in the bear population, the Department neglected and failed to review and update their policies to address and provide solutions to manage and control the increased overpopulation of black bears in their natural habitat beyond what these habitats could provide. They also failed to implement the necessary actions to control and prohibit the urbanization of bear populations resulting from the overpopulation of the natural wild habitat. Additionally, in the absence of adequate oversight, the Department failed to implement controls and practices that prevented the overpopulation and "exponential" growth of urbanized bears in residential neighborhoods.

It's important to note that the Department is subject and bound by the laws that are established by state legislatures. Regulations are established by the Fish and Game Commission and regulations may not supersede the laws established by state legislations. The CDFW is mandated to operate within the regulations established by the Commission. The management of bear populations, when operating correctly and in adherence to each entity's laws, missions, goals, and objectives is a bureaucratic partnership and one that cities throughout California relied on.

During the 22 years between 2000 and 2022, according to a Department Bulletin dated, February 16, 2022, the Department failed to review and update its various bear policies. It also appears that in 2013, the Department (as well as the Commission) underwent a fundamental shift in practices and philosophies. In 2013, the Department of Fish and Game changed its name to the Department of Fish and Wildlife, implying that their focus was shifting away from hunting and the stigma that might imply. It was also at that time when Sierra Madre started to experience a noticeable increase in urbanized bears, an increase that CDFW now refers to as an "exponential increase." Along with the increase and overpopulation of urbanized bears in Sierra Madre came four bear attacks on humans in Sierra Madre. An amount that exceeds anything experienced elsewhere in the entire state of California.

That same year, 2013, the Commission also prohibited using hounds for bear hunting. Since that policy took effect, the annual hunting harvests have declined significantly, further facilitating the overpopulation of bears in their natural habitats and in urban neighborhoods. Since that time, the CDFW, on numerous occasions, has also stated that the Angeles National Forest was no longer able to support the overpopulation of bears in their natural habit that resulted as a result of their policies. This overpopulation forced bears into the urbanized neighborhoods where we now have several generations of urbanized bears that sadly, according to the CDFW, are unable to survive in their natural habitats. According to the CDFW, these bears rely solely on human food sources and are not candidates for relocation, regardless of the potential threats they pose.

At one point, in order to address the overpopulations of both wild and urbanized bears and to address public safety concerns, the Department and Commission decided to increase the total number of bears that could be taken in an annual bear-hunting season. According to CDFW biologist, Rebecca Barboza, this increase created a public outcry by the anti-hunting crowd. Reacting to the outcry, the Department and Commission decided to place a higher priority on the public outcry over public safety and reversed their decision. This decision has helped facilitate the exponential increases in the urbanized bear populations, bear encounters, and the threats that are associated with urbanized bears. With the increased bear populations, increased property damage, increased home entries and attacks, a reasonable person would assume that public safety would be a top priority by the Legislature, the Department, and the Commission. Apparently not. For a period

of time, Sierra Madreans were directed to contact the Pasadena Humane Society (PHS) to report all bear encounters and that PHS would forward the report to the CDFW. However in 2021, it was discovered by the Sierra Madre City Council that the PHS failed to contact the CDFW, putting Sierra Madre residents in increased danger. One might find it interesting that at that very same time, the Humane Society of the U.S. (HSUS) was involved in passing a legislative bill in California to outlaw all bear hunting in California. The HSUS, (who also funds local Humane Societies,) petitioned the Commission to ban hunting as well as supported a proposed bill, SB 252, that was submitted by California Senator Scott Wiener. After it was exposed that SB 252 contained an abundance of false statements, false data, and numerous misrepresentations, Wiener withdrew the bill.

For Sierra Madre, bear encounters and sightings are a common and potentially dangerous reality. For the most part, nothing is being done to protect the residents, especially school children. Early this week, a sow and two cubs were filmed on Sierra Madre Blvd. and then heading north on Baldwin past 3 elementary schools. This happened at the same time school children were arriving to attend class. Sierra Madre schools have not been informed on the increased dangers and have not been informed on who to call in the event of a bear encounter on campus. The Department has failed to inform our schools of the increased dangers.

Even as recent as last week, a Sierra Madre Canyon resident reported to the CDFW that a young bear was observed in a state of extreme stress and needed attention. The CDFW representative informed the resident that the CDFW had run out of tranquilizers and would not be able to respond for an additional 3 days. Considering the fact that the very same CDFW representative was contacted a week earlier notifying her that a bear was seen on St. Rita's elementary campus during regular school hours, I find it unconscionable that this level of gross negligence and reckless endangerment could even be possible. Another resident reported that last week she was chased by a bear on south Canon, just a few houses south of the middle-school. Fortunately, she said that a man in a truck pulled up, opened the door, and told her to get inside. And, signs have recently been placed at the entrances to the Sierra Madre Canyon that alert residents and guests that they are "entering wild animal territory" and that they are not to "hike, bike, or jog alone." How on earth was this allowed to happen in our residential neighborhoods?

The Department of Fish and Wildlife have made it clear that they have no intention of reducing the bear overpopulation, regardless of the increasing threats in residential neighborhoods and schools. At best, all they can offer are power-point presentations that advise reducing food sources. They also advise all pet owners to keep their pets indoors, and to lock all doors and window in your home. They only advise changes in human behaviors and take no responsibility for their negligence in performing their duties to control bear populations. Their own policies state that the Department shall, "alleviate economic losses or public health and safety problems caused by wildlife." In reality, Sierra Madre's safety has been ignored by the Department. We have exceeded and gone far beyond what bear-proof trash containers and power-point presentations can solve. Our schools are regularly put in danger by bears. Homes are regularly broken into by bears and bears are becoming noticeably more aggressive.

Unfortunately, there has been no adequate oversight of these agencies. Their rogue practices that ignore their own policies have put our neighborhoods and homes in danger. This past month, the Canyon has seen an unprecedented number of home break-ins by bears. The Department takes no responsibility for their gross negligence. They place all blame on residential neighborhoods and common human practices, like keeping food in your refrigerator. In her power-point presentation, Barboza claims that the "heart of the problem is food sources and attractants" when in reality the heart of the problem is 22 years of the Department's gross negligence regarding their own policies and a failure and refusal to control bear populations in natural habitats and urban neighborhoods.

The Commission is equally to blame. The Commission's own mission statement requires them to assure that California's wildlife will be "managed with public confidence." What could be more cruel than to do nothing to prevent bears from becoming urbanized and unable to survive in natural habitats, relying solely on human food sources? What could be more reckless than allowing urbanized bears to walk freely in residential neighborhoods, including school grounds during school hours? Considering the eminent danger that Sierra Madre and neigh-boring Foothill cities face, one would think at least there would have been some discussion or action taken at the Commission's regular meetings. Nothing was placed on their agendas in the entire years of 2021 and 2022. They gave more attention to butterflies and kangaroo rats than the safety of school children that are subjected to bears at school. All things considered, how could any reasonable person have any confidence in the Commission?ß

Bears are majestic wild beasts that should never have been subjected and reduced to urbanization. They deserve better treatment than what the Department and the Commission have given them. It is nothing short of textbook animal cruelty what they have created and continue to facilitate. It's time for residents, Councilmembers, and City Staff to put relentless pressure on state legislatures and demand that they immediately pass bills that forces the Department and the Commission to bring safety back to our communities, end this pattern of animal cruelty, and keep bears in the natural habitats that they deserve, not on city streets digging in trash containers.





Learning from the Heart of a Horse

A WHISPER SPEAKS LOUDER

When I was about 12 years old, I remember begging my parents to let me have a horse. I'd been fortunate enough to have had lots of pets and small farm animals throughout my childhood, and I enjoyed spending time at the local barn with my friend's horses, but my lifetime dream was to have a horse of my own. My father had left his job in the aerospace industry years before, to pursue his dedication as a Christian missionary, so we were living on what they called a "shoe-string" budget at that time.

When I think back on those days, growing up as the baby of seven children, it amazes me that I never realized how poor we were. It never mattered because my parents always ensured that we had everything we needed, and most importantly we were wealthy in love. My mother sewed our clothes, my father did the yard work and home improvement projects himself, and we kids were expected to perform chores to earn our weekly allowances. As far as my memory serves me, we never experienced a lack of affection or compassion in our home, so I guess we just assumed we were as "rich" as any of our friends were. In retrospect, I realize what a wonderful childhood I had.

When I was 13, my father finally gave in and bought me a pony. Unbeknownst to me, he'd been watching the classified ads in the local newspaper, hoping to find one we could afford, and finally came across a Welsh pony for sale at a nearby farm. The owner wanted \$75 for "Coco", and even at that rock-bottom price, I know my dad was going out of his way to accommodate my desire to be a horse-owner.

Coco came with nothing more than a halter and a lead rope, so I learned very quickly to ride bareback and handle him without the force of a bit and bridle. My sister, Vicki and I had such fun doubling up on Coco and trotting around the rural parts of our area, riding on the local mountain trails and playing in the back woodlands surrounding our town. Those are some of the best memories I have from my youth and I would trade them for nothing.

When I realized how much responsibility went into owning a pony, it was a rude awakening for me. Every day after school, I had to go out and find Coco in the field, rope him and bring him back to the barn, groom him, clean out his stall, feed him, and let him rest a while before I could finally enjoy the fun of taking him out for a ride. Coco was a bit of a curmudgeon, so it was a challenge and a physical work out for me to perform the daily ritual with him at the barn.

I later learned that Welsh ponies are known to be head-strong compared to other equines. They require a lot of patience and loving discipline to help keep them in line. According to my memory, I suppose I did okay working with Coco, considering he was my first pony and I had little previous experience with horsemanship and all that went into it. I bonded with Coco immediately when I brought him home, which made it easier for me to be patient and understanding when he tried to buck or throw me.

Little by little the two of us had an understanding of what to expect and how to respect each other. Caring for Coco and learning about his way of thinking was such an important part of my life as a youngster. My folks used a good balance of encouragement and discipline in raising us kids, and I was lucky enough to have had an excellent school education, but there is nothing like working with a horse to teach a human how to live gracefully.

All these memories flooded back to me one day, after watching a documentary titled "BUCK", a bio-pic focused on the life of a gentleman named Buck Brannaman, who inspired the story behind the film, "Horse Whisperer". I remember seeing the film, when it first came out and being very impressed and emotionally affected by the story, but until I watched the 'Buck' documentary, I had no idea that "Horse Whisperer" had been based on a real life character named Buck Brannaman.

Horse Whisperer was about a man who had a unique ability to communicate with horses, and he used it to train and handle horses in a humane manner. Ultimately, the character in the film succeeds in bringing new life to not only his equine subjects, but also to the humans involved. It was such a heart-warming story for me because it validated what I always believed to be true about my relationships with the precious animals in my life. I came to realize that if we humans would be willing to take the time to understand the minds and hearts of our fellow species, we would be far more apt to succeed in living our own lives with grace and dignity.

### HOW DOGS MAKE US LAUGH

My 23-month-old Labrador, Thurber, makes me laugh out loud at least five times every day.

As I write this column — attempt to sit at my desk and write, that is — my silly puppy keeps dropping his ball at my feet, hoping to get me to play with him.

Which makes me laugh out loud.

My Mornings Start with Dog-Induced Laughter

I knew getting a dog would change my daily routine, but I had no idea how much he would improve my life and make me feel so cheerful.

In fact, it wasn't until he arrived 21 months ago that I realized that several days would pass in my life in which I did not laugh a whit.

A lack of laughter is bad for us, our families, our friends and our entire civilization, if you ask me.

And, I dare say, as a civilization, we are taking ourselves way too seriously right now at the expense of cheerfulness and laughter.

As we laugh less, we become more anxious, agitated and angry and our civility towards our fellow citizens suffers.

Which is why I wish everyone could experience the joy of having a dog.

Every morning, after Thurber eats breakfast and does his business, I lay back down to read the news on my phone and to ease into the morning.

And Thurber jumps up on the bed with a ball or bone in his jaws, tail wagging with mischief in his eyes, as he dares me to try to take it from him — which causes me to laugh out loud.

Dog-Induced Laughter Promotes Civility and Empathy

Thurber's antics make me laugh so hard and so often, I can only imagine how much public civility would be improved if everyone in our country could experience the daily joy he brings me.

Civility is "the foundational virtue of citizenship," developmental psychologist Marilyn Price-Mitchell wrote a decade ago in Psychology Today.

It's behavior "that recognizes the humanity of others, allowing us to live peacefully together in neighborhoods and communities."

She explained that the psychological elements of civility include awareness, respect, self-control and empathy — the very characteristics a professional dog trainer is currently helping me develop in Thurber.

Empathy — the ability to understand and share the feelings of another — is certainly a skill we Americans are losing in our increasingly isolated, angry, social-media-driven world.

But pets like my best buddy Thurber can help bring us together and help us restore our argumentative nation to a civil, well-functioning republic.

Child development specialist Denise Daniels explains in The Washington Post that "emotional intelligence," or EQ, is a measure of empathy.

She points to the findings of the Yale Center for Emotional Intelligence, which researches EQ and teaches people how to improve it, and notes that a high EQ score is the best indicator of a child's success — as well as an adult's.

Which brings us back to the value of pets.

Daniels writes that a variety of research in the U.S. and U.K. has shown a correlation between attachment to a pet and higher empathy scores.

I know my buddy, Thurber, has certainly improved my empathy and EQ score.

How to Promote a More Cheerful World

I didn't realize that my emotions for my puppy would run so deep, or that I would work so hard and do so many things to give him the happiest, healthiest life he can experience.

Plus, everywhere we go — and he loves few things more than jumping into the backseat of my truck — he makes total strangers smile, laugh and converse with me.

His simple presence can bring human strangers together. He not only makes us forget the petty human world — for a little while, at least — but he reminds us that a simple but magnificent creature like him can turn the most hardened souls back into empathic, laughing, happy children.

As I work hard to train Thurber to be a great dog who exhibits compassion, self-discipline, courtesy and empathy, he is training me right back to improve all of those very same skills.

I can no longer imagine what my world would be like without my lovable Labrador enriching it for me — and everyone else who meets him every day.

As I said, I wish all of my fellow citizens could become more cheerful by inviting a furry family member into their homes.

It wouldn't solve all of the world's problems, but we'd certainly be more cheerful and civil as we work to solve them!

#### DAILY MONEY MANAGERS CAN HELP SENIORS WITH FINANCIAL CHORES

Dear Savvy Senior:

Can you recommend any services that can help my elderly mother with her financial chores? My dad always used to handle the bill paying and paperwork, but he passed away last year, and mom struggles to keep on top of things. And I don't live close enough to help her on a regular basis. Concerned Daughter

Dear Concerned:

It sounds like your mom could use a good daily money manager (or DMM). These are financial savvy professionals that can help older adults who have difficulty managing their own day to day

The types of services they provide typically includes paying bills, maintaining financial records, balancing checkbooks and negotiating with creditors. DMMs can also prepare checks for clients to sign, help older people organize bank and financial records, prepare and deliver bank deposits, gather and organize documents for tax returns, help decipher medical bills, and review bank statements in order to detect potential financial abuse or fraud.

Where to Find DMMs

Depending on where your mom lives, DMM services may be available through private nonprofit elder assistance organizations or government agencies. These agencies often use volunteers to provide basic DMM tasks, such as bill paying at no cost. To find out if this is available in your mom's area contact her Area Aging Agency. Visit ElderCare.acl.gov or call 800-677-1116 for contact information.

In addition to the non-profit DMMs, an increasing number of individuals and private for-profit companies have started offering DMM services for a fee. Cost for these services varies by region but it often ranges between \$25 and \$100 per hour. Most clients need approximately four hours of services per month, but this too varies according to the complexity of the person's financial situation.

The best place to look for a professional DMM in your mom's area is through the American Association of Daily Money Managers (AADMM.com), which offers an online directory that lets you search by ZIP code. All the pros listed there have signed the group's code of ethics. Some have passed a certification exam to earn the designation of Certified Daily Money Manager.

Before hiring a daily money manager, however, get references from two or more of their clients and check them. Also, find out what they charge and what type of insurance coverage they have. Keep in mind that neither federal nor state governments regulate the DMM industry, so there is little oversight of these services. So before turning over your mom's bills, make certain it's someone you can trust.

One other highly rated bill-paying service you should know about that's specifically designed for older adults and caregivers is SilverBills (SilverBills.com). Available nationwide, this is a secure concierge bill management service that will manage your mom's bills and pay them on her behalf, on-time and correctly, for a flat fee of \$50 per month.

If you opt for this service, your mom will be paired with an account manager who will communicate and work with her over the phone, or through email, text or mail (her preference) – no computer is required. SilverBills also reviews all bills for errors and fraud and provides monthly statements showing the date, amount and manner of each payment.







#### PRE-ELECTION STRESS DISORDER

I'm already anxious about the outcome.

I speak of next week's elections, and a modern malady the Mayo Clinic refers to as "Election Stress Disorder."

'We notice it in our bodies, the tension in our shoulders," says Dr. Robert Bright, a Mayo Clinic psy-

chiatrist. "Sometimes people get GI (gastrointestinal) upset or headaches. People have trouble sleeping.'

Bright says the scary negative political ads aren't helping our stress levels.

"He is the candidate who voted in favor of puppy mills and sugar rationing and making chocolate chip cookies illegal!" such ads may as well say.

Every time there's an election, we're told that it's the most important in our lifetime — that if candidate XYZ wins, the sky will collapse, Earth will become a giant sinkhole, the Sun will stop shining....

If we let the hyperbole get to us, it's no wonder it induces such a powerful stress response.

The origin of stress goes back to the early days of humans, when many creatures didn't view us as their superiors, but as their lunch.

When a human saw a lion coming his way, he was overcome by stress. The stress brought on an adrenaline rush, and the adrenaline sent one message, loudly and clearly: RUN!

"Fight or flight" stress was an essential natural response to threats and it kept many humans from becoming another creature's dinner

But long after a human's stress mechanism was much less needed for his survival, we continued to suffer from it in ways it was never intended to do.

We suffer stress when we see the high cost of the gasoline we must put in our cars — so we can drive to the grocery store where we are stressed by the price of food that has risen faster than you can say reckless government spending.

And now that, like it or not, politics has seeped into every moment of our waking lives, elections have become way more stressful than they once were.

No matter what happens next week, half the country will have a temporary moment of joy, if their candidate wins, and the other half will suffer — you guessed it — more stress.

Half the country will be certain this midterm election will have been the most fair and transparent in history, and the other half will be certain fraud caused their candidate to lose.

Whether happy or mad, though, one thing is for certain: many won't be able to resist the urge to go on social media and argue about politics with friends, family and neighbors, which will cause even more stress.

And rather than cool down over political matters that are largely out of our control, we'll get angrier and more vindictive and that will be the energy we carry into our holiday gatherings, where harsh and bitter words will be said that may harm relationships forever.

So what can we do to nip election stress in the bud, Dr. Bright?

We can relax, he says, and realize that all that we can control is our own vote and that it is no better or worse or more important than anybody else's.


"And that's the wonderful thing about living in a democracy," he says. "We each have an equal stake."

Besides, there's another very important reason not to stress over our elections: The real stress doesn't generally kick in until we realize we elected a bunch of buffoons.











The latest tally of money spent has come out by the most ironic of all named groups, the "Neighbors for Fairness". This group is made up of Sierra Madre citizens, funded by the developer New Urban West, to the tune of nearly \$200,000 and counting. We will only know the total amount after next week's election. The

\$200,000 has been doled out to at least 10 different companies, including a law firm, numerous public affairs teams, designers, consultants, printers, delivery people, all located throughout California and New York. Their goal is to twist the stories, create fake grassroots movements and plant their signs on the very thing we are trying to stop. They bring piles of money and considerable experience to bludgeon another small town into submission; in this case it's our Sierra Madre. Tragically, it works and they get better at it every year. We are sitting ducks. If Sierra Madre citizens would simply look at the campaign Form 460, they would see for themselves that we are being duped. We urge you to simply go to the campaign form 460 filed by the Neighbors for Fairness and look at the amounts spent and the places the money is going... Go to their websites and read about the people being paid to change your mind. It is a treasure trove of evil intentions and expert manipulation. But wait, it gets worse. The Neighbors for Fairness are posting ads with endorsed statements from the local city council. On the one hand they claim that we need to do what they say and vote No on Measure HR because otherwise the city will be sued. On the other hand, the city council is literally supporting the Neighbors for Fairness in hiring lawyers and PR firms whose known tactics include suing cities and busting referendums when their attempts at manipulating weak city council members falls short.

Let's look at just a few examples from this Form 460 of who you will find and what they say in their own websites.

Through last week, the developers have spent \$28,942 with the law firm of Nielsen Merskamer known for their referendum busting tactics in the town of Moraga. They were able to overturn the will of the people through a paperwork technicality. Way to go. The Neighbors for Fairness have hired this attorney whose specialty is "guiding clients through the complexities of the initiative and referendum process." Thanks to the city council for endorsing the very group that will go after us if the developer does not get its way.
 How about the four separate public affairs teams they have hired. Each one has its own

• How about the four separate public affairs teams they have hired. Each one has its own tactics on how to turn you. First, we have Southwest Strategies; on the take for \$23,118 - "We know what makes California's communities tick. We engage with residents and businesses to build stakeholder support for outreach, advocacy and education programs." If you look up one of their key employees (search Chris Wahl, San Diego Tribune) you will find him in the middle of controversy where he is alleged to have been lobbying and raising money for city officials at the same time he was engaging in mediation talks. They weren't lying when they said they know what makes communities tick.

• The Musella Group, cashing in \$8,000, states that "Developing a robust strategy to educate elected officials and policymakers is the foundation to successful advocacy. We know how to have a positive impact on the process to achieve your business objectives."

• Laer Pearce & Associates has only made \$4,375 but it should be worth the money because "When your issue comes down to a vote of the people or an action by a regulatory board, or you simply need perceptions changed and outcomes influenced, we have unique and finely tuned skills that can help achieve your strategic objectives".

and finely tuned skills that can help achieve your strategic objectives".

• Atlantis Group, at \$12,000 says "We foster communication and gain active support for your project or policy from stakeholders, and from elected and appointed officials."

They have also sent \$5,250 to a lady in Brooklyn to take the Yes on Measure HR and reshuffle graphics to confuse the citizens as to whether yes is no or no is yes. There is also \$20,000 spent on lawn signs and \$5,750 to a door hanger company.

Please look all this up yourself and don't let these developers and their hired goons do this to Sierra Madre.

#### CITIZENS FOR TRUTH – OUR FREEDOM IS IN DANGER, EVEN IN SIERRA MADRE

Anyone who has watched the news on TV or picked up a newspaper has seen the armed men clad in body armor (always men) who have no authority waiting at ballot drop boxes, with the promise that they will be at polling places as well. Yet, in the state of Georgia, a law was recently enacted to make it a crime to offer a bottle of water to someone waiting in line to cast their ballot. We've written about why this would be beneficial and would result in nine large houses each on one two-acre plot of land. Also reported in past articles – similar to Measure V, the developer has tried

and confuse people by inferring "No means no development, yes means McMansions." In reality a no vote would be a yes vote for the development of 42 houses, on 17 acres, outside the scope of our General Plan and zoning laws. Seventeen acres, because developer New Urban West is inexplicably throwing in a three-acre park, right next to Bailey Canyon. However, one speculation is that this would make it cheaper to build the houses, rather than give each house a little extra lot size.

Last weekend a resident who was canvassing for Yes on HR in town on a busy street, when she noticed a car very slowly going by. She was talking to a resident, when a presumably paid canvasser came up behind her to hand the resident a door hanger with No on it, stating that our member was lying, and not to listen to her.

We believe our residents and our voters have the right to know about the intimidation tactics that are being used right in our little Sierra Madre. Yes, it can happen here, and it is. What price freedom as we know it? Please don't let your vote be purchased, \$22 per vote if we get 100% voter turnout, more likely \$44 per vote with a usual 50% turnout.

### A TRADITION OF GREAT & LIVABLE CITIES, PART 2

Over fifteen years ago, in this paper, I sent in a letter titled "A Tradition of Great & Livable Cities". At the time we were at a crossroads. Developers were seeking to monetize our quaintness, pouring money into a jaundiced campaign to sway us. Here we are again.

A key argument in support of Meadows is the city thinks it is best, so butt out. In opposition to the citizen led effort to save our town the development crowd make outrageous yet vague legal threats, shout about property rights, talk about magically creating water, of destroying a park to build a park. In fact, citizens not only have a right to speak out about how they are governed, but they have an obligation. Who are the people who have fought to save our city? They are doctors, lawyers, CPAs, finance professionals, artists, teachers, firemen, police officers, retired military who all care about this town. Here are a just a few reasons why:

• The Meadows project will be up to 7 times denser that what is allowed under Measure HR, with 5-foot property line setbacks. Look at the google maps street view of the developer's other projects.

• Property rights are not relevant. The Meadows property was not zoned for residential and if it was, it exceeds our codes. Property owners have a right to apply for special exceptions, but not to get them.

• There are no legal grounds to sue the city. It doesn't mean these "caring" developers won't sue if they don't get their way, but we have an obligation not to roll over in the face of every lawsuit rumor.

• Another rumor by the pro-development crowd is that One Carter cost the city millions in legal costs. This is not true in amount or causality. Look at the budgets. In the general budgets, legal expenses are so inconsequential as to not warrant its own line item or mention. If you analyze the One Carter debacle, among the problems was speculative money dumped into a preservation minded city during a housing bubble, approvals by an inexperienced city who cut deals and made exceptions. It was bulldozed and left as a desert for 15+ years. One Carter is in fact a poster child for not approving the Meadows project.

The city will be further challenged by a budget deficit with the Meadows project. Ask yourself why the city has not provided analysis of the long-term financial implications from the project. An analysis of the 450+ California cities shows that higher density is associated with lower housing prices. Obviously. Nobody has grown their way to balanced budgets. The lure of increased development is a sure path to making matters worse.

Most importantly, the Meadows project will be the densest development in our city's history, a 42+ tract home development with minimal superficial exterior nuances, permanently scarring our town and hillside. Please vote YES on Measure

#### THE GENERAL PLAN - THE PLAIN TRUTH

These are the "BUZZ" words that you have heard from the Stop the Project group since the beginning. They have been telling you that the Monastery is not adhering to the General Plan. Most people don't really know what the General Plan is but it sounds official.

This is a LIE like so many other things that the voters of our city have been told. The following is taken from our city's general plan, "The General Plan is intended to be both a long-term and a dynamic document, and must be periodically updated to respond to changing community needs. Unlike the housing element, which is required by State law to be updated every five years, a General Plan does not expire and is not required to have a specific time frame." There are seven mandatory elements of a general plan – land use, housing, circulation, open space, conservation, noise, and safety. (The Plan helps guide the city in these elements)

There are provisions in the General Plan that allow property owners (which the Monastery is) to apply for variances to those building/zoning codes. SECTION 1. GENERAL PLAN AMENDMENT Pursuant to Code Section 17.64.050, the Planning Commission may recommend approval of a general plan amendment and zone change whenever the public interest, convenience and necessity so require. The Monastery has complied with and received approval for a Specific Plan, therefore complying with our General Plan. The proponents of Measure HR have used these scare tactics and misinformation knowing full well that the Monastery is in compliance with the General Plan guidelines.

The Specific Plan affects only those 17 acres where the Meadows project is to be built. The remainder of the property will remain institutional as it is presently. The Monastery can continue the use of their property and not be stripped of their property rights. Under Measure HR, the Monastery is being stripped of their property rights because they have a group of self-serving residents surrounding their property who want to prevent them from developing the bottom 17 acres of their property. This is private property and the Monastery has the same property rights as any other property owner in our city.

Sierra Madre has at least three other Specific Plans that are welcome additions to our city: Senior Living Facility on Esperanza Kensington

He's "devastated" at being "targeted", while any other property owner would be similarly "targeted" if insisting on such change in use from original zoning that would bring irreversible harm.

We're urged to oppose HR because "Community Leaders... Mayor & City Council" tell us to. Unfortunately for them, this recommendation comes when many have diminished confidence in their leadership – feeling that if they'd done their jobs, we wouldn't have to be enduring this conflict in the first place.

have to be enduring this conflict in the first place. Measure HR calls for development to comply with our Hillside zoning restrictions – which are comprehensive and clear. They reflect considerable expertise (and expense) in their development, and support from our City Council in becoming part of our Municipal Code some sixteen years ago. In addition to house and lot sizes, they address fire protection, excavation, drainage, natural terrain, wildlife and habitat, flood and drought, seismic issues, sightlines, visual impact the "identity, image and environmental quality of the site".

Was the developer ever asked to proceed under these restrictions? Was there ever an attempt at compromise within the framework of Hillside zoning protections? Was any option considered other than the developer's demand for their own "specific plan"? What protections were sacrificed in the process?

Alarmed by the acquiescence at City Hall, residents themselves got Measure HR on the ballot to protect Sierra Madre. Then our Council decided not to wait until votes were cast November 8, but to go ahead and approve the project, anyway.

Now residents are again coming together on a referendum to put the Council's approval on hold, ensuring that those of us who live here and cherish Sierra Madre will ultimately have our voices heard.

It didn't have to be this way. And maybe with fresh faces on the City Council and renewed dedication to the interests of constituents and our community, rather than those of outside developers, it won't have to be this way again.

# HALLOWEEN, J. EDGAR HOOVER and THE 2024 ELECTION

My granddaughter is now three and really it has been a great many decades since I walked along trick or treating and certainly I never was in costume.
