Man who **Attacked Planned Parenthood Pleads Guilty**



An Inland Empire man, who admitted firing BB guns at the Planned Parenthood facility in Pasadena nearly a dozen times, agreed Wednesday to plead guilty to violating the federal Freedom of Access to Clinic Entrances (FACE) Act. According to the Department of Justice, Richard Royden Chamberlin, 54, a former Altadena resident, also admitted that he was carrying a loaded .22-caliber handgun during one of the attacks and agreed to plead guilty to being a felon in possession of a firearm and ammunition, according to a plea agreement filed today in United States District Court.

Chamberlin acknowledged driving past the Planned Parenthood facility in Pasadena and fired his BB gun at the clinic on at least 11 occasions between June 2020 and May 2021. In his plea agreement.

Beginning on June 27, 2020, Chamberlin's attacks involved him firing BB pellets through the window of his car. The attacks caused physical damage to the clinic, including shattered windows, and also served to intimidate the staff of the clinic, Chamberlin admitted in the plea agreement.

On March 29, 2021, an employee of the clinic heard an object hit her office window. The next day at 8:30 a.m. while the clinic was open and receiving patients, Chamberlin again drove by and fired his BB gun at the front entrance. No one was injured in any of the shootings.

On May 7, 2021, the Pasadena Police Department stopped Chamberlin while he was driving away from the clinic following yet another BB gun attack. At this time, Chamberlin possessed eight BB guns, including BB guns designed to look like assault rifles. On the front passenger seat of his vehicle, police found a backpack containing a .22-caliber pistol, which was loaded with 10 rounds of ammunition.

During a subsequent search of his home, authorities recovered thousands of rounds of ammunition, gun powder, a dozen additional BB guns, a black cylinder resembling a suppressor, a Polymer 80 gun-making kit, various gun parts and multiple documents identifying and referring to Planned Parenthood.

Chamberlin agreed to plead guilty to one count of being a felon in possession of a firearm and ammunition, a felony offense that carries statutory maximum penalty of 10 years in federal prison, and one count of forcible interference with the obtaining and provision of reproductive health services, a misdemeanor offense punishable by up to one year in prison. A date for Chamberlin to appear in court to formally enter the guilty pleas has not yet been

Talk: Music of Ancient Mesoamerica

Composer and educator Christopher Garcia will lead a free presentation about the indigenous instruments and music of pre-Columbian civilizations and perform on some of the instruments Wednesday, Dec. 7, at 2 p.m. at the Pasadena Senior Center. The historic region of ancient Mesoamerica – the modern-day region from southern Mexico to northern Costa Rica – was populated by Aztec, Olmec, Zapotec, Maya and Toltec civilizations.

The best-known instruments were flutes, whistles and ocarinas, all made of clay, and drums, some made of wood, and others of clay. Voices were important components of the ritualistic music. Much of the music and instruments were played at ceremonial events. Some instruments are still heard today in the indigenous music of various regions and cultures with roots in Mesoamerican.

Oregon and Penn State coach Hugo Bezdek, recently retired Rose Bowl Stadium CEO Darryl Dunn, 1977 Rose Bowl Game MVP Vince Evans and 1987 All-American Lorenzo White will be inducted into the Rose Bowl Hall of Fame as the Class of 2022.

This year's Rose Bowl Hall of Fame Induction Ceremony will be a private event held in Pasadena the week of the game. The inductees will also be honored in the Rose Parade presented by Honda and on the field during the 109th Rose

Bowl Game on January 2, 2023. This year's game will be a traditional Rose Bowl Game, with a team from the Big Ten meeting a team from the Pac-12, but will not be played on New Year's Day due to the Tournament of Roses' "Never on a Sunday" rule. The game will be the 17th Rose Bowl Game played on Monday, January 2.

The Rose Bowl Hall of Fame was established in 1989 to pay tribute to members of the Rose Bowl Game who have contributed to the history and excitement of the game, and those who embody the highest level of passion, strength, tradition, and honor associated with The Granddaddy of Them

the Rose Bowl Game. Bezdek led the Oregon Webfoots to a 14-0 victory over Pennsylvania in the 1917 game, marking the first win for a West Coast team in The Granddaddy of Them All. He was then selected to coach the Mare Island Marines in the 1918 Rose Bowl Game, which featured two military teams due to World War I. Finally, Bezdek brought Penn Major League Baseball team. He was inducted into the Football Hall of Fame in 2019. College Football Hall of Fame in 1954. Bezdek died in 1952 at

Darryl Dunn spent 27 years working at the Rose Bowl Stadium, including the last 23 as the stadium's CEO. Under Dunn's leadership, America's Stadium hosted countless concerts, international soccer matches, UCLA home

the age of 68.

The Tournament of Roses football games, the Rose announced recently that former Bowl Game, College Football Championships and CFP Semifinals. Dunn oversaw several stadium renovations, including the locker rooms and the Terry Donahue Pavilion. He helped establish the Rose Bowl Legacy Foundation, which has raised millions of dollars to fund additional stadium upgrades. After leading the Rose Bowl Stadium through the pandemic, Dunn retired in

July of 2022.
Vince Evans was a two-year starter at quarterback for USC and led the Trojans to the Pac-8 title in 1976, which earned a spot in the 1977 Rose Bowl Game against Michigan. USC won the game, 14-6, as Evans completed 14-of-20 passes in the game and scored the game-winning touchdown on a fourth-and-goal rush from the one-yard line. For his efforts, he was named MVP of the game. The Trojans would finish the season with an 11-1 record and ranked No. 2 in the final polls. Evans was selected by the Chicago Bears in the sixth round of the 1977 NFL Draft. He would go on to 16year professional career that spanned three decades in the NFL and USFL. Since retiring from football, Evans has led a successful career in real estate in Southern California.

White ran for 113 yards and two scores in the win. LAWSUITS CHALLENGING ARCADIA CITY COUNCIL APPOINTMENT AND COUNCIL DISTRICT MAP RESOLVED

ARCADIA, CA - Two lawsuits challenging the appointment of an Arcadia City Councilmember and the adopted City Council District Map were resolved yesterday. The Settlement Agreement between the City and the petitioners ends a sixmonth legal battle that challenged the validity of Councilmember Michael Danielson's appointment in March 2022 and the City Council Redistricting Map, adopted in April 2022.

Judge Mary Strobel of the Los Angeles County Superior Court found on October 4, 2022, that the appointment of Councilmember Danielson was lawful, and a judgment was entered in favor of the City. Pursuant to the Settlement Agreement, the Plaintiffs in this lawsuit will not appeal the judgement in the City's favor. In return, the City has agreed not to pursue recovery of its court costs.

The petitioners challenging the City, the HQH Chinese American Equalization Association and Arcadia Voters' Rights Group, first sued the City of Arcadia and the City Council in May 2022. The litigation sought to invalidate the appointment of Councilmember Danielson, and therefore, overturn the City's District Map approved during his appointment. Pursuant to the same Settlement Agreement, this litigation was dismissed by order of the Court prior to a hearing.

In response to the satisfactory resolution of these lawsuits, Mayor Tom Beck said, "We are pleased to have successfully resolved these two legal matters, and the City's recent litigation concerning Councilmember term limits, in our favor. We are now focused on welcoming the newly elected City Councilmembers on December 6, 2022, and the historic representation they bring to the Council."

THE PASADENA COMMUNITY POLICE ACADEMY IS WAITING FOR YOU!

I graduated from the Fall Session of the Pasadena Community Police Academy on November 2nd, 2022. It is a bi-annual, 8 week program that gives you an "up close and personal" view of every unit within the Pasadena Police Department. You might ask, "Why would anyone want to sign up for that?!". Let me tell you why you need to get on their wait list for their Spring 2023 Academy.

I was surprised to meet so many officers in every dept/unit that were so dedicated, brave and passionate about what they do. They all want to keep you, your families, your businesses and your property safe. They work tirelessly together and sometimes alone to cover every possible thing that can go wrong in this city. You would be surprised to hear just how many things do go wrong in a day in Pasadena, some more dangerous than others.

These officers are away from their families for long hours, risking their own safety, working on shifts that are unpredictable from day to day.

I did a four plus hour ride along with one of the officers. Before we left, I thought I was going to throw up. The first place we went was to the scene of a murder that had taken place the night before. I heard about it in the shift briefing before my "ride along" and was glad that the officers already had discovered surveillance footage. It would only be a matter of time before the killer was behind bars. By the time I did my ride along, I had already heard from the Homicide Unit Officers during class and I knew how efficient they were at using every possible resource, including your tips, to apprehend killers. Their success rate is over 90% due to their dedication and unrelenting efforts to comb through information to get to the truth and locate their perpetrators.

On my ride along, we went to one call after another, each one completely different from the call before. My officer was always calm and cool and assessed each situation quickly. He responded with admirable de-escalation techniques. I knew this was no small feat as one of our Academy classes was dedicated to role playing. The entire role playing evening, my classmates, including myself, hand cuffed and shot up innocent "ac-

tors" as we all got overwhelmed with scenarios that played out quickly, often dangerously with out of control emotions causing people to behave in unpredictable ways. After that evening, my respect for officers skyrocketed. Their ability to read a situation quickly, determine who is who, respond with the correct amount of force at the right time while keeping their own emotions in check is nothing short of amazing. This does not come natural. The level of training these officers go through (in a variety of areas) would surprise you.

Another class was at the shooting range, where not only did we get to shoot a variety of guns, but we got to act out electronic scenarios with electronic guns (think life size video games) on a big screen. Me and my classmate "partner" got shot so many times that we were glad we still had our real jobs. Our inability to assess potential dangerous situations quickly and accurately cost us. Then we started shooting innocent "electronic" people trying to

keep from getting ourselves killed because we started over compensating in our attempts to not get killed. Our anxiety got the best of us.

I'd love to go into all of the interesting details that every department shared with my class, but this article would never end. Some of my favorites, The Air Ops Unit with their infrared lights, camaras and three minute response time, made me proud.

The Special Investigation unit is working bravely, tirelessly to get drugs off the streets and away from our kids. Fentenyl is pernicious and now comes in candy colored tablets that they work hard to irradicate. I was proud to hear of their brave successes.

The Defensive Tactics unit has focusd on Jujitsu training for 15+ years. It means the "Gentle Art"

in Japanese. This style of martial arts enables officers to apprehend suspects with minimal injury to the suspect while improving the time it takes to get the suspect under control.

The Fraud/Stolen Identity unit never ceased to fascinate me. Perpertrators purchase machines off of Amazon inexpensively that enable them to recreate credit cards. The success rate with which perpertrators convince Pasadena Citizens to relinquish thousands of dollars to expunge non existant warrant(s). To this I say "Don't sent money/crypto currency to anyone without checking with the police first."

Records, Admin Services, Communications, Special Victims Unit, Forensics, Neighborhood Services, Burglary, Dispatch, PAL, Traffic (Motorbikes), Hope, Jail, Crime Stoppers, Event Planning/Security, Counter Terrorism and the K9

Units all deserve a big shout out as well. Each unit has a lot to share about their progressive policies, dedicated officers and their individual strategies for working together to make an overall organization that works efficiently for you and this city. This is all done with a shortage of officers on a tight budget.

I encourage you to sign up for this program and get to know the people that are working tirelessly to keep you and those dear to you safe. You won't regret it. Apart from it being incredibly informative, they also make it a lot of fun. Their good hearted banter and commraderie is infectuous. If anything you will walk away highly informed about this great city, and proud to know that you are protected by a fine group of officers dedicated to you and your safety.







FINANCIAL AID TIP OF THE MONTH, DECEMBER 2022

Know your school's satisfactory academic progress standards

Satisfactory academic progress, or SAP, is an important phrase in the language of student aid for Kentucky students to know, according to KHEAA.

SAP comes into play after you have taken college or technical school classes and are applying for student aid for the next school year.

All colleges that award federal student aid must have SAP standards, which are based on three key areas: GPA, pace and a maximum time frame.

The GPA students must have may vary by school, major and whether a student is pursuing an undergraduate or graduate degree.

To meet the pace standard, students must pass a certain percentage of the classes they take in a given period of time. This may also vary by college.

Maximum time frame means students have to finish their degree within a given number of attempted credit hours. For example, a school may require a student to pass 120 credit hours to earn a bachelor's degree, but the student must earn those 120 hours without taking more than 150 hours.

KHEAA is a public, non-profit agency established in 1966 to improve students' access to college. It provides information about financial aid and financial literacy at no cost to students and parents

In addition, KHEAA disburses private Advantage Education Loans on behalf of its sister agency, KHESLC.

HOME ALONE

I have a darling dog named Molly, who at her ripe ole age of 14 years is content staying home when her beloved humans are away, but it hasn't always been that way. When Molly first came to live with us, she'd literally loose it every time we attempted to go somewhere without her, even for a short period of time. I'd never before had a pet that was afraid to be left home alone, so I assumed I was among a limited few who had to deal with such a scenario. I soon learned that the problem is far more common than I'd thought.

Typical signs of the canine condition known as 'pet separation anxiety' include constant under-the-fence dirt-digging, scratching at doors windows and walls, incessant whining or howling, destructive chewing, urinating or defecating indoors during the owner's absence, and effusive frantic greetings upon the owner's return. My Molly displayed every one of these behavioral traits from the day I adopted her, and it was quite disheartening. The poor girl was terrified of being left home alone. The question begged, "What causes an otherwise easy-going canine to become over-the-top anxious and frantically fearful when left alone?"

There are numerous theories as to why domestic pets fret in the absence of their humans. Among the most agreed-upon reasons is that the animal experienced some sort of trauma in the past, leaving an imprinted memory resulting in a lack of trust in the humans' promise to return, or the dog was indeed abandoned and left to fend for itself, perhaps coming close to the point of starvation before finally being rescued and cared for by a forever friend.

I found one story in an on-line post about an adult dog that lived in a comfortable home with a loving owner for many years. The dog had access to the house and yard all its life and there had been no history of trauma, but when the owner suddenly passed away in the house, the dog was trapped inside. A week went by before a neighbor became concerned that there had been no activity next door, and decided to investigate.

Ultimately the family was contacted. They came and rescued the dog and, of course dealt with all that went along with loosing their son. One can only imagine what that poor dog went through while staying by his master's deceased body in the meantime. From that day on, the dog was in full fear anytime the family attempted to leave him alone. No wonder.

What can be done to help heal the rooted reasons for pet separation anxiety? I learned quite a lot in my quest to do what I could to help Molly get past her fear. Most importantly, the animal's emotional needs must be identified, validated and met. Paying lots of attention to a fretful pet is certainly in order from the start. In fact, positive reenforcement techniques for any pet should include tons of TLC and plenty of petting. Special treats for good behavior can be helpful, in moderation. Uplifting verbiage such as "I love you", and "I am proud of you" should be constant in a regimen for healing the heart of a pet suffering from fear of abandonment.

Animal psychology research has proven that certain terms of endearment can have a positive im-



pact on domestic animal behavior. Even if you are pessimistic about talking to your dog, why not do it anyway? It might lift your own spirits to speak words of encouragement out loud even if no one else understands what you are saying. 'Those in the know' also strongly encourage calm greetings upon return home. The tendency is to be excited and use high tones when returning home after time away, but experts say that can exacerbate the problem.

In addition to these common-sense remedies for comforting pets dealing with "left-alone syndrome", there are products on the market that can help lower the level of anxiety. I purchased a natural stress-relief pet product for Molly called Rescue Remedy. Using that, coupled with a consistent regimen of leaving her at home for short periods of time, and gradually increasing the lengths of time we left her, proved to be an affective process for progress.

I also bought Molly a Thunder Shirt, a product marketed more specifically for calming dogs during thunder storms, fireworks, heavy winds or other loud outdoor noises that can't be controlled. But the Thunder Shirt has also been an affective calming mechanism, in general. It definitely helped with Molly's 'home alone' stress.

Another purchasable product designed to minimize pet separation anxiety is a calming collar. There are a few different brands of calming collars out there. I never pursued this means of resolving the problem with Molly because we were able to make good progress with the Rescue Remedy along with the Thunder Shirt and a regular regimen of coming and going over time. But I've heard good things about the collars so it might be worth a try.

Another helpful habit that can play a part in pulling a pet through separation anxiety, is establishing a close relationship with a reliable, honest, humane local pet sitter such as myself. My clients call on me to visit their pets at the most optimum time, to break up an otherwise long and monotonous day. I arrive at the requested hour, take the pup out for a walk and/or playtime in the yard, then I spend the remaining time loving and cuddling before I leave. If meals are called for, I include that in my visit as well. If the owners have to be away more than a day, I stay with the pet(s) overnight. It makes all the difference in the world to have a familiar friend to rely on!

I wish the best to any pet owner out there who happens to be dealing with a pup suffering from the fear of being left alone. It's not easy, but with lots of love and patience, I know from experience, it gets better. Our pets are a lot like us humans. We want to feel needed, loved unconditionally, and perhaps most importantly, safe at home. Well guess what? So do our furry, four-legged friends, and as we all know, they are worth it. Love and let live.

Yesterday in Highland Park there was a sweep of a homeless area, where they all had to move their tents and stuff, and the sanitation department's large crew filled trucks with junk and cleaned the sidewalk. Before their work, you could smell the area from 200 feet away. At least 15 police officers stood by because some of the homeless camped there got angry. At least a few shouted violent accusations towards the officers. When it was nearly over, I walked right through the thick of it to see the stuff that homeless people collect. My eyes saw some useful daily life objects, but mostly junk and trinkets. My mind was spinning.

Then, I could not help but contemplate the vast amounts of worthless material stuff that so many people accumulate. The difference is that housed people can hide their stuff in garages, back rooms, and rental units.

We all accumulate these things, thinking they are valuable, and we keep these objects, believing that they will impart something special, or that they will appreciate in dollar value, or even in some spiritual or esoteric way. But it is all material stuff.

Here are a few reasons why I have become very minimalist in my approach to the collection of physical stuff.

First, when I began getting interested in survival skills, I realized the great value of storing enough food at your home that will get you through an emergency. Like maybe a few weeks, even a few months' worth of food. That's not especially what I call hoarding. One of my initial purchases of wheat was so large that I had an entire wall in a back room full of buckets of wheat. A year later I realized I rarely eat wheat, and slowly gave away and sold most of them.

Then I considered being prepared for blackouts and other emergencies, and realized the

great value of having certain extra clothing, blankets, manual tools, knives, those sorts of things. Yes, you could say I was starting to collect. And from there, it just goes on an on. Should you store all the wood you find so that you can have a fire in the fireplace every night for the next year? Should you collect all tools and lumber you find so you can build a shed or chicken coop in your back yard without going to the lumber yard? And should you collect all that lumber even if you're not actually making such a shed or chicken coop? That's how you get into the collection of stuff.

It's all really good useful stuff that you might use in an emergency. Before you know it, you're at yard sales and thrift stores, buying things at ridiculously low prices that you know you might use one day. Or, you tell yourself, you could sell it to make extra cash. But you don't sell it, because the retail price for your object – despite its inherent usefulness – is little more than you originally paid

I've gotten to this point. I had plenty of stuff to survive the next apocalypse, but I wasn't really using most of it. And I had to have shed after shed after paid storage unit to store all these really good things. Before you know it, your living space is crammed full of stuff that you never use, but which is -you've convinced yourself - very very valuable.

It's a big trap. In the past 20+ years, I moved a few times, and carefully looked at all the very good material things that I collected. I realized that much of it I never used. Never. So I decided to "bite the bullet" and clean house. I was not willing to move truckloads of stuff to my new place. My criteria was that if I had not actually used the object - despite my having determined that it was "very valuable" - in the last 10 years, then I got rid of it. I gave dozens of boxes of goods to a Boy Scout leader to give outdoor gear to low-income scouts. I gave a truckload of wood and bone and rock and other natural materials to native American friends to use in art projects. I made many boxload donations to Salvation Army and Goodwill. And I filled my blue recycling bin about a dozen times, and filled the black trash can many times as well. Yes, I sold some things, but selling takes time, and you rarely get back what you paid, especially not when you have a time crunch.

And I never regretted shedding my life of the material baggage. I found that the world still had lots of hardware stores and grocery

stores and art supply stores, and that if I was actually doing and using a product, I could just go get it. And if it was truly unavailable, I realized it would not be the end of the world. I could do without. I learned to be rich in the degree to which I could do without stuff.

That's not to say that I have no supplies or boxes of stuff. I do. But I regularly check what I have and give away what I do not need. I do not wait for Christmas or birthdays – I just give away when I realize I have been serving the object and not the other way around. I had a dream that helped me to realize the wisdom of this choice. At a time when my wife and I decided to live separately, I moved out. But because I had so much stuff in the place we'd been living for nearly 20 years, it took a while for me to clean it out. In my dream, I was dead, and I was looking into the window of my old office. My wife was there with helpers and they were discarding most of my stuff. I was horrified at first, but then realized that the stuff they were throwing away had little or no monetary value, and no sentimental value to them. It had some value to me only because it was something I collected, or used in a class, or used for research. And I helplessly watched the junk that I thought was valuable - but after I was dead, it wasn't! I never forgot that dream, telling me that maybe, just maybe, all the junk that I have collected really is of little to no value

Of course, stuff is useful in life. We use stuff all the time, for all our activities. But it is SO easy to get inundated in stuff and miss what life is all about. We forget that our feeling of accomplishment and fulfilment is an interior something, not a thing that is the result of accumulation.

What then must we do? That is, what must we do if we wish to alter this stuff-accumulation pattern. (If you don't think it's a problem, you don't have to do a thing).

How about not buying something in the first place? You know what I mean – you're standing there salivating about some piece of clothing or art piece or knife or whatever, and you know you don't really need it, but you want it, and you're slowly convincing yourself that it's a great bargain! You probably don't need it, and your life will

go on quite well without it. Remember, do your very best to separate need from want in your life. If you already have a lot of the item, and it's sitting in your garage or cluttering up your living space, or worse, you're paying for a storage unit, then, YOU DO NOT NEED IT! Don't buy it. That's the simple part, if you can do it. Just don't buy the stuff in the first place.

OK, so, perhaps that's not the option. You're going to make a purchase. Find one that will not cost you more money as time goes on. You know what I mean, a product that uses odd-size batteries that are not cheap. Or those coffee makers that require you to buy the little cups that fill up landfills. You can always choose a long-lasting ecological product, more or less. If you really work at it, you can make your buying choices support the products that we should all be using, and not junk that clutters up your life.

I also ask myself when I obtain something new: Can I ever sell this for even close to what I paid for it? Or, can I sell it for more than I paid? Will it appreciate in value? Or is it something that no one in their right mind would pay anything for next month?

I also ask myself if the product will materially improve my life, and make me a better person, and more self-reliant. Most stuff will not do that, let's be real. But sometimes a product can be life enhancing, and it's really great to have.

Anyway, you get the idea. Your life will be better without junk. You are rich in the degree that you can do without something. Get rid of your clutter.

LITTLE KNOWN PROPERTY TAX RELIEF PROGRAMS HELP **SENIORS SAVE**

Dear Savvy Senior: I recently learned about a property-tax relief program for seniors in the county where I live. Apparently, there are hundreds of these programs across the country that many retirees, like me, are eligible for but don't know about. What can you tell me about this? Overtaxed Eddie



Dear Eddie:

Great question! Residential property-tax refund and credit programs exist in nearly every state, but unfortunately few people know about them. These programs can help retirees and many other Americans by reducing their property taxes. Here's what you should know.

Rising Property Taxes

Property taxes are a major source of income for local governments, but while they help fund key public services, they can be a financial drain for many homeowners, especially retirees, many of whom live on

According to Attom Data Solutions, a property-data provider, the average American household payed \$3,785 in property taxes in 2021, but this amount varies widely depending on your state's tax rate and your home's estimated value. For example, New Jersey residents paid \$9,476 per year on average in 2021, while West Virginia residents paid \$901.

To help ease this tax burden, most states offer a number of property-tax relief programs. But states aren't always proactive in letting people know. It's up to you, the homeowner, to find out what's available in your county or city that you may be eligible for, and to apply.

Relief Programs

Property tax relief programs, sometimes called exemptions, release eligible homeowners from paying some or all of their property tax obligation. How long the exemption lasts can vary depending on where you live, and the reason you're applying for the exemption.

The tax-relief process varies by county, city or state. In general, you'll have to meet certain eligibility requirements, submit an application and provide documents that support your request. Most programs will either reduce, waive or freeze property taxes for seniors, veterans, surviving spouses, disabled and low-income residents.

But there are some counties that also offer basic homestead exemptions to homeowners regardless of age or income, and others that may provide exemptions to homeowners that have recently made energyefficient improvements to their home.

Where to Look

The best way to learn about local property-tax relief programs and their eligibility requirements is to visit your county, city or state website that collects your property tax. Most of these sites also provide applications and instructions, and will allow you to apply either online, by mail or at your local tax office.

Another good resource for locating programs in your area is the Lincoln Institute, which has a property-tax database that lets you to browse programs across the country. To access it go to Residential Property-TaxReliefPrograms.org.

AARP may also be able to help through their Property Tax-Aide service – see PTAconsumers.aarpfoundation.org. This free program, which is available in 13 states (Arizona, Colorado, Florida–Miami Dade County, Illinois-Cook County, Kansas, Maryland, Michigan, Minnesota, Missouri, Nebraska, New Hampshire, New York and North Carolina) and the District of Columbia helps eligible homeowners and renters apply for relief.







Let us raise a loving cup; Peace on earth, goodwill to men,


