The City of Sierra Madre gives notice, pursuant to State of California law, that the City Council will conduct a public hearing to consider a request to designate the Pickard-Hoover Residence, located at 500 N. Michillinda Avenue, as a Historic Cultural Landmark in the City's Register of Historic Resources. Subsequently, the City Council will be considering a Mills Act contract for restoration and rehabilitation of the subject property. The Pickard-Hoover Residence is a Spanish Colonial Revival home, design and workmanship retained since its original construction. The property is also associated with the productive life of Herbert Charles Hoover, son of the 31st President of the United States, and chairman of the Sierra Madre Boy Scouts. Pursuant to Sierra Madre Municipal Code Section 17.82.050, a property may be designated a historic landmark if it meets prescribed historic or architec-

At the meeting of November 17, 2022, the Planning Commission conducted a public hearing. Upon conducting a site visit, on December 1, 2022, the Planning Commission voted in consent to recommend the City Council the approval of the landmark designation.

I SIGNED THE PETITION FOR THE REFERENDUM Now what happens?

Protect Sierra Madre had only 30 days to get signatures of 10% of Sierra Madre voters, for an election (a referendum) to overturn the City Council's approval of the Meadows project. 1,300 signatures are now being reviewed by the County. Although some may be disqualified for technical reasons, we are certain to have enough qualified signatures for a referendum.

When the Certification is received by the City Council, they will have 3 options - to rescind their approval, to schedule the election for Nov 2024, or to call an earlier special election. A special election is generally requested by the developer, who pays for that election.

A vote to overturn City Council's decision, approving The Meadows project, does not make any permanent change. It does, however, stop the Meadows project for at least a year. The Developer can present another housing project to the City Council a year after the vote.

Because NUW has invested so much time and money in this project, there is NO question that they will return in a year with a project to develop the parcel. But, the people will send a clear message, by voting to overturn the approval, that they want the developer and the City Council to make changes in any project to develop the monastery parcel, and to consider the citizens' opinions in those changes.

Property owners have a right to do with their property whatever is allowed by our ordinances and State law. They are allowed to sell their property and to receive fair market value for it. But our regulations ensure that the rights of one property owner can NOT negatively impact the rights of other residents. The safeguards of our ordinances allow the City to restrict or deny any development contrary to our General Plan policies and ordinances.

Sierra Madre has established objective development standards to ensure that any development, whether reviewed by our Planning Department, Planning Commission or City Council, will be held to the same standards that have always limited overdevelopment in our City.

We have protections in place - when our General Plan and Ordinances are fairly applied to EVERY applicant! But because in 2020, an agreement between the City and the Passionists in Illinois, a "Memorandum Of Understanding" allowed a SPECIFIC PLAN for the Meadows Project, the Passionists were able to evade those protections in our ordinances that every other property owner is bound by.

Citizens of Sierra Madre were never made aware of these negotiations during the water moratorium, or of the MOU, signed at a single meeting - during the Covid shutdown.

The Council, before signing, never considered or discussed with the Citizens, any other option that might allow the Passionists a fair market price for their land, and ALSO protect the values of our General Plan. They never pursued with their constituents the possibility that funds might now be available to help the City buy and conserve the land, as everyone prefers.

They never discussed with the Citizens whether the impacts of a development limited by our existing ordinances might be preferable to special privileges, extended to a single landowner.

By voting to overturn the City Council's approval of the project, we citizens will make it clear - we do NOT think the project approved is the best plan for that parcel.

We believe that the City Council should enforce the General Plan and Ordinances that protect the special nature of our town. And, most importantly, that they must consider the opinions of the residents who they have promised to represent.

For just \$85 per year (less than \$7 per month), this voluntary program provides coverage for fees associated with any paramedic services or emergency transportation provided. The fee covers the subscriber and all other members of their household related by blood, marriage or adoption.

The charge for an ambulance transport can be as high as \$3,000. Even with medical insurance, copays and deductibles can range between \$50 to \$500 for transport. When paramedics are needed, cost should not be a



Perseverance Rover Gets the Dirt on Mars



The mission's first two samples of regolith – broken rock and dust – could help scientists better understand the Red Planet and engineers prepare for future missions there.

NASA officials announced Wednesday that Perseverance rover snagged two new samples from the Martian surface on Dec. 2 and 6. But unlike the 15 rock cores collected to date, these newest samples came from a pile of wind-blown sand and dust similar to but smaller than a dune. Now contained in special metal collection tubes, one of these two samples will be considered for deposit on the Martian surface sometime this month as part of the Mars Sample Return campaign.

Scientists want to study Martian samples with powerful lab equipment on Earth to search for signs of ancient microbial life and to better understand the processes that have shaped the surface of Mars. Most of the samples will be rock; however, researchers also want to examine regolith broken rock and dust – not only because of what it can teach us about geological processes and the environment on Mars, but candidate who uses Mars also to mitigate some of the challenges astronauts will face on the Red Planet. Regolith can affect everything from spacesuits to solar panels, so it's just as interesting to engineers as it is to scientists.

Engineers designed the special drill bit after extensive testing with simulated regolith developed by JPL. Called Mojave Mars Simulant, it's made of volcanic rock crushed into a variety of particle sizes, from fine dust to coarse pebbles, based on images of regolith and data collected by previous Mars missions.

"Everything we learn about the size, shape, and chemistry of regolith grains helps us design and test better tools for future missions," said Iona Tirona of NASA's Jet Propulsion Laboratory in Southern California, which leads the Perseverance mission.

Tirona was the activity lead for operations to collect the recent regolith sample. "The more data we have, the more realistic our simulants can be." The Challenge of Dust

Studying regolith up close could help engineers design future Mars missions - as well as the equipment used by future Martian astronauts. Dust and regolith can damage spacecraft and science instruments alike. Regolith can jam sensitive parts and slow down rovers on the surface. The grains could also pose unique challenges to astronauts: Lunar regolith was discovered to be sharp enough to tear microscopic holes in spacesuits during the Apollo missions to the Moon.

Regolith could be helpful if packed against a habitat shield astronauts from radiation, but it also contains risks: The Martian surface contains perchlorate, a toxic chemical that could threaten the health of astronauts if large amounts were accidentally inhaled or ingested.

"If we have a more permanent presence on Mars, we need to know how the dust and regolith will interact with our spacecraft and habitats," said Perseverance team member Erin Gibbons, a McGill University doctoral regolith simulants as part of her work with the rover's rock-vaporizing laser, called SuperCam.

Besides answering questions about health and safety hazards, a tube of Martian regolith could inspire scientific wonder. Looking at it under a microscope would reveal a kaleidoscope of grains in different shapes and colors. Each one would be like a jigsaw puzzle piece, all of them joined together by wind and water over billions of years.

There are so many different materials mixed into Martian regolith," said Libby Hausrath of University of Nevada, Las Vegas, one of Perseverance's sample return scientists. "Each sample represents an integrated history of the planet's surface."

As an expert on Earth's soils, Hausrath is most interested in finding signs of interaction between water and rock. On Earth, life is found practically everywhere there's water. The same could have been true for Mars billions of years ago, when the planet's climate was much more like Earth's.

More About the Mission A key objective for Perseverance's mission on Mars is astrobiology, including the search for signs of ancient microbial life. The rover will characterize the planet's geology and past climate, pave the way for human exploration of the Red Planet, and be the first mission to collect and cache Martian rock and regolith (broken rock and dust).

Subsequent NASA missions, in cooperation with ESA (European Space Agency), would send spacecraft to Mars to collect these sealed samples from the surface and return them to Earth for in-depth analysis.

The Mars 2020 Perseverance mission is part of NASA's Moon to Mars exploration approach, includes Ārtemis missions to the Moon that will help prepare for human exploration of the Red Planet.

Fraud Alert: Credit Card Skimmers

Skimming devices are hidden electronics used to steal banking and personal information stored on credit and debit cards.In most cases, skimmers are being placed inside gas pumps and are undetectable without opening the machine.

Citizens can reduce the likelihood of becoming a victim by following the below tips:

- Pay inside at the gas station, instead of paying at the pump.
- If not using cash, always pay with a credit card, not a debit card, for better fraud protection.
- If using a debit card, run it as a credit card instead of putting in a PIN number.
- Consider using a refillable prepaid card to purchase gas at the pumps.
- If you haven't done so already, switch to a chip reader on your card.
- Regularly monitor your bank statement for fraudulent activity.
- Report fraudulent activity to your local law enforcement agency.

Originally dubbed "the devils wine" because the bubbles tended to explode in the thin bottles, champagne has long been the choice (well, my choice) to celebrate special occasions for as long as I can remember. January 1st is National Champagne Day, and for good reason - more bubbles will be served from December 24th to January 1st than any other time of the year. Remembering that only grapes from the region of Champagne, France can be so-titled, our last review for the year celebrates bubbles from Champagne: Mumm Cordon Rouge Brut. This is a non-vintage winner - just like many blends I have written about from California, some of the best champagnes I've had are non-vintage. The wine maker has access to over 500 acres of grapes, and the Reims area of Champagne produces great juice year after year. The Mumm name is rivaled only by the House of Moet for champagne dominance. Though you might see me at the local market picking up a bottle of Veuve Cliquot, for \$10 less I can hardly notice the difference.





Of course, this is not a beverage I would recommend drinking on a regular basis, but for a very lasting memory of a great occasion, this champagne will surely create it! Many of you expressed the need for me to keep the prices down in this article - trust me I hear you loud and clear - but for a celebration I do like this champagne. The Cordon Rouge has a wonderful depth of flavor, though some say a little too sweet (I disagree). If stored properly and chilled to the right temperature you will enjoy this immensely. Save the strawberries and cherries for the prosecco, this is real champagne. Champagne goes also very well with fried food (the bubbles cut through the oils of the food) and will also compliment a nice bowl of salty popcorn. Yes, I said popcorn. One last tip for the holidays, your sparkling wine or champagne will not keep overnight, so once it's opened at the restaurant or your home plan on sharing with a friend to finish it. HOW TO DONATE BLOOD

All blood types are needed to ensure a reliable supply for patients. A blood donor card or driver's license or two other forms of identification are required at check-in. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other do-nors 18 years of age and younger also have to meet certain height and weight requirements.

Blood and platelet donors can save time at their next donation by using RapidPass* to complete their pre-donation reading and health history questionnaire online, on the day of their donation, before arriving at the blood drive. To get started, follow the instructions at RedCrossBlood. org/RapidPass or use the Blood Donor App.





The Chorale is looking to accept Pasadena area high school students from ninth through 12th grade to enroll into its Listening to the Future program that will begin in January 2023 and run through June 2023. The five-month composition program culminates with the Pasadena Chorale performing the student composers' new work at its Listening to the Future concert on June 17, 2023. Students can learn how to apply at https://www.pasadenachorale.org/listening-to-the-future. A teacher recommendation is required to apply and applications must be submitted by December 31, 2022.

"Listening to the Future is an arts education program that is very special to me. Created and supported by Pasadena Chorale, Listening to the Future began in 2016 to give young composers a chance to hear their music performed in concert. There wasn't a program like it in Pasadena," said Pasadena Chorale Founding Artistic & Executive Director Jeffrey Bernstein. "This year we're thrilled that L.A.based Amy Gordon will return as our composer mentor. Amy was the composer mentor in 2019-20. She's a terrific composer and a superb educator."

The high school students chosen to participate in the Pasadena Chorale's Listening to the Future program will be selected based on their music experience, level of readiness, and teacher recommendation. Students will meet with professional composer Amy Gordon every two weeks, alternating in-person and Zoom meetings. Gordon will provide feedback on their work and help them revise it. Students will produce one piece of original music for the Chorale and one arrangement of an existing

In March 2023, all six student composers will meet together as a class with Amy Gordon and the Chorale will rehearse the students' new work for the first time. The student composers will have the opportunity to listen to their music performed by the 70-member Chorale live and in-person. Gordon will continue to help the students fine tune their work in preparation for rehearsals for the Listening to the Future concert that will begin in 2023. The final pieces will be performed at the Chorale's June 17 concert. Students will receive video and audio recordings of their finished work that they can include in their portfolios and in their college applications.

The Pasadena Chorale's Listening to the Future is a highly-selective program that is mostly ideal for high school juniors and seniors. In the six years since the program began, the Pasadena Chorale has had six professional working composers mentor 24 student composers, and 62 compositions have

Both Nami and Fikret were living in rooms in the front part of the

duplex. Nami was from Tokyo, working at a Japanese firm in downtown Los Angeles while she earned her CPA license. Fikret was a student from Germany who'd be going home in a few

That December was dark, pressing, my mind a constricted box of sorrow and loss.

RW had earlier suggested to Dolores that she take Nami and Fikret to see the annual Griffith Park festival of lights, and Dolores had mentioned it to Fikret. I brought it up to Fikret and he wanted to go. I think he was more concerned about me getting out and "getting normal" than he was about seeing some electric light display. Anyway, he arranged with Nami to go one evening after Nami got home from work, and I drove. I had never seen the light show either, and though I was in no mood for "joy," I wanted Nami and Fikret to feel happiness, and the joy of the season that the youth can best appreciate.

My mental state was very constrictive, narrow, even subdued horror. It was as if I'd been hit in the face with a 2x4, and I could not see beyond my shocked pain. But I tried, with great effort, to "enjoy" an evening out with Nami and Fikret as best I could. It was the weekend after Dolores died. Nami got home early from work, and it was already dark. Fikret made a very light meal - more of a snack - for everyone before we drove off to Griffith Park in my Jeep. I was preoccupied with now living a life turned upside-down, with no perception of light at the end of my tunnel.

Fikret and Nami were noticeably happy, upbeat, and they seemed to be happy to be doing something with me. Fikret had come on a few field trips with, but I'd only gone out rarely with Nami. I know they were both fully cognizant of my pain and I think they were being happy because they wanted me to be happy. I think that the lights of Griffith Park were a very minor attraction.

As we drove, we spoke about their day, and other light matters. I always enjoyed talking with Nami over dinner about what sort of day she had at work, and what new English words she learned. We drove into the large expansive parking lot east of the Los Angeles Zoo, and drove around until we saw where to park for the festival of lights. People parked their cars, and then boarded buses which set sail every 15 minutes or so, or until the buses were full. The three of us were the first to enter a bus, so we got the seats we wanted. A few adults filed in, and then a whole group of school children came in and filled the bus. The driver turned off the lights, and we were off down the two miles or so of the electric light display.

The children spontaneously sang Christmas carols at the tops of their voices. Nami and Fikret tried to follow along: Jingle Bells, Rudolph, Silent Night, all the classics. Mostly, the children sang enthusiastically and loud with lots of laughter for the first verse until the song faded as the children didn't know the words. After loud laughter, another song would begin.

I could tell they were all having great fun, though I was barely there. I had to shut off most of my painful feelings and emotions and turn on only that part of me that was needed for ordinary interactions with others. I was glad that there was so much happiness in the world, but I was in pain.

I was in a darkness of my own, alone, as if I was severely and suddenly cut off from all that was important to me. Which was, in fact, what happened. After the light show, we returned to the Jeep, and I drove on in a stupor. I asked Nami and Fikret if they wanted to see more Christmas lights, and they said yes. Christmas Tree Lane was impressive, but monotonous to me. Nami and Fikret just said "Oohh," and "Ahhh," and "Look at those, wow!" I tried to explain the history of Christmas Tree Lane, how I grew up just around the corner, and I drove by our family home on North Los Robles.

I didn't want to go home quite yet. "Going home" would mean that I would go back to the rear duplex alone, would sit there for awhile listening to music or watching TV, feeling the full grief of losing Dolores, by myself. It meant I would go to sleep with my grief, unable to find solace in music or TV. I would turn off the TV and music, and in the darkness I would fall into my abyss of sorrow until I awoke the next day. No, I didn't want to go home yet.

 $I \ told \ Nami \ and \ Fikret \ that \ I \ knew \ of \ another \ Christmas \ light \ display \ and \ we \ drove \ across \ town \ looking \ for \ it.$ We never found it, but they got a tour of East Pasadena and Sierra Madre before we stopped for some snacks and finally went home.

We then went into the front kitchen when we got home, and enjoyed some cookies and coffee. We all laughed together and we watched a little bit of a Christmas movie on TV. It was a good evening overall, but it would be a long time before I could feel joy again.

Still, eventually, little by little, I learned that though life is short and precious, Love is what makes it meaningful!

TIPS FOR BEING A LONG-DISTANCE CAREGIVER

Dear Savvy Senior:

What tips do you recommend for long-distance caregivers? I help take care of my stubborn 86-year-old mother who still lives at home about 150 miles from me. Need Advice

Dear Need:

Providing care and support for an aging parent who lives far away can present a variety challenges that can make the job difficult and stressful. Here are some tips and resources that may help you.

Long-Distance Caregiving

When it comes to monitoring and caring for an aging parent from afar, you have a couple of options. You can hire a professional to oversee your mom's needs, or you can manage things yourself by building a support system, tapping into available resources, and utilizing technology devices that can help you keep tabs on her.

If your mom needs a lot of help, you should consider hiring a geriatric care manager who will give her a thorough assessment to identify her needs and will set up and manage all aspects of her care. But geriatric care managers are expensive typically charging between \$100 and \$250 per hour after an initial assessment of \$150 to \$750 and are not covered by Medicare.

To find a geriatric care manager in your mom's area, visit AgingLifeCare.org or contact the nearest Area Agency on Aging (call 800-677-1116) to see if they have a list of providers.

If, however, your mom only needs occasional help, or if you can't afford to use a care manager, here are some things you can do yourself to help her.

Create a care team: Put together a network of peo ple (nearby friends or family, neighbors, clergy etc.) who can check on your mom regularly, and who you can call on from time to time for occasional help. Also put together a list of reliable services you can call for household needs like lawn care, handyman services, plumber, etc.

Tap local resources: Most communities offer a range of free or subsidized services that can help seniors with basic needs such as home delivered meals, transportation, senior companion services and more. Contact the nearby Area Aging Agency to find out what's available.

Check essential documents: This is also a good time to make sure your mom has the following essential legal documents: a will; a living will and health-care proxy, which allows you to make medical decisions on her behalf if she became incapacitated; and a durable power of attorney, which gives if needed.

4 YEAR-END TAX-SAVING STRATEGIES FOR 2022

time, it's also the deadline for your family to implement several key tax-savings strategies.

By acting now, you can significantly reduce your tax bill, due in April, but with just a few weeks left in 2022, you must act fast.

While there are dozens of potential tax breaks you may qualify for, here are 4 of the leading moves you can make to save big on your 2022 tax return. However, there may be other opportunities for saving, so meet with your tax advisor to make certain you haven't missed one.

1 - Maximize retirement account contributions

By maximizing your contributions to tax-deferred retirement accounts, such as IRAs and 401(k)s, you can not only save for retirement, but also reduce your taxable income for 2022.

In 2022, you can contribute up to \$6,000 to an IRA and up to \$20,500 to a 401(k) if you're under 50, and up to \$7,000 to an IRA and \$27,000 to a 401(k) for those 50 and older. If you don't have the cash available to fund the maximum amount, try to contribute at least any amount that will be matched by your employer, since that's basically free money, and you lose it if you don't use it.

That said, the ability to deduct your traditional IRA contributions from your taxes comes with certain limitations. These limitations are based on factors, such as whether you or your spouse is covered by a retirement plan at work as well as your adjusted gross income (AGI), so make sure you know how your family is affected by these limits when taking deductions. On the other hand, Roth IRA contributions are not tax deductible, since they are made after taxes are taken out, but withdrawals from a Roth in retirement are tax-free.

Additionally, consider maxing out contributions to your Health Savings Account (HSA). Contributions to HSAs for 2022 are capped at \$3,650 for individuals and \$7,300 for families, with an additional catch-up contribution of \$1,000 allowed for those age 55 and

You have until December 31, 2022 to contribute to a 401(k) plan and until April 18, 2023 to contribute to an IRA or HSA for the 2022 tax year.

2 - Defer income if you'll make less next year

If you're expecting to make significantly more income this year than in 2023, try to defer as much income into next year as possible. However, this strategy only makes sense if you'll be in the same or a lower tax bracket next year.

This might mean asking your boss to delay paying a year-end bonus until after Jan. 1, 2023, or if you're self-employed, waiting to invoice certain clients until the new year. On the other hand, if you think you'll be in a higher tax bracket in 2023, you may want to do the opposite and accelerate income into 2022 to take advantage of a lower tax bracket.

Although the end of 3 - Use "loss harvesting" to offset capital gains the year can be a hectic With the stock and crypto markets down this year, it can be the ideal time to use a strategy called "loss harvesting," which means selling taxable investment assets, such as stocks, mutual funds, and bonds, at a loss to offset any capital gains you may have realized earlier in the year. Capital losses offset capital gains dollar for dollar.

If your losses exceed your gains, you can write off up to \$3,000 of collective losses against other income. Any losses of more than \$3,000 can be carried over into the next year. In fact, you can carry over such losses year after year over your lifetime.

Note that the loss harvesting strategy does not apply to tax-advantaged accounts, such as 401(k)s, IRAs, and 529 plans. Additionally, the IRS "wash-sale" rule prohibits using this tax write-off for buying a "substantially identical" asset within a 30-day window before or after the sale that generated the loss.

Given the restrictions, you should always consult your CPA or financial advisor before employing loss harvesting to ensure it doesn't backfire on you.

4 - Watch your required minimum distributions (RMDs)—or ensure your parents are watching theirs—if you or they are over age 72

If you have an employer-sponsored retirement plan, including a 401(k), 403(b), traditional IRA, SEP IRA, or SIMPLE IRA, you must start taking required minimum distributions (RMDs) by April 1st of the year that follows the year you turn 72. After that, annual withdrawals must be made by December 31st each year to avoid a serious penalty.

If you fail to take the proper RMD, you may face a 50% excise tax on the amount you should have withdrawn based on your age, life expectancy, and your account balance at the beginning of the year. That said, if you do make a mistake, you may be able to avoid the penalty by requesting a waiver from the IRS. You can request a waiver if your failure to take the RMD is due to a reasonable error, and you take steps to make the required distribution. To request a waiver, submit Form 5329 to the IRS, with a statement explaining the error and the steps you are taking to

Note that in 2022 the IRS updated its uniform life-time table to calculate RMDs to account for longer life expectancies. As a result, your RMDs for this year may be slightly lower compared to previous years. Maximize Your 2022 Tax Savings

Implementing these-and other-year-end tax-saving strategies could save your family thousands of dollars on your 2022 tax bill. But if you don't act soon, some of these opportunities may vanish for good, so act now and lock in your savings.

DOES LIFE HAVE TO BE LIKE A DOG RACE?

You know what I mean by a dog race, don't you? Dogs race around the track chasing a mechanical rabbit that they can never catch. It's different from a horse race wherein humans sit on top of the horses and hit them with whips. In both kinds of races the dogs and the horses don't really win anything. The rabbit really isn't real and the horses at Santa Anita lately are dying but the races keep going on for the benefit of the owners and the bettors and the crowds who escape from the reality of the rest of their

My point is that for the poor dogs running is all an illusion. There is no real rabbit to catch. They are deluded into believing there is a reward for all their effort but the make-believe rabbit is just an instrument of control used to make the dogs perform in accord with the desires of their owners. I use this example of dog racing as an analogy for the methods used to control human behavior. It is an accepted fact that the minds of young children are able to learn and instantiate new information in a way not possible for adult minds. I really don't know why this is true but one has to simply look around to see almost every single child acquire language in some mysterious way.

Almost every single child acquires skills in language with absolutely no structured lessons. Really it's an amazing unexplained process that is not connected to the intelligence of the individual child. In fact, humans such as Albert Einstein and Nobel Prize Winning Richard Feynman are reported not to have spoken almost until the age of four. Typically, most humans

are using language at about two and are quite accomplished speakers by the age of four.

To continue my animal metaphor, it already feels like I am beating a dead horse. My point is that young children all have these wonderful active minds capable of doing amazing things and yet the adult world fills these minds with nonsense and lies. Going through this holiday season it is so clear that children's minds are deluged with fantasies about Santa, and goblins, and ghosts. Personally I put all the teaching about religion and the all-powerful deity watching over us who requires that we be good boys and girls and do what our parents and teachers tell us or face unimaginable horrors in the same category. Kids are taught not ask questions and just do what we tell you is the message from the all-powerful God.

Of course, eventually, many, or even most kids, feel betrayed. They realize that there is no Santa, and no ghosts, and have deep questions about God and the after-life. At some point the thought that doing what their parents want them to do is not the purpose of their own lives. These realizations are certainly confusing and frequently traumatic as people struggle to find meaning in their own life. Those, who have been taught not to question begin to question everything and search for an escape from their own despair. Going back to the attendance at horse races individuals seek to escape from their confused inner life and seek diversions like amusement parks and festivals and frequently find drugs as a means of escape. Very frequently in today's societies individuals are prescribed drugs, easily abused drugs to mitigate their despair. Another means of escape is often adventure and lawlessness and risk-taking behavior and violence; all in all it's not a very pretty picture.

Is all this early exposure to what I call lies and fantasy necessary to enable people to

live in a civilized manner? Frankly, I think not. For reasons I cannot fully explain I was never exposed to religion, had no birthday parties, no access to television (it wasn't available in the 1940's) no trick or treating or Halloween Costumes, no toys that I can remember and yet surprisingly, I guess, I have always been a pretty happy person free to pursue my own curiosities. In Elementary School I actually was known as the "question box". What did I do? My parents somehow had acquired a multi-volume encyclopedia and I read the whole thing. The name of the Richard Feynman short memoir is "The Pleasure of Finding Things Out". The author is pictured on the front cover with his head back, relaxed, happy, and satisfied. I have that book on my bedroom dresser and receive inspiration as I wake up.

On the top of page 10 Feynman laments that he was recruited into the Manhattan project to assist in developing a bomb that would defeat Germany. Even after it became clear that Germany would be defeated without the necessity of developing a potentially world-destroying Atomic Bomb Feynman says he continued to work to develop the bomb and didn't ask

Questions are really important and it is my hope, hopefully all of our hope, than we can ask questions about the civilization that has developed and which seems to be in the process of

DID SOMEONE SAY...'SHAZAM'?



Saint Nick wasn't the only man in a red suit that magical Christmas season 50 years ago.

On Saturday December 23, 1972, I walked from my house to Sharp's Drive-In Market and splurged on four 20-cent comic books.

One of my selections was heavily influenced by an ad appearing in DC Comics: "Coming in December...DC's Christmas gift to you!

Shazam is coming!"

I could scarcely wait to rush home and open my copy of "Shazam!" #1. Unfortunately, my gut reaction upon seeing the interior artwork was, "What's this cartoony junk???" You see, I had recently sworn off "kiddie" comics. But "Shazam!" grew on me. By the second issue, it was my favorite title.

"Shazam!" #1 featured the triumphal return of "the original Captain Marvel" and his extended family. Introduced in Fawcett's "Whiz Comics" #2 (cover-dated February 1940), Captain Marvel was the alter ego of boy reporter Billy Batson. By speaking the magic word "Shazam!," Billy summoned a mystical bolt of lightning and transformed into a costumed adult super-hero who saved the world from countless threats.

During the 1940s (what comics aficionados refer to as the Golden Age of Comics), Captain Marvel appeared in his own 12-chapter Republic movie serial and even outsold Superman on the newsstands.

But "the world's mightiest mortal" went into limbo in 1953 because of (a) the declining popularity of super-heroes and (b) a long-running lawsuit in which DC accused the good captain of being a rip-off of Superman.

That's why "Shazam!" was such a big deal in 1972, bringing Captain Marvel and the rest of the Marvel Family back to a nostalgia-crazed world after almost 20 years. (The comic had to be named "Shazam!" after the magic word and the wizard who gave it to Billy, because in the ensuing decades rival Marvel Comics had trademarked the name Captain Marvel and introduced the first of a series of heroes bearing that name. Countless fans over the past half-century have gotten the book title and hero name confused, so DC officially changed the hero's name to Shazam circa 2012.)

Still...even though the revival spawned a fondly remembered live-action CBS Saturday morning program and a 1981 NBC animated version, the Big Red Cheese (as arch-villain Doctor Thaddeus Bodog Sivana dubbed him) never matched his former glory.

(When I was writing for "Comics Buyer's Guide" magazine in 1987, I received a letter from Captain Marvel co-creator C.C. Beck, lamenting that the modern handlers had made the character either too silly or too grim, rarely capturing the delicate balance of whimsy and suspense that marked the original incarnation.)

I'm glad DC keeps going back to the drawing board, trying to let the do-gooder live up to his potential. My family enjoyed the 2019 movie and looks forward to next year's sequel, "Shazam! Fury of the Gods."

I hope that this Christmas some lucky child finds Shazam! graphic novels or a DVD of the aforementioned movie under the tree.

We still need to believe in the triumph of good over evil.

We still need some good, clean fun.

And we sometimes need to comfort ourselves with the fantasy that one magic word could endow us with the strength to solve all our problems.

I heard rumors that the concept has even reached the White House, whose current occupant perhaps read the 1940s adventures of Captain Marvel.

"With one magic word...fourscore and seven years ago..."

By the way, if anyone asks you what the difference between ignorance and apathy is, tell them, "I don't know and I don't care."


