"FOR THE SAFETY OF OUR AUDIENCE..." SIERRA MADRE PLAYHOUSE SEEKS MORE FUNDS FOR FACELIFT

even beauty needs a helping hand... or two...or three. Factually, there is much work to be done in this great city: roads to be fixed, libraries and museums to be repaired, pipes to be replaced, and many other facelift projects to be considered. But money is tight, red tape is thick, and justification is essential.

On October 25, 2022, the City Council was presented with yet another refurbishment request—The Sierra Madre Playhouse (SMPH). The building, which sits at 87 W. Sierra Madre Blvd. was built in 1910, though theater performances have dazzled citizens of this town since around 1880. And the show goes on, with A Patsy Cline Holiday Concert expected to delight December theater-goers through the 23rd of the month. But the venue still needs major structural, mechanical, plumbing, and wiring renovations, despite some recent renovations.

Oh, funding, where art thou?

The SMPH Board of Trustees came before the City Council during that October 25th meeting and presented a Capital Campaign Appeal for a \$350,000 grant. The grant would be used for a new HVAC system, electrical replacement, new roofing, re-painting, ADA-compliant restrooms, and city

According to CEO and Board President David Gordon, the Playhouse now seeks \$250,000 in reduced from the original grant request of \$350,000) in grant money to complete "Phase 2" renovations.

> During the October 25th meeting, City Council requested more information from staff, including a list of Sierra Madre's unfunded projects and an overview of the General Fund budget.

> On December 13, 2022, a presentation was given before the Council by Community Services Manager Rebecca Silva-Barrón and Finance Director Hillary Guirola-Leon. Ms. Leon spoke of the 24 unfunded projects for consideration which total over \$8.5 million. These projects include self-contained breathing apparatus for the Fire Department, a playground replacement at Memorial Park and Mt. Wilson Trail Park, and remodel for the new Public Safety site in the old Bank of America building.

> Leon also gave a brief breakdown of the General Fund budgeting, showing solid reserves, a positive bounce-back from the pandemic response, and a reduction in expenditures. But can the (continued on page 2)

dip into the General Fund to help the Playhouse achieve its restoration goals?

'Tis the season...but no

It is Christmas time. So, can the city give a financial gift to the SMPH from the General

Article XVI, section 6 of the California Constitution states, "the Legislature shall have no power to...make any gift or authorize the making of any gift, of any public money or thing of value to any individual, municipal, or other corporation whatever." So, that would be a hard Grinchy "no." It would also be unconstitutional.

In addition, the SMPH is not owned by the city. A private, non-profit organization owns it. The donation of funds would require that the city retain real property interest in the building or maintain programming control. Neither option seems plausible. But there are other options.

What About The American Rescue Plan Act (ARPA)

The American Rescue Plan Act was created to help businesses & organizations economically affected by the pandemic. In March 2021, Sierra Madre received expenditures from ARPA of approximately \$2.58 million. Those allocations were distributed as follows:

- Non-profit Assistance Grant- Incurred =
- Premium Pay Essential Workers- Incurred \$200,656
- Sierra Vista Playground Project- Budgeted \$800,000
- · New Public Safety Building Improvements-Budgeted - \$1,000,000
- Library Grant Matching Requirements \$334,605

This would leave \$56,480 of ARPA allocations remaining.

An ARPA grant can be used as a source of funding to "respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and non-profits, or aid to impacted industries, such as tourism, travel, and hospitality.

Suppose the Playhouse can provide documentation indicating that a new HVAC system is needed to help stop the spread of COVID-19 through poorly ventilated public spaces where people congregate? In that case, an ARPA grant may work for them. SMPH would enter for an "Encore" to follow.

into an agreement with the city and have to show what the funds were used for.

But this is only a tiny portion of funds being sought for SMPH repairs.

David Gordon, President and CEO of the Playhouse addressed the Council first to make his pitch for the 103-year-old structure. "I feel there is a way in which you can give the Playhouse \$250,000 and also a matching grant of \$350,000 for the library," Gordon said before a packed house. He then proposed receiving \$250,000 from ARPA funds, giving \$150,000 to the library, and obtaining the remaining \$200,000 from General Fund Reserves, adding that it would be "simple, legal, and prudent." Gordon suggests a "grant program" as a legal way around giving an unconstitutional gift.

Acclaim or Criticism?

Though everyone expressed support for the Playhouse, opinions differed regarding funding options. "I am a big proponent of community theater," stated Diane Sands, Member of the Board of Trustees for the Library and President of the Historical Preservation Society. "However, as valued as the Playhouse is as a cultural asset to our town, it is nevertheless not owned by the city...but the public library is. If funds are taken away from the ARPA money... it means that matching funds are taken away. Please don't take ARPA funds away from the library matching," Sands pleaded.

"No one sector can effectively establish or sustain a creative place," said Eileen Walker, SMPH Board Member. "It takes a broad range of private, non-profit, and governmental entities to make them happen. By supporting the Playhouse and stepping up to be the cornerstone of our Capital Campaign, the city of Sierra Madre can participate in a partnership that is the essence of creative placemaking. I urge you to support the Capital Campaign," Walker petitioned.

City Council did discuss the possibility of using ARPA funds as a loan option to the SMPH, which would be forgivable, but such a risk could be too high for both the Playhouse and the city.

Council Members expressed concerns over extra spending when the city has concerns over water, infrastructure, and public safety. For now, a unanimous motion was passed to award the SMPH the remaining funds in the ARPA Allocation totaling \$56,480.


THIEVES BURGLARIZE BOTTLE SHOP

At approximately 2:30 am Thursday morning, thieves broke into Sierra Madre's iconic Bottle Shop located on Sierra Madre Blvd.

It has operated from the same location since the 1960's without incidence.

According to SMPD Sgt. Kamchamnan, the perpertrators struck quickly stealing more than \$30,000 of high end liquor. They entered through the front door and were "all hoodied and masked up", making facial recognition next to impossible for the security cameras.

Cameras were able to capture photos of the 'get away' vehicle believed to be black BMW with the plates removed.

Tuesday, December 6th

SIERRA MADRE POLICE INVESTIGATE A POSSIBLE THREAT AT ST. RITA SCHOOL

Sierra Madre Police Officers were dispatched to St. Rita School in the 300 block of North Baldwin Avenue, regarding a possible threat of violence at the school. Once informed, the Police Department took immediate steps to investigate the incident, including interviewing numerous potential witnesses, viewing social media accounts, and conducting searches. The investigation remains active and ongoing.

While Officers conducting the initial investigation determined that there was no immediate threat to the school, there will be increased patrols around all Sierra Madre schools to ensure the safety of students and staff. Officers have also spoken to the family of the student and will continue to investigate the matter.

The Police Department is committed to fully investigate each threat. When probable cause exists, appropriate enforcement action will be taken. We focus on ensuring the safety of students, school staff, and community members as we respond to these incidents.

We continue to encourage students, parents, and school staff to immediately report any information that poses a threat to the safety of others. We continue to communicate with St. Rita School, as well as local, regional and federal law enforcement partners, to share information and ensure the safety of our schools and our community. We ask that the public remember to follow the philosophy of "See Something, Say Something" when witnessing or hearing suspicious activity

Anyone with information regarding this or any threat to a school is asked to call the Police Department immediately by dialing 9-1-1, or (626) 355-1414 for a non-emergency.

This information is preliminary and is intended for informational use rather than being a formal investigative report.

At approximately 7 AM, officers responded to the 400 block of Mariposa Ave. for reports of a theft from motor vehicle. Upon arrival, the reporting party stated that the catalytic converter was stolen from their vehicle. The Detectives' Bureau is following up on this incident.

Yes, I'm ready for Christmas. I've been making pumpkin cookies for Jessie and Emily to deliver to their teachers this week before they escape the confines of the classroom for Christmas break. That's today's picture. Dozens of cookies in little bags, which will make you wish you had some.

Here's the pumpkin cookie recipe, in case you want to make them and give some to everyone you know.

PUMPKIN COOKIES

3-1/2 cups all-purpose flour 2-1/3 cups old fashioned oats

1-3/4 tsp. baking soda

1-1/2 tsp. salt

2 tsp. cinnamon (generous)

½ tsp. nutmeg ¼ tsp. ground cloves

Combine the above in a large bowl. With your electric mixer, blend the following then add to the flour mixture:

3-1/2 sticks butter, softened 1-3/4 cups white sugar

1-3/4 cups packed brown sugar

1 15-oz can Libby's 100% pure pumpkin (not pumpkin pie mix)

2 large eggs

1-3/4 tsp. vanilla extract

Add as many pecans, walnuts, dried cranberries, raisins as you'd like to have. This makes a LOT of dough. Chill your dough overnight before you bake.

Bake at 350 for 14-16 minutes until firm and lightly browned. Enjoy them and share them. Christmas is for giving.

Speaking of sharing, The Candlelight Walk is tomorrow, Sunday, starting from St. Rita's at 7:45. Hoping for no rain and lots of happy folks to share this lovely time.

Best of all, I've been reading the Christmas story from the Gospel of Luke, which blesses me. Hope it blesses you, too.





Pasadena Public Health Department announced Friday that health officer orders have been revised to strongly recommend masking for everyone ages 2 years and older, regardless of vaccination status, in indoor workplaces, indoor public spaces, and public transit. In addition to strongly recommending masking in indoor workplaces, indoor public settings, and public transit, the health officer orders establish threshold criteria that would lead to mandatory masking, including COVID-19 including hospitalizations infections, and staffed inpatient hospital beds. Indoor masking continues to be required in all

healthcare settings.

Recent variants of
COVID-19 have infected a significant proportion of residents in Pasadena and Los Angeles County. Pasadena Public Health Department is asking all residents to layer in sensible COVID-19 protections this holiday season, including indoor masking and getting vaccinated and boosted.

"With increased travel and large gatherings, masking and staying up to date on your COVID-19 vaccinations are the best way to protect yourself and your loved ones," said Pasadena interim Public Health Director Manuel "These basic Carmona. precautions can help prevent increases in COVID-19 cases and avoid the need for mandatory masking in indoor workplaces, public settings, and public transit."

The updated health orders

establish threshold metrics, including COVID-19 infections, hospitalizations and staffed inpatient hospital beds, to determine when mandatory masking indoors will be required. Local hospitals and healthcare facilities are significantly strained. Managing high levels of COVID-19 cases is an ongoing challenge for the healthcare system and limits resources available for helping those in need of treatment.

"We are seeing increases in COVID-19 cases and local hospitalizations and unseasonably elevated levels of influenza infections that put our local residents at increased risk for severe illness and death," said Pasadena Health Officer Dr. Eric Handler.

To reduce the transmission of COVID-19 and other respiratory diseases precautions include:

Wearing a well-fitting respirator or mask (e.g., N95, KN95, KF94)

Staying up to date with COVID-19 vaccination, vaccination, including all primary series doses and boosters, and getting a flu vaccine

Staying home when sick and following recommended if exposed to practices COVID-19, including seeking treatment

Testing if you are sick or have been exposed to someone with COVID-19

Lawsuit Filed over Rent Control Measure H

The California Apartment Association (CAA) announced Friday that they have filed a lawsuit and a preliminary injunction alleging that the Pasadena rent control initiative adopted by voters in November is invalid.

According to a statement, the lawsuit, filed in Los Angeles Superior Court, came just days after the Pasadena City Council certified the election results, situating Measure H to take effect as soon as Dec. 22. CAA officials also said they intend to seek a preliminary injunction to prevent the measure from being fully implemented while the lawsuit is considered by the

"Though rent control itself has generally been upheld as a valid exercise of local government powers, CAA's lawsuit targets the process used to adopt the ordinance and discrete elements of the law," they said.

The CAA statement continued, the lawsuit alleges that the measure, which was placed on the ballot as an amendment to the city's charter, nearly doubles the length of the charter and effectively restructures the city government with the creation of an independent rent board. In so doing, the measure fundamentally changes the city charter and effects a so-called "charter revision," the lawsuit claims. Though the difference in terminology may sound insignificant, the distinction between a charter amendment and charter revision carries serious legal consequences. Charter amendments may be proposed by citizens' initiative as Measure H was - but under the state constitution, charter revisions can only be put forward by the city council or a charter review commission.

The relocation assistance requirement will almost exclusively affect owners of units protected from local rent control under the Costa-Hawkins Rental Housing Act. The lawsuit alleges the relocation assistance requirement penalizes owners who exercise their rights under Costa-Hawkins, creating an

If successful, the lawsuit could result in Measure H being declared wholly invalid, though the court also could strike just portions of the measure found to result in a charter revision or to violate state law.

ARCADIA POLICE BLOTTER

For the period of Sunday, December 4th through Saturday, December 10th, the Police Department responded to 841 calls for service, of which 102 required formal investigations. The following is a summary report of some of the major incidents handled by the Department during this period.

Sunday, December 4:

At 2:50 a.m., an officer responded to the intersection of Santa Anita Avenue and Huntington Drive regarding a solo vehicle traffic collision. Upon contacting the driver, the officer detected a strong odor of alcohol emitting from her breath and body. Through a series of tests, the officer discovered the 31-year-old female from Monrovia had been driving with a blood alcohol content of .177%, well above the legal limit. He was arrested and transported to the Arcadia City Jail for booking.

Upon locating and stopping the vehicle, the driver admitted to being in possession of a controlled substance. A records check revealed the suspect also had an outstanding misdemeanor warrant. 

DUARTE FINAL ELECTION RESULTS OF THE NOVEMBER 8, 2022 GENERAL MUNICIPAL ELECTION

At the December 13 Duarte City Council Meeting, City Council adopted Resolution No. 22-39 reciting the facts and declaring the results of the General Municipal Election on No-vember 8, 2022. Elections for City Councilmembers were conducted in Districts 1, 4, 5, and 6 and the following candidates were elected to serve for a four-year term:

District 1 - Margaret E. Finlay District 4 - Tera Martin Del Campo District 5 - Samuel Kang District 6 - Cesar Andres Garcia

Duarte City Council also appointed Jody Schulz as the new Duarte Mayor and Vinh Tru-ong as Mayor Pro Tem at the December 13 City Council Meeting. Councilmembers ap-point the Mayor and Mayor Pro Tem amongst themselves and each position serves for a one-year term.

Supervisor Kathryn Barger was in attendance to swear in re-elected Councilmember Mar-garet Finlay and newly elected Councilmember Tera Martin Del Campo. Re-elected Councilmember Cesar Andres Garcia was sworn in by his mother, Lydia Garcia.

The Duarte City Council is comprised of seven members who are directly elected by Du-arte voters. The Council serves as the legislative body for the City and is responsible for establishing City policies, adopting City ordinances and resolutions, holding public hearings, adopting the City's budget, and authorizing City expenditures. City Council also ap-points the City Manager, City Attorney, and the members of City commissions and com-mittees. Councilmembers serve a term of four years and the elections of councilmembers are staggered.

Measure J, an ordinance establishing a healthcare workers minimum wage ordinance in the City, was also up for consideration at the November 8 election. A majority of Duarte voters did not vote in favor of Measure J and therefore it will not be adopted.

Elections for City Council representative in Districts 2, 3, and 7 will be held in 2024 at the end of the current representatives' 4-year term. Learn more about your district by visiting the City's redistricting website.

Public Health Reports 22 New Deaths and 9,473 New Positive Cases of Con-firmed COVID-19 in Los Angeles County

This week, LA County reported continued high case numbers along with rising hospitalizations. Most alarming is the increase in test positivity which has more than tripled since mid-December, indicating surging transmission across the county.

With high rates of transmission, unfortunately, even those who are vaccinated can become infected and infect others. And while the hope is that Omicron symptoms are milder, the current rise in hospi-talizations is a cause for concern. Hospitalizations have increased by 30% since last Tuesday; the alarming rise in hospitalizations follows an alarming increase in cases



Fiction is sometimes better told then fact. The wine industry is no exception. I am told German draft-dodger Jacob Schram made camp in Calistoga in 1860 looking for a place to plant his vines. One hundred sixty years later "Schramsberg" is producing some of my all time favorite sparkling wines to this very day. Is it good enough for me? It certainly was for Richard Nixon. In 1972, Barbara Walters hosted then-President Nixon and China's premier Zhou Enlai with it, and Schramsberg sparkling wine has been served at state functions by every president (and yes, in the Dills household) since the mid-eighties.



yeast plays an important role in the fermentation role of the wine's richness and body, making the wine crisp and low in tannins (The Monks found this out by accident). Many readers ask me about sparkling wine or champagne storage. I buy champagne to drink right away, but if you are able to purchase a six-pack to save a few dollars, that's fine. This Schramsberg, if stored properly, in a nice cool place bottle on it's side, it will be good for years to come, but why let it sit all alone when it should be enjoyed?

Yes, the holidays are here, and my research tells me that consumption of bubbles goes way up during the holidays. This is not a picnic sparkling wine - this is one of my favorites and I savor every zesty sip. Enjoy with a special friend, dinner, or a nice soft cheese.

CONGRESSMAN SCHIFF ON RISING HATE **CRIMES IN L.A. COUNTY**



Washington, D.C. - Today, Congressman Adam Schiff (D-Calif.) issued the following statement on the L.A. County Commission on Human Relations hate crimes report:

"I am deeply troubled by the unprecedented surge in hate crimes in Los Angeles County. The rising number of acts of violence against Black, Asian, and LGBTQ+ Angelenos are horrifying, and tragically mirror the awful mass shootings and targeted attacks we have seen in Buffalo, Colorado Springs, and other cities across the nation. I am also particularly disturbed that Jewish Angelenos were victims of an overwhelming number of the reli-giously-motivated hate crimes, especially as antisemitic vitriol has reached a fever pitch in recent weeks. As this report shows, there is no room for silence or

ambivalence on these matters – we must all condemn bigotry and lies wherever we see them, because the con-sequences of inaction are too great to bear."

WHAT HAPPENED WHEN I WAS IN **GUATEMALA**

I was sitting in a bus, driving through the Guatemalan countryside when I got the call that my brother Richard had died. I was troubled, and upset, and saddened

that I'd not see Richard again. I closed my eyes and began to think over some of our life together. I thought mostly of childhood incidents, and they mostly made me laugh.

But mostly, when I heard of his death, I was sad. He'd not be around anymore, even though we probably only talked once a month or so. The last time I saw Richard was just two months earlier, at the memorial for his own son Jonathan who died in a motorcycle accident. I realized that life is short and precious, and we don't always get all the time we think we need, or deserve.

The following two days in Guatemala were particularly painful, not entirely but partly because of thinking about Richard. One night I spoke with a friend, Doug, and Doug told me many things, including that my pain wasn't because of Richard's pain, but because of my own fears about life. We had a long and insightful conver-sation. Doug told me that Richard would appear to me that night in my dreams. But Richard did not appear to me that night.

The following day, I was sitting in our shamanism class at the upper room of the hotel at Lake Atitlan, learning about the esoteric meaning of certain Mayan glyphs. The instructor, Miguel Angel Vergara, led us in a meditation while light mu-sic was playing.

When I closed my eyes, I found myself on a large flat mountaintop, not unlike the top of one of the many pyramids we were visiting. Richard was there with me, smiling. He didn't say anything, but we held hands and began to dance in a circle, slowly at first. We smiled and laughed as we held hands and twirled. We laughed, and Jona-than joined the circle, as we talked lightly about how much fun it was. Dolores joined, and my mother and father joined, smiling. My mother said, "Aren't you going to invite us to dance?", and we all laughed and continued to dance in this circle.

It was such pure, child-like enjoyment, and others, seeing our delight, quickly joined. Helen joined the circle, and Tom and David and Gilbert quickly joined. Pam, Michael, and Jeffrey joined. Spouses and children joined and the circle got bigger and louder and we were singing and smiling and it was like a Michael Jackson We are the World songfest, except the music was more like the Jewish folk song Hava Nagilah. [If you don't knoew this song, you should listen to it right now on YouTube to get a feel for my dream].

We went round and round and friends began to join - I saw the neighborhood friends join with Richard – Lee Keller, George Sotello, Robert Haddon, Jim Billups, and I saw the many family friends join the dance - Paul Martinez and Carlos Frausto and the deFazios. People kept joining, friends of Richard and friends of his friends and the circle got larger and larger, and the music was like this celestial an-gelic music and we moved as one and we smiled and we felt a oneness that you just want to feel on earth but you rarely do.

The circle got larger and larger and as we danced and moved we all began to see that we were all one family, one organism, and we recognized that if I hurt you, I hurt myself, and that if I steal from you, I steal from me, and that if I cause pain to you, I cause pain to myself. We were all moving and there was no fear, no pride, no lies, no prejudice, no Democrats, no Republicans, and Richard in his bright green shirt, was smiling broadly.

As the circle continued and everyone felt their oneness with each other, and with Richard of course, I saw flashes of bright white light all around us – believe me, this would make a great music video! While we danced, Richard was on the far side of the circle and he said, "Don't cry for me." I said, "People are sad. Why not cry?" He said, "Don't cry. Just live better. Live your life, and be good. Live better and respect each other and be good to each other. Do that in my memory."

My meditation ended. I opened my eyes and realized I'd been very far away. In Richard's name, I thank every one of you for being a part of this wonderful circle.

LA County Animal Care grants girl's request for unicorn license -- if she can find one

LOS ANGELES -- A girl named Madeline, with a vivid imagination and re-markable awareness of how bureaucracy can dash dreams, got her wish when she asked Los Angeles County animal control authorities for a license to own a unicorn - if she's able to find one.

The first-of-its-kind permit came with strings attached, however: The mythical creature must be provided ample exposure to sunlight, moonbeams and rainbows

and have its horn polished at least once a month with a soft cloth.

Director Marcia Mayeda of the county Department of Animal Care and Control sent the girl a heart-shaped, rose-colored metal tag with "Permanent Unicorn License" emblazoned on it, along with a white fuzzy unicorn doll with pink ears, purple hooves and a silver horn.

The department's response came after the girl wrote it a brief letter last month: "Dear LA County, I would like your approval if I can have a unicorn in my backyard if I can find one."

Mayeda commended the girl for her "sense of responsible pet ownership to seek permission in advance" and for thoughtfully considering "the require-ments of providing a loving home to animals."

The agency posted images of the correspondence, the license, the medallion and the stuffed toy on its social media accounts, with the girl's last name ob-scured. Its five conditions for unicorn ownership also require that any sparkles or glitter sprinkled on the animal be nontoxic and biodegradable, and that it be fed watermelon at least once a week.

HOW TO REDUCE YOUR MEDICAL BILLS

Dear Savvy Senior:

What tips do you recommend to Medicare beneficiaries dealing with hefty medical bills? My husband recently had open heart surgery and is recovering slowly, but the medical bills are coming in fast and furious and they're putting us in medical debt. Struggling in Springfield



I'm sorry to hear about your billing struggles, but medical debt has unfortunately become a chronic problem in this country. According to U.S. Census data 19 percent of Americans households carry medical debt, including 10 percent of households headed by someone 65 or older. Even seniors on Medicare can easily get snagged in a web of complicated billing and coverage problems.

To help you slash your medical bills, here are some tips recommended by health care experts that you should try.

Double check your bills: Almost half of all medical bills contain at least one error, including duplicate charges or charges for services you never received. If you're facing a high bill and are on the hook for some portion of it, request itemized invoices from the hospital and other providers that detail everything you were charged for and go through them line by line. If you find something you don't understand or find fishy contact the provider for an explanation or a correction.

Wait for your EOB: Doctors' offices and hospitals may mail initial bills to you before they even submit them to your health insurer. So, hold off on any payment until you receive an explanation of benefits (EOB) from your provider – Medicare, supplemental Medicare, Medicare Advantage, or private insurer. This will show what you owe after your insurance has paid its portion.

If your EOB shows that your insurer is refusing to pay for services that you think should be covered, call them to see whether it's a correctable mistake, such as a coding error for a certain test or treatment. If it's truly a denial of coverage, you may need to file an appeal. For details on how to file a Medicare appeal, see Medicare.gov/claims-appeals/how-do-i-file-an-appeal.

Ask for a discount: Call the hospital's accounting office or the billing staff at your doctor's practice and ask if they can reduce your bill. You'd be surprised how often this works. Or if you have the funds to pay the entire bill, ask the hospital or provider for a "prompt pay" discount which may save you 15 percent

If it's best for you to pay your bills over time, ask the billing office to set up a no-interest payment plan for you. It's in the provider's interest to work with you to obtain payment.

You can also call the hospital where your husband had his surgery and ask a billing specialist if the facility offers financial assistance. According to the American Hospital Association, about half of U.S. hospitals are nonprofit. This means they are required to offer free or discounted services in some instances. This is usually reserved for low to moderate income patients who have limited or no health insurance, but requirements vary from hospital to hospital.

Get help: If you've gotten nowhere on your own, contact the Patient Advocate Foundation (patientadvocate.org, 800-532-5274) who can help you understand and negotiate your medical bills, free of charge. Or consider hiring a medical billing professional to negotiate for you but be aware that these services can cost upward of \$100 an hour. You can find potential candidates through the Alliance of Professional Health Advocates (advoconnection.com). Be sure to choose someone who is credentialed by the Patient Advocate Certification Board.



The only time I can remember going to a clothing store with my mother, (it was Robert Hall in North Hollywood), was to purchase a sports jacket prior to my Junior High School graduation. I remember getting nauseous in the store and fleeing. A brown Sports jacket came home with us and I wore it at the graduation. At that time I can recall worrying whether it was appropriate as other students compared the labels of their coats differentiating the quality of one coat from the other.

To this day I am generally unconcerned about the way I look and am annoyed when I am reminded how sloppy I appear because there are spots on my clothing or food spots on my face. Why does anyone else care---but they do. This brings me back to the question of presents. My long-suffering tolerant wife with her low expectations of me deserves a Christmas present. She always buys presents for the whole family and asks me to at least sign the cards which I grudgingly do. When we are thanked for the presents at later dates I rarely remember the gifts my wife picked out.

This is all humiliating! Soon I will be eighty or at least seventy-nine and if I am going to change "no time is like the present". That was one of my mother's favorite sentences. She was always doing things and buying

This week | presents especially for her mother. Now that I think of it, she continued to buy presents, dresses, for her mother even after her mother passed away. I am beginning to understand. My mother took great pleasure in doing things for others and buying and giving presents. Boy, was she selfish. She wanted to keep all that pleasure of shopping and buying and giving for herself. All that she ever asked of me was that I not rip my pants. (I'm kidding, you know)

I fear that I have given you a completely wrong picture of who I am or who I take myself to be. Recently, I was talking with a friend who complained about her grandchild's reluctance to clean her room. She asked if I was any good at cleaning my room and I explained that growing up I never had a room or shared one with anyone else. I slept on the living room floor, never picked out or had much interest in my own clothes and certainly never prepared a meal or turned on the gas range or the oven. There was no microwave in those years. Let's not be too dramatic; I did frequently open the pantry doors looking for ready-made snacks but I was never very good (and still am not) at opening packages. I, furthermore admit, that I was never instructed as to the proper use of knives and forks and still am not very good at

Now I have really depressed myself and almost want to go look in the mirror, which I rarely do, to try and assure myself that I am a worthwhile person. Really I know I don't have to do that. I was a good son who had no domestic responsibilities but was expected to be up at 5:30 in the morning to assist my father in our truck with early morning deliveries and then after-school fill the orders with merchandise from the wholesaler that we had picked up earlier. My mother took the orders from customers over the phone during the day and we survived. As my father gradually lost his vision he and I tried to keep it secret from the rest of the family and I did a lot of the driving and transported him to the eye doctor. I loved my family and knew they loved me and we were always a unit that survived and worked together. I always considered myself fortunate especially in comparison to my father and his mother and siblings who had escaped from the Ukraine barely ahead of a murderous pogrom.

Yes I am a fortunate one who will summon up the courage to go shop for a Christmas present for my deserving wife but for the moment I have misplaced my credit card. Maybe the Christmas Holiday will be cancelled --- no that would be unfortunate for

everyone—even me.
