#### THE CITY OF ANGELS

"A true angel is always looking out for others and sharing the kindness of Heaven with earth."

The sidewalks of Chicago were dirty that day, just as they exist most every day of the summer. My father and I were strolling down a busy section of city, as we both stepped over an old tarnished penny. I suppose no one had given much thought about the penny, and certainly not enough to kneel down to insert a worthless copper piece into their pocket. I do not know why my father spoke. Maybe it was one of those personal thoughts he was asking himself out loud, maybe he want me to think about the value of money and that even a penny contained worth as it was earned by another person's work, or maybe it was a combination of many things. "I do not know if I would reach down to pick up a dime," he mysteriously spoke into the air. There was nothing more he added, and I noticed an expression of disappointment in his face. I did not argue with his thinking. The sidewalk was trampled by shoes, and a full sterilization would be required for any object one dared to touch.

The poignant pen of William Shakespeare famously wrote, "The eyes are the window to your soul." We habitually forget our conversations with people, but when we meet a unique pair of eyes, we seem to remember them. One of the most decorated covers of National Geographic is of a young nomadic girl with her deeply curious eyes. Without a single word, her powerful story is compellingly spoken.

I have always been interested in knowing where angels are physically found, for certainly, they are all around us. During the holiday season, it is part of the Christmas story. An angel visits Mary and Joseph, and as the shepherds are tending their flocks by night, down into their camp enter the angels, announcing the birth of Jesus. "The Good Book" is filled with stories of angels, and there are times when angels are described as walking amongst us, observing our deeds. That echoes true to me, for the one aspect foreign to an angel of Heaven would be an imperfect world such as ours. Since we, and the visiting angels to Earth, have an important partnership in the work of Heaven.

It is a fascinating idea to imagine that angels learn something from us, and in certain circumstances, are given the power to assist. There are many times I have been in need of help. I have often thought God stationed a personal angel over me to observe the assistance and protection I required. The day will arrive when we shall all know the physical characteristics of an angel, but until that eternal moment of time, I do believe it

is in the eyes.

I was both blessed and cursed to have a job where I could arrive in the early hours of the morning. Los Angeles is almost empty at 5:00 a.m., and one encounters a different face of the city at that time of the day. The automobile traffic is light, the sidewalks are vacant, and the hustle and bustle of society is still slumbering in bed. I was only a couple of blocks away from work as I exited the freeway. A gentle looking homeless man was off the curb, in the street. I could see an emptiness in his face, as though life and all of its joy and meaning were erased, and what remained were the great burdens carried alone without family or love. As I sat at the red light, I watched as he stared off into an invisible place and time that I could not fully see, where the hardships of life actively haunted him.

The place he was occupying in the street, the tattered clothes that hung from his shoulders, the unshaven face of stubble, compelled me to think of him in a certain way, but even amongst the darkness of that winter morning, with only a dim light above, I was overcome by the bright and inviting light that radiated out from his eyes. They made me to think of Heaven. So I wondered, just maybe, this is an angel. I could not keep my mind off him that day, and I am sure I was supposed to say something to him - even if it was just a kind word to let him know that the world cared. I did none of that, much like the old penny of the street, so tarnished and dirty. I just stepped past" him and kept driving.

Many years later, upon a mouse-like quiet morning, I motored through Los Angeles in those early hours when the moon was still in sight. My office was in a different location now, so it altered my drive from freeway to the city streets. The windows of the donut shops and coffee houses had their usual suspects clinging to their cups of

I was five minutes past Dodgers stadium as I turned in the direction of Santa Monica and the mid-city Los Angeles area where I worked. It was a pleasant and fairly straight ahead drive from here, and soon, I would be settling into my of-fice chair. I had developed an odd habit of timing each of my trips going into work, and on some miraculous mornings, a vast succession of lights would flip to green as I traveled in some engineering feat that turned the city of stop-andgo into a journey down a country road. It was not uncommon, since the street I traveled on had two lanes on each side, to have another car glued to my door for several miles as we galloped through the city as one. So it was on this morning, block after block we went.





the other car took a small lead. Our industrial horse race sped past the houses, lights and buildings of the city. There was one section at the end of this drive that I feared. It is a poorly lit section of homes and the cross traffic would be traveling between 35-60 MPH, depending upon the driver. One morning, I arrived to see the hedges were destroyed, fully knowing what had happened. Massive rocks were placed around that house on that corner a few weeks later and about a year after, as I passed this intersection, a fresh accident, with two cars resting against the boulders. I told myself, if I should die in my car, it would be in this place on some quiet morning.

I was also very intrigued by this place because I felt a great sense of pain or pleasure depending on the color of the light. This particular morning, I arrived at the top of a small hill where the road gracefully bent and straightened before me. I was not far from work now -- it was the home stretch. A quarter mile into the distance, the intersection's light towered over the trees of the sidewalk. If it was already green, with the length of road I had to travel, I could not legally make the light. If the light was changing from red to green, however, I could catch the light with a second to spare.

On the mornings I made the light, I had a feeling of euphoric victory, having beat "my opponent." The other driver, still beside me, knew this as well, as he slightly darted a bumper ahead of me to make sure he would also catch the light. He looked into my window with those eyes of an angel, and then he stepped out of my way and onto the sidewalk. #### RICHARD (DICK) JOHNSON

October 25, 1931 - November 13, 2022

Richard Leroy Johnson, affectionately known as Dick Johnson, passed away November 13th, 2022 of Natural Causes. He was 91. He was preceded in death by his lovely wife Elva Johnson who passed in March of 2021. Dick had been a resident of Sierra Madre CA since moving his family there in 1964. He was currently a resident of the British Home in Sierra Madre.

Dick was born in Los Angeles CA on October 25th, 1931 to Mernie and Edna Johnson. He grew up in San Gabriel CA with his older sister Shirley and attended Alhambra High School. Dick had many memories of growing up in the San Gabriel Valley. One of them was during World War II, General Patton spoke at his Middle School to encourage children to buy war bonds. He grew up during the Depression, and he loved making his own toys. When he was old enough to drive, he saved his own money and bought a car. He loved working on cars and was known for making them lower and faster. At one time he was a regular at the Santa Ana Drag Strip now known as John Wayne Airport.

After serving in the Air Force during the Korean War, Dick went to school at San Diego State University to become an aerospace engineer. He worked full time while attending school in San Diego.

He married Elva Pickett of Sierra Madre August 7th, 1955. She was the love of his life and they were married 66 years at the time of her death. He worked at Convair in San Diego and he and Elva started their family there. In 1964, he got a job offer from Garret Air Research in Torrance CA so they moved to Sierra Madre CA on Montecito Ave where they lived until they moved to the British Home in 2014

While working at Garret, he worked on many of the Apollo Rockets and also the Space Lab Station. In addition, he worked on many military projects to make aviation safer for military personnel.

Dick was very involved in the community of Sierra Madre. He was Chairman of the Art Fair, President of the Historical Preservation Society, and a Library Board Trustee. In addition, he volunteered for the AYSO Region 2, coached Little League and Pony League teams and served on the Board of Trustees for the Sierra Madre United Methodist Church. Dick was named Sierra Madre's Older Person of the Year in 2014. He loved Sierra Madre! He donated to many different charities but his favorite was to help Veterans.

One of his true passions was working on the Montecito home that was designated a Historical Landmark. It was built in 1881 and was a Victorian 3 story home. It was built entirely of wood and required lots of love and care. Dick and Elva took much pride in keeping the home restored the entire time while residing there.

Dick is survived by his 5 children, Cristii Johnson Cox (Dave Cox), Kari Johnson Janzen (Tom Janzen). Heidi Johnson McAteer (Mike McAteer), Rick Johnson (Dianna Johnson), Jason Johnson, and 11 grandchildren, 8 great-grandchildren with one on the way. Dick and Elva raised their five children in Sierra Madre CA. Dick was very involved in his children's lives. He coached their baseball and soccer teams and always had time to play catch or help work on school projects. He was known in the neighborhood as the guy that fixed cars, motorcycles and bicycles. He loved working in his garage, making sculptures and painting art.





The City's Citizen Service Center (CSC) will also be closed Monday, Dec. 26, and Monday, Jan. 2. You can contact the CSC via the web or mobile app, or by calling (626) 744-7311. Requests submitted over the weekends will be monitored. City trash collection will occur as normal during Christmas week. There will be a oneday delay of trash collection during New Year's week.

Residents can drop off their Christmas trees Monday, Dec. 26, through Tuesday, Jan. 3, for recycling at Eaton Blanche Park (3100 E. Del Mar Blvd.) or Robinson Park (1081 N. Fair Oaks Ave.) between the hours of 7 a.m. and 2 p.m. Please remove all stands, ornaments and lights prior to drop-off. Curbside Christmas tree pickup will take place Jan. 3 through Jan. 13 on residents' regular pickup day.

Pasadena Transit and Pasadena Dial-A-Ride will not operate on Christmas Day or New Year's Day, Ian 1 On Monday, Ian Pasadena Transit will go into service around 1 p.m., after Rose Parade impacts have cleared. Please check PasadenaTransit.net more information.

All Pasadena Public Library branch sites will close today at 5 p.m. and will reopen Tuesday, Dec. 27. Library branches will again close Saturday, Dec. 31, at 5 p.m., and will reopen Tuesday, Jan.

The City's Permit Center will be closed Monday, Dec. 26, and Monday, Jan. 2.

All parks will be open for picnics, fun and play; however, no site reservations are being accepted for the holidays.

According to South Pasadena police, on Tuesday, December 13, at 9:51 p.m. officers responded to the 700 block of Mission Street for a report of Mission Street for a report of an assault with a deadly weapon involving a vehicle. An officer arrived on the scene within minutes and located the

The unidentified victim indicated he had just exited the northbound 110 freeway and stopped to use his telephone in a parking lot in the 700 block of Mission Street. While parked, the victim stated another vehicle pulled directly in front of him, blocking his path. The driver of the vehicle exited and approached the victim, accusing him of following him on the freeway. It appears that each party captured video during the dispute.

As the suspect was leaving the parking lot, he struck the victim with his vehicle. When the officer arrived on scene, the suspect had already left the area. At no time during the incident did the victim identify the suspect or indicate the altercation was anything more than coincidental.

On Thursday, December 15, South Pasadena Police learned the suspect involved in this case is believed to be a member of Elon Musk's security team. Detectives do not believe Musk was present during the confrontation.





#### NASA Retires InSight Lander Mission after Years of Science



*The mission has* concluded that the solarpowered lander has run out of energy after more than four years on the Red Planet.

NASA's InSight mission has ended after more than four years of collecting unique science on Mars.

Mission controllers at the Propulsion agency's Jet Laboratory in Southern California were unable to contact the lander after two consecutive attempts, leading them to conclude the spacecraft's solar-powered batteries have run out of energy - a state engineers refer to as 'dead bus."

NASA had previously decided to declare the mission over if the lander missed two communication attempts. The agency will continue to listen for a signal from the lander, just in case, but hearing from it at this point is considered unlikely. The last time InSight communicated with Earth was Dec. 15.

"I watched the launch and landing of this mission, and while saying goodbye to a spacecraft is always sad, the fascinating science InSight conducted is cause for celebration," said Thomas Zurbuchen, associate administrator of NASA's Science Mission Directorate in Washington. "The seismic data alone from this Discovery Program mission offers tremendous insights not just into Mars but other rocky bodies, including Earth.'

Short for Interior Exploration using Seismic Investigations, Geodesy and Heat Transport, InSight set out to study the deep interior of Mars. The lander data has yielded details about Mars' interior layers, the surprisingly strong remnants beneath the surface of its extinct magnetic dynamo, weather on this part of Mars,

and lots of quake activity.

Its highly sensitive seismometer, along with daily monitoring performed by the French space agency Centre National d'Études Spatiales (CNES) and the Marsquake Service managed by ETH Zurich, detected 1,319 marsquakes, including quakes caused by meteoroid impacts, the largest of which unearthed boulder-size chunks of ice late last year.

Such impacts help scientists determine the age of the planet's surface, and data from the seismometer provides scientists a way to study the planet's crust, mantle, and

'With InSight, seismology was the focus of a mission beyond Earth for the first time since the Apollo missions, when astronauts brought seismometers to the Moon," said Philippe Lognonné of

Institut de Physique du Globe de Paris, principal investigator of InSight's seismometer. "We broke new ground, and our science team can be proud of all that we've learned along the

way."

The seismometer was the instrument that remained powered on as dust accumulating on the lander's solar panels gradually reduced its energy, a process that began before NASA extended the mission earlier this year.

"InSight has more than lived up to its name. As a scientist who's spent a career studying Mars, it's been a thrill to see what the lander has achieved, thanks to an entire team of people across the globe who helped make this mission a success," said Laurie Leshin, director of JPL, which manages the mission. "Yes, it's sad to say goodbye, but InSight's legacy will live on, informing and inspiring."

All Mars missions face challenges, and InSight was no different. The lander featured a self-hammering spike – nicknamed "the mole" – that was intended to dig 16 feet (5 meters) down, trailing a sensor-laden tether that would measure heat within the planet, enabling scientists to calculate how much energy was left over from Mars' formation.


Designed for the loose, sandy soil seen on other missions, the mole could not gain traction in the unexpectedly clumpy soil around InSight. The instrument, which was provided by the German Aerospace Center (DLR), eventually buried its 16-inch (40-centimeter) probe just slightly below the surface, collecting valuable data on the physical and thermal properties of the Martian soil along the way. This is useful for any future human or robotic missions that attempt to dig underground. The mission buried the mole

to the extent possible thanks to engineers at JPL and DLR using the lander's robotic arm in inventive ways. Primarily intended to set science instruments on the Martian surface, the arm and its small scoop also helped remove dust from InSight's solar panels as power began to diminish. Counterintuitively, the mission determined they could sprinkle dirt from the scoop onto the panels during windy days, allowing the falling granules to gently sweep dust off the

"We've thought of InSight as our friend and colleague on Mars for the past four years, so it's hard to say goodbye," said Bruce Banerdt of JPL, the mission's principal investigator. "But it has earned its richly deserved retirement."





Dessert before dinner? Why not? I have said many times in our teachings here that if you like it, buy it. Over the holidays I hosted a wine seminar at the Whole Foods in East Pasadena. Our list of wines included champagne, sangria, chardonnay, and a petite sirah, with price points ranging from \$10 to \$50 (yes, that was the Taittinger Champagne). To my pleasant surprise the hit of the tastings was a Petite Sirah from San Simeon Winery.

If you recall last weeks article on "fruit forward" and "jammy", a petite sirah is often a perfect starter wine for those just learning about wines, or those who might want an alternative to cabernet. Prices can range from \$8 to \$30 for a bottle. At \$18 for the San Simeon Sirah, this Orange County Fair gold medal winner is a great value in my book. It is indeed a bit jammy, but that is perfectly acceptable with grapes that are aged well. Petite sirah grapes were first introduced in France in the 1800's, but really never caught on partly due to the high humidity in Rhone. Here





I was waiting in line to buy something at Target, and the friendly checker asked the man ahead of me if he was ready for Christmas. It was a cheerful and innocent question. After all, in December in the United Stated, it does seem like getting ready for Christmas is the number one dominant activity, and it's the reason that lines in all the stores are long and why you cannot easily find parking.

"No, I don't celebrate Christmas," the man responded, and then he went on to explain how much money he saves by not observing "all that silly stuff." I did overhear enough to hear that he was single, and then he walked on. I wondered if that was the real reason he didn't observe Christmas. He could have been a Jehovah's Witness, Jewish, Muslim, Buddhist, or any of the other dozens of religions and sects which don't observe the Christian Christmas holidays.

Though I have both fond and depressing memories of the Christmas season growing up, I have worked through all the mish-mash of symbols that have gotten thrown into the Christmas motif, and I regard them as generally uplifting. I have long ago ceased my mindless Christmas card-sending and gift-giving out of some sense of social obligation, but I still immensely enjoy special times with friends and families in what is the darkest time of the year.

Many years ago, I was asked by a local non-profit to share at a Christmas event the "real meaning" of Christmas. Even after I agreed to do this, I wondered to myself: How can I do that? How can I be sure that I've really got it? How will I know whether or not I'm right?

My job was to discover what all the symbols and practices of Christmas mean, and how we might best realize and vivify those meanings during this time. Needless to say, it was a tall task.

I found that the best way to share my research was to be honest, explaining my background, how I went about my research, and what I personally concluded.

I explained how I grew up in a Catholic family, and was taught that Jesus was born on December 25, which is obviously why we celebrate his birthday on that date. So I had to begin my presentation with the man who is at the center of Christmas, Jesus. It turns out that all historians agree that Jesus was not born on December 25, but rather in May or September, probably in the year 6 B.C. by our current reckoning. Not only that, many of the modern symbols and practices of Christmas-time actually pre-dated Jesus, and were celebrations of the Winter Solstice by the people that Christians called "pagans."

So then I had to stop and define "pagans." Originally people outside of the strong influence of Roman power were called the pagani, country folk, a term that had no religious overtones in the beginning. Eventually it became a term of derision, meaning non-Christian, for the people who practiced the old religion of Mithraism.

In the time of Jesus, there were many religions and gods and Gods, and they didn't all get along. Jesus, as everyone knows, was a practicing Jew, and observed the Jewish holy days. After the crucifixion, his followers carried on the message of

> None of this is new, of course, and these details can be found in any encyclopedia, including such tomes as The Golden Bough, and Manly Hall's Secret Teachings of All Ages.

> So why do we celebrate Jesus' birth on December 25, when we know that the early Judaeo-Christians didn't celebrate Jesus' birthday at all?

> Most ancient religion is astronomy-based, and draws great symbolism from the cycle of the earth around the sun. The winter solstice is the day of the least light, from which the days have increasingly more light. The birth of the sun has long been anthropomorphized into the birth of the sun. Jesus wasn't the first to be commemorated with the winter solstice. Mithra, born of a virgin mother in a cave, was said to be born on December 25. Nimrod from Babylon was also said to be born on December 25, as was Osiris, Quetzalcoatl, and others.

> The new religion of Christianity was still struggling in the 4th century, and its adherents were still being persecuted for their faith when Constantine became the emperor. Constantine also converted to Christianity. In his attempt to unite his kingdom, he made Christianity the official religion, and he Christianized all the so-called pagan commemorations. As a result, the birth of the Sun that was already commemorated by the Mithra-pagans was now going to commemorate the birth of the Son, Jesus.

> Some of the symbols that have been adopted into the Christmas season are universal symbols of eternity, life, and light, symbols such as wreaths, evergreens, the tree, lights and candles, the giving of gifts, the virgin birth, and birth in a stable.

> Santa Claus was based on a very real Catholic bishop named Nikolas of Myra (modern day Turkey) who gave gifts during the winter and the newly-established Christmas season. He was born in March 15, 270, and actually participated in the First Council of Nicaea in 325, the famous council where early church doctrine was argued and decided. He died on December 6th, 343. This generous bishop was remembered for the gifts he gave, and his image was severely watered-down over the years by Coca-Cola and others who used him in their advertising.

> It's correct that many people have been turned off when they learn of the roots of modern Christmas. Some even find all this depressing. But I am not like the man in line ahead of me at Target. I'll still observe the Christmas season, and I enjoy the lessons that are buried within all these

Can I say that today I know the "real meaning" of Christmas? I have come closer to experiencing the universal "magic" of Christmas in my personal life, year by year, and I feel that this is an on-going process, where there are always more nuances to be learned. I never get tired, for example, of watching Capra's wonderful Christmas movie, "It's a Wonderful Life," and watching Jimmy Stewart confront the meaning and purpose of his own life, and the value of true friendship. Though he had nothing to give others that fateful year, it turned out his greatest gift was the service he'd done for so many in the town.

And for this reason, I have long felt that "It's a Wonderful Life" expresses "the real meaning" of Christmas: slow down, breathe, recognize the higher power, and acknowledge your friends and family who are the real gifts in your life.

#### SIMPLE HOME SAFETY SOLUTIONS FOR AGING-IN-PLACE

Dear Savvy Senior: Falls and fires are the two things I worry most about for my elderly father who lives alone. Do you have any suggestions on what we can do to help keep him safe, and keep an eye on him from afar? Concerned Daughter

Dear Concerned:

Of course! There are a number of small adjustments and modifications you can make to your dad's home to help protect him from falls and fires, both of which cause thousands of injuries and deaths each year. Here are some tips to get you started.

Eliminate tripping hazards: Since falls are the leading cause of home injury among seniors, a good place to start is to pack away your dad's throw rugs which are common tripping hazards or use carpet tacks or double-sided tape to secure them. You may also need to adjust your dad's furniture so there are clear pathways to walk through and position any electrical or phone cords along walls and out of the

For hardwood steps, consider attaching a nonslip tread to each one to provide traction and help him see the edge. And for added protection in the bath-room buy some nonskid rugs for the floors and use adhesive nonslip treads or a mat with rubber suction inside his tub or shower stall.

Improve his lighting: Good lighting is essential for safe aging-in-place, so check the wattage ratings on your dad's lamps and light fixtures, and install the brightest bulbs allowed, and add supplementary lighting if necessary.

You should also purchase some dusk to dawr nightlights for the bathroom and in the hallways that light up when the sun goes down. And mount some motion sensor lights outside the front and back doors and in the driveway that automatically come on when he comes and goes after dark.

Get grab bars: These can significantly reduce his risk of bathroom falls. Install them where he enters the shower or tub and on a wall inside the stall, but don't use grab bars that attach with suction. Instead, have wall-mounted bars put in by someone who can affix them to the wall studs. It's also best to choose bars whose surfaces are slightly textured and easier to grip.



Ensure railings are stable: Wherever he has steps – stairways, entryways or basements - he needs sturdy railings. Ideally, they should be on both sides of the steps.

Prevent cooking fires: There are several affordable products you can purchase to help your dad prevent home cooking fires like BurnerAlert discs that attach to a stove's knob and will continuously blink or beep after the stove has been in use for a preset amount of time, and Ome smart knobs that can control a stove's heating settings from an app. Or you can invest in a more expensive iGuardStove sensor that shuts the stove off when it doesn't detect motion for five minutes.

Install smoke alarms: Install a smart smoke alarm in your dad's house (buy one for each floor) that will alert him when smoke or carbon monoxide is detected. These smart devices will also send alerts to your phone to let you know when a problem is detected. Google Nest and First Alert both smart smoke and carbon monoxide detectors.

Add fire extinguishers: Get portable multipurpose fire extinguishers for each level of your dad's house and in the garage.

Consider a medical alert: To ensure your dad's safety and provide you some peace of mind, consider getting him a medical alert device that comes with a wearable SOS button that would allow him to call for help if he were to fall or need assistance.

What I've discovered in helping my clients preserve their whole legacy, is that we can learn so much more than expected -- about ourselves and our loved ones - when we ask the right questions.



Around this time of the year, The Gracious Mistress of the Parsonage and I revel in our family memories. Unlike me, she has some wonderful memories because of her large



people. We are being torn apart and we know that a nation divided cannot long stand. Our culture is running amuck. So many of our

young people are depressed and disoriented and not even sure what they are or want to be.

So many of our kids are being harmed by the decisions they make now — when the true blessing of a young life is to flourish and grow and become what God intends you to be.

I will soon experience my 60th Christmas on Earth and my childhood was immersed in so much more clarity and simplicity.

We didn't have an abundance of material things, but we had a lot of laughter and joy and, thanks to the nuns at St. Germaine Catholic School, tremendous clarity.

The good nuns taught us that there is order in our conflicted universe — that there is good and bad, and that they're at battle everywhere, every day, in every heart.



They taught us we have the free will to choose our direction, good or ill.

We were taught to pray to align ourselves with good and order and to root out dishonesty and nastiness from our beings.

The virtues were pounded into our developing minds and we had better learn to embrace and master them: prudence, temperance, courage and justice.

We were taught that as we strive for good, we must fend off bad behavior: excessive pride, envy, gluttony, lust, anger, greed and sloth.

That is what I am focusing on as we celebrate the Christmas season. I am praying for those I love, my neighbors, my country, my world.


I don't know what impact I will make, but hope is all I have. And I'll give it everything I've got.

At about 10pm the British heard the Germans singing Christmas Carols. The British started to sing along. The British then heard confused shouting from the other side. They heard the voice of an enemy soldier, speaking in English saying, "Come over here."

One of the British Sergeants answered "You come half way...I come half way". And what happened next was nothing short of miraculous.


Enemy soldiers, on both sides climbed nervously out of the trenches and met with handshakes and words of kindness. The soldiers traded songs, smokes, and wine. It wasn't just on one battlefield. Cease-fires across the Western Front involved British, French, German, and Belgian troops laying down their guns and meeting the enemy halfway across the battlefield. One German soldier's diary described a British soldier setting up a makeshift barbershop and giving German soldiers haircuts for a few cigarettes. Even reports of makeshift soccer games breaking out on the same battlefield they were fighting on hours earlier.




