CITY COUNCIL APPOINTS THREE **NEW MEMBERS TO PLANNING COMMISSION** By Kevin McGuire

After weeks of significant rainfall in Southern California, conditions improved just in time for the first City Council Member meetings of 2023.

Regular Meeting: Tuesday, January 10

There were some new roles, new faces, and a full agenda for the first day back before a minimum crowd Tuesday evening. Edward Garcia took the center seat as the new Mayor of Sierra Madre, with Kelly Kriebs taking on the new role as Mayor Pro Tem. With a successful campaign, Kristine Lowe fills the seat vacated by long-time Council Member and former Mayor Rachelle Arizmendi. Council Member Robert Parkhurst returns to his role, while the longest-standing Council Member, former Mayor Gene Goss, returns to begin his ninth year serving this community.

One of the first orders of business for the new Council was to fill current and anticipated vacancies on The Planning Commission. On June 30, 2022, Commissioner Bob Spears completed his second full term, but due to the absence of any applications to fill the vacancy, Mr. Spears served a partial term which ended on December 31, 2022.

In addition, Commissioner John Hutt will finish his second term on June 30, 2023. Therefore, a new Commissioner is needed to fill Hutt's seat by

Four applications have been received to fill these two positions. Those

candidates are: Joe Catalano

Mr. Catalano, a 32-year resident, served on the Planning Commission from 2017-2020. He is an adjunct professor of Urban Planning at Cal Poly Pomona and was nominated to the College of Fellows at the American Institute of Architects.

Christine Moran

Dr. Moran ran for Sierra Madre City Council during the 2022 campaign. Her background includes engineering, science, and management. She is the engineering manager for the Data Pipeline and Planet Labs. She has lived in Sierra Madre for three years.



Patrick Simcock

Mr. Simcock has spent 49 years in Sierra Madre and has served on the UUT Oversight Committee and the Sierra Madre Community Foundation board. In addition, Mr. Simcock worked as an engineer and a commercial property loss prevention consultant.

Yong Yoo

Mr. Yoo has worked as an architect for PBK serving California Schools for over 25 years. He has served on the Design Review Board for the City of Glendale and the Design Review Commissioner in Pasadena. Mr. Yoo went through the process and built his own home in Sierra Madre, where he has resided for five years.

All applications to fill Board vacancies are forwarded to the City Council for review and recommendations. According to the staff Agenda Report, the appointment of an applicant to the vacant position requires a major-

Two of these candidates, Dr. Christine Moran and Patrick Simcock, appeared in person and had a chance to speak before the Council. Dr. Moran spoke first. "I am interested in bringing an unbiased, neutral, scientific lens to thorny community issues as we try to balance our needs for housing, environmentalism, upcoming California regulations, and the priorities of current community members," Moran said.

Patrick Simcock highlighted his work as an engineer and his present job of 15 years. "I currently work as a high-hazard property loss prevention consultant where I regularly need to understand and apply fire and safety codes," Simcock stated. "I feel that working with many codes on a frequent basis will help bring additional expertise and insight to our commission."

All Council Members agreed that Mr. Simcock was the best candidate to fill the immediate opening to replace Bob Spears. But, picking a second candidate to replace John Hutt in July took more work. Council Member Lowe went with Dr. Moran, but Council Member Parkhurst couldn't pick a clear choice between Dr. Moran and Mr. Yoo. Council Member Goss seemed to favor both Moran and Yoo but leaned more toward Dr. Moran, while Mayor Pro Tem Kriebs, who encouraged Dr. Moran to seek a commission spot, felt Yoo was more qualified for the Planning Commission role. Mayor Garcia and Kriebs both voiced that Dr. Moran should continue to seek a commission position.

Mayor Garcia appointed Simcock and Yoo to the two open positions. The Mayor also praised Bob Spears for his service, which triggered a round of applause from the audience. Spears was present. "You are a treasure to this town," Garcia said.

Special Council Meeting: Wednesday, January 12

After filling two vacancies on the Planning Commission during their regular Tuesday night meeting, the City Council was back in session on Wednesday to fill an unexpected vacancy after Peggy Dallas resigned her seat, citing health reasons. Dallas, who started her first term on the Commission in 2021, was the only architect in the group of five members. Yong Yoo, appointed on Tuesday to fill John Hutt's seat in July, is also an

Staff suggested that Yoo's appointment start immediately to fill the seat left by Dallas and to look toward the two remaining candidates, Joseph Catalano and Dr. Christine Moran, to possibly fill John Hutt's seat on July 1, 2023. Mayor Garcia agreed and initiated a vote to immediately appoint Yoo to take Dallas' seat and Dr. Moran to take Hutt's seat. The vote was unanimous.

DENNIS LEE MARQUARDT April 8th, 1943 – December 30th, 2022

Dennis Lee Marquardt passed away with family at his side after a prolonged series of health issues on Friday, December 30th, 2022. He was born in Pasadena, CA on April 8th, 1943. He moved to Covina at the age of 8, where his father, LeRoy, started the Covina Little League.

While growing up, Denny played youth baseball, American Legion baseball and other youth sports, making a name for himself as a stellar athlete even before enrolling

There he starred as a four-year letterman in both baseball and basketball. Excelling in these sports, he was named to numerous All-CIF teams in both sports. After graduating from Covina High School, Denny signed a baseball contract with the Los Angeles Dodgers, where he played outfield for five years. During the off season, he would return home to Covina and take courses at Cal Poly Pomona, keeping his promise to his

the off season, he would return home to Covina and take courses at Cal Poly Pomona, keeping his promise to his mother that he would get his degree.

After his years with the Dodgers, Denny finished his studies at Cal Poly Pomona and received a Bachelor of Science degree in Physical Education. He then received his teaching credential from Pepperdine University and later his Masters in Education. Denny started teaching at Temple City High School in 1968, where he taught Health and Safety and Drivers Education to every incoming freshman for 35 years. In 1970 Denny met Clare Collins. an English teacher at TCHS who would later become lins, an English teacher at TCHS who would later become his wife for the next 45 years. Denny coached a year of basketball at TCHS before being named the head baseball coach in 1971, a position he held for 27 years until 1997. As the Varsity baseball coach, his teams were, year in and year out, among the best in Southern California. In 27 years, his teams made 20 CIF playoff appearances and won ten Rio Hondo League Championships.

Denny amassed 398 wins as the head coach and was recognized with induction into the San Gabriel Valley Coaches Hall of Fame. His jersey, Number 7, is retired at Temple City High School, and just recently the school's baseball facility was named Dennis Marquardt Stadium honoring his 27 years of dedication to the baseball program and the young men he coached along the way.

Denny was a very involved dad from the get go, doing

his best to attend his sons' sport-ing events and his daughters acting/ singing performances. He built their family home to be one where they could entertain, as well as, where all their kids' friends were always welcomed. He even went so far as to add a basketball hoop to the neighborhood cul-de-sac so kids had a place



to go play or let off some steam. He always supported youth in their endeavors and always told his kids to dream big. Denny never met anyone he didn't like and always wore his heart on his sleeve. He dreamed big and he loved big.

Dennis and Clare resided in Sierra Madre for the past 48 years and to the end of his days still maintained "it was a best place to reise you kids and live. I love this town."

Dennis was predeceased by his wife, Clare Collins Marquardt, and son, Michael Marquardt and his parents, LeRoy and Helen Marquardt. He is survived by his sister, Janis Marquardt, children Katherine Marquardt, Martin Marquardt (Mary), Andrew Marquardt (Karen); grandchildren Calvin, Camille and Kennan, his brother-in-law, Charles Collins, sisters-in law Sharon Collins and Otilia Charles Collins, sisters-in law, Sharon Collins and Otilia Collins, nine nieces and nephews, and twelve grandnieces and grandnephews.

PATRICK **NEILAN**

Patrick Jon Neilan passed away peacefully December 22nd, 2022 after a short and quickly progressing cancer diagnosis. He was surrounded by his children and in the comfort of his own home, just as he had wished. Please join us in remembering and honoring the life of our beloved father on Saturday, January 28th, 2022 at 10:00am at St. Rita Catholic Parish in

Sierra Madre.

Born on July 3rd, 1947 to Bernard & Blanche Neilan, Patrick was number nine of eleven children. He grew up in the small farm town of Faulkton, South Dakota and as a farmer's son, learned the lessons of hard work at a young age by waking up at dawn to tend to cattle At 18 years old, he enlisted in the Viet-& crops. nam war. He boarded a troop carrier in December of 1966 and spent the next 29 days at sea before arriving in Vietnam in January of 1967. He served under the 523rd Engineer Company operating heavy equipment and was one of five soldiers that would go around fixing blown out bridges. He made 5 ranks in 16 months earning his way up to an E5 Specialist. In January of 1968, one of the deadliest times in Vietnam, Pat extended his time by 30 days before returning home in February of 1968.

Upon returning home from Vietnam, Pat secured a job in Minneapolis as an inspector before moving to Los Angeles in 1969. This transition from war to civilian life back home was a very difficult period for him. Alcohol became his crutch as he readjusted to life after the war. Over the next few years, Pat attended night school at Pasadena City College and received straight A's earning his associate degree. He got sober in 1973 after his participation in AA and from what he described as a power greater than himself. He would remain sober the rest of his life and attributes his 49 years of sobriety to his

faith and trust in God. In the years afterwards, Pat would drive up the coast to Big Sur to find peace and quiet. He would visit New Camaldoli Hermitage that overlooks the vastness of the Pacific Ocean to spend time in a place where all visitors were required to take a vow of silence. He further developed his connection to God and spoke fondly of the calmness and serenity he felt while there.

In 1974, Pat spent time as an ironworker helping build the 210 freeway. A freeway that would be well traveled by him through his many years in Southern California, specifically, Monrovia and Sierra Madre. He received his general contractor license in 1979 and would go on to remodel many projects and later build a home for his young family in Monrovia, CA.

His life changed forever when he became a father in 1985, welcoming his first son, Cody Patrick. Not long after, in 1986 his second son, Thomas Ryan was born. In 1989, his family was complete by the birth of his daughter, Molly

Pat's greatest gifts were his children but his greatest loss was losing his son, Cody, to Leukemia in 2005. Cody's death devastated Pat as it would any parent. He used to go to the cemetery to grieve and be close to Cody up to three times a day shortly after his passing. In the recent months prior to Patrick's passing, he remarked to Thomas and Molly the following: "I've been able to witness the miracle of life through the birth of all of you. And I learned how fragile and vulnerable life is when Cody became sick. And through Cody's death, I learned what a gift life is - what a gift it was to be his father and to continue being yours"

Pat was many things; a builder of homes and highways, a thoughtful and attentive neighbor, a serving patriot, a caring Brother and Uncle, a loving Father, and a wonderful Grandpa. His family loved him dearly, they miss him immensely and will carry on holding his words close. "Life is not to be taken for granted - it's an experience and it's not to be endured. Go for the gusto and really make the most of it."

NASA/JPL's Lunar Flashlight Team Assessing Spacecraft Events & Programming



The mission is characterizing its new "green" propulsion system and developing a modified plan for the briefcase-size satellite's journey to the

NASA's Lunar Flashlight mission successfully launched on Dec. 11, 2022, to begin its four-month journey to the Moon, where the small satellite, or SmallSat, will test several new technologies with a goal of looking for hidden surface ice at the lunar South Pole. While the SmallSat is largely healthy and communicating with NASA's Deep Space Network, the mission operations team has discovered that three of its four thrusters are underperforming.

The mission team, which first observed the reduced thrust three days after launch, is Propulsion working to analyze the issue and provide possible solutions. During its cruise, Lunar Flashlight's propulsion system has operated for short-duration pulses of up to a couple seconds at a time. Based on ground testing, the team thinks that the underperformance might be caused by obstructions in the fuel lines that may be limiting the propellant flow to the demonstrate this technology

The team plans to soon operate the thrusters for much longer durations, hoping to clear out any potential thruster fuel line Earth orbit. obstructions while carrying out trajectory correction maneuvers that will keep the SmallSat on course to reach its planned orbit around the Moon. In case the propulsion system can't be restored to full performance, the mission team is drawing up alternative plans to accomplish those maneuvers using the propulsion system with its current reduced-thrust capability. will employ an energy-efficient near-rectilinear halo orbit, taking it within 9 miles (15 kilometers) of the lunar South Pole and 43,000 miles (70,000 kilometers) away at its farthest

Only one other spacecraft has employed this type of orbit: NASA's Cislunar Autonomous Positioning System Technology Operations and Navigation (CAPSTONE) Experiment mission, which launched in June 2022 to a different nearrectilinear halo orbit, the same one that is planned for Gateway. CAPSTONE also experienced difficulties during its journey to the Moon, and some of the NASA teams who helped the SmallSat reach its planned orbit are lending their expertise to help resolve Lunar Flashlight's thruster issues.

Managed by NASA's Jet Laboratory Southern California, Lunar Flashlight is the first interplanetary spacecraft to use a new kind of "green" propellant, called Advanced Spacecraft Energetic Non-Toxic (ASCENT), that is safer to transport and store than the commonly used propellants such as hydrazine. One of the mission's primary goals is to for future use. The propellant was successfully tested with a previous NASA technology demonstration mission in

Other systems on Lunar Flashlight are performing well, including the neverbefore-flown Sphinx flight computer, developed by JPL as a low-power, radiationtolerant option for SmallSats. Also performing as designed, Lunar Flashlight's upgraded Iris radio - which is used to communicate with the Deep Space Network – features a new precision navigation capability that future small spacecraft will use to rendezvous and land on other solar system bodies. Portantino comments on the Governor's California Budget

Senator Portantino Excited by Film & TV Tax Credit Extension

Senator Anthony Portantino released the following statement regarding Governor Newsom's 2023-24 State Budget proposal:

As we look to the future and see uncertain economic times, I applaud Governor on his budget proposal, which makes key investments taking into consideration the economic uncertainty Californians are facing. The 2023-24 State Budget proposed today is just the beginning of the budget process that will include negotiations with Legislature, but I am pleased with the steps the Governor has taken.

I am excited and encouraged that the Governor has taken the opportunity to support two items in his budget that I have been working on. First, the budget proposes to provide \$15 million for the purchase and installation of commercial dishwashers at schools to address singleauthored Senate Bill 1255, a bill that was sponsored by Coalition and would have created a grant program for schools to do just that. This funding will help schools with the upfront costs associated with the purchase and installation of this important effort.



ALL ARCADIA UNIFIED ELEMENTARY SCHOOLS EARN HISTORIC ACCLAIM IN CALIFORNIA'S COVETED 2023 DISTINGUISHED SCHOOLS PROGRAM

This dashboard system is comprised of CDE-specified state indicators, which include assessment results, chronic absenteeism, suspension rates, and socioeconomic data.

"This state distinction signifies how our world-class team of educators, counselors, staff, board members, and administrators continuously work together, no matter the circumstances, and partner with our wonderful students and families to find collaborative, creative, and meaningful strategies to support the successful academic and social-emotional development of our students," said Dr. Forsee. Arcadia Unified's six elementary schools and Rancho Learning Center will hold their California Distinguished School titles for the next two years, as the CDE recognizes elementary schools in alternating years from the state's secondary schools. In the past, all of Arcadia Uni-

fied's middle schools, Dana, First Avenue, and Foothills, have also been recognized at least once as California Distinguished Schools, and last yeast, Arcadia Unified's Foothills Middle School was named a 2022 National Blue Ribbon School by the United States Department of Education.

"California Distinguished Schools represent examples of not just excellent teaching, learning, and collaboration, but also highly successful, data-driven school efforts ranging from professional development for educators to mental health and social-emotional wellness strategies to address the needs of students and families," said State Superintendent of Public Instruction Tony Thurmond. "Their innovation and hard work have helped to ensure their students can heal, recover, and thrive—even in the toughest times."

2023 California Distinguished School honorees will receive official recognition in a CDE-hosted awards ceremony on Feb. 16 at the Disneyland Hotel in Anaheim. AND A HAPPY NEW YEAR TO YOU

We all know restaurant locations throughout Sierra Madre and Pasadena that seem to turn over every fall. I have heard the word "cursed" used for several locations many times. For instance, the location on the corner of San Gabriel and Colorado seems to be one that is cursed for sure – it started as the Vault, then it became Rio Rio, then Ta Vu, and then a sushi joint (which I actually loved because the prices were right) then it became a chicken wing restaurant. Well, I love wings so let's see what happens next. For another "cursed" location, remember Jerry's Famous Deli in Old Pasadena? Let's name all the restaurants that went through that location: Union Cattle Company, Pasadena Brewing, Brix, Haven Gastro Pub... and it started as a gym! I just drove by on Rosemead where Robin's BBQ was, its now pretty much a shell, could there be something new in the works? I even hear that Burger Continental has been leased, so what's next there?





When talking to owners, they often point the fingers at the landlords saying the rents are too high. The excitement and the confidence of "I'll do it better" might be too strong of a lure for restaurateurs to handle. I was bewildered that El Chollo moved from Fair Oaks (Old John Bull) to the Paseo. As the building sat empty for a few years, I thought isn't some rent better then no rent at all? Celebrity Chef Rocco said on his TV show that the mortality rate for restaurants is 90% the first year. My father said he'd rather have open heart surgery than own a restaurant.

Let's look at this fact: the survival rate is higher then 10%, and these numbers are not specific to our area. Several years ago, researchers at Cornell University and Michigan State University conducted a study of restaurants in three local markets over a 10-year period. They concluded the following: after the first year, 27% of restaurant startups failed; after three years, 50% of those restaurants were no longer in business; and after five years 60% had gone south. At the end of 10 years, 70% of the restaurants that had opened for business a decade before had failed. Those are far different numbers than the 90% first-year failure rate quoted by our television star chef. Another academic research study concluded that 81.4% of all small business failures result from forces within the control of the owners/managers. The bottom line is that even if the failure rate is a little daunting, failure is not inevitable.

ASSESSOR JOINS FORCES ON FRAUD ALERT SYSTEM

County Combined Effort Launches e-Notification Program

LOS ANGELES, CA – Los Angeles County has come together to launch an innovative program that will keep homeowners advised when activity occurs on an individual's property by using registrants' email addresses.

The Property Owner e-Notification Alert (e-Notification) is an extension of the County's existing Fraud Notification Program, which informs property owners of recorded activity on their property.

The Los Angeles County Assessor's Office along with the County Registrar-Recorder/County Clerk and the County Dept. of Consumer and Business Affairs have joined forces to offer this innovative tool that expedites the notification process to a property owner using their registered email address. Owners can register at the Assessor's website at https://assessor.lacounty.gov/.

"Along with being notified by regular mail within 5 to 30 days on activity on a person's property, now that property owner will be notified within 48 hours by email as long as they are registered," said Assessor Jeff Prang. "This is another tool to try and deter fraudulent activity by some unscrupulous individual trying to take advantage of a property owner."

Currently, the Registrar-Recorder/County Clerk mails fraud notifications directly to homeowners and renters within 30-days when a Grant Deed, Quit Claim Deed or Deed of Trust has been recorded on their chain of title, or, within 5-days, when a Notice of Default, or Notice of Sale is recorded to advise the property is subject to entering foreclosure. As of Jan. 5, in addition to receiving paper copies via US mail, an email will be sent within 48 hours to the E-Notification registrant of a recordation of an aforementioned document and will include a statement advising about the recording on their property.

"We are excited to be in partnership with the Assessor and the Department of Consumer and Business Affairs to provide direct digital notice to e-Notification Registrants when a transaction has been recorded on a property," said Dean C. Logan, Los Angeles County Registrar-Recorder/County Clerk. "Providing notification to e-Notification Registrants when a recording takes place ensures they remain informed and can take immediate action, if needed, to protect against malicious or fraudulent activity."

To enroll for e-Notification, you will need to create a profile on the Los Angeles County Assessor's portal at assessorportal.assessor.lacounty.gov and opt-in for e-Notification. Most important, if a property owner has any questions about the notification received, or believes a recorded notice is suspicious, they should contact the Dept. of Consumer and Business Affairs at (800) 593-8222, or by email at homehelp@dcba.lacounty.gov.

"We are excited to partner in the launch of the e-Notification program to ensure that registered property owners are quickly alerted via email whenever a foreclosure, transfer of title or mortgage is recorded on their property," said DCBA Director Rafael Carbajal. "Contact us if you have any questions about the program, need foreclosure assistance, or if you suspect fraudulent activity. We are here to help."

ALL THINGS By Jeff Brown

My mom died a year ago, and her passing brought me a disorienting mixture of grief and relief. She was 98. and had suffered from dementia for more than a decade. In her last two months my mother's joy in eating ("Yum, Yum") finally faded, and seeing her laboring to breathe tortured me. When her body finally gave out, it was no Surprise, but the sudden absence death creates is always a shock. In the ensuing weeks, I found myself with what is referred to as "dreadful freedom." I'd spent afternoons with my mom virtually every Saturday and Sunday for the 13 years since my Father died, took her on my family's vacations, drove her to doctors, hired and managed aregivers, winced as her care gradually consumed her life's savings and then some, witnessed time and disease ravage her mind and body.

Now that her life is over, part of mine was, too. My weekends were strangely, terribly, wonderfully free.

When death brings relief from prolonged suffering, those left behind often fell some guilt-tinged relief. I've experienced that emotion more than once. When COPD, cirrhosis, and botched hospital care left my father in a coma and on a ventilator, I had to invoke his living will to compel doctors to turn off the machines. As his breathing ceased, I knew he'd be grateful and felt joy that he'd been freed from his broken body. The same occurred when my brother died at age 31 from AIDS, after a fast-forward decline into serial infections and emancipation that was nearly unbearable to witness. A central teaching in Buddhism, whose wisdom I greatly admire, is that the art of life is embracing every moment, and letting go of those moments end. We deepen our suffering by clinging to a status quo that is not in our power to preserve. It's supremely difficult skill to master, this letting go, but it can bring a measure of peace. Ends, it seems, are often followed by beginnings. Farewell to 2022, and to all the loved ones we survivors had to let go. William Falk - Editor in Chief "The Week"







MOVIE REVIEW: "One Night in Miami"

On this weekend when Americans honor the legacy of Rev. Martin Luther King Jr., let's consider another civil rights leader of that era: Malcolm Little, aka Malcolm X. Though there are hours of interviews of Malcolm X that you can watch on Youtube, I found the movie "One Night in Miami" very insightful and instructive.
"One Night in Miami" begins by introducing us to four men in 1964: Cassius Clay, Malcolm X, Jim

Brown, and Sam Cooke, each arguably at the top of their game in, respectively, boxing, civil rights, football, and music.

The movie begins with brief introductions to these key players – we assume that most viewers already know them. We begin by watching the fight that jettisoned Cassius Clay to the heavy-weight title of the world, the February 25, 1964 fight with Sonny Liston. Then, after the win, Jim Brown and Sam Cooke expected to party with Cassius until the cows came home, but they first meet at the motel room which Malcolm X reserved for them.

The bulk of the movie then deals with their conversation, which, of course, no one has any idea if anything like this actually took place. That's the beauty of "One Night in Miami": Writer Kemp Powers took great literary license, set into the historical reality of the day, and tried to present us with what these four Greats might have talked about. The result is riveting, insightful, humorous, and sad, and opens a portal to the thinking of those directly involved with the civil rights struggle

After the fight, Malcolm X and Cassius Clay had planned a short discussion, and Cassius is trying to decide how and when to announce that he will join the Nation of Islam. Once Cooke and Brown arrive, they want to know when others will join them for the party, but Malcolm tells them that it's just them, and no liquor. They are not happy.

Malcolm X is the spiritual leader and guide of the discussion, admonishing each of the men to do

better, to rise up, to not let their lives be dictated by their white agents and bosses. Perhaps the most revealing and compelling discussion is when Malcolm X chides Sam Cooke for not rising to the occasion of civil rights in his music, and for just pandering to the emotional whims of his mostly white audiences. Cooke is incensed, pointing out how he owns his label, owns his copyrights, and how he has worked towards equality through economic means. Cooke angrily points out that everyone in the room has an actual job, that is, all but Malcolm X. That only momentarily silences the actor portraying Malcolm X, who seems to be fairly accurately representing the real Malcolm X as a strict and uncompromising American Muslim.

Another near fight breaks out during a later discussion where Malcolm X tells Clay, reluctantly, that he is actually thinking of leaving the Nation of Islam. Clay goes into a rage, feeling that Malcolm X was just using him to lend credence to Malcolm's own possible breakaway group.

Powers did a masterful job of combing through the historical record to paint a realistic picture of the conversation that could have happened, which weaved together the drama occurring in each of

Clay was going to "come out" as a Muslim and knew it might hurt his career.

Cooke loved Bob Dylan's song which so accurately described Cooke's feeling – "how many roads must a man walk down, before he is called a man?" – and he was visibly ruffled by Malcolm X's suggestions that he wasn't doing enough, that a white man was beating Cooke to this civil rights message. The movie depicts Cooke's new direction by his performing of "A Change Is Going to Come" on the Johnny Carson show. (In fact, this song was recorded before Clay's heavyweight fight). Brown was at the top of his game, and was about to decide to retire from football and go into acting,

And Malcolm X, wanting to inspire each of these men to even greater heights in service to the goal of equal rights for the black man, was himself in turmoil. Though Malcolm X had become the eloquent spokesman for the American-born Nation of Islam, he was well aware of the lavish lifestyle of the leader, Elijah Muhammad, and his many women. Most objective observers regarded Malcolm X as nearly a saint by comparison to the leader of the Nation, and after Malcolm X's visit to Mecca, he saw a new side of Islam, that Islam embodied people of all races. He knew that breaking from the Nation would have dramatic consequences, and he even foresaw his eventual assassination.

Though the movie makes a few alterations in the chronology of known historical dates, the movie otherwise flows well and is believable. I was spellbound, and could not stop discussing its various aspects long after it was over.

The movie ends with certain highlights of each of the four men: Cassius Clay declaring the next day that he was a member of the Nation of Islam, and his name was now Muhammad Ali. Jim Brown retiring from football and pursuing an acting career. Sam Cooke revealing a new song which revealed a new direction towards support of the civil rights movement. And lastly, Malcolm X is shown reading the manuscript of his autobiography, as told to Alex Haley. Almost a year after Cassius Clay won the heavyweight title, on February 21, 1965, Malcolm X, no longer with the Nation of Islam, was giving a talk at the Audubon Ballroom when he was gunned down by at least three members of the Nation of Islam that night.

"One Night in Miami" shares a personal, private side of these four men, and does justice to their memories.

Cassius Clay played by Eli George, Malcolm X played by Kingsley Ben-Adir, Jim Brown played by Aldis Hodge, and Sam Cooke played by Leslie Odom Jr. If you haven't the slightest idea of how to commemorate King Day, try watching "One Night in Miami."

Billie Holiday (1915-1959) was a trail-blazing musical artist, known as perhaps the first female vocalist to use her voice in the style of jazz improvisation. Recording first with Benny Goodman, she became the first Black female vocalist to front a white band, that of Artie Shaw. She also performed with Count Basie and Duke Ellington. She had long professional associations with saxophonist Lester Young (who named her Lady Day; she called him Prez) and pianist Teddy Wilson.

Born to poverty in Philadelphia, she was a victim of sexual assault while still a child and sentenced by the court to a Catholic correctional institution. It was only her first experience with the court, however. She was convicted at age 13 (along with her mother) of prostitution. Subsequent arrests involved possession of narcotics and substance abuse.

Despite a turbulent life, abusive relationships, and racism, she prevailed to become one of the greatest jazz and blues artists of her time, before her untimely demise at age 44 from cirrhosis of the liver. In addition to multiple hit recordings, she sold out Carnegie Hall three times.

Actor-singer-playwright Synthia L. Hardy brings the story of Billie Holiday to vibrant life. In Billie! Backstage with Lady Day, Billie is being interviewed by unseen reporters as she unfolds the story of her turbulent life. 

WHAT HAPPENS IF YOU WORK WHILE RECEIVING SOCIAL SECURITY?

I started drawing my Social Security retirement benefits back in 2021 when I was forced to retire early, but I'm now interested going back to work part-time. Will this affect my benefits, and if so, how much? Back to Work

Dear Back: You can collect Social Security retirement benefits and work at the same time but depending on how old you are and how much you earn, some or all of your benefits could be temporarily withheld. Here's how

SSA Earning Rules

Social Security says that if you're under your full retirement age and are collecting benefits, then you can earn up to \$21,240 in 2023 without jeopardizing any of your Social Security if you don't reach your full retirement age this year. But if you earn more than the \$21,240 limit, you'll lose \$1 in benefits for every \$2 over that amount.

Full retirement age is 66 for those born between 1943 and 1954, but it rises in two-month increments every birth year to age 67 for those born in 1960 and later. You can find your full retirement age at SSA.gov/benefits/retirement/planner/ageincrease.html.

In the year you reach your full retirement age, a less stringent rule applies. If that happens in 2023, you can earn up to \$56,520 from January to the month of your birthday with no penalty. But if you earn more than \$56,520 during that time, you'll lose \$1 in benefits for every \$3 over that limit. And once your birthday passes, you can earn any amount by working without your benefits being reduced at all.

Wages, bonuses, commissions, and vacation pay all count toward the income limits, but pensions, annuities, investment earnings, interest, capital gains and government or military retirement benefits do not. To figure out how much your specific earnings will affect your benefits, see the Social Security Retirement Earnings Test Calculator at SSA.gov/OACT/COLA/RTeffect.html.

It's also important to know that if you do lose some or all of your Social Security benefits because of the earn-

ing limits, they aren't lost forever. When you reach full retirement age, your benefits will be recalculated to a higher amount to make up for what was withheld.

For more information on how working can affect your Social Security benefits see SSA.gov/benefits/retirement/ planner/whileworking.html.

Be Mindful of Taxes Too

In addition to the Social Security rules, you need to factor in Uncle Sam too. Because working increases your income, it might make your Social Security benefits

Here's how it works. If the sum of your adjusted gross income, nontaxable interest, and half of your Social Security benefits is between \$25,000 and \$34,000 for individuals (\$32,000 and \$44,000 for couples), you have to pay tax on up to 50 percent of your benefits. Above \$34,000 (\$44,000 for couples), you could pay on up to 85 percent, which is the highest portion of Social Security that is taxable. About a third of all people who get Social Security have to pay income taxes on their benefits.

For information, call the IRS at 800-829-3676 and ask them to mail you a free copy of publication 915 "Social Security and Équivalent Railroad Retirement Benefits," or you can see it online at IRS.gov/pub/irs-pdf/p915.pdf.

In addition to the federal government, 12 states - Colorado, Connecticut, Kansas, Minnesota, Missouri, Montana, Nebraska, New Mexico, Rhode Island, Utah, Vermont and West Virginia - tax Social Security benefits to some extent too. If you live in one of these states, you'll need to check with your state tax agency for details

There are several things you can do to avoid probate. Perhaps the most common involves establishing a revocable living trust. Since a properly funded and maintained trust owns the assets, not the estate, those assets do not have to go through the probate process.

Despite this, creating a living trust does not guarantee an individual's assets will receive protection from creditors if that person has debt. What it does mean is that his or her heirs may have more flexibility compared to probate. In other words, by creating a living trust, your trustee may be able to negotiate with creditors more easily to reduce any outstanding debt. In theory, creditors may still sue to repay the debt in full. However, since this could involve significant costs, creditors may prefer to settle instead.

When Do Surviving Family Members Pay the Deceased's Debts?

Most of the time, it's unnecessary for surviving family members to pay the deceased's debt with their own money. Instead, as noted above, payment of debts is either paid out of the deceased's estate, or if there is no estate, the debts are extinguished. However, there are some exceptions to this, including the following:

Co-signing loans or credit cards: If someone cosigns a loan or credit card with the deceased, that individual is responsible for clearing any outstanding debt associated with that account.

Having jointly owned property: If an individual has jointly owned property or bank accounts with the deceased, that person is responsible for clearing any outstanding balances associated with these assets.

Community property: In some states, including California, Arizona, Nevada, Louisiana, Idaho, Texas, Washington, New Mexico, and Wisconsin, the surviving spouse is required to clear any outstanding debt associated with community property. Community property is any property jointly owned by a married couple.

State laws: Some states require surviving family members, or the estate more generally, to clear any debts associated with the deceased's healthcare costs. Additionally, if the estate's executor failed to follow a state's probate laws, it might be necessary for him or her to pay fines. What To Do When Someone Dies

When someone dies with outstanding debt, it's important to take swift action to handle their affairs and neestate repays any outstanding un-secured debt, including credit card gotiate their debts. Below are some steps to follow when faced with this

1 - Understand Your Rights

Since probate laws vary between states, it's a good idea to thoroughly research the probate process in each state the decedent owned property or hire a probate lawyer to handle the estate for or with you. Many states require creditors to make claims within a specific period, while also requiring surviving family members publicly declare the deceased's death before creditors can collect any outstanding debt. It's also against the law for creditors to use offensive or unfair tactics to collect outstanding credit debt from surviving family members. It's generally a good idea to ask creditors for proof of any outstanding debt before paying.

2 - Collect Documents Collecting documents straightforward, particularly if the deceased left all their vital financial papers in a single location. If the surviving family members cannot locate these documents, they can request the deceased's credit report, which lists any accounts in the deceased's name. Your lawyer can help you with

3 - Cease Additional Spending This is essential to prevent any debts in the deceased's name from increasing further, even if there is another person authorized to make payments. Ceasing additional spending includes canceling any recurring subscriptions and helps prevent unnecessary complications when negotiating with creditors.

4 - Inform Creditors

Proactively contact the deceased's creditors to look into options for negotiating the debt and notify credit bureaus of the death. To complete this process, it's useful to have several copies of the death certificate to share with insurance companies and creditors. Afterwards, ask to close all accounts in the deceased's name, and request the credit bureaus freeze the deceased's credit, preventing others from unlawfully getting credit in his or her name.

5 - Close the Estate

Once all debt has been paid off, forgiven, or extinguished, the executor can officially close the estate. The process for doing this varies based on how assets and debts were held, so do not attempt this part alone. Get help from an experienced probate attorney. Ensure Your Family Doesn't Get

Effective estate planning involves taking care of your affairs, and this includes ensuring your debts will be handled in such a way that your family isn't left with a big mess or inadvertently forced into court. Consider scheduling an appointment with a trusted estate planner to help protect your assets and prevent creditors from reducing the gifts you want to leave your loved ones after death.



Why is race even brought up in these contexts? The reason is obvious but rarely even stated today. There continues to be continuing racial discrimination directed against individuals of African heritage that makes very clear the distinction between seeming American ideals and values and the actual policies reflecting continuing realities and practicalities. A few elected politicians may make us all feel better but that does not mean real change has

These laws were passed permitting violence against Black People. These Laws in practice

I would be very | mandated racial segregation in public facilities and institutionalized economic, political and social disadvantages and second class citizenship for most African Americans living in the United States.

Jim Crow laws were enforced until 1965, coincidentally the year I entered UCLA Law School at which time there were no African American students enrolled (and only 2 women; but that's another problem which merits a separate discussion). My point today is that all Americans must, or should recognize, the unspeakable injustices that have been inflicted upon Black People for generations. For a huge percentage of White Americans it was just assumed that Black People (it is now fashionable to use the term "people of Color" to refer to all non-White minorities) were inferior. Americans used that rationale to explain the continuing dehumanization of African-Americans that, if the truth be known, continues to this day.

Presently in California the California Reparations Task Force has reviewed the racist harm inflicted on generations of people. The task force is intended to list recommenda-

tions to atone for generations of trauma suffered by Black children among ongoing depictions of White families as ideal and Black families as not. During the very short time I worked with the Southern Christian Leadership Conference in Mississippi in in 1966 I became very aware of this damaging and completely incorrect assumption. As young Black students became entitled to attend integrated Schools, they were warned by their parents that all White Children were well-behaved and studied hard and actually were kind of superior. I was happy to be there to remind these young people that this was not who White People were and all that the new students had to do was to do their best as they were damn smart themselves.

It is now 66 years later and Americans have come to realize the unfairness and discriminatory policies that have taken place and, yes, we feel bad about it. White people have had the benefit of better education, better health care, more family stability, and every other kind of benefit. Personally, I do not feel that giving certain individuals a pile of money is the answer. Right now before we try to remedy past wrongs let us do something about the present discrepancies in equality of opportunity. Child care help, free college tuition, free tutoring, no interest residential loans, and available free counselling to try and keep families together are necessary and can be instituted now. Something like Nixon's War on Drugs, which amounted to a War on Black People is not necessary, but the use of is a problem. Before we deal with the past, let's try to make the future better. I think we would all feel better about that.

Ketchup is banned from elementary schools in France unless French fries are on the lunchroom menu. In Victoria, Australia you cannot change a light bulb unless you


are an electrician. \$10 fine Married women in La Paz (Bolivia) are limited to one glass of

TOM PURCELL LAUGHING YOUR WAY TO HAPPINESS What makes us happy and fulfilled?



According to the directors of the Harvard Study of Adult Development, the longest scientific study of happiness ever conducted, the answer is very simple: our relationships.

'The stronger our relationships, the more likely we are to live happy, satisfying and overall healthier lives," according to the book "The Good Life," which recounts lessons from the Harvard study.

"Relationships in all their forms — friendships, romantic partnerships, families, coworkers, tennis partners, book club members, Bible study groups — all contribute to a happier, healthier life."

Most of us know this to be true, yet too often we pursue the shallow and material things that do not make us happy.

On one hand, we want wealth and fame. We want people to recognize us when we walk into a public place.

On the other hand we know wealth and fame are bogus. You never know who your real friends really are. You're surrounded by people looking for a handout.

I enjoy talking with older people, who are a treasure trove of experience and wisdom.

I still remember the conversation I had 20 years ago with my brother-in-law's dad, who told me what it was like to grow up during the Great Depression.

He said his family had no money, but he had no idea they were financially poor because they were otherwise wealthy beyond belief.

His city neighborhood was filled with characters, people watching out for them and lots of friends to play with. He said it took forever to walk to the store and back because of all the people stopping him to say hello.

He said he felt sorry for kids today who have material wealth but will never know the warmth of being surrounded by so many people who cared for you.

But we know all this. We know that the happiest moments in our own lives involve friends and family.

These are the people who affect the deeper part of our nature, our spirits and souls, where true happiness resides.

These are the people who help us when we're down, or engage us in deeply satisfying conversations, or make us laugh so hard our guts hurt.

Perhaps that's why laughter and a sense of humor are key components of happiness, according to The Atlantic.

"Consuming humor brings joy and relieves suffering," the magazine reports.

"In a 2010 study from the Journal of Aging Research, the researchers gave one group of senior citizens "humor therapy" — daily jokes, laughter exercises, funny stories and the like — for eight weeks. A control group did not receive this therapy. At the end of the experiment, the people in the first group reported feeling 42 percent happier than they had at the beginning. They were 35 percent happier than the second group, and experienced decreases in pain and loneliness."

The evidence is clear that engaging and laughing with family and friends are the keys to human happiness and fulfillment.

But sadly, rather than create more connections with other human beings, the U.S. Census reveals that Americans — especially elderly Americans — are increasingly becoming isolated and lonely, reports PBS.

The solution to unhappiness and loneliness is clear to me: Make more friends, engage and visit those who are isolated, and tell more silly jokes like this one: "Where is happiness made? At the satisfactory."




