IN SIERRA MADRE PUBLIC SAFETY COMES FIRST



Sierra Madre Police & Fire Departments Hold Public Safety Town Hall

On Wednesday evening Sierra Madre residents had the opportunity to hear first hand how Police and Fire work hard to keep them safe. The event, moderated by Mayor Edward Garcia, included presentations from SMFD Chief Brent Bartlett, SMPD Acting Chief Henry Amos, and 'Chief in Waiting' Gus Barrientos. Bartlett's presentation showcased the fire department's achievements since becoming a fully paid department in 2019. The department still has 4 volunteers, 3 of whom live in Sierra Madre. In 2022, they responded to 1,382 incidents of which 79% were EMS calls. Their budget for 2022-23 is \$2.9 million and they were able to recover over \$600,000 of that expense by participating in programs such as deployments to wildfire events (Oak Fire & Kinney Fire), etc.

Amos introduced the department's next Chief, Barrientos and reviewed the current crime trends from 2017 - 2021. Crimes in Sierra Madre have been trending downward with 2021 showing the largest decline of over 200 incidents. Included in those figures are the departments work with the Justice Department's ICAC (Internet Crimes Against Children). There are currently 20 sworn officers, 4 dispatchers, 1 Administrative Director and several reserve and p/t officers who make protecting Sierra Madre a priority. SMPD also noted that as a result of a recent spate of early morning commercial break-ins, additional mea-

sure are being taken in an effort to curtail such activity. The audience was also reminded that, "If You See Something, Say Something", reviewing several types of suspicious activities to notify them of. As for the PD budget, Amos reminded the audience that unfortunately the only way in which the department can recoup its' costs was through the issuance of tickets, to which the audience' audible response was comical.

After the presentations, break out sessions afforded attendees the opportunity to speak with members of the departments one on one, share their experiences and express their concerns and what they felt the departments priorities should be. Both departments received very positive feedback. Both departments noted that Recruitment and Retention are they biggest challenges. S. Henderson/MVNews

MT. WILSON TRAIL & BAILEY CANYON TRAIL SEVERELY DAMAGED BY **RAINSTORMS**

The rainstorms over the last several weeks have severely damaged Sierra Madre's Mt. Wilson Trail and Bailey Canyon Trail. As a result, the City of Sierra Madre has closed both trails because they are unsafe for public use. The trail damage is extensive, including trail washouts, trail failures, precarious rockslides, and downed trees. There is a section of the Mt. Wilson Trail that will require the installation of a 30-foot wooden bridge to make the trail

passable. This is the worst cumulative trail damage in over 30 years and it will take time

All labor on Mt. Wilson Trail and Bailey Canyon Trails is done by community volunteers, who work tirelessly and continuously to repair and maintain the trails to keep them open and safe for public use. The necessary supplies and tools used by the volunteers are paid for with tax-deductible community donations to the Fletcher Trail Maintenance Fund, as neither

the City of Sierra Madre nor the US Forest Service provides any funds for the supplies or labor. Without the work of the volunteer trail maintenance crew, the trails would become impassable, as the recent rainstorms demonstrate

Mt. Wilson Trail and Bailey Canyon Trail are important and valuable community resources that are used by hundreds of hikers, runners, families, and nature enthusiasts of all ages. Users of both trails come from Sierra Madre, the entire San Gabriel Valley, Los Angeles Basin, and beyond. The goal of the Sierra Madre Trails Maintenance Crew is to ensure these trails remain open and safe for public use for years to come.

This year's annual Mt. Wilson Trail Race (MWTR) will be held on May 27, 2023. First run in 1908, the MWTR is the one of the oldest races in California. The MWTR course is 8.2 miles from Kersting Court to Orchard Camp and back. The trails need to be ready for this important community event.

REPRESENTATIVES FROM GAS COM-PANY TO PROVIDE UPDATES ON RECENT CHANGES AT COUNCIL MEETING

With increased gas prices and recent cold snaps across the nation, SoCalGas customers can expect higher gas bills in the upcoming weeks. CITY ADDING FOUR-WAY STOP TO **BUSY INTERSECTION IMPLEMENTATION** WARRANTED FOR ORANGE GROVE, MOUNTAIN TRAIL, AND SAN CARLOS

Sierra Madre has seen many improvements over the years regarding the safety of our pedestrians and drivers. We've seen more crosswalks added, cross-walk flashing lights, and more police presence to curb traffic offenders in the city.

Now the city wants to tackle other traffic trouble spots—the intersections of Orange Grove Avenue, Mountain Trail Avenue, and San Carlos Road and at Orange Grove Avenue and Rancho Road. After several accidents this past year, the city wants to put a four-way stop at these intersections to help prevent any further calamities. Adding these Stop controls would have to be coordinated with the City of Arcadia, which borders Sierra Madre at the site.

A Wildan traffic engineer performed a signal warrant analysis, reviewed the three-year traffic collision history of these two intersections between 2019 and 2021, and recommended a four-way stop at Orange Grove Avenue, Mountain Trail Avenue, and San Carlos Road, which was the scene of six traffic collisions over those three years, according to data from California's Statewide Integrated Traffic Records. A minimum of five crashes to (continued on pg. 3)

A PROPERTY FIT FOR A PRESIDENT

Making the Pickard-Hoover Residence a Historical Landmark

In November 1932, a Presidential motorcade rode through Los Angeles—the final destination—Sierra

The President was Herbert Hoover, who was said to have visited Sierra Madre on several occasions during the colder months to visit his son, Herbert Charles Hoover, who resided at a corner property at 500 N. Michillinda Avenue in what is known today as the Pickard-Hoover Residence. Business owner Frank Pickard was the first owner of the Spanish-styled property, which was built in 1928 and sat on 1.4 acres. Once the President's son moved in, legend has it that the property was referred to as "The Winter White House."

Suzanne and Malcolm Edwards, the current owners of the Pickard-Hoover property, have applied to nominate it as a Historical, Cultural, and Architectural Landmark. Upon designation, the Edwards are hoping to reap the benefits of The Mills Act, which grants tax breaks to homeowners of historic homes in exchange for rehabilitation and maintenance of the properties.

During the City Council meeting on January 10, 2023, a public hearing was held to discuss adopting Resolution 23-03, which would approve the historic designation of 500 N. Michillinda Avenue and approve a Mills Act contract for the restoration and rehabilitation of the Pickard-Hoover Residence.

Associate Planner, Joshua Wolf, gave a presentation on the property and highlighted the criteria needed to receive the Historic Landmark designation.

Historic Significance

Criterion A - That the site is associated with local, state, or national cultural, social, economic, political, or natural history, events, or persons significant to the history of Sierra Madre, or it reflects significant geographical patterns, including those associated with different eras of settlement and growth, particular transportation modes, or distinctive examples of park or community planning.

During a slide show, Wolf presented a photo featured in the Los Angeles Times, taken at the entrance of the Pickard-Hoover Residence, depicting Herbert Charles Hoover and his family, including President Hoover posing as a "Welcome Nation's Chief Executive" photo op.

On July 14, 1930, Mr. Hoover TIME, highlighting his accomplishments as an engineer, radio communications

innovator, and advisor to foreign governments. During his residency in Sierra Madre, Mr. Hoover served the community as the Chairman of the Boy Scouts in 1935.

Architectural

Criterion B - That the architectural style is representative of the work or is one of a few remaining examples of a notable builder, designer, or architect, or it embodies distinctive characteristics of a style, type, period, or method of construction, or, is a valuable example of architectural achievement or innovation such as the use of indigenous materials or craftsmanship.

The Pickard-Hoover Residence was built in a Spanish Colonial Revival style. Since it was built, there have been multiple additions to the building which altered the exterior appearance, but they were found to be compatible with the style of the original.

Some of this charming home's characteristics include:

- Multiple side-gabled and low-pitched roofs and eaves with shallow or no overhang
- Red brick patio and garden paths
- Arched entryway with heavily carved door Interior wood-beamed ceilings, and
- Monumental fireplace mantels with brick or stucco surface and decorative tile.

The property has four fireplaces, a guesthouse, and a pool house. And it's certainly worth mentioning that there is a children's area playroom in the theme of "Winnie the Pooh" designed by the author, A.A. Milne. He was a family friend of the Hoovers.

Mills Act | Rehabilitation | Maintenance

The Mills Act allows the city to enter into 10-year revolving contracts with qualified historic properties. Participants could receive 40-60% property tax savings each year for newly renovated properties. Those tax savings are meant to give property owners some relief regarding specific restoration tasks and maintenance.

Rehabilitation projects for the Pickard-Hoover Residence include repairing and replacing exterior features and systems. Roof maintenance, termite repair of the pergola, renewal of wood trim, and repair of brick chimneys are some external areas that need attention.

Systems-related work includes repairs to the heating and cooling system, new insulation, plumbing, and foundation repair. The total repair costs are estimated at \$573,183. That's \$7,935 more than tax breaks would cover, a loss of revenue for the city annually.

Despite the cost incurrence, City Council generally felt the Pickard-Hoover Residence was a good investment for the city, approved the Mills Act contract, and adopted Resolution 23-03 unanimously.



warrant a Stop sign.

A second factor reviewed was the volume of traffic in this area. In this scenario, the minimum traffic for the minor street is 300 vehicles per hour (vph) for 8 hours and 200 (vph) on a minor street to warrant a Stop control. This intersection's major and minor roads averaged 368 vph and 216 vph, respectively. Guidelines are based on recommendations in the California Manual on Uniform Traffic Control Devices

But the engineer did not recommend a four-way stop at Orange Grove Avenue and Rancho Road, which had one traffic collision during the review period. Factors in this decision included just one traffic collision in 12 months, and the minor streets in this area only reached 74 vph, 126 vph shy of what's needed to warrant a Stop control.

On January 10, 2022, Director of Public Works Chris Cimino gave a presentation before City Council, followed by a unanimous vote to implement a four-way stop at Orange Grove Avenue, Mountain Trail Avenue, and San Carlos Road.





New Rubberized Play Surfaces Installed at Park Playgrounds

The Department of Public Works, in partnership with the Department of Parks, Recreation and Community Services, announced Thursday the completion of the installation of new rubberized play surfacing at Brookside Park Reese's Retreat and Villa Parke playgrounds. Reese's Retreat has become one of the City's most popular playground destinations since opening eleven years ago. Its popularity stems from its unique piratethemed play equipment and its rubberized play surfacing that provides for universal accessibility.

According to Pasadena City Manager Miguel Marquez the Villa Parke playground recreational provides opportunities for recreation center's Head Start Program as well as the surrounding community. Due to heavy usage at both locations, the rubberized playing surface deteriorated beyond repair and required complete replacement.

He said a \$195,000 capital improvement project, the



replacement of the rubber surface at the Villa Parke playground was completed in November 2022 and at Reese's Retreat in December 2022. The construction schedule for each park was designed to accommodate residents, allowing them to be able to use the parks during each of the school holiday breaks.

San Marino Fire and Police



Members of the San Marino Fire and Police Departments were recognized by the City Council and the San Marino Unified School District Board of Education for their part in a critical cardiac arrest incident occurring at San Marino High School. The immediate actions to initiate CPR by bystanders and San Marino police officers, and the quick response by San Marino Fire Department personnel to initiate manual defibrillation, resulted in the survival and recovery by the patient. Studies have found that bystander CPR can double or even triple the chance of survival from an out of hospital cardiac arrest. SMFD, as a member of the Verdugo Fire Communications Center, participates in the PulsePoint program, which alerts bystanders to cardiac arrest incidents in their immediate vicinity at moment of dispatch. The app also alerts bystanders to the locations of nearby automatic external defibrillators (AEDs), so that immediate aid may be provided until paramedic personnel arrive.

Chu Commends DHS, Urges Passage of the POWER Act

The Department of Homeland workers who are victims of violation of labor rights can now access a streamlined and expedited deferred action process or temporary relief from deportation as they cooperate with labor standards investigations.

Holden Introduces Lead Recognized for CPR Incident Testing Bill for TK-12 Schools

Assemblymember Chris Holden introduced, AB 249, School-site Lead Testing, which requires water utilities to test water faucets and fixtures in Transitional Kindergarten (TK)-12 schools for lead concentrations greater than five parts per a billion (5 ppb) over the next five years and replace fixtures that test above the standard.

"Lead consumption among youth and disenfranchised communities at a higher rate," said Chris Assemblymember Holden. "Assisting schools with the resources and appropriate standards to ensure the water fountains our children drink from are safe will help us protect our schools, students and communities."

While there is no safe amount of lead content in drinking water, children are particularly vulnerable to elevated levels of lead exposure, which can lead to adverse cardiovascular, reproductive, renal, immunological, neurological effects, and cancer. The federal government and state of California have enhanced lead testing standards and processes, but the misalignment of lead testing standards for childcare centers and TK-12 schools leaves room for important improvements for long-term results and safety.

"Lead is a neurotoxin that can permanently damage young children's nervous systems," said Susan Little, Working Environmental Group's senior advocate of government affairs in California. "Even small amounts of lead can lower a child's intelligence, cause behavior and learning problems, slow growth



and harm hearing. The Centers for Disease Control states that there is no safe level of lead. This harmful substance doesn't belong in the drinking water children consume at school."

"Lead exposure is a health, education, and racial justice issue for our kids," said Ted Lempert, president of Children Now, a statewide children's advocacy organization. "We thank Assemblymember Holden for authoring this legislation to protect students from lead in drinking water, and we are pleased to partner with Environmental Working Group to co-sponsor the bill. Children Now is committed to ensuring that schools have the supports and resources they need to keep kids safe."

"In 2018, I introduced AB 2370 which required the California Department of Social Services (CDSS) to adopt regulations for lead testing of child day care centers as a part of the Department's Child Care Licensing Program," said Holden. "It also ushered child day care centers to test their drinking water once every five years. By aligning childcare and school lead testing standards we can protect children from the toxic effects of lead."

CITY OF DUARTE RECEIVES \$1.6 MILLION IN FEDERAL FUNDING FOR THE DONALD AND BERNICE WATSON GREENBELT TRAIL IMPROVEMENT PROJECT

After significant advocacy efforts by Congresswoman Grace Napolitano, the City of Duarte will receive \$1.6 million in federal funding for the Donald and Bernice Watson Greenbelt Trail Improvement Project as part of the 2023 Omnibus Appropriations Bill recently signed

Community Development Director Craig Hensley and his department have sought funding for the improvement project for several years, marking this acquisition a huge milestone. Opened in 1977 and recently renamed in memory of the first African American Mayor of Duarte, the Donald and Bernice Watson Recreation Trail is a multipurpose trail that runs from Buena Vista Avenue to Royal Oaks Park. The historic trail provides ample recreational opportunities for residents and guests alike, and its gentle slopes and shady oak trees make it one of Duarte's key attractions.

The project will provide key improvements and maintenance to this beautiful trail including reconstruction of the pathway. Following improvements, the new recreational trail will feature permeable asphalt paving and an updated stormwater diversion system. There will also be several safety updates including additional lighting for increased visibility, accessibility alterations, and the installation of public health and community amenities.

"We are ecstatic to receive funding for this incredibly important project," said Hensley. "We could not have secured this funding without the immense sup-port of Congresswoman Napolitano and her team. Her work on our behalf will allow the City to greatly enhance recreational opportunities for our residents."

Congresswoman Grace Napolitano's efforts helped secure \$48.7 million in funding for 15 community projects throughout her district including Duarte's Trail Improvement Project. The NRA's ideal world by Wiilam Falk "the Week" editor You might not have realized it, but our country is getting safer every day. How can that be? you might ask. Didn't the murder rate soar 30 percent in 2020, and isn't violent crime up nearly everywhere? Isn't there, on average, more than one mass shooting of four or more people every day — including a crazed gunman's barrage of 33 shots in a New York City subway this week? Yes, true enough, but look at the bright side: The sale of deadly weapons has been surging at a record pace for years, with nearly 40 million firearms sold in 2020 and 2021. Better yet, in 25 states, you can now legally buy and carry a firearm without a permit, testing, or training.

For decades, the National Rifle Association and Second Amendment absolutists have assured us that the more guns there are in our communities, the safer — and "more polite," lol! — we'll all be. With nearly 400 million guns now in American hands, surely we must be the safest nation in the world.

Actually, no. All those guns have turned our streets, schools, and homes into a 21st-century version of the Wild West, with tens of thousands of casualties. Nine mass shootings erupted on a recent weekend, leaving eight dead and 60 wounded, including a gunfight at a car show in Arkansas that left 27 people — including six children —injured. Road-rage shootings have become daily events.

When people feel disrespected on the road, Houston Mayor Sylvester Turner said, "now instead of throwing up the finger, they're pulling out the gun and shooting." In NRA dogma, the best response to this endless carnage is to arm yourself and prepare to shoot back. So, when a "bad guy"sprays bullets in a crowded bar, theater, school, workplace, or subway, "good guys" can whip out their guns and return fire, while the unarmed dive under chairs. Doesn't that vision fill you with warm feelings of safety?

U.S. POSTAL SERVICE ANNOUNCES NEW PRICES FOR 2023

Forever Stamp to Rise Three Cents

WASHINGTON, DC — The United States Postal Service filed notice with the Postal Regulatory Commission (PRC) of price changes to take effect Jan. 22, 2023. The new rates include a three-cent increase in the price of a First-Class Mail Forever stamp from 60 cents to 63 cents.

If favorably reviewed by the Commission, the proposed increases will raise First-Class Mail prices approximately 4.2 percent to offset the rise in inflation. The price changes have been approved by the Governors of the U.S. Postal Service.

The price for 1-ounce metered mail will increase to 60 cents, and the price to send a domestic postcard will increase to 48 cents.

A 1-ounce letter mailed to another country would increase to \$1.45.

There will be no change to the single-piece letter and flat additional-ounce price, which remains at 24 cents.

The Postal Service is also seeking price adjustments for Special Services products including Certified Mail, Post Office Box rental fees, money order fees and the cost to purchase insurance when mailing an item.

As operating expenses continue to rise, these price adjustments provide the Postal Service with much needed revenue to achieve the financial stability sought by its Delivering for America 10-year plan. The prices of the U.S. Postal Service remain among the most affordable in the world.

The PRC will review the changes before they are scheduled to take effect. The complete Postal Service price filing, with prices for all products, can be found on the PRC website under the Daily Listings section at prc.gov/dockets/daily. The Mailing Services filing is Docket No. R2023-1. The price tables are also available on the Postal Service's Postal Explorer website at pe.usps.com/PriceChange/Index.

Dr. Gordon Amerson shared key updates on the Duarte Unified School District at a recent Duarte Kiwanis Meeting. During the Covid 19 Pandemic:

- The district provided 100,000 grab-n-go meals as a drive-thru - and they provided food for everyone in each car - not just their students.
- 2500 laptops and 300 hot spots were provided to students. Since DUSD already had a policy for one laptop or tablet per student, they were ahead of the game.
- DUSD was the first district in the entire region to provide drive-thru Covid 19 vaccinations through a partnership with City of Hope.
- As school transitioned back to "in person" they were able to continue to provide "independent study" for those students who did better from home.

From 2017 - 2020, the scholastic results of DUSD students contin-

ually improved. Now, the support needed really is more related to issues of isolation and lack of socialization for kids who were home for so long. The DUSD recognizes the need for more mental health support for these students.

The School District is in the process of building a Multi-Sport Complex on the Duarte High School Campus. When completed, this complex will be the only one in our region to provide access for night games/tournaments throughout the community.

In my mid-20s, I was introduced to a different way to commemorate my birthday. My mentor, R.E. White, devised something he called The Birthday Run. The essence of this practice was to run a lap for every year and to attempt to recall the significant details of that year while running. I have done this run nearly every year on my birthday since my mid-20s, except a few cases when I was very sick, and then I did it a few days later.

R.E.White introduced this practice to the members of the non-profit he founded, and most but not all - of the members routinely did this. Some told me that it was too hard, or that it was actually bad for their bodies to do so much running. I never argued with any-one about it, but I continued to do it myself because I found personal value in the deeply introspective act of a

The Birthday Run concept is more than just the run. When fully observed, it involved friends and family, a meal together, a special "memory bath" for the birthday person, and a sharing of goals for the future, and significant memories from the run. Today, I am only sharing some significant memories from my recent run and some action I took.

I usually prepare for this run by writing out every year in a small notebook, and then the age I would turn that year, and what grade I was in, and other significant milestones through my past nearly 7 decades. Whereas I usually see a lot of details each year when running, this year I noticed patterns. And behind those patterns, I noticed motivations, both good and bad, for many of my life's choices.

I realized that people came into and out of my life. There was my natal family, of course, and I found myself feeling the most profound deep appreciation for all that my parents did, mostly without any thanks. And then I saw the many close friends, male and female, that came into my life. Often, it was as if they suddenly appeared and were automatically apart of whatever inner circle I had. I realized that try as I might to "make friends," friends always appeared, rather organically, and became a part of my life, and they were not usually the people I was trying to make friends with. Even serious relationships al-ways seemed to arise organically, without my trying, and I have concluded that - some-how those people were intended to, or destined to, be a part of my life and whatever my life was about

Much of what I did in my life was the quest for money and the quest for love, or whatever I thought was "love." But I insisted in my early years that at least my pursuits for "money" should provide fulfilment in the moment, not just in the distant long-term. I learned to en-joy every learning experience for its own immediate values, and I learned to enjoy all the diverse jobs that I held for the sheer pleasure of working, and for the inherent lessons that each job provided.

[Nyerges is an educator and author. He's written such books as "Urban Survival Guide," "Ex-treme Simplicity," and others. Information about books have no core values except sheer sur-vival, and the pursuit of pleasure. That's not necessarily a bad thing, but I always wanted more. I often quit jobs even when I needed the money because I felt that I was wasting my life, that I was dying inside. Yet, I still pursued endless jobs of many sorts, because money is as important as oxygen in our society. And I always wanted to enjoy the process, and have the process of "working for money" be an activity that broadly benefits me.

> So, in my broad perspective of things during this year's run, I saw nearly everything in terms of relationships, love, money, and the fulfillment of character. It was quite an in-sight.

> And one more thing. Each year when I review my life during the run, I look for anything that I'd done wrong but did not make amends for it. In past years, I went back to some-one I'd stolen money from and repaid them. I would call someone and apologize for some past deed, usually to have them say they have no memory of it. This year, I had been re-calling the time when I was about 14 when I stole bags of cement from a neighbor's gar-age, and hauled the cement via a wagon to a friend's backyard where we planned to build a "clubhouse." The clubhouse was a disaster, and though I know the neighbor realized I stole the cement, I never suffered any consequences and never repaid the theft. I finally decided to make good on that old debt. There are a lot of funny, and sad, details - and I wrote about that episode in my book "Watermelon Dreams" (available from Amazon).

> So after my run this year, I drove over to the house where I'd stolen the cement. I was going to give the current owner a \$50 gift card from Home Depot. I stood in front of the door, gift card in hand, rehearsing the story I would tell the surprised homeowner. I ex-pected them to laugh, or to say that I don't owe them anything. These things are harder than you can imagine! So I knocked, and knocked again. Nothing. No one was home. I then wrote the most concise note possible, slipped the note and gift card into an envelope, and slipped it into the mail box. Done. Very anticlimactic, but now that particular debt will not plague me at night. An anchor pulled up, no more karma to suffer in hell from that childhood act of pointless thievery.

> I've only shared this with a few people, but the responses were quite varied. One old friend applauded me for trying to make amends for my past. Another scoffed, wondering why I was wasting my time on "little things" when there are so many great problems in the world. I simply smiled, and said that I was in no position to deal with world problems if I do not handle myself first. Another more analytical friend was quiet for a moment, and then said, "Do you think \$50 really handled your debt? I mean, that was, what, more than 50 years ago? What about interest, and penalty?" I thought about that. He might be right...

> Anyway, that's what I did for my birthday. And I offer profound thanks to the one friend who encouraged me, and assisted me, in making amends for this old theft.



TOP FINANCIAL SCAMS TARGETING SENIORS TODAY

Dear Savvy Senior:

What are the most common scams today that target elderly seniors? My 75-year-old mother has been swindled several times over the past year, so I'm being extra cautious. Paranoid Patty

Dear Patty:

Great question! While many scams today are universal, there are certain types of fraud that specifically target older adults or affects them disproportionately. And unfortunately, these senior targeted scams are on the rise.

According to the Federal Bureau of Investigation (FBI), in 2021 there were 92,371 older victims of fraud resulting in \$1.7 billion in losses. This was a 74 percent increase in losses compared to 2020.

Here are five of the most common senior scams that were reported last year, that both you and your mom should be aware of.

Government imposter scams: These are fraudulent telephone calls from people claiming to be from the Internal Revenue Service, Social Security Administration or Medicare. These scammers may falsely tell you that you have unpaid taxes and threaten arrest or deportation if you don't pay up immediately Or they may say your Social Security or Medicare benefits are in danger of being cut off if you don't provide personal identifying information. They may even "spoof" your caller ID to make it look like the government is actually calling.

Sweepstakes and lottery scams: These scams may contact you by phone, mail or email. They tell you that you've won or have the potential to win a jackpot. But you need to pay a fee, or cover taxes and processing fees to receive your prize, perhaps by prepaid debit card, wire transfer, money order or cash. Scammers may even impersonate well-known sweepstakes organizations, like Publishers Clearing House, to fool you.

Robocalls and phone scam: Robocalls take advantage of sophisticated, automated phone technology to carry out a variety of scams on trusting older adults who answer the phone. Some robocalls may claim that a warranty is expiring on their car or electronic device, and payment is needed to renew it. These scammers may also "spoof" the number to make the call look authentic.

One common robocall is the "Can you hear me?"

call. When the older person says "yes," the scammer records their voice and hangs up. The criminal then has a voice signature to authorize unwanted charges on items like stolen credit cards.

Computer tech support scams: Theses scams prey on senior's lack of knowledge about computers and cybersecurity. A pop-up message or blank screen usually appears on a computer or phone, telling you that your device is compromised and needs fixing. When you call the support number for help, the scammer may either request remote access to your computer and/or that you pay a fee to have it

Grandparent scam: The grandparent scam has been around for several years now. A scammer will call and say something along the lines of: "Hi Grandma, do you know who this is?" When the unsuspecting grandparent guesses the name of the grandchild the scammer most sounds like, the scammer has established a fake identity.

The fake grandchild will then ask for money to solve some unexpected financial problem (legal trouble, overdue rent, car repairs, etc.), to be paid via gift cards or money transfers, which don't always require identification to collect.
