

PUBLIC SAFETY IN SIERRA MADRE NEWS

SERGEANT GRANT CADZOW 10 QUESTIONS
For the next several months Sierra Madre's Police and Fire Departments will be running a weekly segment titled, "Get to Know Your Public Safety Officer" in the Mountain View News. The purpose of this special segment will focus on our police and fire department employees for all of us to learn a little bit more about the men and women who serve our community. This week's special segment we feature Sergeant Grant Cadzow

Sergeant Grant Cadzow has worked with the Sierra Madre Police Department since 2015, and currently serves as a Sergeant. In his 9-year career at Sierra Madre, Grant has served as a Field Training Officer, Emergency Operations Coordinator, Drone Operator, and Police Volunteer Program Coordinator. He recently spearheaded a project for the police department that introduced body worn cameras to all patrol personnel. Grant represents the next generation of the department's leadership and management team and is sure to play a key role in the future of the Sierra Madre Police Department.

1. When did you know you wanted to be a police officer?

I thought about it when I was in high school. I had family members that got involved in drugs. I felt helpless and that I could do nothing to help. I wanted to be able help others that might feel helpless and don't know what to do. I did not get serious about law enforcement until I met my girlfriend's father (now my father-in-law). He told me the profession required people with integrity, courage, and dedication. He told me an officer has to be able to do what's right even when it's the hardest thing to do. He was that as a cop. That is who I wanted to be and what I wanted to do.

2. Why did you choose to work for the Sierra Madre Police Department?

When I was applying, I came up here for a ride along to get to know the city more. I could tell the city was a close community. The Police Department provided high quality and more personal customer service. They had a professional, but family feel and it felt right for the type of guy I am.

- 3. What do you like best about your job and your role as a supervisor? I have been able to be involved in more projects that shape the future of the Department.
- 4. We understand you played a key role in the development of the department's drone program. What can you tell us about that experience and how does a drone program benefit our community?

When I was tasked with starting the program, I knew very little about drones. Like most people, I looked at them as "toys." I went to some trainings, got my FAA part 107 license, and started looking into first responder drone use. It was very easy to see the value for first responders using these devices. They will enhance performance, efficiency, reduce liabilities, and enhance safety for police and citizens.

5. How do you see your role in Police Department moving forward?

I hope to keep progressing the services of the Department while preserving the traditions and values that make the City and Department so unique and special.

6. Favorite place you frequent in Sierra Madre?

I don't know if I have a favorite. I like to go to Lucky Baldwin's so Lisa can try to embarrass me, I like to talk to Mike at Ruiz Shoe repair, visit Vic at Corfu, Edgar at K petrol, Sarah at Drop a Load, Miguel at City Hall, and Mr. Wiedemen in Kersting Court.

7. Tell us a little about your family?

My family is everything to me. God has been great to us! My beautiful wife Brittany married me 11 years ago. She teaches a moderate to severe Kinder/1st autism class. We have three blessings together. Elsie is 9 and loves gymnastics and the Miraculous Ladybug. Gunnar is 7 and loves monster trucks and jiu jitsu. Everly is 3 and loves Smurfs, wrestling, and being in charge. We also have chickens at our house.

8. What activities do you like to do when you are not serving our city as a police officer?

My favorite thing is being a dad. When I'm not at work, I am theirs. We try to do as many things together as we can. Trips to the beach, mountains, church, monster truck shows, random camping trips, watch football, etc. We also like to get out to the family farm.




9. What's the most heroic moment you've experienced on the job?

That is a hard one to answer. I have been here and seen our officers up against many different things that I consider heroic. Violent people, large protests, saving lives, close bear encounters, calls with fentanyl, the bobcat fire, the pandemic, etc. It feels wrong to pick one.

10. What is one thing unique about you that some people may not know of you?

My faith in God guides me. I believe in the warrior and guardian mindset that is sometimes needed to do this type of work, but also in leading with a servant's heart.







SIERRA MADRE: IT'S STILL HOT!

During extremely hot and humid weather, your body's ability to cool itself is challenged. When the body heats too rapidly to cool itself properly, or when too much fluid or salt is lost through dehydration or sweating, body temperature rises and you or someone you care about may experience a heat-related illness. It is important to know the symptoms of excessive heat exposure and the appropriate responses. The Centers for Disease Control and Prevention (CDC) provides a list of warning signs and symptoms of heat illness, and recommended first aid steps. Some of these symptoms and steps are listed below.

Heat Cramps - Heat cramps may be the first sign of heat-related illness, and may lead to heat exhaustion or stroke. Symptoms: Painful muscle cramps and spasms usually in legs and abdomen and heavy sweating. Seek immediate medical attention if cramps last longer than 1 hour.

Heat Exhaustion Symptoms: Heavy sweating, Weakness or tiredness, cool, pale, clammy skin; fast, weak pulse, muscle cramps, dizziness, nausea or vomiting, headache, fainting.

Seek immediate medical attention if the person vomits, symptoms worsen or last longer than 1 hour.

Heat Stroke Symptoms: Throbbing headache, confusion, nausea, dizziness, body temperature above 103°F, hot, red, dry or damp skin, rapid and strong pulse, fainting, loss of consciousness.

First Aid: Call 911 or get the victim to a hospital immediately. Heat stroke is a severe medical emergency. Delay can be

City to Install **New Marker** at Robinson **Family Home**



The Pasadena City Council is set Monday night to discuss installing a more visible memorial at the site of the Robinson family home where Mack and Jackie Robinson and their siblings grew up. The agenda report is for information only and the council is not expected to

According to city staff, currently, the site is memorialized by a bronze plaque imbedded in the concrete parkway in front of the house at 123 Pepper

The proposed Robinson Family Home Memorial and Historical Marker will stand five feet tall and have three plaques with language that honors the entire Robinson family, not just Mack and Jackie, staff said. The scope of work for this project includes extending the concrete in the parkway to accommodate the new plaque installation; removing the existing plaque and concrete patching; painting the curb in front of the site red to create a no parking zone; installing a metal pole to support the three 20" x 24" metal plaques; and removing and replacing the existing bush between the memorial and the driveway. The project is designed for ADA accessibility they said. For the three new plaques,



Earthquake After Action Report

On August 12, a 4.4 magnitude earthquake shook the Los Angeles region, including San Marino. Immediately following the shaking, City employees were evacuated to designated meeting spots and Fire and Police personnel surveyed City and Public Safety facilities for potential damage. Fire and Police then initiated a windshield survey of the City along predetermined routes. Surveys were completed with no damage observed or reported.

The earthquake came less than one week after a 5.2 magnitude earthquake struck near Bakersfield. Following the Bakersfield earthquake, City staff reviewed the Earthquake Operations Annex to the City's Emergency Operations Plan, which proved beneficial on Monday. The August 12 earthquake is the third earthquake to strike the same region of the Puente Hills Fault since June 2024. According to Dr. Lucy Jones, 2024 has had more earthquakes than any year

The San Marino Fire Department encourages residents to review their family's earthquake preparedness plans and attend the Fire Department's quarterly emergency preparedness workshops to ensure that San Marino residents are disaster ready.

NASA Funds Research Projects Advancing STEM Career Development

NASA announced Wednesday that they have awarded \$6 million to 20 teams from emerging research institutions the United States supporting projects that offer career development opportunities for science, technology, engineering, and mathematics (STEM) students.

This is the third round of seed funding awarded through the agency's MOSAICS (Mentoring and Opportunities in STEM with Academic Institutions for Community Success) program, formerly the Science Mission Directorate Bridge Program. The program seeks to expand access to NASA research opportunities in the science and engineering disciplines, as well as to NASA's workforce. "The STEM workforce

continues to grow, and today's students, studying at a variety of higher-education institutions community colleges, primarily undergraduate institutions, and minority-serving institutions — are the STEM workforce of tomorrow, who will work to solve some of our biggest challenges at home while answering some of our biggest questions about our universe," said Padi Boyd, director of MOSAICS at NASA Headquarters in Washington. "Exposing today's students to the incredibly inspiring and cutting-edge discoveries made through NASA's space science people and resources ensures that these students get the training they need to persist in STEM careers, while fostering enduring collaborations between NASA researchers and faculty at a wide range of

institutions."

NASA's Science Mission

Directorate MOSAICS program funds research projects building relationships between college faculty and researchers at the agency while providing mentorship and training for students in STEM disciplines. The projects support teams at academic institutions that historically have not been part of the agency's research enterprise including Hispanic-serving institutions, historically Black colleges and universities, Asian American and Native American Islander-serving primarily institutions, and undergraduate institutions.

The program previously awarded seed funding to 11 Experience With NASA Langley teams in February and 13 teams Research Center: Polarimetry in April. When it comes to the art of dining, there are rules—old and simple, like the turning of the tide. Rules that should be followed not out of compulsion but out of respect, for yourself and those around you. These are the kind of rules you remember, like a good night in Paris or a long day at sea.

Your napkin, folded in half, should rest on your lap the moment you sit down. It waits for nothing neither for food nor drink. It is there, ready and silent, like a soldier at his post.

If you must leave the table, the napkin, loose and easy, lies to the left of your plate. It is never used for anything more than a dab at the corners of your

mouth or your fingertips. For all else, there is the restroom—use it.

At formal dinners, a charger stands guard beneath your plate during the starter, but when the main course arrives, it is removed—disappearing as quietly as it appeared.

The forks, knives, and spoons are your tools, set in order like a row of oarsmen—outside to in, one course at a time. Forks to the left, knives and spoons to the right. The bread and butter plate sits to the left, waiting above the forks, while the water glass, with its cold simplicity, stands above the knives.

When passing food, do so counter-clockwise. And do not eat until everyone is seated, until all have been served. It is a matter of honor, a matter of respect.

Nothing belongs on the table except what is meant to be there—food, drink, utensils. Elbows, notebooks, and the clutter of life are to be kept at bay, like a good fisherman knows to keep his line clear.


When you cut your food, do it no more than two bites at a time. Bread is to be torn, one bite at a time, and buttered with care—not slathered. And never, never season your food until you have tasted it.

A piece of bread can be used to soak up the last of the gravy, but only with a fork—never with your fingers. It's the way of things.


If you must leave the table, place your utensils on the edge of the plate, tips pointing inward in a V, like the wings of a bird ready for flight. When you are done, lay them side by side, diagonally across the plate, like the mast of a ship brought to harbor.

These are the rules—simple, honest, and clear. They're not just about how to eat, but about how to live.

I'm Gustavo Lira, Tasting Room Manager and Wine Buyer at The Bottle Shop in Sierra Madre with another wine and spirits selection.

Here's a wine with a unique twist – it's a red grape varietal that is made into a white wine. Let me introduce you to El Lugar Pinot Noir Blanc, Greengate Ranch SLO Coast 2023. It is not Pinot Blanc, but rather it is Pinot Noir Blanc. Pinot Blanc is a white grape varietal whereas Pinot Noir is a red grape varietal. So... how does it become a white wine? Pretty



simple process – the Pinot Noir grapes were pressed off the skins immediately to have no color influence. The skins of the grapes give color to the wine, so if you remove the grapes immediately from the skins, you will have a white wine.



Coby Parker-Garcia is the winemaker and owner of El Lugar. I have known Coby for several years now and I consider him to be one of the best winemakers on the Central Coast. He's located in San Luis Obispo, and he makes Chardonnay, Pinot Noir, Rosé of Pinot Noir, Pinot Noir Blanc, Syrah, and Sauvignon Blanc. This is 100% Pinot Noir which was fermented and aged in stainless steel barrels. The grapes are sourced from the Greengate Ranch & Vineyard located 3 miles from the Pacific Ocean near San Luis Obispo. The vineyard is Certified Sustainable.

The wine is a little pale gold with citrus and pear aromas. It's a richer white wine with a bit more body since it is a red grape varietal. Lovely apricot, orchard fruit, and citrus notes on the palate. The finish is juicy and long with some smoky elements and spice. This wine pairs well with chicken, pork

chops, and all things mushroom! Well-made Pinot Noir Blanc is hard to find - Coby made only 105 cases of this wine, so get this while you can. It's absofriggin delicious!

The El Lugar Pinot Noir Blanc SLO Coast 2023 is available at The Bottle Shop for \$39.99. Say you saw it in the Mountain Views News and get it for \$35.99 through Monday, August 19th. I will be pouring this wine on Thursday and Friday, August 22 & 23 at The Tasting Room along with wines from Aaron Jackson. I have a "crush" on Aaron and Coby – both are top winemakers who shouldn't be overlooked. I will feature El Lugar Pinot Noir Blanc, El Lugar Spanish Springs Vineyard Pinot Noir, Aaron Petite Sirah (the best Petite Sirah around imho), and Aaron Spanish Springs Pinot Noir. It's an incredible lineup from two amazing winemakers.



CHILDHOOD'S END

I hadn't been able to sleep much the night before. For various reasons, it had been a long, introspective night, thinking about my entire life, what I had accomplished, where I had failed, all the things I had done wrong, was my life worth living -- that sort of thing. I arose very early. It was Saturday, and the sun had not begun to rise over the hills to the east. It was very quiet, and I could actually feel the collective heave and sigh of relief as the city took a break from the madness of racing around day after day so you can afford to do whatever it is that you believe you'd rather be doing than racing around every day making money.

The streets were still dark, and cool, and devoid of people. I began to bicycle through the city streets, first working my way through the downtown apartment areas, and then gradually north where there were more trees and bigger yards. The mountains were glowing with the rising sun, and by now the sky was light and birds were chirping everywhere. A few cars were now on the road, and an occasional jogger whished by on the sidewalk.

The sun took its time in rising and the sky was overcast and cloudy on this early Saturday morning. A cool breeze blew down the city streets as a mountain breeze might blow down a canyon.

I turned my bicycle around and began to coast back down the hill, and after a few miles, I turned down a street where a family I knew lived. I slowly bicycled by and saw that only Jim, the young six-year-old, was out in the yard playing. Jim was the son of a friend of the family. I said hello, and he recognized me and said hello. He asked me if I wanted to see the dirt people. I got off my bike, and got down on my hands and knees, and he showed me the little tunnels and trails of the dirt people, and he showed me where they lived, and how they drove around on little pebbles. He pushed a pebble with a long stick, and made a sound like an automobile engine.

"See how they go?" he said, excited. "Make yours go," he commanded, and so I began to push a little pebble around with a stick. I had to make sounds like a car when the dirt people wanted to turn quick or stop suddenly, and I had to keep the pebble on the roads that Jim had built. Jim told me about the monsters that come out sometimes and the dirt people have to run and hide, because the monsters are so powerful.

He pointed to a little ant that had come out of a hole, and Jim gave voice to what he saw as a monster ant: a slow, deep growl as it walked along the dirt people's road. I was informed that the monster always takes the easy path along the dirt people's road, because the monster was lazy. That was its weakness, and the dirt people could use that fact to their advantage when they wage a war against the monsters.

Each pebble, each leaf, each stick, each undulation of the ground had a name and a meaning in Jim's world into which I had entered. I was lying there in the dirt with him, pushing a pebble, making sounds, and truly enjoying myself when his mother came out. "What are you guys doing?" she asked to both of us, but really to me.

Jim responded, "The dirt people are all getting together because the monsters are getting ready to invade. We watched the monsters begin the war, and the dirt people are now all trying to defend themself, right?" he looks at me.

His mother looks at me sideways, noting that I am covered in dirt as is Jim. She smiles, and says only "Oh." She just stands there and looks, and I know that it means nothing to Jim, but I feel the censure of an adult in the adult world, and I realize that I should feel embarrassment. When I think about it, I realize that I did feel a little embarrassed, but mainly because somehow I've been taught that some things are for children and some things are for adults. Adults are not allowed entry into the make-believe world of children, at least not by other adults.

So after a while, I got up, and shook off the dust. I told Jim's mother that I was just passing by, and I said goodbye to Jim. Sobered up to proper reality, I rode on, and eventually headed back home.

I had truly enjoyed myself lying there in the dirt, without video games or electronic entertainers which so many of today's youth are addicted to. We were enjoying a simple pleasure of life that required nothing but an active imagination and the ability to believe. And that's what's wrong with adults. Our bodies got older and we allowed our minds

to ossify. We put aside imagination for pragmatism, and we gave up the ability to believe for hard-earned cynicism.

That morning, I realized that childhood ends when you can no longer lie in the dirt and imagine.





From The Desk of Steve Sciurba, Safe Path For Senior

The White House described the results of its first Medicare negotiations for the price of 10 prescription drugs on Thursday.

The announcement came before the second anniversary of the Inflation Reduction Act, the law giving the federal health insurer for older Americans the authority to haggle with drugmakers over the price of their products. Completion of the first negotiations would represent a milestone for the White House, which has made negotiating lower drug prices a centerpiece of its domestic agenda.

President Ioe Biden and Vice President Kamala Harris are slated to tout the details during an event in Maryland later, casting it as a key accomplishment of a policy platform focused on easing consumer

The administration faces a Sept. 1 deadline to disclose the negotiated rates. The private discussions between federal health officials and drugmakers kicked off last October, when the nine manufacturers whose drugs were selected agreed to opt into the process. Those drugs included Eliquis, Xarelto and Jardiance, among others.

Medicare must explain how it arrived at the prices by March 1 before they kick in Jan. 1, 2026. The agency plans to finalize guidance this fall for the next round of negotiations, and it's scheduled to publish by Feb. 1 the new list of up to 15 drugs selected. The prices reached during those talks would go into effect in 2027.

Both the White House and the Harris campaign have envisioned the savings promised by the negotiations as playing a significant role in November's election. And polling has consistently shown that negotiating drug prices appeals to a majority of voters in both parties.

DOES MEDICARE COVER CATARACT SURGERY

Dear Savvy Senior:

How does Medicare cover cataract surgery? My eye doctor recently told me I've developed cataracts and should consider making plans for surgery in the next year or so. Almost 67

Dear Almost:

Like gray hair and wrinkles, cataracts are an inevitable part of the aging process. Eventually, everyone (usually

in their 60s) will develop cataracts, a condition that causes cloudy or blurry vision. The only way to correct this is through cataract surgery.

Fortunately, Medicare does cover medically necessary cataract surgery, which includes removing the cataract and implanting a standard intraocular lens (IOL). This is a small, lightweight, clear disk that replaces the focusing power of the eye's natural crystalline lens to restore clear vision. This procedure is performed using traditional surgical techniques or lasers.

This coverage can be a substantial savings, since cataract surgery often costs about \$1,800 to \$2,800 per eye.

Cataract surgery is usually an outpatient procedure, covered under Medicare Part B. Once you pay the annual Part B deductible, which is \$240 in 2024, you're responsible for the Part B coinsurance.

That means you'll pay 20 percent of the cost for covered services yourself. If you have a Medicare supplemental policy, also known as Medigap, you'll have full or partial coverage for the 20 percent Part B coinsurance.

If you happen to be enrolled in a private Medicare Advantage plan, rather than original Medicare, you'll also have coverage for cataract surgery. However, you may have to pay different deductibles or copayments and need to use an in-network provider. You'll need to call your plan to find out its coverage details before you schedule surgery.

What's Not Covered

Be aware that Medicare only covers cataract surgery with standard (monofocal) intraocular lenses, which improves vision at just one distance so you may still need glasses for close-up vision. Medicare will not cover premium (multifocal) intraocular lenses that can correct vision far away, up close and in between, so you can go glasses-free after surgery.


Premium interocular lenses are expensive, costing approximately \$1,500 to \$4,000 per eye, which you would be responsible for if you choose to upgrade. Talk with your doctor about your options and costs before your surgery.

Are Eyeglasses Covered?

Even though Medicare usually doesn't cover eyeglasses or contact lenses, it will pay 80 percent for one set of corrective glasses or contacts after cataract surgery. Medicare, however, limits its coverage to standard eyeglass frames and lenses. If you want to get deluxe frames, progressive or tinted lenses or scratch-resistant coating for glasses, you'll need to pay those costs yourself. Medicare also requires that you purchase the glasses or contacts from a Medicare-approved supplier.

Also, if you have any post-surgery complications or problems that are deemed medically necessary to address by a doctor, Medicare covers those expenses too. Any drops, antibiotics or other medication prescribed after your surgery would be covered by Medicare Part D or a Medicare Advantage plan that includes prescription drug coverage.



GOVERNMENTMANDATED VACATIONS rs has sponsored a hill to mandate pai



Sen. Bernie Sanders has sponsored a bill to mandate paid vacations for all employees.

Like so many of Bernie's proposals, it sounds good until you get into the nitty gritty.

Look, it's true, as Bernie argues, that the United States is the only advanced economy that does not require employers to provide paid vacation time.

It's also true, reports CNN, that "not only do American workers get less vacation time than workers in other industrialized countries, but they also opt to take fewer days off."

Consider: The average American worker gets about 18 paid vacation days a year and uses only 14 of them. Compare that to the French who average 37 paid vacation days a year and use nearly every one of them.

Bernie's solution, reports MSN.com, is to "guarantee at least one hour of paid vacation for every 25 hours worked and ensure full-time employees two weeks of paid vacation in addition to paid sick or family leave."

Though I don't like the government telling any of us what we must and must not do, it is true Americans need to get better at freely choosing to vacation.

I've been self-employed for most of my career, and nobody has been worse at taking

a break from their workload to recharge their batteries — but isn't that a personal challenge I should work out on my own, without the government getting involved? Back in 2014, I wrote about some interesting vacation insights shared by economist

He said that, for starters, 91% of full-time private sector employees already received paid vacations. Those who did not were typically low-tenure employees at small businesses — and new government mandates would hurt, rather than help, such employees.

Bronars said that U.S. labor law is flexible enough to allow employees to negotiate fringe benefits that benefit them and their employers.

Perhaps some employees prefer higher pay and fewer vacation times, for instance. Maybe others prefer more flexible hours.

Paid-vacation mandates would eliminate such flexibility.

Stephen Bronars in a Forbes magazine article.

Plus, he continued, by forcing employers to give paid vacations to new or part-time workers, who may not currently be receiving them, labor costs will increase.

Bronars said that our current flexibility "is an advantage, not a weakness, of our system and leads to more employment growth and greater job security than we would have if we adopted European-style labor market regulations."

In other words, the freedom of an individual and his employer to work out the terms of employment by themselves generally benefits everyone.



Whatever the case, Americans need to get better at "vacating" more often.


TheStreet reports more than half of Americans who ARE on vacations continue to work on their laptops while they are away, because they fear falling behind at work and losing their jobs.




