





PUBLIC SAFETY IN SIERRA MADRE NEWS

For the next several months Sierra Madre's Police and Fire Departments will be running a weekly segment titled, "Get to Know Your Public Safety Officer" in the Mountain View News. The purpose of this special segment will focus on our police and fire department employees and all of us to learn a little bit more about the men and women who serve our community.

DISPATCHER LILLIANA CORTEZ



Lilliana has worked with the Sierra Madre Police Department since 2018, where she started as a Community Service Officer. In mid-2019 she was promoted to her current role as a Police Dispatcher. In her short career, Lilliana has established herself as one of our most experienced dispatchers with key organizational assets. Recently, Lilliana obtained her Bachler's Degree in Sociology with an interest in Law and Society from California State University Los Ángeles. She also has specialty training as Communications Training Officer and Tactical Dispatcher with the regional tactics team Sierra Madre PD is a part of (F.S.E.T.). Lilliana has earned the reputation amongst her peers as somebody that is a dedicated hard worker, extremely professional, and somebody that truly cares about the people she works with and the community she serves. Let's learn a little more about Lilliana.

What made you want to become a Police Dispatcher?

I actually didn't want to be a dispatcher at the start of my law enforcement career. I always wanted to be a police officer. It wasn't until I started working

as a Community Service Officer with Sierra Madre Police that I saw what it really meant to be a Police Dispatcher. I always had a calling for helping people in need, so when I was given the opportunity to become a Police Dispatcher with the Sierra Madre Police Department, I jumped at the opportunity and never looked back.

Why did you choose to work for the Sierra Madre Police Department?

I worked at a bigger agency before coming to Sierra Madre. By chance I was given the opportunity to apply to become a Community Service Officer here. I knew after only a couple of months working here that this town was different than any other. The love and support I receive from this Police Department really make me feel welcome every day, and that is the reason why I chose to work here.

What do you like best about your job and role as a Police Dispatcher?

I would say the thing I like the best about by job is knowing that I have and can continue to make a difference in people's lives. Whether it's something big or small, I know that when they call into Dispatch, emergency or not, they are asking for help, and I am the one that gets to make their day just a little bit better.

What would you say is the hardest part of your job?

I would say the hardest part of my job is having to always mentally stay ready for what the shift will bring and not letting the outside world affect that.

It's been said that in order to successfully do the job of a Police Dispatcher, you have to have the ability to multi-task. Can you briefly provide examples or "paint a picture" for our readers, what is meant by this?

Being a Police Dispatcher does take a lot of multi-tasking. Here in Sierra Madre, we work alone, so we do not have a partner like most other agencies. That means we have to handle both the phones, emergency and non-emergency, and the radio at the same time. When there is an emergency going on, for example a traffic accident with injury, we will receive multiple people calling trying to report the accident. Some will call 911 and some will call the non-emergency line. It is our responsibility to filter all those calls, take down the pertinent information, dispatch officers, and keep them updated with any new information we receive. We also have to relay the information to the Fire Department so they can assist as well. That is just one call for service. If there happens to be another emergency happening at the same time or shortly after, we have to shift focus and repeat the process all over again, but at the same time continue to monitor the original call. So yes, being able to multi-task in extremely stressful situations is needed in order to successfully do this job.

What's the most heroic moment you've experienced on the job?

I have had a couple of moments I would say I felt heroic but my most memorable to date would have to be when I was able to help a young female escape a home from a very dangerous situation without being harmed. I stayed on the phone with her for over 30 minutes before we were able to successfully extract her safely.

At approximately 10:00 AM, officers responded to the 200 block of West Sierra Madre Blvd. to meet with a citizen who fell and suffered and injury at Memorial Park. Sierra Madre Fire Department (S.M.F.D.) was already on scene treating the male. The male stated while walking with his walker, he released the brake which caused the walker to roll forward causing him to fall. Officers took a report and checked the location.

Wednesday, August 21 General Incident

At approximately 2:30 PM, officers responded to the 50 block of East Laurel Ave., in regards to a possible vehicle burglary report. The citizen stated she left her home to run errands and when she returned, she discovered a window on her vehicle shattered. The officers canvassed the area and located a camera, based on the officers investigation, it appreared no one entered the vehicle and the citizen stated nothing was taken. It appereared the damage was caused by an unknown means and appeared accidental. Officers took a report for documentational purposes.

Friday, August 23

At approximately 5:00 PM, officers responded to the 100 block of West Highland Ave. to meet with a citizen regarding a theft report. The citizen stated unknown suspects entered her unsecured vehicle and took her property. Later, the suspect(s) returned her property. The victim was unable to see the suspect(s) and there were no cameras in the area. The victim is desirous of prosecution if the suspect(s) are located. The case has been forwarded to the Detective's Bureau for a follow up.

Saturday, August 24 Family Offense

At approximately 12:00 AM, while on patrol at the intersection of Baldwin Ave., and Grandview Ave., officers observed a stop sign violation. As the officers attempted a traffic stop with their emergency lights on, the vehicle failed to yield and continued to drive to their residence in violation of evading a peace officer. The driver then exited the vehicle and began running. Officers gave verbal commands to stop and get back in the car, in which he ignored and continued to run towards a fence and into the residence. Upon investigation, officers located a 1 month old child left unattended in the vehicle with multiple open alcoholic beverages. The vehicle was impounded for evidence. The case is under ongoing investigation.



INGREDIENTS

½ cup chopped celery (chop small for easy eating)

1 cup red grapes

1 medium chicken thigh (boneless, skinless) ½ cup Greek yogurt (or non-dairy yogurt)

3 tbsp. almond slivers

½ medium lemon (juice and zest) 1½ tsp. Dijon mustard (no sugar added)

1 medium bunch fresh parsley

1 tbsp. extra virgin olive oil (to grease the skillet) ½ tsp. salt (or to taste at serving)

INSTRUCTIONS

Rub the chicken with salt and pepper (or any spices you want to use) and leave it for 20 minutes at room temperature.

Grease a grill pan with olive oil and fry the chicken thigh on both sides until browned, and the chicken reaches at least 165 F. on a meat thermometer. Cut it into strips and set it aside.

Cut each grape in half or into quarters, as you like. You can remove the seeds if your grapes have them. Chop your almonds as well.

Cut grapes on a cutting board.

Grate and juice the lemon into a bowl. Add the zest to the yogurt and mustard. Add a pinch of salt and stir the sauce until smooth.

Dressing ingredients in a small, green bowl.

Place prepared ingredients in a salad mixing bowl, add chopped parsley, and mix. Taste the salad for salt and leave it in the refrigerator for 1 hour.

Place whole-grain crackers and lemon slices on the edge of a serving plate. Arrange the salad in a loose mound, drizzle with the dressing, and serve.

The Altadena Library Foundation has supported and strengthened the mission and resources of



THE TASTING ROOM **INCREDIBLE SPANISH** GARNACHA

I'm Gustavo Lira, Tasting Room Manager and Wine Buyer at The Bottle Shop in Sierra Madre with another wine and spirits selection.

I love it when I come across a wine that is new to me that is delicious and over delivers. Furthermore, I love introducing such wines to all of you. This week's wine is a prime example of that - Sindicat La Figuera 2021 from Montsant Spain. It's from the husband-and-wife team of Sara Perez and Rene Barbier - who are





These two come from families of outstanding winemakers. Sara's father and Rene's father were part of the group known as the "Gang of Five." This group is credited with the reemergence of Priorat as a fine wine region of Spain. Clos Mogador was founded by René Barbier, and Clos Martinet was founded by Josep Ll. Pérez. Priorat is almost surrounded by Montsant which is where this wine originates.

Montsant's vineyards vary from some located on steep terraces at altitudes

between 164 and 2,300 feet above sea level. There is intense Mediterranean sunshine during the day and cool temperatures at night. The soil is mostly granite and slate. Montsant has a reputation for high-quality red wines that are very expressive with tons of character.

The Sindicat La Figuera 2021 is 100% Garnatxa Negra and the grapes are sourced from vineyards near the town of La Figuera. The elevation of the vineyards is 1,800 feet and the vines' average age is between 30 to 80 years old. The vines are farmed biodynamically, there is minimal intervention in the cellar, native yeasts are used, minimal sulfites are added, and the wine is vegan.

The wine's aroma is gorgeous – notes of white delicate flowers and white pepper. The mouthfeel is light and delicate. On the palate, you get more white pepper, citrus, and floral notes. It's a clean, fresh, and very balanced wine with pleasing natural acidity and subdued alcohol. I'd pair this wine with salads, seafood, grilled sausages, and savory meats.

This wine is an incredibly delicious wine that is a tremendous value. One of the better grenaches I have had recently. Don't wait too long, this is going to sell out fast!

THE SIX SECOND KISS

Most kisses shared may be short and sweet. Perhaps you are running off to work, in the middle of cook-

ing, or about to go to sleep. Lengthening kisses to six seconds could be a key to a better relationship. Dr. John Gottman says it's long enough to make a moment of connection with our partner. It stops the busyness in your brain and puts your focus on your partner at that moment. There doesn't have to be talking, listening, or problem-solving. It's just a time to connect with your partner physically and feel close to them. It also accomplishes a lot of principles and needs in our relationship in only six seconds.

What the six second kiss can do for you

The more you practice an elongated kiss, it can also become a habit. A six second kiss is one of the least time-consuming ways to improve things with your partner. In fact, if you have two kisses per day the total time per week amounts to less than 90 seconds

So, keep kissing. It has the potential to benefit the overall health of your relationship. A study of 70,000 people in 24 countries conducted by sociologists determined that small gestures to show love throughout the day have a major impact on couples' longterm happiness and success. Though 6 seconds is the minimum time, Gottman says, has an effect, that doesn't mean you literally need to count to six in your head before stopping. Above all, it's a way to make sure that people connect in a meaningful way every day. Just "relax and enjoy the kiss." Dr. Gottman suggests saying some sweet things to your partner before and after the kiss. Sharing something positive with each other like 'I love you' or 'I'm so happy to be with you.,"

The 6-second kiss symbolizes love, devotion, and partnership in the journey toward deeper intimacy and connection. By embracing this simple yet profound practice, couples can unlock new levels of emotional closeness, passion, and fulfillment in their relationships.

As John Gottman aptly summarizes, "In the end, it's the small moments of connection that make the biggest difference." So why not start with a kiss?

Approach each kiss with genuine affection, presence, and mindfulness, focusing on the connection with your partner.

Experiment with different settings and contexts to keep the practice fresh and exciting.

Communicate openly with your partner about the significance of the 6-second kiss and the impact it has on your relationship.

Embrace spontaneity and creativity, allowing the ritual to evolve organically over time. A six-second kiss is an easy, practical way to build connection.

TOM BROWN JR.: JANUARY 29, 1950-AUGUST 16, 2024

Those of us in the field of outdoor education are familiar with the famous New Jersey tracker, Tom Brown Jr., who died last week. Brown was somewhat controversial, and highly revered by his many students.

Brown gained popular attention in the late 1970s after the publication of his first book, "The Tracker," and his school that he founded in New Jer-sey's Pine Barrens where he grew up. Tom describes his early days in his first two books, where he thought about what he would do with his life. He and his childhood friend were already good naturalists in their teens, having learned and honed many of the outdoor skills right in his own expanded back vard.

I began to hear about Brown around the late 1980s, and I often read an article about Brown to my students which described Brown's year that he spent living primitively in the wilderness. Brown's story is very inspiring, and best told in his "Tracker" book. I found it very invigorating and it re-vived my interest in outdoor education, and often shared some of those details with my own students. Brown was fascinated with the art of track-ing, the art of reading animal and human footprints, and inspired a gen-eration of students to do likewise.

I knew a man who lived as a camp host in the Angeles National Forest for 10 years, and he told me how he spent some time with Tom Brown Jr. in his early days of teaching. My friend, Bear, told me that time with Brown involved primarily being cold and hungry in the woods, and doing everything you could to overcome those. Indeed! And in order to cater to the growing number of students who came to him, Brown developed a detailed curiculum and a talented staff who took the students well be-yond the basics of fighting cold and hunger. They learned to make fire with the bow and drill, build primitive shelters, make eating implements, purify water, and of course, how to track animals.

I never had the opportunity to meet Mr. Brown, though we'd both been writing for Mother Earth News and other magazines.

Brown was the son of a preacher, and was often accused of being like a preacher himself, and has even been compared to a Marine drill ser-geant! His personality was intense, and he must have really loved the fact that he was able to spend his life pursuing those simple skills that he loved as a child. He once wrote that he wanted to pass along to his stu-dents those skills that he was privileged to learn in his childhood. He la-mented the fact that modern development in the Pine Barrens was slow-ly eating up the very wilderness where he loved to camp and to teach, so it was harder and harder to replicate his early experiences.

His school was very popular, with typically 80 students crammed into his barn for all day instruction. The courses he offered were five day clas-ses where you camped on-site and learned the skills by living them, rain or shine. Perhaps the best description I've read of a week with Tom Brown Jr. was described by Neil Strauss in his "Emergency" book.

Tom Elpel, author of "Botany of a Day" and other outdoor books, writes about Tom Brown Jr.: "As a story teller, it wasn't always obvious where truth left off and story began, but it didn't matter. It was a form of mass coyote mentoring. Myself and millions of other people were inspired to seek a deeper nature connection through wilderness survival and track-ing from Tom Brown's stories. I had a tracking box in my bedroom as a teenager. I spent much of my teenage and young adult years trying to learn how to live in the wilderness with only a knife. My grandmother and I flew out to New Jersey to attend the Standard Course at the Tracker School in 1985 when I was 17. The intro class seemed a little too basic for me by then, but I've always been glad we went. Thank you Tom Brown Jr. for all you contributed to the world."

Tom wrote 11 articles for Mother Earth News, and 19 books. The books could be divided into two categories: guide books, and autobiographical books. The guidebooks are enjoyed by many, and are without contro-versy. Of the autobiographical books, "The Tracker" is the best, and I highly recommend it.

The controversy about Brown has to do with his legendary mentor, an Apache named Stalking Wolf, grandfather of Tom's best friend Rick. Stalking Wolf is said to have died when Tom was 17, and Rick was said to have died in Europe shortly thereafter. Detractors of Tom Brown Jr. have doubted the existence of Stalking Wolf and sometimes of Rick. However, Brown's many students and followers have focused on the ac-tual practical teachings from





HOW TO FIND LEGAL HELP WHEN YOU CAN'T AFFORD A LAWYER

Dear Savvy Senior: Can you recommend any programs or organizations that provide free or lowcost legal services to seniors? I believe I

need some professional legal help but have limited income and very little savings. Almost 70



Dear Almost:

Whether you need help drawing up a will or a contract, or you're facing some sort of legal jeopardy or dilemma, hiring an attorney can be expensive. Most lawyers today charge anywhere between \$100 and \$300 an hour. Fortunately, there are a number of different programs and organizations that offer free legal advice and may help you find a free or lw-cost attorney. Here's where look for help in your area.

Legal Aid: Directed by the Legal Services Corporation, legal aid provides free legal assistance to low-income people of all ages. Each community program will differ slightly in the services they offer and income qualifications. Visit LSC.gov/find-legal-aid to locate a program near you.

LawHelp: Powered by Pro Bono Net, a national nonprofit organization, LawHelp.org is a terrific resource that will help you locate free legal aid near you, get answers to your legal questions and even fill out legal documents. These free services are for people with low to moderate incomes.

Free Legal Answers: This is an online program created by the American Bar Association that matches lowincome clients with volunteer lawyers who agree to provide brief answers online for free. This service will not answer criminal law questions and it's not available in every state. See ABAfreelegalanswers.org to look for a program in your state.

Senior Legal Hotlines: There are around 30 states that offer senior legal hotlines, where all seniors over age 60 have access to free legal advice over the telephone. To find out if this service is available in your state, g o to ProSeniors.org and click on "Resources," followed by "U.S. Senior Legal Hotline Directory."

Senior Legal Services: Coordinated by the Administration on Aging, this service may offer free or low-cost legal advice, legal assistance or access to legal representation to people over the age of 60. Your Area Agency on Aging can tell you what's available in your community. Call the Eldercare Locator at 800-677-1116 to get your local number.

Local Law Schools: More than 200 university law schools across the country have pro bono programs that offer free legal assistance provided by law students, who are supervised by their professors. See American Bar. org/groups/center-pro-bono - scroll down and click on "Directory of Law School Public Interest and Pro Bono Programs" to locate a program near you.

Pension Rights Center: This is a nonprofit consumer organization that provides free legal assistance for problems with pension, 401(k) or other retirement plans. Go to PensionRights.org/find-help to search for help in your state.

Stateside Legal: For military members, veterans, and their families, StatesideLegal.org provides access to free legal information and legal assistance in your area.

National Disability Rights Network: This is a nonprofit membership organization that provides legal assistance to people with disabilities through their Protection and Advocacy System and Client Assistance Program. If you are disabled, visit NDRN.org to find help in your state.

Other Options: If you can't get help from one of these programs, or find that you aren't eligible, another option is to contact your state or local bar association to see if there are any volunteer lawyer projects in your area or if they can refer you to a low-fee lawyer. To contact your state or local bar association, go to FindLegalHelp.org.

DOCTOR - COULD YOU REPEAT THAT?

For the first time in my life, I've been having health issues. It was nothing serious, but just enough to be aggravating.

The Gracious Mistress of the Parsonage has been very helpful with my medical issues. She arranges all of the medicine I'm supposed to take every day; otherwise, I probably wouldn't take any. She often asks me, "How are you today?" I look at her, smile, and say, "I'm fine." "No, you are not fine. Now take your medicine." Obviously, she doesn't think I'm fine, but I guess I'm fine with that.

My health issues are very superficial, at least from my perspective. I get up in the morning, eat everything I can get a hold of, take a little nap in the afternoon, and do whatever I want to do. No matter what I do or don't do, I am still "not fine," according to The Gracious Mistress of the Parsonage.

When I have a doctor's appointment, she usually accompanies me be-cause she knows I will not remember anything the doctor says. Of course, she is absolutely truthful about that. I hear what my doctor is say-ing, but I'm not always listening to what he says. The only thing I hear from the doctor is, "You're doing fine; keep up the good work."

Most health issues had to do with getting old. The older you get, the more your body seems to wear out. So, I'm going to continue getting as old as I can, even if it means hobbling down the road of life. I noticed something rather interesting. Whenever I go to see a doctor, he or she is always looking for what's wrong with me. I never had a doctor examine me to find something that was right with me.

I know what that means, of course. If there's nothing wrong with me, the doctor has no job. If he does find something wrong, no matter how small, he at least has a job.

Several years ago, before I had these health issues, I went to my doctor every year for an annual checkup. Every time I went, the doctor ended the session by saying, "Somebody your age should have something wrong with them." He was always trying to find something wrong with me. It's a good thing I wasn't seeing a psychiatrist. I remember something happening at one of my yearly visits to the doctor. It was on a Monday, and the day before, I had an episode of shingles on the right side of my body. At the time, I didn't know what it was.

When I went to see the doctor on Monday, I showed him some of the marks on my right arm, and I've never seen my doctor so excited. He said, "Let me examine that. Something must be wrong." Well, he examined it and re-examined it, and every time he examined it, his smile got bigger and bigger. Then, after his examination, he said, "You have been hit with the shingles.'

Of course, I didn't know what that meant at the time, but he explained it, and every other sentence was a giggle. I'm one patient who never had anything wrong with them and finally has something wrong with him. That's what my doctor lives for.

That was over five years ago, and it seems like my health went downhill after that. Not too much, just enough to be aggravating. I did spend sev-eral days in the hospital. I had a heart attack and had to have a stent put in. I had the Covid episode, which kept me locked in my house for two weeks.

In spite of all of that, I seem to be getting back to some good health. I still have to have regular six-month physical checkups. I have a series of doctors that I have to see, and that just is life.

Last week, for example, I had my six-month appointment to see my heart doctor. I had some tests taken a week before, and he was going to re-view them for me at this appointment. He went through all of the regular processes, examined my report, and finally, he was finished. As he was closing up my file, he simply said, "Sir, you are good." I looked at him and said, "What did you say doctor?" "I said, you were good."

Looking at him and then back at my wife, who was with me, I said, "Doc-tor, could you repeat that last word for me so my wife can hear it?" He looked at me, my wife, and then laughed and said, "good."

I looked over at my wife, who was not smiling then, and said, "My dear, did you hear what the doctor said? Do you need the doctor to repeat it? Looking at me with no smile, she said, "I heard everything the doctor said."

As we left the doctor's office, I smiled and said as I walked out, "I'm good." Let's see how The Gracious Mistress of the Parsonage can han-dle that one.

For many years my favorite Bible verse has been, Proverbs 17:22, "A merry heart doeth good like a medicine: but a broken spirit drieth the bones"

I realize there are many problems in life, but my focus should not be on that, but on the God who is bigger than any problem I might have. My faith in God creates a merry heart in my life.

PUT THE LIGHTS ON SERENDIPITY

Do you know the word? Please do not confuse it with "synchronicity" which is similar but markedly different. Synchronicity refers to one moment in time wherein seemingly unrelated events occur simultaneously and

yet are upon reflection deemed to bring delight or make us sit up and take notice. Synchronitious events occur concurrently; they are highly improbable coincidences with no seeming causal link but may turn out to have great significance in our own life. "Serendipity" is very different. It is an occurrence which at the moment has no particular positive significance but is later revealed to be highly advantageous.

The most frequently described example of serendipity is the scientific discovery which has had an extremely positive effect that has benefitted all of us. I am describing the discovery of penicillin which is considered to be one of the most important scientific discoveries in the history of medicine. The story of the discovery has been described as "The yellow brick road to penicillin: a story of serendipity" and is understood to have resulted in the subsequent creation of antibiotics. These antibiotics have saved multiple millions of lives; but my point is that at the time of its discovery penicillin was not thought of to have any positive consequence. The discovery resulted from a chance realization by Alexander Fleming who had gone on a vacation after failing to clean up a mold spill.

Upon returning home some time later he observed that bacteria from another adjacent lab had flown into his lab and multiplied. He observed that evidence of the bacteria was everywhere except for a spot where the spilled mold remained. He determined that the mold had killed the bacteria but at first did not realize the significance of the discovery. With the help of other scientists in other fields the significance of the bacteria-killer (antibiotic) was identified and understood, and Sir Alexander Fleming was awarded the Nobel Prize, and the rest of the world has benefitted.

The serendipitous event that I am now going to describe has, I believe, an importance to me as the chance discovery of penicillin. On June 27, 2024, my wife and I were of a plane flying home from Boston. On the plane there were television screens showing the ongoing debate between President Biden and ex-President Donald Trump. President Biden looked terrible. He appeared old, feeble, and confused. During the prior months I had agonized over President Biden's condition and was certain that he would be defeated in the coming election. President Biden had emphatically stated his refusal to step aside.

If President Biden were to be the candidate, I was certain that Donald Trump would be elected President. Prior to the Debate all polls reflected the likelihood that Trump would be elected and I, and almost everyone I knew, was in despair. 
How often does lightning strike? Worldwide about 8.6 million strikes a day. Do the math and that's 100 strikes per second.




