CITY SEEKS SPECIAL ASSESSMENT AGAINST ABANDONED PROPERTY

City Council approved Resolution 24-62 confirming public nuisance abatement costs and authorizing the city staff to record a special assessment and/or lien against a Sierra Madre property to recover city

The abandoned property, located on Alta Vista Drive, has been the center of attention due to complaints by neighbors over the condition of the property and the sighting of a bear living at the house, which was dubbed "Jurassic Bear" for learning how to open doors like the velociraptors similarly did in the 1993 hit movie "Jurassic Park." But, in this instance, the bear broke the window to enter the home, according

The Los Angeles Times featured the property in a September 2024 article, stating that the plot was covered with shrubs and downed trees and that a BMW was sitting in the driveway collecting dust. Foul smells emanated from the house, and the city has been sending violation notices since 2019, according to a report from City Manager Jose Reynoso, with no response from the homeowner, Steven Gaiser, who moved to the state of Washington.

According to City Attorney Aleks Giragosian, the city tried many times to reach the homeowner through phone calls, mail, and email but has not received a response. Giragosian addressed the issue during the City Council meeting on October 8,

Several notices have also been posted at the property. Giragosian stated that Mr. Gaiser has been paying his property taxes. "At this point, the city staff is seeking your approval of this resolution in order to work with the county to record a special assessment against this property so that the city can recover costs next time this property's property taxes are assessed," said Giragosian.

The city has recently taken action at the property by removing the high shrubs and debris outside the house, which is considered a fire hazard, cleaning up feces and dead animals, and decomposing food

Now, the city wants the property owner to reimburse \$18,003 in administrative, contractual, and legal fees associated with the public nuisance abatement, as the Sierra Madre Municipal Code allows.

As for "Jurassic Bear," who moved into the house in early August, the California Department of Fish and Wildlife attempted to capture it on August 14, but the bear was not home at that time.

The next day, the City's Code Enforcement Officer found the property to be a public health hazard and issued a Notice of Nuisance Abatement Action stating that after judicial approval, the city would have the right to remove rubbish, clear brush, remove biological hazards, and board up the property's doors and windows, which they did. Once again, Mr. Gaiser did not respond to the notice.

According to the Municipal Code, "The charge or cost of removal of the abatement of the nuisance by the city shall constitute a lien against the property occupied by the person maintaining the nuisance and a personal obligation against the owner of the property pursuant to Section 38773 of the California Government Code."

Resolution 24-62 passed unanimously.

As for "Jurassic Bear," its whereabouts are unknown. But keeping doors locked may be a good suggestion.

WHY THE URGENCY WITH BALLOT MEASURE PS

From 1921 until 2007 the fire and medical services to the City of Sierra Madre were provided by a committed and dedicated group of volunteers with almost no budget impact to the city. In 2007 the residents of our city voted to receive Advanced Life Support (Paramedic) services which caused a strain on the city budget. The UUT was implemented to support the Paramedic Program and further staffing costs for police personnel.

For several years the volunteer department struggled to keep volunteers in place. By 2015 Sierra Madre could no longer adequately staff the fire department in order to respond to calls and the city then considered contracting the fire services to another entity such as Arcadia, maintaining our own department, or exploring various options. Residents of the city made their wishes clear that they wanted to maintain our own public safety departments.

The City Council, struggling with budget increases and revenue issues, created by the UUT sunsetting from its 10% level to 8% and it was heading to 6% the next year, created a citizens group to analyze the city's future revenues and rising costs. The Group presented their findings and recommendations to the City Council on September 22, 2015. Their findings indicated that the UUT should be increased to at least the previous level of 10%, and a stable revenue source such as a parcel tax was urged for the future if the city was to maintain our own fire department.

On September 1, 2019, the city chose to implement a career fire department. A full-time career department is a huge budget increase for the city and the department has been struggling to recruit and retain good, qualified people since they were earning 12-25% less than the comparable cities. To stop the continuous revolving door in both our police and fire departments, salary increases were applied to both departments. It took major efforts on the part of both departments (2019 to April of 2024) to get the staffing numbers up to what was needed.

There has been a lot of criticism on social media as to why the City Council did not address this matter sooner. The City Council has been addressing this matter for years, looking for ways to generate additional revenue for the city and cutting costs where possible. No one could have predicted the massive nationwide staffing shortages in fire and police departments across the country and most especially in Southern California. All the departments in our area are struggling to keep their staffing numbers in place. Some departments are so desperate to get people to work they are offering sign-on bonuses and luring people away from other departments. This is creating a crisis in smaller cities who are desperately trying to maintain their personnel. Sierra Madre can't compete in this arena, and we have a fire and police department that are highly trained, qualified and professional. They are working in Sierra Madre because they understand how wonderful our city is.

Our city is a wonderful place to live in large part because of our public safety departments. Our city is a safe place to live where people feel safe walking on our streets, our crime rates are low, and parents feel comfortable allowing their children to be downtown and being with their friends. People and businesses are not being hassled by homeless people camping in our parks and doorways.

A group of concerned citizens partnered with the police and fire unions and agreed to work towards generating a measure that would provide for additional revenue for our city to maintain stability in our police and fire departments. This committed group was able to attain the signatures required to get Ballot Measure PS on the November ballot.

There are those on social media who are stating that this is a scare tactic by the city and why don't we just have sheriffs like La Canada. First and foremost, this is a citizen's initiative by a group of concerned citizens and our public safety departments. This is a critical time for our city because if we can't maintain the staffing in our departments they can't function in their capacity.

For the record the Long Beach police department is one of the hardest hit and is down several hundred officers from their staffing requirements. You see crime rates soaring and burnout in their departments.

For those of you who feel that we should just go to sheriffs and county fire which is what La Canada has please be aware that you will be getting less service and have line items for those public safety services much greater than Measure PS. The property tax bill in La Canada has line items to cover their public safety costs and a additional direct assessment. The information that I received was \$3,000 for one million is property assessment.

Time is of the essence. Please vote YES on Measure PS to help protect our city!

ABOUT THE MEASURE

The Public Safety for Sierra Madre Measure is a citizen-led initiative to raise the necessary funds to keep Sierra Madre safe. Without additional funding, our police and fire departments could be at risk of closing and being outsourced to county agencies.

The measure raises over \$2 million over the next 7 years by issuing a parcel tax on lots throughout the city. These funds would be subject to strict auditing that protects your tax dollars and ensures that funds stay in Sierra Madre to keep our city safe

The following represents a summary report of some of the major incidents handled by the Sierra Madre Police Department during this period. This list is not intended to be considered exclusive or all-inclusive.

Sunday, September 29 Auto Burglary

At approximately 1:30 AM, officers responded to the 600 block of West Sierra Madre Blvd regarding suspicious circumstances. A citizen reported he saw a vehicle trunk open and a man walking away from the vehicle. Officers arrived on scene and noticed the vehicle's trunk open along with the passanger door. Officers met with the owner of the vehicle who stated she was missing various items from her vehicle. Officers canvassed the area and were able to locate the subject who had the vehicle owner's possessions still on him. The victim was able to identify her belongings and the items were given back. The subject was arrested and transported to Pasadena Jail. The case has been forwarded to the District Attorney's office for filing considerations.

Sunday, September 29 Traffic Accident

At approximately 12:30 PM, officers responded to Santa Anita Ave and Arno Dr for a traffic collision. Based on the officer's investigation, it appeared the citizen caused this collision by failing to properly place her vehicle in park while leaving it unattended, in violation of an unattended Vehicle on the Highway. Officer's took a report and documented the damage.

Wednesday, October 2 Vehicle Stop

At approximately 5:00 PM, while on patrol, officers conducted a traffic stop on Baldwin Ave and Orange Grove Ave. The vehicle was stopped for expired registration tabs. A records check of the vehicle showed the registration had been expired since 2020, and the vehicle was displaying 2023 registration tabs. Officers removed the 2023 registration tabs from the vehicle and booked the registration tab into evidence. The driver was cited and released into the field.

Saturday, October 5 Injured Person

At approximately 12:00 PM, officers responded to the 200 block of West Sierra Madre Blvd in regards to a citizen who fell and sustained injuries. Sierra Madre fire department was on scene and treated the citizen. She declined medical transport. The citizen stated her foot caught the raised concrete which caused her to fall forward. Officers took a report for documentation purposes.

Saturday, October 5 Vehicle Violation

At approximately 2:40 PM, while on patrol, officers conducted a traffic stop on the 3000 block of East Sierra Madre Blvd for a vehicle without license plates. The driver told officers his license was expired, a records check revealed his license was suspended. The vehicle was displaying temporary paper plates which did not return back to the vehicle. A records check of the vehicle showed the registration had been expired since 2023. The driver was cited, and the vehicle was towed.

Saturday, October 5 Stolen Vehicle

At approximately 10:30 PM, officers responded to the 200 block of North Grove St in regards to a stolen vehicle investigation. The vehicle owner stated he did not give anyone permission to take, use, or drive his vehicle. The suspect who took the vehicle is known to the citizen. The case has been forwarded to the Detective Bureau for follow-up.

"With one in three California adults experiencing some form of intimate partner violence during their lifetime, the Commission on the Status Women is dedicated supporting survivors and providing access to city resources needed to overcome abuse."

The Commission on the Status of Women is collaborating with three community organizations that provide direct services to survivors of domestic violence to present the Light a Candle event. Organizations include YWCA Glendale Pasadena, Shepherd's Door and Peace Over Violence.

According to crime statistics published by the California Department of Justice through the Open Justice initiative, domestic violence-related for assistance have been steadily rising in the City of Pasadena over the past ten years, with a particularly sharp increase in weaponinvolved reports from 2022-2023, the most recent year of available data.

Polytechnic School Halts the PolyFields Project in Altadena

In a public letter to the community Tuesday, Polytechnic School in Pasadena, stated that they are officially withdrawing the land use application to the County of Los Angeles for the embattled PolyFields project in Altadena.

Poly Fields would have also included outdoor lighting for night events, amplified sound, and a 208-vehicle underground parking structure.

PPHD Advises Take Steps to Avoid Coyote Conflicts



Pasadena Department (PPHD) encourages the community to avoid coyote conflicts by taking precautions that can help protect themselves and are found throughout City neighborhoods and live among Pasadena natural resources, homes, and businesses.

"Coyotes are naturally fearful of people and typically go out of their way to avoid human Acting interaction," said Director of Public Health, Manuel Carmona. "When coyotes are comfortable around humans, it is a strong sign that someone nearby is intentionally or inadvertently feeding them."

Adolescent coyotes leave their dens late summer or at the start of fall, due to pack leaders forcing adolescent coyotes out of their packs. As they begin searching for their own territory or a new pack to join, the possibility of coyote activity in Pasadena neighborhoods increases.

Coyote hazing is a great way to maintain coyote's fear of humans and involves using deterrents to move coyotes out of an area or discourage coyote behaviors. Residents who work with their neighbors to establish a consistent culture of hazing will be more successful in keeping coyotes at a distance. "We all have a role to play in maintaining coyote's fear of humans and hazing is the most important action we can take to safely coexist with coyotes," said Carmona.

Follow these hazing tips when encountering a coyote to help ensure you and your family's

- Make yourself appear large, stand your ground, and force the coyote to leave; never turn your back or run away from a coyote but ensure they are not cornered and always have an exit route.

- Maintain eye contact and make the coyote feel uncomfortable. - Pick up small pets and young children off the ground, and stand your ground while facing

the coyote. - Be aggressive by making loud noises such as yelling, using an air horn or other noisemaker, clapping, or banging a pot and

Shine bright lights, spray water, open and close an umbrella, or throw tennis balls in the direction of the coyote. "It is important to create a

Health hazing to prepare for the possibility of encountering coyotes when walking pets," said Director of Wildlife Education and Services of Pasadena Humane, Lauren Hamlett. "This their pets from coyotes. Coyotes includes always staying present and aware, leashing pets, and never placing pets in situations where they are vulnerable to wildlife interactions."

Take steps to be a more alert pet owner:

Walk your pets on a 6-foot or shorter fixed-length leash. Retractable leashes do not provide sufficient control over pets and should be avoided.

In the spring and summer, be on the lookout for coyotes and avoid areas where they are frequently seen, which may indicate a den site.

Keep cats inside or consider using an enclosed outdoor patio space to help protect cats. Supervise dogs outdoors or keep them in enclosed areas.

Remove all attractants from your property including outside pet feed, unsecured trash, messy bird feeders, and fallen fruit.

PUSD MAXIMIZES FUNDING TO ADVANCE STUDENT ACHIEVEMENT

The Pasadena Unified School District leadership remains deeply committed to maintaining a quality education for our students while resolving the district's budget shortfall due to the expiration of one-time COVID relief funds and lower-thanexpected State revenue.

Our priority is to increase our students' proficiency in literacy and math and advance their college and career readiness in an environment that prioritizes their well-being.

PUSD's final budget for 2024-25 included measures to ensure fiscal stability for the next three years and achieved positive certification from the LA County Office of Education. The effort continues through the 2026-27 fiscal year to meet our goal of long-term budget sustainability. Like other districts across California, we are currently spending more than we are bringing in in revenue, or deficit spending. PUSD's responsible fiscal stewardship during the pandemic allowed us to grow our one-time reserves.

While we are fortunate that these one-time reserves are sufficient to cover the deficit this school year, we are projected to fully exhaust our reserves, and, in fact, have negative reserves, by the end of next school year if no actions are taken. We are facing difficult choices, but the work has already begun.

We have already made progress in our deep review of our district's financial practices and operational efficiencies and are adjusting to improve both the short and long-term budget outlook In continuing our work, we are fulfilling our commitment to engage our community through the Superintendent's Budget Advisory Committee, gathering a wide range of views on our progress and future. The Advisory Committee is helping identify priorities and will provide valuable recommendations.

Here are some key steps we have taken as part of the district's Fiscal Stability Plan that strengthen the district's fiscal stability by 2026-27 and beyond:

- As a result of reductions to the 2024-25 budget, we realigned the services of central office staff and moved them to schools and classrooms
- We achieved reductions as possible by attrition through retirements and closing of vacant positions;
- We are reviewing hourly payroll expenses and working to bring some contracted services in-house

On the other side of the ledger, we are actively enhancing revenue by increasing attendance, managing assets, and offering services to other districts. This is wide-ranging and creative in developing additional revenue to offset necessary budget reductions. These have been crucial steps in our budget, a demanding task involving the Board of Education and our PUSD community in the decision-making process.

The PUSD Board of Education fully understands its responsibilities and works closely with staff to address this critical issue. Budget stabilization is a long-term process with many steps along the way to fiscal solvency, at the same time protecting the learning of the students entrusted to our care.

Our path to fiscal stability has been challenging and is ongoing. We are committed to making our district stronger and more efficient in serving our community of students and families/caregivers. This effort will continue through the 2026-27 fiscal years to meet our goal of long-term budget sustainability.

We are proud of our teachers, administrators, and staff and their professionalism. We are committed to ensuring fair and equitable compensation for our valued employees.





The atmosphere is casual, yet there's something undeniably authentic about the space. The staff are attentive, and Vic himself makes sure everything runs smoothly.

What to Order: Let me start by saying, as someone born in Greece, I have a soft spot for authentic Greek flavors. A must-try is the Greek Village Salad—this is the real deal, folks. No lettuce, just fresh tomatoes, cucumbers, onions, olives, and feta cheese, all drizzled with olive oil and herbs. It's as authentic as you can get, and a refreshing option for anyone seeking a true taste of Greece.

Now, while Corfu offers all the Middle Eastern staples—hummus, gyros, boreg—it's their kebobs that steal the show. My personal go-to is the chicken kebob, which is tender, juicy, and perfectly seasoned. Whether you're there for lunch or dinner, the kebobs are a standout. Pair them with a cold bottle of Hillas, a Greek beer that is both crisp and delicious.

Greek Siesta Time: A word to the wise—Corfu takes a well-deserved siesta from 3 PM to 5 PM daily, so plan your visit accordingly. It's a nod to the slower pace of life in Greece, where mid-afternoon breaks are sacred.

Final Thoughts: Whether you're in the mood for Mediterranean or Middle Eastern cuisine, Corfu has a little something for everyone. The mix of authentic Greek dishes with Middle Eastern classics makes it a versatile choice. And if you're looking for a laid-back evening with good food, good music, and even better company, Corfu is the place to be.



HOW TO GET OUT OF YOUR HEAD: 12 MIND SHIFTS WHEN YOU'RE STUCK IN YOUR HEAD

1. Focus on your senses: Come back to the space around you. Engaging the senses brings attention to the present moment. Like a tree that isn't watered don't attend to a thought and it dies away. There is no mental pain without thinking. What's wrong with right now if you don't think about it?

- 3. Focus on your breathing: Conscious breathing is a powerful tool for centering one's thoughts. Envisioning oneself inhaling positivity and exhaling stress can act as an emotional and mental reset, effectively dialing down anxiety and promoting relaxation.
- 4. Get moving: Physical activity is an effective distraction from ruminative thought patterns. This can range from intense exercise to leisurely activities like a casual walk to a coffee shop.
- 5. Focus on someone else: Thoughts are empty. They dissolve if you don't give them attention. One becomes less preoccupied with personal worries by actively seeking to assist another individual. Help others.
- 6. Get busy: Immersing oneself in a project or hobby requires concentration and diverts attention from repetitive thoughts. Scott Kiloby Basics 1 & 2 on Youtube is helpful with too much thinking
- 7. Focus on gratitude: Acknowledging things one is thankful for can shift the mind from a negative space to one of appreciation and contentment.
- 8. Focus on forgiveness: Forgiveness is a pathway to mental liberation; it allows individuals to release resentment and embrace peace. Viewing others with empathy & understanding enables people to move past lingering negative emotions.
- 9. Talk it out: Discussing troubling thoughts with someone trustworthy can be cathartic and healing.
- 10. Get in the flow state: Engaging in activities that induce a flow state, where one is fully absorbed and losing track of time, creates a sense of euphoria and engagement.
- 11. Practice meditation: Meditation offers a refuge for the mind, a serene space to be still Thoughts are generally not important. They will come and go by themselves less and less if you don't give them attention.
- 12. Focus on the present moment: Living in the present is the ultimate remedy for a preoccupied mind. Reorient one's awareness to the immediacy of the present, dissolving the grip of past regrets or future worries.

DAY OF THE DEAD Remembering Those who have Passed

This year's Day of the Dead taught me a lot about myself and my relations to other people in my life. For one, the whole point of the Day of the Dead commemoration is to first pay tribute and honor to all those who have gone

before us, and are no longer with us. We honor them because we are foolish to not do so. Plus, since we are honoring those whom were close to us and we loved, we remember them because they made us who we are, they enhanced our lives, and they (hopefully) made us better people.

A second reason for the commemoration of the Day of the Dead is to remember that we will not be here forever. I know we all intellectually believe that, and even know that, but somehow we do not translate that into treating our fellow men and women better. IF we really, deep down, grasped the shortness of life and the fact that we all have a finite amount of days to do something meaningful, then we'd most likely not waste time, and make every moment count.

During my Day of the Dead, I just happened to see a Bruce Lee quote: "If you love life, don't waste time, for time is what life is made up of."

Though the holiday is redeemable, that is possible probably only through the path of individuals who choose to observe in a more traditional way.

On the eve of Day of the Dead, we lit a little candle, set out flowers, and remembered the departed loved ones. I recalled my mentors, my brother, my sister, my parents. We recalled Helen's mother, recently departed. We recalled close friends and their parents and spouses

who have left the physical sphere. I found that I used to think of the departed with fear and uncertainty. These days, I try to allow myself to smile, to think of how their time in my life enhanced who I am and what I do. I smile, and sometimes I cry, because I loved them so much.



HOW TO FIND A CHEAPER MEDICARE PRESCRIPTION DRUG PLAN

Dear Savvy Senior:

What's the easiest way to compare Medicare Part D prescription drug plans? My Part D premium is increasing again in 2025, so I would like to use the fall open enrollment to find and sign up for a cheaper plan. Shopping Around

Dear Shopping:

I'm happy to hear you're comparing your Medicare coverage options this fall! Research shows that many Medicare beneficiaries with Part D coverage can lower their prescription drug costs by shopping among plans each year during the open enrollment season, which runs Oct. 15 to Dec. 7.

There could be another Part D plan in your area that covers the drugs you take with fewer restrictions or with lower costs. You never know until you look. You'll also be happy to know that thanks to the

Inflation Reduction Act, in 2025 annual out-ofpocket costs will be capped at \$2,000 for all Medicare Part D beneficiaries.

Here are some tips and tools to help you shop and compare Part D plans.

Plan Finder Tool

If you have internet access and are comfortable using a computer, you can easily shop for and compare all Medicare drug plans in your area and enroll in a new plan online, and it only takes a few minutes.

Just go to Medicare's Plan Finder Tool at Medicare. gov/find-a-plan. You can do a general search on the right side of the page, under the title "Continue without logging in." If you wish to save your drugs and pharmacy information, you can log into or create your Medicare account on the left side of the

Next, type in your ZIP code and choose the type of coverage you're looking for, enter the drugs you take, choose the pharmacies you use, and indicate whether you are interested in a mail order option.

The plan finder will then display results for plans in your area. Be aware that a plan may not cover all the drugs you take, but it may cover alternatives. It will also tell you if the plan has a deductible and how much the monthly premium is.

Initially, the plans will be sorted by "lowest drug + premium costs." This is the closest estimate to what and author of "The Savvy Senior" book.

you may pay out of pocket for your Part D coverage for the year. You can select "plan details" to find out more specifics about coverage, including any coverage restrictions that might apply to your drugs.

Before enrolling, it is a good idea to call the plan directly to confirm any information you read on plan finder, as information may not be completely up to date.

If you need help, you can call Medicare at 800-633-4227 and they can do this for you over the phone. Or contact your State Health Insurance Assistance Program (ŚHIP), which provides free unbiased Medicare counseling. To find a local SHIP counselor call 877-839-2675 or see ShipHelp.org.

Any changes to coverage you make will take effect Jan. 1, 2025. If you take no action during open enrollment, your current coverage will continue next year.

Extra Help

If you're lower-income and having a hard time paying your medication costs, you may be eligible for Medicare's "Extra Help" program. This is a federal low-income subsidy that helps pay Part D premiums, deductibles and copayments.

To be eligible, your annual income must be under \$22,590 or \$30,660 for married couples living together, and your assets (not counting your home, personal possessions, vehicles, life insurance policies or burial expenses) must be below \$17,220 or \$34,360 for married couples. The Sierra Madre Public Library, Civic Club, Rotary Club, Kiwanis Club, and the Sierra Madre Woman's Club (men are welcome too) encourage senior volunteers, offering a rewarding way to remain active. The YMCA also provides special senior memberships, promoting social interaction through fitness classes and events.



It's not that I don't try to remember things; I can't remember things I'm supposed to remember. It has nothing to do with my age because it started as far back as I can remember.

Her memory is perfect. She can remember things that actually never happened. How she does that is beyond my understanding. Trust me, I'm not going to ask her to explain it to me because then I would have to remember that explanation for the rest of my life. Some things are not worth remembering. It's not so much that I don't remember things, I just am busy when things are happing. I don't remember what's happening when I'm watching TV because I'm busy doing something else. When The Gracious Mistress of the Parsonage is conversing with me, I don't remember everything because I'm busy doing something else.

When I was young, one of my favorite authors was James Thurber, who wrote the short story "The Secret Life of Walter Mitty," which later became a movie.

When Thurber was young, he and his brother played a game called "William Tell," which I had never heard of before but somehow involved bows and arrows. In the middle of that game, his brother, by mistake, shot an arrow hitting Thurber in the left eye, causing him to lose that eye. Later, his other eye suffered, and he was almost completely blind.

Thurber was a writer, and most of his writing was done in his head. Then, the next morning, he would sit down with his secretary, and she would write out the story as Thurber would dictate it to her. Often, when Thurber and his wife were having dinner with some friends, his wife would say, "Jim, will you stop writing and listen to what we're saying?" Of course, he was always working on some short story wherever he was.

Although I am not blind, I often do the same thing. I'm always working on a sermon, a newspaper column, or an article in my head even when I'm with others. I might be watching TV, visiting friends at some restaurant or just sitting at home with my wife.

I can remember just about everything I'm writing in my head which I will write out later. That technique, which I learned from James Thurber, has greatly profited me. However, it has also hindered me in the social area. Even though I can remember what I was

working on in my head at the time, I can't remember the conversation with people around me. I can never figure that out. The Gracious Mistress of the Parsonage often says, "Do you remember what I told | com

That is a question to ponder. Whether I say yes or no, I'm still in some trouble. Now, if she said something like, "Do you

remember what you were thinking last week when we were at dinner with some of our friends?"

Whenever we have dinner with friends, I look forward to the next morning. During that dinner, my head is swarming with ideas and thoughts about a project I'm working on.

One of these days, I'm going to thank those people for giving me the opportunity to think through a project I'm working on. On occasion, the Gracious Mistress of the Parsonage and I are on a trip across

While driving the Gracious Mistress of the Parsonage will look over at me and say, "Ok, what are you thinking?"

Because I'm thinking I don't hear her at first. Finally, she gets my attention and I once replied, "Oh, I was just thinking of what a wonderful, lovely, gracious wife I have. I'm so fortunate."

She has a hard time responding to that.

Great thought. A verse of scripture came to mind. Psalm 139:23-24, "Search me, O God, and know my heart: try me, and know my thoughts: And see if there be any wicked way in me,

PUT THE LIGHTS ON IS EVERYONE LOSING? ARE THEY LYING TO US?

This morning in the rebroadcast of an interview with Connie Chung, I heard her use the term "tabloidiism" as a way of describing what has happened to news reporting.

I consulted the internet and read that tabloidism is "a style of journalism that uses the tabloid format to focus on popular culture and celebrity gossip and uses sensational headlines and quick unverifiable articles." Typical of the genre is focus on intimate details about the lives of celebrities and other

When the interviewer, Walter Issacson, asked Connie to explain the reason behind the phenomena, her answer was a simple one-word response, "money". No surprise, huh? Human beings are who they are and as Walter Issacson has described in the five biographies that I have read covering Leonardo da Vinci, Elon Musk, Albert Einstein, Benjamin Franklin, and Steve Jobs all exhibited questionable behavior. And these are, or were, all celebrated people.

For example, I hate knowing that Albert Einstein the super-brilliant physicist, pacifist (in fact I am wearing socks with his picture on them at this very moment) a man whom I admire greatly, did something that I cannot forgive.

No- I am not talking about the indisputable fact that he was the impetus behind the creation of the atomic bomb eventually dropped unnecessarily upon the Japanese cities of Hiroshima and Nagasaki. Most of us have been affected by tabloidism and the short and often inaccurate descriptions of what is actually happening around us. Few of us any longer read full books and bookstores are closing all over town. Seeing the "For Lease" sign at the nearby Vroman's bookstore felt to me like the loss of a dear relative.

HERE IS MY HOPE: We should know that much of the news that surrounds us ARE LIES designed to just keep bringing more money to the undeserving power brokers. Perhaps the best remedy is to pay attention only to GOOD NEWS and to eschew the spectacle.

Sure, I know that Hurricane Milton is about to land in Florida and there may well be catastrophes, but we must try and not be distracted and keep our eye on the ball to find the best true pathways to cope with future needs. Of course, I will feel better tonight if the Dodgers win their game. After all, like the rest of you, I am only human.

"A smooth lie is still a lie." - Joy Reid, MSNBC, on JD Vance's debate performance

What stood out to me in Special Counsel Jack Smith's recently unsealed brief on Donald Trump's efforts to overturn the 2020 election was the extent of his sociopathic lying. It isn't a matter of being wrong and later correcting oneself (as Gov. Tim Walz said on Fox News, "I own up when I make a mistake"). With Trump it's constant, deliberate lying. As the brief makes clear, Trump knew what the truth was - no meaningful numbers of missing ballots, ineligible voters, voting machine hacks or corrupt election officials. He'd been repeatedly so advised by staff and personal counsel. His concern, though, was not discerning the truth but staying in power - so he lied about

64 lawsuits had been filed with only one partially successful (involving some 200 disputed votes). In response, Trump replaced reality-based counsel with Rudy Giuliani - more amenable to the continued lying. Erstwhile advisor Steve Bannon suggested Trump simply declare victory; "That doesn't mean he's the winner . . . He's simply going to say he's the winner."

Then-V.P. Mike Pence spoke with Republican Governors who assured him there'd been no evidence of election fraud in their states. But regardless, Trump warned Pence that if he didn't go along with the lying, hundreds of thousands would "hate your guts" and "think you're stupid".

In late November 2020, then-Attorney General Bill Barr heard Trump lie on Fox that the Justice Department had "ignored evidence of fraud". Barr told the Associated Press they had indeed thoroughly investigated whatever "evidence" and came up empty. He resigned shortly before Christmas.

This remains relevant today as Trump on the campaign trail continues repeating what he knows to be lies with MAGA members now sitting on local election boards continuing to believe them.

I use the term "sociopathic" advisedly, but in terms of "manipulation, deceit" and "lack of empathy" - it fits. I've no sympathy for the 1,300 who've Farmer, "Lying is the most personal been charged with federal crimes act of cowardice there is."

Election workers throughout the Trump's claim country have been subjected to of the Biden physical (and death) threats against (and death) threats against themselves and their families. Considerable time ahead of the election is now devoted to security training and site reinforcements - but for Trump, all the better.

Beyond elections, Trump and his surrogates have been lying about Hurricane Helene, accusing the Biden Administration of withholding aid from Republican-leaning areas. (As president, Trump sought to withhold wildfire aid from California - until staff brought him electoral data showing there were in fact parts of California that voted Republican). He's lied about funds diverted from FEMA - lies repeated by MAGA congressmen who know full well how

the appropriations process works. More than 230 have been killed in Hurricane Helene, with hundreds of thousands homeless or without power. From former Lt. Gov. Geoff Duncan of Georgia, "The lies are one of the biggest reasons, I am a lifelong Republican supporting Vice President Harris. The lies are dangerous. ... We need to hold him accountable for it." Knox County, Tennessee Mayor Glenn Jacobs posts that if MAGA "could maybe put aside hate for a little bit and pitch in to help, that would be great." But Trump relies on the hate.

This unabashed, unabated lying was on full display at the debate between Trump's running mate Sen. JD Vance and Gov. Tim Walz. PolitiFact scored Vance "False" or "Mostly False" on subjects ranging from immigration to abortion, Iran, opioids, healthcare and January 6.

Vance refused to acknowledge that Joe Biden won in 2020. But the highlight was his outburst, "you guys weren't gonna fact-check!" It was like - "You're telling me I can't just lie? There goes the gameplan!" At the beginning of last week's "60 Minutes" interview with V.P. Harris and Gov. Walz, it was explained that a primary reason for Trump's refusal to participate was that there'd be factchecking. (As CBS reminded, "That's what we do.")

JD Vance is an educated guy. He undoubtedly knows the truth (as in 2016 when he wrote that Trump could be "America's Hitler"). But for now, he has to follow the head of the ticket: It's not campaigning on the facts to win an election, but lying as necessary to ultimately prevail regardless of how votes are cast.

How sweet it is that Donald Trump's crimes in the wake of his 2020 defeat are finally back in the headlines, just in time for the final sprint to the 2024 election.

Thank you, Jack Smith, for the recently-released court brief that meticulously details the federal case

against Trump. And thank you, Liz Cheney, for crossing the aisle and warning voters that Trump's "depraved cruelty" – putting his own vice president's life in jeopardy on Jan. 6 - is proof that he "can never be trusted with power." And thank you, Tim Walz, for those final minutes in the VP debate, exposing JD Vance as a election-denying MAGAt who hates democracy.

Trump has been rage-posting about Smith and Cheney (of course), and it's easy to see why. He's terrified of losing his campaign to stay out of jail, and the timing of Smith's evidentiary brief could not be worse for him. Even though he's horrifically stupid about substance, he instinctively understands media optics, so he knows it's politically perilous to have the coup criminal case in the news between now and Nov. 5.

Granted, there's a huge pool of potential voters who've inexplicably forgotten about the violent Capitol insurrection, and who don't know or care about Trump's relentless efforts to overthrow the free and fair election he lost - like plotting with various conspirators to scream "election fraud" where none existed, pressuring local authorities to "find" him votes that didn't exist, trying to bully some key counties to stop tallying ballots, and ginning up slates of fake electors, and much more. For millions of feckless or oblivious voters, the developments will not matter a whit.

But with less than a month left on the clock, in a race that's supposedly close, the chilling factoids in special counsel Smith's court document could resonate with enough Trump-averse independents and Republicans to buttress Kamala Harris' campaign in the home stretch.

In Bruce Springsteen's endorsement of Harris, he said that our fight for a democratic future depends on "women and men with the national good guiding their hearts." It's those people, across the political spectrum, who might well heed the tidbits in Smith's narrative. Especially these:

Mike Pence was refusing to play ball, the goons went ballistic and Pence (plus his family) had to be whisked to safety because his life was in danger. Trump, alone in his dining room, watched the violence on TV. When an aide informed Trump that Pence was imperiled, his answer was: "So what?"

- Trump told family members that "it doesn't matter if you won or lost the election. You still have to fight like hell." (Translation: If you vote against a totalitarian, your vote doesn't count. The totalitarian will say he

won anyway.) - When Trump's lawyers told him that his baseless election fraud claims wouldn't hold up in court, Trump ordered them to file lawsuits anyway. The fight was all that mattered; in his words, "The details don't matter." (Example: At one point Trump spread word that 36,000 non-citizens had voted in Arizona. Fuve days later, he upped the figure to "a few hundred thousand." Then "40 or 50,000." Then back to 36,000. All those numbers were illusions.)

One Trump aide, who repeatedly told Trump that his loss was legit and that his election fraud claims were delusional, got so fed up that he emailed a colleague: "It's tough to own any of this when it's all just conspiracy shit beamed down from the

mothership.' Trump wanted Republican national chairwoman Ronna McDaniel to circulate a lie about (non-existent) election fraud in a key Michigan county, but McDaniel told Trump that even Michigan's Republican House Speaker thought the claim was "f... ing nuts.

At the tail end of the VP debate, slick Trump supplicant JD Vance tried to dodge questions about the 2020 election aftermath, insisting that he's focused on the future. Too bad his boss didn't get that memo, because in Michigan last week, Trump focused yet again on the past. Referring to 2020 he said: "We won, we won, we did win.

I doubt Trump knows who William Faulkner is, but he clearly hews to one Faulknerism: The past is never dead. It's not even past." The bloody chaos he inspired in the wake of

that election - for which he's been indicted on four counts by a federal grand jury - is a harbinger of what's to come unless Harris wins by the most decisive possible margin. If that were to happen, he might finally be held accountable in court for the havoc he has wreaked on our core democratic institutions.







LETTER TO THE EDITOR

On Wednesday, October 9, at the PUSD School Board candidate forum for District 6 at Sierra Madre Town Hall, I watched in frustration as the incumbent evaded public questions, misrepresented her record, and avoided accountability.

Sierra Madre constituents in attendance said Ms. Fredericks had not been keeping the community informed, for example, with the passage of the current PUSD ballot measures. Ms. Fredericks placed the blame on the consultants who conducted the survey, claiming she relied on their survey results to determine public support of the measures. She also said she did not have enough time to inform the public because the resolution had just recently passed.

However, the survey only reflected the input of 406 "likely voters" district-wide. At the August 17, 2023 PUSD Board meeting, consultants presented the timeline, and at the February 29, 2024 PUSD Board meeting, Ms. Fredericks voted to move forward with the measures. Her answers stating she didn't have enough time to inform the public nor gather feedback in the area she serves were disingenuous.

The reality is that instead of keeping the public informed, Ms. Fredericks spent her time volunteering for other political candidates, as well as traveling to DC and Sacramento to meet with Congressional and State officials. Her re-election campaign was rewarded with big-name endorsements while we were left in the dark (plus PUSD paid for these trips to DC and Sacramento).

The discussion then shifted to questions on the current \$516 million Measure O bond allocation, Ms. Fredericks suggested that there were hundreds of millions of dollars that the Board could still reallocate. In reality, although the bond has not been drawn down yet, those funds are dedicated to specific projects over the next 5 years.

Ms. Fredericks pointed out that she advocated for a study session on health and safety projects for all PUSD schools. Parents who were at the meetings, like myself, know this was just grandstanding after finding out that she had a School Board challenger. This study session she requested failed to capture any other Board votes because the Board had already voted (6-1 with Ms. Fredericks in favor on Sept 7, 2023) to spend most of the bond money to prioritize three schools (Longfellow, Madison, and Muir) and to allocate just \$40 million for the fire, life, and safety and other necessities for other schools. Ms. Fredericks voted to prioritize modernizations based on a heat map of where most students live (which is not in District 6) instead of spreading the money to the schools that objectively need the most urgent infrastructure repairs.

There was an estimated \$400 million in assessed needs and we had a \$516 million bond. Fredericks did not initially support ending facility disparity but has misled the public to think she has. In fact, in her op-ed in Pasadena Now on Sept 27, 2023, Ms. Fredericks advocated for closing more of our schools instead of repairing the schools where children attend.

Ms. Fredericks attests she plans to "do better" if re-elected. She continues to evade the public with her ability to blame others, without taking any accountability for her actions.

The time for change is now. If the challenger, Lisa Kroese, wins on November 5th, I know we will get clear information, a chance to be involved in the decision process and a leader who is able to gather information and share it with both constituents and the Board.

YES ON MEASURE R + MEASURE EE MEANS YES TO GREENER COOLER PUSD SCHOOLS

I humbly ask for your vote YES on Measure R and Measure EE to prioritize our public schools this November 2024. Investing in today's children means many generations return on investment. This month we witnessed the death and devastation of families and communities caused by Hurricane Helene and Hurricane Milton throughout our nation's southern states, underscoring the importance of preparing for the extreme weather conditions caused by climate change.

At the other extreme, our communities in southern California have experienced record high temperatures, longer and dryer summers in recent years. Extreme heat creates increasingly hazardous conditions in outdoor areas and structures where the 14,000 students of our district learn and play. Even the California legislature is taking the extreme heat conditions seriously. On October 1, 2024, California passed Senate Bill 1248, a bill requiring local schools to implement protocols for extreme weather situations. The bill was nicknamed Yahushua's Law, in honor of the 12-year-old boy who died during P.E. during a summer 2023 heatwave. Unfortunately, weather protocols which typically means keeping students inside creates other problems and challenges. Firstly, not all of our facilities have air-conditioning systems or they need upgrading, so keeping students inside on an extremely hot day may not be feasible for some schools and students would need to be sent home, losing instructional time. Keeping students indoors is not a long-term solution as we already know the detrimental effects on the mental health of children (and adults) of quarantine during the height of the COVID pandemic. Especially our young learners, they need to learn by playing and staying active.

The simple answer is to make our school's outdoor spaces cooler. The temperature of today's playgrounds are not like what we grew up with in elementary school. For example, on a 91 degree day this year, the asphalt measured 157 degrees without shade and 119 degrees with shade, and a plastic slide measured 166 degrees, while the grass under an oak tree measured 82 degrees. According to the California Schoolyard Tree Canopy Equity study of 2023, PUSD school sites tree canopy coverage ranges between 8% and 15%, well below the 30% recommended by urban forestry experts. This is why I introduced this week at the PUSD Facilities Committee meeting, the Resolution to Increase Tree Canopy Levels and Reduce Asphalt in Outdoor Areas of Pasadena Unified School District in order to Enhance Student Learning Environment and Safety.

Our buildings are between fifty and one hundred years old – in some cases, it's beyond repair simply because they no longer make the parts. This is why with Measure O funds of 2020, the district chose to modernize rather than simply repair some schools as that would be a more efficient use of tax payer dollars to invest in construction that lasts. In November 2023, the Board approved a 5 Year Bond Program, which has a construction timeline for schools and the cost of each project. The plan includes modernizing 7 elementary, middle, and high schools across the district, each school District.

costing between \$21 million and \$63 million. Additionally, many schools have and will receive wet utility repair, electrical service, new restrooms, accessibility/walkway repair, field reconditioning, and HVAC repair and upgrades. The total cost of the 5 Year Bond Program Plan is about \$470M. We would save \$124M in state matching funds if State Measure 2 passes (so please VOTE YES on Measure 2)

You can find the 5 Year Bond Program at pusd. us/departments/measure-o/master-plan Additional projects beyond the \$470 million include district wide security lock replacement so that teachers can easily lock doors from the inside in an emergency situation, as well as security cameras and secure front entry way at each school. An additional \$40 million budget is reserved specifically for urgent health and safety projects including HVAC, fire alarm systems, structural building integrity, accessibility (elevators and ramps), window replacement, roofing, asphalt repair/reduction, lighting, classroom repairs. I'm happy to report that Sierra Madre Elementary successfully upgraded their electrical system and HVAC modernization this summer. For more detail on the current status and expenditure of construction projects, please go to PUSD Facilities & Capital Projects Committee website for the agenda containing the most recent Construction Project Status Reports. In summary, while \$140 million in bonds have been issued and \$84 million has been spent to date, the remaining balance of the \$516 million of Measure O has been earmarked

PUSD's Measure R is a unique bond that a local community group called PUSD Green Schoolyard Coalition helped to craft. In addition the traditional upgrades, this bond includes outdoor greening projects. Founded by a few Sierra Madre Elementary school parents, this group successfully convinced the district to include student-accessible green space as an allowable use of Measure R funds, for example, asphalt removal, stormwater retention systems, bioswales, heat-mitigating surfaces, shade trees, facilities infrastructure to support carbon-free energy sources and waste management systems, composting, pedestrian and bicycle paths, electric bicycle stations and parking.

While Measure R funds building improvements, PUSD's Measure EE will help to fund the competitive salaries our teachers and staff deserve. Some of our teachers work multiple jobs and often pay for classroom supplies out of their own pocket. They deserve to be fully supported for the quality instruction they provide for our students. Given that 80% of our public school funding comes from the state and the state budget is only giving a 1.07% cost of living adjustment this year, our district will need to make up the difference to keep our quality teachers and staff.

There are many choices on this November ballot. This is an opportunity to invest in the 14,000 students of Pasadena Unified School District, our emerging leaders for our community. I humbly ask for your YES vote on Measure R, Measure EE, and Measure 2.


