

I am the Retired Fire Chief for Sierra Madre and a resident since 1973. My wife of 51 years and I bought our house to raise our 3 children in a safe and community oriented city. My cousins owned the house next door and my Grandmother Ann Lowe lived behind them. This town still has the same charm through the many changes we have experienced such as new neighbors, increased home values, and especially through the updates to public safety!

I was a Volunteer Firefighter for 38 years and the last Chief who did an Executive Staff position at no cost to the City of Sierra Madre. I'm also the Chief that saw the need for Advanced Life Support Paramedics in 2007 because modern emergency medicine had made amazing measures at saving lives and our residents deserved these services!

We were the only volunteer department in LA County and we all knew this wouldn't last forever. Safety is my number one concern and has always been the priority of the City. So when the department moved towards a fully paid department, I'm really glad I'm retired and didn't have to figure out how to pay for this!

I fully support the Measure PS and am voting YES! It's really not even a question for my family and I! Taxation is always a difficult pill to swallow, but Measure PS keeps all funds locally here in town and can only be used for the stated purpose of Public Safety Personnel.

I'm thankful that my old friend and fellow volunteer firefighter Jim Walsworth took this upon himself to help our town. His wife Martha worked for our family business and was on the Firefighters' Wives Auxiliary with my wife Scarlett. The Sierra Madre Police Association President Kyle Bailey I watched grow up since his Dad Wayne Bailey was the Police Chief while I was Fire Chief. My daughter volunteered as a Fire Captain and now volunteers again as our City Council Member. All of these hardworking people support this Measure because they are invested in keeping us all safe and making sure we keep th local charm we all want to protect!

I encourage everyone in town to VOTE YES ON PS! I knew this day would come when we would have to be taxed to pay for a new fire department and this needs to pass to keep our police and fire department local and to protect our small town community charm!

ABOUT THE MEASURE

The Public Safety for Sierra Madre Measure is a citizen-led initiative to raise the necessary funds to keep Sierra Madre safe. Without additional funding, our police and fire departments could be at risk of closing and being outsourced to county agencies.

The measure raises over \$2 million over the next 7 years by issuing a parcel tax on lots throughout the city. These funds would be subject to strict auditing that protects

The following represents a summary report of some of the major incidents handled by the Sierra Madre Police Department during this period. This list is not intended to be considered exclusive or all-inclusive.

Tuesday, October 8 Disturbance

At approximately 1:30 PM, officers responded to the 100 block of West Sierra Madre Blvd regarding a disturbance. A citizen became irate after the ATM would not release his debit card. Officers checked the location for damage and took a report.

Saturday, October 12 Vandalism

At approximately 8:45 AM, officers responded to the 100 block of North Lima Street for a vandalism report. The citizen discovered the rear window to her vehicle was shattered. The citizen stated nothing else was damaged or stolen. There were no cameras or witnesses in the area. Officers took a report for documentation purposes.

Saturday, October 12 Vehicle Violation At approximately 11:00 PM, while on patrol, officers conducted a traffic stop on North Michilinda Ave and West Sierra Madre Blvd for a vehicle with an expired registration of over 2 years. The driver stated he did not have a driver's license. A records checked revealed the driver only had an identification card. The driver was cited for an expired registration and driving without a license.

OP-ED: WHY SIERRA MADRE NEEDS MEASURE PS - A **VOTE FOR COMMUNITY, SAFETY, AND SUSTAINABILITY**

As Sierra Madre residents, we share a common love for our town's unique charm and close-knit community. It's this very essence that makes Sierra Madre stand out from neighboring cities. However, we cannot take this idyllic way of life for granted. To ensure that our town continues to thrive, support, and protect its residents, it's time we face an undeniable reality: our public safety services are at risk due to underfunding.

Measure PS will specifically allocate funding to bolster our police, fire, and emergency services. Over the past few years, Sierra Madre's budget has been increasingly strained, leaving our vital public safety departments struggling to meet growing needs. Currently, the funding gaps are threatening essential services like emergency response times, adequate staffing of police and fire personnel, and the ability to maintain equipment critical to both departments. In an era where natural disasters and public health emergencies are unpredictable, we simply cannot afford to cut corners when it comes to safety.

Measure PS ensures these services receive the financial support they need to continue operating effectively. It's a small price to pay to ensure we have Sierra Madre police officers on patrol, Sierra Madre firefighters ready to respond, and the assurance that in times of crisis, help will always be available.

The alternative? Contract out to the County and lose local control and be subject to the County's policies and practices with no guarantee that police patrols will be maintained

when there are currently shortages in the Sheriff's Department.

Imagine longer response times when you call 911, a reduced police presence in our neighborhoods, and a reduced number of firefighters and paramedics. These are not hypothetical concerns — they are the reality we'll face if Measure PS doesn't pass.

Measure PS is an investment in the long-term well-being of Sierra Madre. A safe community is not only a secure place to live but also a desirable place to raise families, start businesses, and welcome visitors. Strong public safety infrastructure maintains property values, encourages local economic growth, and fosters a sense of stability.

Furthermore, Measure PS includes provisions to ensure accountability. The funds will be earmarked exclusively for public safety services, meaning we can be confident that our tax dollars are going directly toward maintaining and enhancing our police and fire

A WORD FROM THE OTHER SIDE.....NO ON PS MEASURE PS: DISHONESTY AND DECEPTION ON THE BALLOT

I'm a firm believer that there is no greater exercise in democracy than taking an issue to a vote of the people. It's important to keep in mind, though, that our founding fathers warned the residents of the new America against the threat of the "tyranny of the masses", and it should also be noted that in their wisdom, our founding fathers recognized that a true democracy can be defined as, "...two wolves and a sheep voting on what's for dinner". Regardless, I still believe in "We The People's" right to determine our destiny.

Where I start to have problems with votes-of-the-people is when one side or the other is dishonest and deceptive. Measure PS uses the same tired but effective dishonest and hyperbolic fear-tactic that is often used to increase taxes for schools or public safety. Think back to the dishonest rhetoric used to pass the UUT. I can remember back a few years ago when the mayor at the time stood in the fover of city hall and claimed to a crowd of residents that we were in a "financial crisis" and would not be able to fully fund our police and fire departments without passing the UUT. Of course that UUT money was conveniently placed in the General Fund and has been used in part to fund items with a lower priority and other non-essential expenses.

Regarding Measure PS, I've read and studied the text of the proposed ballot measure and have reviewed the hyperbolic propaganda in support of the measure that was mainly financed by self-serving unions. I have found the rhetoric of both to be equally dishonest and deceitful. Even back when the signatures were being gathered to place the initiative on the ballot, I observed that the same dishonest rhetoric was being used to gather signatures.

Having served as an elected City Councilmember some years back, and having gone through the budgeting process, I can say that municipal financing, budgeting, and accounting is complex. It is grossly different than the financing of private business. However, in my opinion, elected officials need to spend taxpayer's money with the same sensitivity that they spend their own hard-earned dollars. In saying so, I believe every single expense should be priority based. Higher priority expenses must always be budgeted and financed first before other feel-good expenses. Seriously, imagine heads-of-households telling their children, "well kids, we can only afford part of this month's rent but the good news is that we'll be going to Disneyland this Saturday." Not only would that be reckless and irresponsible but it would be a a government that lives within its means!

In my opinion, a responsible City Council will always prioritize and fund police, fire, water, and public works first, in their entirety, and without exception before a single cent is spent elsewhere; before community services, library, commissioner recognition dinners, or any other expense. It's often referred to as "Priority Based Budgeting" and is basically what every responsible family must do to maintain a healthy and sound household.

So the question becomes, "Does the City receive sufficient revenues to fund those four prioritized items?" The answer is yes but proponents of Measure PS are falsely telling you 'No". But don't take my word for it, just read the text of the Measure.....Section 3.38.020. (B) Necessity of Parcel Tax reads. Reads, "Without supplemental funding, revenues in the general fund are insufficient to sustain the current level for police, fire, and paramedic services...) The statement is false. The reality is that there are sufficient general funds unless the Council recklessly and irresponsibly spends those funds elsewhere on items with lower priorities and non-essential expenses like recognition dinners, library, community service events, etc.

Or, for example, in the Measure, Section 3.38.080. (A) Use of Proceeds., it reads, "The purpose of the special fund is to supplement, NOT REPLACE, existing and future funding from the general fund used to pay for police, fire, and paramedic services...". Again this is false. Every dollar that is placed in a special or restricted fund that was previously a dollar that came from the general fund is a replaced dollar that the general fund can spend elsewhere. It's a tactic that cities have used to free general fund money for other discretionary expenses. A good example was the restricted State CRA funds of the past. On a side note, although the Measure states the purpose is not to "replace" the general fund, there is no mandate for this, only that the tax revenues must be used for restricted specific uses. Even on the proponent's website they admit that general funds would be a replacement and freed to support other less and nonessential services as evidenced with their claim, "Voting YES on Measure PS...assuring there are general funds for other City services.'

We can also look at the hyperbole in the union's propaganda that claims, "our safety is at stake", and claims that the Measure "prevents dangerous reductions in police and fire services". It prevents nothing other than the possible reduction in NON-ESSENTIAL services or irresponsible deficit spending. Also, don't be too deceived by the proponent's claim that this is a "citizens led initiate." This is mostly the work of and by the "Paid for by Safety For Our City, Sponsored by Public Safety Unions" as evidenced by all of the flyers and propaganda.

Government, by it's very nature tends to increase and in doing so it creates a lust and hunger for additional taxes. Therefore, the bottom line is that the City needs to live within their means without fleecing the taxpayers for more money. The City needs to adopt and utilize a priority based approach to budgeting and fund the police, fire, water, and public works first in their entirety. Because, frankly, if I hear a home intruder in my home at 2 AM, I want to be able to call the police, not the librarian!

It's time to just say "NO" to increased taxes and hold our elected officials accountable to fiscal responsibilities.

Pasadena Police Serves Gang Warrant



Pasadena police arrested five suspects last week wanted in connection to gang activity that included armed robbery, weapons violations and vandalism.

According to police, on October 10 at 4:00 a.m. the Pasadena Police Department's Street Crime Unit served a multilocation search warrant, simultaneously, in the San Gabriel Valley. The operation was the result of a comprehensive criminal investigation involving a Pasadena criminal street gang whose illicit activity had been increasing over the past several months.

Due to the simultaneous execution of the warrant and violent history of the criminal street gang, Pasadena Police Department utilized a multitude of specialized teams; both from within and from neighboring jurisdictions. The teams included: Pasadena PD Street Crime Unit, Pasadena PDSWAT, Pasadena Special Section, Investigations Pasadena PD Violent & Majors Crimes Sections, Glendale PD SWAT & Special Enforcement Detail, Burbank PD SWAT & Gang Unit, Covina PD SWAT and Gang Unit, West Covina PD SWAT, U.S. Marshal's Pacific Southwest Region Fugitive Taskforce, and L.A.S.D. Major Crimes.

The operation yielded the recovery of a shortbarreled semi-automatic rifle with a highcapacitymagazine, drum revolver, and three semiautomatic handguns with highcapacity magazines. See below photograph for further details.

Two male juveniles and three male adults were arrested and booked at the Pasadena Police Department's Jail. They were booked for various felony crimes, to include armed robbery, felony vandalism, and weapons violations.

The Pasadena Police Department's Street Crime Unit was created in May 2023 to interrupt street level criminal activity, with an emphasis on criminal street gangs, street level narcotics, and crime that impairs the community's quality of life. They have recovered 86 firearms since their inception.




Olmos, the voice of Chicharrón in Pixar's "Coco," concluded his visit by reading a book about a mythical character to Mayfield's Third-Grade class.





SUGAR IN WINE. DO THE MATH.

I'm Gustavo Lira, Tasting Room Manager and Wine Buyer at The Bottle Shop in Sierra Madre with another wine and spirits selection.

I recently featured German Rieslings and people were quite surprised at how dry they can be. People were also surprised to find out that some German Rieslings have less sugar content than some red wines. Last week the San Francisco Chronicle had an week the San Francisco Chronicle had an article on the amount of sugar present in a popular Pinot Noir. That wine, Meiomi Pinot Noir, contains quite a bit of residual sugar. The latest 2023 vintage contains 21 grams of sugar per liter per the Liquor Control Board of Ontario. The other vince marting d in the outside. Diel Topo wine mentioned in the article - Dial Tone

Pinot Noir 2023 – contains 0.4 grams per liter. Doing the math, you'd have to drink approximately 52 bottles of the Dial Tone Pinot Noir to equal the amount of sugar in one bottle of the 2023 Meiomi Pinot Noir. I've tasted Meimo Pinot Noir and it has always tasted sweet and artificial to me, but I didn't realize how much sugar was in it until I read the article.

Comparing the German Rieslings I featured last week, the 2021 Wagner Stempel Estate Riesling had 4.3 grams of sugar per liter - which tasted almost bone dry. Simple math tells you that you would have to drink almost 5 bottles of the Riesling to equal the amount of sugar in one bottle of the Meiomi Pinot Noir.

If you are concerned about the amount of sugar in your wine, do some research and find out how much sugar is in your wine. The information is usually on the website of the winery. Just look for the tech sheets or wine tech information on the winery's

website. The vast majority of wines we have at The Bottle Shop are dry with minimal amounts of sugar. Although we don't carry Dial Tone Pinot Noir, I do have an alternative - the 2023

Bishop's Peak SLO Coast Pinot Noir. It is a delicious and dry Pinot Noir from the Talley Vineyards people up in Arroyo Grande. I don't have the numbers for the 2023 vintage, but the sugar levels in past vintages were 0.26 grams per liter in 2022, and 0.07 grams per liter in 2021. The 2023 vintage is probably along those lines. It's a gorgeous Pinot Noir. Red fruit, spice, mint, and citrus notes come forth. It's juicy

and fresh at the finish. It is absolutely one of the best values around year after year. It tastes like a Pinot Noir should. It doesn't have the coy sweetness or the artificial flavor that I find in Meiomi Pinot Noir. The 2023 Bishop's Peak SLO Coast Pinot Noir is available at The Bottle Shop for \$18.99.

ABOUT ISHI – IN HONOR OF INDIGENOUS PEOPLES DAY

Last Monday was once called Columbus Day, now called Indigenous Peoples Day. To commemorate that day, I gave a talk at the non-profit WTI about the man known as Ishi, and how Ishi represented the civilization that had been destroyed.

On August 29, 1911, an obviously starving man was found trying to find bits of meat out-side a meat-processing facility in Oroville, California. He was dressed in rags of old cotton fragments. He was arrested by the local sheriff without incident, and taken to the local jail, and it was clear that he understood neither English nor Spanish.

It was quickly determined that he was an indigenous man who spoke a language that was not common, and anthropologists and other translators were called.

In the first week of September in 1911, crowds of local people came by the jail to see the man that the media were then calling a "wild Indian."

It turns out that this "wild Indian" was the last of his group of the Northern California Yana territory. Through a translator that spoke a similar language, they learned that this man had wandered about 60 miles from his home camp, and that all of his family and clan were dead. He was the last of the Yahi (the southern-most of the Yana group), and because a name was demanded, the translator decreed that he will be called "Ishi," meaning "man" in the Yahi language.

In his first few days in his jail cell, Ishi ate or drank nothing that was given him even though he was obviously emaciated. It was learned later that Ishi believed he would be put to death by his white captors, since that is what had happened to everyone else in his little circle of family and associates.

Thomas Waterman and Alfred Kroeber, two professors with the University of California, Berkeley, Museum of Anthropology, intervened and took Ishi under their wings, and brought him to their facility, then in San Francisco, where the story slowly unfolded. Ishi lived there for the next five years until he died in March of 1916.

The story of Ishi is a fascinating one. He has been compared to the famous 5000 year old "Ice man" found in the Swiss Alps, whose body and artifacts told us so much about that bronze age period of Europe. But Ishi was a living person, not an artifact from the past. He has also been described as a living Rosetta Stone, a way to translate the literal practices and facts from one nearly extinct culture to another.

Much has been written about this "last wild man" who came out of the California wilder-ness in 1911. To some, he was an embarrassment, a harsh reminder that the indigenous peoples of the state were still here, after the harsh treatment by the Spanish missionar-ies. The native population also

survived the short reign when California was part of Mexi-co, and they (barely) survived the Gold Rush era of 1848 to 1855, when thousands of mostly Irish miners came into the state with the hopes of getting rich.

The gold rush put great pressure on the indigenous populations, since the mining activity damaged water supplies, killed fish, and new infectious diseases such as smallpox and measles were introduced. If that wasn't enough, the new settlers of the area put a bounty on the natives. The northern-most Yana group actually was entirely wiped out, and the Yahi group (of which Ishi was a part) dropped precipitously.

[Nyerges is the author of several books including "Self-Sufficient Home" and

The work of Waterman and Kroeber did much to reveal and reconstruct the Yahi culture, and the life of Ishi in particular.

Ishi was able to describe family units, and the ceremonies that he knew, though much of his peoples' traditions had already been lost when he was growing up. He also identified material items and showed the techniques by which they were made, such as how to make fire with the hand drill, how to make arrows, bows, and shelters. He also provided valuable information on his own language to the linguist Edward Sapir.

On the level of physical anthropology, Ishi showed to the world how people made their tools, homes, and lived off the land. He became a hero of flintknappers – those who take up the art of making stone arrow points – because he was one of the very last native stone tool makers in North America, and his techniques are now widely copied.

But Ishi lacked the acquired immunity to the diseases common among European Ameri-cans, and was frequently ill. He died of tuberculosis on March 25, 1916. It is said his last words were "You stay. I go."

Possibly the best presentation of the story of Ishi was documented in Theodora Kroeber's 1961 book, "Ishi in Two Worlds." Theodora was the wife of Alfred Kroeber, who worked most closely with Ishi, so she had access to some of the best insights into the recent histo-ry of Ishi, and his clan. For example, most of the northern Yana people were considered extinct by the Gold Rush, and Ishi's southern clan, the Yahi, had greatly reduced num-bers. After the Three Knolls Massacre, the Yahi population was even further reduced. Ishi would have been a very young child in 1865.

In late 1908, a group of surveyors reported coming across what they later believed to be Ishi's camp. It was occupied by two men, a middleaged woman, and an elderly woman. These were respectively Ishi, his uncle, his younger sister, and his mother. Ishi, his uncle, and younger sister managed to flee, but the mother was sick and unable to flee and hid herself in blankets. The camp was ransacked, and the mother died shortly after Ishi re-turned. He never saw his sister and uncle again.

Ishi then spent the next three years in the wilderness alone. There were fires in that area, and at about 50 years of age, Ishi had wandered about 60 miles from his home camp. By August 29, 1911, Ishi was starving, and was captured while hunting for meat scraps, thus beginning the revealment of the last indigenous person who'd been living the old ways.

Remember, the Spanish invaders destroyed the great civilizations of the Aztecs and Maya, in their quest for gold. California goldminers did essentially the same thing. Neither seemed to recognize that the real gold, the spiritual gold, that was there in the form of the living culture. That living gold is always more valuable than the physical gold. I am re-minded of the saying, "I sought my soul, but my soul I could not see. I sought my God, but my God eluded me. I sought my brother, and I found all three."



SENIORS EMBRACE EXERCISE FOR HEALTH AND LONGEVITY

As the global population ages, the importance of exercise for seniors has never been more evident. Re-search consistently shows that regular physical activity not only improves physical health but also enhances mental well-being, making it essential for older adults.

Local community centers have seen a surge in senior fitness programs, offering tailored classes such as yoga, tai chi, and water aerobics. These programs are designed to accommodate various fitness levels, promoting both strength and flexibility. "Exercise is crucial for maintaining mobility and independence," says Sarah Jenkins, a fitness instructor specializing in senior wellness. "It helps combat common issues like arthritis and balance problems."

The benefits of exercise extend beyond the physical. Studies indicate that engaging in regular activity can significantly reduce the risk of depression and anxiety in seniors. Many participants report improved mood and social connections through group classes. "I used to feel isolated after my husband passed away, but now I look forward to my weekly classes and the friends I've made," shares Mary Thompson, a 72-year-old participant.

Communities are encouraged to support senior fitness initiatives, recognizing the profound impact of exercise on quality of life. Local governments are increasingly investing in accessible parks and recrea-tional facilities to promote active lifestyles among older residents.

As more seniors prioritize their health through exercise, they are not only enhancing their longevity but also inspiring younger generations to adopt healthier habits. The message is clear: staying active is key to aging gracefully.

BEST CPAP ALTERNATIVES FOR SLEEP APNEA

Dear Savvy Senior:

I've been diagnosed with sleep apnea and have been trying to use a CPAP device for the past six months but can't tolerate it. Are there any alternative treatment options you can tell me about? Sleepy Sam



Dear Sam:

I'm sorry to hear your CPAP mask is keeping you awake at night, but I'm happy to hear that you're addressing your obstructive sleep apnea (OSA) problem. Left untreated, OSA is linked to daytime sleepiness and an increased risk of anxiety, diabetes, hypertension and stroke.

For those whose aren't familiar, OSA causes your breathing to pause during sleep because something blocks your airway, like your tongue or relaxed throat muscles. Losing weight, quitting smoking, and limiting alcohol can all help ease obstructive sleep apnea symptoms such as snoring.

The primary treatment for people with moderate or severe OSA is a continuous positive airway pressure (CPAP) machine, which keeps your airway open by pumping air through a mask you wear over your mouth and/or nose when you sleep.

But many people, like yourself, have difficulty tolerating CPAP and don't stick with it. But CPAP machines have become smaller and quieter, with more comfortable options available. And for some people with mild to moderate OSA, less invasive alternatives to CPAP may be worth considering. Here are several to ask your doctor about.

Dental device: This is designed to move the jaw so that the tongue shifts toward the front of the mouth to help keep the airway open. It's one of the primary alternatives to CPAP and can also be used with CPAP to help make severe obstructive sleep apnea milder.

A dentist who specializes in sleep medicine (find one at dentalsleep.org) will be able to customize its fit to help your breathing without causing harm to your bite or teeth. These custom-made oral appliances can cost between \$2,000 and \$4,000 but may be covered by insurance.

There are much cheaper options available online to treat snoring, but experts say these may not help with OSA, and could move teeth out of place or cause jaw issues if they're not properly fitted.

Position therapy: For some, sleeping on the back can make obstructive sleep apnea dramatically worse. In these cases, switching to side sleeping – perhaps using pillows or a tennis ball attached to a shirt back – can sometimes help.

Tongue trainer: In 2021, the Food and Drug Administration approved a tongue-stimulating device for mild sleep apnea called eXciteOSA (exciteosa.com), which people wear for 20 minutes a day for six weeks and then 20 minutes a couple of times a week indefinitely. It costs \$1,650 and is not covered by insurance.

Surgery: Those who can't tolerate CPAP could have upper airway surgery to reduce the size of their soft palate or other tissue in their throat. But such options don't always work, have serious potential complications, and cannot be reversed. So, in general, they should not be first-line treatments.

A newer option is a surgically implanted device called Inspire (inspiresleep.com). Approved in 2014, it stimulates a nerve that moves your tongue to keep your airway open. Inspire can be removed if it is not tolerated, but it should also be tried only if someone is unable to use CPAP, and it is not an option for everyone.

Drug therapy: A new study, recently published in the New England Journal of Medicine, found that tirzepatide - the main ingredient found in type 2 diabetes medication Mounjaro and weight loss treatment Zepbound - helps reduce symptom severity by almost two-thirds in adults with obesity and obstructive sleep apnea. Ask your doctor about this option.





at you - down [there] a beautiful woman - they'll look at you and they will kill you" - Donald Trump, addressing an audience member

at the Economic Club of Chicago when asked about the impact of mass deportations on the economy.

The big news of the week was Trump's comments to Maria Bartiromo on Fox about the "enemy from within"; "We have some very bad people we have some sick people, radical left luna-tics". But he assured they "should be very easily handled by, if necessary, by National Guard, or if really necessary by the military, because they can't let that happen."

Trump's willingness to use the military against Americans comes in tandem with previews of Bob Woodward's new book, wherein Trump's former Chairman of the Joint Chiefs of Staff Gen. Mark Milley describes Trump as "fascist to the core" and "the most dangerous person ever". Last month, Trump threatened to prosecute and jail "unscrupulous" election workers "at levels, unfor-tunately, never seen before in our Country."

As expected, the MAGA team assures there's nothing to worry about. On CNN, Virginia Gov. Glenn Youngkin insisted Trump was simply suggesting using the military in dealing with undoc-umented immigrants - even after host Jake Tapper had played Trump's exact quote, in which he identifies one of those "radical left lunatics" as Congressman Adam Schiff.

Others have excused Trump's statements as merely "negotiating positions", or "Trump being Trump". But interviewed on CNN, Olivia Troye, advisor to former V.P. Mike Pence, recalled how "I walked those grounds outside the White House the day that Donald Trump suggested we shoot protesters and Americans. . . I had friends there in that square with their families. They were peacefully protesting."

Also on that interview was Kevin Carroll, former counselor to retired Marine Gen. John Kelly when he served as Trump's homeland security secretary; "He wanted to use the military to shoot migrants, including women and children, crossing the Rio Grande. . . He wanted to invoke the Insurrection Act to use federal troops against protesters during the George Floyd demonstrations..." As Carroll summed it up, "Trump was just itching to misuse the military."

The fear now is that, under hiring guidelines outlined in Project 2025, Trump would no longer have staff members who'd tell him "No". Asked for an assessment of Trump's threats, his for-mer Defense Secretary Mark Esper told CNN, "Yes, I think we

should take those words serious-ly." But according to polls, the major concern among voters remains the economy. V.P. Harris has made her priorities clear; help for first-time close.

They will look | homebuyers, affordable childcare, the wealthiest in-dividuals and corporations paying their fair share of taxes, assistance for small business start-ups, etc.

Trump has had opportunities to put forward his own plans for the economy. At a Fox town hall focused on women's issues, he was asked specifically about the price of bacon. Trump's ré-sponse was that Ukraine wouldn't have been invaded under his watch. (He also referred to himself as the "Father of IVF".)

Then there was the Economic Club of Chicago, where Trum interviewed by Bloomberg Ed-itor-In-Chief John Micklethwait. He was asked about his proposed tariffs and the fact they'd "push up the cost for all of these people to buy foreign goods.

. . That is just simple mathemat-ics." Trump replied that he's "always good at mathematics".

When asked for comment on a Wall Street Journal analysis that his proposals would push deficits up by \$7 trillion over a decade (twice the amount of Harris'), Trump observed "They've been wrong about everything". And as for the interviewer himself, "You've been wrong all your life on this stuff". Asked about breaking up Google, Trump responded by talking about voting rolls in Virginia.

Pressed for an example of cutting waste in government, Trump mentioned remodeling Air Force One. And as for assembling German-made cars in the U.S., "We could have a child do it." Asked about help for small businesses, Trump talked about Apple (with a \$3.6 trillion market cap). And then as to the impact of forcibly deporting 11 million immigrants - well, there's that opening quote above.

As summed up by reporters Nikki McCann Ramirez and Ryan Bort in Rolling Stone, "it quickly became clear that the former president has no conception of the mechanics of or the potential ramifications of the economic platform he's running on". NOW THAT'S RICH HIGH BEAMS AND OTHER ROAD SIGNS

Wow, believe it or not, I am going serious on you this week. I'll try to end on a upbeat and humorous twist. Anybody other than me notice it seems like half of the cars on the road

have their headlights on all the time? That's not the problem. The problem is a significant number of people on the road are driving with their high beams on.

HARRIS POKED THE BAIER IN THE DEN OF DISINFORMATION



In all likelihood, 99 percent of the Fox News faithful who saw Kamala Harris Wednesday night came away convinced anew she's awful. But her decision to visit the notorious propaganda outlet had very little downside.

If she managed to sway a percent or two, that could help her in a close election.

What she did demonstrate - for the small share of Fox viewers with open minds - is she is the precise opposite of how Trump routinely depicts her. He says she's dumb, cognitively impaired, and incapable of stringing sentences together. Perhaps it shocked some viewers to discover none of those slurs are true. Perhaps some viewers will give her points for sitting in the lion's den and showing she's tough and articulate. Perhaps some female viewers noticed she refused to abide Bret Baier's constant interruptions, the first of which came 20 seconds into the interview.

But the most galvanizing moment came late in the half hour, when Harris denounced Trump for railing the other day about unleashing the U.S. military against "the enemy within." Baier was ready for that – or so he thought. He teed up a video clip that sought to whitewash Trump's comments; earlier Wednesday, Trump had insisted, "I'm not threatening anybody." That was the clip.

Well. What else could we expect from a fake news network that was compelled to shell out \$787 million in a court settlement after it was outed for amplifying Trump's relentless lies about the 2020 election?

It was no surprise that the clip Baier aired was deftly edited to omit all of Trump's rants about the so-called enemies within - the "sick" and the "evil" and the "dangerous" and the "Marxists" and the "communists," and "the Pelosis" (one of which was attacked by a hammer-wielding MAGAt). Harris promptly exposed that classic Fox trickery by slapping Baier silly:

"Bret, I'm sorry, and with all due respect, that clip was not what he has been saying about 'the enemy within' that he has repeated when he's speaking about the American people. That's not what you just showed. Here's the bottom line, he has repeated that many times. You and I both know that he's talked about turning the

American military on the American people. He has talked about going after people who are engaged in peaceful protest. He has talked about locking people up because they disagree

"This is a democracy. And in a democracy, the president of the United States, in the United States of America, should be willing to handle criticism without saying he'd lock people up for doing it. And this is what is at stake, which is why you have someone like the former chairman of the Joint Chiefs of Staff saying what Mark Milley has said, about Donald Trump being a threat to the United States of

Baier was facing the camera, so it was impossible to see the tire tracks on his back.

Another great moment was when Baier pointed out that roughly half the voters seem likely to support Trump, he asked Harris whether she thought they were "stupid." That was an obvious Baier trap, inviting her to utter a basket-of-deplorables remark a la Hillary. But she was too smart to take that bait: "I would never say that about the American people!"

Are at least a small percentage of Fox viewers willing to abide a strong woman who refuses to kowtow? We'll see about that. But her forthright fervor likely did her no harm - and it'll arguably play better, in the social media clips, than Trump's response Wednesday night, during a Florida event, to a question about whether he still thinks climate change is a hoax. He proceeded to talk about his Doral golf course:

"I get awards, environmental awards for the way I built it for the water, the way I use the water, the sand, the mixing of the sand and the water, I mean many different, but I've had many awards over the years for environmental, the way I've built because you know about building that's what you do...The water is coming up an eighth of an inch over 300 years, the ocean is gonna rise and you know nobody knows if it's true or not but they're worried about the ocean rising an eighth of an inch or a quarter of an inch in 300 years.'

Harris was willing to do Fox News, so perhaps Trump would be willing to explain his climate change comment in a sitdown with MSNBC.

He'll do it right after he releases his medical

This allows athletes to train more frequently and push themselves harder without the lingering soreness that typically follows a tough workout.

Additionally, compression therapy may help prevent injuries. Overworking muscles, tendons, and ligaments without proper recovery increases the risk of strains and injuries. When muscles heal quickly and efficiently, the body is better prepared for the next workout, reducing the chances of injury. This is especially important for those who train at high intensities over consecutive days.

There is also evidence that using compression therapy regularly can enhance athletic performance. Faster recovery means athletes can push harder during their next workout without feeling as fatigued. Over time, this can lead to improved performance as the body is able to sustain higher levels of training with less downtime between sessions.

To maximize the benefits of compression therapy, it's essential to use the devices correctly. The optimal time for compression therapy is immediately after exercise when the muscles are tired and blood circulation is needed to clear out waste and bring in nutrients for repair. Most compression sessions last between 15 minutes and an hour.

Some compression devices allow users to adjust the pressure levels. Finding the right balance is key—the pressure should be firm enough to promote blood flow but not so tight that it becomes uncomfortable. Overly tight compression can cause discomfort and might even hinder circulation rather than help it.

Adding compression therapy to a recovery routine, which might also include proper stretching, hydration, and balanced nutrition, can further improve results. However, anyone with medical conditions or injuries should consult a healthcare professional before using compression therapy to ensure it's safe for their specific situation.

MEASURE PS IS NOT THE SOLUTION

The time has come for the voters in Sierra Madre to start thinking with their head and not their heart. This town really isn't Mayberry and never will be. Yes, it is a delightful community with much to love. But, we are being asked to OK a new tax that really won't do much to keep things going in the long term.

Measure PS would not be necessary in the first place if the city had a sufficient revenue base to sustain itself as a "self-service" city. The belief that a parcel tax will fix things is unrealistic.

Sure, it is nice to be able to point to shiny police vehicles and fire engines and say "those belong to us!" But they come at high cost and that cost will only continue to grow. The City has had many opportunities over the years to spread the overhead of the services it provides, but has stubbornly refused. There simply is no way going forward that there ever will be enough money to go it alone. There are very few cities any more that are fully "self-service". All of them are much larger than Sierra Madre, with far more robust revenue sources. And all of them are in just as much financial difficulty as this town.

Measure PS creates a parcel tax many times larger than anywhere else in California, and that is to support among the smallest police and fire departments in the State. This parcel tax will supposedly expire in seven years. Does that mean that a sudden removal of, by then, about \$2.5 million per year will not be an issue? That is ludicrous. This tax will never go away, and for anyone to say otherwise is either foolish or dishonest. There will be another measure to extend this tax. Just remember that we were coaxed into approving a permanent 10% utility tax—when it was set to being sunsetting—that would solve the city's financial difficulties, until it didn't. Then we gave the OK to a sales tax hike because that would solve the city's financial difficulties, until it didn't. And here we are again being asked to pay even more with a brand new tax.

And looking at the way Measure PS is worded, it will index to the CPI, but never be less than a 1% increase. What that means is that this tax will go up every year even if the CPI goes into minus territory—which it did most recently in 2008-2009.

The bottom line is that Sierra Madre can't afford itself any more. Throwing more money at this situation won't fix it. It is time for the City's leaders and residents to come to grips with the reality that the halcyon days of yore have been left behind.

It's time for Sierra Madre voters to think with their head and not their heart. Vote NO on Measure PS.




