

The New Year is just a day away. Sounds like "Annie" "Tomorrow, Tomorrow, I love ya, tomorrow, you're only a day away!"

I'm thankful I can end the year by talking about a new business here in town! A pottery studio in Kersting Court, owned by a delightful young man, Yau Tong, who has been creating beautiful pottery for 17 years. The picture this week is Yau Tong. One Cup Studio opened on November 2nd. Before opening this new studio, he was home-based where he created his pottery and gave classes. He is planning to offer classes as soon as he is fully settled into his new studio. He creates his own glazes and the items he makes are dishwasher and microwave safe. That's a big plus! There's a pottery wheel in the studio and Yau Tong does custom orders and even carries pieces from other artists. So exciting, a new place to check out and buy something beautiful. Our other new business, the bookstore, "Fables & Fancies" is doing splendidly! Another place to shop here in town!



I saw somebody or other on some Food Network show talking about that fine old Southern tradition of devouring a bowl of blackeyed peas on New Year's Day. My grandmother, Louise Pitzer Sessions, was born in Texas (none of us knew exactly what year as she felt that was nobody's business but her own), raised in Virginia and eventually ended up in California. She was a great believer in that black-eyed peas thing as she totally agreed with the philosophy that said eating them on New Year's Day would bring wealth and success in the coming year. That really never happened but she made really incredible cornbread to go with them. That was my favorite

Here's a little excellent superstition to go with your black-eyed peas:

There are several DO NOT's if you want to keep your black-eyed pea dishes "lucky":

Day has come and gone, but it's not too late to treat yourself to some black-eyed peas.

Do not add chicken stock as chickens and other fowl move backward as they eat. 2. Do not use beef, as a cow will move forward, sideways and backwards as they graze, whereas, a pig al

ways pushes forward as it eats. Do not use canned peas as they've already swelled so your luck will not "swell" as it will with dried peas.

My grandmother subscribed to a couple of these: She used lots of bacon in her peas and she had no intention of buying dried peas, picking through them to find any duds or whatever, soaking them for hours and so forth. Instead, she marched across the street to the Market Basket and bought a couple of cans of whatever was on sale. She cut up a couple of onions, several pieces of bacon, fried those

together till they were soft and slightly brown, drained out the bacon fat, added the peas and let the whole thing simmer together for

an hour or so while she made the cornbread. Hers was the best I've ever had. No, I don't have her recipe. I wish I did. Yes, New Year's

The Christmas bills haven't started showing up yet, which means I'm living in a happy sense of false security that my Discover bill won't be too bad at all. (Go ahead, laugh!) But in the realm of shopping, I came across an article about how much the 12 Days of Christmas would cost this past year. Giving your true love every item from "The Twelve Days of Christmas" would cost you 5.4% more this year. That's more than double last year's 2.7% increase! As a whole, the 12 presents would cost \$49,263! I don't know, friends and neighbors, I've always wanted a small but tasteful bag of diamonds and that would cost less than all those 12 totally ridiculous gifts.

Each year I like to pick a Word of the Year. Rather than setting goals or resolutions based on improvements or fixing something in your life (exercise more, lose weight...sigh) we can start our year with a word that symbolizes our intentions for the year ahead. My word this year is

#### **PWP Water Main Project** Begins on Monday

Pasadena Water and Power ("PWP") officials announced Thursday that they are replacing a 90-year-old water main that stretches along Grand Avenue beginning Monday. The six to four inch line will be replaced by a 12 to eight inch ductile iron mainline pipe, which will reinforce PWP's water service reliability in the area. The project is currently projected to be completed by the end of August.

To minimize the project's impact on residents and businesses in the area, PWP will implement several special measures. Construction efforts will be contained to approximately one block at a time, starting near the intersection of Green Street to the north and proceeding south on Grand Avenue until reaching California Boulevard. Water service will be intermittently interrupted and will be noticed 48 hours in advance. Temporary traffic control and detour signs will be posted at all times during construction. Work will occur Monday through Friday from 9 a.m. to 4 p.m., unless specifically notified.

Los Angeles County Board of Supervisors Chair Kathryn Barger and Supervisor Hilda Solis have introduced a motion to declare Thursday, January 9, a Day of Mourning across Los Angeles County in honor of former President Jimmy Carter, who recently passed away on December 29,

2024, at the age of 100.


United States President
Biden recently proclaimed
January 9, as a National Day of Mourning, ordering the closure of federal government offices as a mark of respect for the late President Carter. Barger and Solis' motion aligns Los Angeles County with this federal observance, following the precedent set in 2018 when the Board honored the late President George H.W. Bush with a similar action.

"President Jimmy Carter's lifelong commitment to public service, human rights, and global peace exemplified the highest ideals of leadership," Barger said. "It's fitting that Los Angeles County joins the nation in paying tribute to his extraordinary legacy by

observing a Day of Mourning." The motion calls for the closure of all non-emergency and non-essential County offices, agencies, and entities on January 9, allowing county employees and residents to reflect on President Carter's contributions to the nation. Essential services, including public safety and emergency operations, will continue uninterrupted as determined individual County Department Heads.

#### Pasadena Library Receives Lunch at the Library Grant

Pasadena Public Library received a \$33,176 grant from the California State Library for the 2025 Lunch at the Library program. This award is an increase from the previous year's grant, ushering in the fifth year of Lunch at the Library at the Pasadena Public Library.

Lunch at the Library is a state-wide initiative that provides grants, training, and resources to help libraries establish successful summer meal sites or provide programming and resources at other community meal sites. Pasadena Public Library offers both.

In 2025, Pasadena Public Library will continue to visit free meal sites throughout the community, providing high-quality and high-interest books for children ages 0-18 to add to their home libraries while connecting families to the annual Summer Reading program. In addition, the library will continue to offer free meals at the Jefferson Branch Library and plans to add a second meal site at another branch library. Library meal sites will have a scheduled daily activity, primarily led by a local educator and community partners. These activities will incorporate farming, STEAM, sustainability, music and other enriching, educational activities. Many of these programs will be continuous; encouraging longterm participation throughout the summer.

During the summer of 2024, the library served 1,619 free meals

to kids while engaging families in learning activities and summer reading participation. The 2024 program also engaged 17 youth interns and volunteers—providing young adults with work experience and development.

Lunch at the Library helps address food insecurity over the summer months while promoting literacy. According to the 2022 Pasadena Community Health Needs Assessment, 13.9% of households reported being food insecure. Among new parents who participated in the 2022 Pasadena Maternal Health Assessment, 10.7% of new parents reported food insecurity.

The goal of Lunch at the Library is to provide healthy food and literacy, two ingredients that every child needs to succeed in school

## OUND SAN GABRIEL

#### **ADAM SCHIFF SWORN** IN FOR SIX-YEAR TERM AS CALIFORNIA'S U.S. **SENATOR**

LOS ANGELES (CNS) - After being sworn in for a sixyear term, Burbank Democrat Adam Schiff set a record for being the only senator in the history of the U.S. Senate to have taken the oath of office three separate times in less than one month.

Sen. Alex Padilla accompanied Schiff on the Senate floor as he took the oath of office Friday morning. After the ceremony, Schiff issued a statement in which he described his role as an ``honor of a lifetime."

``From the towering redwoods of the north to the fertile farmlands of the Čentral Valley, from the breathtaking beaches and deserts of the south to every community -- large and small -- in between, California is a big state with big dreams," Schiff said in a statement.

'We must work to ensure that every Californian can share in what our state has to offer. And that starts with the work necessary to build more housing and lower the cost of living," Schiff added. ``To create an economy that works for everyone and protects our planet for generations to come."

According to the U.S. Senate Historian, Schiff set a record after taking the oath of office three separate times. In March 2024, Schiff won a special election and later a general election following the passing of former Sen. Dianne Feinstein, who died in September 2023.

Following his November election victory over Republican Steve Garvey, Schiff was sworn in Dec. 9, 2024 to serve out the remainder of Feinstein's term. Laphonza Butler filled Feinstein's seat on an interim basis pending the results of the November election.

On Dec. 19, 2024, he took the oath of office once more after the California Secretary of State certified the state's election results.

Schiff's office previously announced he will serve on the Senate committees of the Judiciary; Agriculture, Nutrition and Forestry; Environment and Public Works; and Small Business and Entrepreneurship.dam Schiff



#### HELPING CHILDREN DEVELOP HEALTHY **DEVICE AND MEDIA HABITS**

(StatePoint) What are TikTok's privacy settings? Can parents control what advertising their children see on Facebook? How do parents limit the amount of time their children spend on

A new parent tool, the Glossary of Digital Media Platforms, offers the answers and will be handy for parents of children trying out new phones or other tech-related holiday gifts. The American Academy of Pediatrics Center of Excellence on Social Media and Youth Mental Health developed the free resource, which contains detailed information on popular digital platforms, including Apple, Discord, Facebook, Instagram, Pinterest, Snapchat, TikTok and X, with more to come.

"Parenting around media can be so challenging," said Jenny Radesky, MD, FAAP, co-medical director of the Center of Excellence. "Figuring out what apps and settings are best for your family is an important part of the conversation. At the center, we created the Glossary of Digital Media Platforms to make it a little easier for parents to learn about each app and figure out what settings and tools exist to keep their kid safe while connecting online."

Users click on a platform to learn about its default and customizable safety settings; messaging and friending controls; screen-time management settings; parental controls and more.

Parents aren't the only ones looking for assistance when it comes to the online world. Pediatric providers, teachers and others who work with children and teens can introduce the glossary briefly during clinic visits, back-to-school nights, in newsletters, or other communications and encourage families to have conversations about safe and balanced relationships with social media. The tool can also facilitate conversations on concepts like private versus public accounts, time limits and how to block or filter upsetting content.


Here are some examples of how the glossary can be used:

- · If children have iPhones, parents can learn more about the Family Sharing feature, which includes settings to limit who a child can contact, downtime/do-not-disturb settings and the Ask To Buy option that requires a parent to approve purchases.
- If social media and notifications are distracting teens at night, families can use the glossary to look up apps and how to silence notifications or activate other nighttime settings.
- For teens who are stressed out by negative content on social media feeds, the glossary contains information on tools to curate feeds and block and filter content.
- If a child's school has a phone policy, families can look up device or app settings to silence distracting apps during school hours.

The glossary joins a roster of resources available at Center of Excellence on Social Media and Youth Mental Health, which includes conversation starters for parents concerned about how their children are using social media. The center's activity cards can help young children build healthy relationships with media and their devices before they grow into teens and young adults.

Megan Moreno MD, MSEd, MPH, FAAP, co-medical director of the Center of Excellence, urges parents and other adults to avoid taking a doom-and-gloom approach when talking about the sometimes-dangerous social media landscape with kids.

"We can give ourselves grace for these initial reactions of worry and fear, but we have a choice to make on what we want our reaction to be going forward," Dr. Moreno said. "We can choose open-mindedness. We can choose curiosity. We can choose evidence over hype, and we can stay centered on our children and families."

Christmas dining options in Pasadena were slim, but this year, my daughter and I found a worthy spot to continue our tradition of a festive meal. With Panda Inn no longer staying open for the holiday, we were fortunate enough to enjoy dinner at Gaucho Grill on South Lake Ávenue—a restaurant

I've been a fan of since they opened nearly four years ago.

As many of you know, I was born in Greece and have traveled extensively, exploring a wide range of cuisines. While I haven't been to Argentina, I can confidently say they are renowned for their beef and steaks—and Gaucho Grill lives up to that reputation.

The restaurant had a warm and inviting atmosphere, perfect for the holiday. I wholeheartedly recommend the steak dishes, as they are the highlight of the menu. My friend Dave Yost, a local restaurateur, even raved about their "Steak for Two," claiming it's among the best in town. While we opted for more modest portions, we were thoroughly satisfied with our choices.

Our meal began with Prawns and Hearts of Palm, a starter that set the tone with its fresh and vibrant flavors. For our mains, we chose the Gaucho Skirt Salad and the Short Rib Pappardelle. Both dishes were impeccable, but the steak in each truly stole the show. The skirt steak was perfectly cooked, and the short rib complemented the pappardelle beautifully.

A small quibble: we requested to sit at the bar but were seated at a table instead. I'll be back for looked like a great Happy Hour menu.

When the weather permits, Gaucho Grill offers outdoor dining, adding a lovely option for those who enjoy al fresco meals.

#### **INGREDIENTS**

- 1/2 pound flank steak
- 1/4 teaspoon salt
- 1/8 teaspoon freshly ground pepper
- 2 tablespoons peanut oil, divided 1/2 cup beef broth or water
- 1 tablespoon light brown sugar
- 2 tablespoons soy sauce
- 2 teaspoons fresh lime juice 1/2 teaspoon cornstarch
- 12 ounces fresh Brussels sprouts, trimmed and halved
- 1 red jalapeño or red serrano pepper, sliced
- 1 tablespoon grated fresh ginger
- 2 garlic cloves, thinly sliced 1/4 cup chopped fresh mint
- Hot cooked rice

#### **DIRECTIONS**

- 1. Cut steak diagonally across the grain into thin strips. Sprinkle with salt and pepper.
- 2. Stir-fry steak, in 2 batches, in 1 Tbsp. hot oil in a large cast-iron or stainless-steel skillet over high heat 2 to 3 minutes or until meat is no longer pink. Transfer to a plate, and wipe skillet clean.
- 3. Whisk together beef broth and next 4 ingredients in a small bowl until smooth.
- 4. Stir-fry Brussels sprouts in remaining 1 Tbsp. hot oil over high heat 2 minutes or until lightly browned. Add jalapeño pepper, ginger, and garlic, and stir-fry 1 minute. Pour soy sauce mixture over Brussels sprouts, and bring mixture to a boil.

Cook, stirring often, 3 to 4 minutes or until sprouts are tender. Stir in mint and steak. Serve over rice.




#### ALL THINGS By Jeff Brown

#### John Wheeler A Non-Duality Expression

#### FINDING OUR ANSWERS

In the Catholic Church, there is a practice known as Confession. I was taught how to do Confession as a child growing up in Catholic school. You enter the little closet-sized room and kneel. There is a partition in front of you and a priest is on the other side. We were taught what amounts to the

formula for saying Confession. You tell the priest how long it has been since your last Confession and then you recite all the bad things you have done. The priest listens and then tells you what form of penance you must do in order to atone for your sins.

Now, there are some Catholics who take this very seriously, because they want to change their character. They pour out their hearts to the priest and they might be in the Confessional for 20 minutes while everyone else is waiting in line. Such individuals undoubtedly gain the most by this practice.

As a school child, I did not take it very seriously, and worked hard to think of something to tell the priest - little things like lies or hitting my brother. I would never dream of actually being serious with the priest because we were children, and were just going through the motions of what our parents and teachers told us we had to do. To make things worse, there were older boys, even some family members, who bragged that they did whatever they wanted - lying, stealing, sexual misconduct, drugs - and that they were always OK as long as they got to a Confessional before they died! I did not find that sort of mindset to be even pragmatic, let alone spiritual.

In time, even though I was no longer a Catholic, I understood the profound importance of looking deep and revealing one's "sins" for the end goal of improving your character. It had to be sincere, and it was usually painful if you were truly altering your bad character habits. When I was under the tutelage of my guru, starting in the mid-1970s, I was taught what I would call a secular version of the Confession, called "Retrospection." Retrospection was a review of each day before sleep, where you judge all your acts of import, either "good" or "bad." This was ideally done in writing, so you don't forget. Then, as part of the Retrospection, you write down how you will rectify whatever bad things you might have done that day. IF you were sincere, you would make that rectification as soon as humanly possible, which meant first thing the next day. You might call someone to apologize for some act, or you would return money that you took, or whatever it took to balance the thing you did. Good things were also acknowledged, though no action is required there. It's good to self-recognize that you took the right action, but resting on your laurels is indul-gent.

Since I have practiced both the Confession and Retrospection, I can say that both practices are essential to improving your character and overcoming your own character flaws IF they are done with deep sincerity. To me, it really doesn't matter what you call yourself in terms of religious allegiance; what really matters is that you take it to heart, and live a better life because of this.

Now, I have shared the above in order to put a recent dream of mine in context. In the dream, I was attending Mass at St. Elizabeth church in Altadena, where I also went to school for 8 years. The church was very crowded, and I noted that people were using the Confessional, which is unusual for a Sunday. Anyway, when it was free, I entered the Con-fessional, and was about to begin the usual rigamarole. I noticed that the screen was al-most see-through, which was not the norm. I told the elderly priest (who I could see quite well) that I hadn't been in church in decades, and then, rather than recite a litany of all my sins, I explained how I was trying to understand the point of my life, and anyone's life, and always trying to live a life that had meaning and was not rote. I spoke for some time ex-plaining this. After I was done talking, another priest appeared behind the screen and he addressed me

by my name, which surprised me. At least when I was growing up, Confession was a near-ly secret event and the priest and parishioner never saw one another. Anyway, the priest told me that none of the stuff I just told them mattered much. He said that all that really mattered in life is if I did what I said I would do. He added that all that really matters in life is know what to do, and to not do, and that "how" we do everything is all that matters.

Then he held up a paper which seemed to be a receipt for some book. "You purchased this some time ago," the second priest told me. "Why haven't you read it? The answers you seek are there." I was stunned. Is this how they do Confessions now? And I was frustrated because, in the dream, I could not see the title of the book.

Then he held up another paper, which looked like a school transcript, and told me that I had signed up for some class, and that I needed to actually take the class, or finish it. "You will find your answers there," he assured me, though again, I could not read the class title on the paper.

Finally, before departing, the younger priest told me that his life in the Confessional is very boring since most people go through the formula and are not sincere about changing their bad ways and making amends. He said I was refreshing because I shared what I was feeling and avoided the roteness with which I had attended to religious ceremonies most of my life. That made me feel good, but I was still frustrated as I woke up to a new day. What book was I to read? Did I already possess it? And what class did I sorta start, but didn't follow

Needless to say, I have a lot of material to work with now in this New Year.

## DOES MEDICARE COVER TALK THERAPY SERVICES?



Dear Savvy Senior:

What types of mental health services does Medicare cover? I struggle with anxiety and depression, and my primary care provider recommended I see a therapist or psychiatrist.

#### Dear Annie:

Medicare actually covers both outpatient and inpatient mental health care services and programs to help beneficiaries with anxiety, depression and many other mental health needs. Here what you should know.

#### Outpatient Coverage

If you're enrolled in original Medicare, your Part B coverage will pay 80 percent (after you've met your annual \$257 Part B deductible) for a variety of counseling and mental health care services that are provided outside a hospital, such as in a doctor or therapist's office, hospital outpatient department or community health center. These services can also be received via telehealth.

You, or your Medicare supplemental (Medigap) policy, is responsible for the remaining 20 percent coinsurance.

Medicare also gives you the expanded option of getting treatment through a variety of health professionals such as psychiatrists, psychologists, clinical nurse specialists, clinical social workers, nurse practitioners, physician assistants, marriage and family therapists and mental health counselors.

To get this coverage, you'll need to choose a participating provider that accepts Medicare assignment, which means they accept Medicare's approved amount as full payment for a service.

If you choose a nonparticipating provider who accepts Medicare but does not agree to Medicare's payment rate, you may have to pay more. And if you choose an opt-out provider that does not accept Medicare payments at all, you will be responsible for the entire cost.

To locate a mental health care professional in your area that accepts Medicare, go to Medicare. gov/care-compare, click on "doctors & clinicians" and type in your location, followed by "clinical psychologist" or "psychiatry" in the Name & Keyword box. You can also get this information by calling Medicare at 800-633-4227.

#### Inpatient Coverage

If you happen to need mental health services in either a general or psychiatric hospital, original Medicare Part A covers this too, after you've met your \$1,676 Part A deductible. Your doctor should determine which hospital setting you need. If you receive care in a psychiatric hospital, Medicare covers up to 190 days of inpatient care for your lifetime. And if you use your lifetime days but need additional care, Medicare may cover additional inpatient care at a general hospital.

#### Additional Coverage

In addition to the outpatient and inpatient mental health services, Medicare also covers yearly depression screenings that must be done in a primary care doctor's office or clinic. Annual depression screenings are covered 100 percent.

And if you have a Medicare prescription drug plan, most medications used to treat mental health conditions are covered too.

#### Medicare Advantage Coverage

If you get your Medicare benefits through a private Medicare Advantage plan, they too provide the same coverage as original Medicare does, but may impose different rules and will likely require you to see an in-network provider. You'll need to contact your plan directly for details.



**HOW DOES IT FEEL** Seriously, how does it feel? The first day of the year 2025 has already brought tragic news of an attack in New Orleans. We probably all have at least one thing in com-

mon. We don't know what is going to happen next and many of us are worried. My own year started strangely as I awoke from a dream containing a long story explaining how I had been programmed as a spy. In the morning, I at first wondered if my values and beliefs were truly my own.

Perhaps the feeling began even before I went to bed. On Monday, December 30th, I had an appointment to endure an endoscopy examination. This is a medical procedure wherein one is sedated, after which a camera is inserted down one's throat for the purpose of inspecting the upper organs of one's body. I am guessing that perhaps this recognition of my own ignorance as to my physical body carried over into the dream as I speculated about the contents of

I am just guessing now, but I think this questioning is also connected to the movie my wife and I saw last week entitled "The Complete Unknown" a depiction of the life of Bobby Zimmerman, or Bob Dylan as he came to be known. Bob Dylan's music, especially during the 1960's seemed to express or formulate my feelings in that era. Sixty years later I proudly maintain these same values. It is what life has taught me. In 1966 I was fortunate to live in a dorm at UCLA as the coordinator of the Upward Bound Program. I was lucky to be allowed to live in the Dorm with selected High School Students from Watts and Boyle Heights and my values were forever affected by this experience. Some of these before under-achieving students have become mayors, legislators, and

Can you remember the 60's? It was time of momentous change or at least it appeared to be. My participation in the program amounted to allow students and myself to learn from one another. Students had different experiences and different abilities. Some of the students had been witness to the demonstrations downtown and in Compton recalled today as the Watts Riots. These "riots" lasted six days from August 11 -16, 1965. Rioters burned and overturned cars and looted and damaged stores. During this summer of 1965, just after graduating Berkeley, and prior to entering UCLA Law School, I served as the driver for my 55 year old father. He had lost his eyesight a few years earlier but continued to work as a salesman with my mother serving as his driver. Now in the summer of '65 I was his driver as we went with him from store to store, cigar stand to cigar stand, taking orders for cigarettes and candy. I remember one particular stop which made a lasting impression upon me. The cigar stand owner was there at his place of business with rifle almost in hand. He was an old Jewish man, a Concentration Camp survivor, who explained that life was unpredictable, but you must always keep your head about you and do what you have to do and what you feel is right. That is a lesson I learned, a lesson my father had learned as his family had escaped the pogroms in Ukrania and as he continued to work without eyesight.

In my career as a defense criminal lawyer and as a single parent raising two children of very different abilities, I have learned that life gives each of us different circumstances and often different abilities. Nevertheless, no matter who we are and where we find ourselves, there are always choices to be made. I have learned to keep my eyes open (as my father taught me eyesight is not required} and to carry on always expecting the best and ready to deal with the worst

There will always be choices and "by keeping my eyes open" and staying in touch with the lessons I have learned I am my own person ready to cope with the future and to strive to be always the best person I can be. Yes Bob, I feel pretty good.

Now there's another battle between MAGA and Mar-a-Lago, yet again amongst those about to take charge. And we're still weeks out from the Inauguration.

This one began with Donald Trump's choice of Indian-American Sriram Krishnan, who'd helped Elon Musk revamp Twitter/X, as Senior White House Advisor on Artificial Intelligence. Krishnan, like Musk and Vivek Ramaswamy, is a proponent of allowing programs like H-1B visas to bring in increasing numbers of immigrants to work hightech jobs.

against Indians to want the original MAGA policies I voted for." (Over 70% of H-1B visa holders come from India.)

MAGA activist Laura Loomer jumped in to argue those jobs "should be given to American STEM students . . . This is not America First Poli-cy." She added, "It's not racist

While Musk and Ramaswamy claimed a shortage of skilled tech workers here at home, former Trump adviser Steve Bannon charged, "This thing's a scam by the oligarchs in Silicon Valley to basically take jobs from American citizens, give them to what become indentured servants from foreign countries, and then pay 'em less." There were reminders that major corporate employers of H-1B visa holders were also reporting waves of layoffs – with Tesla a prime example.

Musk (rather than the president-elect) had to engage: "I will go to war on this issue the likes of which you cannot possibly comprehend." He called those attacking the H-1B program "contemptible fools (who) must be removed from the Republican Party." More than a dozen conserva-tive bloggers complained of having their accounts downgraded on X af-ter accusing Trump of abandoning his MAGA base and siding instead with those "oligarchs in Silicon Valley".

Ramaswamy had his own peculiar take: Yes, there is a shortage of qual-ified American workers – and it's all the fault of our "culture" having "ven-erated mediocrity over excellence". While "immigrant parents" limit the amount of time their kids spend on TV, "most normal American parents" don't. Those "normal American parents" simply aren't instilling in their kids the values necessary to succeed as "immigrant parents" do.

Sports podcaster Pablo Torre, a classmate of Ramaswamy's at Harvard, offered an analogy: "he's going to talk to that (MAGA) base, a nativist base, the same way that . . . white people have been talking to Black people in America for a really long time – I don't think they're going to like it."

Software engineer "Phil in Denver" posted his own take on H-1B work-ers: "At a time when even a first-year engineer's starting salary was in the \$70-80k range in most of the country, these engineers were working for about \$40k. THIS is the reason Musk et al really want more H1Bs. . . . they can't just hop to another job if things don't work out . . . (These workers) are not smarter, they are not more capable, and they certainly are not more experienced. What they are is cheap and pliant and that is ALL that the DOGE crowd and their fellow tech bros care about. And it is all they ever will."


A self-described "long time Trump supporter" posted on Trump's Truth Social about his own tech job: "They put everyone on worse insurance plans and stopped matching 401k. Finally, they started bringing in H1Bs and let all the long-term employees go after we trained our replace-ments."

MAGA diehards identify with the Trump of 2016, who called the H-1B program a means to import foreign workers "for the explicit purpose of substituting for American workers at lower pay . . . I will end forever the use of the H-1B as a cheap labor program, and institute an absolute re-quirement to hire American workers first". But now it's Trump under Elon Musk: "I've always liked the visas, I have always been in favor of the visas. That's why we have them".

Democrats appear to be sitting this one out. They won't side with sup-porters of importing cheap labor at the expense of American workers, nor with those who reflexively oppose any program that predominantly bene-fits the other-than-white. For Republican officeholders, it's how to main-tain allegiance to Trump while not alienating the MAGA base they rely on for holding their office in the first place.

This latest MAGA vs. Mar-a-Lago battle comes just after the one over government funding and just before the next one over whether Mike Johnson (R-LA) keeps his job as House Speaker. And we're still weeks out from the Inauguration.

After I'd started this column, news broke and I considered changing the topic. But I'll leave it with the opening quote and the following: George W. Bush said of the man who ended his father's bid for re-election, "Pres-ident Carter dignified the office." A federal appeals court has upheld ver-dicts against Trump for sexual abuse and defamation. On the day Trump again becomes president, flags at our nation's capital and throughout our country will be flying at half-staff.

### WHY WARMING UP BEFORE EXERCISE IS A MUST

You've probably heard the phrase "warm up before you work out." While it might seem like an extra step, warming up before exercise is essential for preventing injuries, improving performance, and ensuring that your body is ready for whatever activity you're about to do.

What exactly is a warm-up? A warm-up is a set of low-intensity exercises that prepare your body for more intense activity. It increases your heart rate, loosens up your muscles, and helps improve blood flow to your joints. A good warm-up gradually increases your body's core temperature, so your muscles and tendons are ready for movement without putting stress on your body. If you skip this important step and jump straight into an activity, you're much more likely to experience injuries like strains or sprains, or even more serious damage like tendonitis. NOTE: Warming up does not mean stretching. Stretching cold muscles can have negative effects on your body and be counterproductive.

The key to a successful warm-up is focusing on the muscles and joints you'll be using during your activity. Here's why it's especially important for some common fitness activities:

Cycling. This low-impact exercise can be great for your heart, legs, and overall fitness. However, jumping straight into a bike, especially on a long ride or during a fast-paced cycling class, can lead to muscle strain in your knees, hips, and back. Prepare by doing 5 minutes of easy pedaling after a few leg swings and ankle rolls to loosen up your joints.

Swimming. The water provides a fantastic full-body workout that strengthens your core, arms, and legs. But diving into cold water without warming up can shock your muscles, making it harder to swim efficiently. It can potentially cause strains and stiffness when you first start out, which can impact your performance and increase the risk of shoulder or leg injuries. Try a few gentle exercises on land before getting into the pool, like arm circles and shoulder rolls, followed by easy swimming strokes to gradually increase your body's temperature.

Tennis or Pickleball. Both of these activities require quick lateral movements, sudden sprints, and lots of twisting motions. Without warming up, these rapid changes in direction can strain your legs, shoulders, ankles and lower back. Your body needs to be ready to move in all directions, especially during fast-paced games. Without preparation, your muscles may not be able to handle the intense movements. Start out with a few minutes of light walking, followed by side movements and arm swings to get your body ready for the game.

Hiking. Trail walking, especially in hilly or rocky areas, can be harder on your body than you might think. It requires balance, strength, and coordination, particularly in your knees, calves, and hips. Starting out cold can lead to stiff muscles and make the hike feel harder. You'll increase the chance of injuries like sprains or muscle cramps too. Do some leg stretches like calf raises and lunges, along with ankle rolls to prepare your lower body before setting out.

Strength Training. Lifting weights helps build muscle and improve overall strength, but without preparing your muscles, you could strain your shoulders, lower back, or legs while lifting heavy loads. A proper warm-up helps your muscles become more flexible and ready to take on the stress of strength training. Start with light cardio, like walking or cycling, followed by moving all your joints. Try doing lighter sets of your exercises first to warm up the muscles you plan to work.

Yoga. Known for its flexibility and relaxation benefits, yoga can also strain your muscles if you dive into deep stretches without warming up. Your muscles need to be loose and flexible to avoid injury during poses. Start with a few gentle, flowing movements or simply take a brief walk before beginning your routine.

Running. Although running may seem like a simple activity, it's tough on your legs and joints. If you don't warm up properly before running, you could end up with tight muscles or painful shin splints. Cold muscles can also make running feel harder than it needs to be, and you're more likely to get injured during the activity. Begin with a brisk walk for the first few minutes, followed by a light jog.

Warming up before exercise may seem unnecessary, but it's crucial for preparing your body. Taking time to warm up helps prevent injuries, boosts performance, and ensures a better workout. So, before exercising, don't skip this step—your body will thank you.

## AVOIDANT VS. ATTRACTIVE GOAL-SETTING

We've entered the season of reflection—when many of us pause to evaluate what went well over the past year and identify areas ripe for growth. The pillars of a fulfilling life often fall into familiar categories: health and wellness, relationships, work and creativity, and how we invest our time and money. Yet, how often do we find ourselves setting the same goals year after year? Reflection is a valuable practice, but a common trap is getting stuck in a negative thought loop.

Negativity bias is a design feature of the human brain. It's our mind's way of keeping us safe, scanning for potential dangers and pitfalls. This wiring has served humanity well for millennia, helping us avoid wild animals, poisonous plants, and other threats to survival. But in today's safer, more predictable world, this ancient mechanism often leaves us dwelling on perceived shortcomings rather than focusing on opportunities for growth.

The good news? You can break free once you notice you're in a negativity loop. You can ask yourself: Is this thought true? Is there another way to look at this situation? The answer is almost always yes.

There's a better way to set goals: through attraction, not avoidance.

Consider why you want to make a change. Picture your goal as if it's already achieved. Use affirmative, attractive lan-guage that motivates and excites you. For example:

• "This year, I'm working to improve my fitness because I'm walking the Camino de Santiago in April."

Notice the power of the language:

- I am—not "I want to," not "someday." It's a declarative statement that brings the vision to life. You can al-most see yourself walking through Spain, soaking in the scenery and the camaraderie.
- Here's another example:
- "I'm improving my fitness by biking with my spouse. We love riding to our favorite café for brunch."

These statements focus on what you're moving toward, not what you want to avoid. Instead of framing the goal around preventing a heart attack, stroke, or disease, you're envisioning joyful, specific outcomes. While media and medical professionals often emphasize the negative consequences of poor health choices, that approach rarely inspires sustainable action.

This year, try something different. Start by creating a vivid mental image of your goal as already achieved. Then, think of one small step you can take to begin. No matter how tiny, a single action sets the wheels in motion. Keep taking those steps, and you'll find yourself achieving more than you imagined.

Let's take sleep, for example—one of the topics we explored last week. Here's a baby step to improve your rest: Commit to getting outside first thing in the morning. Ideally, within two minutes of waking, but within the first hour will do. Exposure to natural light resets your circadian rhythm, leading to deeper, higher-quality sleep and improved brain and cardiovascular health.

It's so simple: Step onto your porch in your bathrobe and soak in the morning light. The beauty of this practice? No one else sees the sunrise from your exact perspective. That sunrise is uniquely yours, a moment just for you. Go get your sun!

This year, embrace attractive goal-setting. Visualize the life you want, take small steps toward it, and watch how much closer you'll be to living the life of your




