CITY OF SIERRA MADRE WATER SYSTEM experienced wildfire impacts and may have fire-related contamination. As a precautionary measure, this notice is being issued until test data is available.

DO NOT DRINK-DO NOT BOIL YOUR WATER Failure to follow this advisory could result in illness.

The CITY OF SIERRA MADRE WATER SYSTEM NUMBER 1910148 is located within the EATON FIRE wildfire impact zone; however, the City of Sierra Madre never lost system pressure in any water zone, and the City did not suffer any damage to its critical water infrastructure. The City was able to maintain pressure in all zones within the water system throughout the event. The City conducted an initial assessment of the water system with routine bacteriological samples taken throughout the water system. All samples were analyzed by a third-party certified lab and found absent of coliform bacteria. As a precaution, the City of Sierra Madre is now required to test for Volatile Organic Chemicals (VOCs), including benzene. The State Water Resources Control Board, Los Angeles County Health Department, and the City of Sierra Madre are advising residents of the affected area to NOT USE THE TAP WATER FOR DRINK-ING AND COOKING UNTIL FURTHER NOTICE.

Due to VOCs ability to vaporize at lower temperatures and become airborne, residents are advised to:

- Limit use of hot water.
- Limit shower time/bathing, and do not take baths (use lukewarm water and ventilate area)
- Use a dishwasher to wash dishes and use air dry setting
- Wash clothing in cold water Avoid using clothes dryers (dry laundry outdoors) Do not use hot tubs or swimming pools
- Do not use ice from automatic ice makers
- Use proper ventilation when using water indoors

What should I do?

DO NOT DRINK YOUR TAP WATER - USE ONLY BOTTLED WATER. Bottled water should be used for all drinking (including baby formula and juice), brushing teeth, and making ice and food preparation until further notice.

DO NOT TRY AND TREAT THE WATER YOUR-SELF. Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water

SIERRA MADRE EATON FIRE UPDATES:

Sierra Madre City Manager Jose Reynoso confirmed that as of Friday evening there were 14 confirmed homes that were completely destroyed and 25 structures, which include garages and ADUs that were also damaged by fire. Damage assessments still being conducted..

Restrictions on parking have been eased, however as heavy equipment is working on clean up and restoration of services, residents are asked to avoid parking on the streets. (See details on page 2).

The Sierra Madre YMCA on E. Sierra Madre Blvd. is a resource center for fire victims and a location for donations. The Sierra Madre community have

The Eaton Fire is 73 percent contained today ... up overnight from 65 percent.

Firefighters continue to extinguish hot spots in steep ...inaccessible ... canyons near Winters Creek ... Mount Lowe ... and Mount Wilson. Crews and water dropping helicopters are also working in unison to extinguish any remaining heat in those areas.

The fire has burned more than 14,000 acres in the Altadena and Pasadena areas since it began on January 7th.

It has left at least 16 people dead ... destroyed nearly 8700 structures. and dam-



Every scrap book, is the history of those efforts and the efforts that came before. Every single lost item in this time of unpredictable tragedy is like an eraser, that cleared the chalkboard of the family's existence.

It is the embodiment of the lives that lived there. It is the monument of the dedication that it takes to turn a space into a home. It is the destruction of the rare instances of dreams realized. It is painful it will take years to recover; if at all, and so much of the "Stuff" is irreplaceable. It is Not Stuff!

THANK YOU FROM YOUR UPPER CANYON "MARLBOROUGH TERRACE" NEIGHBOURS!



Thank you, Bill Duvall, Jay Calleton and Dyon Taylor, our dear neighbours, for putting out hotspots and embers on Tuesday night, January 7th, 2025 in our upper canyon. You did this during that treacherous wind event, in the dark, on steep terrain and in life threatening conditions. Ya'll stayed back attempting to save homes while many of us evacuated. We understand you worked throughout the night.

We also extend our most heartfelt thanks to our neighbours who joined in later to fight on. They include Taylor Caruso, Giovanni DePaolis, Connor Haas, Mike Hodgkinson, Miro Serrell Freed, Duane Waliser, and Andres Zamorano.

Additionally, this resident learned that more upper canyon dwellers jumped into action by dousing the flames on the other side of our neighbourhood. Thank you so much Ray Fountain, Serge Lakobrija- and your stepfather Milan as well as our neighbour: Hovik Oganezov.

Apologies if anyone was missed or not mentioned, here. We have since learned that the lower canyon also had residents up by the Dam and other areas flighting flames – the Hagen brothers and Richie Wisz along with Miro, a former 'Hotshot' who was interviewed on CNN.

You are all our brave heroes. We owe you an enormous dept of gratitude.

Sadly, we lost a home on Churchill Road that once belonged to the late, great Minor Harkness of the Sierra Madre Search and Rescue team. The other home lost is artist Lynne Fearman and her husband, Ed. Our hearts go out to these neighbours.

Still, we cannot thank you all for the efforts to save the homes along the hillsides below Mt Wilson trail, it could be that the entire upper canyon was saved! enough

Some of our neighbours had just moved in to this beautiful canyon and some are 'old timers' having lived here for decades, like Bill Duvall. Many were well prepared for evacuation – as in this resident's case, it happened to be our 5th fire experience since 1992. The previous four fires had little to no wind events, but this Eaton fire was a different animal. On January 16th , we viewed our home (s) from up above on the hillside and can see scorched earth, trees and debris that are just a few feet away from the back of our houses. Thanks also goes to the tireless work from volunteers who are now on our Mt Wilson trail clearing brush, and getting it prepared for the next phase: to protect our homes from potential mudslide issues.

WALKING SIERRA MADRE -The Social Side by Deanne Davis

"I'd like to cancel my subscription to 2025. I've experienced the free 7-day trial and I'm definitely not interested."

I expect a lot of us feel exactly like that and my constant prayer is, "Oh Lord, please no more wind!" As people we know are trying to cope with the worst thing they could ever imagine, i.e., losing their homes and everything they treasured, I'm sitting with this blank page trying to think of something to say that will bring comfort and hope. Friends and neighbors are doing everything they can to help each other and food, no matter what some peo-ple say, is always a big comfort. Why do they call macaroni and cheese comfort food? Because it is.

A couple of days ago, my dear next-door neighbors, Sarah and Jay, asked me if I could use some zucchini as a friend of theirs had given them seven homegrown beauties. Having grown zucchini, I discovered that it's delicious when it's small and tender but if you turn your back on those cute little ones, they somehow grow into the size of baseball bats and you can grate all day to make zucchini bread and never use up one of them. So, I grated two of these more than medium size dark green babies and made zucchini bread. If someone you know needs comfort they can just slice and eat, this will do the trick.

ZUCCHINI BREAD

Preheat oven to 350 degrees. Grease 8" x 4" loaf pan

1-1/2 cups all purpose flour 1 tsp. ground cinnamon (generous)

14 tsp. ground nutmeg (generous)
1/2 tsp. baking soda
1/4 tsp. baking powder

¼ tsp. salt Combine all those in a large bowl

1 cup sugar

1 cup grated zucchini

¼ cup vegetable oil

- A Mudflow and debris flow mitigation plan is being worked on by The Public Works Department.
 - o Please keep wind driven debris off the parkway and street as crews will begin deploying K rails in strategic locations.
- Please maintain the practice of disposing of spoiled food like you would in your bear-resistant trash can.
 - Place the spoiled food in a trash bag and not include food containers.
- Athens has provided the City with additional bins for spoiled food disposal at Sierra Vista Park.
- These bins are only for spoiled food
- o Please do not add your regular waste or trash to the bins located at Sierra Vista Park.

1 tsp. or more grated lemon peel ½ cup pecans (optional) dried cranberries are good and a little chopped apple is also a delicious, comforting

Combine all that in a medium bowl. Mix well then add to the dry ingredients.

Spoon batter into greased pan. Bake 55-60 minutes or until a wooden toothpick inserted near the center comes out clean. Cool in the pan on a wire rack for 10 minutes or so. Remove the loaf from the pan and cut yourself a slice. You can spread a little butter on it, pour yourself a cup of coffee and thank God for comfort

This recipe can be doubled as many times as you like. The two zucchini I used ended up being four loaves of bread. You can make lots of little loaves, too, and give them to those around you who could use a little comfort. The picture is the four loaves of zucchini bread.

I got this recipe from the Pasadena Star News in 2011 from Dorothy Reinhold's column, which is no longer there. In it, she described her son's ecstasy about the zucchini bread that his 3rd grade teacher, Mr.s Corinne Le, had baked and brought to share. "It's soooo good," he said, "and she gave me the recipe!" Corinne Le knew how to bring comfort to 3rd graders and I hope this will bring you some, too.

We don't even know how strong we are until we are forced to bring that hidden strength forward. In times of tragedy, of war, of necessity, people do amazing things. The human capacity for survival and renewal is awesome." Isabel Allende



- PUBLIC WORKS LEAF BLOWER & POWER UPDATES
- LA County has issued a temporary ban on the use of ALL leaf blowers to mitigate health risks associated with fire ash, smoke, and particulate matter.
- The Leaf Blower Ban will remain in effect until the County Health Officer determines that recovery conditions no longer pose a health risk.
- More sections of the City have restored power.
- Residents still experiencing outages are encouraged to call Southern California Edison (SCE) at 211 and to contact the City for additional support.

Public Health Department Declares Local Health Emergency

Pasadena Public Health (PPHD) Department Acting Health Officer, Dr. Parveen Kaur, declared Wednesday a local public health emergency due to the widespread impacts of Eaton Fire, including the presence of ash and particulate matter in the air throughout the community.

Ash and debris pose a significant potential current and future risk to health, safety, and the environment. PPHD is declaring a local health emergency to ensure residents take appropriate measures to protect themselves from toxic ash and debris, as well as proactively positioning the city to access County, State, and Federal resources and programs that will be critical to the rebuilding process.

PPHD is distributing free personal protective equipment (PPE) those impacted by the Eaton Fire at 450 N. Lake Ave., in conjunction with Pasadena Water and Power bottled Department's water distribution site, that started Wednesday and will be available from 10 a.m. to 3 p.m.

The use of power air blowers, including leaf blowers, is prohibited until further notice to help protect the health and wellbeing of residents. These devices stir up ash and particulate matter into the air, further worsening air quality and increasing health risks for everyone and their pets, particularly for those with respiratory conditions, older adults, and children, vulnerable populations.

Red Cross Offers **Financial Assistance**

The American Red Cross said it is committed to providing individuals affected by the devastating wildfires with safe shelter, access to food, basic health services, and emotional support. In addition to assisting those currently in our shelters, they will also begin providing financial assistance to residents who lived within the fire perimeters of Eaton, Palisades, Hurst, and Kenneth, as defined by Cal OES.

These current active perimeters can be found (in orange) on Tab 4 the Red Cross 2025 California Wildfire Disaster Partner Brief.

Curently they have actively begin outreach to specific individuals whose primary residences were located within these defined areas. These individuals are eligible for this initial Red Cross Financial Assistance program. For those they have contact information for, they will send an invitation to enroll via email, text message, or phone call directly from the American Red Cross. A COALITION OF ADVOCATES TODAY URGED LOS ANGELES COUNTY ELECTED OFFICIALS FOR A JUST RECOVERY FOR VICTIMS OF THE **EATON FIRE**

Residents and advocates gathered at the First African Methodist Episcopal Church, one of the oldest Black congregations of this denomination in Pasadena, to join a rallying cry for equitable restoration. The Eaton Fire, which started Jan.7, has so far resulted in the deaths of 17 people and stood at 65% containment with more than 14,000 acres burned as of Jan. 17th.

During the news conference organized by LA Voice, a multi-racial and multi-faith organization, Pastor Kerwin Manning of Pasadena Church said this is about their community, ``our flock," getting everything they need for restoration.

'At the beginning of this year, Jan. 1, the whole world's eyes were on us. They were watching the beauty of the Rose Parade and the floats, and then they turned their attention to the Rose Bowl game," Manning said. ``One week later, they were watching the devastation. They were watching the destruction -- what the best way we can describe it is as a war zone," he added.

Friday's call to action is a message that Altadena and Pasadena what several speakers affectionately referred to as ``Dena" -- will stand together for all impacted people, including those who are most vulnerable. The group outlined four critical pillars for a just recovery of their community:

-- Ensuring everyone gets help with in-person, in-language support while navigating FEMA, insurance, unemployment resources and other services. Non-federal programs must be accessible to all impacted residents regardless of status.

- Protecting the sanctity of home and community for renters with a countywide rent freeze and eviction moratorium to combat rent gouging; for homeowners by establishing rebuilding policies, and for small businesses and community centers by providing displacement-prevention measures and financial assistance in particular for those in the fire zones;

-- Economic relief such as cash assistance for residents' whose livelihoods or wages have been impacted by the fires regardless of status, and that rebuilding efforts include labor protections, job opportunities, as well as improvement of the conditions for incarcerated firefighters; and

-- Ensuring environmental resilience by incorporating sustainable infrastructure and traditional ecological practices during and after the rebuilding.

Rev. Larry Campbell, a pastor of First AME of Pasadena, noted that 54 congregation members lost their homes due to the fire. They've also experienced the overwhelming task of navigating FEMA, insurance companies and what he described as ``wolves in sheep's clothing" ready to take advantage of victims under duress.

Fay Austin, 88, said she has lived in Altadena since 1977. She had to evacuate at 3 a.m. alongside neighbors. They drove around for two hours before finding refuge at the Pasadena Convention Center with the American Red Cross. Austin expressed her worries about finding temporary housing as prices have shot up. But she is not deterred, as she, like so many others, begins the journey toward

Rosa Salas, a member of the Coalition for Humane Immigrant Rights and teacher at St. Mark's, which burned down, shared her story as well. ``We grew up in Dena, the home my father chose 53 years ago when he arrived from Mexico to build a better future for our family," Salas said.

Over time, this hard work and determination... plant(ed) the seeds of generational wealth through homeownership.'

'A proud Latino-Dena heritage, and people ask me, `Where does that lasting legacy come from?' The answer is clear: African American trailblazers broke those systemic barriers like red lining." In the 1960s, Black people moved into Altadena, leading to a flourishing Middle Class by the 1970s as a result of the 1968 Fair Housing Act, prohibiting racial discrimination in housing.

According to Census data, by the 1980s the Black population was at its highest at 43%. In 2020, data showed the population of Black residents was at 18% of about 42,000 residents.

Donald Kincey and his family have lived in Altadena for four generations. He recalled the night of the fire. ``I went home thinking that I was okay, looked at the mountain, and I knew I wasn't okay," Kincey said. His family was elsewhere -- something he was thankful for as his parents are in their 70s. His father is also compromised from the coronavirus, Kincey noted.

'I stayed in the neighborhood and violated the (evacuation) order. I know that people on my street were elderly. I wanted to be there for anybody. I kept my house wet until the water ran out and I sat there and watched everything burn." Kincey cried as he said his home, sister's home, mother's home and his business were lost. "I want to make sure that we fight, we stay, we don't sell out, no matter what," he added.

L.A. County Supervisor Board Chair Kathryn Barger, who represents Altadena, published a letter Thursday in which she made a commitment to her constituents. ``There is fear among many in the African American community, who have had their homes for generations, that they will not be able to rebuild," she wrote. ``For some, these homes are more than structures. They are legacies passed down through decades -- a symbol of perseverance and family heritage. We cannot allow this wildfire to extinguish that legacy.

County, state and federal officials are also stepping in to protect fire victims from price gouging. They've implemented a crackdown on scammers and urge residents to be wary of potential offers.


Areli Hernandez, director of executive affairs for CHIRLA, encouraged undocumented immi-

grants or those who may not qualify for federal assistance to seek help through the organization's iRelief Fund, among other initiatives on their website. She urged them to seek available resources from the state such as CalFresh, too.

She provided one last bit of advice that could apply to everyone impacted fires: ``If there's somebody who comes to you with an offer, whatever it's for -- housing, your home, your property -- just

``If it's too good to be true, always check back with somebody in the community, like an organization, to verify if what they're saying is accurate. Reach out for help," Hernandez said.

ASSEMBLYMEMBER JOHN HARABEDIAN AND SPEAKER **ROBERT RIVAS ANNOUNCE ACTIONS TO FAST-TRACK FIRE** RECOVERY, KEEP DISPLACED **CALIFORNIANS HOUSED**

(PASADENA, CA) — Today, Assemblymember John Harabedian (D - Pasadena), Speaker Robert Rivas (D-Salinas), and members of the California State Assembly gathered together at incident command at the Rose Bowl to announce legislation to fast-track recovery, keep fire victims housed, and allocate billions to help Los Angeles County recover.

"I grew up in Sierra Madre and have always been proud of our community's strength, diversity, and unity. This past week has tested us like never before, as many have lost homes, jobs, and places of worship," said Assemblymember John Harabedian (D-Pasadena). "Recovery won't be easy, but by supporting one another, I know we can rebuild and I'll be with you every step of the way. I look forward to working with Governor Newsom, Speaker Rivas, and Pro Tem McGuire to provide swift relief to our community."

"We are moving right now to keep Californians housed as recovery begins, speed up recovery, and approve billions of dollars in funding to kickstart toxic debris removal and rebuild and repair schools. Families must be able to send their children back to school immediately," said Speaker Rivas (D-Salinas). "Let me be very clear," said Rivas, "We must reshape our state government so that we are better able to prevent disasters like this from happening again. All options must be on the table. We'll have more to say on that real soon. Right now we want those affected by the fires to know that imme-



diate help is on the way so you can begin to recover."

The announcement comes after Speaker Rivas met with L.A. Assemblymembers and local officials, and visited the Altadena, Malibu and Palisades communities.

Assemblymember Harabedian introduced the following bills Monday to help provide essential relief to wildfire victims:

AB 238, Mortgage Deferment Act: Under the Mortgage Deferment Act, borrowers are entitled to request an initial forbearance of their monthly mortgage payments for up to 180 days, and may request up to an additional 180 days. This bill is inspired by the CARES Act, which provided

mortgage payment forbearance to those experiencing financial hardship during the COVID-19 national emergency.

AB 239, State-Led Disaster Housing Task Force: establishes the State-Led Disaster Housing Task Force (SLDHTF) to operate throughout the long-term recovery period following the recent wildfires. Its primary purpose is to assist with coordination between the federal government, state agencies and departments, and local municipalities. The bill is modeled after FEMA guidance that each state establish a ŠLDHTF.

The Assembly delegation also announced legislation today to help fire victims which would stop additional cumbersome building standards, accelerate state permit review for reconstruction, expedite con-

struction of Accessory Dwelling Units in the Coastal Zone, keep displaced Californians housed, and prohibit evictions if a tenant shelters wildfire victims or their pet.

These bills will be heard in Assembly policy committees during the spring.

Assemblymember John Harabedian represents the 41st District composed of the cities of La Cañada Flintridge, Pasadena, Altadena, Sierra Madre, Monrovia, Bradbury, San Dimas, La Verne, Claremont, Upland, Rancho Cucamonga, Oak Hills, Piñon Hills and Phelan.



Official government accounts generally post professional, relevant, and timely information.

Look for official announcements or references to other credible sources, such as links to government websites or trusted news outlets.

Be wary of accounts with low follower counts or sudden, rapid growth.

Government accounts will never ask for sensitive personal information via social media.

NEW `RAPID-RESPONSE' EFFORT TARGETS WILDFIRE-RELATED INSURANCE FRAUD

LOS ANGELES (CNS) - A new ``rapid response" effort to prevent and prosecute insurance fraud targeting wildfire survivors is now operational, it was announced today.

The partnership described by Insurance Commissioner Ricardo Lara and L.A. County District Attorney Nathan Hochman focuses on raising awareness, prosecuting fraud and equipping survivors with tools to navigate recovery safely.

``Scammers exploit vulnerable times, preying on survivors with false promises and fraudulent schemes," Lara said in a statement.

`We've seen this in past wildfires. By partnering with the Los Angeles County District Attorney's Office, we*re amplifying protections for wildfire victims and empowering consumers to protect themselves. My department is committed to guiding you with resources to make informed decisions and avoid scams."

As survivors begin recovery, Lara said, the insurance department's Disaster Assistance Response Team has been deployed to wildfire-affected areas to protect survivors from scams and fraud. In coordination with the contractors state license board and other agencies, DART helps educate residents about their rights, checks contractor and vendor licenses, and ensures compliance with state regulations.

The D.A.'s fraud and corruption prosecutors, meanwhile, are working with county and state agencies to hold individuals and businesses accountable for fraud, including insurance, public benefits, and charitable donation scams. Penalties for fraud can include fines and jail or prison time, Hochman said.

'Our office's fraud-fighting prosecutors have a message for scammers: You will not get away with impersonating insurance companies in order to steal from wildfire victims in Los Angeles County," Hochman said Friday. ``Our office is on high alert for insurance scams and we will relentlessly pursue and seek the maximum punishment for the criminals who seek to exploit the victims of the LA County fires. ... Insurance fraud will not be tolerated under any circumstances.'

In previous wildfires, the insurance department arrested criminals engaged in fraud, including one case where a person falsely posed as legal counsel, filed fraudulent smoke and ash claims, and pocketed settlement checks,

To address common scams like public adjuster fraud, the insurance commissioner issued a notice reminding public adjusters to adhere to strict laws governing their conduct. Lara urged survivors to carefully review adjuster contracts, understand fees -- typically a percentage of the insurance claim -- and verify the adjuster's license on the department's website.

As part of the educational effort, Lara is hosting free two-day insurance support workshops on Saturday and Sunday in Santa Monica and Jan. 25 and 26 in Pasadena to help survivors understand their insurance policies and the claims process, while also providing information about available resources for rebuilding and recovery. The workshops are open to all those impacted by the recent wildfires.

Call 800-927-4357 to schedule a one-on-one appointment with a Department of Insurance expert.

The department has resources for disaster survivors and strongly encourages consumers to check out the help, including how to avoid scams after a disaster. There is often unscrupulous individuals who try and take advantage of disaster survivors who can be vulnerable during a challenging time, Lara said.

Consumers who have questions on their insurance or wish to file a complaint against a public adjuster can do so on the department's website or by calling 800-927-4357.

The insurance department urges consumers to check the public adjuster's license and make sure they are properly licensed and in good standing by visiting the department's website or by calling the 800 number.

Also, Lara said, homeowners should be sure to check the contractor's license with the contractors' state license



PASADENA UNIFIED FIRST PHASE REOPENING

Dear PUSD Community,

I am pleased to share a milestone in our community's recovery from the Eaton fire: we are announcing the first group of schools that will reopen to bring students, staff, and families back together.

PUSD is reopening schools in phases, with a goal of returning all students to in person learning by the end of January. Each campus will open after rigorous cleaning and sanitizing and environmental tests to ensure campuses are safe and ready to welcome students back. Students are currently in self-directed learning.

Ten schools and programs will open on January 23:

Phase 1 - 10 schools and programs

Hamilton Elementary

Willard Elementary & *Children's Center

Blair Middle and High School

San Rafael Elementary

McKinley School

*Rose City High School

*Center for Independent Study

*Pasadena Adult Living Skills

*Twilight Adult School

*Aveson Global Leadership Academy

*located on the Wilson campus

Approximately. $3,400\,\mathrm{TK}$ - $12\,\mathrm{students}$ (and additional children's center and Twilight Adult students) will return to school

School principals will send detailed information about the reopening to their school communities.

To accelerate reopening, campuses located further from the fire's impact will reopen first, allowing the community to begin its path toward healing. A team of more than 1,500 PUSD Maintenance and Operations workers and contractors are conducting extensive cleaning and sanitizing, including air filtration devices, vents, and surfaces. Each site will be reopened only after environmental testing. The cleaning process is detailed and takes time, a factor for larger campuses. For example, it took five days for large teams to complete cleaning at Blair Middle and High School. To date, 38 tons of outdoor debris have been removed from campuses.

Before welcoming students back to school, our resilient staff will attend an All-Staff Reopening event Jan. 22 to help address the aftermath of these devastating fires. Details will be sent to staff by separate email.

The Eaton Fire significantly impacted the District, with severe damage at five campuses: Eliot Arts Magnet Middle School, Franklin Elementary (closed in 2020), and three charter schools—Edison (Odyssey), Loma Alta (Rosebud Academy and Oak Knoll Montessori) and Noyes (Aveson School of Leaders). More than 10,000 of PUSD's 14,000 students were evacuated from their homes.

Learning Options and Resources

Self-Directed Learning Options for students until they return to school at gopusd.com/learning. This takes into account students who may have been displaced from their homes and may not have access to their district-issued devices.

Resources continue to be available for students with replacement devices, Grab and Go meals, housing assistance, childcare services through community partners, and other critical supports. Information can be found on the District's Fire Relief website.

Community partners have played a key role in PUSD's recovery efforts. We are profoundly grateful for the outpouring of support and solidarity from all corners of our community. We are grateful for the contributions made to our students through the Pasadena Educational Foundation's pased.org/responsefund.

Your strength and compassion are the bedrock of our recovery efforts. Together, we will navigate these challenging times, rebuild our schools, and ensure a brighter future for the Pasadena Unified family.

Coming Together After the Eaton Fire

Today also marked a significant moment in our recovery from the Eaton Fire as hundreds of our school community members gathered at Pasadena City College. It was deeply moving to see so many familiar faces, to witness the hugs, tears, and moments of connection that remind us of the strength we find in each other.

Many of you shared your stories of evacuation, loss, and resilience. We watched as community members wrote heartfelt messages to our staff members who lost their homes. Students engaged in art therapy activities while parents connected with our enrollment team and gathered essential supplies from our resource booths. These moments of support and healing are exactly what our community needs right now.

To our students who lost homes, who were evacuated, who are still displaced – we are here for you. To our staff members directly impacted by the fire – your PUSD family stands with you. And to our entire community – thank you for showing up today, for supporting one another, and for demonstrating what makes our school district truly special.

We will continue to keep you updated as we move forward together.





THE BEGINNING OF THE END

A personal account of the Great Fire of 2025

On January 7, 2025, a Tuesday, I was in Highland Park to operate the weekly farmer's market, as I have done for years. It was windy, but tolerable, and I hoped that the winds would die down so the canopies that the farmers used would not be blown away. Apparently, winds were heavy in other areas, and about a third of our vendors did not

The modified market proceeded, and the wind seemed to gradually increase. Yes, there had been predictions of high winds in the news, and I assumed, as I usually do, that those highest winds would be high in the mountains and deep in the canyons, such as the Interstate 5 corridor.

By 4 p.m., steady winds made the market challenging to operate. By 6 p.m., my wife called me, telling me to try to get home as quickly as possible. "The winds are horrendous," she told me, and she could see smoke and the red glare of fire to our home's east and north. Our home is right on the Altadena-Pasadena border, just a few short blocks from Eaton Canyon, where apparently the high winds knocked down a power line and started a fire.

"The fire doesn't look good," she added, "and we have no power. Try to get home quickly. You might not be able to get back because they are telling people to evacuate." I could tell that this was serious, more serious than I had imagined. Meanwhile, I had to stay at least another hour to close down the market, as winds increased and closing up the farmers' canopies became very difficult.

I finally drove back amidst increasing winds, with branches and tree limbs blocking some roads. I drove up Lake Avenue and realized we were in a serious emergency status. As I freely drove north into Altadena, there was a line of car headlights heading south, as the exodus was continuing. Some street lights were out, and people were driving more recklessly. I could feel a sense of panic developing.

I managed to get into my neighborhood without any barricades, a darkened neighborhood where most neighbors were clearly already gone. This was about 8 p.m. High winds buffeted everything, and I as parked, I could see the orange sky to our east and north, as black smoke billowed into the sky. I didn't know that then, but I was seeing the burning of the Jewish synagogue on Altadena Drive and the Palm Villa rest home occupied by senior citizens. It had already been evacuated by the time I got home.

My wife and I quickly put a few key items into our cars, such as clothes, toiletries, some photos, and computer. While my wife continued to collect a few necessities, I watered the outside. Sparks flew down from time to time in the high winds, which made me realize that we might never return to our small and humble home. But it wasn't the time to think about things – we were operating on automatic pilot.

We finally drove off, not sure where we were going, but we headed down to Colorado Blvd. in Pasadena, home of the annual Rose Parade, to the hotel row area. The first hotel we saw had a long line of cars trying to get in, and a crowd in the lobby so we drove on. My wife found a smaller place down the road which had one room left, which we booked for the night.

We spent a fitful night, and I did my best to relax and sleep, though it was hard. We talked through what steps we'd take if everything we had got burned to the ground.

During the days that followed, we did hear from many of our friends who lost everything. My childhood friend Joe Sierra told me how he looked out and saw his neighbor's house burning across the street from his Marengo home. He knew there were high winds, but had no idea the firestorm would get right next to his home. He grabbed his cat and jumped in his truck and took off as the neighborhood burned down. "I wish I had grabbed at least a spare pair of pants," Joe told me.

In the morning, we were able to return to our home, still standing. We were on the fringe, and the still-raging fires were already well to the east and northwest of our neighborhood.

THE WILDFIRES IN EATON CANYON: SENIORS COPING WITH LOSS AND UNCERTAINTY



I'M NOT OLD JUST YOUNG CHALLENGED

Most people are fascinated by their age as if it makes any difference in their lives. Some people are very intimidated by getting older and struggle against it.

When I was young, I couldn't wait to get older. I couldn't wait until I was old enough to get a driver's license. Why does it take so long to get old when you're young, and when you're old, it flies by like a bullet?

Sometimes, I get a call from a scammer who asks me how old I am. I respond, "I'm not sure how old I am because every year my age changes." Then I hear the infamous

I have several relatives who will never accept how old they are. They are frozen at 20 and try living as though they were 20 years old. It never works out, but I won't be the one to tell them. Why try to act like you're younger than you are when you could just be yourself?

STUART TOLCHIN PUT THE LIGHTS ON INADEQUACY OF WORDS



Right now, I am thinking about the word "wind." This is not surprising since it was the raging winds last week that my wife and I first noticed as we learned about the fire that was racing up-above us in Altadena. We were forced to evacuate our home for a week. Now we are back in our home, vigilant about potentially high winds affecting the continuing nearby fires which would require us to evacuate again. Of course, that's not the worst thing that could happen. Homes of

that's not the worst thing that could happen. Homes of our friends, including the home where my wife and I were married, Foxes one of our favorite restaurants, and golf course where my son worked are all no more!

Of course, my words do not really describe the feelings of loss behind the words. They are just labels which frequently obscure more than they reveal. I first thought of this feature of words when my wife and I were prevented from returning home by National Guardsmen standing in their combat uniforms next to their tanks preventing us from returning. Finally, the next day after we returned my wife walked around the area and told me that she saw a firetruck from Tahoe at the top of our hill in front of an empty house. She asked the firefighters why they were gathered there and was told that they had been directed to stand in front of all fire stations.

It is true that the house has an old sign in front that says "Fire Station" but this is a remnant of long ago. Many years ago, this house operated as a volunteer fire station but since then the city built its own fire Station on Sierra Madre Boulevard in the middle of town. (The whole town has only ten thousand people). The old sign is still in front of the place now converted into a house and the words misled the firecrew.

When my wife told me of her encounter, I was immediately reminded of a chapter I had just read in the book, "THE THINGS THEY CARRIED" by Tim O'Brien which is one hell of a book. It is described as a book of literary imagination that combines fiction with non-fiction. The incident I recalled was the story of Mary Anne Belle, described initially as a typical seventeen-year-old attractive girl who had managed to wrangle her way to Viet Nam to join her soldier boyfriend whom she planned to marry. She looked like a cheerleader, perky, and fresh-faced. Already she and her boyfriend had talked of getting married when he was able to return. A house had already been selected in respectable Cleveland Heights where it was assumed they would soon live together. In a remarkably brief time Mary Anne's values and expectations completely changed.

Soon she stopped wearing jewelry and hygiene became a matter of small concern. In not too long a time she disappeared and was gone for different periods of time. Before disappearing, she began the questioning of her values and plans after being exposed to the different world of War in Viet Nam. Eventually she reappeared and "at the girl's throat was a necklace of human tongues. In her own words she explained that now "I feel close to my own body-----because I know exactly who I am." This language resonates with me.

Perhaps facing the destruction of my own home and everything else I value has made me aware of how little I know of myself or of anything else. The necklace of human tongues wordlessly speaks of the distrust of language and accepted values. Going back to the word 'wind" I think of the word "windbag" described by Wikipedia as a person who talks a lot without saying anything interesting or important. As my experiences of the last week have demonstrated the "wind" is something interesting and important the meaning of which is obscured by the word. A moment ago, I received an emergency call from Kaiser directing me to come to the facility for an "ultrasound". I have little understanding of the procedure, but I am now faced with a lot I don't know, and the words don't help.

Let it be that it is only the "wind" that soon must die down. (I don't want to be morbid, but I am over 80 and a bit scared or scarred. Despite the inadequacy of my "words" you might understand what I am feeling even though I, myself, am unsure and don't like to talk about it) WORDS DON'T HELP.

Now it is the next morning and I wish I could say I feel guilty that our house is still standing while so many others have lost everything but the truth is while I feel sad about all the loss I am immensely grateful that my house is still standing and at least I am well enough to still play golf even if I have to find a new course.



Fox News reported early-on that the truck used in the attack was seen coming across our Southern border, but corrected itself an hour later - this sighting was weeks before the truck was rented by the perpetrator and with a different driver. But at the end of the day, long after retractions had been made and facts became more clear, Trump posted to his Truth Social platform: "TRUMP WAS RIGHT ABOUT EVERYTHING!" This is a post from someone about to become President of the United States. Let that sink in.

At his Mar-a-Lago press conference earlier this month, Trump claimed that among rioters at the January 6 insurrection, "there wasn't one gun that they found." At least eight individuals have been prosecuted for illegal possession of firearms at the Capitol on that day. Regarding trade with Europe, he complained "they don't take our cars". The EU is our second-largest market for vehicle exports. As for aid to Ukraine, "Europe is in for a tiny fraction of the money that we're in." Through October 2024, Europe has committed twice as much (\$250 billion) as we have (\$123 billion).

As the catastrophe of our Palisades and Eaton fires was unfolding, Trump posted about "Governor Gavin Newscum". Again, let that sink in - this was not coming from some bratty, name-calling third-grader but from one who in a few days will be inaugurated as our 47th president.

Trump complained Gov. Newsom "refused to sign the water restoration declaration put before him that would have allowed millions of gallons of water. . to flow daily into many parts of California, including the areas that are currently burning". There wasn't any "water restoration declaration". Trump just made that up. Whatever it was he was referring to, it didn't involve water flowing to "areas that are currently burning", but mainly to Central Valley farmers.

He continued, "no water for fire hydrants, not firefighting planes." According to our Department of Water Resources, most reservoirs were "at or above" average levels the day before the fires broke out. Fire hydrants were intended to take care of an occasional house fire, not infernos engulfing entire communities. Aircraft were grounded because of high winds.

Trump claimed there's "no money in FEMA". The agency has nearly \$30 billion in its Disaster Relief Fund and has agreed to reimburse California for its firefighting costs.

There's nothing illegal about a politician lying, exaggerating or simply making stuff up – but there's no First Amendment protection when it's done "in furtherance of a crime". In his report released last week on Trump's efforts to overturn an election, Special Counsel Jack Smith made clear, "The throughline of all of Mr. Trump's criminal efforts was deceit -- knowingly false claims of election fraud -- and the evidence shows that Mr. Trump used these lies as a weapon to defeat a federal government function foundational to the United States' democratic process".

The Washington Post logged over thirty thousand falsehoods during Trump's first term in office. The lying has continued since, and will over the next four years. To paraphrase the great songwriter Burton Lane, "How can we believe him when he says whatever, when we know he's been a liar all his life?"



What Needs to Happen Before You Can Return to Your Property?

Los Angeles County, along with local, state, and federal partners, is working tirelessly to ensure areas affected by the Eaton Fire are safe for residents to return. Here's what must happen before your community is ready for repopulation:

Fire hot spots must be fully extinguished.

Urban Search and Rescue operations need to be completed.

Roads must be cleared of hazards, such as downed power lines, fallen trees, and broken glass.

Streets and road infrastructure must be repaired and deemed safe for travel.

Utilities, including water, electricity, gas, and sewer systems, must be inspected to ensure they are safe.

Homes and other structures must be evaluated for fire damage, structural weaknesses, and potential for collapse.

□ A Red-Tagged building means it is unsafe and cannot be entered.

□ A Yellow-Tagged building means some areas may be safe but only for limited use or specific purposes.

POST-FIRE FITNESS

When wildfires sweep through an area, they leave behind more than charred landscapes and heartbreaking loss. The air itself becomes a hidden danger, carrying microscopic particles and chemicals that can harm your health, especially if you're someone who loves outdoor exercise. Understanding how to stay active while protecting your lungs is key to maintaining your fitness and health in the weeks and months following a fire.

Air pollution from wildfires doesn't just smell bad—it can cause real harm. Wildfire smoke contains tiny particles called PM2.5, which are about 30 times smaller than a human hair. These particles can penetrate deep into your lungs and even enter your bloodstream. Breathing them in during exercise, when you're taking deeper and faster breaths, increases your exposure.

Short-term exposure to poor air quality can irritate your eyes, throat, and lungs, but long-term exposure can lead to more serious conditions like asthma, heart disease, or reduced lung function. For outdoor exercisers, this poses a tough question: How

Check out the air quality first. The Air Quality Index, or AQI, is a tool you can use to decide whether it's safe to exercise outside. The AQI measures five major air pollutants, but wildfire smoke makes PM2.5 the primary concern. Here's a quick guide to AQI levels and their impact on outdoor exercise:

0–50 (Good): Air quality is safe, and you can exercise without restrictions.

- 51–100 (Moderate): Air quality is acceptable for most, but sensitive groups should be cautious. 101-150 (Unhealthy for Sensitive Groups): People with respiratory conditions should limit outdoor activities.
- 151–200 (Unhealthy): Everyone should avoid prolonged outdoor exertion.

201+ (Very Unhealthy to Hazardous): Stay indoors and limit physical activity.

Apps like AirNow and websites from local environmental agencies provide real-time AQI updates for your area. Make checking AQI a part of your routine because the air quality will likely remain unhealthy for weeks after the fires.

Note that smoke and ash travel far. Even if the fire is hundreds of miles away, wind can carry smoke into your area. Check the AQI even if you don't see or smell smoke. Wildfire particles are even worse than urban smog. PM2.5 from wildfires often contains toxic chemicals from burning homes, vehicles, and other materials. These are more harmful than typical urban air pollution.

How hard you plan on exercising matters too. High-intensity workouts increase the amount of air you breathe by 10 to 20 times compared to rest, which means you're inhaling more pollutants if the air quality is poor.

If you're determined to exercise outdoors, make it as safe as possible.

First, adjust the time of day you're going to be outside. Air quality tends to improve during midday when the sun disperses pollutants. Avoid exercising in the early morning or late evening when smoke often settles closer to the ground.

Second, aim for the best location. Parks with dense tree cover or areas near water may have slightly better air quality than open spaces. However, avoid recently burned areas where ash and debris can be stirred up by wind or foot traffic.

Third, switch from high-intensity activities like running to lower-impact exercises such as walking or yoga. This reduces your breathing rate and minimizes exposure to pollutants.

Other things can help too. Like staying hydrated. By drinking plenty of water you help your body flush out toxins. Include antioxidant-rich foods like berries, spinach, and nuts in your post-workout meals to support lung health. If you can handle wearing a mask, a N95 or P100 mask can filter out most of those PM2.5 particles. You can always switch to indoor workouts for the time being too. Having cleaner air to breathe will make your workout more enjoyable and productive.

If you spend a lot of time exercising outdoors, you'll know fairly quickly whether it feels safe to be outside. The difference between fresh, clean air and polluted air is noticeable within minutes. Breathing in those tiny particles, especially during intense physical activity, can quickly make you feel off or even sick. Symptoms like coughing, shortness of breath, a scratchy throat, metallic taste in the mouth or dizziness can appear rapidly. Remember, you're exercising for your health. Pushing yourself in dangerously poor air quality not only hinders your progress but also risks long-term damage to your lungs and overall well-being. Instead, experiment with alternatives. Consider indoor workouts, low-impact exercises, or even try something new to stay active while giving your body a break from harmful air pollutants. Above all else, keep monitoring the air quality in your area until it's safe to return to your outdoor routine.

In challenging times like these, self-care is not a luxury—it's a necessity. This is true for all of us. Seeing the vast destruction of our community is impactful for each of us. Navigating a loss on such a grand scale is difficult. One powerful tool for calming anxious minds and fostering emotional well-being is the Emotional Freedom Technique (EFT). This method isn't just for adults; it's simple

enough to share with children, helping the whole family navigate stress together.

What Is EFT?

EFT, or Emotional Freedom Technique, is a scientifically backed practice combining tapping specific acupressure points with an intentional focus on emotional challenges. Often described as "emotional acupressure," EFT has been shown to help individuals recover from stress, anxiety, and trauma, including veterans and victims of crime or other life-altering events.

Gently tapping on designated points stimulates your body's energy meridians, releasing emotional blockages and promoting relaxation. It's a technique grounded in science that reduces cortisol (the stress hormone), alters brain wave activity, and encourages emotional balance.

How to Perform EFT

- Here's a simple guide to practicing EFT for emotional relief:

 1. Identify the Issue: Clearly define the emotion or issue you're experiencing fear, sadness, anger, or survivor's guilt.
- Rate the Intensity: On a scale from 0 to 10, rate the intensity of the emotion, with 10 being the most severe.
- Setup Phrase: Tap the side of your hand (the "karate chop" point) while saying, "Even though I feel [emotion], I deeply and completely accept myself."
- Tap the Points: While repeating affirmations like "I release and let this go" or "I love and accept myself," gently tap on the following points:

 • Top of Head: Center of the scalp.

 - Eyebrow: Inner edge, near the bridge of the nose.
 - Side of Eye: Outer edge of the eye socket.
 - Under Eye: Just below the eye.
 - Under Nose: Between the upper lip and nose.
 - Chin: Center of the chin, just below the lower lip.
 - Collarbone: Just above the collarbone.
 - Wrist: Grab the wrist of the tapping hand with the opposite hand and gently release the wrist.

Repeat the process, reassessing the intensity of the emotion after each round. Many people notice a significant reduction in emotional intensity within just a few minutes.

Benefits of EFT

- Reduce Stress and Anxiety: EFT promotes relaxation and helps release pent-up tension.
- Enhance Mood and Well-being: Addressing emotional blockages fosters a sense of calm and happiness.
- Build Self-Confidence: EFT challenges negative self-beliefs, empowering you to embrace your strengths.
- Strengthen Relationships: Managing emotional reactivity improves communication and connection with loved ones.

Sharing EFT With Your Children

Children, like adults, experience emotional ups and downs. By teaching them EFT, you provide them with a lifelong tool for managing stress and building resilience. Engage them in the process by explaining it as "magic tapping" that helps emotions feel better. Keep the language simple and the tone lighthearted, making it a fun and comforting activity.


