SIERRA MADRE 2025 CERT GRADUATES

The Sierra Madre Community Emergency Response Team (CERT) graduated 13 new members last Saturday. The week-long training is a 24-hour FEMA-certified course on disaster preparedness designed to ensure residents have the basic skills to act safely while assisting themselves, their families, and neighbors during a major disaster. CERT members may also volunteer to assist the fire department when resources are stretched

Over 40 people were involved in the final day's exercise, including more than a dozen students from Sierra Madre Middle School's Service Club who were "victims" which had moulage provide by Nichole Rinker to simulate real-world injuries.

The training was provided by former Sierra Madre volunteer firefighter captain and Mayor Pro Tem, Kris Lowe. Kris is Coordinator for Glendale's Public Safety Academy at Hoover High School, a program that provides college and career readiness in the Public Safety and Service sector.

The CERT graduates, after their final training exercise and a written test, were awarded FEMA certificates by Mayor Robert Parkhurst and CERT President Pat Alcorn. As part of their training, graduates receive a CERT backpack with their personal protection equipment.

CERT would like to thank the City of Sierra Madre and Bob Spears, Emergency Services Manager, for supporting CERT and allowing the use of the Emergency Operations Center for the training. Under the direction of Captain Chris Bertrand, firefighters from the Sierra Madre Fire Department provided expert training in cribbing and fire suppression.

Sierra Madre CERT is funded entirely by donations and grants. Backpacks and training supplies were provided by a "California for All" LIS-TOS grant. Additional costs were covered by a generous grant from the Sierra Madre Civic Club.

It is critical that residents get trained and learn to prepare themselves for initial hours and days after a major disaster. CERT plans on holding its next CERT Basic Training Class in 2026. More information can be found at www.sierramadreemergency.org or by emailing info@sierramadrecert.org.



NUMEROUS REASONS TO HONOR OUR VETERANS



Americans have served or are currently serving their country and more than 1.3 million gave the ultimate sacrifice.

According to the U.S. Census Bureau, there are approximately 15.8 million U.S. veterans living to-

day — about 6.1 percent of the adult population. Roughly half are age 65 or older and nearly 2 million are under 35.

Our older veterans served in World War II, Korea, and Vietnam. The younger veterans primarily served in Iraq and Afghanistan after the 9/11

World War II veterans are dying at a rapid pace. According to the U.S. Department of Veterans Affairs, fewer than 100,000 are still living, down

More than 43 mil- | from 16 million who served.

Of the 5.7 million Americans who served in the Korean War, approximately 767,000 are still alive. My father, who served during the Korean War, left us nearly three years ago at the age of 89.

As for Vietnam, around 5.6 million of the 8.7 million Americans who served in that war are still living.

To round out the numbers, more than 8.4 mil lion veterans have served during the Gulf War era, which spans from 1990 to the present. Additionally, approximately 4.4 million served during

Some living veterans served across multiple war periods. Nearly 63,000 served during the Vietnam War and both Gulf War eras — from August 1990 through August 2001 and again from September 2001 onward.

More impressively, nearly 37,000 living veterans served in World War II, the Korean War, and the Vietnam War.

have served — living or dead — Memorial Day is specifically for those who died in service.

It began after the Civil War as "Decoration Day," a time to decorate the graves of fallen soldiers. Today, it's a day of national mourning, and rightly so.

To date, more than 1.3 million Americans have died in military service. About 4,500 died during the American Revolution. In the Civil War, around 370,000 Union soldiers and an estimated 260,000 Confederate soldiers lost their lives.

We lost 116,516 in World War I and nearly 405,000 in World War II. The Korean War claimed 36,574 lives; the Vietnam War, 58,220.

Modern warfare has led to fewer battlefield deaths — a silver lining of improved medical care and technology.

Of the Americans who served in Iraq and Afghanistan, more than 7,000 died. Nearly 50,000 were wounded and many still suffering from their

Many Americans confuse Memorial Day with Veterans Day. While Veterans Day honors all who you the battlefield. Many struggle with PTSD, physical injuries, job placement and endless health challenges.

> In any event, each veteran who gave the ultimate sacrifice represents a life cut short — young men and women who never came home, never started a family, never got to see the freedoms they died to protect.

Their families carry that loss forever. Their sacrifice is not just national — it's heartbreakingly personal.

ANNOUNCES 2025 GRANT AWARDS TOTALING MORE THAN \$200,000

Sierra Madre Library Included With Recipients

PASADENA, Calif. (May 21, 2025) - The Pasadena Tournament of Roses® Foundation is proud to announce its 2025 grant awards, totaling more than \$200,000, to 21 organizations in the San Gabriel Valley. These grants will support new and ongoing programs benefiting children, teens, adults and seniors.

The Foundation's 2024 Golf Classic presented by J.P. Morgan Chase & Co. was a resounding success, raising more than \$100,000 in net proceeds. This year, we are proud to welcome five new organizations to receive grant support that have not previously been awarded a grant from the Tournament of Roses Foundation.

In 1983, the Foundation was created to receive and manage contributions from the Pasadena Tournament of Roses Association, its members, donors, friends of the Foundation, sponsors and public supporters. The Association and the Tournament of Roses Foundation are focused on positively impacting the Pasadena community through charitable giving, volunteerism and community involvement.

Since its inception, the Foundation has funded more than \$5 million in charitable contributions on behalf of the Tournament of Roses Association, to invest in people through sustainable programs. This year, one \$35,000 grant and one \$20,000 grant were awarded, in addition to 19 other community initiatives that received grants of up to \$10,000.

\$35,000 grant – The Sierra Madre Library inspires lifelong learning by providing access to information, programs and resources that enrich the community. The Sierra Madre Library will add a dedicated teen room for the first time as part of a major state-funded renova-

tion. This inclusive space will feature academic resources, games, furniture and technology to promote connection, support learning and serve the evolving needs of the community's youth.

\$20,000 grant - Founded in 1990, Partnership for Success (PFS) is a collaboration between Pasadena schools—Chandler, Mayfield Junior, Polytechnic, Westridge—and the Pasadena Unified School District (PUSD). This summer academic enrichment program helps close achievement gaps for economically disadvantaged PUSD students. Spanning nine consecutive summers, it begins after fourth grade and continues through the summer after high school graduation, serving about 400 students annually. By leveraging partner school resources and expertise, PFS delivers a high-quality educational experience at no cost, removing financial barriers to academic and personal growth.

The Foundation grants are divided into three categories: Education (Early Childhood Learning, STEAM/STEM, Literacy), Sports and Recreation, and Visual and Performing Arts. These broad categories allow the Foundation to contribute to our local communities' civic, cultural and educational advancement. SIERRA MADRE FIRE HAZARD SEVERITY ZONES UPDATE By Kevin McGuire

SM Fire Chief Brent Bartlett presented an updated report on the Fire Hazard Severity Zones (FHSZ) during the City Council meeting on Tuesday, May 13.

The City Council received and filed the report issued by CAL FIRE and directed city staff to assess local implications related to zoning, building codes, defensible space requirements, and public education. The community can expect public outreach regarding these updated hazard classifi-cations within the Local Responsibility Areas (LRAs) to prepare for the implementation of updat-ed maps.

The new maps will incorporate new climate science and wildfire modeling, according to the re-port. State laws require the city to adopt these updated maps. City staff aims to outline the next steps in response to the everchanging wildfire hazard landscape.

According to the report, under Public Resources Code §4202 and Government Code \$51178, CAL FIRE is mandated to classify lands within LRAs into three fire hazard zones: Moderate, High, and Very High. The 2025 update integrates advanced fire behavior modeling, which accounts for wind patterns, ember transport, and recent climate data (2003-2018).

Before the updated maps, Sierra Madre only listed the High severity zones. The maps don't show short-term wildfire risks such as Red Flag conditions; they only reflect longterm hazard conditions, according to Chief Bartlett. Local authorities are allowed to increase, but never de-crease, the fire severity warnings.

This is the first time the maps for LRAs have changed since 2011. In addition to Red representing the Very High risk, Orange has been added for High, and Yellow for Moderate risk. As a result, some residents were removed from the Very High risk to either the High or Moderate zones.

Key considerations include:

• Model Enhancements: Incorporation of 50-year wildfire behavior projections using local wind and ember data.

• Zoning Impacts: Properties within High and Very High zones will be subject to Chapter 7A of the California Building Code (Wildland Urban Interface standards) and natural hazard disclosure requirements during real estate transactions.

• Public Tools: Residents can access zonespecific data using CAL FIRE's online FHSZ Map Viewer. • Urban Edge Dynamics: Proximity to wildland areas may rapidly alter zone boundaries, even between visually similar neighborhoods.

 Collaboration and Support: CAL FIRE will provide technical assistance to local agencies and is committed to hazard alignment without stifling development.

• Insurance Caveats: The hazard-based mapping system differs from the risk models used by in-surers, although similar data inputs may overlap.

Local implications may include updates to safety elements in the General Plan, revisions to de-velopment review processes, and expanded public outreach on defensible space and home hardening strategies. Subsequent Council meetings are scheduled to consider formal adoption of the maps. Dates are as follows:

• May 27, 2025 - Public Hearing: Fire Hazard Severity Zone Map Adoption (1st Reading) • June 10, 2025 - Consent: Fire Hazard Severity Zone Map Adoption (2nd Reading).

As part of the Strategic Plan Correlation, the Fire Department, in collaboration with the Public Works Department, has completed the annual brush-clearing events for 2025 to reduce wildfire risk and enhance community

The Fire Department also hosted a "Home Hardening" presentation to educate resi-

from wildfire damage. This initiative will continue on an annu-al basis. There will also be information listed on the city's social media sites, and town hall meet-


ings will be announced.

The Fire Department also sent out a survey to the community, which elicited some excellent feedback, according to Chief Bartlett. The survey revealed that most residents are aware of the fire zone to which their properties belong. The biggest concerns were increased insurance rates, development impacts, and the accuracy of the maps. Ninety-four percent of those sur-veyed support the use of science-based data to contribute to the development of these new map models.

Chief Bartlett is encouraging residents to join the Fire Safe Council, which is seeking non-profit status, to allow funding to be made available. According to the Sierra Madre Community Emer-gency Response Team (CERT) website, the Sierra Madre

Fire Safe Council is a community-based organization that shares the objective of making California's communities less vulnerable to catastrophic wildfires. Fire safe councils accomplish this objective through education pro-grams and projects such as shaded fuel breaks or firebreaks to protect area residents against an oncoming wildfire and to provide firefighters with a place to fight the oncoming fire.

dents on strategies to protect their homes In addition, there is the FireWise USA® pro-



gram, which encourages FireWise Communities to "band together" to reduce the risk of wildfires. This program is the Neighborhood Watch for wildfire danger. As a result of neighborhoods becoming FireWise Communities, residents may be eligible for discounts and rebates on their insurance. There is an application process, and you can download their toolkit and learn more at www. nfpa.org/education-and-research/wildfire/ firewise-usa.

Memorial Day is Monday and Sierra Madre never fails to salute, commemorate and remember those who gave all. There have been so many pictures everywhere you look this past week, leading up to Monday, of small flags adorning graves at Veteran's Cemeteries, stretching as far as the eye can see as friends and families of those who rest there gather to-

remember. One of the most touching pictures, as far as our family is concerned, is one of our grandchildren, Nicole, Blake and Luke Simon at the Los Angeles National Cemetery, visiting the grave of their other grandmother, Margaret Ineson, who was a Navy nurse. They were very small at the time but love was written all over them. Sierra Madre is such a special place to be on Memorial Day. John and I went so many years to Pioneer Cemetery, where he rests now, to participate in the Memorial Day ceremonies and came away every single time glad we had gone. We visited Arlington Cemetery some years ago. It was an unforgettable experience. We wept the whole time we were there. 639 acres with close to 400,000 people buried there.

Some time ago, I saw this great statement by Laurie Roberts, USA Today Network:

"Before you slap the burgers on the grill, remember Inchon and Heartbreak Ridge and Chosin Reservoir where heroic Marines fought to their last breath against overwhelming odds.

Remember Khe Sanh and Hamburger Hill. Remember Ramadi and Fallujah and Kandahar. It's easy to forget the fallen, especially on a day when the sun is shining and we are so blessed with the tremendous good fortune to live in peace."

The picture today is my son, John, and his son, Caleb, who will be 12 years old in just a few days and is well on his way to becoming an Eagle Scout. High adventure took place last weekend when John, Caleb and their Scout troop set off backpacking to the summit of Mt. San Jacinto. Setting off from sea level, they took the Palm Springs Tram up to the 8,500 ft. elevation, hiked 3 miles with full backpacks, set up camp then hiked 4.25 miles to the summit at 10,800 ft. Hiked back down to base camp, spent the night and then returned home. They didn't quite hit the summit but the entire experience was amazing. Why am I telling you this? I have a hiking experience I think you'll enjoy.

Many years ago when we were all much much younger, My husband, the adorable John, now a resident of heaven, thought we would all enjoy hiking down the Mt. Wilson Trail from the top. Which is still 6 or 7 miles. Never having hiked anywhere in my life, I set out in cute suede boots and no socks. John carried baby Crissy, who was about one, in a carrier on his back, and we drove up to the top and started down. This was a bad idea in so many ways as I developed blisters immediately and daughter, Leah, who is now a tremendous hiker, and I collapsed part-way down and asked to be left to die. Son, John, and daughter, Patti, ran up and down the trail gleefully and couldn't understand what was wrong with us. John did the kindest thing any man has ever done for his wife: he gave me his socks to wear. We did finally complete the downward march and found John at the bottom sitting on the grass sharing wine with some guy who also happened to be sitting on the grass.

John hiked to First Water countless times and would be so sad to see the Trails closed now as volunteers work to repair our beloved Mt. Wilson Trail. The MWTR Recovery Run, planned for Saturday, October 4th is a community event to raise money for trail reinforcement and redesign in many places. You can help by contributing to the Fletcher Trail Maintenance Fund which pays for the equipment, materials, supplies and tools used by our awesome Trail Maintenance Crew volunteers. City Council will not meet on Monday.

The City of Pasadena will have trash collection on Monday. There will be no delay to trash, recycling and yard waste collection; however, bulky item pickups will not be available.

The City Service Center (CSC) will be closed on Monday and will reopen at 8 a.m. on Tuesday.

Pasadena Water and Power (PWP) will also be closed. Residents and businesses with any power emergencies should call the Power Emergency Line at (626) 744-4673. For waterrelated emergencies, call the Water Emergency Line at (626) 744-4138. PWP's regular Customer Call Center will be closed for the holiday, but customers can access their accounts and pay bills online at PWPweb.com or by calling (626) 744-4005.

The City's Municipal Services Payment Center and Parking Office will be closed on Monday. All parking meters not posted as a "No Parking" zone will be free on May 26, and time limits will not be enforced. 

CAL FIRE SEIZES OVER 100,000 POUNDS FROM ILLEGAL FIREWORKS OPERATION IN LOS ANGELES COUNTY

Commerce, CA - Today the CAL FIRE - Office of the State Fire Marshal (OSFM) seized over 100,000 pounds of illegal fireworks discovered in Commerce, CA, located in Los Angeles County.

CAL FIRE - OSFM responded to a claim of a current fireworks importer/exporter licensee with CAL FIRE – OSFM not following laws and regulations related to requirements of their license.

This seizure results from a CAL FIRE - OSFM investigation of a current fireworks importer/exporter licensee not following laws and regulations required by their license.

CAL FIRE - OSFM would like to commend ongoing efforts to help curb the use and sales of illegal fireworks, protecting the public from the hazards they present. Additionally, we would like to thank Los Angeles County Fire Department as well as the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) Task Force. The collaborative efforts of all agencies involved demonstrate their ongoing commitment to protecting our communities.

"As we approach the 4th of July and a typical increase in usage of illegal fireworks, this seizure should be a reminder of our zero tolerance to illegal fireworks in California," said California State Fire Marshal Daniel Berlant.

Since January 2025, California has seen over 4 million dollars in property loss from fireworks-caused fires. CAL FIRE would like to remind everyone that it is illegal to sell, transport, or use in California fireworks that do not carry the "Safe and Sane" seal, and to possess or use fireworks in a community where they are not permitted. Violations of these limitations are subject to fines up to \$50,000, and up to one

California has zero tolerance for the sale and use of illegal fireworks. Illegal fireworks include:

- Bottle rockets
- Roman candles Aerial shells
- Firecrackers
- Other fireworks that explode, go into the air, or move on the ground in an uncontrollable manner

Fireworks are illegal in parts of California due to the significant risk they pose, as they cause severe injuries and millions of dollars in property damage each year. Large grass crops and dry vegetation increase the threat of devastating fires throughout all of California.



Both of Dr. Hacking's sisters pursued the family business in higher education as well. Alison Pike is a professor of psychology at the University of Sussex in Brighton, England, and Jane Hacking is a professor emeritus in Slavic Languages at the University of Utah. They took a more direct route in following their very well-known and accomplished father, Ian Hacking, who was a world-renowned Canadian philosopher and author who wrote a dozen highly regarded books. He taught at some of the most prestigious universities, including the University of Cambridge and Stanford. He won the Holberg Memorial Prize in 2009, which came with an award of \$750,000. That was just one of several awards and recognitions, which included being elected Fellow of the British Academy, the Royal Society of Canada, and the American Academy of Arts and Sciences.

"He was the smartest man I have ever known," Daniel recalled. "He demanded intellectual curiosity and academic excellence. He was also a fantastic teacher who loved to take his son camping. We would hike for hours to some remote campsite, cook steaks over the fire, and sleep under the stars, where he would explain the constellations in the night sky. We cycled through Northern California, the Italian Alps, and the flatlands of Holland and Germany. Never a dull moment. He actually led me to a career in K-12 education because I was not going to try to follow in his footsteps as a college academic."



While taking a slightly different route, Dr. Hacking ends a career in education that his late father would be extremely proud of. The elder Hacking dedicated his third book, written in 1975, The Emergence of Probability, to his son Daniel, who calls it his most prized possession.

"My father was a tough man to love, but he made me a non-complaining tough son of a gun," Daniel said.

After being promoted to Principal at John Muir Middle School in 2003 where he was for 7 years, Hacking made the journey to Arcadia in 2010 when he was named the Principal of Dana Middle School, a position he held for 11 years before being promoted to the Secondary Director of Curriculum, Instruction, and Assessment for Arcadia Unified.



LA COUNTY REOPENS LOMA ALTA PARK

ALTADENA (CNS) - In another recovery milestone for the Altadenacommunity, Los Angeles County today reopened Loma Alta Park, which was damagedin the Eaton Fire and underwent significant renovations to become a ``superpark."

"Loma Alta Park is a vital gathering place where our community cancome together, especially in times of healing," county Board of Supervisors Chair Kathryn Barger said in a statement. "After the trauma of the Eaton Fire, having a space to reconnect, rebuild relationships, and support one another isincredibly important. Parks like Loma Alta help restore not only our physical surroundings, but our sense of belonging. Social connection is essential to recovery, and this reopening is a meaningful step forward for Altadena."

The park in the 3300 block of Lincoln Avenue underwent extensive renovations and upgrades following the Eaton Fire. It now includes a pair of Dodger Dreamfields -- the only baseball fields in Altadena -- along with a

renovated gym and basketball courts funded by the LA Clippers Foundation, which will offer a Jr. Clippers Basketball Program for Altadena youth. The Clippers Foundation also funded a new computer lab and tech center

The park also now includes a satellite senior center and library, after-school programming for kids 5-12 and a Tiny Tots program for kids 3-4, mental health services and an Our SPOT Teen Center. The park's swimming pool was also renovated. The Altadena Rotary Club will also move its summer concert series to the park due to extensive fire damage at the previous venue,

Farnsworth Park.

County officials said volunteers also planted 44 trees, 32 tree seedlings and 818 plants at the park, and spread 50,000 square feet of mulch.

Murals were also painted throughout the park, including work by local artists Victor Ving, Eric Junker, Ryan Burch and Katie Chrishanthi Sunderalingam.

``L.A. County Parks is grateful for the outpouring of support for Loma Alta Park from many generous partners, Supervisor and Board Chair Kathryn Barger, several county departments, and L.A. residents who just wanted to lend a helping hand," county Parks Director Norma E. García-González said in a statement. ``We had over 2,000 volunteers from across L.A. County sign up in April to help their Altadena neighbors by painting murals, planting trees and shrubs, and enhancing the park.

"Loma Alta Park was fortunate that none of its buildings burned, which allowed us to move quickly to meet this community need, and now it is ready to better serve Altadena with new and expanded services and facility

improvements. The community asked for the park to reopen, and knew we needed to meet the moment. Here we are, as promised, just two months later."

LEGEND IN OUR BACKYARD: A RIDE THROUGH LIFE WITH HALL OF FAME JOCKEY MIKE SMITH

In the quiet calm of the foothills, where horses train just a stone's throw from where we sip our morning coffee, lives one of the greatest jockeys in the history of horse racing — Mike Smith. With over 5,600 career wins and mounts on champions like Zenyatta and Justify, Smith is a legend not just at the track, but right here in our own backyard.

At 59 and closing in on 60, Mike still brings the energy and focus of a rider half his age. I caught up with him for a conversation about fitness, food, and what keeps him grounded — both in the saddle and around town.

Staying Fit, Staying Sharp

"I still feel great," Smith says. "I stay active, stretch a lot, and try to eat smart." He's not riding horses every day, but when he does, he makes it count. "The key is keeping the weight down without losing strength."

The work ethic and discipline that took him to the top of the sport are still intact. "There's no shortcut. You put in the work — day in, day out."

Where Mike Eats — From Arcadia to Del Mar

Mike's career has taken him everywhere from Del Mar to Lexington, but when it comes to favorite meals, his local picks say a lot about his roots.

"Arroyo Chop House is one of my favorites. Smitty's is solid, and I've always liked Houston's," he says. "And The Derby in Arcadia — that's a classic. Great food, great vibe."

On a cheat day? "Sierra Donuts," he grins. "That's my treat spot."

In Del Mar, where the coastal air meets racetrack tradition, Mike doesn't miss. "Tracton's is great, and I love Pamplemousse — both are special places."

With all he's accomplished, Mike keeps it in perspective. "I never take it for granted. I still love being around the horses, the people, the fans."

And yes, he still gets a thrill on race day. "Walking into the paddock before a big race — the butterflies are still there. That's when you know it still matters."

In Summary

Whether he's dining at Arroyo Chop House or riding into the winner's circle, Mike Smith is a rare blend of world-class talent and neighborly humility. We're lucky to call him a local — and lucky he still takes the time to talk horses, donuts, and life with fans who admire the ride.

INGREDIENTS

1 pound strawberries, hulled and halved (about 3 cups), plus 8 ounces more, coarsely chopped

1 tablespoon fresh lemon juice

½ teaspoon kosher salt

1 cup low-fat milk

1 cup heavy cream

⅔ cup sugar, plus ⅙ cup more for macerating

½ cup light corn syrup

¼ cup vodka or silver tequila

DIRECTIONS

In a blender, puree halved strawberries with lemon juice and salt. Strain through a finemesh sieve. (You should have 1 1/2 cups of puree; reserve any excess for another use.)

Combine milk, cream, 2/3 cup sugar, and corn syrup in a medium saucepan. Bring to a boil,

then reduce heat to low and simmer 2 minutes.

Strain mixture into a bowl set in an ice bath and let stand, stirring occasionally, until cold, about 5 minutes. Stir in strawberry puree. Refrigerate, covered, at least 2 hours and up to overnight.

Stir together remaining 1/2 cup sugar and vodka. Add chopped strawberries and macerate at room temperature at least 2 hours, or in the refrigerator, covered, up to 12 hours.

Process puree mixture in an ice cream maker according to manufacturer's instructions. When it has the texture of soft serve, drain macerated berries (reserving syrup for another use) and fold into ice cream. Transfer to a loaf pan and freeze, wrapped in plastic, at least 4 hours and up to 1 week. Let stand at room temperature 10 minutes before serving.



OCTAVIA E. BUTLER'S

OCTAVIA BUTLER'S "PARABLE" BOOKS

In the last few months, numerous friends that I should read r's "Parable of the

have told me that I should read Octavia Butler's "Parable of the Sower," a book that she wrote in 1993. I finally got a copy to see what it was all about.

The book is a day by day account of growing up in a futuristic society that is disintegrating at every level. The story begins in a town called "Robledo," which I am told is the Pasadena/Altadena area where Butler lived. There are pervasive water shortages, climate change, economic depression, and vagabonds everywhere ready to steal and kill for whatever you have.

Butler's story is told through the eyes of then 15-year-old Lauren Olamina, who watches her little world as things just get worse. There are dead bodies in the nearby foothills, and thieves who regularly go into your yard to steal whatever fruit is on your tree.

The day by day existence is rough, dangerous, and unpredictable. Police are around, but generally only if they are paid for

their services. Lauren sees her father disappear and never finds out what happened. Her plan is to travel north, by foot, and make it to a better place. Slowly she collects a small band about her whose focus is to escape the burning and destroyed towns. Food, water, and medical aid are constant issues.

Lauren is a writer and has also slowly compiled a collection of truisms, which she calls Earthseed. We're not sure if Lauren's Earthseed is a religion or a belief system, but it gives her hope. To her, God is Change.

This is a hard book to read since it feels too real, and it makes you want to do everything you can possibly do to maintain all that is good and just in society so we never go down that path.

I wondered if Butler could see into the future.

In her sequel to "Parable of the Sower," which is "Parable of the Talents," the daughter of Lauren is the main character, describing the difficult development of a community in Oregon that seeks to find meaning and order in a dysfunctional society.

In "Talents," Butler mentions the politics of the day, almost as a footnote. In her fictional 2032, there is a Texas Senator Andrew Jarret whose followers seem to be a throwback to the Klu Klux Klan, burning and killing people they do not like.

Writes Butler, "Jarret insists on being a throwback to some earlier 'simpler' time. 'Now' does not suit him. Religious tolerance does not suit him. The current state of the country does not suit him. He wants to take us back to some magical time..." a time that Butler adds never really existed. "But these days when more than half the people in the country can't read at all, history is just one more vast unknown to them."

"Jarret supporters have been known, now and then, to form mobs and burn people at the stake for being witches," and witches is defined as a Moslem, Jew, Hindu, Buddhist, or in some areas, Mormons, Jehovah's Witnesses, 'cults,' even Catholics, anyone who doesn't match Jarret's version of Christianity. Butler adds that Jarret "condemns the burnings, but does so in such mild language that his people are free to hear what they want to hear."

In Butler's quasi-prophetic works, she says that Jarret tells everyone, "Join us, our doors are open to every nationality and every race. Become one of us. Help us to make America great again." Jarret lets people know that if they do not join him, "whatever happens to you as a result of your own sinful stubbornness is your problem."

In the story, Lauren's daughter is concerned that her little Earthseed group might be viewed as a 'cult' by the blind followers of Jarret.

Again, the book is hard to read, and one cannot help but think that Butler had a glimpse into one possible future. It is my belief that Butler wrote the book so that readers would awaken to the path that might lead to this "future," and do everything possible to create a world that is just, fair, and equal for all.

ESSENTIAL LEGAL DOCUMENTS ALL SENIORS SHOULD HAVE

Dear Savvy Senior:

What kinds of legal documents do I need to help my family take care of me in my elder years? I would like to get my affairs in order but could use some help. Approaching 80



Dear Approaching,

All adults, especially an older adult like yourself, should have at least five legal documents to protect yourself and your family. These documents will make sure your wishes regarding your estate are legal and clear and will help minimize any conflicts and confusion with your family and your health care providers if you become seriously ill or when you die. Here are the key documents you need, along with some tips to help you create them.

Durable Power of Attorney: This document allows you to designate someone you trust to handle your financial affairs if you become incapacitated.

Advance Directive: This includes two documents that spell out your wishes regarding your end-of-life medical treatment. The two documents are a "living will" which tells your doctor what kind of care you want to receive if you become incapacitated. And a "health care power of attorney" (or health care proxy), which names a person you authorize to make medical decisions on your behalf if you're unable.

To complement your advance directive, you should also consider getting a Physician Orders for Life-Sustaining Treatment – see POLST.org. This is a state specific form that your doctor would fill out that translates your end-of-life wishes into medical orders to ensure your wishes are carried out.

A Will: This lets you spell out your wishes of how you'd like your property and assets distributed after you die, whether it's to family, friends or a charity. It also allows you to designate an executor to ensure your wishes are carried out and allows you to name guardians if you have dependent children.

In addition to a will, if you own real estate or have considerable assets, another option you may want to consider is a "revocable living trust." This functions like a will but allows your estate to avoid the time and expense of probate (the public legal process that examines your estate after you die) and helps ensure your estate's privacy.

HIPPA Release: This form gives your healthcare provider permission to discuss your medical care and medical bills with those you designate. You may need specific HIPAA release forms for each medical professional or health care establishment you deal with.

Do-It-Yourself

If you have a simple estate and an uncomplicated family situation, there are do-it-yourself resources that can help you create all these documents for a few hundred dollars. Some top-rated options to consider include Quicken WillMaker & Trust software (see WillMaker.com), Trust & Will (TrustandWill. com) and Legal Zoom (Legal Zoom.com).

Get Help

If, however, you want or need assistance or if you have a complicated financial situation, blended family or have considerable assets, you should hire an attorney. An experienced lawyer can make sure you cover all your bases – especially when writing a will or living trust – which can help avoid family confusion and squabbles after you're gone.

Costs will vary depending on where you reside, but you can expect to pay somewhere between \$500 and \$2,000 for a basic estate plan that includes a will, power of attorney and advance directive. If you want your estate plan to include a living trust, that can run anywhere between \$1,500 and \$5,000.

The National Academy of Elder Law Attorneys (NAELA.org) and the National Association of Estate Planners and Councils (NAEPC.org) are two good resources that have directories on their websites to help you find someone in your area.

If money is tight, check with your state's bar association (see FindLegalHelp.org) to find low-cost legal help in your area. Or call the Eldercare Locater at 800-677-1116 for a referral.



Among the deals touted were an \$8.5 billion investment from Qatar in a Texas energy company, \$200 billion in Amazon cloud computing from Abu Dhabi and \$600 billion from Saudi Arabia for an airport project.

administration also bragged about billions in military purchases by Qatar – also either announced under Biden or which had "been in the works for years", according to a congressional aide quoted by the Post. A White House spokesperson referred to some of these as "reaffirmed investments". Others were described as "aspirational". And then there were doubts

But as the Washington Post later reported, these deals and others had already been made months, if not years, before - under President Joe Biden. The

whether Saudi Arabia could come up with even half the cash needed to fund what they'd been talking about, anyway. But the trip wasn't about the president making deals for our country; it was an opportunity for those who accompanied him - dozens of CEOs and top

execs from Nvidia, Amazon, Cisco, Qualcomm, Open AI, Palantir, etc. - to make deals for their companies. Nvidia, for instance, struck deals with the UAE

and Saudi Arabia for semiconductor chips The Guardian describes as "the most advanced in the world for the creation of artificial intelligence products". Under President Biden, such deals were restricted in the interest of national security – fearing these technologies would somehow make their way from the Gulf states to China. But national security isn't a concern of President Trump's and, apparently, neither are issues like the war in Gaza and Iran's influence

What was important was rewarding his billionaire donors with the opportunity to make billions more on the president's first overseas trip of his second term. Also tagging along, of course, was Elon Musk – so he could ink more deals for his Starlink satellite communication system.

At a crypto convention in Dubai the week before the trip, it was announced the UAE was putting \$2 billion into Trump crypto through the Trump family's World Liberty Financial – with Eric Trump on stage for the announcement. That same day, the Trump administration lifted restrictions allowing the UAE to buy those semiconductor chips from Nvidia. (Now what was that Hunter Biden thing all about again?)

Tied into the trip was news of that \$400 million Boeing 747-8 for President Trump from Qatar. Since such a "gift" without Congressional approval would violate the Emoluments Clause of the Constitution, it was later clarified that the plane would be going to the Defense Department, and then to the Trump Presidential Library once Trump left office (with assurance he wouldn't then be using it personally – like yeah, right).

It was seen as a successor to the aging Air Force One. Trump had ordered replacements for that plane back in 2018, but they probably won't be ready until nearly the end of this second term - if then. With the special requirements for a president's Air Force One (most passenger jets don't need protection against electromagnetic waves from a nuclear blast), even this new one from Qatar would have to be retrofitted in a process taking years and an extra billion-or-so dollars.

With all this still to be resolved, it appears Trump went ahead anyway - the plane was delivered and parked at the San Antonio airport. It was presented as a generous out-of-the-blue offer from Qatar, but now we know Trump had been shopping around for one since deciding he just couldn't wait for those already-ordered replacements to be ready.

There's another aspect to the deal reported by Forbes that puts it in a whole different light: Qatar has been trying to unload this plane for years. It'd been on the market since 2020 – with no takers. They did manage to unload one like it on President Erdogan of Turkey back in 2018, but at a then-cost of \$23,000 an hour to fly, one wonders if the Turkish president afterwards had any second thoughts.

And that per-hour flight cost doesn't include the millions of dollars in ongoing storage and maintenance. Even without the required retrofitting, the plane Trump is saddling us with is due in a couple years for its 12-year maintenance - itself taking months and costing millions, while it's becoming harder to find mechanics to work on them. Billionaire oil sheiks nowadays are going for more efficient, versatile two-engine planes (think Boeing 787 or Airbus A350) – not those four-engine outmoded guzzlers with the extra-large runways they require.

Qatar has managed to rid themselves of an obsolete, unwanted, money-pit liability – improbably finding someone thinking they're getting a deal in being able to take it off their hands ("Only a FOOL would not accept this gift on behalf of our Country"). 






ROTATOR CUFF STUFF

By the time you read this I will have gone under the knife - again. This time for a repair of one of my rotator cuff muscles. If you suspect you may have a shoulder injury that requires surgery, read on. You can follow my progress at the Facebook page listed at the end of this story.

It started many years ago. First with a sore bicep muscle. Then difficulty pulling off clothing over my head. More recently pain while lifting weights for arm work. Then discomfort while sleeping on it. I pretty much don't pay attention to minor aches and pains. As someone who has worked out more than 30 hours a week for 40 years, you get used to strains, sprains and muscle knots that come and go. But this has persisted for a long time. And now that it is definitely not going away, it needs to be taken care of.

What exactly are the rotator cuff muscles and what do they do? The rotator cuff is a group of four muscles and their tendons that surround the shoulder joint, helping to keep the

shoulder stable and allowing you to move your arm in various directions. These muscles are:

- 1. Supraspinatus: Located on the top of your shoulder blade (scapula), this muscle attaches to your humerus bone and helps lift your arm away from your body.
- 2. Infraspinatus: Found on the back of your shoulder blade, it allows you to rotate your arm outward.
- 3. Teres Minor: Also on the back of your shoulder blade, this muscle assists in rotating your arm outward.
- 4. Subscapularis: Situated on the front of your shoulder blade, it helps rotate your arm

Together, these muscles and tendons form a "cuff" around the top of your arm bone (humerus), keeping it securely in the shallow socket of your shoulder blade. This setup allows you to move your arm in many directions, such as lifting, reaching, and rotating, while keeping your shoulder stable. The deltoid muscle is the outer shell that moves and shapes the shoulder. The rotator cuff muscles are deeper stabilizers that keep the joint secure.

In my case, it's a complete tear of the supraspinatus muscle and tendon that is involved. After years of overuse, the muscle has torn off the bone and slipped back making the other muscles pick up the slack to keep the arm moving and functioning as best as possible.

Such tears don't heal on their own due to limited blood supply to the tendons, which hampers the body's natural healing process. Plus, the detached tendon may retract, making natural reattachment difficult. Over time, the muscle can weaken and be replaced by fat tissue, further complicating healing. Despite this, not everyone with a complete tear would opt for surgery. Many find relief through physical therapy, which can improve function and reduce pain. But, for someone like me, who wants to continue to have a high level of physical activity using my arm for lifting weights, swimming and fitness classes there isn't really a choice. And if I leave it as is, it will eventually lead to an entire shoulder replacement which my doctor said is way worse than a hip replacement!

The procedure is done arthroscopically. Just a few holes in the front and back of the shoulder. It really is a fascinating process to see how they anchor sutures into the bone and then sew the tendon back onto it. Kind of reminds me of one of those bags that cantaloupes are sold in. Criss crossed mesh. Technical name is Transosseous-equivalent (TOE) double-row repair.

Whatever it's called I'm not looking forward to it. Two surgeries within 10 months means another summer of no fun. Recovery time is the worst part. At least 4-6 weeks in a sling. Then a full 3 months to get back to using it in any kind of normal capacity. God forbid I retear it during healing (something that happens more often than you would think – about 25% of the time in people my age) and need to have surgery all over again. To make matters worse, I think I have the same issue in my other arm but I'm not ready to deal with finding that out just now.

Sometimes I feel like the body parts are breaking faster than I can fix them. But the good news is that they CAN be fixed. Yes, parts wear out from years of overuse. I absolutely expected that. Still I much prefer this over heart disease, diabetes, stroke and obesity issues. I guess an occasional 'repair' from an active lifestyle is a worthwhile trade-off for overall long-term health.

UNLOCK YOUR LIFE

WHAT WOULD YOU DO WITH A LITTLE MORE TIME?

"Put your hand on a hot stove for a minute, and it seems like an hour. Sit with a pretty girl for an hour, and it seems like a minute. That's relativity." Albert Einstein

When I turned 40, I became more attuned to death. I thought dying at that age would be shocking—a tragedy—but it happens. I decided I'd better start taking better care of myself.

At 50, I accepted that death was definitely on the menu. I'd better start having more fun. In my 60's, I'm doing my best to make the most of things, and I find it harder than I expected. My questions have changed. Is it possible to be truly known, or to truly know? Everyone around me seems so sure of everything, while I seem to know less and less. At this point, I find myself asking: "What would you do if you knew you only had a little more time?"

I'd try to be kinder and laugh more. I'd get out of the house and meet new people. I'm trying to be less resistant, more forgiving, and more loving.

Henry David Thoreau said, "I went to the woods because I wished to live deliberately, to front only the essential facts of life, and see if I could not learn what it had to teach, and not, when I came to die, discover that I had not lived... I wanted to live deep and suck out all the marrow of life, to live so sturdily and Spartan-like as to put to rout all that was not life, to cut a broad swath and shave close, to drive life into a corner, and reduce it to its lowest terms...'

I will be 64 soon, and my mother was 66 at the time of her death. I'd love to eliminate everything that's not essential, but I'm finding that to be more difficult than I imagined. It's easy to acquire possessions, but far more difficult to shed them.

I woke up this morning thinking about forgiveness.

I'm noticing the small transgressions and slights that I've held onto. My longtime friends and friendships have changed. One of my coping skills is constantly reminding myself that everything changes, and nothing stays the same, but sometimes, my resistance is so subtle that it sneaks up on me.

Lots of my friends are judges now. That has changed the landscape of friendship in the legal community, and I was hurt by it. Many now believe their relationships with lawyers should be confined within the four walls of the courtroom, regardless of decades of friendship before they took the bench. I felt abandoned, excluded from lives I once shared. But I'd never considered the other side. In today's world of constant surveillance and scrutiny, perhaps these once-close friends now live in a kind of social prison. Every interaction outside the courtroom risks being misinterpreted, photographed, or posted online. Their position demands a distance that may pain them as much as it does me. I'm learning that there's another way to interpret what felt like rejection. It may not be personal after all, but the price of the robes they wear.

The real question isn't what we would do with more time, but how we choose to spend our precious moments now. Let go of what doesn't serve you. Don't resist love when it appears. Practice self-kindness daily. The time to live fully isn't someday—it's today.




