WHERE CAN YOU SEE THE SIERRA MADRE ROSE FLOAT???

On December 31st, we are planning our Float Departure Ceremony to commence at approximately 5:30-5:45 p.m., then we'll leave the barn at approximately 6:00 p.m., heading towards Kersting Court, arriving at approximately 6:10 p.m. We will remain there about 20 minutes, then continue on to our line-up spot on Orange Grove, where it will remain overnight before the parade. If it's inclement weather, we'll wave as we sail by without stopping.

After the Rose Parade, the float will be at FloatFest, the post parade viewing area near PHS, the remainder of January 1st and all day January 2nd and 3rd.

On the evening of January 3rd we will move the float back to Sierra Madre when we're allowed to leave post parade/FloatFest.

We will be taking the float straight back to the Float Barn at 587 E. Sierra Madre Blvd., Sierra Madre. On the morning of January 4th, approximately 9:30 a.m., we will open the barn for viewing and may have excess flowers available. Around 3:00 p.m., we will be closing up for the day.

## AN UPHILL DRIVE TO BETTER TRANSPORTATION IN SIERRA MADRE

In 2023, Mountain Views News first reported on the dwindling transportation options in Sierra Madre and on in-service buses that are ready to be put out to pasture due to reaching their "end of use" status. You may have heard stories of students and other residents hiking up to Foothill Blvd. to catch the closest public transit to school and work.

City Council was approaching the second hour of their regular meeting on Tuesday, December 9th, when they were presented with an update on the direction of Sierra Madre local transportation and some program options.

James Carlson, Senior Management Analyst, gave a presentation to start the discussion. So, what's been happening over the past two years? Has the City made progress? Or has the idea of better transit stalled with a flat tire on the side of the road?

According to Carlson, over the past two years, the Local Transportation Ad Hoc Subcommittee has worked "diligently to improve local transportation." The Subcommittee collaborated with the Public Works Department to redesign Sierra Madre's Local Transportation Program in hopes of restoring regional connectivity and better serving local needs.

As a result of these efforts, Metro Line 268 to Sierra Madre returned to action with a "revised fixed-route concept" connecting to Pasadena, Arcadia, Foothill Transit, and the Metro L Line (formerly the Gold Line). This helped serve area schools, get folks to shopping areas, gyms, and parks.

But it's been an uphill struggle to reach an agreement on new local transportation programs. In July 2024, the City issued a Request for Proposals (RFP) for the operation of a new local transportation program and received two submittals. According to the report, A San Jose-based airport shuttle contractor was deemed non-responsive due to a lack of relevant experience. The second proposal from the City's current contractor, Transdev (formerly First Transportation), for consideration was now the only proposal.

But on October 17, 2025, the Public Works Department concluded that Transdev's final offer, which Carlson said, "even more significantly reduced hours and services," and was not financially sustainable beyond an estimated five-year period, and would deplete reserves from Proposition A, which is a half-cent sales tax dedicated to transportation funding. In other words, it was more than the city budget could handle.

As a result, at the December 9th meeting, Public Works recommended that the City Council reject the current Transdev proposal, reconvene the Local Transportation Ad Hoc Subcommittee, and authorize development and release of a new RFP that refines the service model. They hope for a plan that addresses the Americans with Disabilities Act (ADA) and cost concerns, preserves Proposition A, reserves funds for long-term program viability, and attracts multiple qualified proposals, according to Carlson's presentation. Carlson also said the Subcommittee will review "lessons learned" from the previous RFP experience, and suggested to Councilmember Edward Garcia that "they should cut bait with Transdev."

## New Year's Closures & Reminders

Pasadena residents and businesses are reminded that city hall and most city services will be closed for the New Year's holiday Thursday. Specific closures, exceptions and reminders are noted below.

Pasadena residents and businesses with any power emergencies on Thursday should call Pasadena's Water and Power (PWP) Department at (626) 744-4673. For water-related emergencies, call (626) 744-4138. Customers can access their accounts and make payments through the automated phone system at (626) 744-4005 or online at PWPweb.com.

The City's City Service Center (CSC) will also be closed Thursday. You can contact the CSC via the web or mobile app, or by calling (626) 744-7311. Requests submitted over the weekends will be monitored.

City trash collection will have a one-day delay of trash collection during New Year's week. Residents can drop off their Christmas trees through Friday, Jan. 2, for recycling at Eaton Blanche Park (3100 E. Del Mar Blvd.) or Robinson Park (1081 N. Fair Oaks Ave.) between the hours of 7 a.m. and 2 p.m. Please remove all stands, ornaments and lights prior to drop-off. Curbside Christmas tree pickup will take place Jan. 5 through Jan. 16 on residents' regular pickup day.

Pasadena Transit Route 33 will operate on a Sunday schedule on Thursday. All other routes and Pasadena Dial-A-Ride will not operate on New Year's Day, Jan. 1.

All parking meters are free and parking time limits will not be enforced on Thursday. Overnight parking restrictions will not be enforced through Saturday, Jan. 3, and will resume at 2 a.m. on Sunday, Jan. 4. Violations for red curb/no parking zones, driveway blocks and blocking fire hydrants will continue to be issued at all times.

Library branches will close on Wednesday at 1 p.m. except Jefferson Branch Library, which closes at 5 p.m. All libraries will close on Jan. 1. On Friday, Jan. 2., the Hastings, Hill Avenue, La Pintoresca and San Rafael Branch Libraries will be open for regular hours, all other Pasadena Public Libraries will resume regular hours Saturday, Jan. 3.

The City's Permit Center will be closed on Thursday, however, many services will be available via Permit Center Online, where you can obtain subtrade permits and submit plans for new construction, tenant improvements, accessory dwelling units, and additions.

All recreation and community centers will close at 5 p.m. on Wednesday. All recreation and community centers will be closed Thursday.

The Pasadena Public Health Department's (PPHD) Immunization Clinic Services, Cashier Services, and the Vital Records Public Counter will be closed for all in-person services Thursday. Pasadena Fire and Police Departments will continue to be staffed for all patrol, jail, fire, paramedic and other emergency services. Always call 9-1-1 for life-threatening emergencies. ## Volunteers Put Final Touches on Rose Floats

South Pasadena rose float volunteers were "dry decorating" the city's entry "The Great Picnic Heist," over the Christmas holiday getting it ready for fresh followers -expected to start arriving today.

"We'll cut them sort them and then start putting flowers on the deck," said Decoration Co-Chair Janet Benjamin (pictured top right).

Benjamin said the float depicts a sleeping bear with a group of eight ants steeling his lunch, "It's the teamwork of the ants trying to get the food that goes with the main theme of the parade. 'The Magic in Teamwork.'"

Benjamin said one setback

was that Strawflower they need have been stuck in Customs and Border Protection for over a month. Benjamin said this also goes for many of the floats, this year, that use Strawflower.

"If we can't get it we have a plan B, plan C and D," she joked.

The base of the float will be covered in recycled Christmas trees.

She said that they also hope to reveal a secret rider on the back of the float, "our costume is also stuck in Customs in China."

Benjamin said the cost of this year's float had topped \$200,000.

## Altadena Forever Run



### Proceeds Direct Relief to Altadena Eaton Fire Survivors and Funding for Sheriff's Support Group of Altadena

One year after the Eaton Fire blackened the ridges above Altadena, event organizers announced that an inaugural Altadena Forever Run is set to wind through the foothills of the San Gabriel Mountains January 4, as a powerful symbol of recovery.

The run will start at 8 a.m. at Mariposa Junction 849 E. Mariposa St. in Altadena. Registration is free for Los Angeles Sheriff's Athletic Association Members.

"This is more than a race. It's a tribute: to those who lost, those who helped, and those who are rebuilding," Organizers said. "Proceeds from the Altadena Forever Run directly support Altadena Eaton Fire survivors, through the Altadena Eaton Fire Relief Fund, a GoFundMe non-profit organization, helping families restore what was lost and strengthen what endures. The race also helps support the Sheriff's Support Group of Altadena. Your participation, your sponsorship, your presence, each is an act of solidarity and hope."

According to organizers runners will begin on Mariposa Street, from there, the course climbs gently toward the foothills along Altadena Drive, winding through tree-lined neighborhoods, where century-old Craftsman homes once stood. The route touches the very edges of the burn zone, where chaparral is already reclaiming the hillsides.

The event will have three course according length and difficulty.

- 10K Run (6.2 miles): The full 10K follows the 5K route, offering spectacular views of the San Gabriel Mountains before returning toward the historic Mariposa business district. The course then turns west, guiding participants past neighborhoods in various stages of rebuilding, a moving portrait of perseverance, where homes under construction stand as symbols of endurance and hope. The run passes Charles White Park before finishing triumphantly back on Mariposa Street.

- 5K Walk/Run (3.1 miles): Extending into the lower foothill neighborhoods east of Lake Avenue, this course will bring runners and walkers through streets lined with volunteers and cheering residents.

- 1K Family Walk/Run (0.62 mile): Starting at El Molino Avenue and heading west past the Altadena Library before looping back to Mariposa Street, this short, course is for families and children to share in the spirit of the day.

At the Mariposa Junction Finish Line, music, local food, and community booths await—celebrating every participant and every mile completed. Each finisher's medal is more than a keepsake; it's a symbol of perseverance, "a reminder that from the ashes, Altadena Forever Runs."

The course has a two-hour time limit. The Run is a rain or shine event, if it rains, the event will go on as scheduled. No refunds will be issued due to weather.

# AROUND SAN GABRIEL VALLEY

## APPEALS COURT AFFIRMS ORDER FOR VETERAN HOUSING ON VA WEST LA CAMPUS

LOS ANGELES (CNS) - A federal appeals court has upheld a court order requiring the U.S. Department of Veterans Affairs to construct 1,800 permanent housing units and 750 temporary housing units for disabled veterans on VA property in West Los Angeles, according to court papers obtained last week.

A three-judge panel of the U.S. 9th Circuit Court of Appeals in Pasadena on Tuesday also affirmed that the VA's leases with Brentwood School and Bridgeland Resources violate the West Los Angeles Leasing Act of 2016 and are therefore void. However, the panel allowed UCLA's lease for a portion of the VA grounds for its Jackie Robinson Stadium, used for baseball games.

"This class action lawsuit, and its numerous appeals, demonstrates just how far the VA has strayed from its mission," Circuit Judge Ana de Alba wrote in the Ninth Circuit opinion. ``There are now scores of unhoused veterans trying to survive in and around the greater Los Angeles area despite the acres of land deeded to the VA for their care. Rather than use the West Los Angeles VA Grounds as President Lincoln intended, the VA has leased the land to third party commercial interests that do little to benefit the veterans."

The VA did not immediately respond to a request for comment.

The Ninth Circuit heard oral arguments in April in the federal government's appeal of U.S. District Judge David O. Carter's landmark ruling regarding the VA's obligations to provide housing and care for disabled,unhoused veterans. On Nov. 25, 2024, appeals panel granted a stay of Carter's ruling pending the government's appeal.

Carter submitted his final judgment, reaffirming earlier findings and delivering a decisive victory for disabled veterans in October 2024. Following multiple hearings in Los Angeles federal court, the judge issued several key orders, including locking down UCLA's baseball complex until its activities on the VA campus focus on serving veterans, capping an oil well on the campus, and expediting the construction of temporary housing.

The judge's final decision followed an earlier ruling requiring the VA to build 750 temporary housing units and 1,800 permanent units within six years on the 388-acre campus. The ruling came after a four-week non-jury trial in which the district court found that the land-use leases the VA had with UCLA, the private Brentwood School, and oil company Bridgeland Resources, were unlawful.

During the trial, the VA argued it was out of space on its campus, and that the lack of available acreage precludes any increase to the 1,200 housing units the agency had promised to open by 2030. VA attorneys alleged that any relief ordered by the court would burden the department financially and deprive it of the flexibility needed to solve veteran homelessness.

The Ninth Circuit decision requires the VA to build 750 units of temporary supportive housing within 18 months, construct 1,800 units of permanent supportive housing within six years, and end the use of what was found to be discriminatory income restrictions for affordable housing by ensuring that veterans' disability payments do not count against their eligibility for supportive housing.

In a virtual news conference Wednesday, plaintiffs commended the Ninth Circuit opinion.

"These veterans have served the country, now it's time for the country to serve the veterans," said Mark Rosenbaum, attorney with the law firm Public Counsel and lead counsel in the case. `` This has been going on for far too many years."

Rosenbaum said the case paves the way for disabled veterans across the country to demand the housing and care they may have been denied.

Rob Reynolds, an Iraq war veteran and advocate for veterans seeking housing at the VA campus, said the ruling is `` long overdue. The veterans are very thankful. There shouldn't have been a situation where veterans returning from war didn't have access to the housing and services that they need."

Although UCLA was permitted to continue using VA grounds for Bruins baseball, Rosenbaum indicated he would file further litigation to reverse that part of the decision.

WHEN ILLNESS RUINS CHRISTMAS

For many families, Christmas is a season of anticipation—bright lights, shared meals, and long-kept traditions. But when illness strikes, the holiday can change suddenly, replacing celebration with worry and quiet resilience.

Every year, hospitals see a rise in admissions during December, from winter viruses to flare-ups of chronic conditions. A child’s fever, a parent’s unexpected diagnosis, or a grandparent’s frailty can bring plans to a halt. Trees go undecorated, travel is cancelled, and festive tables remain empty. The disruption is not only practical but emotional, as expectations built over weeks collapse in a matter of hours.

Illness often isolates families at the very moment they expect togetherness. Those who are sick may feel guilt for “spoiling” Christmas, while relatives struggle with helplessness. For healthcare workers, the holiday is frequently spent on long shifts, caring for patients who would rather be home. Wards are decorated with tinsel and paper snowflakes, but they cannot replace familiar voices and routines.

Yet, amid disappointment, many discover a quieter meaning to the season. A pared-back Christmas can shift focus from gifts to care: checking in by phone, dropping off meals, or simply sitting together. Small kindnesses—a nurse’s reassurance, a neighbor’s errand—take on greater weight when health is uncertain.

Mental health professionals note that acknowledging grief is important. It is acceptable to feel sad when illness interrupts cherished traditions. At the same time, adapting expectations can ease the strain. Celebrations can be postponed, simplified, or reimaged. A January gathering or a shared video call may not be ideal, but they preserve connection.

When illness ruins Christmas, it reminds us that the holiday’s heart is not perfection, but compassion. In choosing patience, empathy, and care, families often find that—even in a difficult year—the spirit of Christmas endures.

HOW TO FIND A QUALIFIED NURSING HOME FOR A LOVED ONE

Dear Savvy Senior,

Can you give me some tips on picking a good nursing home for my father? Since his stroke, I’ve been taking care of him at home, but he’s gotten to the point where it’s too much for me to handle. Exhausted Daughter



Dear Exhausted,

Choosing a nursing home for a loved one that provides quality is a very important decision that requires careful evaluation and some homework. Here are some steps you can take that can help you find a good facility and avoid a bad one.

Make a list: There are several sources you can turn to for referrals to top nursing homes in your area including the Area Agency on Aging (call 800-677-1116 or visit [Eldercare.acl.gov](http://Eldercare.acl.gov) for contact information); your dad’s doctor or nearby hospital discharge planner; friends or neighbors who may have had a loved one in a nursing home; and online at Medicare’s nursing home compare tool at [Medicare.gov/care-compare](http://Medicare.gov/care-compare). This tool will not only help you locate nursing homes in your area, but it also provides a 5-star rating system on recent health inspections, staffing, quality of care, and overall rating.

Also, keep in mind that it’s always best to choose a nursing home that’s close to family members and friends who can visit often, because residents with frequent visitors usually get better care.

Call your long-term care ombudsman: This is a government official who investigates nursing home complaints and advocates for residents and their families. This person can tell you which nursing homes have had complaints or problems in the past and can help you locate a good facility. Visit [LTCombudsman.org](http://LTCombudsman.org) for local contact information.

Contact the nursing homes: Once you’ve narrowed your search, call the nursing homes you’re interested in to verify that they can facilitate your dad’s needs. Also, find out if they have any vacancies, what they charge, and if they accept Medicaid.

Tour your top choices: During your nursing home visit, notice the cleanness and smell of the facility. Is it homey and inviting? Does the staff seem responsive and kind to its residents? Additionally, be sure to taste the food, and talk to the residents and their family members, if available. It’s also a good idea to visit several times at different times of the day and different days of the week to get a broader perspective.

And be sure to find out about their staff screening and training procedures, staff-to-patient ratio, and the staff turnover rate.

To help you rate your visit, Medicare offers a helpful checklist of questions to ask at [Medicare.gov/media/document/12130nursing-home-checklist508.pdf](http://Medicare.gov/media/document/12130nursing-home-checklist508.pdf) that you can print and take with you on your visit.

Paying for Care

With nursing home costs now averaging \$324 per day nationally for a semi-private room and nearly \$371 for a private room, paying for care is another area you may have questions about or need assistance with. Medicare only helps pay up to 100 days of rehabilitative nursing home care, which must occur after a hospital stay of at least three days.

Most nursing home residents pay for care from either personal savings, a long-term care insurance policy, or through Medicaid once their savings are depleted. Or, if your dad is a veteran, he may be able to get funds through the VA’s Aid and Attendance benefit (see [VA.gov/pension/aid-attendance-housebound](http://VA.gov/pension/aid-attendance-housebound)).

To learn more about the payment options, ask the nursing home director. You can also get help from your State Health Insurance Assistance Program (SHIP), which provides free counseling on all Medicare and Medicaid issues. To find a local SHIP counselor visit [ShipHelp.org](http://ShipHelp.org) or call 877-839-2675.

Christmas was over, and the house began to quiet down in a good way. Don't get me wrong, I love the noise when all the family is together. It is a good feeling to be with your family during this wonderful holiday season. I love the energy!

I enjoy the presents and watching the family opening theirs, but I especially love the holiday feasts prepared by The Gracious Mistress of the Parsonage. PROFILES FROM THE FIRE: CHIP JOHNSON

Chip Johnson grew up not far from John Muir High School in Northwest Pasadena. He graduated from St. Francis High School in La Canada, and went on to teach business law and social studies for 12 years at St. Francis. He then went on to teach 7th and 8th graders in the El Monte School District. He moved into his home in the northwest section of Altadena in 1986, and lived there with his wife and 5 children. He was enjoying his retirement with his wife and one child still residing with him in his picturesque corner of his Altadena neighborhood. Until January 7.

During the day of January 7, there were high winds, and Johnson heard about the fire and saw the glow of the fire to the east. As he watched the fire progress, he packed items in his car “just in case.” “But we really didn’t think we’d need to evacuate,” he explained. “We’ve been through fires many times before and it never got to us. It always stayed in the hills.

Though friends called Johnson about the fire and the possibility of evacuating, he received no official notices on his phone. He began to water down his house just in case, to prevent an ember from burning his home.

As darkness proceeded, the winds continued to get stronger, and trees and wires came down. Johnson sent his wife and daughter to the daughter’s parent’s home, and he and his son went to other relatives’ homes in Altadena to help water down their homes. Johnson pointed out that there are several little water companies that serve Altadena, and while the Las Flores Water Company had good pressure, there was low pressure where he lived, serviced by Lincoln Avenue Water Company. “I went with my son to several other houses and some had good water pressure for us to wet down the houses, and some didn’t” (Johnson has six relatives who reside in or near Altadena). “We saw whole blocks of houses burning,” he explains, and with a bit of angst, he adds that he figured his house was lost. In fact, even though everywhere around his neighborhood was on fire, he got a phone call while he was helping relatives saying, “Your house is still there.”



He went home, and worked with a neighbor to gain access to another neighbor’s pool, and used a sump pump to spray the pool water on the neighbor’s house. (The neighbor’s house survived the fire.) But because of the dense smoke, and high winds and blowing embers, Johnson thought he might get trapped in the neighborhood. He and his son collected the dogs, some basic clothing, important papers and laptop, and went to a cousin’s house by the Rose Bowl. But it was too crowded there since many relatives had also gone there, so Johnson and family went to his son’s house, away from the fire in Pasadena, closer to Arcadia, and stayed there for a few weeks.

When he was able to get around the National Guard barricades and get back to see if his house survived, he felt a certain shock to see his house and a few surrounding neighbor’s homes, still standing. However, nearly all of the surrounding homes for blocks around had been reduced to rubble, burned to the ground with just fireplaces standing.

As soon as he could go back regularly, he went back to clean up the burned vegetation and general clean up, though now there was no electricity, and no gas, and no water.

Why did his home and handful of his neighbors’ homes survive? Johnson really doesn’t know, but speculated that the coating of Tex-cote on his house might have been part of the reason. (Tex-cote is a product that is sprayed on the exterior walls, like stucco, and it is designed to reflect the sun’s heat and reduce the exterior wall surface temperatures by as much as 40 degrees f.) “When the workers sprayed it on, they were a little sloppy around some the attic vents and somewhat covered the openings. But that might have actually helped to keep embers out of the attic.” He also had recently installed a new roof. Additionally, his home sits in a small valley with a small ridge line to the north and east. It’s possible that the lay of the land in that little cul de sac kept the fire away from his house. “Still,” he exclaims, “my neighbor’s homes to my south, and north, and west, all burned to the ground!”

Johnson and family eventually rented a two bedroom place where they stayed with their dogs. They only managed to return to their home in July, a full six months after the fire.

In the meantime, they did a full remediation on the house, including removing all the insulation, and discarding most of the furniture. Johnson noted that the fire was so close to his house that the hinges on the wrought iron gate were melted.

In all, six of his relatives lost their homes due to the Eaton fire -- his brother and five cousins. After the fire, Johnson noted that he would see possible looters “dozens of times,” driving up and down the streets, presumably looking for scrap metal or something to steal. “They had no reason to drive up my street because it’s a cul de sac. If I saw them only once, I figured they might be lost, but if I saw them twice, I was suspicious.” Johnson would put on lights, and music, and use cameras, and often go outside when he believed would-be looters were driving though.

He shares that he used to walk in the neighborhood at night, but now it’s pitch black and eerily quiet, so he doesn’t do so much. Plus, the emptiness has resulted in seeing a bear more regularly in the neighborhood. He still sees regular coyotes, but they were around before the fire. The most irritating thing to him is the real estate agents who constantly call, wanting to know if he will sell his place.

Even though the old neighborhood barely exists anymore, and will not likely look like it did before the fire, Johnson and family are staying. “I’ve lived there for 40 years,” he says smiling. “Altadena’s my home. I don’t want to move somewhere else and be a 72 year old rookie.”

## HAVE YOU GIVEN UP ON EXERCISE?

Every January, the same pattern repeats for many people who want to exercise. They start the year hopeful, motivated, and ready to make a change. Gyms get busy, walking paths fill up, and fitness classes overflow. Many people truly believe this will be the year they finally stick with exercise. But by February or March, motivation fades, routines fall apart, and exercise slips away again. This cycle leaves people frustrated, discouraged, and wondering what is wrong with them. The truth is simple and important: the problem is not the person. The problem is the way exercise is often taught and expected to work.

One major reason people give up on exercise is unrealistic expectations. Many people expect fast results. They want weight loss, strength, energy, and confidence to appear quickly. When progress feels slow, disappointment follows. Exercise does not work on a short timeline. Real improvement happens gradually over weeks and months. Small efforts done consistently matter far more than intense workouts done for a short time. When people understand this, they are less likely to quit.

Another reason people stop exercising is the lack of a clear plan. Saying "I will work out more" sounds good, but it is not specific. Without deciding when, where, and how exercise will happen, it becomes optional. Busy days make skipping easy. A simple plan creates structure. Scheduling exercise like an appointment helps it become part of daily life instead of something that disappears.

Many people rely on motivation, but motivation is unreliable. Some days you feel inspired, and other days you do not. Waiting to feel motivated often leads to missed workouts. Habits work better than motivation. Doing the same activity at the same time builds consistency. Once exercise becomes a habit, it requires less effort and less negotiation.

Past experiences also shape current behavior. People who have tried and failed before may believe exercise is not for them. Maybe they joined a gym and stopped going. Maybe a program was too hard or too strict. These experiences create negative feelings around movement. Failure does not mean you cannot succeed. It provides information about what did not work.

Exercise is as much mental as physical. Thoughts like "I am too old" or "I am not athletic" quietly interfere. Fear of failure and self-doubt often stop people before they begin. Learning to notice these thoughts and replace them with realistic expectations can remove a major barrier. Exercise should support your life, not punish it.

Another common mistake is believing exercise must be long or intense to count. Many people think if they cannot exercise for an hour, it is pointless. This creates all or nothing thinking. Ten minutes matters. Walking matters. Gentle movement matters. Consistency builds progress, not perfection. Starting small makes success possible.

The best exercise program is one that fits your real life. Enjoyment matters more than intensity. If you dislike an activity, it will be hard to continue. Choose movement you enjoy or can tolerate. Track what you do so progress feels visible. Celebrate showing up. These strategies are often missing from fitness advice.

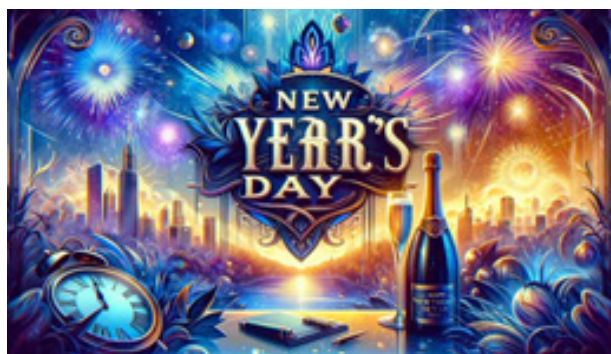
These ideas are the foundation of my new book, "Given Up On Exercise? Your Foolproof Path to Lasting Fitness". It is written for anyone who feels discouraged, deconditioned, or tired of starting over. The book focuses on understanding past struggles and creating a realistic plan that lasts.

If you have given up on exercise before, you are not alone. Many people struggle for years before finding an approach that works. This year does not need to be perfect. It needs to be different. Start small, be patient, and focus on consistency. Fitness grows when it fits your life and is doable.

January is a powerful moment because people are thinking about change, health, and the future. Instead of chasing extreme goals, use this time to reset your relationship with movement. Ask what feels manageable, supportive, and realistic. Plan for setbacks instead of pretending they will not happen. Missing a workout is not failure; quitting completely is. Progress comes from returning, again and again, without judgment. Exercise should help you feel capable in your body and confident in your choices. When movement fits your values and your schedule, it becomes something you do, not something you dread. That shift is what finally allows fitness to last.

Long term success is built through patience, self-awareness, and kindness. There is no perfect program, only one that works for you. Give yourself permission to learn as you go. When exercise supports your life instead of controlling it, staying active becomes possible, sustainable, and empowering.

## ALL THINGS NEW YEARS JAN. 1ST? by Jeff Brown



January 1st is considered the beginning of the New Year largely because of ancient Roman traditions, later strengthened by calendar reforms and global standardization. The choice is not based on astronomy or seasonal change, but on historical, political, and cultural developments that began over two thousand years ago.

In early Roman history, the calendar year originally began in March, which aligned with the start of spring and the agricultural season. This is why several month names—September (seventh), October (eighth), November (ninth), and December (tenth)—no longer match their numerical positions in the modern calendar. March was also dedicated to Mars, the Roman god of war, making it a practical time for military campaigns and civic activities to begin.

When Julius Caesar introduced the Julian calendar in 45 BCE, he officially established January 1st as the first day of the year throughout the Roman Empire. This reform created a more consistent calendar system based on the solar year and helped standardize civil administration.

However, traditions varied, and many regions continued to celebrate the new year on different dates.

The important shift to January 1st occurred in 153 BCE. The Roman Senate decided that newly elected consuls, the highest officials in Rome, should take office earlier in the year so they could respond promptly to military and political challenges. January was named after Janus, the Roman god of doorways, beginnings, and transitions. Janus was often depicted with two faces—one looking to the past and the other to the future—making January a symbolic and appropriate starting point for a new year.

During the Middle Ages, New Year's Day was observed on various dates across Europe, including March 25 (the Feast of the Annunciation), Easter, and December 25 (Christmas). These differences caused confusion in legal documents, taxation, and historical records, as the same date could belong to different years depending on the location.

The issue was resolved in 1582 with the introduction of the Gregorian calendar by Pope Gregory XIII. This reform corrected inaccuracies in the Julian calendar and reaffirmed January 1st as the official start of the year. Catholic countries adopted the change first, while Protestant and Orthodox regions followed gradually.

As global trade, science, and diplomacy expanded, the Gregorian calendar became the international standard. Consequently, January 1st emerged as the universally recognized beginning of the New Year—a date shaped by history, governance, and tradition rather than by natural cycles.

My mother died almost fifteen years ago but as I awoke, I had forgotten that and spent a couple of minutes trying to figure out how to call her back wanting to apologize. Finally, I realized it had all been a dream, but I am still thinking about it.

This whole past week has been strange. My wife, a born Catholic, and I a born Jew spent eight consecutive days lighting Hanukkah candles. Right after lighting the candle lighting, we said a prayer from a flyer handed out at the Chanukkah lighting ceremony in the center of Sierra Madre which occurred last Saturday. What were we doing there? A neighbor invited us to attend reminding us that he had constructed the giant menorah which would be displayed. Okay, so we went and after the lighting we invited him to dinner with us at a newly- opened restaurant across the street. Unexpectedly, he insisted upon paying for all three of us---a very surprising connection!

Anyway, after lighting each candle at home my wife and I pronounced the words phonetically that were written on the paper she had kept. It was important to me not to even read the English translations that also appeared on the page. This leads me to discuss the three books I have recently read which I think are connected to my dream last night and other unusual things I have done in the past pre-Christmas week. The first of the books is entitled ONE LAST THING BEFORE YOU GO –Why You Should Interview Your Parents. Reading that book made me very aware of how much more there is and was to know about my parents, who are both long-deceased, and myself.

The last book I read was entitled THE FINAL SOLUTION by Michael Chabon. What fascinated me was the book cover picture of a giant parrot. Remarkably I failed to take notice of the title of the book which many of you must know was a plan orchestrated by Nazis. The book begins as the boy and the parrot are observed by a feeble 89-year-old man who has lost all interest in talking with other human beings.

I read the book almost to the end before I realized that the old man was probably Sherlock Holmes and that the boy was Jewish and had somehow escaped to England from a Nazi Concentration Camp. Somehow it hit me that “THE FINAL SOLUTION” referred to the plan orchestrated by Nazi Germany during World War II for the genocide of individuals they described as Jews. I reread the book a couple of times each time, becoming more aware of my own arrogance and ignorance.

The other book which has had an influence on me is entitled ISHMAEL authored by Daniel Quinn. It also involves conversations between a man and an animal. This time the animal is a gorilla, and the conversations are about the arrogance and ignorance of “civilized” man who seems on the road to bringing about the destruction of the entire human species. I think that book and the other two have something to do with my dream about an interrupted conversation with my mother in addition to my Chanukkah lighting and attendance. On Sunday, I also marched up and down the Sierra Madre hills doing my best to join in singing Christmas Carols.

What is going on, I think, is that I am becoming aware of my own superficiality and ignorance and am trying to do something about it. There is so much more to experience as a part of our existence than I have ever appreciated. Sadly, I have remained out of touch with the appreciation of fellowship, friendship, community, and shared experiences. For that, I blame my mother. That’s what I wanted to talk to her about. Perhaps it wasn’t her fault, but I wanted to talk about it.

Sometimes language gets in the way of understanding thus the need for parrots, gorillas and reading phonetically. Now I can worry about the coming rainstorm and the potential need to evacuate as that is easier to understand and possibly still to ignore.

## HOWARD Hays As I See It

*Mr. Trump's America will be increasingly blind and blundering, feeble and friendless.” Hillary Clinton*

(Former Naval intelligence officer Malcom Nance posted, “WHOEVER DESIGNED THE TRUMP CLASS ‘BATTLESHIP’ GOT THE DESIGN FROM G.I. JOE.”)

Hardly anyone buys the line anymore that armed, masked federal agents are in our communities to get “the worst of the worst” off the streets. The FBI has been directed to compile a list of “leftist networks”. Views the administration say reflect “anti-Americanism” are deemed “threats to our national security”. White House aide Stephen Miller wants organizations like Act Blue charged with funding “domestic terrorism”. It’s what “Mr. Trump’s America” is all about: armed federal agents ready to act should those exercising First Amendment rights be declared “threats to our national security”, or when those supporting dissenting voices are charged with aiding and abetting “domestic terrorism”.
