With two city council members sitting on Sierra Madre's seven member adhoc Finance Committee, the public had the opportunity to voice their ideas and opinions regarding city finances at a Town Hall meeting last Saturday. The two council members, Kurt Zimmerman and John Buchanan dominated the

dialogue as other committee members remained noticeably quiet throughout the 2.5 hour meeting. Both councilmembers were also clearly opposed to the Police Initiative that, according to critics, if passed will further exascerbate the city's finances.

## "Search 'n Social"

The Sierra Madre Search and Rescue team put on their "Search 'n' Social" event last week, complete with mock rescues, so residents could learn first hand how various rescue operations are conducted, all while eating ice cream complete with chocolate

fudge on top.

The team demonstrated what to do and what not to do, if you're lost hiking. There was also a mock base station set up showing how searches are coordinated. Kids learned "Hug-A-Tree and Survive" program on how not to get lost, how to stay comfortable



if they do get lost, and how to be spotted and found. They were also shown how a car can be pulled up a hill if stuck; some even got to try it out themselves completing the task in only minutes. The Sierra Madre Search and Rescue Team is a 24 hour-per-day, 365 day-per-year, non-profit, all volunteer organization founded in 1951 to save lives through mountain rescue and outdoor safety education. Each team member goes through a rigorous 18 month training which includes getting to know all of local hiking trails as well as winter safety, mountain safety, and wilderness survival. Team members must also become fluent in reading topographic maps before graduating. For more information call (626) 355-3411. 

## 21st Annual Fire Prevention Festival & Open House





## Celebrity Family Useless Information



## Planning Commission and City Council Work On Improved Communications

Despite an agenda that lead some to believe otherwise, improved communications between the Sierra Madre City Council and Planning Commission was to have been the sole topic of discussion at last Thursday's special study session. Councilman Kurt Zimmerman was adamant that the discussions stay focused on communications between the two bodies and not on matters such as the Downtown Specific Plan (DSP) and other development issues. Zimmerman's primary concern was centered around the fact that there had not been sufficient time for public review of those matters to address them during that meeting.

City Manager Elaine Aguilar apologized for any misunderstandings that may have occurred as a result of staff's attempt to list topics where communications had been an issue. Planning Commission Chair Bob Spears also acknowledged that the purpose of the meeting was to work on improved communications.

Each member of the council and planning commission had the opportunity to publicly identify issues they felt would help the two bodies work together more effectively. A feeling among some planning commission members was that too often the City Council had overturned Commission recommendations without the benefit of knowing the basis for the commission's actions. "The Planning Commission must make their decisions based upon the law and the City Council has to consider politics, I get that", said Spears. In response, Zimmerman noted that the council had only overturned two decisions in the last 18 months.

It was clearly stated that neither the council nor the planning commission desired to 'rubber stamp' the other bodies actions. The planning commission, however, expressed a desire to have a representative present when the council voted on their recommendations in order to explain how the decision was reached based upon existing codes and regulations.

Councilman Don Watts, who is officially the liaison between the commission and the council expressed his frustration with the prior administration. Watts felt they had hampered his ability to act out of their concerns

of a alleged conflicts of interest.

The planning commission has had a difficult time with the application of existing codes for a variety of reasons. In some instances, our municipal code and zoning ordinances have become outdated due to changes in State and Federal Laws. In other instances, it was noted, the language is just ambiguous. There are also problems with what Spears describes as "clerical errors, overlaps,

The commission has agreed to use one of their monthly meetings each month to identify such instances. To start they will, "Identify things that we can find grounds to fix easily", and send those recommendations to the council. Spears said the goal of the planning commission was to, "make sure we are very transparent."

## City Manager Set To Resign But Not Before New Heritage Square Developer Is Selected

Pasadena City Manager, Cynthia Kurtz, announced last week that she planned to step down Jan. 8 after holding the position for over 10 years. Kurtz said she first wants to oversee the embattled Heritage Square developer selection process to its end. According to

reports she was the first woman to hold the position in the city's 121 year history. According to Zack Stromberg of the city's Public Affairs Office, Kurtz began her service to the city in 1987 as the capital projects administrator, later in 1991 she became director of the Public Works Department and was then appointed city manager in 1998. She oversees 11 departments, 2,300 employees with an operating budget of more than \$500 million.

"From the beginning, Cynthia offered strong leadership in Pasadena on the Metro Gold Line, which was a strong factor in our success," said Mayor Bill Bogaard. "She has guided the City Council in important decisions including deregulation of electricity, the NFL controversy and the City Hall retrofit project. I regret to see her go, and the City Council and I are grateful for her willingness to continue her service to the city of Pasadena through the Heritage Square developer selection process."

#### Revisiting Heritage Square Bid Award


At the same city council meeting Mayor Bill Bogaard apologized for long delays in the Heritage Square development which many say has taken over a "decade" without any signs of construction. Staff reports state the city acquired a large part of the 10 parcels of property at Fair Oaks Avenue and Orange Grove Boulevard in 2004.

"I regret the delay that has taken place, the loss of decorum that occurred in this chamber, the impression that people were disrespected or insulted. To any who had such feelings, I express an apology," he said as part of the short comment.

Prior to apologizing Bogaard had said," Deliberations on Heritage Square so far have been unusually controversial, and I have friends from the community who tell me they left the Council Chamber on prior occasions with feelings of anger, futility and disrespect, and that others they know had similar feelings."

Although the public comment period had toned down a bit from past meetings, which included taunts, heckling, and shouts of racism, a number of people still demanded that the Bakewell Company, run by local community backer Danny Bakewell Jr., be awarded the project. The Bakewell Company was selected as the clear winner of the bid by the Heritage Square development selection process.

In August Bakewell's partner Century Housing Corporation, said they were no longer interested in moving forward with Heritage Square. However Bakewell



indicated that his company was still interested and would find a new partner. At the time the council voted to end the 60 day exclusive negotiations with The Bakewell/Century Housing Partnership prompting many in the city's Northwest to claim the process was, all along, fixed.

At that time the meeting came to a complete standstill as each member of the council was asked by the public, , to disclose any conflicts council members may have with the current selected developers, Bakewell or others; whether or not any of the counsel's spouses worked for, and would subsequently gain from, another developer being given the contract.

The suggestion was that Bogaard tried pushing for Heritage Housing Partners of which his wife has a direct interest. He later denied any wrongdoing although he had recused himself a number of times in the past on similar matters.

Ishmael Trone, co-chair of the Heritage Square Developer Selection Committee, along with John Kennedy both said they were insulted by allegations that they had manipulated the process to favor the Bakewell Company. Some called the act a counter-productive smear campaign.

The city hired an unnamed Orange County investigator to create a report claiming Bakewell had met privately with committee members. Trone and Kennedy said such actions have now tarnished their reputations. "We have a right to know who asked for this report," Trone said. "None of it is true and no one interviewed us."

Councilmember Chris Holden in August asked for, "a cooling off period," lasting through the council's seasonal September vacation. At the council meeting Bogaard asked that they please move forward.

Kurtz said in a report that after the scope of the project is finalized and the independent financial analysis of the project is done, the chief executive officer be required to review the qualified proposals and return to the community development commission with a recommendation in December. Trone said that if another development selection committee was formed, if asked, he would gladly sit on that committee as well with no hard feelings regardless of which developer was chosen.

## Pasadena Goes To The Dogs As Thousands Descend On This Years Wiggle Waggle Walk

Like something read from a Dr. Seuss book, big dogs, small dogs, some with some spots, some not, some with short hair others with long, but one thing was certain Saturday as they all came together, they were the ones certainly in charge as their masters were simply outnumbered three to one.

And, there were so many dogs that at any given time the sheer number of them taking part in this year's Pasadena Humane Society Wiggle Waggle

Walk stretched for more than a mile around the Rose Bowl. Even though some dog owners only made the 3.1 mile loop by carrying their beloved pets, everyone seemed to have fun. There was also a shorter one mile route around just the front of the Rose Bowl and many opted for



that since the weather was hot.

Pasadena Humane Society and SPCA spokesperson Ricky Whitman said more than 2,000 walkers helped raise in excess of \$237,000 for the animals at the shelter. She estimated that 3,000 to 3,500 dogs were at the event throughout the day. That compared with 1,200 people from around Southern California last year that helped raised \$155,000.

"I would call that a success," she said. "We were even surprised at the large number of people that turned out, it was great. We exceeded way over our fund raising goal." She said prior to the event they had hoped to raise \$2,000, "for the animals."

The Pasadena Police K9 unit held a demonstration and many event goers had the opportunity to meet the specially trained German Shepards. Police said the dogs are trained in Germany before coming to the United States. Many others took part in the event's Family Fun Fair

such as the Kidspace's own mini Wiggle Waggle Walk.

Pasadena Humane Society President and CEO Steve McNall said the shelter was currently at its max caring for more than 10,000 animals from seven cities, including Pasadena, South Pasadena, San Marino, La Canada/ Flintridge, Sierra Madre, Arcadia and Glendale. He said other services they provide include animal control, investigation of animal cruelty and neglect, licensing, adoptions, pet behavior help and training classes. He also said they do outreach and education in several different cities.

McNall escorted the event riding in a new red Ford convertible Mustang as an equestrian unit also started the dogs walking.

The Pasadena Humane Society has 75 employees and over 400 volunteers.

## New Women's Shelter Focus of Zonta Meeting

The Pasadena chapter of Zonta International recently held their monthly meeting featuring a guest speaker from the Union Station Foundation. Sandra Peterson, Director of Program Standards and Evaluation, gave an informative lecture and presentation in which she describedtheprogramsavailable for homeless women in the area. Union Station Foundation is the San Gabriel Valley's largest private agency serving the poor and homeless. Through fundraising efforts of the last seven years the expansion of the center, with the inclusion of a 20-bed women's dormitory, is nearing completion.

"Last Friday we had our open house for our new 20-bed women's dorm," she said. "Up until now we had been housing women and men in the same dorm and were only able to serve about nine women at a time."

Peterson reinforced the urgency for the need of a women's dormitory on the premises, sharing that one of the reasons women choose to remain on the streets, rather than in the shelter, could be due to the fact that they are trying to avoid an environment where they are being "shoved in with the men."

"That was one of our main goals for getting a totally separate shelter," said Peterson.

"So that women could really feel safe and they could have a special place that was their

own."

The most recent Pasadena Homeless Count, completed in 2007, documents that there has been a slight decrease in the destitute population from 1,165 in 2005, to the current number of 969. But, the fact remains that 465 of this total are women and children.

According to Peterson, some homeless women in Pasadena have been living on the streets for over 15 years. The new shelter, which should be operational in the next few weeks, is meant to offer a comfortable environment where they can have a meal, and hopefully open up to case worker in the first steps to socialization. "It has happened in the past, and I guarantee you with this new women's program, it will happen more often," she said.

Aside from the expansion of a women's dormitory the renovation also includes offices for clients to meet privately with case managers, a multipurpose room for classes, support groups and meetings; and expanded food storage and freezer capacity to allow the acceptance of larger donations to the facility.

Being able to write a column for the newspaper since last November has given me a perspective on brush fire safety and how to communicate my concerns with my fellow hillside and canyon dwellers that I would not have had otherwise. Two years ago I came home from a meeting of the Southern California chapter of the Society of American Foresters where I met people from other Fire Safe Council chapters in Southern California and knew that we needed to start a chapter here. Less than a year later we had a column in the newspaper where we were able to get our message out to the community.

Practically every week this past year there has been a fire to talk about because our fire season has never ended. This drought is perhaps the worst in recorded history. Every week there is a message to repeat and repeat again. The homeowner living in the "Very High Fire Hazard Severity Zone" has one thing in the fire triangle (heat, fuel, oxygen) that they can control--Fuel. Create a defensible space around your home through fuel modification in the Home Ignition Zone, and water wisely the decorative plants and big trees to keep them from being a fire hazard on your property.

## Precycling

The subject of precycling was brought up briefly in our article last week entitled, "Trash Free Lunches," but the term itself was not defined. Precycling is making buying choices that support responsible products and packaging which in turn, makes recycling easier and reduces the amount of garbage thrown away.

The following recycling tips focus on supermarket shopping, but the ideas apply to other forms of shopping as well. These are but a few, some off repeated

to other forms of shopping as well. These are but a few...some oft repeated.

1) Avoid the paper vs. plastic dilemma. Durable canvas or string bags are light and convenient to carry and can be used thousands of times. They save an astonishing amount of paper and plastic over time while also saving money.

2) Avoid single-or limited-use items. Don't buy plastic razors, throwaway cleansing pads, cigarette lighters, or foil baking pans. Reduce or eliminate your use of disposable plastic diapers, which account for a startling two percent of total U.S. landfill volume.

3) Compare the size of the package to the size of the product. Do without products like juice boxes for children. They have layers of cardboard, plastic and aluminum and a plastic straw attached. Avoid single-helping packages. Choose products that are not in plastic trays and do not have attached "promotional" materials.

4) Spread the word. Tell grocers, store owners, restaurant managers and others that you are making your buying decisions based on the environmental impact of products. ## PCC Names Honor Student Sean O'Connor As New A.S. Trustee By Dean Lee

Big changes for Pasadena City College as ecological conscience student Sean O'Connor became the newest elected Student Trustee. O'Connor said last month that he planned to make awareness of environmental issues a top priority, something many students said is badly needed.

Currently the school is about as "un-green" as can be worrying many in the student government including former student body president, Natalie Courtney, who said she planed to start a club on campus this semester to address the issue.

PCC has no recycling programs and uses no green power such as solar or wind power on the campus even though a number of new buildings in the last few years have been built. Building upgrades are being done through the 2002 voters approved Measure P General Obligation Bonds giving \$150 million to the school.

Many have questioned why lights in the schools new parking structure off Bonnie Avenue just north of

parking structure off Bonnie Avenue just north of Del Mar Boulevard were never retrofitted solar. The campus has a number of other major projects such as the Campus Center under construction. Courtney said she and others plan to push for green building technologies to be used in the newer structures.

Warren Weber who sat on the Measure P Citizens Oversight Committee said that solar power was not as cost effective as a fossil fuel burning power plant so at the time it was not included in the projects.

Earlier this year representatives from Greenpeace were shocked to find such a lack of understanding at the school as they campaigned for a day about the issue of global warming.

"I intend to facilitate exchanges between the student body and the office of student trustee by actively soliciting input on important campus issues," said O'Connor. "I wish to promote an environmentally conscious campus while guaranteeing economic effectiveness, encouraging activities that foster social networking, and generate a positive ambiance on campus."

O'Connor was born in Frejus, France, a small village on the Mediterranean coast. After moving to Monrovia with his parents in 1996, he attended the Lycee International de Los Angeles, a French American school, for three years. O'Connor then enrolled in a

rigorous home-schooling program. PCC accepted O'Connor into their High School Diploma Program, and he was able to obtain his diploma in 2005 at the

O'Connor took fencing and was a member of Boy Scouts of America. He also enjoyed traveling around the world on vacations with his parents, which allowed him to experience other cultures.

O'Connor said he is honored and grateful to the student body at PCC for electing him student trustee.

After completing one more year at PCC, O'Connor plans to transfer to UCLA, where he hopes to obtain a degree in environmental science.

PCC's Board of Trustees made permanent this summer limited voting powers given to the Student Trustee making the position one of the most powerful in student government in the state.

Last year the Board had given then Student Trustee Connie Chung the limited voting powers after she lobbied for the right to second motion items in front of the board. The issues had been voted down a number of times previously.

Stress. Everybody has it, and everybody goes through it. It's apart of life and there's practically no avoiding it. So if you feel yourself feeling stressed, look at your situation and try to react positively. You can also take a little time out of your day to relax, take a breather. A little meditation couldn't hurt either. Take control of your life and try to manage your stress wisely. Besides, usually, there's no one to blame but yourself, so do yourself a favor a have less stress!



As I write this on the first day of October 2007, two anniversaries swirl around my memory like twin waltzers on a ballroom floor. The first of these is of a Saturday last year at Mt. Wilson, on the last weekend

of October, when I first encountered the editorial staff of this newspaper at an Open House of the Observatory. Somewhere in the course of our tour the question was posed: "Would you like to write a column for our newspaper?" Although I had been a professional writer since 1957, I had never written a newspaper column before, and the idea intrigued me—especially when they said I could write about "whatever excites you." That was an offer I couldn't refuse.

Nearly a year has passed since I began writing "Looking Up," and I've never had a moment's regret. I've found that the weekly exercise of having to write 500-600 words on a topic of my choosing is a kind of aerobic mental exercise—a bit like a stiff hike or an evening of folk dancing would be for the body—and it probably contributes to keeping me young.

Over the past year, my columns have ranged in subject-matter from historical pieces about Mount Wilson Observatory to the latest space and astronomy news—with a few excursions into things like local geology, the joys of stargazing, the seasons, time changes and the nature of time, the excitement of flying, Los Angeles history, and local science/astronomy education. The one thing they all have in common is some connection to the thought of "looking up."

At first, I worried that I might run out of things to say. But, so far at least, ideas have just kept on bubbling up, like water from an artesian spring. Often, as we approach deadline, I will say to my wife, Laura: "What in the world can I find to write about this week?" Usually at that point, we'll go for a walk around the block and talk about it, and before you know it the question is somehow resolved. It always happens—and believe me, writing this column is one of the most fun things I've ever done.

ANNIVERSARY NO. 2 — I mentioned earlier that I've been writing professionally since 1957. It's easy to remember that date because it all started, really, with the launch by the Soviet Union, on October 4, 1957, of the first man-made object to orbit the Earth—a tiny, grapefruit-sized satellite that the Soviets called Sputnik and the international scientific community named "1957 Alpha."

The date of that launch is usually considered the beginning of the Space Age. I also count it as the beginning of my writing career. I had recently been hired by a maker of electrical connectors, Cannon Electric, as a member of their advertising department staff, and they decided to make me editor of a small and languishing publication for customers with the rather imposing name of Cannonade. I was given a lot of freedom to re-shape Cannonade as I liked—and one of the first assignments that came my way was to write an article about how a South Pasadena manufacturer of precision instruments, Boller & Chivens, had built a very-wide-field telescope that was being used to track and photograph the newly launched satellite.

I reveled in the assignment and found that I thoroughly enjoyed the interviewing process (it was a special pleasure to hear the "beep-beep" of Sputnik live on a shortwave radio in the Boller & Chivens office) —and at that point my career as a science/ technology article writer was launched.

I think I can also count October 1957 as the beginning of my career in poetry. Very late one night, not long after the Sputnik launch, I sat down and expressed in the following poem my feelings about the new age that I felt was just then beginning: 1957 ALPHA October 4, 1957

> Somewhere beyond this night's dark boundaries, there Above the farthest fringe Of cirrus gleaming by the Moon's command, And where no earthly thing has ever been Since Earth began, There is, tonight, this strangest work of man. This little ball, hurled up, defiantly, To pirouette around our aging globe And sit in council with the silent stars Has made us all a part Of something vast beyond the mind's conception. We are like children, run away from home: Our hearts, in pride and apprehension, know That home will never be the same again.



planting of trees in March, to increase public awareness of the importance of trees in the city environment, and the popular Holiday Home Decoration Awards in










War in Sicily and Italy 1943-1944





## How Do You Know?

When you get a prescription, or think the thyroid balanced, possibly creating and are facing the shelves and shelves of possibilities, how do you choose the right one? Is it a net positive energy provider making your body "stronger?" Or an additional body stressor that weakens your body's ability to heal itself? tool for taking care of yourself.
In the "alternative" world, most practitioners use some form of muscle testing to "check" for your body/mind/ spirit system's acceptance of a proposed course of healing action. For those who don't use it, there are several reasons ... disbelief and mistrust - of either process or self. This process absolutely requires the "external" practitioner to develop selfcentering in a "calm and opinionless" point from deep inside out, and a willingness to allow this inner body knowledge to be heard, respected and trusted. It can be done many ways ... to and by yourself with thumb-finger pulls, finger/finger strength; to you by someone else, using the finger processes, or other sets of muscles: feet movement, arm testing either standing or sitting ... many different ways.

## Just Off The 210 Freeway

Go a little East on the 210 Freeway to the City Of Claremont and you will be treated to a real "Gem of a Restaurant." Tutti Mangia is in the very capable hands of Chef Hugo Molina; you might remember Hugo from his days as the Chef at the Parkway Grill Restaurant in Pasadena. In fact, Zagat once called Parkway Grill the 'Spago of The East.' That was, of course, when Hugo was running the kitchen.

My friend Steve Knight, of KIEV/KRLA Radio, calls Tutti Mangia sophisticated yet unpretentious, and I agree totally. The room is attractive with original artwork and a small but serviceable bar for a glass of wine or a cocktail.

What to order? While the menu leans toward Italian on my last visit I was very impressed by The Bisteca (Steak), a 12 oz "Sterling Silver" (a rib eye) served with a Barbera Wine reduction. The cow is grass fed to get the marbling of the Steak just right. I started my meal with a garlic soup that I recommend with thumbs up!!! Other entrees to consider are Orecchiette con Pollo - a "Little Ear" pasta sautéed with Chicken and a Romano cream sauce or Risotto con Gamberi Zafferano -Arborio rice sautéed with large shrimps and mushrooms. Desserts are also a plus, with a Blackberry Sorbetto. Many wines by the glass
