# Councilman Buchanan Speaks Out "A SUSTAINABLE FUTURE FOR AN ALL AMERICA CITY"



As the ad hoc finance committee moves toward its recommendations on how to fund much needed additional police compensation and a permanent paramedic program, I wanted to take a moment to reflect on the broader policy consideration that gave rise to the current discussion – that of budget

This issue has been at the forefront of discussions since I have been on the council. Indeed, this is my second ad hoc committee on finances devoted to paying for public safety needs and the discussion we are having now is much the same as before. The one difference is our recently adopted two year budget has made adopted two year budget has made all the more apparent that a day of reckoning is, in budget terms, fast approaching.

This is not to say the city is "broke" right now. We have emergency reserves equal to about 25% of the overall general fund budget and

overall general fund budget and we will be able to pay for existing city services through fiscal year

2008-09. The budget reserves should be 50% for a city our size however. Moreover, the current two year budget has no money for cost of living increases for any of our employees, including our police officers. On the capital portion of the budget, the street improvement program has been suspended and we have no money to set aside for large scale equipment replacement in the Fire department. The paramedic program is only funded for two

What we also know is that at the end of two years current revenue streams will not cover the cost of existing general fund services. Revenue increases (mostly from property tax, utility users tax, and limited sales tax) do not keep pace with the cost of delivering existing services. The cost of those services rises faster than the inflation rate measured by the Consumer Price index, because the cost of city (continued on page 3)



I was sure a little chaotic, funny and touching. There, we created a legacy for the next 100 years of our community's history. Decades from now, our children and grandchildren will pour over that photo and exclaim, "Look how young Grandma was." Or "What funny clothes they used to wear" or think of us as the pioneers. We hope you were a part of that history. That photo will create a new legacy for the next 100 years of Sierra Madre.

# Stabbing Trial Date Postponed

The trial of Ryan Swender 19, Richfield Chang, 25 and Marvin Chang, also 19 who are each accused of attempted murder in the brutal stabbing of an innocent Sierra Madre teen, has been postponed until November 5, 2007.

According to newly assigned Deputy District Attorney Garrett Worchell, the next court date will be a "Pre-trial Hearing", meaning that the actual start date for the trial is still unknown. That hearing will be held in front of Judge Teri Schwartz.

Sources have disclosed that there have been at least two plea offers that were agreeable to two of the defendants. However, the third defendant has insisted on going to trial. Because the defendants are being tried together, all three must agree to any plea bargain.

Delays in bringing violent criminal matters to trial is excruciatingly difficult for victims and their families. In addition to recovering from the wounds, the anxiety of waiting to relive the experience on the witness stand is, as experts on the subject have acknowledged, "unbearable". Speedy trials not only benefit the community, they also mark the beginning of the victims emotional recovery.

Plea bargains, although sometimes unpopular with the public, often help expedite closure for the victims. They are most often used where defendants have prior criminal convictions and a jury trial runs the risk of additional jail time.

The stabbing, which took place in Memorial Park on December 1st of last year, is alleged to have been the result of Swender soliciting the assistance of the Changs (unrelated) to beat up "all the teens in Memorial Park". In testimony at the preliminary hearing, the 'teens' referred to were a group that had been involved and/or present at an argument between Swender and another youth earlier in the day. The victim was not a part of that group.

services is heavily weighted toward things like health care benefits, workers compensation, and pension contributions. In addition capital improvement costs are heavily influenced by volatile energy prices and world-wide demand for basic materials like lumber and concrete. Revenues, on the other hand, have not - and will not - rise at a similar pace.

In sum, these trends are not sustainable even if we add no new cost items to the budget. Yet state mandates for things like environmental compliance and planning updates become ever more complicated and costly and we can expect that to be a continuing fact of life.

For all these reasons we need to act now, before the "day of reckoning" when the fixes will be even more costly and difficult. The council has selected two budget priorities as crucial steps toward sustaining our current level of city services – police pay and paramedics. We cannot continue down a path of negotiations with the police officers union where they demand raises and the city's response is to say, "We wish we could" and hope that operating revenues will show unanticipated increases. (This last year the police officers received a four percent raise and an additional step increase, but we do not have the funds to do it again). This process has resulted in impasse and the imposition of a one year Memorandum of Understanding with no ability to predict where future raises might come from. This is a process fair to no one.

To budget in a sustainable way, we need to identify and put in place a funding stream that allows us to enter into a multi-year agreement with the POA that provides for predictable cost of living increases our officers can count on. The objective financial and legal analysis of the POA's initiative shows it is not the solution. It is too costly and unworkable, and it compromises our independence as a city. Nonetheless it reflects a view I share – if we want to have our own police department (and I most definitely do), we have to pay our officers more than they make now! To budget in a sustainable way we also need a dedicated revenue stream to fund the vital paramedic program it took so long to get and which has already made a material difference in the quality of life for sick and injured residents.

Once these public safety issues are addressed we can then plan for our other city employees and long term capital needs and put Sierra Madre on a sustainable fiscal path. I am confident we can do this. We are an All America city because, at crucial moments, we have looked ahead, seen a need, and banded together to develop solutions as a community. Will the solution here cost a bit more? Yes. But the cost of doing nothing is much greater.



# Pasadena Humane Society Set To Expand

The city council earlier this month unanimously voted to allow the Pasadena Humane Society to expand their facilities. The council in effect is creating a new definition for "Animal Shelter" to be added to City's Zoning Code's Glossary of Specialized Terms and Land Use Type. Planning and Development Department associate planner, Beilin Yu, said the purpose of this amendment is to create a new definition that distinguishes non-profit animal shelters from for-profit animal services. Yu said that to prevent other nonprofit shelters opening in the area, the new zoning will only apply to a small area around the now existing Pasadena Humane Society. For years, the Humane Society has been out of compliance, she said.

The issue came to the council after the Humane Society purchased a property adjacent to their current shelter. The move will increase the total size by 25 percent, extending the facility to Del Mar Boulevard. Under existing city zoning, animal boarding use was not allowed in the area.

Pasadena Humane Society President and CEO Steve McNall said they were still evaluating the new property and would not know the exact uses for the new building for about eight months. However, he did say that the existing shelter was at capacity and un-adopted cats were one of their biggest concerns. He said most likely the expansion would focus on that, as well as expanding parking availability.

Councilmember Steve Madison noted the timing, with the issue coming to them one day after this year's Pasadena Humane Society Wiggle Waggle Walk with more than 2,000 walkers and dogs helping raise more than \$237,000 for the animals at the shelter.

During the discussions, Councilmember Sid Tyler also raised concerns that people in private homes could start breeding animals. Richard Bruckner, Director of Planning and Development Department, said that in certain areas, with a Conditional Use Permit, someone could in fact breed animals. City Manager, Cynthia Kurtz, said that staff would inspect for possible violations involving boarding situations in residential areas.

# JPL 28 Wins Temporary Injunction

A lawsuit, which began when a group of 28 Jet Propulsion Laboratory employees took a stanceagainsttheintrusivepolicies set forth by the U.S. government, since been gaining momentum into the spotlight of judicial scrutiny. The suit claims violation of constitutional rights with the implementation HSPD-12, which is the policy for a Common Identification Standard for Federal Employees and Contractors, set forth by President Bush, post 9/11.

The issue originally came to worldwide attention on Aug. 30, when 28 senior scientists and engineers at the Jet Propulsion Laboratory (JPL is a part of Caltech) filed suit in United States District Court for the Central District of California against NASA, the Department of Commerce and the California Institute of paperwork. Technology (Caltech) on behalf of a class of JPL employees who are being required to waive their privacy rights and submit to an unconstitutional intrusive background investigation in order to retain their jobs with

It has since been a roller coaster ride as far as victories and defeats are concerned. For example, the case was initially defeated on Oct. 3 when, during the hearing in his Los Angeles courtroom, Judge Otis Wright said he was inclined to issue a limited temporary injunction before Oct. 5 in the case of the 28 JPL employees who filed suit against Caltech and NASA over the detailed personal investigations associated with issuing new identification badges for access to the JPL facility. None of the 28 employees do any classified work.

The next day, however, Judge Wright changed his mind. Rather than issuing the temporary injunction he described in court that Monday, he denied the employees' plea for court protection. A few hours later, attorneys for the JPL employees said they would file an emergency appeal of Wright's decision to the Ninth Circuit Court of Appeals in San Francisco.

Caltech had imposed an Oct. 5 deadline for employees to (cont. on page 7)

complete a detailed personal questionnaire and to "voluntarily" a waiver permitting investigators to conduct openended probes into intimate personal background details, including sexual relationships. Employees who did not comply by that date will be locked out on October 27.

Hundreds of JPL employees have taken issue with the background checks. In addition to the 28 plaintiffs, more than 250 employees have signed an on-line statement stating that they completed the questionnaire under duress in order to keep their jobs. Many others are vet to comply with NASA's requirements. As pointed out by Caltech attorney Mark Holscher in a previous court appearance, only 4100 out of 7500 JPL employees and contractors have initiated the required

The women of JPL, some employed for decades, have banded together in a letter writing campaign to Hillary Clinton, Barbara Boxer, Elizabeth Dole, and Diane Feinstein, to name a few. A portion of the letter states, ""We write to you as a community of women scientists and engineers [...] Our mothers' era was marked by the struggle for equal protection under the Constitution. What legacy will we leave our daughters if we

allow those rights to erode?" In a surprise eleventh hour move, on the Oct. 5 deadline, the Ninth Circuit Court of Appeals stepped in, entering an emergency injunction against the National Aeronautics and Space Administration and the Jet Propulsion Laboratory. The Court ruled that NASA could not require JPL scientists and engineers holding non-sensitive positions to sign waivers of their privacy rights. If the Court had not issued this injunction, thousands of scientists would have had to choose between waiving their privacy rights and keeping their jobs.

This temporary injunction will be addressed, again, in the upcoming weeks. JPL employees are not seeking monetary gain from the lawsuit, but are focused

# Moratorium On Condo Conversions In Pasadena Set

The Pasadena City Council recently voted unanimously for a 45-day moratorium on condo conversions. This vote wins a victory for affordable housing advocates who, weeks earlier, had presented the issue as a rising community concern. The moratorium will allow a task force to study the issue and make recommendations for an ordinance on condo conversions, and affirms that there would be no net loss on affordable housing while the task force was reviewing the subject.

The problem of renter displacement makes the issue of condo conversions a major concern for affordable housing advocates. It pushes renters into Pasadena's burgeoning luxury market, which is basically unaffordable for those with very low and low incomes. Community leaders, from organizations like the League of Women Voters, AARP, ACLU, Union Station Foundation and other groups, attended the meeting to offer support and give their experiences with people being displaced from the community.

Several community members described the ordeal of having to move to conditions less than favorable due to being forced out from their homes for a new business venture project. Councilman Chris Holden initiated the idea of a moratorium and task force after considering the course of a project presented to the board weeks earlier by the housing advocates. The project was an apartment building, which had two \$800 rental units and two \$600 rental units, up for conversion with the renters being evicted.

Marvin Shatner, one of the housing advocates, urged the importance "that the composition of the committee we're proposing include representatives from the housing community," he said. "Our concern is not luxury housing or conversion of luxury housing, renting for \$2000 to \$3000 a month. We are concerned with apartments renting below that point. It's a question of fairness to the tenants [who are] being forced out of their homes."

As the council reviewed the motion, one councilman questioned the idea of maintaining the property as an affordable unit, once the property is purchased, because the owner could then resell the unit at market rate. The practice is a tactic of investors trying to make a profit. Cynthia Kurtz, City Manager, also said a practice of reinvesting in the owner's property could result in landlords raising the rents to unaffordable levels if the apartment owners are not allowed to sell their property as condo conversions. The task force would weigh the challenges facing them with this

Shatner believes the "profit-making ability of conversions is so great that some 25,000 rental units in Pasadena would be at risk if you didn't develop some form of control over condo conversions."

Most community members expressed their thanks to the council on developing a moratorium and expected the issue to go beyond its 45-day review. "There are a lot of variables here," said Mr. Segal, a community member in support of the moratorium. "I want to reiterate one thing Marvin Shatner said: We always worry about the fairness to real estate developers. We ought to start worrying about fairness of renters. Renters are important to the community as real estate developers who come in and make their money, and they are gone."

The profile of who gets displaced can be anyone. It is the homeless, who are trying to change their lives, ones attending programs being offered at facilities like (continued on page 6)

# Reporter Gives New Meaning To 'Covering Your Beat' During Jewelry Heist

A reporter for this newspaper did what anyone would do given the situation. After seeing a man running from a South Lake jewelry store Tuesday afternoon with a store employee close in tow yelling, "Stop that thief," she dialed 911 from her cell phone.

Within minutes, three or four motorcycle police were on scene as the store manager of Arnold's Fine Jewelry at 350 South Lake Ave., was giving a description of the

suspect on the reporter's cell phone.

Sales Floor Manager, Pamela Bloem, told police the thief had grabbed \$10,000 in diamonds and other jewels after he requested that a section of diamonds be brought out for his viewing. Police later said the total loss was 14 wedding rings estimated to be worth

"We have only had a couple of instances in our 21 year history but never to this extent," Bloem said. "I thought the police responded quickly."

Before it was all over, a number of police cars also combed the streets with a helicopter overhead looked for a suspect described as being of average height and build, short, almost shaved dark hair, and wearing a long-sleeved gray tee shirt.

Pasadena police spokeswoman, Janet Pope Givens, said police have a description of a man, African-American, between the age of 30 and 40. She said police are asking anyone that might have seen a person leaving the area in a hurried fashion or anything else suspicious, to call the Police Department Detective Section at (626) 744-

The reporter also said she saw the suspect run through the Burlington Arcade behind the 300 block of South Lake Avenue and hop onto a bicycle. A maroon/silver mountain bike was later found abandoned blocks away and reported to police.

The suspect was last seen cycling towards Caltech via San Pasqual Ave. The reporter said police thinks the suspect may have blended in with students on the Caltech campus.

# Abandoned Shopping Carts Still Constitute À Nuisance, City Says

Pasadena's Economic Development Technology Committee on Wednesday night put off directing the city attorney to draft a new zero tolerance law prohibiting shopping carts that are abandoned or remain unattended on private property, city streets, alley, sidewalk or other public right-of-way for an extended period of time.

The committee is made up of council members, Victor Gordo (Chair), Steve Madison, Jacque Robinson and Mayor Bill Bogaard. Robinson was absent. No store representatives were at the meeting and Madison said he thought their input was needed before any decision could be made. Madison stated that by including grocery stores such as Ralph's or Vons, other ideas could surface of which the committee might be unaware. He also said he wanted more input from stores that now use locking devices to prevent stray carts, such as Target. Gordo agreed, and the committee set the issue to be heard again at their next meeting. The committee meets on the 1st and 3rd Wednesdays of each month.

The new ordnance would amend the city's existing Shopping Cart Ordinance which requires retailers providing shopping carts to submit and annually update an abandoned cart prevention plan. Among other requirements, the law holds stores accountable for inventorying their carts, providing a community outreach process, and implementing a mandatory retrieval process if carts are removed from a store or business.

Despite the existing ordinance, city staff said a total of 9,070 shopping carts were picked up citywide last year. Some have criticized the wheel locking systems, saying they lead to a pile-up of carts at store exits. At times,

shoppers have said cars have had to swerve around locked carts left in the street and pedestrians have observed the carts accumulating quickly on sidewalks adjacent to stores. The 99¢ Only Store in the 1700 bock of Colorado Boulevard has a wheel locking system, and at times locked carts impede entering or exiting the store.

Jon Pollard, the city's code compliance manager, said that if a store was required to put in a cart containment system such as bollards, short posts that prevent carts from leaving an area, they could not inhibit disabled persons or the elderly.

"They would have to submit plans to Planning and Development," Pollard said. "If there was any kind of problem they would then be required to put wheel locking systems in instead of the bollards.

According to city staff, the cost of an electronically operated wheel locking system can range between \$5,000 and \$30,000, depending on the complexity and size of the installation.

Pollard said retailers would only be required to install a physical cart containment system if they were issued more than 10 administrative citations in a 30-day period for shopping carts that had been abandoned "off-premises."

According to city manager, Cynthia Kurtz, the costs now associated with city-wide sweeps that target certain areas for speedy removal which includes maintaining a vendor hotline, would all be reduced.

The cities of Glendale,

Monterey Park, Pomona, and Long Beach all have similar shopping cart abandonment laws. Pollard advised, however, that the California Shopping Cart Retrieval Corporation fought vigorously, but unsuccessfully, against Glendale's ordnance. "They view this as essentially, putting them out of business," Pollard said. Pasadena is one of many cities currently contracting with the California Shopping Cart Retrieval Corporation to pick up lost shopping carts.

**Red Flag Warning** -- A **Red Flag Warning** is a forecast warning issued by the <u>United States National Weather Service</u> to tell area firefighting and land management agencies that conditions are ideal for wildland fire ignition and propagation. It is especially common in the hills of California in mid to late summer. After drought conditions, and when <u>humidity</u> is very low, and especially when high or erratic winds which may include lightning are a factor, the Red Flag Warning becomes a critical statement for firefighting agencies, which often alter their staffing and equipment resources dramatically to accommodate the forecast risk. Community opposition to the change in the taxi voucher program brought people out to meet with the MTA about the effects of their revised distribution of taxi vouchers and bus tokens to the public. The meeting, held Oct. 4 at the Altadena Senior Center, was an opportunity for MTA to hear the comments from the public about this change. The change is a shift toward using more bus tokens and fewer taxi vouchers for participating agencies to distribute to its members. This change is a yearlong work-inprogress that has not been finalized. The change is an

alternative solution to the auditor's 2006 recommendation to entirely eliminate the program. According to the auditor's determination, the majority of trips taken by participants did not meet the program's eligibility requirements. While at first glance this issue seems like it is one of low priority for consumers, it has a major effect on the lifestyle of seniors' basic needs.


Prior to changing its distribution process, MTA held a meeting with participating agencies to inform them of the change. The actual distribution of tickets is administered by brokers ILLA and FAME, who distribute the vouchers to the various agencies. However, some agencies received drastic reductions of taxi coupons for their communities. For instance, Pasadena Senior Center's allotment was cut from 1,600 to 100 a month. The Altadena Senior Center did not receive any bus tokens to distribute because they had not been automatically shifted to the program, which would have qualified them to receive bus tokens. So, the Altadena center had to apply to be included in the bus token program. MTA representatives said the cuts should have been a 35% reduction level, and that the centers' distribution cut experiences were too drastic.

Diane Ward, from Santa Anita Family Services, presented a petition from 52 individuals to the representatives at the meeting. A representative from Villa Park communicated the concerns and needs of 20 individuals who did not have transportation to make it to the meeting. Rita, a representative from Mike Antonovich's office, expressed the concern of meeting attendees there that the trial period of study was too long. "Altadena in particular, the typography here has treacherous walking. A young person can't walk the hills. I think you need to consider this point," she added.

Seniors especially valued the opportunity to use taxi vouchers, because most have difficulty walking and standing for long periods of time. The most frequent trips were used to buy groceries. Having to carry several bundles or packages is difficult for the older seniors. Factoring in the inclines of the hills makes the task a much harder and trying challenge. Many people stated that taxi vouchers were great for trips to doctor appointments, and other similar needs.

The voucher and token usage information is reviewed for improvements every three months in all communities. Comments are taken in both Los Angeles County and the San Gabriel Valley areas. Based on what they heard, the MTA representatives offered a direct link to the participating agencies and their users so they can more directly express their concerns in writing about upcoming program changes next year. This was an effort to extend a courtesy, since the taxi representative left the meeting during public comment time before hearing the concerns about the taxis problems from some of the public. One concern was the rejection of taxi voucher service to the Altadena area.

Another meeting will be held in Spring 2008 to hear more public comments before the revised program becomes final. Lance Johnson, a senior from the Altadena Senior Center, made a recommendation that would require the program auditors to walk the routes before the Spring meeting, "to see how far it is and how long it takes to get there," to better understand the challenge of walking in the hills just to reach transportation points. Another gentlemen from the Pasadena Senior Center also expressed concerns about the additional weather challenges facing seniors walking during both summer and winter seasons.

the Union Foundation. Irma was one such person known by Rabbi Marvin Gross . He discussed her challenges with the City Council Monday evening. Irma had been a Pasadenan since she was two years old. She was one of Union Station's success stories, from her arrival there a year ago after finding herself in hard times. When her program ended, she spent the last five months frustrated looking for an affordable apartment. Thankfully, she found a place in North Hills. "That's the issue we have at Union Station. Our people succeed. Then they move out to Lancaster, Palmdale, Las Vegas and wherever it is. They almost never stay in Pasadena," he added.

The face of who gets displaced continues throughout the city. It might be a grandmother who lived with her family in a Section 8 property, now being forced to live on a sister's couch. Or the person could have been one of the quiet tenants living at the Pasadena Athletic Club, now being developed for a new project. Or maybe you were one of the 167 tenants from the Pasadena Manor who had expected to live their life as Pasadenans, now living in San Dimas. Pasadena Manor is

now boarded up and waiting for redevelopment. "We all had to go," remembers Joyce, as she recounted her experience to the City Council members. "It was very stressful for some people... people who have contributed to Pasadena. One lady, writing a book about Pasadena, is now living in a motel where she can hardly pay for food... A man who designed floats. These are people. They aren't wealthy, but they have contributed to this wonderful city that we have. And they have to live in horrible conditions. I think this is horrible for this wonderful City of Pasadena to

Eric Winters, a real estate broker, presented the other side of the affordable housing problem. He said there were some individuals who "wanted to get off the rent treadmill cycle. Low price (properties) are the most difficult to find. The conversion units are the most affordable," he believes, citing that the new condos are the ones that are mostly unaffordable for most first time buvers.

The City Council will formally present the moratorium for publication next week and the moratorium goes into effect seven days after its presentation, and continues for 45 days.

The California Telephone Access Program (CTAP) is a free State program of the California Public Utilities Commission. They can distribute one special telephone per person, at no charge, to individuals

certified as having difficulty hearing, seeing, moving, speaking or remembering and who have phone service where they live. Examples of equipment CTAP loans are amplified phones, phones with loud ringers, speech amplifier devices, large button phones, cordless or speaker phones, anti-stuttering devices, picture phones, and speed/memory dial telephones.

CTAP is currently distributing the ClearSounds 50-ER Emergency Connect Phone. In case of an emergency, this phone has a wrist-watch or pendant style remote control. When the emergency control button on the 50+dB amplification wristband or pendant is pressed, the phone can call your six preprogrammed contact phone numbers. A prerecorded message alerts your contacts of the emergency.\* Call (800) 806-1191 to receive an application or to ask questions about the program and or equipment.

a person's right to privacy outside of the workplace. More importantly, it is based on the constitutional rights that have been violated in order to enact HSPD-12. The suit claims violations of the U.S. Constitution's 4th Amendment protection against unreasonable search and seizure, the 14th Amendment's protection against invasion of the right to privacy, the Administrative Procedure Act which prevents the promulgation of regulations that affect rights without following proper procedures, The Privacy Act that states the Federal government can't pass legislation that invades the privacy of a citizen, and the rights of privacy secured under the California Constitution.

"This is just another example of a host of other unlawful procedures enacted by President Bush, including domestic spying and surveillance, the loss of right to council and the denial of habeas corpus," Attorney for the JPL 28 Dan Stormer said, adding, "It's just another step in the destruction of the Constitution."

The U.S. Court of Appeals for the Ninth Circuit has extended the injunction and set argument on the appeal for the week of December 3-7. The Court stated "Appellants' motion for an injunction pending appeal is granted. Appellants raise serious legal and constitutional questions, and the balance of hardships tips sharply in





# Blamestorming

blamestorming (v): Sitting around discussing why a project failed and who was responsible.

You know those dreaded emails that you get in groups of six from your friends? Well, I actually received one this week that provided the perfect definition and title for my column. Blamestorming. In short talking about it, shifting the blame and basically doing

You see, since July I have had a column festering on the topic of Product Recalls and their increasing frequency. I had not published

it because every week the number and severity of recalls just kept increasing. The food we eat, the toys we give our children, the cars we drive all have been on the recall list this year. The numbers are outrageous – over 173,000 pounds of beef in one recall; 21 million toys from one manufacturer. It seems to me that if you haven't been affected by a recall then you probably live on Mars. Honestly. Even if you grow your own food you may not be protected, there have been recalls of pesticides and tools and equipment. So what is going

In these post 911 days no one wants to even think that it could possibly be an act of terrorism, especially in our food supply. In these days of the increasing rate of autism and other diseases, no one wants to think that the cause could be the result of years of intake and/or exposure to lead. These days, in fact, we don't really want to talk about it. But we should. We need to. It is important for us to know if we are the victims of terrorism or greed and I suspect the latter. And while I realize that we live in a capitalistic society, one driven by the distribution of goods that are determined mainly by competition in a free market, in this country we have lived securely with the notion that the drive for profits would not supercede the standards that we have established to protect us.

When reports of recalls first hit the news, the finger was pointing east. China. It's their fault. They produce lead laden products, they drug our food, they did it.

But, after looking a little closer we find that these Chinese companies were acting per the instructions on our trusted American manufacturers. Have you ever questioned the quality of anything produced by Mattel? So much for blaming the Chinese and companies

Back on our mainland we find all manner of contamination in our food. Fresh or processed it doesn't matter. Some brand names we recognize easily, 'Topps', Kraft, Wegmann's, Campbell Soup (yes, they have a recall of their Chunky Potato Soup w/Cheddar and Bacon Bits – seems the soup has "plastic contaminants"). Other names are obscured in the recall identification process. For instance, with the toothpaste recall the name of the companies that distribute were often published, not indicating the brand name that it was commonly

And what about the companies that knowingly import goods that do not meet US Health and Safety Standards? Personally, I have always been suspicious of some of those bargain items that we often use for decorations. Despite the fact that they have no labeling that warns of the lead content – things like those 99 cent Halloween Pumpkin Pails which look perfect because of their size, for trick or treating. There is an active recall of them because of their lead content.

So what are we doing about all this? Blamestorming and absolutely nothing else. There are some who say that the communications with the American public are getting better. Sure, the Consumer Products Safety Committee is right on it. They are identifying the culprits - salmonella, e coli, lead poisoning. They will tell you who mislabeled the product that you bought that was supposed to be chicken and turned out to be beef. They will let you know who forgot to tell you that eggs are in that processed food, but you already know that because of your allergic reaction. They will also sell you a big political crock that they are doing their job because they have told you about the problem. BUT WHAT ARE THEY DOING ABOUT IT? Just telling us doesn't do a thing. What about being a little proactive here people? How about a little law enforcement?

# Around The Town With Sir Eric Maundry

A hastily prepared and widely circulated official document, published at the most elite levels of local civic authority, sent shock waves through those holding the majority opinion on development here, and concerned Sierra Madreans headed to City Hall October 4th for a rare Thursday evening meeting prepared to do battle. The document, generated by our own City Government, was an announcement for what appeared to be one of the most important meetings in the recent history of Sierra Madre. Bringing both the Planning Commission and the City Council together into one room for the first time in living memory, the official Agenda for this confab proclaimed that such loaded topics as The Downtown Overlay Zone, Commercial Zone permitted uses, Manufacturing Zone, R-1 Zone, applications, covenants, views, Housing Element update, General Plan update, and other planning related issues, would all be up for discussion. In other words, every single divisive issue that has roiled this town over the last half decade was now on the table. And all at the same time! it, and neither did the City Manager. "Who proposed these items?" asked the Councilman. All assembled looked at one another, but none could answer ... After a few folks made largely ineffectual attempts at explanation, Enid Joffe took the microphone. Believing that only she could bring light to these matters, all eyes in the room turned to The Mayor. She took a deep breath and began to speak. But all that came out of her mouth was about the need for all of us to get along, and perhaps the Agenda wasn't all that well thought out, but isn't it nice that all assembled were together and having a nice talk? Some particularly put-out folks headed for the door. Joe Mosca, taking a moment to address the Planning Commission with his most pressing concerns, stated, "And as you know, the RHNA numbers are in!" This, of course, is a reference to the recent SCAG edict that we must prepare ourselves for the construction of 138 "units" (read: condos). It appeared to many in attendance that what Joe was asking the Planning Commission to do was serve as the City Agency that would execute the nefarious deed. Obviously there were no takers for Joe's challenge. ... John Buchanan, a man who feels he is given to moments of great profundity, dropped this golden-throated wonder upon the few still hanging out: "Unanimous votes do not always mean unanimous opinion." Yes, isn't it sad how once laws are passed they just don't do justice to the personal feelings of the lawmakers who sent them on their way? Eeesh. And then a few moments later John delivered one of those statements he's become famous for: "Of course, an economic study will be needed!" Uh oh, somebody hide the checkbook. John wants to hire more overpriced consultants, again. Isn't that how we went broke in the first place? . After this spectacle yours truly was badly in need of self-medicating. Here is the entire opening narration to "The Outer Limits":

"There is nothing wrong with your television set. Do not attempt to adjust the picture. We are now controlling transmission. If we wish to make it louder, we will bring up the volume. If we wish to make it softer, we will tune it to a whisper. We will control the horizontal. We will control the vertical. We can roll the image, make it flutter. We can change the focus to a soft blur, or sharpen it to crystal clarity. For the next hour, sit quietly and we will control all that you see and hear. You are about to participate in a great adventure. You are about to experience the awe and mystery which reaches from the inner mind to ... The Outer Limits."

By comparison, the most frequently remembered opening to "The Twilight Zone" WAS spoken by Rod Serling, and went something like this:

"There's another dimension, not only of sight and sound but of mind, a place of things and ideas, between the pit of Man's fears, and the summit of his knowledge. There's a signpost up ahead, next stop... The Twilight Zone." Regards,

# PLUTO IN SHARP FOCUS BUT OUT OF THE PLANETARY CLUB

Almost 30 years after the discovery of Pluto's large moon Charon, a University of Hawaii astronomer has used a ground-based telescope to take an image of the Pluto system that exceeds the sharpness possible with the

Hubble Space Telescope.

"Several favorable factors occurred simultaneously to yield these spectacular images of the Pluto system," said Dr. David Tholen, who performed the observations during the early evening of September 5 using the adaptive optics system on one of Mauna Kea's twin Keck telescopes. "The natural 'seeing' was better than average that night, more sensitive wavefront sensors were installed on the telescope, and Pluto was at its maximum brightness, thereby giving the improved adaptive optics system more light with which to work its magic," he

The adaptive optics system uses a deformable mirror and sensors that allow it to compensate for turbulence in Earth's atmosphere that normally blurs the light from celestial bodies. The new images, which have a resolution of about 35 milliarcseconds, are about 20 times sharper than the images of Pluto taken 30 years

Altogether, Tholen took 16 images of the Pluto system during one hour on the Keck telescope. When he combined all 16 images to form a single image, Nix and Hydra, Pluto's small satellites discovered with the Hubble Space Telescope in 2005, became clearly visible. The new satellites are both about visual magnitude 23.5 compared with 14th magnitude for Pluto.

Astronomers have estimated that Nix and Hydra are less than 100 km in diameter, compared with 1212 km for Charon and about 2300 km for Pluto. Scientists planning the 2015 flyby of Pluto with NASA's New Horizons spacecraft are intensely interested in the results.

MEANWHILE, CALTECH ASTRONOMER MIKE BROWN also has his sights set on Pluto. He will tell us about it on Sunday, October 28, at 2:30 p.m. at the Altadena Public Library. His talk is titled "HOW I KILLED PLUTO AND WHY IT HAD IT COMING."

For the past seven years, Dr. Brown and his associates have been scanning the skies for planets beyond Pluto. In 2005, after a search of about half of the sky and the discovery of dozens of objects almost the size of Pluto, they finally found Eris, the first object larger than Pluto, and the first that might have been called a new planet. In addition to raising a new avalanche of scientific questions, this discovery drives home the need to answer a question that astronomers have been unwilling to answer for years: "What is a planet?" Dr. Brown will discuss the story of the discovery and give a perspective on why the question of planethood is difficult and why the new class of dwarf planets was created to describe all of

SO, ARE THERE EIGHT PLANETS, OR NINE? The International Astronomical Union has declared Pluto to be officially NOT a planet, but a "dwarf planet." The rebuilt Hayden Planetarium in New York City set up its planetary exhibits with only eight planets—ending with Neptune. In Los Angeles, however, visitors at the newly renovated and reopened Griffith Observatory will find nine planets—Pluto included. Queried about this by Huell Howser in a TV interview, Observatory Director Ed Krupp said, "Pluto will always have a home at Griffith Observatory." # SKIN / Art & Ideas 2007 A Pasadena Festival Oct. 10 - 31, 2007

SKIN is an ongoing jaw-dropping, mind-blowing, Pasadena, California art "happening" of an international level of quality. I am super-proud of my city and really happy to see so much good art! After living in New York for 18 years I confess I had the usual snobbery and did not believe such an art event was possible in CA, and certainly not in Pasadena, but I was proven very much "wrong" and thank God for it!

SKIN is, conceptually, so far above the average citywide art fair. The subject/ issue "Skin" has been meticulously dissected throughout the entire city by our various art, historical and educational institutions, each one bringing a different viewpoint to an astonishingly deep, intelligent (and wonderful) degree. In every instance, the viewpoints were insightful and innovative. Here are but a few of the venues.

At Art Center College of Design, a beautiful campus (especially at night), the exhibition is called "In the Dermisphere" and focuses, literally, on "skin" as in flesh, curated by Stephen Nowlin who did a superb job. There are beautifully rendered figure drawings with absolutely perfect technique by Mark Castanon. There is odd, distorted Photoshop art of human skin stretched over strange forms by collaborators Aziz + Cucher. I confess to usually disliking art that uses Photoshop technique - as it is so often, and so poorly, over-done - but these pieces made arresting use of the technique. There were heartbreakingly beautifully rendered drawings of horses by Tom Knechtel in silverpoint and graphite on paper. In an ingenious piece, real animal skins were layed out side-by-side in a wooden box on loan from the Natural History Museum which allowed to viewer to contemplate on how beautiful and varied the different furs of animals are in themselves -- incredible, really. I could have stood

At the Armory Center for the Arts, contemporary work by artists of color from the Chelsea galleries in New York were flown in for an exhibition entitled "New Images of Identity." The perspective of this show seemed to be "personal/ interpretative" in relation to "skin". As usual with Chelsea work, the art was loaded with ideas which one could not possibly figure out without an encyclopedic artist's statement. I was happy, however, to see a return to painting exhibited in these pieces, and many were very good. The pen and ink drawings of Laylah Ali stood out as exceptional, each one exquisite.

The Armory Northwest compound is literally "alive" with its active metal forge workshop in the back with some beautiful work exhibited by the blacksmiths who work there, a trio of Airstream trailers (my long-time favorite!) ingeniously converted into office space, a school bus transformed into a wood-shop/ classroom for kids (brilliant!), and an airplane hangersized art exhibition space in the grand tradition of the Los Angeles "great" ones. Photographs by the late Don Jim (from his Lavish L series) stole the show.

Other notable venues found different ways to interpret the theme.

Pasadena City College has a fascinating exhibition in their gallery of close-up photographs of soldier tattoos by Mary Beth Heffernan. The college also continues with other events until the end of October, including "What Color is Black: The Invention of Race in Brazil" on October 24th at 8:00 p.m. Go to artideasfestival.org for dates, times and locations.

The Pasadena Public Library has many interesting events, some still to come, including 'The Beauty Backlash" on October 25th at 7:30 p.m. Our libraries have really come through for this festival with so many branches having special exhibitions. Again, dates, times and locations are found at artideasfestival.org.

As beautiful and fascinating as this festival was, the planners also need to be commended for their important work in addressing the importance of the central issue of the subject matter. As Martin Luther King said "All prejudice is evil, but the prejudice that rejects a man because of the color of his skin is the most despicable expression of man's inhumanity

We all need to place roses at the feet of SKIN festival director Terry LeMoncheck and everyone who planned, curated and coordinated this amazing and very relevant event. 
on... Next stop, Olvera Street.

# Kellye Wallett: Pasadena Area Gardens in Watercolor

Kellye Wallett's had a couple of lives and careers. Her lilting, Hawaiian-influenced voice and features are still very identifiable as "Nurse Kellye" to aficionados (like me) of television's M\*A\*S\*H show from twenty some years ago, still in worldwide re-runs today.

Her current "other" life as a water color artist has captured the beauty of some of the Pasadena area's famous gardens and settings. Before LA became her stomping ground, Wallett's renderings of San Francisco waterfront settings were represented by Polk Gallery.

Her "Gardens of Pasadena" collection includes the Wrigley estate/ Rose Bowl headquarters on Orange Grove, Pasadena City Hall's Central Fountain, Descanso Gardens in La Canada and the Huntington Gardens. Others from that grouping immortalize garden scenes and doorways from Descanso Gardens watercolor, less ostentatious, though no less captivating surroundings. Many originals and some gicles from the collection are on permanent loan to the city of Pasadena, displayed during

business hours at the Police Department headquarters across from City Hall at 207 N. Garfield.

Wallett pointed out the location of her Central Fountain perspective, as well as features of the huge renovation project recently completed at City Hall. Her work was previously displayed at City Hall after her one-artist show there a few years ago, but it was felt her work should be displayed in more public accessible spaces, rather than inside city offices, so they were moved to the Police Station.

Several department employees have their own Wallet's art in their work areas as well, and she appears to be a well-recognized, well-loved fixture in the city domains. Our tour of her public display, accompanied by Ronnie De Vries of the Police Department, was punctuated by joyful calls of welcome and recognition here and there, as was an amble through the outdoor walkways of historic City Hall.

Wallett's work "Koi" was chosen as representative of Senate District 21 for the California State Senate's California Contemporary Art Collection, and was displayed in the State Capitol. The same work was chosen for t-shirts and poster use for the LA Marathon during the last Democratic convention held here in LA. Her commissioned painting of the Maguire Gardens at Pasadena's Central Library were incorporated into invitations and lithographs for the New Jersey state reception during that convention.

In addition to work as a water color artist and LA's cherry-blossom festival producer, Wallett is an active volunteer in the public art arena. She holds an appointed Arts Commission position in Pasadena. She mused on the challenges, funding, politics of choosing and building new public art to be into a cohesive representation within the city, as well as efforts and expense to properly archive, preserve and display city-owned art.

One special favorite of mine is her "Domes" work overlooking downtown Pasadena. Wallett told of her ventures up the bell tower of a Pasadena church in order to capture her envisioned perspective. It required not only scaling the bell tower, but a trip up an extension ladder to get just a little more height to achieve

just the right view. The resulting sunset-lit panorama offers the magnificent red-tile roofed City Hall dome in the foreground, with several landmark edifices, reminiscent of an old European city.

If you're tired of the noise, confusion, crowds and parking situation in Old Pasadena yet want to enjoy a positive dining experience, here is my suggestion -Restaurant Lozano in Sierra Madre, where regional California and American dishes are served in very relaxed and pleasant surroundings by friendly servers. Weather permitting, be sure to dine on the outdoor patio with its impressive view of Mt. Wilson in the distance.

What to order for your dinner on your first or second visit? Begin with the Crispy Goat Cheese Quesadilla with a red chipotle sauce (\$10) or Crab Cakes with red pepper aioli sauce (\$12). If you want to begin with a soup, a bowl of Spicy Tortilla soup would be a good way to start (\$7). Ask to have the chef make it even spicier. That's the way I

There are many possibilities from the list of entrees. Here are my tips: Jerk Chicken topped with cilantro-lime cream (\$17), a Slow Roasted Brisket with the house steak sauce and mashed potatoes (\$17) or the Homemade Three Cheese Ravioli with a wild mushroom sauce (\$16). There are also four Mexican dishes available, but I prefer to choose from the many more interesting dishes I found on the menu. The lunch menu lists dishes under \$20, with most well under that amount. A number from the dinner menu are included at lunch with lower prices and slightly smaller portions. 

# New Date For Turkey Tussle Annual PHS vs. Muir Rivalry Will Be Held On Thursday, November 8th



Change your calendars, the date of the Turkey Tussle Football Game, Pasadena High School vs. John Muir High School has been changed.

Previously scheduled for November 9th, Friday, however since the UCLA game that weekend will be held at the Rose Bowl the Turkey Tussle has been moved up to Thursday, November 8th.

This is a rivalry that has been going on for decades. According to the PHS website, "The Turkey Tussle

football game is an annual tradition between Pasadena High School and cross town rival John Muir High School. This tradition began in 1947 when the game was played between Pasadena Community College and John Muir Junior College. These two schools played until 1953. In 1954 the annual rivalry was played between what was now Pasadena High School and John Muir High School.

The winning school takes possession of a ceremonial Victory Bell. One of the highlights for the winning team is to rush to the end zone, celebrating their win, by ringing the Victory Bell. In June 2005, the John Muir campus was burglarized and the Victory Bell was stolen. On February 7, 2006 the Victory Bell was found near a road in the Angeles National Forest." Muir has dominated this event since its inception. Since 1954 when the rivalry between the high schools began, PHS has only won 18 times. The last win was in 1995. 


