The Goldberg family, Milton and Harriet's children-Michael Goldberg and Roberta Goldberg-Braun and grandchildren Rebecca and Daniel Braun also paid tribute to Harriet and Milton. As the official ceremonies were taking place,

local children played on the piles of dirt, just as they have for the last sixty plus years. When the accolades and thanks were done, the Goldberg Family, along with the Mayor and former Mayor John Buchanan, pitched their shovels in the ground and the first tree was planted. 
"Reduced Size Modifications" Possibility For Skilled Nursing Center Project Developer Responds To City's Request

Narrowly making the November 2^{nd} deadline imposed by the city, the developer of the skilled nursing facility, Sierra Madre Land Company, advised City Hall that they intended to proceed with the project and to meet with the city to discuss "reduced size modifications". This declaration was in response to a letter from City Manager Elaine Aguilar which summarized an October 23rd meeting with the developer and city staff. At that meeting, it was confirmed that the project would require "discretionary review" by both the Planning Commission and City Council on issues that conflict with the city's current zoning, Downtown Overlay Zone, Measure V and/or the General Plan.

An all too familiar sight for Sierra Madre has surfaced again - lawn signs pronouncing displeasure with proposed development plans. This time, however, it is neither the Downtown nor the Hillsides, rather, it is the quiet residential community immediately surrounding Alverno High School.







DEVELOPER (cont. from page 1) "Wistaria Village Mixed-Use Project", currently calls for the construction of 55 units ranging from 1 to 3 bedrooms to be built on the property at Sierra Madre

This project, along with the Howie's Market project are the primary reason residents moved forward with Measure V. The initiative, which passed in April, basically prohibits projects that exceed three stories, thirty feet in height and density above 13-18 units per acre from being constructed without voter approval.

And, while the developer has voluntarily stopped any progress on the project pending the outcome of the April election on Measure V, it is primarily the conflicts with other existing codes that are problematic. Specifically, according to the Downtown Overlay Zone and the Municipal Code, the setback along Sierra Madre Blvd. does not meet the minimum requirements and the parking proposed contradicts the municipal code.

In a letter dated October 2, 2007 to the developer from Interim Development Services Directors Anne McIntosh and Donna Butler, Sierra Madre Land Company (SMLC), after articulating the problems with setbacks and parking, they pointed out that the deposit for the EIR had not been paid and that on March 14, 2007 the developer authorized an extension of the certification of the EIR to January 22, 2008. By so doing, the developer waived his right to move the project forward under a state law that penalizes municipalities for dragging their feet on development applications. This has been a major concern of Councilman Watts, who informed the council that the December 9th deadline was fast approaching. The law gives cities one year to process applications once they have been deemed complete. The Skilled Nursing Center Application was deemed complete on December 11, 2006, one day before the council set a date for the Measure V election.

In the October 2nd letter, four courses of action that

could be taken were outlined:

1. The application could "proceed to the Planning Commission with no changes, no environmental impact report and a staff recommendation of denial";

2. The EIR process could be initialized "with payment and authorization to proceed but with no design changes and a possible recommendation of denial.";

3. "Redesign the project to bring it into compliance with the Downtown Overlay Zone (no variances) and proceed with the appropriate environmental review"; or

4. Withdraw the current project and "resubmit a project that complies with Measure V".

In the letter, it is stated that staff would determine their recommendations based upon the "merits" of the submittal.

A meeting between the parties to place on October 23, 2007 at which time they discussed all of the issues facing the existing application. The City Manager requested that the developers inform the city by the end of business November 2nd if they intended to proceed with the project. A response was received late Friday and, according to Aguilar, the Sierra Madre Land Company, LLC, indicated that they would go forward with the project with "reduced size modifications". It was not known at press time what other changes, if any, were to be made.

Racing a Thursday deadline the Ad-Hoc Finance Committee met Saturday morning with residents to once again discuss how to deal with the city's financial problems. By the time the meeting was over, the committee was leaning toward adopting recommendations of doubling the current User Utility Tax from 6 percent to 12 percent. Such an increase would possibly add as much as \$1.5 million to the general fund to pay for, among other things, the pending Police Firefighters Public Safety Initiative. City Manager Elaine Aguilar said raising the Utility User Tax would be the least complicated of the choices. However, such an increase still might not cover the entire budget shortfalls yet requiring cuts in other services such as, the senior center and library.

She said the language in the current UUT is also outdated would have to be revised even if the police initiative was not on the ballot. If the city council chooses something other than the UUT as a means of curing Sierra Madre's revenue problems, Aguilar said the city might have two tax measures to vote on at the same time.

Voters would be asked to update language in the city's current municipal code relating to the UUT as required by law and to vote on whatever tax the councils decides upon in order to generate more revenue for Sierra Madre.

City Attorney Sandra Levin said last week that proposed federal legislation next year could prevent cities from rewriting any new UUT municipal codes thus requiring changes to be made prior to the federal law going into effect.

The expansion plan is part of the Alverno Master Plan as required by the city of Sierra Madre. Any site

that exceeds 1 acre and has development plans

that will be carried out in stages, is required to file a Master Plan and have it approved. According to City Manager Elaine Aguilar, "The plan is typically something that the property owners develop. If the project is over one acre, is phased over time, then the master plan must be filed." Such a plan would also be required should the Monastery decide to develop their land. Even the Congregational Church, which has four separate sites that combined exceed 1 acre have to submit a Master Plan. Aguilar noted that in the instance of both Stonehouse and 1 Carter, no Master Plan was submitted. Aguilar says that those developments would be limited to the one phase currently approved by the city. The Master Plan requirement is part of the 1996 General Plan.

Submittal and approval of the Master Plan without the support of the community, especially those directly impacted by the expansion will be difficult. As with applications for conditional


The Hunkpapas- Scouts Select Coral Y For Service Project



Alzheimer's Association Stages 15th Annual Memory Walk

LOS ANGELES - For the first time in 15 years, Memory Walk is "on the move" to Downtown Los Angeles, it was announced by Peter Braun, President and CEO, California Southland Chapter of the Alzheimer's Association. The historic event is set for Sunday, November 4th and is the first ever Memory Walk that will occur in the heart of the city of Los Angeles. The new route, beginning in The Watercourt at California Plaza, will take the nearly 3000 expected participants past such iconic Los Angeles landmarks as Disney Hall and the Los Angeles Central Library during the approximately two mile walk. Peaceful Protest Targets Military Recruitment Tactics

Several local organizations united on the Pasadena City College campus at noon last Friday, rallying in protest against the war in Iraq while also calling for honesty in recruiting practices from the Marine, Army, Navy and Air Force Center located across the street from PCC.

Participating in the event were members of the American Friends Service Committee, Catholic Worker, Foothills Peace Coalition,

CodePink, ANSWER, and Latinos Against the War. Representing PCC were the clubs, Students for Social Justice and MEChA.

The groups allege that military recruiters prey on students with promises of money for college, sign-up bonuses and professional opportunities, while not sharing that at times these agreements are not always met.

"New recruits into the armed 🃗 services are often misled by enticing promises that recruiters cannot, or do not deliver," said Michael Wisniewski Steven Gibson, LA Program

Director of the AFSC. "Because voluntary military service includes the willingness to sacrifice one's life, this decision should be honored by truthful, accurate recruiting practices."

Another issue is the allowance of recruitment on college campuses. As military recruiters struggle to meet their lagging goals,

community colleges are becoming prime targets for their sales pitches. Community college students are often the most in need of funds to continue and advance their education and recruiters know this, said Gibson.

The legality of on-campus recruitment dates back to 1995 when Congress passed the first Solomon Amendment, denying schools that barred military recruiters from campus any funds from the Department of Defense. The next year, Congress extended the law's reach to include funds from the Departments of Education, Labor, and Health & Human

Services. Defense Department regulations proposed in 2000, and formally adopted in 2002, toughened the law by interpreting it to require revocation of federal grants to an entire university if only one of the university's subdivisions (its law school, for example) runs afoul of the law. In 2005, Congress amended the law to explicitly state that military recruiters must be given equal access to that provided other recruiters.

After the groups convened on the PCC campus, the protest progressed across the street to the front of the recruitment center with the primary goal of shutting the center down, if only for one day.

"Today a group of U.S. citizens have come together as part of their civic duty to speak to the morally wrong methods and practices of military recruiting at this time," said Gibson, addressing the recruiters. "We are opposed to the war in Iraq and we still insist U.S. military recruits be treated fairly, honorably and honestly at all steps in their interaction."

The Army and Navy immediately locked their doors. However, the Marines called the police and attempted to stay open, finally conceding by closing shop later that afternoon.

Their were several speakers who shared the realities of their military experiences, including Agustin Aguayo, who was imprisoned for refusing a second deployment in Iraq. His wife, Helga, announced that on November 5th, he will be recognized as a conscientious objector by the Supreme Court. Other speakers included parents of soldiers in Iraq.

Regarding the protest, the USMC Public Affairs Representative of Los Angeles, Corporal Miguel Carrasco, stated that "even though these incidents happen at several locations it is still our job to look for the best Americans that want to join and serve our country. As Marines, we are glad to provide [the forum] that provides citizens the rights to do as they please."



Sierra Madre Fire Safe Council TIP OF THE WEEK

Until recently it would have been hard to imagine homes burning on the beach in Malibu from a fire that started in the hillsides above. In the early days of forest management it was feared that lumber resources would be lost due to fires that started in neighboring towns.

Today, for the most part the fear of where a fire will start has reversed. A few years ago a forest fire did start in Mt. Baldy village with the explosion of a cabin propane hot water heater. Such accidents can and will happen, but arson is a crime against society that is hard to comprehend. Likewise, youngsters playing with matches causing recent fires in Griffith Park and Agua Dulce make you shudder at the thought of the careless lack of supervision.

Fire Safe Councils were praised for their work by Fire Chiefs in San Diego County. In Sierra Madre, Red Flag Fire Patrols are on the alert during Santa Ana wind storms for arcing power lines and embers flying miles ahead of the fire front, igniting spot fires. All Trails and Forests are closed due to High Fire Danger.

In the Santa Ana wind storms, homeowners have only one thing that they can control: the creating of a defensible space around their homes. Even with all that you can do to prepare, there may be a time in Sierra Madre, as in San Diego and Orange County this October, where you do what you can do and then get out of nature's way.

The next Fire Safe Council meeting is Monday, November 12 at 7 P.M. in the City Council Chambers. Fire Marshall Snyder will be showing a film entitled: The Science of Brush Clearance. "Did You Know?" What A "Waste"

One out of every \$11.00 that Americans spend on food goes for packaging. That figure has virtually remained unchanged since the FMI (Food Marketing Institute) started tracking it in 1986. 30% of all plastics produced are used for packaging, and packaging waste accounts for approximately 1/3 of all the garbage that Americans send to landfills. Roughly 5 million tons-more than half of all plastics we throw away each year- are packaging.

There are some simple things to do to start creating a positive effect on the environment. For starters: * Buy eggs in cardboard-not Styrofoam- cartons. * Most cereal boxes are made of recycled cardboard. Their boxes are gray on the inside. The packaging for many cookies, crackers, dry goods, etc. are also recycled. Look for the "recycled" logo.* Buy carrots, onions, potatoes, etc. loose, and not in plastic bags.* Choose sauces, condiments, baby foods, spreads, etc. that are packaged in glass instead of plastic. * Avoid plastic containers, especially "squeezable" ones, which are made up of different types of plastic in several layers, and are dramatically non-biodegradable.

If 10% of Americans purchased products with less plastic packaging just 10% of the time, we could eliminate some 144 million pounds of plastic from our landfills, reduce industrial pollution, and send a message to manufacturers that we're serious about alternatives.



In a departure from previous seasons, when the Sierra Madre Playhouse presented the very popular stage classics like "The Sound of Music" and "A Christmas Carol" as holiday shows, the selection this year was made for a musical that is

entirely appropriate for the holiday season yet would not be overly familiar to its audience from prior productions.

"Narnia" is a 1986 musical based on the novel "The Lion, The Witch and The Wardrobe" by C.S. Lewis (1898-1963). The Irish Lewis was an atheist in his youth, and fascinated with the more fantastic elements of Norse mythology. At age 31, he converted to Christianity and the Anglican Church, influenced by his close friend, fantasy author and fellow Oxford faculty member J.R.R. Tolkein, a Catholic. Lewis became known as a Christian apologist, whose writings called for an examination of the truth of Christianity through the use of reason. But his most famous work was the series of books collectively known as The Chronicles of Narnia. The books are Christian allegories, but also work as family-friendly straight-ahead adventure stories, so they can honestly be enjoyed by believers and non-

In the stage musical "Narnia", based on the novel "The Lion, The Witch and The Wardrobe," four English children travel through a dimensional portal behind a wardrobe to a different place, the frost-encloaked land of Narnia, where talking animals are common and human are scarce. Narnia is held in the thrall of the evil White Witch. Aslan, a regal lion, is coming, gathering an army to fight the White Witch and her band of vicious wolves and wicked elves. Aslan gives up his life to rescue a traitorous English child in mortal danger, but is soon resurrected, and with power restored and with the aid of the children, marches on to confront the forces of evil once and for all.

Director Alison Kalmus places the narrative within the context of a live BBC radio broadcast in 1940 during the Blitz, adding an additional layer of allegory (Allies vs. Nazi Axis) to the proceedings, and distancing itself from the cuteness of Disney (which released its film based on the story in 2005. The "broadcast" is a dramatic flourish. Ms. Kalmus is aware that the first book in The Chronicles was first published nearly a decade later). The notion of a resurrected hero places the story within a Christian context, but the story elements of the battle between good and evil are accessible to all audiences regardless of religious affiliation. It's a fantasy adventure suitable for the entire family. Unlike most "radio play" stagings, the actors are "off book" (not reading from their scripts), more in the

traditional style of performance. There will be a Foley artist (one who visibly performs sound effects live).

Because of the intense performance schedule (twenty-three performances in a single month), some roles are double or triple cast. The company of players includes (in alphabetical order): Tiffany Brevard, Graham Cranston, Philip D'Amore, Stuart Galbraith, Sarah Gillman, Keith Harmel, Mary House, Corey Lynn Howe, Amy Lim, Johnson Lo, Christopher Loop, Dave McGee, Roberto Merkell, Kelly Myersfield, Sean Peterson, Megan Sanborne, Don Savage, Barry Schwam, James Shechet, Nina Silver, Stasha Sturdyke, Tracy Thomas, Tristan Willhelm and Kenneth Woods.

Assistant director/stage manager: Corey Lynn Howe. Costume design: Lynne Thomas and Liz Peterson. Set design: Don Bergmann and Dave Calhoun. Sound design/Foley artist: Barry Schwam. Properties/Foley assistant: Martha Merkell.

Alison Kalmus directs. She has directed the Sierra Madre Playhouse holiday shows for a number of seasons now. As founder and artistic director of Southern California Lyric Theatre, she draws upon her own operatic background to populate her casts with performers who are vocally trained and have superlative singing voices.

It is anticipated that many of the performances will sell out, so early reservations are strongly encouraged.





Sierra Madre Fire Marshall Rick Snyder Recently Conducted A Training & Demonstration on the Use of Thermo-Gel Homeowner Kits

In the 1993 firestorms that hit the Altadena and Kinneloa areas, the only homeowner retardant products available were foam-based. But foams are easily blown away from the wind created by the fires, and the heat causes the air bubbles to expand and pop, so the protection window is measured only in minutes. "I can't tell you how delighted and grateful I am that Sarah's home was one of those saved, and that her comments support my points about life safety. It's not just that we have to put a cooling break and between our homes and the fires, but we have to BREAK the emotional barriers down that typically prevent people from leaving when they should, and give them the confidence to leave early. That way, many more homes, and lives, can be saved."

MYSTERY COMET EXPLODES INTO BRIGHTNESS


A ONCE-FAINT COMET has made a sudden leap from obscurity to center stage. Comet 17P Holmes, now visible to northern hemisphere residents, increased its brightness by a factor of one million in late October, going from magnitude 17 to 2. This means that it is currently visible to the unaided eye as well as binoculars and telescopes,

offering a unique viewing opportunity for sky watchers.

'This is a terrific outburst," said Brian Marsden, director emeritus of the Minor Planet Center, which tracks known comets and asteroids. "And since it doesn't have a tail right now, some observers have confused it with a nova. We've had at least two reports of a new star." The comet could fade in a matter of days or weeks, so astronomers recommend that viewers take a look now.

Comet Holmes is located in the constellation Perseus and is visible for most of the night. In appearance, it resembles a fuzzy, yellowish star. Sky charts showing where to look for the comet are online at http://www.skyandtelescope.com/observing/ home/10775326.html and http://www.space.com/spacewatch/071025-comet-<u>holmes.html</u>.

Amateur astronomer Edwin Holmes, who was looking at the Andromeda galaxy at the time, discovered Comet Holmes in 1892. The comet has presented a mystery to astronomers ever since. It likely was undergoing a similar outburst when discovered, since it reached 4th magnitude and was faintly visible to the unaided eye. After fading, it brightened again by a factor of 100 in January 1893 before fading again for good.



The comet orbits the Sun once every 7 years at a distance of about 200 million miles (compared to Earth's 93-million-mile orbit). As a result, it was re-observed in 1899 and 1906 before being lost for nearly six decades. Based on a prediction by Marsden, the comet was recovered in 1964.

"Since then, it's been behaving well—until now," said Marsden.

On October 23rd, the comet was a dim 17th magnitude, 25,000 times too faint to be seen with the unaided eye. One day later, it had brightened to 7th magnitude, and the most recent observations peg it at magnitude 2 to 3. (Going from 17th to 2nd magnitude

means that the comet has become a million times brighter. In the brightness scale used by astronomers, the magnitude number is inversely proportional to the brightness, and a change of five magnitudes represents a change of 100 times in brightness.)

"When the Deep Impact probe hit Comet 9P Tempel, there was almost no change in brightness," said Marsden. "This outburst by Comet Holmes is extreme!"

Indeed, the outburst has left experts scratching their heads. How could a tiny comet, whose nucleus is no more than two miles across, grow so bright so fast? Perhaps a crack opened in the comet's surface, exposing fresh ice to the sun and causing an explosive eruption of dust and gas. No one knows for sure. Undoubtedly, professional astronomers will be studying it closely in the weeks to come.

Does Anyone Know What Time It Is?



Twice a year I'm reminded of that □ old Chicago song, "Does anyone know what time it is?" It also reminds me about some things I learned in college. In U.S. History I learned that time zones were devised in the 19th century to make the railroads safer. In Physics I learned about Heisenberg's "Uncertainty Principle" and Einstein's "Theory of Relativity"—that time is very much a function of place and place is very much a function of

Starting in 2007, daylight time begins in the United States on the second Sunday in March and ends on the first Sunday in November. On the second Sunday in March, clocks are set ahead one hour at 2:00 a.m. local standard time, which becomes 3:00 a.m. local daylight time. On the first Sunday in November, clocks are set back one hour at 2:00 a.m. local daylight time, which becomes 1:00 a.m. local standard time. These dates were established by the U.S. Energy Policy Act of 2005, Pubic Law Number 109-58, 119 Statute 594 (2005). They are sometimes called "summer time and winter time". More often they are referred to as "Daylight Standard Time" and "Daylight Savings Time".

It's important to remember that not all places in the U.S. observe daylight time. In particular, Hawaii and most of Arizona do not use it. Now that's confusing. No wonder Californians refer to people from Arizona as "Zonies". And if things weren't confusing enough, in 2006 Indiana suddenly decided to betray its allies in Hawaii and Arizona joining the

rest of us "Standard Timers". See what I mean—Standard Time does sounds a lot like the "Heisenberg Uncertainty Principle" and Einstein's "Theory of Relativity".



What Time is it in elsewhere?

Many other countries observe some form of 'summer time",

but they do not necessarily change their clocks on the same dates as the U.S.

Daylight time and time zones in the U.S. are defined in the U.S. Code, Title 15, Chapter 6, Subchapter IX—Standard Time.

Finally, Coordinated Universal Time (UTC) is a high-precision atomic time standard. UTC has uniform seconds defined by International Atomic Time (TAI), with leap seconds announced at irregular intervals to compensate for the **Earth**'s slowing rotation and other discrepancies. Leap seconds allow UTC to closely track <u>Universal Time</u> (UT), a time standard based not on the uniform passage of seconds, but on the Earth's angular rotation.

Time zones around the world are expressed as positive or negative offsets from ÛTC. Local time is UTC plus the time zone offset for that location, plus an offset (typically +1) for daylight saving time, if in effect.

If I've confused some of you more than you were about time, I apologize. I'm just a writer, not a scientist; my job is to simplify and make understandable the complex and unintelligible. I try my best but sometimes I fail. If you're still really confused, call the physics department at Cal-Tech. I'm sure they can answer the rhetorical question posed by the Chicago song I alluded to earlier—I'm sure they can tell you what time



Healing From The Inside Out

Since Dr. Toru Abo published his book, "Immune Revolution" in 2003, there has been a sea change in health care treatment in Japan, and moving outward around the globe. "Your Immune Revolution," the English translation of Dr. Abo's book, is very readable, taking complex ideas and making them easy to understand. It clearly shows that reaching the root of stress - be it mechanical or structural, emotional / spiritual, or nutritional, is essential for true healing to occur. Someone recently pointed out that



When Buddy Switzer started lining his driveway with pumpkins in 1971, I am certain he couldn't imagine what an impact it would have, especially on a young couple named Doug and Heather Parker who moved down the street a few years later. "We were definitely inspired by Buddy Switzer," recalls Heather. Looking out of her living room window on Halloween one would say that it was a tremendous inspiration. There were several thousand people lined up waiting patiently for the chance to walk the entranceway to her home, view the incredible displays and drink a cup of cider.

On each side of the walkway were pumpkins and squash carved in every conceivable configuration. There was a giant spider whose body was a pumpkin. There was a three tiered water fountain made primarily of pumpkins. There was an oyster shell with pearl - oh - they were pumpkins too. There was also Rupert's Son, 600 lb. squash who never made it to the weight and girth of his 700 pound dad. On the other side of the walkway were the remains of friends of Halloween. A bride and groom and lots of other creepy creatures. There was also a clever ad carved in a pumpkin paying homage to All Quality Painters who did the work on their beautiful craftsman.

The Parkers have lived in Sierra Madre since 1983 and moved to the south side of Alegria. "We knew it was a special street," recalls Heather. It was then that they met the Switzers and the Sutcliff's. Donna Sutcliffe shared with Heather

Donna Sutcliffe shared with Heather and Doug the history of Alegria and the mission of providing "a safe gathering place for her children." And so Doug and Heather joined in. At first they bought their pumpkins but in 1998 when Doug discarded the pumpkins after Halloween in the backyard as mulch and was

surprised when they came up. He had started a crop of "mutant" pumpkins. It is from the descendants of that first crop that the pumpkins used to decorate the Parker home hail.

After his initial luck, Doug studied the art of growing pumpkins. He became somewhat of an expert in the development of Atlantic Giant Pumpkins. His first two weighed 150 pounds and he made the first 'eyes' that adorn his lawn.

Doug and Heather seemed to have perfected the art of how to mesmerize thousands. It takes a lot of work and commitment. In addition to the dozens of huge pumpkins that were transformed, Heather cooked apple cider. They served visitors 85 gallons of cider and over 100 pounds of candy. For years, they used to have a counter to keep track of how many visitors came to the house, however, it finally "blew up around 3,000."

The couple has been married 30 years and have two adult children, Kyle and Kirsten. For Halloween, brother Chris came all the way from Clayton, North Carolina to help Parker carve. It takes about seven hours for each the really big pumpkins. Parker's mom, Joann Parker of Arcadia was also on hand Wednesday night.

You won Me Over!

As reviewes, we like to use words to describe our meals - Scrumptious, Succulent, Superb, never better, and of course "The Best". Restaurants like to use words to describe their dishes - World Famous, Home Made and Fresh!!!! If it is home-made, I think the health dept would have something to say about the chili being made at The Chefs house and if it's World Famous, does that mean when I am in Athens, Greece, The Tour Bus Operator will ask me about the pies at Smitty's? I will digress.

The first few times I went to Houston's I was on the fence. First of all I remember it being a Velvet Turtle many years ago. It's a little dark inside and, man oh man, is it pricey!!! Let me say I think the entrees are on the expensive side, however the wine list is reasonable.

I have dined at Houston's at least ten times in the past year and I have to say that the overall experience has grown on me, to become one of my absolute favorite restaurants in the area at which to dine. Why? I find that the food is above average and the service is stellar (another "S" word) - - - you are greeted and seated, brought water, told the specials, brought drinks and your food, usually by different servers. This Houston's is a well oiled machine.

Let's talk about the food and prices. Let's start with The FAMOUS French Dip (\$18), usually the dish that I order while at Houston's - a Roast beef on French roll and definitely a must try. Barbeque Ribs (\$27) oven baked, comes with fries and cole slaw; rib fans will enjoy these. Are you a sushi fan? There are many choices on the menu and they tell me they sell a lot of sushi. But why go to a steak place for Sushi? When dining with a large party, someone might prefer it. Prices range from \$12 to \$16. I suggest the Seared Tuna Roll at \$16. On my next visit I'll order the Lump Crab Cakes at \$(market); when done right you can never go wrong with a crab cake. The desserts feature a Five Nut Brownie and an Apple Walnut Cobbler at (\$8) - both very sweet and tasty!! In surveying the wine list, I was impressed with Schramsberg at \$9 a glass and a Tantara Chardonnay at \$9 as well.




