Notice of Election Posted

Votes Will Be Cast For 5 City Offices and 3 Ballot Measures Will Be In April

On December 12th and 14th, respectively, Sierra Madre City Clerk, Nancy Shollenberger posted at City Hall, the "Notice of Election" and the "Notice To Voters Of Date After Which No Arguments For Or Against A City Measure May Be Submitted To The City Clerk". The Notice of Election concerns the election of two members of the City Council; the election of the City Treasurer and the election of the City Clerk. All seats are for full four year terms. The Notice To Voters informs the public of the three measures that will appear on the General Municipal Election ballot in April. They are the Minimum Police Wages and Benefits and Prohibition on Staff Reductions or Contracting For General Police Services Without Voter Approval; the Utility User's Tax Increase and Modernization Ordinance and the Utility User's Tax Advisory Measure.

The nomination period for the city offices began December 17th and closes on January 11, 2008. Nomination papers have already been requested by Mayor Enid Joffe and Former Mayor John Buchanan, who are running for re-election to the City Council. City Clerk Nancy Shollenberger is also seeking re-election. Joffe and Buchanan are seeking their second term. Shollenberger, has been City Clerk for 28 years.

Former councilman Bill Tice has also taken out nomination papers for a council seats as well as two new faces on the scene. One potential candidate, an active member of Sierra Madre Residents For Responsible Development during the Measure V campaign, is still contemplating his entry into the race. The other, Thomas Roberts, a 36 year old husband and father, said, "I decided to run for two reasons – I received a notice in the mail that my utility tax was going to increase 6% and because I also received information stating that only 76% of my social security would be available when I am ready to retire."

New Year Brings New Laws

Every January 1st new state and federal laws take effect. This year, the most significant ones deal with the California Department of Motor Vehicles. Below is just a sampling of the changes in the law. For more detailed information, go to *www.dmv.ca.gov*.
There are now limits on the number of times a person can renew a temporary disability parking placard.
There are increases fines for second and third violations related to illegal parking in disabled spaces.
Repeated DUI (driving under the influence offenders) will face stiffer fines and more restrictions.
Smoking with Minors in the car is now illegal. The new law makes it, *"an infraction punishable by a fine not exceeding one hundred dollars (\$100) for a person to smoke a pipe, cigar, or cigarette in a motor vehicle any time a minor is present in the vehicle."*

The Sierra Madre Police Department, with assistance from Day One Pasadena, recently did a random check of the five businesses in the city that are licensed to sell cigarettes. The purpose of the check was to make certain the businesses were complying with all federal, state and local laws regarding cigarette sales, especially laws that prevent the sale of cigarettes to those under the age of 18.

With the assistance of five teen 'decoys', two outlets, Mary's Market and Valero Gas were cited for failure to follow the law. The decoys, who are students under the age of 18, were able to purchase cigarettes, even after displaying a valid school id card in one instance.

According to Chief Marilyn Diaz, at Valero's on Baldwin, the student showed their identification and was still able to purchase a package of cigarettes from the clerk. The business was cited for violation of the municipal code (first offense) and fined.

Mary's Market engaged in three violations. The business, which changed ownership earlier this year, did not have a current license to sell cigarettes; they did not check the identification of the minor and they sold individual cigarettes, which is also a violation of Federal law.

On the other hand, three local businesses, Happy's Liquor's, The Bottle Shop and Highlander Liquors did not sell to the decoys. Each of those businesses were awarded a Certificate from the City for their compliance efforts.

In 2005, Day One, with a grant from the County of Los Angeles, made a similar random check in Sierra Madre. At that time, the local

police were unaware of the 'sting'. "Three of the five businesses that were checked in 2005 were in violation of the law. Now we are down to just two. That is some improvement. Also, none of the businesses that were cited before were in violation of the law this time," said Diaz. "That's progress".

Valero, in an effort to mitigate the fine and show compliance with the city's laws, immediately submitted a plan for training their employees. By implementing it, they may be able to mitigate the fine for their offense.

Day One Pasadena is a community-based nonprofit organization involved in health policy advocacy and community mobilization efforts for alcohol, tobacco, and other drug prevention among teens.





Happy New Year By Rich Johnson

Well, Happy New Year Sierra Madreans, Upper Hastingites, Lower Hastingites, Arcadians, Monrovians, and all the ships at sea. What year is it now? Oh, it's 2008. I have an idea. Let's get all our 2008 New Year's resolutions lined up end to

end and see how far they stretch. Now, next to that line, let's line up all the successfully completed resolutions of 2007 end to end and compare the two lines. Which one is shorter? Hmmmm. Maybe that's not such a good idea.

Instead, let's take a look at the month of January. And so, with the 2008 federal elections looming, let's look for some January-federal government trivia. (Looking, still looking, checking...) Aha! I found something. January, it seems, looks like a popular month for the feds to perform social engineering on a national level. Two intrusions come to mind. First, in January 1974, the increasingly popular President Nixon signed a bill requiring states to comply with a national speed limit of 55 mph. (And some think it was Watergate that did him in. Ha!) This caused most people to slow to 65 mph. The federal speed limit was finally repealed in 1995, which meant the speed limit was raised to 65 mph, which meant people started driving at 75 mph. The gap was longer because, in the 1700s, it took a while to get from home to Washington D.C. 



A New Year's Resolution For Human Rights By Teresa Baxter

In response to recent controversy surrounding the 2008 Tournament of Roses Parade, All Saints Church has chosen to focus its annual New Year's Eve Service on a re-commitment to the United Nations' Universal Declaration of Human Rights. Members of a human rights coalition who oppose the float on the grounds that it celebrates the Chinese government, a government which has historically committed serious human rights violations, will join city officials and organizations that apparently disagree with activists and support the float as a celebration of the Olympic Games. In an effort to create some sort of harmony regarding the issue, the City of Pasadena and Mayor Bill Bogaard did adopt the UN Declaration on Dec.10, 2007, designating it as Human Rights Day on the 49th anniversary that the General Assembly of the UN created and proclaimed the human rights document which part of states,

"Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,

Members of the controversy will be asked to join together in unity on New Year's Eve at All Saints Church, on Monday at 7:30 pm, to reaffirm their personal



commitments to human rights and dignity of all people, a set of principles upon which the entire community can agree, stated Peace and Justice Director of the church, Lori Kizzia.

Members of the Pasadena City Council, Mayor Bill Bogaard, United Nations Pasadena, Amnesty International, Cal Tech Falun Gong Club, Visual Artists Guild and community members will be participating in the All Saints New Year's commemoration of Human Rights.

According to All Saints; prayers, music and candle lighting will be offered in solidarity with those who suffer injustice, violence and famine throughout the world, and will hold up those who commit themselves to working on behalf of humanity in the struggle for universal human rights.

Pasadena's 2007 Five Biggest Untold Stories By Dean Lee

This year ends in just days and, as everybody reflects back at 2007, it's easy to name the big stories of the year. Some are still unfolding as this is written.

As the attention focused on The Heritage president. Square project, City Hall reopening, Youth violence and many other stories like a beam from a high-powered searchlight, here are the biggest stories of the year left in the dark.

1. Speed Limits Unenforceable on Many Pasadena Streets

Pasadena has not surveyed many city streets in at least five years as mandated by law, stated City Manager Cynthia Kurtz in September, taking most of the blame herself for not bringing the issue to council. She said the violation was brought to the city's attention after being challenged in court.

"The courts made it clear that Pasadena needs to get itself back into compliance with state law," she said, adding later, "Once we are put on notice by the courts that the city is out of compliance, we may not send our officers to those streets for enforcement. So it's not that we can give out tickets knowing that some might not be challenged, or some may not go, we are prevented from sending our officers there."

Recommendations were sent back to the Transpiration Advisory Commission and never heard of again. This affects 27 streets throughout the city including Hill Ave. next to Pasadena City College, where Police Chief Bernard Melekian said there was a real fear kids would start drag racing.

2. Pasadena Fire Department Set to Start Toying Around







NATIONAL TREASURE IS FAR FROM A TREASURE....BUT IS IT WORTH NINE BUCKS?

I took my son, Schuyler Jr., to see the new National Treasure movie a few days ago. "Book of Secrets" they called it.

Before I go any further, I should say right off the bat that I'm not a special effects guy. Generally I shy away from films that rely on endless noisy car chases, gratuitous car crashes, incomprehensible electronics, ludicrous technology, and human beings surviving physical calamities that they have no believable or mathematical way of surviving.

Oops. National Treasure: Book of Secrets has all of those things. So I suppose I was a little predisposed to not liking it. But it's also a movie that relies on history. Or rather the magic of history, to inspire young minds and make old heads wonder.

Nicolas Cage plays Benjamin Franklin Gates, historian



and professional treasure hunter, who sets out to prove that his great, great-grandfather, Thomas Gates, was not one of the plotters of the assassination of Abraham Lincoln. His quest turns up a secret code to a treasure map embedded within a recently discovered page of John Wilkes Booth's diary, precipitating several car chases, non-stop technological pyrotechnics, and the pursuit of a lost city of gold possibly buried somewhere below Mt. Rushmore. Oh, brother. If you look for plausible, gritty realism in films, On The Waterfront or Casablanca, this is not.

Little Schuyler, of course, loved the special effects. The chases, and guns, the electronics, everything. (I tried whispering historical tid-bits in his ear whenever I could get away with it, just to balance things out.)

The historical references were wonderful. They made the Civil War come alive. I felt like I was a young buck back at Berkeley---Sky Logan, history major extraordinaire. I also felt a little sorry for the rest of the audience, because some of the history references were pretty esoteric. When they were talking about things like Britain supporting the Confederacy to obtain cheap cotton for textiles or Lincoln's bodyguard mysteriously leaving his post at Ford's Theater or Booth escaping via the one suspiciously unguarded bridge




And that's what it comes down to. Your ability to suspend disbelief.



how much we focus on the possibilities. It seems we, as a society, have lost some of our sparkle for the future.



High Lights In The Dark Of The Year

Angelus Silesius, a German poet who lived from 1624 to 1677, wrote, "Friend, if thou wilt be someone, stand not still. Thou must from one light to another

go." And at almost exactly the same time, in a far different culture, the revered Japanese haiku poet Basho wrote, "Before the light that things give off dies in the heart, it must be expressed."

Clearly, light has a special importance for us humans, and never more so than at this darkest time of the year. And so it seems good to celebrate, as we say good-bye to 2007, a few of the year's bright memories.

FIRST LIGHT. On Nov. 1, Monrovia High School's new 12-inch telescope celebrated its "First Light." At a ceremony in the high school's main lobby that evening, the refurbished observatory was dedicated and given the name "The Juan O. Escaño Sr. Astronomy Research and Education Center." Mr. Escaño's son, Juan O. Escaño, Jr., recruited a number of co-sponsors to equip the observatory, and their joint contributions are valued at between \$250,000 and \$500,000. This makes Monrovia High School one of the best-equipped secondary schools in the United States for astronomy education.

A MILLION TIMES BRIGHTER. In October, a once-faint comet made a sudden leap from obscurity to center stage. Comet Holmes, located in the constellation Perseus, increased its brightness by a factor of one million, going from magnitude 17 to 2. Seeing the comet—a great pale blob as large as a full moon—in binoculars and telescope was a personal "High Light" for me, unlike anything I had ever seen. Even more pleasurable was sharing the experience with students at a university near my home.

ONLY 20 LIGHT-YEARS FROM KANSAS. It isn't Oz, but it could be a new lifesupporting habitat, just 20 light-years away. In April, a team of Swiss, French, and Portuguese astronomers announced discovery of an Earth-like planet with a radius only 50% larger than Earth's, and possibly having liquid water on its surface. The planet, one of more than 200 already discovered around other suns, orbits a small star called Gliese 581.


A STAR'S GLOWING FACE. In May, an international team of astronomers using Mount Wilson Observatory's interferometer array announced that they had taken an image of the surface of the star Altair. This is the first time ever that the surface of a relatively small star, similar to our own Sun, has been imaged. The team used four of the six telescopes operated on Mount Wilson by Georgia State University's Center for High Angular Resolution Astronomy (CHARA). Until now, astronomers could gather tremendous amounts of data from stars, but could not capture images of what stars looked like. Even in the largest telescopes, stars could not be magnified beyond points of light. By combining the light from CHARA's multiple telescopes, astronomers can now zoom in on stars to get high-precision images.

2007 was a good year for those who study starlight. For the rest of us, let's also keep looking up. It stretches not only the back, but the mind as well. A happy (and bright) New Year to all!





decided to do it again for Christmas. When the holidays rolled around again this



A half-century ago, on Jan. 31, 1958, JPL's Explorer 1 became America's first satellite to reach Earth orbit, launching our nation into the space age. "In January 2008 we celebrate the 50th Anniversary of Explorer 1, the first American satellite, which was built at JPL. This is a historic milestone not only for the Jet Propulsion Laboratory, Caltech and Pasadena, but for the country," said Charles Elachi, director of JPL. "I can think of nothing better than kicking off the celebration with a float in the ultimate New Year's pageant, the Rose Parade.


On the parade float, Explorer 1 fires off the launch pad at the center. In its wake arises a collection of historic JPL robotic explorers, as well as planetary ports of call. On one of the solar panels displays a floral "photographic" representation of the Explorer pioneers whose vision ignited the spark for U.S. space exploration – William Pickering, then director of JPL, scientist James Van Allen and rocket designer Wernher von Braun.

Ascending from Explorer's fiery plume are a Martian orbiter and a six-wheeled Mars Science Laboratory, which in 2010 will carry on the tradition of NASA/JPL robotic exploration. On the other edge of the plume, climbing beyond the garland of rings surrounding the planet Saturn is JPL's Voyager 1 - humanity's most distant emissary - which is now on its journey headed into interstellar space.

The 25-foot-tall float is jacketed by everything from black seaweed, eucalyptus leaves, split pea and ground walnut shells to daisies, roses, carnations, chrysanthemums, carnations, strawflower and cut everlasting.


I realize now that the circus didn't come to town after all. Thanks to Galletly, we are the circus.



Let's also keep an eye on Mojito's in Pasadena, Café Beaujolais in Eagle Rock and The new deli UGO's in *Sierra Madre.*


The Worst?
