## Cell Phone Tower Goes On Line

## Wrought Iron Fence a Sticking Point

In a city known for dropped calls, a new cell phone tower should be a welcome relief. Although the actual timeline for completion of the tower is past due, it is up and temporarily using power from the Sierra Madre Rose Float Association building.

The new tower is disguised as a pine tree and located in the city's maintenance yard behind Sierra Vista Park.

The fence was just one of many things that delayed the project. A T-mobile spokesperson had told the

city council last year that the tower would be up by September. The delay, according to Bruce Inman Director of Public Works was also the result of issues over what carriers would be using the tower.

Before the project's final inspection, a wrought iron fence put up Thursday presented a last

some kind of oversight he said.

"When the plans were submitted to the city, you know, nothing was ever said about it," Thompson said. "That's why the points were put there because that's the way they are called for in the plans."

He said the city was worried that someone playing nearby could be hurt.

"Removing the points, the idea is a good one because it is city property," he said. "With all the ball fields around, we don't want one of the small kids climbing up there and getting impaled."

He said the fence can be easily fixed.

"I built the fence myself here in my shop," he said. "If it called for a square top I would have done that. We are going to go and cap the fence so the points are removed."


The cell tower has a three mile, 360 degree signal radius and is receiving acccording signals Thompson.

He also said the tree was made of exactly the same material as artificial Christmas trees, but it is "beefed up" for industrial use and has special UV protection. It has a 20-year life span he added.

Thompson indicated that most of the expressed concern had initially been on the appearance of the artifical tree.

Thompson praised city staff saying they were some of the nicest people he had ever worked with.

"Chris and all the guys over at that yard, you couldn't ask for a better bunch of people to work with," he said. "Helpful and informative, just pleasant all around."

#### Tuesday's Primary Kicks-Off A Busy Election Year

Tuesday's Presidential Primary is just the beginning of a long election year. On Tuesday, voters will be faced with a number of important decisions. In addition to selecting their party's nominee for President, Californians will be asked to vote on seven ballot measures, and in Pasadena and Los Angeles, User Utility Taxes.

All registered voters should have received two voter guides. The principal guide has propositions 91, 92 and 93. The second, supplemental voter guide has Propositions 94, 95, 96 and 96, all of whom qualified for the ballot after the principal guide was printed.

Most voters will decide which way to vote on the propositions based upon who is supporting them. And as ususal, voters need to be careful as to the true meaning of a 'Yes' or 'No' vote.



## Recipe of the Month: **Corn Chowder**

1 Tbs Vegetable oil

1 small onion, coarsely chopped

2 packages (16 oz. each) loose- pack frozen whole-kernel corn thawed, divided

2 cups water

3 chicken flavor bouillon cubes

1 can (12 fluid oz.) Evaporated milk

1/2 cup chopped red bell pepper ½ tsp chopped fresh rosemary

1 Tbs chopped fresh basil (optional)

Heat oil in large saucepan. Add onion; cook, stirring occasionally, until tender. Add 4 cups corn; cook, stirring occasionally until tender. Add water and bouillon; cook, stirring frequently, for 15 minutes or until corn is very soft.

Place corn mixture in a blender or food processor; blend until smooth. Return to saucepan. Stir in remaining corn, evaporated milk, bell pepper and rosemary. Cook, stirring frequently, for 10 minutes or until chowder is thick and bell pepper is tender. Season with salt and ground black pepper, if desired. Garnish with basil. Note: For a Southwestern-style twist to this recipe, add 1 can (4 oz.) diced green chiles with the bell pepper. Eliminate rosemary; stir in 1 tsp chopped fresh cilantro. Garnish with cilantro leaves instead of basil Yields 4 servings (Nestle)

Proposition 92 \$944,000

Establishes in state constitution a system of independent public community college districts and Board of Governors. Generally, requires minimum levels of state funding for school districts and community college districts to be calculated separately, using different criteria and separately appropriated.





# Mayor's Wife Among Those Opposed To Proposed Speed Limit Hikes

Narrowing a list of 28 Pasadena streets down to eleven still out of compliance with state law, the city's Transportation Commission Advisory (TAC) spent most of Tuesday night listening to opposition to raising speed on these streets, and only after these traffic calming measures are put in place should we do the traffic surveys and studies." TAC later agreed and voted on similar concerns.

Others told horror stories about living on Pasadena Avenue and other nearby streets, including South St. John Ave., not on the



Pasadena Avenue next to Huntington Hospital

limits on one of the eleven streets before sending their recommendations to the city council.

Police said they cannot issue seeding tickets using radar or LIDAR (Light Detection and Ranging) out-of-compliance streets until speed limits have been re-established.

Residents opposed to increasing current limits included Claire Bogaard, Pasadena Mayor Bill Bogaard's wife, who is outraged at raising the speed limit by 10 mph, from 35 mph to 45 mph, along Pasadena Avenue next to Huntington Hospital, a number of schools, a park and the Ronald McDonald House at 763 S Pasadena Ave.

Bogaard said she was against "the consideration of raising any speed limits anywhere in the city of Pasadena, especially along Pasadena Avenue."

She also said "there are many traffic calming measures that can be used

list, which was said to be also affected.

"Until you've lived in this area, you really don't realize how bad the traffic is and I believe the premise of what you're saying, that the traffic should be whatever the traffic can bear, is incorrect," said a homeowner on South St. John Ave.

She also said she, along with her neighbors, have had their cars sideswiped a number of times. Pasadena police Lt. Phlunte Riddle, of the city's traffic section, said there had been 13 accidents in that area last vear. None of them resulted in fatalities, however, she noted that most of them were caused by drivers running red lights.

None of those that spoke were from East Pasadena, where the majority of the speed limit increases would be increased, including East WashingtonBoulevard and Riviera Drive, both north of Sierra

Madre Boulevard; Villa Street between Altadena Drive and Sierra Madre Boulevard, and Mountain Street between North Altadena Drive and Hill Avenue.

Above Washington Boulevard, Hill Avenue is also included. All these streets are all set to be raised by five mph.

In other parts of the city West Glenarm Street, Colombia Street and Pasadena Avenue, north of California Boulevard, would also be raised five mph. South of that, Pasadena Avenue would go up the highest of any proposed street to 45 mph.

Only West Drive adjacent to the Rose Bowl would be reduced by five mph and 14 streets throughout the city will remain the same speed.

After voting in favor of sendingrecommendations studying traffic calming measures before rising any speed limits TAC also asked that the police bring back traffic data on the Pasadena Avenue area something they said was not done. Riddle said the street had been out of compliance for at least 10

Calming measures could include road narrowing, different surface materials, crosswalks and unsynchronized signal lights among other things they said.

TAC also voted unanimously in favor of notifying all residents in the effected areas. Their recommendation was to see if there was feedback, and if not, to changes the  $limits to the {\it recommended}$ higher speeds.

Commissioner Julianna Delgado said she thought telling drivers to "go faster," was saying pedestrians were unimportant and was a slap in the face to the city's push to make Pasadena a walking friendly town.

## Federal Funds Wish List includes Parks, Gold Line Extension

The Pasadena city council Monday night approved a three part 2008 federal priorities list that includes, among other things, asking the federal government for \$13.5 million for soundwalls along the 210 freeway and \$15 million for a water system improvement program.

Other earmarked part one city priorities include requesting \$1 million for a transit maintenance facility, \$650,000 for Robinson Park rehabilitation and renovation; and \$700,000 to fund the new Pasadena Healthcare Link.

"We share copies of this with our representatives in Washington," said assistant City Manager Julie Gutierrez. "So it goes to Congressman Adam Shiff, Senators Dianne Feinstein and Barbara Boxer and, as they look at what committees they're on, they know where our priorities are."

She said Carolyn Chaney and Associates has been the legislative liaison services with the federal government for years and provides the information working with those representatives.

Gutierrez said the second part of the priorities included a long list of regional projects including the second phase of the Gold Line extension, possibly out to the Ontario Airport.

She said the extension would ease anticipated traffic buildup in East Pasadena.

Pasadena is also involved in longterm water supply projects, including recharging the Raymond Basin. Recent drought conditions have dropped the groundwater table three to six feet, city staff said. The city has backed efforts by the Raymond Basin Management Board in asking for federal assistance.

The Arroyo Seco Watershed is also on the list, as eight miles of it extends through Pasadena and is considered to be the largest open space area in the city. The city is supporting a feasibility study to look at restoring water resources and an environmental restoration plan for the Arroyo.

Gutierrez said the federal government

had not given money for open space in the past five years, but they hoped to get assistance with the Arroyo through a Master Plan that proposes a number of upgrades to existing Robinson Park. She said the improvements are a part of ongoing efforts to curb youth violence.

We're hoping that a funding source that has been available, although not in the last five years, but previously, may be coming up again," she said about all city parks. "We want to make sure that is a priority for us."

She also said they backed JPL as one of the most important federally-funded economic engines in the area which provides many jobs, although the last part of the federal priorities include legislative concerns about suing NASA regarding Perchlorate contamination of drinking water at the city's Sunset Wells. They proposed creating a trust fund at the Environmental Protection Agency to provide grants to communities affected.

The city's fire and police departments are also currently joining other agencies in a common radio network called Interagency Communications Interoperable System, and they need money for the large capital costs for the program, according to staff.

Other legislative concerns read like a list of the city positions on the presidential debates, including immigration, homeland Security and taxation among other hot political topics.

On immigration, "The city of Pasadena strongly believes that immigrants strengthen the community economically and culturally, and welcomes their contributions to society," the report reads. It also stated that having the Rose Bowl, Rose Parade and JPL all in Pasadena presented, "unique challenges in protecting its citizens from terrorist threats.

During Monday night's meeting, councilmember Chris Holden asked that all the priorities, both state and federal, be put on the city's website, something not yet being done. Everyone agreed it was a good idea and staff said it would be done by the end of the week.

# Controversial Blogger Thrown Out Of Informational Meeting on Measure D

Pasadena Public Information Officer Ann Erdman walked into the City Hall Council Conference Room Tuesday afternoon for a media briefing on the city's controversial Utility User Tax Measure D and simply said "this meeting is not open to the public."

She then gave members of the press two choices, saying those not reporters could leave, or cancel the whole meeting giving both Pasadena Pundit blogger Wayne Lusvardi and political consultant Martin Truitt no choice.

Both left but not before Lusvardi handed out stacks of copied literature opposing the measure.

Copies including the city's own staff reports, a letter from Mayor Bill Bogaard to Barbara Boxer opposing

an extension on the federal moratorium on internet fees, and the transcripts from a lawsuit filed against their group Citizens for Responsible Government that challenged rebuttal arguments for the measure to be placed on the Feb. 5 ballet.

Pasadena Weekly reporter Andre Coleman apologized saying he invited them. He also said neither they nor he meant any trouble and that the two only wanted to hear what was being said. Erdman said she was faithful that what was said in the meeting would get reported fairly through the press.

In a media blast sent Jan. 23 Erdman wrote "There is plenty of speculation, and a fair share of misinformation, about Measure D on the Feb. 5 local ballot, which would update the text in the

Pasadena Municipal Code related to Utility Users

Lusvardi later said he thought he had a right

to stay being a "para-professional blogger"

"Bloggers should be granted access to press briefings as paraprofessional journalists." He said. "That right will have to be gained another day however." He then said measure D was an internet tax something Erdman and other city staff said was untrue.

City staff also handed out information saying measure D only updates the city outdated codes. "Nothing changes and people would not see any immediate change even if the measure did not pass," they said. They also said \$10 million

That sounds so romantic, but let's get real...Sharing a glass of wine with your valentine while enjoying a special meal is more like it. The wine is to be savored during dinnertime conversation while enhancing the tastes of your dishes. Seek out products with a sense of place that use minimal or no inputs and let the vineyards speak for themselves. Fine wines will taste of summer rain on the grapes, the sunlight that fell on the vines and the warm minerals of the soil. Organic and Biodynamic vintages are particularly adept at bringing out this sense of place. Labels to look for:

Organic - Organic vineyards help preserve soil quality, enhance biodiversity and conserve water, ensuring harvests for generations. Note that "100-percent organic" wines must be made entirely from organically produced ingredients, while "organic" wines must be made of 95-percent organic ingredients. Neither of these two varieties may have added sulfites. Wines made with organic grapes have at least 70 percent organic ingredients and can include sulfites.

Biodynamic- Even though biodynamic vintners pay attention to astrological cycles, you won't have to worry that your star sign might not match your wine. Biodynamic standards are older than organic, but very closely allied in their promotion of sustainable practices and elimination of pesticides and synthetic fertilizers. Biodynamic wines, however, can be pricey. (www.demeter-usa.org)

LIVE/Salmon Safe- The Low Input Viticulture and Enology label was put in place to ensure that Oregon vineyards remain disease-free, as they have been historically, while limiting the use of chemical pesticides. LIVE promotes planting of species appropriate to local conditions, reliance on beneficial insects, fungi and plants, and increased biodiversity. "Behind this data are individual kids whose futures depend on them passing the high school exit exam," said Superintendent Edwin Diaz. "I wanted the Board to be assured that each high school and their staff have thought about the consequence of kids not graduating."

Diaz noted that each high school has identified strategies within, and outside, the instructional day with intensive focus and commitment to providing the right type of instruction that needs to take place in order for

the students to pass the exit exam. At this point several PUSD principals were given an opportunity to share strategies for student success.

"We're working on five things right now," said Blair High School Principal Rich Boccia. "Building relationships with the kids, targeting who the students are, embedding our strategies in a regular structural program...with CAHSEE courses throughout the day. This will include one day CAHSEE boot camps that build on skill base and confidence."

Data showed that in the comparison of cumulative CAHSEE passing rates from Nov. 2006 to Nov. 2007, the district wide passing rate for juniors and seniors was increased by 4 percent and 8 percent, respectively. Juniors at Muir High School showed the biggest gain with an 11 percent increase passing the CAHSEE. Blair High School placed highest among seniors, with a gain of 17 percent passing the exit exams in 2007.





## California Proposition 93:

Too Much "Con" Not Enough Pros and Cons

Why not make truth-in-advertising laws apply to political campaigns? Probably because if truth-in-advertising laws did apply to politics, the Federal Trade Commission would have time to regulate nothing else. Take Proposition 93, for example: there's more "con" in the Feb. 5 ballot measure than pros and cons—indeed, you can find more truth in circus side show!

Our state operates on the proposition system. Measures receiving minimum number of signatures are put on the ballot along with the primary candidates and the people have access to direct democracy. While I'm not much of a populist, I think having a limited direct democracy is fine, if not very interesting to talk about.

Proposition 93 is officially billed as "Limits on Legislative Terms in Office." A more accurate title would be, "Expansion on Term Limits for Incumbent Legislators." The limit for most legislators is now 14 years—three two-year terms in the Assembly, plus two four-year terms in the Senate.

Proposition 93 reduces the term limit of legislators from a total amount of 14 years to 12 years. This is 14 and 12 years regardless of which legislative chamber. Then, as a matter of routine, after 14 years in the Legislature, our lawmaker runs for statewide office or moves across the street in Sacramento and becomes a lobbyist. That's the downside of term limits, which helped inspire Proposition 93, the measure that sets the career limit in the Legislature at 12 years, but allows all 12 to be served in either house.

By default, I'm against term limits. I like professionalization in state legislatures. However, I would also like to kick our current legislators out the door, particularly the corrupt leadership of Fabio Nuñez and Don Perata. California just can't afford these

two bozos any longer.

Proposition 93 would also end what the pro-93 ads call the "revolving door" in the Legislature, by "limiting" legislative service to 12 years in either the Assembly or Senate or a combination of years in either as long as they don't surpass 12. Or is it 12 years in the Assembly and then 12 more in the Senate? The language of the measure is vague on this point.

Extending terms limits from six years to 12 in the Assembly and eight years to 12 in the Senate is a worthy idea, but look at the unsavory baggage that goes with it: Forty-two incumbent legislators who are now term-limited out would be allowed to remain in office beyond the current term limits.

That means legislators approaching their limit (e.g. Fabian Nuñez and Don Perata), get to start over. They will then enjoy 12 more years in the legislature. While this bill appears to decrease the terms of legislators, it actually increases them—some to as much as 18 to 20 years in office!

California has consistently been overwhelmingly pro-term limits. All attempts to overturn term limits have failed miserably, much to my displeasure. Therefore, many voters are probably going to be drawn in by this measure. What many of them are going to miss is that this proposition basically resets the number of years each legislator has served, as if they were just starting.

In my ideal world, we would vote this bill down (one that actually increases the terms of legislators, something I would normally support) and then in the future overturn term limits. I also realize the odds of that happening are astronomical. For now I must be content with voting NO ON PROPOSITION

The thought of 12 more years of Señor Nuñez and his compadre Don Perata is just too much to contemplate. It's time to say: enough is enough!

The City of Sierra Madre (City), as the Lead Agency under the California Environmental Quality Act (CEQA), has determined that it will prepare a Draft Environmental Impact Report (EIR) for the Stonehouse Project described below. The City will prepare the EIR in accordance with CEQA, implementing guidelines ("Guidelines"), and City procedures. The purpose of this notice is to advise and solicit comments and suggestions regarding the preparation of the EIR, environmental issues to be addressed in the EIR, and any related issues, from interested parties other than potential Responsible Agencies, including interested or affected members of the public.

The City of Sierra Madre prepared an Initial Study for the proposed project on January 15, 2008 and is currently available for public review. The Initial Study was prepared in accordance with the City's guidelines implementing the California Environmental Quality Act (CEQA). The Initial Study determined that the proposed project may have a significant effect on the environment, and therefore, and EIR is required. Copies of available project materials may be reviewed or obtained from the City address shown above.

**Project Location.** The project site is located at the base of the San Gabriel Mountains within the northeastern portion of the City of Sierra Madre. The 102.56-acre project site, currently known as the Heflin Estate, is located north and west of Stonehouse Road with approximately 400 feet of frontage on the north side of Grand View Avenue. The site is bounded on the north by the San Gabriel Mountains, on the west by residences at the terminus of Camillo Street, on the south by Grand View Avenue, and on the east by residences along Liliano Drive in the northeastern area of the City of Sierra Madre. The northern portion of the site is in natural open space and is contiguous with the undeveloped southern face of the San Gabriel Mountains. The project site is located entirely within the Hillside Management Zone ("HMZ").

**Project Summary.** The proposed project involves the subdivision of 24.67 acres of the 102.56-acre project site into 22 singlefamily lots. The subdivision proposes to use only the lower onethird of the property to create 22 residential lots ranging in size from approximately 15,000 square feet up to 2 acres, two private roads, and a debris basin within the 1989 Hillside Management Zone ("HMZ") boundary. Over two-thirds of the property would remain open space. No homes are currently proposed, however it is expected that the subdivision would eventually be developed on a lot-by-lot basis. Twenty-one new dwelling units will be constructed on the site, resulting in a net increase of 18 units. The project would also require the construction of an earthen debris basin within the 1989 HMZ boundary. It is proposed that the combination debris/ detention basin would be constructed in the canyon east of lot 12 and north of lot 13. This basin would be sized to store a debris potential volume of 18,600 cubic yards, the volume required for

The Heflin House and its associated grounds would be retained and would continue to be accessed from the terminus of the Camillo Street in the west-central portion of the property while the three rental units located downslope near Grand View Avenue would be demolished.

So, Who Won?

By the time you read this column you will may very well know who California selected as Presidential candidates for the upcoming November election. I do not know who is to be (or, from your view, who already has been) selected. Strange isn't it? We all know that when we look at the stars in the sky what we see happening right now is something that actually happened thousands of year's

ago. These celestial events have taken that long to get to us-- it's a very long dial-up time. Anyway, the point is that often what we take as "reality" is actually only our individual and unique immediate perception -- often quite different from the event perceived by others. (Yes, we are participant-creators of our own universe and all that.) This recognition, I think, has helped me to better understand the Presidential selection process and may be get a better handle on the factors behind human decision-making. (Maybe, there's a future for me in advertising?)

Let me try and share my insight. John Edwards has projected himself as a Populist candidate emphasizing the needs of the poor and expressing a willingness to combat the corporate rulers of this country for the purpose of eliminating at least a little of the huge economic disparity that exists in this Country today. His message was not well-received and after he withdrew from the race polls were taken which discovered that Senator Edwards simply was not very popular with economically disadvantaged but was quite popular with upper middle-class Democrats. What goes here? Why do voters consistently make selections contrary to their own economic self-interest. Contrary to most "educated" people, I do not thing the decisions stem from ignorance. I think the answer is found by discovering what perceptions influence the final choice. For educated and fairly comfortable voters John Edwards rhetorical message simply made them feel good. His words created in these people a warm and fuzzy as he spoke of an America that was compassionate and fair and not beholden to its corporate overlords. To some of us that feels good and that good feeling is enough to determine our choice whether it's good or bad for us econimically; it"s more important that we feel good about our country and ourselves. Other people, less economically comfortable people, hear a different message. Edwards keeps talking about the poor and their deprivations and the unfairness inherent within our greedy materialistic society-- who wants to hear this stuff-- life hard enough without focusing on tis negativity. Let me, at least imagine myself being rich and think like a rich person. After all, thinking like a rich person is pretty muck like being a rich person--even if it isn't, it still feels better than thinking of myself as poor and deprived. It's not only the poor who allow themseves to be influenced this way--it's most of us snd it's most of the time. Democrats of my age like to think back to the days of JFK WHEN WE WERE PROUD TO BE AMERICANS (not like now). It was Camelot and the best and the brightest and most valiant knights were venturing forth to do good-- not much good actually happened--you know, the Bay of Pigs and all-- but we all felt good anyhow. Under LBJ lots of good thing happened; important civil-rights legislation happened largely through the efforts of this powerful an comsummate deal-maker; but were we happy? No, we weren't. It wasn't just Viet Nam; it was that LBJ was large and crude and profane and that his wife and daughters were not as elegant as Jackie and the Kennedy clan. Who cares what LBJ actually accomplished--we simply were not as happy.



## Asteroid Made Rare Close Flyby of Earth On January 29

An ASTEROID approximately 800 feet in diameter flew past Earth on Jan. 29, with its closest distance being about 334,000 miles.

Asteroid 2007 TU24 was discovered by the NASA-sponsored Catalina Sky Survey on Oct. 11, 2007. Scientists in NASA's Near-Earth Object Program Office at JPL have determined that there is no possibility of this asteroid ever impacting Earth in the foreseeable future.

"This will be the closest approach by a known asteroid of this size or larger until 2027," said Don Yeomans, manager of the Near Earth Object Program. "As its closest approach is about one-and-a-half times the distance from Earth to the Moon, there is no reason for concern," Yeomans added. "On the contrary, Mother Nature is providing us an excellent opportunity to perform scientific observations."

Asteroid 2007 TU24 reached an approximate apparent magnitude of 10.3 on the night of Jan. 29–30, before quickly becoming fainter as it moved farther from Earth. On that night, the asteroid was observable in dark and clear skies through amateur telescopes with apertures of at least 3 inches. An object with a magnitude of 10.3 is about 50 times fainter than an object just visible to the naked eye in a clear, dark

Just before the flyby, JPL scientists were able to obtain images of the asteroid using high-resolution radar data. Their data indicated that the asteroid is somewhat asymmetrical in shape, with a diameter of roughly 800 feet.

Steve Ostro, JPL astronomer and principal investigator for the project, noted that the radar observations enabled his team to guarantee that the Jan. 29 approach is the closest this particular asteroid will come to Earth until at least the end of the next

The first radar detection of the asteroid was made on Jan. 23, using the Goldstone 230-foot-diameter antenna. The Goldstone antenna is part of NASA's Deep Space Network Goldstone station in Southern California's Mojave Desert. Goldstone's 230foot antenna is capable of tracking a spacecraft traveling more than 10 billion miles from Earth. The surface of this antenna must remain accurate within a fraction of the signal wavelength, meaning that the precision across the 41,400-square-foot surface is maintained within 0.4 inch.

Ostro and his team plan to make further radar observations of asteroid 2007 TU24 through Feb. 4, using the National Science Foundation's Arecibo Observatory in Puerto Rico.

Scientists working with Ostro on the project include Lance Benner and Jon Giorgini of JPL, Mike Nolan of the Arecibo Observatory, and Greg Black of the University of Virginia.

NASA detects and tracks asteroids and comets passing close to Earth. The Near Earth Observation Object Program, commonly called "Spaceguard," discovers, characterizes computes trajectories for these objects to determine if any could be potentially hazardous planet. The Arecibo Observatory is part of

the National Astronomy and Ionosphere Center, a national research center operated by Cornell University, Ithaca, N.Y., for the National Science Foundation.

## The Mountain Clymer

Extraordinary People Extraordinary Places (Part 2)

When I have told others about my blind friend, Daniel Kish, and his outdoor adventure school for the blind, the story has been repeatedly met with curiosity about what it is that he and his students could appreciate about the beauty of the mountains. To many who frequently venture out into nature and spend time close to the Earth, the answer to this question is obvious. But there are those who have seldom ventured far from the comforts of the man-made world, or those who have spent time in the outdoors and, for some reason, have never had the joy of experiencing the power of such places...who have never sat and opened themselves up to feel the energy that flows in and around everything in the natural world. Vision is but one sense that is affected by this kind of beauty...the beauty of nature fills all of the senses completely, as well as the soul. If one of the senses is lacking, then the others just have that much more to absorb. Though I am sighted and am a very visual person (my educational and occupational backgrounds were focused primarily in the visual arts), I also tend to be very aware of what I am feeling and touching, and hearing, and smelling when I am out in nature. There are certain places I have visited that have had a profound affect on me...ones to which I had an immediate and strong connection...places that once I had experienced them, I have carried with me always...places like the Grand Canyon, Table Rock in Sequoia, Muley Point in Utah, Andrew Molera State Beach in Big Sur, the Palm Canyon in Palm Springs. I could go on forever. These are magical places...places of incredibly powerful energy and beauty.

One such place in our local mountains is Manzanita Ridge... While not as majestic and stunningly visually beautiful as some of our grand National Parks, it is a place of a great yet subtle beauty and one of an intense energy that is hard for me to put into words. Manzanita Ridge is the ridgeline that connects the San Olene area at the top of the mountain above the Pack Station (and just to the north of Sierra Madre) to Mt. Harvard (the peak just in front of Mt. Wilson). There is a wide grassy area that runs along the top of this ridge that is filled with wildflowers in the spring. Descending the northern slope of the crest there are towering old pines that densely cover the hillside all the way down to the Winter Creek at the bottom of the canyon. The south-facing slope dips into the thick chaparral of the Little Santa Anita Canyon...from the ridge you can see the Mt. Wilson Trail winding through the brush coming up out of Sierra Madre, and then in the distance, the entire L.A. basin all the way to the ocean. On really clear days in the late afternoon, you can catch the last golden sunlight glinting off of the distant water and can actually see, quite clearly, the twin peaks of Catalina Island and large freighters passing by just off shore. Depending where on the ridge you are, you can either see the peaks of Harvard and Wilson with their impressive collection of towers and telescopes to the northwest, or, if you are on the eastern end of Manzanita Ridge, your can take in a view of Newcomb Pass at the end of the Big Santa Anita Canyon.

At almost any given moment on Manzanita Ridge the sky is filled with red tail hawks and ravens and sometimes if you are lucky, you may even catch a glimpse of the golden eagle who lives somewhere in rocky ledges of the surrounding terrain. The cry of the hawks and the caw and melodic clucking of the ravens fill the air. The breeze is rich with a perfect blend of seasonal scents, green or slightly woody dried grass, the sweet essence of the lupine flowers and Spanish broom, the fresh pine scent from the northern canyon and the scent

of sage wafting up from the chaparral of the southern slope.

On most days the ridge is sun-drenched and breezy. Once, though, I was blessed enough to have ridden my horse up there in a snow squall. We took the San Olene Fire Road up from the station to the eastern end of the ridge. As we headed out the ridge, I looked back at the "Clamshell" area of Monrovia Peak. The dramatic lighting of the storm made the clamshell (or more accurately, a scallop shell) that is carved into the side of the mountain strikingly clear. It was, for the first time, apparent to me how it had gotten its name.

I have often wondered if such places actually were extraordinary places, or if for some reason they just affected me in a special way. I had some light shed on this puzzle by my friend Daniel. He visited the station one day and in the course of conversation, asked me if I had any suggestions for a hike. Having just paid a visit to Manzanita Ridge, and with its tranquility and beauty still resonating in my soul, I asked if he had ever made the journey up there. He told me that he had not and that he was not even sure where it was or how to get there. I expressed to him how imperative it was that he visit the ridge and told him that the easiest route from the station was to head out either the Upper or Lower Winter Creek Trails to where they meet to form the Winter Creek Trail which then heads up out of the canyon. About a quarter mile up the trail from the junction, the trail begins to climb through a series of switchbacks that winds through the pines for a little over a mile and eventually spills out onto the ridge. He decided to go with my recommendation and asked my friend, Dave to accompany him to help him navigate one of the turns I had described, with which he was not familiar. They decided to fit a visit to Manzanita Ridge into a longer hike that they had been wanting to take to Mt. Wilson. My son, Patrick, and Dave's friend, Mick, accompanied them on the journey. The trip was more than 15 miles round trip, and took them the entire day. They returned to the station after dark and totally exhausted. We sat in the store on the front porch of the house and I listened as they told me the whole story of their adventure. Many weekend days ended like this at the station. It was one of my favorite parts of life there...finally getting to sit back and relax on the porch as the weekend visitors headed home and the peace and quiet of the night settled in. I loved the bustle of the station on the weekends, but the mountains always let out an almost audible sigh when the last of the happy hikers drove off the mountaintop.

When they had finished recounting their day, it occurred to me that Daniel had finally gotten to visit Manzanita Ridge, so I asked him what he had thought of it. He told me what an amazing place he thought it was...and how the energy and the beauty of it was palpable and that he planned on hiking there again soon so that he could spend more time on the ridge. This was just the confirmation I was hoping to get from him...proof that what I had been feeling all along was real...that the beauty of all of these extraordinary places is not just in the eyes of the beholder...or even in their ears and their noses...it is something that the heart, soul and spirit behold as well. 





## The Eyes Have It

As I gaze deeply into your beautiful eyes ... what will I see? The eyes are the windows of the soul, you know, and in many

cultures, it is rude, or just absolutely "not done" to look directly in someone's eyes - especially a stranger's - when you are speaking with them. Doing that can create a "connection" that has long-term consequences-inappropriately falling in love 'across a crowded room, for example.

Being in eye contact in this "modern, enlightened, Western culture," however, is

almost a requirement. If we don't look into someone's eyes while we are talking, it is almost a given that that we have something to "hide" ... and don't want the other to So, why would I be talking about eyes right now? Well, for a bit over 20 years, I

have known about the concept of iridology (eye-ri-daw-logy) providing a glimpse into an individual's state of health. There's a story in Dr. Bernard Jensen's seminal book, "Visions of Health: Understanding Iridology" (available through Sierra Madre Books) about changes in an owl's irises during a time of healing. Anyway, in the 20 years since I first read about this, the state of the science and art of

iridology has, of course, advanced - especially since Jensen's passing. Because the iris is now understood to reflect one's genetic inheritance, indicating areas of potential health issues, it is recognized that it is not a "diagnostic" tool. Marks in specific iris locations suggest body systems which would benefit from extra prevention, ensuring you get the right nutrients, keep stressors in balance, etc, etc, ... you've heard it all before. But ... an ounce (penny) of prevention may be worth a pound of cure (thousands of dollars, months/years of time and pain) ...

So if I'm looking inquisitively into your eyes, for what am I looking? Well, there's the obvious color (blue, brown or mixed); surface texture, (fine, looser, with small ellipsoid indentations called lacunae, radii and compression furrows (or stress rings); additional overlay surface colorations / splotches of yellow, orange, or brown; or a blue or white "trim" at outer edge of the iris.


This is a subject that needs graphics, pictures and time to study what's going on. Graphics for basic understanding, eye photos to see actual differences, and time to appreciate the beauty, compare, contrast, analyze, connect with what someone says, and time - at least until deep understanding is achieved. The more you look and correlate, the faster understanding occurs.

If my nearest and dearest would just gaze back long enough, and if I really knew what I was seeing, a simple glance could be enough. However, right now a swift glance won't do it. I need at least a magnifying lens and small flashlight. To take photos for an "in absentia" study, one needs reasonable lighting (flashlight and steady hand), 6+ million megapixel camera with "macro lens" to capture details. Then good photo software; blowing the photo up to about 5 or 6" diameter helps a lot. Time to study, to compare what one sees against the "maps" of the iris. Since the iris presents a genetic pattern, only the depths and colors inside the lacunae,

or the overlay color splotches / colorations intensity and size might change. Thus the human iris changes very slowly; if an iridologist is already part of your health support team, having photos taken once a year ought to be enough. To see changes in ongoing chronic situations, fingernail alterations are more informative; in acute situations,

watch the tongue. Tongue colors, textures and shape can change in as short a time as a day (or less) as a situation is corrected. Oops, something else that we haven't paid much attention to either, I'll bet. Each is a personal language offering to share their stories from the inside out, if we can only learn to ask and understand them as they are told.

So, take a chance ... as I gaze into your beautiful eyes ... what would I see?



Fry wings for 10 minutes or until golden and crispy.


Toss chicken wings with desired amount of mustard and ale sauce and serve. Makes 24 wings.



I majored in History at Berkeley. I minored in Journalism. I've passed all the teaching credential exams. Ergo, I suppose it was an unavoidable chunk of my destiny that I would one day write some sort of column with

the intent of educating a large number of data-hungry sports nuts about some fascinating aspect of Sports History, in order to scratch all three itches

That day is today.

I have selected, for the subject of our lecture, a discussion surrounding the most terminally unheralded, generally under-worshiped, and historically under-appreciated athletes in each of the six major sports (And no, I do not consider either soccer or hockey a major sport.).

Quiet please, pay attention. Class is now in session.

**Baseball:** I give you Smoky Joe Wood. You'd think with a nickname like 'Smoky Joe" he'd get more love, but I bet you've never heard of him, huh? ## Weird Weather Wreaks Havoc on Santa Anita By Brad Eastland

The gods must be angry.

In an amazing, incredible, virtually unprecedented development, Santa Anita officials were forced to cancel live racing for both last Sunday, January 27th as well as Monday the 28th, making it an astounding seven days since January 5th that the Arcadia track has been forced to scrap its live product due to massive drainage problems caused by heavy rains. Seven days lost in less than a month. Millions of dollars of revenue lost for good.

These are sobering statistics, seeing as how most veteran racegoers---including this reporter---simply cannot recall a single day of racing being canceled due to weather during the entire decade of the 70s, or the 80s, or 90s.

But to blame the elements for the track's poor drainage is sort of like the man blaming the burglar because he himself left the door open. Santa Anita's muchballyhooed synthetic racing surface, their heralded, brand new "Cushion Track", is the culprit. Or, more specifically, the sand---the heavy, fine silt contained within the synthetic mixture, which absorbs too much water and makes drainage a nightmare. A nightmare making the track itself unsafe for horses and riders alike.

Ironically, Santa Anita's decision last year to replace

the traditional dirt track with a synthetic track was made primarily because it promised to be the safer option.

Bad luck for a sport plagued by huge fall-offs in attendance for over a decade.

Case in point: from January 25th through January 28th, Santa Anita was able to present live racing on only one of those four days. Fortunately that day was last Saturday's 5th annual Sunshine Millions program, a whopping 28,414 race-starved fans showed up, and the program was a huge success. "To be able to have this kind of day with all the uncertainty we had leading into the weekend is very encouraging. We want to thank our fans, horsemen

a day we'll never forget," Santa Anita President Ron Charles declared recently.

The track is working tirelessly to solve the problem. A new polymer and binder mixture is being integrated into the synthetic surface to improve drainage. "We need to get the season rolling again and finish strong, and this new fiberbased product will help us to do that," says Mike Willman, Santa Anita's Director of Publicity. "The fibers encapsulate the existing silt with wax, so that the water can slip by and drain out naturally, rather than get hung up in the sand."

The almost-daily track flooding and last-minute resultant cancellations

have produced some strange, Hollywoodesque scenes. For instance, the only customers in attendance two Fridays ago, during some of the heaviest rains, were die-hard bettors determined to take advantage of simulcast wagering at other tracks. These are the true track loyalists. Yet the sight of just a few hundred patrons wandering the huge compound---a storied, venerable racing institution used to accommodating tens of thousands---was still a shock to veteran horseplayers and long-time track regulars.

It was the eerie equivalent of a race-track ghost

However, where there is despair there is hope. Willman is confident that this new "Pro-Ride" polymer binder and fiber mixture will improve the drainage and save the day. "It absolutely will enable the Cushion Track to drain the way it was designed to drain. We've tested it, and we're confident."

But in the meantime, the track needs your support. If you're looking for a fun fresh outing, come on out to Santa Anita Park and catch some live racing. It's a couple of bucks well spent. Put a couple more bucks down on a beautiful animal's chances and your heart will throb and your palms will suddenly dampen. When they ring the bell and spring the latch on the starting gate, your vision will blur as your mouth goes dry. And then, finally, you'll find that when the field




