### On The Ballot: Sierra Madre City Council

On the General Municipal Election ballot in April, Five candidates are running for City Council. Two of the candidates are incumbents, Enid Joffe and John Buchanan; One candidate, MaryAnn MacGillivary has previously served on the council. One candidate, Bill Tice, has waged two previous campaigns for a seat and Kevin Paschall, who is running for the first time.

#### CANDIDATE "EAGLE" BILL TICE:

"I Really Like To See Things Work"

This year's Municipal Election won't be the first time Bill Tice's name will appear on the ballot. A former Tree Commissioner and resident of Sierra Madre for most of his adult life, Eagle Bill has decided once again to throw his hat into the ring hoping that the third time will be a 'charm'. "I love this city. I would be a dedicated councilman", says Tice in a recent interview. Tice feels that changes must be made in the way the council operates, starting with the "Show 'N Tell" that each council member goes through at the start of meetings. He also would like to see the council bring closure to items brought before them. He cited the incident on Hermosa last year where the parents of a child who was nearly hit by a car asked for a stop sign/ and or speed bump. "All they had to do was put up a stop sign", says Tice. Instead, nothing was done.

Although he wants to see changes, he speaks well of the jobs that the City Manager, Elaine Aguilar, Community Services and Personnel Director Michelle Keith, whom he says "solves problems", and the Public Works Director, Bruce Inman are doing. But he says, "We've lost some good people at City Hall this year, too", referring to the recent departure of Steve Pock from the Planning Department. Tice also speaks highly of Councilman Zimmerman and "will probably vote the same way he does." A familiar sight at the microphone during council meetings, Tice takes any criticism of him in stride. "When I am away, they miss me."

Bill credits himself with being one of the residents who started the campaign against 1 Carter. In fact, it was that protest that earned him the nickname of "Eagle" Bill. During the protest he gave other like minded citizens an Eagle pin, a symbol to remind people of the wildlife habitat that would be destroyed.

Although he does not like raising taxes, he supports Measure U, Sierra Madre's User Utility Tax initiative.

Another concern Tice has is regarding building restrictions in areas other than the hillsides. "I'd like to see set backs and height limits in the other residential areas."

A very spiritual man, Tice and his wife Yoko have resided in the city since 1979. They raised two sons in Sierra Madre. He says marriage and family make you pause for reflection. While speaking of his religious beliefs he added, "I'd like to see prayer at the council meetings. He calls the current council, "secular humanists".

'Eagle' Bill Tice is running his own campaign without any frills. For additional information contact him at 626-355-4678.



### SIERRA MADRE VOLUNTEER FIREFIGHTERS BACK MEASURE U

At its monthly meeting on Wednesday, the Sierra Madre Volunteer Firefighter's Association voted to support Measure U, also known as Safety Measure U, and then in a second vote decided to contribute \$2500 to the committee formed to help pass the measure.

"It is essential that this measure pass" said Battalion Chief Bob Burnett, who was asked to speak to the members about Measure U by SMVA President Bill Messersmith. Burnett, a member of the Safety Measure 4 U committee, noted that without the Measure, there is currently no funding in place for the City's Paramedic Program beyond 2009, as only the program's first two years of operation were funded by the City's recent sale of a Fire Station in the Sierra Madre Canyon.

Members of the Association also signed up to walk the City to help educate voters about the measure, or to place signs in their yards in support of the measure.

Messersmith, who co-chairs the "Safety Measure 4 U" committee with Sierra Madre Police Officer John Ford, had asked the group to consider making a substantial contribution to the committee, and the motion by Burnett to contribute \$2500 was passed unanimously. With its donation, the SMVFA became the pro Measure U committee's largest single donor. Most of the previous donations to the committee had been made by Committee members.

The Committee will use the funds to pay for lawn signs, campaign brochures, a website which is currently in development, and other costs associated with the campaign. The election at which the measure will be placed before the voters will take place on April 8th.

Measure U has received unanimous support of the sometimes divided City Council, which voted 5 – 0 in December to place the initiative on the ballot, and which worked together to craft the "Argument For Measure A" that will appear on the Sample Ballot. There was no "Argument Against Measure A" submitted for inclusion on the sample ballot. The Measure has also been endorsed by the Sierra Madre Police Officer's Association, which has withdrawn its support of an initiative that it had previously placed on the ballot, in order to back Measure U.

Also at the meeting, the SMVFA approved a donation to the Mt. Wilson Trail Race Committee, and a donation to again fund a summer Children's Program at the Sierra Madre Public Library.

### Recipe of the Month: **Corn Chowder**

1 Tbs Vegetable oil

1 small onion, coarsely chopped

2 packages (16 oz. each) loose- pack frozen whole-kernel corn thawed, divided

2 cups water

3 chicken flavor bouillon cubes 1 can (12 fluid oz.) Evaporated milk

1/2 cup chopped red bell pepper

½ tsp chopped fresh rosemary

1 Tbs chopped fresh basil (optional)

Heat oil in large saucepan. Add onion; cook, stirring occasionally, until tender. Add 4 cups corn; cook, stirring occasionally until tender. Add water and bouillon; cook, stirring frequently, for 15 minutes or until corn is very soft.

Place corn mixture in a blender or food processor; blend until smooth. Return to saucepan. Stir in remaining corn, evaporated milk, bell pepper and rosemary. Cook, stirring frequently, for 10 minutes or until chowder is thick and bell pepper is tender. Season with salt and ground black pepper, if desired. Garnish with basil. Note: For a Southwestern-style twist to this recipe, add 1 can (4 oz.) diced green chiles with the bell pepper. Eliminate rosemary; stir in 1 tsp chopped fresh cilantro. Garnish with cilantro leaves instead of basil Yields 4 servings (Nestle)

### 2008 Wistaria Festival Countdown Docents Committee Chair Named


Lisa Spigai-Perez, who teaches at Sierra Madre School and who also sits on the Board of Directors for the Sierra Madre Chamber of Commerce, the Community Arts Commission, and the Mt. Wilson Trail Race Committee, has been selected to Chair the Docents Committee for this year's Wistaria Festival.

Spigai-Perez, known for emceeing the City's Halloween Costume Contest each year, and for doing an "unbelievable" job of announcing the Mt. Wilson Trail Race. She and former Docent Chair Halcyon Koerber are working together to make sure this year's event runs as smoothly as year's past. More than four thousand people are expected to view the vine on Sunday, March 30th, and a crew of nearly sixty docents, many of them veterans who return year after year, will be on hand to educate the crowds about the world's largest blossoming plant, as certified by the Guiness Book of World Records.

Town Historian Phyllis Chapman will again lead a day of training for the volunteers, many of whom are Sierra Madre Civic Club members, teaching them the finer points of the history of the vine and the festival. Nearly two dozen Civic Club members have already signed up for this year's event, with nearly six weeks still to go. Also among the volunteers are usually several members of the City Council, students from local high schools, and members of several other local organizations, including The Friends of the Sierra Madre Library, The Woman's Club, Kiwanis

Spigai-Perez will oversee operations at the two properties on the day of the event, but will also spend numerous hours on the extensive planning that will take place before then. Along with many other duties as the Docent Chair, she will meet and coordinate with the two property owners to make sure everything is done to their satisfaction, recruit volunteers, position docents at several points of interest throughout the properties, coordinate the selection, acquisition and placement of floral arrangements throughout the grounds, make sure each docent has their "information sheet" designed to answer any question viewers might have, coordinate several shifts of volunteers, set up and tear down the informative posters, and generally make sure everyone has a good time. #### Salle Alumnus, Jeff Jahnke Helps Create Foundation for College-Age Cancer Patients.

Pasadena, CA - Imagine you are a young, healthy, vibrant, carefree college student, and all of a sudden your world shatters around you when you are diagnosed with cancer. Now imagine how you are going to pay your college tuition and mounting medical bills, let alone balance your treatment schedule with your course schedule. But this is not a fantasy. This is exactly what happened to one of Jeff Jahnke's friend during his sophomore year at the University of San Diego. In the fall of 2005, Jeff's Delta Tau Delta fraternity brother was diagnosed with Stage III-B Hodgkin's Lymphoma. In order to help their brother and show their solidarity, Jeff and his fraternity brothers organized a head-shaving auction in front of the University Center on USD's campus and raised more than \$4,000 for their brother. When Jeff and his fellow fraternity brother, Scott Chesrown, saw the success of a simple head-shaving event, they were inspired to take their cause to the next level. Jeff remembers the two of them thinking, "If we were this successful helping one person, imagine what we could do for other undergraduates affected by cancer across the nation." Both Jeff and Scott knew that they needed to make themselves a legitimate organization in order to get serious money behind their initiative and thus, "Bleed Purple" was born, (Purple is the official Fraternity Color). Beginning in the spring of 2006, Jeff was the man behind the pen throughout the application process to make Bleed Purple a 501c3, a tax exempt organization. It was a lengthy and time consuming process but, when Scott handed him Bleed Purple's 501c3 certificate in November 2006 Jeff was ecstatic. He thought, "A year ago we were shaving heads in front of the University Center and now we are an official non-profit organization. We can really take this big and make a difference!"

Upon receiving non-profit status, the founders of Bleed Purple at USD wrote a letter to the Delta Tau Delta International Fraternity Headquarters in Fishers, Indiana, about their organization and how it was created by Greeks for Greeks on an undergraduate level. They outlined how chapters across the nation could get behind it because everyone knows someone who has been affected by cancer. It just so happened that Delta Tau Delta International was in the planning stages of their Sesquicentennial Celebration and was looking for a Fraternitywide community service project that could be undertaken by chapters across the nation. They agreed that Bleed Purple was the perfect fit. Currently, every single Delt Chapter across the nation is working on a campaign to support Bleed Purple and a goal of \$150,000 has been set for 2007-2008. Jeff is excited about this national endeavor and is anxious to see Bleed Purple grow and flourish. He knows this period of time is for spreading awareness and raising money but he can't wait to get back to giving out money to deserving cancer patients. "Right now we need to get the word out about our cause to cancer victims on college campuses across the nation. It is great that everyone is raising money for Bleed Purple but it's not complete until we can get the word out so that those with cancer know where they can go to get help," Jeff said.

Looking back, Jeff is the first to admit that service wasn't something he did or thought about doing before he entered La

Salle as a freshman in the fall of 2000. "Participating in Founder's Week and the service I did through my religion classes is what got me out into the community doing service, and I realized that a lot of people need help. The Lasallian motto, Enter to Learn-Leave to Serve kept going through my mind and service became one of my values, one of my maincore principles. It was something I wanted to do on my own time, not because I had to do it for a class." Jeff believes had he not gone to La Salle and been encouraged to participate in service and seen the difference that just one person can make his leadership behind Bleed Purple would not have come about. "My

La Salle experience set me on the right course to think about how big this organization, Bleed Purple, could get and how many people could be helped."

The City of Sierra Madre (City), as the Lead Agency under the California Environmental Quality Act (CEQA), has determined that it will prepare a Draft Environmental Impact Report (EIR) for the Stonehouse Project described below. The City will prepare the EIR in accordance with CEQA, implementing guidelines ("Guidelines"), and City procedures. The purpose of this notice is to advise and solicit comments and suggestions regarding the preparation of the EIR, environmental issues to be addressed in the EIR, and any related issues, from interested parties other than potential Responsible Agencies, including interested or affected members of the public.

The City of Sierra Madre prepared an Initial Study for the proposed project on January 15, 2008 and is currently available for public review. The Initial Study was prepared in accordance with the City's guidelines implementing the California Environmental Quality Act (CEQA). The Initial Study determined that the proposed project may have a significant effect on the environment, and therefore, and EIR is required. Copies of available project materials may be reviewed or obtained from the City address shown above.

**Project Location.** The project site is located at the base of the San Gabriel Mountains within the northeastern portion of the City of Sierra Madre. The 102.56-acre project site, currently known as the Heflin Estate, is located north and west of Stonehouse Road with approximately 400 feet of frontage on the north side of Grand View Avenue. The site is bounded on the north by the San Gabriel Mountains, on the west by residences at the terminus of Camillo Street, on the south by Grand View Avenue, and on the east by residences along Liliano Drive in the northeastern area of the City of Sierra Madre. The northern portion of the site is in natural open space and is contiguous with the undeveloped southern face of the San Gabriel Mountains. The project site is located entirely within the Hillside Management Zone ("HMZ").

**Project Summary.** The proposed project involves the subdivision of 24.67 acres of the 102.56-acre project site into 22 single-family lots. The subdivision proposes to use only the lower onethird of the property to create 22 residential lots ranging in size from approximately 15,000 square feet up to 2 acres, two private roads, and a debris basin within the 1989 Hillside Management Zone ("HMZ") boundary. Over two-thirds of the property would remain open space. No homes are currently proposed, however it is expected that the subdivision would eventually be developed on a lot-by-lot basis. Twenty-one new dwelling units will be constructed on the site, resulting in a net increase of 18 units. The project would also require the construction of an earthen debris basin within the 1989 HMZ boundary. It is proposed that the combination debris/ detention basin would be constructed in the canyon east of lot 12 and north of lot 13. This basin would be sized to store a debris potential volume of 18,600 cubic yards, the volume required for



### The Race In Brief Stage 3

#### Race Kicks Off to Enthusiastic Crowd in Palo Alto

The 2008 Amgen Tour of California started on a high note Sunday in Palo Alto when World Champion Fabian Cancellara (SUI) of Team CSC bested a world-class field containing nine World Champions to claim victory on a fast, flat course lined shoulderto-shoulder with cheering fans. The enthusiastic crowd cheered on the cyclists as they made their way from downtown Palo Alto to Stanford University.

Completing the 2.1-mile course with a record time of 3:51.21, Cancellara will begin day two of the race wearing the yellow Amgen Leader's Jersey when Stage 1 takes the riders from Sausalito to Santa Rosa on Monday morning.

#### Stage 1

Record crowds were on-hand Monday for Stage 1 from Sausalito to Santa Rosa, culminating with a climactic finish in downtown Santa Rosa as Juan Jose "J.J." Haedo (ARG), of Team CSC, sprinted to an impressive win, his fifth stage win in the Amgen Tour of California (2006-2008), ahead of Gerald Ciolek (GER), of High Road, and Heinrich Haussler (GER) of Gerolsteiner.

"The final 60km (40 miles) of the race were very fast; I barely made it to the finish. That was a really hard part for me," said Haedo, Stage 1 winner. "Everyone was really fast today, but when you see the last 200 meters, you go as hard as you can and don't look back. We have a lot of good sprinters in the Amgen Tour of California, really a good level of competition."

#### Stage 2

The second stage saw the emergence of a young star in Tyler Farrar (USA) of Slipstream Chipotle Presented by H30 and the return of old warrior in Mario Cipollini (ITA) of Rock Racing. But the wet and slippery streets of the State Capitol belonged to 2005 World Champion and Belgian superstar Tom Boonen (BEL) QuickStep, who claimed today's stage victory. Stage 2, which took cyclists from Santa Rosa to Sacramento, finished in front of record crowds, taking the total attendance number for the first three days of the race to 425,000, with five days left to go. Governor Arnold Schwarzenegger was on hand at the official post-race ceremonies to help award the jerseys.

"The Amgen Tour of California is a wonderful experience for California and is great for our tourism," declared Governor Arnold Schwarzenegger after Stage 2, where he helped present leader jerseys. "The Amgen Tour of California showcases the state, which has some of the most beautiful places in the world. Thank you to the enthusiastic crowd for being here and being such great fans."

After completing one of the most challenging and defining stages Wednesday which included the brutal Mt. Hamilton (Hors Category) and Sierra Road (Cat. 1) climbs, cycling's new generation shined again as 21-year-old Robert Gesink (NED) of Rabobank took the stage win. While Santa Rosa California resident Levi Leipheimer (USA) of Astana was outsprinted by Gesink for the stage win, the defending champion none-the-less gained the event's overall lead. As the one of most difficult stages in the 2008 Amgen Tour of California, the 103-mile Stage 3 course from Modesto to San Jose featured 165 turns and two critical climbs that separated the pack.

"This win is really great for me because the field of riders is very competitive in the Amgen Tour of California," said Gesink. "Today was a really big win for our team; we were strong as a team today."

#### Stage 4

Six-time Canadian National Road Champion Dominique Rollin (CAN) of the Toyota-United Pro Cycling Team made history Thursday as he powered away to an impressive solo victory in Stage 4. Weather hammered the peloton for nearly seven hours as the stage took riders down the California coast from Seaside to San Luis Obispo on an impressive and challenging course. Defending champion Levi Leipheimer (USA) of Astana was able to retain the overall lead and will wear the Amgen Leader Jersey going into the individual time trial in Solvang tomorrow.

"Last time I raced in such tough weather, I won the stage," said Rollin, referring to a stormy day in Quebec's 2005 Tour de Beauce. "The worse it is, the better I am. When the wind came, I said keep it coming."

#### Stage 5

Stage 5 was dominated by Levi Leipheimer (USA) of Astana for the second consecutive year. Besting David Millar (GBR) of Slipstream Chipotle Presented by H30 by 29 seconds, Leipheimer further built on his overall lead in the 2008 race and will wear the Amgen Leader Jersey going into Stage 6 tomorrow.

Moving into second and third were Slipstream Chipotle Presented by H30 riders David Millar and Christian Vande Velde (USA), respectively.

#### Stage 6

The finish to Stage 6 included an exciting bunch sprint to the finish line. After a review by race officials, Luciano Pagliarini (BRA) Saunier Duval-Scott was determined to be the stage winner, followed closely by Juan Jose "J.J." Haedo (ARG) of Team CSC and World Champion Paolo Bettini (ITA) of Quick Step. Levi Leipheimer (USA) of Astana retained the overall lead heading into the final stage of the race.

### Did You Know? EcoQuiz No. 2

How much waste does the United States produce every day?

American businesses, individuals, and institutions produce about 4.5 pounds of trash per person per day (about 245 million tons in 2005), which is two or three times as much as a typical western European. Our household waste has more than doubled since 1980. That's not just a big pile of trash; it's a major greenhouse gas contributor. The EPA estimates that a 10% increase in recycling would reduce annual carbon emissions by 24.5 metric tons, equal to a year's emissions from 15 million households. In the United States, landfills account for the lion's share of methane—a much more potent greenhouse gas than carbon. (This does not count the greenhouse gas emissions created by making and transporting all those trashed items.) Tapping this methane for energy is increasingly common, but we need to reduce what we send to landfills in the first place.






### Howard Whalen Sculture Garden

I got a call from Hope Smith, a local travel agent and avid hiker, last month asking about an interesting, somewhat overgrown garden at the northeast curve of Mountain Trail and Carter in Sierra Madre. She had peeked in from the street and was intrigued. After several inquiring emails, my own editor, Susan Henderson, gave me the lead to foundation

great enthusiasm on the topic, an emotion seemingly typical of the flavor of what must have been quite the fan

Apparently, with the resurgence of interest in mid-century architecture, interest in the art of this period, like Whalen's, is experiencing a similar resurgence. Those in the know use terms like Post-Modern, figurative, and evocative to describe Whalen's style. Though my own personal art collection and tendencies veer toward traditional oils and water colors, I was particularly attracted to the piece named "Fire Dancers" and my eyes kept returning to it. Anyone who has ridden a packed train at rush hour can empathize with his "Straphangers", while a piece named "Apartment" seems to merge modern high rise living with the high altitude desert living of native Americans in the Southwest.

His techniques are unique in the use of oxides to produce unusual and unexpected effects on the terra cotta. Currently, about a dozen fairly large pieces dot the studio's front garden, interspersed with cactus, shrubs and lots of oxalis, while the studio remains, for now, a revered repository of many more remaining pieces.

The salon atmosphere of his home and studio was a hub for appreciative friends to discuss and share ideas art to theater to politics. Flammer noted that Whalen's devotees were so enamored, that one of them, Duane Waddell, actually purchased the home from Whalen's heirs. Whalen and Waddell, former owner of the Pasadena Playhouse, met in the Altadena production of an original play, and their friendship grew over decades.

Waddell says he and others experienced Whalen's passing as a great loss, and wanted the garden to be a dedication

to his life and his work. In the 25+ years since his death, the home itself has been rented out, but the separately fenced garden remains for the enjoyment of Whalen's devotees. Waddell, who now lives about 200 miles away, indicates that rumors of an impending sale of the property are false. At one time, the garden was open to the public regularly on Saturdays, but "the collection is now under tne purview and responsibility of the heirs," per Flammer...

Slowly, the Whalen heirs have generously dispersed many pieces to local museums, such as the American Museum of Ceramic Art in Pomona, to personal family collections and to the Sierra Madre Library. The library is currently Whalen Strap Hangers



working out the logistics of moving a Whalen fountain from this garden to the newly re-landscaped "front yard" of the library, according to Debbie Henderson, associate librarian in Sierra Madre. The Sierra Madre Civic Club here has arranged funding for professional art movers to move the fountain, "Apartment", "Straphangers" and "Fire Dancers" to the library soon, then install the fountain.

This new donation to the Whalen collection at this library, which already displays "Lion" and "Cactus in a Pod" inside their building, includes many items on loan from the heirs. Henderson commented that she is grateful the family is so cognizant of the Sierra Madre ties for Whalen's art, that it was made here in this little city, arranging that at least part of the collection should stay here in Sierra Madre. The library also received an extensive collection of Whalen's archives, which can be accessed by appointment through Henderson, by calling the library at 626-355-

Jim Paul, another volunteer at the garden, has coordinated volunteer activities at the garden in the past, but a new heart pacemaker has restricted his active involvement currently. As Whalen's contemporaries age and pass on, it becomes harder to coordinate the maintenance and access, without younger interested volunteers and involvement, so every year it becomes more difficult to maintain the garden, especially with the recent torrential rains.

Flammer commented, "I think the term "awe" is abused these days, but when I look at the archives, I find it difficult to come up with few other terms when I see how much his friends and admirers lovingly built a remembrance to Howard's spirit and works. It makes me stop and think, 'What influence have I had?' Humbling, to be sure."

Whalen must have made quite the impression on many through his life and his works, to have so many drawn to honoring him and his work, so many years after his passing! I wish we could have met! At least we can peek appreciatively at this eclectic sculpture garden from the street on the next hike, or view many of the pieces when they are installed at the library!



### The Relevance Of Ghandi

#### The Son Of The Great Leader Speaks To Students At Pasadena City College

A near-capacity crowd filled the Sexon Auditorium at Pasadena City College last Thursday to hear Mahatma Ghandi's grandson speak about his grandfather's teachings. Rajmohan Ghandi presented a lecture, titled the "Relevance of Ghandi in the 21st Century", which was followed by an open forum that allowed questions from the audience.

The talk covered the author's new, monumental biography of his grandfather, "Ghandi: The Man, His People and the Empire", which is considered to be the first to give a complete and balanced account of Mahatma Ghandi's life. Rajmohan, who is also a professor at the University of Illinois, presented unprecedented insight and access to family archives and explored the evolution of his grandfather's teachings of non-violent resistance, while examining the relations between Muslims and non-Muslims.

"If you have a goal of social, political of racial justice are you going to attain that goal through violent or non-violent means," asked Rajmohan. "I feel that Ghandi still speaks to us to attain the levels of awareness brought by non-violence."

According to the curator of the lecture, Susie Ling, Mahatma Ghandi's ideals inspired many, including Martin Luther King and Caesar Chavez.

"PCC is extremely honored to host Professor Rajmohan Ghandi," she said. "With today's chaos in the Middle East and chaos in our neighborhoods, we need to listen again

to Ghandi's words and be reminded of the integrity of non-violent civil disobedience to bring about positive Rajomohan, a peace activist, once served on the Indian Parliament. He also led the Indian delegation to the U.N. Human Rights Commission in 1990. He is currently in the South Asian Middle Eastern Studies program at the University of Illinois at Urbana-Champaign.



A Word From Publisher/Editor Susan Henderson:

Clearly, Black History Month has a special meaning for me this year. For the first time in this country, there is an African American that may be the Democratic nominee for President of The United States. In my lifetime I have met many outstanding brothers and sisters who were quite capable of leading our country, however, Barack Obama has prepared himself, overcome seemingly insurmountable odds, and been at the right place at the right time to make it happen. His candidacy is historic, but in all of the excitement about this achievement, we need to reflect a little on how far this country has come. Voting Rights have not always been a given for Women (more on Hillary Clinton next month) or African Americans. Hail Hamilton, submitted the following timely historical piece on voting rights and our government that I feel is most appropriate given the times and the fact during this month we pay particular attention to African American history.



### Black History Month: The Voting Rights Act Of 1965

efforts to break the grip ofstatedisfranchisement had been under way for

some time, but had achieved only modest success overall and in some areas had proved almost entirely ineffectual. The murder of voting-rights activists in Philadelphia, Mississippi, gained national attention, along with numerous other acts of violence and terrorism. Finally, the unprovoked attack on March 7, 1965, by state troopers on peaceful marchers crossing the Edmund Pettus Bridge in Selma, Alabama, en route to the state capitol in Montgomery, persuaded the President and Congress to overcome Southern legislators' resistance to effective voting rights legislation. President Johnson issued a call for a strong voting rights law and hearings began soon thereafter on the bill that would become the Voting Rights

Congress determined that the existing federal anti-discrimination laws were not sufficient to overcome the resistance by state officials to enforcement of the 15th Amendment. The legislative hearings showed that the Department of Justice's efforts to eliminate discriminatory election practices by litigation on a case-by-case basis had been unsuccessful in opening up the registration process; as soon as one discriminatory practice or procedure was proven to be unconstitutional and enjoined, a new one would be substituted in its place and litigation would have to commence anew.

President Johnson signed the resulting legislation into law on August 6, 1965. Section 2 of the Act—which closely followed the language of the 15th amendment—applied a nationwide prohibition against the denial or abridgment of the right to vote on the literacy tests on a nationwide basis. Among its other provisions, the Act contained special enforcement provisions targeted at those areas of the country where Congress believed the potential for discrimination to be the greatest. Under <u>Section 5</u>, jurisdictions covered by these special provisions could not implement any change affecting voting until the Attorney General or the United States District Court for the District of Columbia determined that the change did not have a discriminatory purpose and would not have a discriminatory effect. In addition, the Attorney General could designate a county covered by these special provisions for the appointment of a <u>federal examiner</u> to review the qualifications of persons who wanted to register to vote. Further, in those counties where a federal examiner was serving, the Attorney General could request that <u>federal</u>

1965 concerted observers monitor activities within the county's polling place.

The Voting Rights Act had not included a provision prohibiting poll taxes, but had directed the Attorney General to challenge its use. In *Harper* v. *Board of Elections*, 383 U.S. 663 (1966), the Supreme Court held Virginia's poll tax to be unconstitutional under the 14th Amendment. Between 1965 and 1969 the Supreme Court also issued several key decisions upholding the constitutionality of Section 5 and affirming the broad range of voting practices that required Section 5 review. As the Supreme Court put it in its 1966 decision upholding the constitutionality of the Act, Congress had found that caseby-case litigation was inadequate to combat wide-spread and persistent discrimination in voting, because of the inordinate amount of time and energy required to overcome the obstructionist tactics invariably encountered in these lawsuits. After enduring nearly a century of systematic resistance to the Fifteenth Amendment, Congress might well decide to shift the advantage of time and inertia from the perpetrators of the evil to its victims. [South Carolina v. Katzenbach, 383 U.S. 301, 327-28 (1966)].

Congress extended Section 5 for five years in 1970 and for seven years in 1975. With these extensions Congress validated the Supreme Court's broad interpretation of the scope of Section 5. During the hearings on these extensions Congress heard extensive testimony concerning the ways in which voting electorates were manipulated through gerrymandering, annexations, adoption of atlarge elections, and other structural changes to prevent newly-registered black voters from effectively using the ballot. Congress also heard extensive testimony about voting discrimination that had been suffered by Hispanic, Asian and Native American citizens, and the 1975 amendments added protections from voting discrimination for language minority citizens.

In 1973, the Supreme Court held certain legislative multi-member districts unconstitutional under the 14th Amendment on the ground that they systematically diluted the voting strength of minority citizens in Bexar County, Texas. This decision in White v. Register, 412 U.S. 755 (1973), strongly shaped litigation through the 1970s against at-large systems and gerrymandered redistricting plans. In Mobile v. Bolden, 446 U.S. 55 (1980), however, the Supreme Court required that any constitutional claim of minority vote dilution must include proof of a racially discriminatory purpose, a requirement that was widely seen as making such claims far more difficult to prove.



### Stuart Tolchin On...LIFE



#### IT'S REALLY NOT SO BAD

I've been feeling really pessimistic for about the last two weeks. This feeling was preceded by a short period of elation connected to my realization that the Presidential candidates of both parties seemed to be people of high intelligence,

quality, and goodwill. All at once I became frightened. What difference can it make now! It's too late.

Even if some body good is elected he or she will be assass in a tedanyway, etc. etc. My actual thought was that we are living like Austrians in the late 1930's; proud of our heritage and history and unaware that we about to be absorbed into some sort of demonic fascist Hell like Nazi Germany.

Luckily, for me, yesterday was a holiday and I was freed from my usual obligations. I had made plans for a 7:00 a.m. tennis game with Charles, a pretty great former College football player but a pretty lousy tennis player. We played a couple of quick sets and although Charles is clearly improving he's not able to beat me yet. Actually, Charles, who's just a little more than half my age, was probably hindered by the fact that he had worked until midnight the night before and had get a ride home because his car was locked in some parking lot downtown. Because it was a holiday I had plenty of time to drive Charles downtown and accept his invitation to walk over to his office and meet his

clients and some of the other staff.

Charles is a Federal Public Defender which can be a pretty rough job. Federal Public Defenders are opposed by Deputy U.S. Attorneys, generally highly qualified people with the resources of the entire United States government. By reputation U.S. Attorneys only go to trial when they're pretty sure of winning. In fact, I was told by one former Federal Public Defender, now sitting as a Superior Court Judge, that in seven years he had not won one trial—and, believe me, this is a pretty brilliant guy. So, anyway, I didn't know what to expect as I walked with Charles to meet his clients and other colleagues on this non-work day. Oh yeah, one more thing -the penalties in Federal Court are, to me who only appears in State Courts, incredibly severe. First time offenders with clean records who are convicted of nonviolent offenses are sentenced to a minimum of two years in prison and are required to remain in prison for almost the full time of their sentence. This is not the case for fist time non-violent offenders without previous convictions who are convicted in the Los Angeles County Superior Courts. These individuals typically receive probationary sentences combined with county jail incarcerations from which they are released after serving only a small percentage of their sentence time. The reason for this disparity need not concern us here (and also I am at a loss to understand it) but anyway my expectations were that Charles' client and colleagues would be a pretty depressed group of individuals much like the attorneys and clients in Dependency Court where I had first met Charles. In that system, a noncriminal Court, people are not faced with a loss of liberty or a fine; instead they are faced with the loss of their children perhaps permanently. There is no right to trial by jury only a hearing before busy jaded overworked judges whose time is spent hearing about the worst moments in people's lives. It is not a pleasant place!

I was thinking about Dependency Court as we approached Charles' building. I hear some bearded thirty something guy in a sweatshirt struggling under the weight of several giant cardboard boxes. I think it's probably some homeless person who's going to hassle us for change and I start searching through my tennis shorts looking for a dollar and wondering why I'm putting myself through this on a holiday, this feels strangely like work. All at once Charles is hugging this guy and introducing me to him. The guy turns out to be a colleague of Charles carrying the boxes of papers being readied for filing the next day on a capital case. Out of nowhere this guy tells Charles that he and his wife are preparing dinner for Charles that night as they know Charles has to begin a trial and won't have time to cook for himself. How incredibly kind and thoughtful of him! I meet Charles' client and his family and they are people that one wishes to help. They are a devoted family, aware that their father may have made some mistakes, but clearly hopeful and appreciative of Charles' efforts in their behalf. I go upstairs and meet some of the other lawyers putting in their time on this non-work day and am highly aware of how good it feels to be a defense lawyer. After forty years it's sometimes easy to forget. As I'm leaving the bearded guy asks my name and says he knows my daughter and that she's doing really good work. (My daughter is an Immigration Attorney often working for free in extremely

difficult cases.) Well that's it. I was off to meet my wife for lunch aware, for the moment at least, that life is actually pretty good. The present is fine---and since there is only present everything else is fine; maybe that doesn't really make sense but it feels right especially on a holiday.

It seems today that some people enjoy displaying their ignorance for all to see. Case in point, your otherwise very entertaining writer Stuart Tolchin ("Tell the People the Truith," Jan 25 issue) tells us that "as far as I know, George Washington .... Was always a vain, calculating, ambitious man." He further tells us that he simply created some uniform to impress the other men and somehow, they were so easily impressed

that they made him general.

that he got his "facts" from an exhibit at the Huntington, so perhaps I should be challenging those exhibitmakers. I would agree with Tolchin that we have devolved into a sad state today where simply being ambitious and rich somehow qualifies you for presidential leadership. #### Where Business Interests And Worthy Causes Intersect

By La Quetta M. Shamblee

"Doing well by doing good" was touted by Louis Gerstner, Jr. in the early 1980's when he was Chairman of American Express Travel Related Services, in reference to the pioneering corporate fundraising model introduced by Amex. Although they were engaged with a number of charitable causes, the flagship project that put them on the map as the corporate trailblazer was their campaign to raise funds for the restoration of the Statute of Liberty.

In just three months, the nonprofit Restoration Fund generated over \$1.7 million, assisted by a \$4 million advertising campaign to reach existing and potential Amex customers. It was structured to generate a donation of one cent for every credit card transaction and one dollar for every new card application. In return, the company reached their objective to increase new card applications and card usage, while simultaneously raising money, visibility and support for the Restoration Fund. Purchases of travelers' checks and travel packages generated additional donations.

The success of this campaign left no doubt that strategic collaborative projects between corporations and nonprofit causes can be structured for mutual benefit. As the fundraising landscape continues to evolve and shift to make it more challenging for nonprofits to secure resources to sustain their programs, a cause-related marketing campaign with a corporate partner is an attractive proposition. This emerging branch of fundraising is now firmly rooted in the philanthropic sector as a viable revenue

As with most innovations in commerce, mom and pop businesses

have long engaged in supporting local school bands, little league teams and other worthy causes. In exchange for donations of cash and other resources needed to operate programs and provide services, nonprofits have donned business names and logos on the backs of uniforms and on banners hanging from gym rafters and fences around athletic fields.

A perusal of products in any supermarket will reveal the prominence of this fundraising approach. From the licensing of the American Heart Association's logo on cereal boxes to Avon's national sponsorship of annual walks for breast cancer, an increasing number of causes and corporations are participating each year. The current RED campaign spearheaded by the musician Bono to raise money to combat AIDS and poverty in Africa is one the most wide-reaching, successful causemarketing projects launched to-date.

Cause-marketing collaborations between local businesses and nonprofits represent opportunities waiting to be developed. Cause Marketing for Nonprofits, by Jocelyne Daw, is a book that provides a comprehensive overview of the subject, also making the case that the economic benefits and societal impact from this model aren't limited to big business as long as the four key elements that define and set this approach apart from traditional marketing and nonprofit-corporate fundraising are considered, including: 1) Creating shareholder and social value, 2) Structuring the relationship as a collaborative, mutually beneficial business-nonprofit partnership, 3) Connecting and engaging stakeholders (including employees and consumers), and 4) Communicating values of citizenship through campaign activities.

By laying the proper groundwork, nonprofits of all sizes can prepare their organizations to benefit from the growing interest in cause-marketing by local businesses and corporations.


# The Book Reports By Jeff Brown



This is a comprehensive portrait of Sewall (1652–1730) who was an Englishborn American judge who presided over the Salem witchcraft trials of 1692. Nineteen innocent men and women were put to death, all the result of trumped up charges. Some were unknown to Sewall, but others were his friends. For many years, he struggled with a strong sense of shame and regret and later announced in public the blame for the executions. He spent much of the remainder of his

life trying to repent in the eyes of God. He wrote extensive diaries, books, almanacs, essays, ledgers, poems and letters. Sewall became the author of America's first antislavery tract, and published an essay on sexual equality. A fascinating account of the man and of daily life in early America.

Never Again (2001)



This film by Eric Schaeffer is very funny. It tells the story of a single middle aged man, Jeffrey Tambor, and woman, Jill Clayburgh, who find each other, have good chemistry and sex, and then begin to wrestle with issues as they search warily for that deeper meaning. They have both been hurt in relationships, are both 54, and neither wants to risk falling in love again, hence the title. And they are both dealing with the normal human issues regarding intimacy, midlife relationship crisis, mortality, loneliness, and the desire for love. It's a romantic farce with complications, a mix of drama and comedy. It includes other characters as well and some Jazz. It

### Snowflakes Are Dancing

COMPOSER CLAUDE DEBUSSY captured the magic of snowflakes in the musical notes composition "Snowflakes Are Dancing." Caltech physicist Ken Libbrecht has captured that same magic in photography, while also probing the secrets of the physics behind the snowflakes' creation.

Dr. Libbrecht, who can include solar research at Mount Wilson Observatory in his many-faceted resume, will share his findings about snowflakes with the Mount Wilson Observatory Association (MWOA) at 2:30 p.m. on Sunday, February 24. The public is cordially invited to this profusely illustrated, free talk at the Altadena Public Library, titled "The Physics of Snowflakes."

Libbrecht has studied and photographed snowflakes for many years and is the author of five popular books on the subject, in addition to a 2008 snowflake calendar. These books can be viewed and purchased at Amazon.com or purchased from the Caltech Bookstore or Vroman's Bookstore in Pasadena.

As usual at MWOA lecture/meetings, there will be complimentary refreshments served before the lecture, beginning at 2:00 p.m. The library is at 600 E. Mariposa St. in Altadena.



Libbrecht's snowflakes honored on a US Postal

PLANET EARTH, IT TURNS OUT, IS NOT THE ONLY PLACE where snowflakes are dancing. NASA's Cassini spacecraft has discovered that Saturn's moon Enceladus is jetting out giant ice geysers three times the size of the moon, and now scientists are beginning to understand how the ice grains in these geysers are created and how they might have formed. Knowing the process of how the plume forms and the path the water-ice particles have to travel is giving them an insight into what may be a liquid reservoir or lake lying just beneath

"Since Cassini discovered the water-vapor geysers, we've all wondered where this water vapor and ice are coming from. Is it from an underground water reservoir or are there some other processes at work? Now, after looking at data from multiple instruments, we can say there probably is water beneath the surface of Enceladus," said Juergen Schmidt, team member on Cassini's Cosmic Dust Analyzer at the University of Potsdam, Germany. This study appeared in the Feb. 7, 2008, issue of the journal *Nature*.


The large number of ice particles observed spewing from the geysers and the steady rate at which these particles are produced require high temperatures, close to the melting point of ice, possibly resulting in an internal lake. The lake would be similar to Earth's Lake Vostok beneath Antarctica, where liquid water exists locked in ice. The ice grains then condense in the vapor evaporating from the water, streaming through cracks in the ice crust to the surface.

Scientists have studied the plume dynamics since 2005, collecting data from several Cassini remote-sensing instruments and those that sample particles directly, like the Cosmic Dust Analyzer. They conclude that an internal lake at a temperature of about 273 Kelvin (32 degrees Fahrenheit) is the best way to account for the material jetting out of the geysers.

The presence of liquid water inside Enceladus would have major implications for future astrobiology studies on the possibility of life on bodies in the outer solar system.

The next Enceladus flyby is in March 2008. The spacecraft's closest approach will be at a mere 30 miles from the surface and the altitude will increase to about 124 miles as the spacecraft passes through the plumes. Cassini will sample the plumes directly and find out more about their makeup.

Ă RETURN TO HOOPS YESTERYEAR? GEEZ, I SURE HOPÉ NOT....

Lakers versus Celtics. The very words still compel the psyches of basketball sluts to tremble. To ache. To yearn for just one more epic showdown between these two storied powerhouses. L.A., left coast, vs. Boston, Beantown USA. Wouldn't that be something? Could it happen?

Uh-huh. Could happen. Could happen this very year, in fact. After all, it happens every 20 years or so. And we're just about due. So what's the big deal?

Well, if you come from my era of basketball fandom, it's a very big deal. No two franchises have so thoroughly dominated any professional sport the way the Lakers and Celtics have cast their giant collective shadow over the NBA. In 61 NBA seasons, one of these two clubs has reigned as champion a staggering 30 times. That's like half. It's hard to fathom, really. It would be like if the Patriots and Giants had each won 10 Super Bowls, like if the Yankees and Dodgers had each won 26 World Serieses to date. (Yes, I know the Yankees have already won 26 Serieses, but the Dodgers are still stuck on six, aren't they Dodger fans. Which sharpens my point. So there.)

And so here we are, more than halfway through the 2007-2008 NBA season, and the Celtics---thanks to the off-season additions of Kevin Garnett and Ray Allen---are high atop the East with a 41-10 record at this writing, while the Lakers, energized by the emergence of Andrew Bynum and the 11th-hour addition of Pau Gasol, are 36-17 and riding quite high themselves. The Lakers and Celtics are suddenly two of the six or so best teams in basketball. Another NBA finals match-up is a definite possibility. It would be their 11th. Obviously the odds of this occurring will improve if Garnett recovers from a nagging belly strain, if Kobe can play at Kobesque levels with his torn pinkie ligament, and if Bynum comes back from his knee injury at close to 100%.

Let's get back to why this Lakers/Celtics thing is such a big deal

Frankly it's a tad painful for me to write about Lakers versus Celtics, because when I was a little kid it always turned out the same. Bill Russell and Red Auerbach raising a trophy over their heads, my heroes Elgin Baylor and Jerry West walking disconsolately off the court, heads down.

However, if you'll bear with me I will struggle grimly on; because this is a rivalry that demands historical review.

Back in the 50s and 60s the Lakers and the Celtics (notice how I impishly and somewhat stubbornly keep listing the Lakers first?) met seven times in the NBA finals. As said, Boston won each time. But the second one, in 1962, could have changed everything. It went the full seven games, and with only a couple of seconds to go in the 4th quarter of the decider Laker shooting guard Frank Selvy had an open 8-foot jumper to win it all. Frank Selvy, who in college once scored a record 100 points in a single game! Eight feet from glory. This wasn't some long, twisting 25-footer, or some desperation half-court heave like the one he made to cap off his 100-point masterpiece. Eight feet. A shot the deadly-accurate Selvy had made a thousand times without giving it a second thought. He missed.

Had that shot gone in, how might it have affected all those terrible repeat performances, when Boston merely capitalized on their psychological advantage over the Lakers time and time again?

In 1969, though, the Lakers had them right where they wanted them. They'd just acquired the great Wilt Chamberlain, they still had Elgin and Jerry, Boston was old and banged up, Russell was 34 going on 54, and consequently the Celtics had only finished 4th in their conference that year. They were done.

No, they weren't. Because the Lakers went out of their way to help these old tired Beantowners find one last burst of adrenaline. For Game Seven, they stuffed hundreds of balloons in the rafters, so that when they won the balloons would rain joyously down upon the multitudes. Have you ever heard of a team owner (Jack Kent Cooke, in this case) doing anything quite so stupid? Bill Russell took one look up into the rafters, then barked angrily to his teammates, "They can't 'bleeping' beat us. But it's going to be funny watching them take down those balloons." They can't beat us, the aging Russell said.

And they didn't. The basketball gods, angered by Cooke's hubris, made sure of that. First, Wilt got hurt in the 4th quarter, but when he was recovered Coach Butch van Breda Kolff (a well-documented idiot of yore) wouldn't put him back in. Then, with about a minute left and Boston up by one point, Don Nelson hoisted up a desperation set shot from just outside the foul line, which slammed hard off the back heel of the rim, bounced ten feet straight up....and dropped in. And that was it. This time the Lakers had only their owner, their coach, and themselves to blame. Final score: Boston 108, Lakers 106. Of all the gutwrenching finals losses to the Celtics, this was the worst.

At least until 1984, when Larry Bird and the Celtics did it again. Heavy underdogs, they parlayed an improbable Gerald Henderson steal of an ill-advised, cross-court James Worthy pass at the end of Game Two into victory, in a game they had virtually already lost. They went on to win in seven games. That made it Boston, 8 finals victories, versus Lakers, a lifetime goose egg.

Finally, in 1985 and again in 1987, thanks to the brilliance of all-time-greats Magic Johnson and Kareem Abdul-Jabbar, the Lakers beat the Celtics in the finals. It was great to finally beat those guys a couple times. But the score still stands Boston 8, L.A. 2. The balm of those two triumphs soothed the scars of the 60s, but it didn't make the scars go away.

So if it does happen, if we do get one more Lakers versus Celtics final this year, please please pleeze let the basketball gods ensure that the Lakers win. And let it be a win that drives a stake into the heart of Celtics fans everywhere. Otherwise, I hope we don't even get there. Because I don't know if us Laker die-ĥards could take another dagger like '62, or '69, or '84.

Sometimes it's okay just to make it to the big dance. But there are other times when getting there, only to have some other guy go home with the girl who brung ya, just makes it worse.

Just ask the Patriots.

# Ken Meyer: 1964 - 2008

Sierra Madre softball lost its touchstone last week.

Ken Meyer, long-time Monrovia resident and the sitting President of the Sierra Madre Girls Softball Association (SMGSA), passed away on February 15th, the victim of a freak ATV accident near San Diego. He was 43.

Meyer's passing leaves a gigantic hole within the SMGSA family. His is perhaps the name most closely associated with girls softball in this area. Not only was he league President at the time of his death, but since 1999 Meyer coached over 20 different teams including regular season, several All-Star teams, and fall ball. Within hours of the SMGSA website's posting the tragic news, dozens upon dozens of heartfelt testimonial messages of condolence and remembrance had flooded the site's message

Ken Meyer was a respected, popular, well-loved man.

A candlelight vigil was held last Sunday the 15th at Heasley Field in Ken's honor. The response was stunning and sobering. On very short notice, and though it was the middle of a holiday weekend, over 400 of Ken's close, loyal friends found time to attend. Many of the attendees were members of the SMGSA family, many others were simply those souls whose lives Ken touched forever. In his eulogy, John Latta, Director of Coaching for the league, summed up Ken's life this way: "I asked my wife and girls what they remember about Ken, and their answers were the same; his sense of humor, and his relentless, never-ending smile. Ken greeted all comers walking up the hill {to Heasley Field} with that beaming smile. I think of Ken and his 'Heasley hospitality', welcoming folks to the field, almost like a restaurant owner might greet his oldest and best customers. Like most of us Ken had a job but the game of softball was his avocation. There was no doubt he loved being on the field. Other than spending time with his family, the game of softball was where Ken wanted to be."

When Latta was done, the field lights went off and candles were lit. Someone put on a Hawaiian version of "Over the Rainbow", one of Ken's favorite songs. One of Ken's daughters read a poem. There was a solitary lit candle on home plate during the ceremony. At the end, others came and added their candles to it. People stayed and talked. No one wanted to leave.

Ken Meyer was a character.

He loved life. He loved to laugh. He was known to hide the occasional Coors Lite in a red cup. He loved to tell stories and tell jokes, especially lame jokes, the lamer the better. No one recalls ever seeing him without a handful or mouthful of sunflower seeds.

"He'd always be eating them in the dugout or coaching box while he cheered on the girls." He was known to be exceedingly passionate about the sport (to put it mildly), not above throwing his hat to the ground and getting ejected from a game if he felt strongly about a bad call. His face would flush red and everyone would laugh, and Ken would laugh back.

It is only fitting that a lasting monument to Ken's commitment to girls softball be put in place for the upcoming season. So beginning on Opening Day, March 8th, the softball field at the Sierra Madre School Upper Campus on Canon Avenue---a field he helped develop and build---shall henceforth be known as "Meyer

Ken Meyer leaves behind his wife Kelly and two daughters, Hannah, age 16, and Madelynn, age 11. But in a larger sense---and perhaps this shall be his legacy---he had many more daughters than that. Because over the years, Ken treated each girl who came through the SMGSA as part of his own extended family. As Kelly herself said recently about her beloved husband, "each girl was like a daughter to him....






