Dorn Platz vs. Sierra Madre No Deal -No Settlement: Judge Says Move On

After failing to reach an agreement at last week's long city council meeting, on Thursday Los Angeles County Superior Court Judge Kenneth Freeman ordered the City of Sierra Madre and Dorn-Platz (for Stonehouse Homes, LLC and One Carter, LLC) to return on April 10th prepared for a Trial Setting Conference. As he promised in November, he has ruled against any additional continuances. In April, unless a settlement is reached, it is anticipated that a date will be set for trial later in

At the council meeting a proposed Settlement Agreement was offered, however, Dorn-Platz would not agree to the terms and conditions. Although they have reduced the number of luxury homes to be built in the hillsides from 35 to 22 and although they did meet with residents who live on the streets surrounding the project, several important issues remain unresolved.

Specifically, according to Director of Public Works Bruce Inman, the amended plans still do not address adequately the issue of cross drainage, sloping, the size of the house on Lot 4 and visibility.

The council had hoped that "something meaningful" would be brought before them, however representative Cathy Teagarden offered nothing acceptable to the city attorney, city manager or council. In addition to Teagarden, the attorney for Dorn-Platz was present. Noticeably absent was Greg Galletly, a principal in the firm who spent a considerable amount of time in Sierra Madre during the early stages of development of the Stonehouse Project, One Carter and the failed attempt to build Maranatha High School on the One Carter site.

Sierra Madre Police Chief Marilyn Diaz, in a speech before the Kiwanis Club, unveiled the city's Annual Report for 2007. The report showcased two years of progress in fighting crime for our city under Diaz's leadership. Based upon statistics submitted to federal authorities by law, the statistics show that the SMPD has made a significant increase in arrests and


Despite challenges with staffing, recruitment, technology and budgeting, the department has been able to, "deliver low cost, high impact services," says Diaz.

According to the report, there has been a 10% decrease in Part I crimes (hard core felonies), and a 70% decrease in residential burglaries for the period 2005-2007. This is in comparison to Pasadena which surprisingly reported a zero increase in crime for the same period and San Marino, which had a 17% increase during the reporting period.

In addition to the outstanding record of arrests and prosecutions, the SMPD has engaged a variety of "non-enforcement" solutions to resolve problems. One example given by Diaz was the utilization of youth volunteers from the Congregational Church to clear brush from the home of an elderly resident who had not been able to do so. Not only was the resident happy, "the kids loved it", Diaz reported.

Crime prevention and public safety programs are also part of what officers deliver. Officer Esther Doyle, who was honored for her work in an elder abuse case last year, is now working with our schools developing a School Emergency Response Team.

Increased visibility on the streets along with effective team work have been largely responsible for the improvements in the services received by residents. However, the city is still facing a financial crisis which the passage of Measure Ú would alleviate substantially.

Walkers, runners, joggers and cyclist all came together Tuesday night to discuss safety around the Rose Bowl although city staff had one thing on their minds —hundreds of group cyclists set to descend on the area come daylight savings time



Commission Considers Plastic Bag Ban

Using Santa Monica and Oakland as municipal models, the Pasadena Environmental Advisory Commission is considering proposing an ordinance banning the free distribution to customers of single use plastic carryout bags at stores within the city of Pasadena.

Last week the Santa Monica City Council agreed to draft an ordinance containing recommendations regarding a ban on plastic bags for commercial establishments in Santa Monica. The Pasadena EAC made public a report that was presented to the Santa Monica City Council—prior to the approval of the ordinance—with pertinent facts regarding the environmental impact

of the non-biodegradable bags.

The report was drafted by Craig Perkins, director of Santa Monica's Environmental and Public Management at the request of the City Council. According to the report it was determined that "plastic bags are responsible for significant negative environmental impacts and that preferable alternatives are readily available and

currently in use. The most effective way to reduce the environmental impacts related to plastic bags is to ban their use and promote the use of reusable carryout bags." The report also recommended that single use paper carryout bags should be allowed as an alternative, but should be able to meet certain requirements to minimize the environmental impacts related to their manufacture and transportation.

A similar ban was adopted by the City of Oakland in July, 2007. Oakland's ordinance applies to all stores generating \$1 million or more in annual sales with the exception of restaurants. The report also stated that, "in August 2007, the City of Oakland was sued by the Coalition to Support Plastic Bag Recycling which argued that the City failed to complete an environmental impact report as required before adopting its ordinance. In response to the lawsuit, the City of Oakland has agreed not to enforce its ordinance until the suit is resolved."

The Pasadena EAC took the first step to awareness of the issue at their meeting held last Tuesday and hopes to generate interest in the matter culminating with a "Town Hall"-type meeting to be held in May.

What accounts for half of the toxic metal cadmium found in the American waste stream?

Disposable batteries account for half of the approximately 1,800 tons of cadmium in our waste stream each year, according to the US Environmental Protection Agency. Batteries commonly end up in local landfills rather than in a battery collection programs that will properly dispose of them. Currently, rechargeables account for only about 11% of the global battery market (overall, a \$50billion industry). 

Growing a 'One Of A Kind' Neighborhood In This 'One Of A Kind' Town

Part of the reason my husband and I felt comfortable in the Sierra Madre neighborhood we chose two years ago, was the family that came out and chatted with us, nearly every time we perused our potential purchase. Friendly and welcoming, but not intrusive, Martin and Carolyn let us know we would be a welcome addition to this little neck of the woods, pardon me, foothills.

Before a job transfer brought us here, we drove straight through LA without stopping, planning ahead for enough fuel to make it all the way through. As born and bred Midwesterners, LA's reputation in Illinois is rather scary, full of Hollywood sound bites on one end of the spectrum and gang wars on the other. This reputation of ill repute pervaded our senses, even when we lived as close as San Diego and San Francisco. For many years, we never even considered job opportunities here, just crossing LA off the list of residential possibilities. Yet we ended up here after all, and set ourselves to making the best of it.

After an exhausting tour of South Pasadena through Monrovia, we felt ourselves drawn back time and again to tiny Sierra Madre. A bit off the beaten path, but with great freeway access to the rest of LA, this eclectic town called to us. They like to point out there are no stoplights here in this city of 10,000. We felt comfortable at the neighborhood church, St. Rita's. We liked the vibes at the many breakfasts, lunches and dinners we ate inside and al fresco at "Only Place" and "Village Pizzeria" in our research and due diligence phase based in corporate housing in downtown Pasadena.

People TALKED to us here in Sierra Madre; chatted with us, shared with us, going out of their way to make us comfortable. This didn't seem to be the LA of television and movies and network news. On moving day, a woman named Kim, whom I met walking on the street and at Sierra Madre Fitness, sent over a welcome basket from the local "Savor the Flavor" store on Kersting Court.

As we've met others transferred here, we hear the story over and over. Hope, a travel agent newly transplanted from Chicago as

a trailing spouse in a job transfer, admittedly dragged

her feet for nearly a year, dreading LA. They ended up here in Sierra Madre. Other transplanted families from New Jersey and Connecticut related similar reluctance and experiences. Debi was amazed at the effort Gooden School's families and community made to connect and welcome them to the area.

A new neighbor, John, moved less than ten miles to our neighborhood. He reflected that after many years in his old neighborhood and town south of here, he didn't know, or even talk to his neighbors. Our police chief, Marilyn Diaz, promptly returns my phone calls and emails, attended our last block party, and greets me like a friend when we see each other in town. Pretty cool in my book. Not the LA I expected.

Which comes to some of the mechanics of building a great neighborhood in a great town. Making sure we know each other. Three things work well here to keep the communication lines open. Well attended block parties bring us together to see each other face to face. Sharing a meal builds a neighborhood. When an issue comes up, we have already built a relationship. Two: Many of us have each other's emails and phone numbers to communicate quickly about a lost cat or a bear lounging in a back yard, or worse, if that comes up. Three: Neighborhood Watch. It's worth the time to schedule a meeting for

your block or your neighborhood. Police representatives are delighted to spend an evening sharing information, answering questions and getting to know you as neighbors face to face. If you and your neighbors already had your initial meeting, I understand that staff encourage a second meeting, with the discussion topic of coexisting with our wildlife neighbors. Call them at 626-355-1414 to set it up.

We're a neighborhood of do it yourselfers, and not hesitant about asking each other for help, and giving it. Martin got it in his head that our dilapidated neighborhood entrance sign bore replacement. Susie Mc Connell, Bruce Inman and the recently retired Steve Pock helpfully guided us through the hoops, requirements, permits and needed resources, with little fuss and bother. Neighbors pitched in financially; Marie and Amy and Carolyn helped with the coordination. Martin and Dick coordinated the installation, and soon it was a done deal. It's just that kind of place.



And so at the end, I come to the spark that really ignited this article. We have a neighbor we've dubbed, St. Neil, despite his non-Catholic heritage. Twice in two months he has driven by at just the right moment when we needed a hand. Screeching to a halt, he just seems to know we need help with the highest of our Christmas lights, or tree stump removal last Saturday Neil showed up, grabbed his chain saw, then added his truck pulling capability, then personal brute force later. Seemingly always at the right moment. How DOES he do that?

Oh sure, we have our local quirks and issues, but I wouldn't live anywhere else in LA, maybe nowhere else... period. So, shhhhh. Don't tell anybody!

HANGE THE WORLD BY CHANGING YOURSELF

Seeking the Path of Practical Ecology Earth Day every day? By Christopher Nyerges

"Live light upon the Earth, If you would not be earthbound." -- Shining Bear

I was only a teenager, but I could never get it out of my mind: "How should we be living our lives? Is there not more to life than seeking money, possessions, and pleasure?" These questions, and their countless variations, were the driving force that led me on my path of botany, ecology, indigenous skills, and spiritual evolution.

Back in the early '70s, there was the beginning of a heightened ecological awareness, but you were still a "kook" if you expressed an interest in practical survival, and if you expressed concern about the growing ecological crisis.

A lot has happened in 30 years. Things have gotten worse. "Great interest" and "good intentions" of the 1970s did not succeed in materially improve our overall trends in the United States. Our rapid population growth, both from within and without, has only exacerbated the situation.

I spent the last 30 years attempting to learn and to apply the "little things" that I can do, and that anyone can do, to choose to be a part of the solution. It is the way that I maintain hope, and that I can find a way to mentally rise above what seems a hopeless situation.

Besides learning many of the elements of what anyone can do, even if you're in the cities, I realized that there is no "enemy" out there. The "enemy" is always within. It is my own proclivity to laziness, to choosing the path of least resistance, to choosing something based solely on economics. Though I have not always succeeded, I have attempted to take the time to determine why we've even here on this earth for a few score years before we die. It certainly cannot be solely

to accumulate a good portfolio. My pursuit of "what to do?" initially led me to study botany. In botany, and specifically in discovering how indigenous peoples used their floral friends, I realized that food and medicine were richly abundant on this earth. While modern agriculture continues to travel down the high-tech path of genetically modified foods, the most nutritious plants on the earth are still wild plants, plants such as dandelion, purslane, curly dock and other so-called "weeds" that are found in urban areas throughout the world.

Dandelion – richer in beta-carotene than carrots. Purslane, the richest plant source of Omega-3 fatty acids. Curly dock, one of the richest sources of vitamin A. These wild plants, and hundreds more, I have used and taught to thousands of students over the past 3 decades. Acorns still abound, and it is a fascinating path of discovery to collect the acorns and process them in the traditions of the Old Ways. In our urban areas, we can find lambs quarter, a spinach relative that is arguably nature's best mineral tablet. We find abundant carob trees planted as ornamentals, and these are edible right off the tree, with three times as much calcium as the same amount of milk. Chickweed is a common weed of lawns, rich in vitamin C and a delicious salad plant.

And get this - because chickweed has the audacity to grow on lawns, there is a poison you can buy in most nurseries that promises to kill all the chickweed on your lawn, as well as dozens of other so-called weeds, which are actually good foods and good herbs.

WHY A LAWN?

Why, why, why? It is apparently because "we" believe that there is some socially redeeming value in lawns. We have never cared for lawns, and have always used that space to create compost, and raise such plants as fruit trees, roses, lavender, and edible groundcovers such as nasturtiums, mints, and tradescantia. This is one of the "little ways" we choose to not contribute to the waste of water and fuel that goes into the care and maintenance of lawns. It is one of our little ways in which we can take charge and be a part of the solution.

And we have spoken up when other neighbors cut their "weeds" down to the bare soil. This is as foolhardy as a lawn, even worse, for it dries the soil, reduces the amount of moisture that that soil can release into the local atmosphere, and contributes to desertification.

Once you learn about the uses of plants, you become a confirmed ecologist. You will not want to pull "weeds" pointlessly, and you would not scrape plants down to the bare soil, as so many of the so-called "gardeners" do with their weed-

It is difficult enough to create a beautiful area where there was once a pointless lawn. It is more difficult to convince others, since most in today's mindset will not only ridicule you, but will find ways to fight you, legally or otherwise.

It is wise to find ways to become a part of the solution, and it is also wise to go forward with eyes open, to avoid unnecessary battles. It is wiser to convince your neighbors to the vast practicality of what you do, rather than have to fight your neighbors when they suggest your "overgrown lawn" is lowering their property values.

One person may not be able to change the world, but each of us can change ourselves. By studying plants, and learning their value, I have begun to see how botany is related to the health of the soil, and how the health of the soil is related to the network of animal life on that land, and this has led me to see how the health of the wild animals directly affects my health and well-being. This is a science, not a "New Age" word game, and the application of practical urban ecology should be approached as a hard science, where you can observe positive results, and where you can repeat those results if you follow the same procedures. SURVIVAL SKÍLLS

I pursue both wilderness and urban survival skills. On most weekends, I conduct field trips where our students learn about using wild plants. We collect woods, and we make fire without matches as people in the past have done for millennia. We teach our students to find natural fibres and make such things as twine, baskets, sandals. We build shelters from branches and leaves. It has become relatively easy to be safe and sound in the wilderness using what nature has provided. But most of us live in the city most of the time.

So we teach and practice urban skills too. Urban skills include such things as making compost, finding ways to recycle just about everything, growing fruits and vegetables, and having battery-operated or hand-powered devices where possible. We have solar heated water, and a small solar electrical system. We would never just toss kitchen scraps into the city trash container, nor would we mindless "pull weeds." Kitchen scraps make good soil, and any wild plants that must be pulled get eaten by us, or the animals.

A side benefit of practicing urban ecology is that you're a little more prepared if there's ever a major earthquake or a blackout. But that shouldn't be your overriding impetus for pursuing practical survival. You should pursue it because it's the right thing to do.



We have a friend who always carries a cloth napkin of his own when at restaurants. He doesn't want to participate in the extra paper waste that goes into the napkins. He has even collected other people's napkins (unused) and took them home to use in various recycling projects. "This is very exciting to receive a grant of this magnitude in support of John Muir students and staff. It is of tremendous benefit to this community," said Orange, during the presentation. "It sends the message that students are valued and we are doing everything that we can to insure that every student has the opportunity to go to college."

PASADENA UNIFIED STUDENT REGISTRATION AND KINDERGARTEN ROUNDUP

From March 17 through March 28, the Pasadena Unified School District will hold new student registration and the annual Kindergarten Roundup for students wishing to enroll in PUSD for Fall 2008. Parents with children who will be five years of age by December 2, 2008, and are residents of Pasadena, Altadena and Sierra Madre should register their children directly at their neighborhood school.

Kindergarteners who register by March 28 will receive a special "Kinder Readiness Prep Package" that will help them prepare for kindergarten. Because many PUSD schools are seeing increased test scores, families are encouraged to register early to be guaranteed a space in their neighborhood school. Proof of residency, age and a current immunization record are required. Families participating in the Open Enrollment process will also register during the same time period. After March 28, if spaces are available at schools, families will be accepted from the Open Enrollment wait lists. After May 9, wait lists will not be maintained and students will have the opportunity to register only at their

neighborhood school. Families are encouraged to use the School Locator found on the PUSD website at www.pusd.us to locate their neighborhood

The Ostrich Effect

This 'infirmity' was originally diagnosed when it came to making financial investment decisions. For instance, the investor who only keeps track of his portfolio when times are good but when the economy turns, he sticks his head in the sand and doesn't want to know what is going on. Such a person is said to be

afflicted with the disease (OE). Lately, the definition has been expanded to include all behavior where we ignore the obvious truth and engage in actions that are based upon what we want to do rather than what we should do, ignoring the facts.

If you want to make it happen, and you want this town to thrive, you better make sure you don't have a case of The Ostrich Effect. Pluck those feathers, now!


Coffee With Joffe The Reality Of Politics

When I ran for office in 2004 I thought I was ready. As a government relations representative for Southern California Edison I had spent hundreds of hours at City Council meetings in the San Gabriel Valley and South privacy. Bay listening to other city's problems. I contentious issues and public comment. energy and lots of new ideas only to learn Closer to home, I had served on the City's Ad Hoc Transportation Committee, General Plan Committee and Planning Commission. During the campaign I tried hard to avoid making promises I might not be able to keep or taking positions on matters where I clearly did not have all the necessary information.

But none of this prepared me for the reality of being an elected council member. For example, the first time I met with the City Manager as a new council member I was briefed on several complex personnel issues. Already there was trouble in paradise. Then I found out that the city was in a far worse budget crunch than I realized. The state had already taken away a portion of our funds to fix their own budget deficit. We eventually got the money back but not before we had to reduce staffing and eliminate programs such as the year round lap swim and our city after school care program. In the next difference between statements made on the budget cycle, we had to suspend our street campaign trail and the realities of governing improvement program halfway through the responsibly. Good luck to all of us during five year plan because we couldn't spare the this campaign season!



theprogram. So much for implementing new priorities; we can't even maintain what we have.

Even though our decision-making process should be as open and transparent as legally possible, there are times that we take actions that seem baffling or counterintuitive to the public. Unfortunately it may not always be possible to discuss the reasons for our actions because they involve potential litigation or personnel matters. The public has a right to know—but that right is sometimes trumped by other laws such as employees' right to

On the financial front, it is very frustrating watched how other City Councils dealt with to a new council member come in with great how little of the budget is actually within our control. \$9 million of our \$18 million total budget for example, is restricted funds and can only be used for the specified purpose. Well over half of our \$6 million general fund budget already goes to public safety (police, fire and paramedics) and yet our police department is the lowest paid in the San Gabriel Valley and we have a volunteer fire department.

Unfortunately, although city revenue sources have remained relatively flat, costs have increased each year due to factors outside of our control such as the state retirement system (PERS), health care costs and additional water and air quality regulations.

So do all candidates change once they take office? Inevitably they do, as they learn about the issues facing the city in much greater detail. As I learned, there is a big

The City of Sierra Madre (City), as the Lead Agency under the California Environmental Quality Act (CEQA), has determined that it will prepare a Draft Environmental Impact Report (EIR) for the Stonehouse Project described below. The City will prepare the EIR in accordance with CEQA, implementing guidelines ("Guidelines"), and City procedures. The purpose of this notice is to advise and solicit comments and suggestions regarding the preparation of the EIR, environmental issues to be addressed in the EIR, and any related issues, from interested parties other than potential Responsible Agencies, including interested or affected members of the public.

The City of Sierra Madre prepared an Initial Study for the proposed project on January 15, 2008 and is currently available for public review. The Initial Study was prepared in accordance with the City's guidelines implementing the California Environmental Quality Act (CEQA). The Initial Study determined that the proposed project may have a significant effect on the environment, and therefore, and EIR is required. Copies of available project materials may be reviewed or obtained from the City address shown above.

<u>Project Location.</u> The project site is located at the base of the San Gabriel Mountains within the northeastern portion of the City of Sierra Madre. The 102.56-acre project site, currently known as the Heflin Estate, is located north and west of Stonehouse Road with approximately 400 feet of frontage on the north side of Grand View Avenue. The site is bounded on the north by the San Gabriel Mountains, on the west by residences at the terminus of Camillo Street, on the south by Grand View Avenue, and on the east by residences along Liliano Drive in the northeastern area of the City of Sierra Madre. The northern portion of the site is in natural open space and is contiguous with the undeveloped southern face of the San Gabriel Mountains. The project site is located entirely within the Hillside Management Zone

Project Summary. The proposed project involves the subdivision of 24.67 acres of the 102.56-acre project site into 22 singlefamily lots. The subdivision proposes to use only the lower onethird of the property to create 22 residential lots ranging in size from approximately 15,000 square feet up to 2 acres, two private roads, and a debris basin within the 1989 Hillside Management Zone ("HMZ") boundary. Over two-thirds of the property would remain open space. No homes are currently proposed, however it is expected that the subdivision would eventually be developed on a lot-by-lot basis. Twenty-one new dwelling units will be constructed on the site, resulting in a net increase of 18 units. The project would also require the construction of an earthen debris basin within the 1989 HMZ boundary. It is proposed that the combination debris/detention basin would be constructed in the canyon east of lot 12 and north of lot 13. This basin would be sized to store a debris potential volume of 18,600 cubic yards, the volume required for detention.

The Heflin House and its associated grounds would be retained and would continue to be accessed from the terminus of the Camillo Street in the west-central portion of the property while the three rental units located downslope near Grand View Avenue would be demolished.

Astronomers Find Dark Cosmic Web

ASTRONOMERS HAVE KNOWN for some time that the Universe is full of mysterious dark matter. This invisible matter forms giant structures of filaments, sheets and clusters. How exactly this dark "cosmic web" is distributed throughout the Universe has long eluded scientists.

An international team of astronomers from France and Canada has recently managed to detect, for the first time, dark-matter structures up to 270 million light years in size. These structures extend to more than 2,000 times the size of our Milky Way. The explored scales are three times larger than any previous analysis showed.

To accomplish this feat, the scientists used a relatively new technique called weak gravitational lensing. The light from distant galaxies is deflected by dark matter as it travels through the Universe to us.

Just as the bone structure of a human body is visible on an X-ray, the dark matter leaves its imprint on the galaxy light pattern, revealing itself through gravity. The careful measurement of this effect (predicted by Einstein) has been the major goal of the Canada-France-Hawaii Telescope Legacy Survey.

A team of 19 researchers from 11 institutions led by the Institut d'Astrophysique de Paris (IAP, CNRS, Universite Pierre & Marie Curie), the University of British Columbia (UBC) and the University of Victoria (UVic) has spent several years developing tools to analyze images obtained by the MegaCam, the largest digital camera in the world. The results are a major leap forward, as such large scales and small signals have never before been probed.

Illustration By Virginia Hoge "These results show that weak gravitational lensing is a reliable and accurate technique for cosmology," emphasizes Dr. Yannick Mellier of the IAP. Next-generation telescopes and cameras will measure weak gravitational lensing over the whole sky, using billions of galaxies. Those surveys are expected to help unveil the nature of dark matter and shed light on the even bigger mystery of dark energy.

> DARK MATTER In the midnight hour, Coming home, I walk into A spider's stretched web.

A 366-DAY YEAR—I'm sure we've all noticed that this February had 29 days something that happens every fourth year. It's easy to remember Leap Year because it's also the year of Presidential elections and the Summer Olympics.

The reason we have leap year is that if we didn't insert an extra day in the calendar once every four years, our calendars would not stay in synch with the time it takes Planet Earth to go around the Sun. We orbit the Sun once every 365 ¼ days. So we add that extra quarter-day per year by putting in one extra day every four years.

This shortest month of the year has an odd history. At first, February was not in the Roman calendar, which had only ten months. Then, in about 700 B.C., Numa Pompilius (the second Roman king, following Romulus) added two months: January, at the beginning of the new year; and February, at the end. Numa gave February 29 days, with 30 days in Leap Year. Later, in 452 B.C., the Romans moved February to its present position, between January and March. Finally, at about the time of Christ, Augustus Caesar gave his name to August (formerly called Sextilis) to honor himself, and took a day from February, leaving it with 28. He did this so that his month could have as many days as July, named for Julius Caesar.

Does your birthday fall on February 29? Too bad—you can only celebrate it once every four years! You are one of about 100,000 Americans (and 2 million people in the world) who celebrate their birthday on Leap Year.

The Mountain Clymer By Kim Clymer-Kelley

weeks ago when I wrote about the dangers in the mountains, it got me thinking about some of the other dangers that I ran into while packing on the trails in the mountains...one in particular... one that I never thought about until I came face to tiny face with them...yellow jackets. I had been warned of many things while training to pack with the previous owner, Dennis Lonergan. He had warned me about the conditions of the trails in the rain and of the danger in crossing fast and deep water. He had warned me to take switchbacks slow, to check the cinches on the saddles and the balance of the loads on the animals frequently and to NEVER tie the pack string to my horse. He had warned me to listen for snakes on the trails and all of the dangerous places along the trails where he and others had had accidents...but he never told me (until after I had found out the hard way) about the problem that yellow jackets can create on the trail. Fortunately the very first encounter we had with them was not on the trail...it at least served as a warning that there were yellow jacket nests, and that they did not like to be disturbed, and that we needed to be on the lookout for them when

One afternoon, after a long pack out to Sturtevant Camp, we stopped to patrol a group of cabins. This particular group of cabins sits on

a hillside just above the main trail. I handed the string of donkeys off to Xoxa, left the pack trail and rode down into that cluster of cute little cottages while Xoxa took the rest of the animals down to the main trail to tie them off while he did some patrolling there. I got off my horse, hitched him to a tree and headed over to the first of the cabins. As I circled the cabin, I noticed that on one end of it, the lattice that enclosed the crawlspace under the cabin had been ripped off. Trash and household items that had been stored under the house had been pulled out and strewn all over yard around the cabin.

"Damn bears", I chuckled to myself as I began to pick up the mess. It was not uncommon to find such messes that bears had left behind when they think they smell something good in one of the cabins. Once the cabin right next door to this one had the entire side ripped off and a little cave dug out from under it when a bear decided to take up residence there. He even accidentally turned on the radio inside the cabin. He was not long gone when we stumbled upon that mess because the batteries in the radio were still working. We thought that the owners had been in until we found the gaping hole in the side of the cabin...and the cozy little den underneath it. Anyway...on this particular day as I walked around picking up stuff and throwing it back under the cabin, I came upon the seat cushion of an old leather office chair. It had been broken off of the rest of the frame, which was lying not far too from it. Thoughts of the Three Bears story went through my head as I bent to pick up the pieces. As I hoisted the seat section off the ground, I was instantly swarmed with hundreds yellow jackets who, apparently, had built a nest in the coils and stuffing of the underside of the seat. It took me a second to realize what the stinging and burning was that I was feeling all over my body and for the buzzing to register as that of a swarm of bees. I threw the seat back on the ground and began to dance around screaming at the top of my lungs...waving my hands and slapping at every part of my body that was being stung. I ran as fast as I could away from the area, but the bees were in hot pursuit. I tore past the two neighboring cabins screaming for help and tearing my clothes off, as the wasps had instantly made their way under my shirt and up my pant legs. They were also in my ears and tangled in my hair...they were everywhere and I could not get away from them. I could hear Xoxa calling for me in the distance and by the time he found me at the far end of the cluster of cabins, they seemed to have called off their attack, though they were still hiding in my clothes and hair. I was crying and screeching each time another one stung me...I felt as though someone had taken a lit cigarette and poked me all over my body. Each new sting felt like an electrical shock. He picked up my shirt off the ground and shook it to get any remaining wasps out of it as I removed my overalls and did the same with them. When I was sure that the clothes were free from all insects, I put them back on. Just as I had finished redressing, Dennis arrived. He had been working on another cabin not far from that group and heard all of the noise.

Even with the knowledge of what yellow jackets could do, our first encounter with a nest on the trail, still took us by surprise. It happened on the upper trail just before reaching the Cascade Picnic Grove. The upper trail runs along the side of the mountain for about a mile and a half. It is the trail that the pack train has to use...not as pretty as the lower trail that follows the streambed, but the only one that is safe for equestrian use. The upper and lower trails both branch off of the main trail in the canyon, about a mile and a half from the station at "Fern Lodge Junction", and run for a mile or so separate from one another until the lower trail climbs to meet the upper trail at another junction called "Falling Sign Junction". From that junction it is another half a mile before the trail drops back down into the canyon. The pack trail is very narrow...less than two feet of tread in some places...with steep drop-offs on the downhill side in many areas, and sheer rock faces and boulders flanking stretches of the uphill side...a tight squeeze that in most places makes it impossible to dismount or to walk along side the animals...if you run into problems along that portion of the trail, it is almost impossible in most places to deal with

On this particular day in late August... unbeknownst to us, the peak of yellow jacket season...we were heading out to camp with our usual load of supplies for a group that was coming in for the weekend. I was riding Jake, my adorable but flakey Arabian, and leading the pack string of four or five donkeys, as Xoxa brought up the rear on my other horse, a very mellow chestnut quarter horse mare named Whiskey. We were nearing the place where the trail drops back down into the canyon to a beautiful spot in the stream. Here the water cascades down a steep rocky stretch of the canyon...giving the place its name, Cascade Picnic Grove. As I rounded the bend and began the descent to the streambed, I suddenly heard a huge commotion behind me. The donkeys pushed frantically up on Jake's rear making him dance nervously and bolt forward on the narrow trail. I dropped the lead the lead rope of the pack string and hurried Jake down the trail to safety of the picnic grove. The donkeys followed in close pursuit charging past me as I crossed the creek and stopping once they reached the clearing on the other side. On the hillside around the bend and just out of sight, I heard Xoxa cursing loudly and nervously. This was followed by a loud grunt and the sound of something tumbling down the hill through the dried leaves. I realized that something or someone had fallen off the trail and down the hill. At that point on the trail there is a steep treed decline of about thirty feet and then a fifty-foot cliff that ends in the middle of the cascade. Fearing the worst, I leaped off of Jake hitched him to a tree, and tore up the hill, passing Whiskey as she raced down the trail. I called to my partner and feared for the worst when he did not answer. When I reached the top of the hill I found Xoxa kneeling on the hillside against a tree that grew just above the edge of the cliff...it had saved him from falling the fifty feet or more onto the rocks below. He carefully made his way to the top of the hill and worked his way over to a place where he could climb over the retaining wall and back up on the trail. With the exception of a nasty raspberry on his arm (as it turned out, from a poison oak vine) and five or six bee stings, he was okay.

We encountered hives like that at least once or twice a summer...sometimes more. Each time it took us by surprise, but we learned better what to do...drop the lead rope for the string and get the hell out of the way because the donkeys would mow you down or knock you off the trail if you didn't. I would usually run Jake down the trail to a wide spot and give them room to get by. Being on the lead animal, I never got bothered, but the yellow jackets would swarm the donkeys and whoever was following them. I later heard many stories from Dennis and Bill Adams (the original owner of the station) about their encounters. They were firm in their belief that yellow jackets posed one of the greatest threats to packers on those trails. Usually they do not attack hikers who are just passing by unless they step directly on their nest (which are usually in the ground along side the trail). So let this be a warning to all of you hikers...if you notice a few bees flying in one area along the trail, keep your distance and walk quickly and quietly by, carefully watching your step as you go. Believe me, they are lightning fast and very short-tempered, and you do not want to make them angry.





Fu Shing Restaurant of East Pasadena

If you have watched my TV Show, The Chef Knows on KJLA TV you know I live for good food!!! A few issues back I had mentioned that King Crab Legs are one of

my favorite dishes ... following closely is Maine Lobster. And if you have followed my reviews I have said time again, that lobster is...well, lobster. As long as it is fresh!!! So, why over pay?!

The Fu Shing Restaurant in East Pasadena, like many Chinese restaurants, offers a nice selection of seafood items - one being a live Maine Lobster. Fu Shing serves it three different ways: Steamed (my choice), garlic or sesame. The Chef cooks the latter two in a wok and it is served cut-up. If you are a lobster lover like I am, the price is right. Usually about \$1 or \$2 above market price, depending on the season. Owner Cindy Chang doesn't mind if you order two. There are no

Another good bet is the Explorer Dinner; it is a multi-course dinner for four that showcases some of Fu Shing's best dishes, currently priced at \$18 per person. Please go to www.fu-shing.com for current menu and updated prices. What you get - Starters: cold appetizer salad, a hot appetizer wonton with real crabmeat in a tangy chili paste. Next is the South Seas Seafood Fire Pot with five different seafood items. The main courses include: Jumbo Scallops, Fire Cracker lamb, Mayo Shrimp with longan, Macadamia Nut Chicken, fresh catfish and a Buddhist Feast in a Noodle basket with fresh vegetables.



Sitting On Top Of The.....

So much is going on. I've made a shift in my life, the

effects of which are rippling everywhere (of course) and figuring out how to stay "on top of the wave" rather than get pulled under by the cross currents is interesting. Of course, I always did love the balance beam, and the uneven parallel bars, not to mention Tilt-a-Whirl, trapeze and just our plain old back-yard swing. I have (blush) even been known to ride that circular thing in Memorial Park's playground, when no one else was there, back in the days when I walked past it on my way to the post office really early in the morning. Movement - it's so important. And so we "exercise" - puff, puff - walking, jogging, the gym, at home.

So why were we talking about chairs the other day? I like one that helps me flex and strengthen my back while sitting. There's a great stool available at one of the back care furniture stores. It has a sort of "bobble head" seat. This means that when I sit on it, I'm always moving one way or another - kind of like riding a horse - exercising those core spinal muscles continuously. The only problem with it is, it's not on wheels. And sometimes things are just out of fingertip range, leading one to s-t-r-e-t-c-h just that little bit more ... and maybe fall off. Seems I'm not the only one this has happened to, either. Now, I don't know about all of you, but for me, within a few moments of hitting the floor, and


deciding that I was OK, I felt odd things happening. A pinch here, an ache there, a funny feeling there, just the surprise, right? Nope. Falling out of a chair pushes the floor-hitting parts of the body inwards, with effects rippling through neck, spine, lumbar region - flexing and torquing muscles, tendons, ligaments and nerves. Heck, we're sturdy and strong. No need for an adjustment, it'll work itself out. It

However, particularly with younger children, and with those of us less active than when we were walking maybe 60+ miles a week (civil engineering surveys have you walk a lot)it's important to have a quick realignment. Children because they don't know how to say it's aching and you want them growing up straight, and older folks because non-alignments can amplify other aches and disturbances.



RIFLEMAN -Revisited By Brad Eastland, Sports Editor

I picked up DirecTV for my new house the other day. One of the "free" channels they gave me for three months to suck me in and induce me to buy more channels

later on was "The Western Channel".

Shrewd channel surfer that I am, I noticed right away that one of the old black-and-white reruns "The Western Channel" shows a couple times every day is The Rifleman.

You older folks remember The Rifleman, right? Reformed outlaw and widower turned rancher Lucas McCain, played by Chuck Connors, lives on a sleepy little spread somewhere in the New Mexico Territory with his young son Mark, and living in such a sparsely populated corner of the world it sure was amazing how poor Lucas was pushed, goaded, and generally compelled by forces beyond his control to participate in a life-ordeath gunfight in nearly every single adventure. Fortunately, ol' Luke was justly known far and wide as "The Rifleman", faster and more accurate with his Winchester rifle than any man with a handgun, employing a modified loop-lever-&-trick-trigger mechanism which allowed him to crank off his rifle rounds in rapid-fire succession, making him the most feared gunman west of the Rio Grande. The Rifleman ran for six years in the late 50s and early 60s, it had the best and most memorable theme song in television (I bet you're humming it right now), the best opening sequence in television (Lucas pumping forth twelve crisp rifle shots in that rapid-fire succession), Connors himself was TV's most physically imposing leading man (6-feet-5-inches tall, handsome, square-jawed, utterly fierce) and for a little kid like me growing up in Iowa the show was and is a priceless trigger for the pleasant memories of a pleasant childhood.

What's all this got to do with Sports, I can hear you begin to



More than you know. Because Chuck Connors not was only a TV star, he was worldclass athlete as well. In fact he is one of only

twelve men ever to play both Major League baseball and in the National Basketball Association.

The basketball career came first. In 1946 he joined the newlyformed Boston Celtics, and immediately put his indelible stamp on NBA lore. On November 5th of that year, as starting center in the first-ever Celtics basketball game in what was then called the Basketball Association of America, Connors became the first-ever pro player to shatter a backboard by dunking a ball. Cool, huh.

Chuck's hoops career didn't last long, and he soon gravitated to baseball. Mainly a minor-leaguer, the Brooklyn-born Connors managed to get into one game for his beloved Brooklyn Dodgers in 1949 (he grounded into a double-play), and two years later logged 66 games for the Chicago Cubs. He was known for his crazy antics on the ballfield, like once doing cartwheels all the way around the bases after a homer. But in his Major League baseball career he did find time to record 48 hits in 202 at-bats for a lifetime .238 average, including two Major League home runs. Not bad for a future TV icon.

By 1952 Connors' pro sports days were done. He was immediately "discovered" by a motion picture scout, made his film debut in Pat and Mike with Spencer Tracy & Katharine Hepburn, and later starred in several movies alongside big-screen legends the caliber of Burt Lancaster, Gregory Peck, Charlton Heston, and James Garner. But it is the small screen's The Rifleman for which he will always be remembered. It's even on his gravestone.

Perhaps Connors' most fascinating contribution to the great sprawling mosaic of Sport, or at least the quirkiest, has to do with the offspring of a Mr. and Mrs Person, residents of Brantley, Alabama in the early 60s. They must have been big fans of *The* Rifleman, which had just gone off the air in '63, because on June 27th the following year Mrs. Person gave birth to a son, and the couple named him after their favorite TV star: Chuck Connors Person. It's a testament to Connors' crossover popularity that the Persons would ever name their son after him. For the Persons, you see, were African-American. (Ironically, years later and not too long before his death, Connors would earn an Emmy Award Nomination for playing a slave owner on the acclaimed, landmark mini-series Roots.)

How does this story end? Well, young Chuck Connors Person developed an instant aptitude for basketball, was a college basketball star at Auburn, was drafted by the NBA's Indiana Pacers, and was voted 1987's NBA Rookie of the Year. On the court he was known for deadly long-range marksmanship, just as his more-famous namesake was known for deadly long-range marksmanship with a gun. Person averaged over 14 points a game in his long and brilliant career, and he's still on the NBA's all-time top-20 list of career leaders in 3-point field goals made. What are the odds that a black kid would be named after a white TV star, share his reputation for deadly long-range shooting, and play the same pro sport? What are the odds the kid from Alabama would earn the same cool nickname?

What was Chuck Connors Person's basketball nickname? What else? "The Rifleman".









