Councilman John Buchanan Is Ready For A 2nd Term

John Buchanan wants Sierra Madre to remain a "full service small town". He is just as determined to do what he can to make that happen as he was when he first ran for office in 2004. "The issues are different than they were ten years ago", says Buchanan, referring to the financial constraints that plague not only the city, but also the county, state and federal governments. However, he says, "I just can't walk away. My inspiration is the town, the volunteers,".

Seeking a second term on the Sierra Madre City Council, his tenure has not been without

controversy. Projects such as Downtown Specific Plan, the developments at 1 Carter, Stonehouse, the old Howie's Market Site and the skilled nursing center have been at the top of the agenda at almost every council meeting since 2004. That hasn't deterred Buchanan, in fact his commitment is so great he has not missed a single council meeting since elected.

Valley, John has lived in Sierra Madre for the last nine years. He has been an active Sierra Madre resident since 2001 when he began serving on the Sierra Madre Library Board of Trustees. His community service also includes serving on numerous other committees and commissions including the Hillside Management Zone Committee and most recently the Ad Hoc Finance Committee. By profession, Buchanan is an attorney for Southern

Buchanan's vision for the city includes the "greening of Sierra Madre". He wants to "institutionalize comprehensive environmental policies".

The city's finances are also of major concern to Buchanan. As a member of the Ad Hoc Finance Committee, he worked with residents on the committee evaluating the city's budget. After careful review, the committee recommended the passage of an increase to the existing User Utility Tax as a new revenue source to fund Police, Paramedics and Fire services. "We need to vote Yes on Measures U [the user utility tax initiative] and UA [the utility tax advisory measure which directs the funds to public safety] in order to preserve





Saint Rita Parish Will Show 1849 Vintage Painting "The Holy Face" March 14-30

St. Rita Parish, Sierra Madre, will offer the public a rare opportunity to view the recently restored painting, "The Holy Face" from March 14-30. Restoration was just completed by Frank van Dongen and assistant, Evelyn Zumaya, of Harlequin Fine Art Gallery and Art Restoration in Sierra Madre.

The long and convoluted history of this painting bears telling. The Bible tells the story of Veronica, who wiped the face of Christ as he carried the cross to Calvary. The faint image of a suffering man's face was left imprinted on the veil and it reportedly caused many miracles, including the cure of the Emperor Tiberius from leprosy. This veil, a fabled relic, has resided at the Vatican since the 8th century. During 1848, riots erupted in Europe, including the Papal States. In an attempt to restore peace, the pope ordered the relic to be offered for public veneration and prayer. On the third day of this exposition, the smudged image on the veil reportedly began to glow, becoming more distinct and colorful. As basilica bells were rung, crowds of Romans flooded the exposition, and church officials came to witness and document the changes in the face. This miracle lasted three hours. One cleric sketched the change in the painting, and sent it to the pope. An artist in the crowd, perhaps a Spaniard, rendered his own visage, but did not sign the painting. His name remains unknown. In 1923, a Spanish bishop brought the painting to Peru, to honor the centennial of that country's independence, presenting it to an order of Carmelite nuns. After an earthquake destroyed much of the convent, the painting was relegated to storage, and nearly forgotten.

Now the work has once again come to light. Rescued from oblivion, and brought to the United States, it has been lovingly restored by Frank van Dongen and his assistant, Evelyn Zumaya, of Harlequin Gallery in Sierra Madre in order that new generations can reflect and wonder, not only on the marvelous events that took place in 1849, but on the Passion and Death of Christ

nearly two thousand years ago.
The very limited viewing schedule includes docents at the following times: March 14, 8:30-11 and 4-7. March 15: 8:30-10 and 3-7:30. March 16: 1:30-5. March 18 9-12. Holy Thursday, March 20: 11-5. Good Friday, March 21: 3-7. Easter Sunday: 7:30-1:30 during and after Masses. Very limited viewing the week after Easter. More than 8 million Americans had their identities compromised in 2005, according to the latest figures from the federal Trade Commission. For some victims, out-of-pocket damages exceeded \$2,000.00, and many spent 130-plus hours clearing their names. Recipe of the Month: Ham & Potato Bake

~For that leftover Easter ham~

Butter, for pan 6 large eggs 1 ½ cups heavy cream Coarse salt and ground pepper 2 baking potatoes (about 1 ¼ lbs), peeled

10 ounces leftover ham, thinly sliced 1 package (10 ounces) frozen broccoli or spinach thawed - squeeze dry with paper towels ½ cup grated cheddar cheese (2 oz.)

1- Preheat oven to 350. Butter a 9-inch round cake pan (at least 2 inches deep). Line bottom of pan with a parchment


2- In a large bowl, whish together eggs and cream; season with 2 tsp. salt & ½ tsp. pepper. Thinly slice potatoes, drop into egg mixture.

3-Lifting potatoes out of egg mixture, arrange half the potatoes in pan. Layer with ham, broccoli (or spinach), cheese and remaining potatoes. Pour egg mixture over top. Press down firmly so that potatoes are fully submerged in egg mixture. 4- Cover with foil; bake until potatoes are tender, about 1 hour. Uncover, continue baking until golden and set. 30 to 45

5- Cool 15 to 20 minutes in pan. Run a knife around edge, and carefully invert onto a plate. Peel off parchment. Reinvert, top side up. Slice with a serrated knife. This dish is basically a crustless quiche; serve it hot, cold or at room temperature. Serves 10.

Presidential Campaign Cheap Shots By Rich Johnson

It's easy to tell Senator McCain is the only soldier in the race. He's no idiot. He's run for cover. Even left the country for the relative calm of Iraq. Go figure.

But is this all new? Were presidential campaigns throughout our relatively short history conducted with class and good sports"person"ship? Let's pull back the covers of our rich history and take a peek.

In 1800, Democrat-Republican Thomas Jefferson ran against incumbent President John Adams. John Adams, member of the Federalist party, claimed that electing Thomas Jefferson would lead to the "teaching of murder, robbery, rape, adultery and incest." A little over the top? Apparently America wanted to be taught that, for Thomas Jefferson not only won the election but was also relected four years later. This relegated John Adams to become the first one-term president.

Adams (Republican). Adams attacked Jackson's marriage, accusing him of living in sin with his wife Rachel. Seems they married before her divorce was final. She became known as the "American Jezebel". Adams even called her the famous Don Imus unmentionable word! Oh yeah, and Adams also accused Jackson of being a murderer, among other things. I guess that's bad. Jackson accused Adams of providing the Russian Czar with American virgins as servants while Adams was Minister to Russia. Who won the contest? I guess being a murderer is overrated. Andrew Jackson became President. And yes, Rachel Jackson became the first Jezebel. Ironically, the loss made John Quincy Adams the second oneterm president, his father being the first.

In 1848, Whig candidate Zachary Taylor ran against Democrat Lewis Cass and third party candidate John Parker Hale (of the Free Soil party). Lewis Cass and the Democrats attacked Taylor, also known as "old rough and ready" for being uneducated, mean and greedy. And, of course, the Whigs accused Cass of being a liar (And I thought calling a politician a liar was a compliment). Well, in this case the liar didn't win. Zachary Taylor became our 12th president. Interesting bit of irony: Taylor, a longtime army general warned the south that if they tried to secede from the union he would lead the armies himself into battle against them. 12 years later his son would become a general in the Confederate army.



Rose Bowl Problems Go Beyond Cyclists

By Dean Lee

What looked at first six months ago to be a complete ban on peloton cyclists around the Rose Bowl has now turned to become a strong relationship between cyclists and the city with a focus on the big picture making the whole area safe of everyone.

The City Council Monday night during their regular meeting put off second reading of an ordnance, if in effect, would not allow any bicycle formation of more than two abreast where signs are posted.

Although, after the meeting, cyclist did threaten the city they would sue that if a ban were enacted.

"The California Association of Bicyclists organization would bring

litigation," cyclist Chris Ziegler said. "There is California Vehicle Code 21 that basically says the cities can't pass local ordnances that effect behavior in traffic lanes on public roadways."

He said the city could only enforce local laws in bike designated lanes or the sidewalk adding that,

"Bicyclists organizations would be afraid of the precedent that would set."

The council's action did not come before Mayor Bill Bogaard made sure cyclists new the ban could still go into effect immediately if a problem exists.

"Second reading could occur on any Monday night where the matter is properly placed on the agenda," Bogaard said. "So in that regard we are continuing our good faith effort to work with the riders but we are not conceding any change in the direction that we are going at this point."

He added that the council was only suspending action at the time although riders said the city had already notified them of the potential lawsuit.


The proposed ordnance came only after then police chief, Bernard Melekian, said cyclist refused to cooperate saying they were not a formal group. He said they were a safety hazard to the city and that statistics showed a number of collisions between bikes and pedestrians had happed over the last several years.

Council members at the timemadecleartheywould ban the activity if someone did not come forward claiming responsibility. Riders quickly formed an ad-hoc committee made up of world class cyclists.

Councilmember Sid Tyler suggested Monday night they impose permits on the peloton, as is done, with other group activities such as soccer. Cyclist later said everyone from dog walkers to jogging clubs would also have to take out permits.

The peloton is groups of cyclists riding in large formations, between three and six riders across, allowing them to "draft"

gaining great speeds found in world racing events such as the Amgen Tour of California that finished at the Rose Bowl last month.

Riders said they have set up their own set of 11 rules making sure a ban would not be necessary.

They include, riders not overlapping wheels or riding overly aggressively, not to cross the centerline or the white pedestrian line at any time during the ride, no aggressive action against anyone and not to enter into the buffer zone for any reason.

Councilmember Victor Gordo said that he would like traffic officers to regulate the area after personally seeing rules not being followed Thursday

night.
"The majority of people walking or jogging continue to walk and jog in the wrong direction," he said holding a new

flyer on safety rules. "I know that we have the campaign to direct people that the correct direction is counterclockwise but that's going to take some effort.

The city launched "Stay Left to be Right" a campaign aimed a walkers and joggers a week before daylight savings time when the peloton starts for the season. The peloton ride usually started at 6:15 p.m. Tuesdays and Thursdays lasting a little more than an hour. It is made up of 100 to 200 cyclists.

An informal survey done by this newspaper last Tuesday night counted 100 people using the Rose Bowl loop. Of those dogs/strollers, walking rollerblading jogging, or anything other than cycling, 67 of them were going in the wrong direction as indicated by signs on the ground.

She also said they were trying not to disrupt service or reduce it, although that means having a contract approved by the city council by July 1. If not, the line would continue to run but MTA would only run reduced service from Memorial Park to JPL until Sept. 5. After that then line would cease if the city did not take it over.

The governance council

made no mention of it. During a very short public comment period many opposed the council's findings, even Metro San Gabriel Valley Service Development Manager, Jon Hillmer, said he had never seen as many email as this. He personally prepared the report.

"I find it interesting that of the 10 bus lines that are up for cutting or changing about a quarter of the opposing comments came related to bus line 177," said, Jim Cowell Associate Vice President for Facilities. "I think what that shows is

that a lot of people care about this reportedly under subscribedroute."

He then showed a picture of a full 177 bus adding, "As you can see there isn't a set empty."

According to long time San Gabriel MTA Sector Representative David Spence, lines 177 and 256 are miscounted compared to other lines. The two are contracted lines and done by randomly counting the number of people on the bus twice a month by a person compared to an automated counting system on other Metro owned buses.

Cowell also read a letter from a blind Caltech rider that said they would now have to walk from California Boulevard to Colorado Boulevard just to get to work.

A total of 20 bus lines throughout Southern California are proposed to be eliminated.

All cuts are part of a three year Metro Connections, a plan to make up a \$71 million shortfall by the MTA, which some said is due to the large costs associated with light rail expansions such as the Gold Line and the new Purple Line. The shortfall accounts for six percent of the MTA annual budget.

System wide, Metro Connections plans to cut 450,000 bus hours.

La Grande Opening; Adaptive Reuse of Historic Rail Depot

Santa Fe rail was once the main artery between San Bernardino and Los Angeles —the last passenger left the Pasadena Santa Fe Depot & Amtrak Station in 1994, only to have the historic site sit for years until Archstone Apartments bought the property with an agreement to renovate the historic station.

It took seven year and a feat of cutting the building into five pieces, then moving it across the street while the MTA Gold Line station was built, moving it back, and then finally turning the once depot into a world class restaurant.

The latest chapter includes breathing, what was once thought of as a rundown area of Pasadena, new life into the Arroyo Parkway surroundings. Last Sunday La Grande Orange Café, now located in the Gold Line Del Mar Station amidst the recently completed Archstone Apartments, held thier grand opening offering a menu sampling to invited guests prior to the first day open, Monday.

The location of the new eatery is of relevance because it has renovated, vet preserved the historic Depot. La Grande Orange Café is part of the LGO Hospitality Group, known for bringing new life to historic and unusual buildings as celebrated destination restaurants.

Bob Lynn, Founder of the Phoenix-based LGO and partner Craig DeMarco are excited by their new venture in the Los Angeles area. In fact, Lynn's roots are in Southern California. He previously held a position as second-in-command of Houston's, which is owned by L.A.-based Hillstone Restaurant Group. "We previously developed



No Constitutional Right to Home School Says A New Ruling

By Dean Lee

A court ruling last month has local parents, politicians and students fuming alike and, this week, vowing to fight to overturn a surprising verdict that says parents cannot home-school their own children unless they have a state teaching credential.

Last month Justice Walter Croskey of The Second Appellate District in Los Angeles County made the ruling involving a case on allegations of abuse or neglect by a father, which some say had nothing to do with home schooling.

"There was a family, the Long family, and they were part of some private Christian home schooling in Tujunga, and there was some kind of intervention with Social Services," explained Martin Forte, owner of Excellence in Education in Monrovia. At "the initial appearance in Superior Court, Social Services wanted the two youngest children put into public school."

According to attorneys in the original case, Social Services asked that the children be put in a public school to get them away from the father. At the time, the court's opinion was that "the home schooling the children were receiving was 'lousy,' 'meager,' and 'bad." It was also the court's opinion: "that keeping the children at home deprived them of situations where (1) they could interact with people outside the family, (2) there are people who could provide help if something is amiss in the children's lives, and (3) they could develop emotionally in a

Forte said these are all the most common "myths" about home schooling.

"Let's address the big 'S,' socialization," he said. "A properly home-schooled child participates in field trips and park days or sporting events. They have a socialization experience of plus or minus a lifetime. They can be sitting there with a grandparent or a child 10 years younger than them."

in public schools have a socialization experience of plus or minus six months, with the age range limited to those in the grades in which they are. Because of this, Forte also said, "home schoolers (sic) assimilate into society better."

"These are really perceived fears, and this is a major one," he said.

Forte later said the most favorable oversight comes from the parents; particularly "the fact that the parent wants what's best for the child. That involves the parent teaching the child, it [may] involve[s] going to classes we have here, or going to a community college such as PCC [Pasadena City Collage]," He pointed out an 11th grade student, Yeran Torosyan, sitting out in front of the Excellence in Education facility, as an

Torosyan said she is currently taking nine classes, including photography and ceramics at PCC, as well as three AP classes at Excellence in Education. Torosyan said she had been home schooled for the last two Supreme Court to reverse the opinion.

broader world than the parents' 'cloistered' years and that the decision was both hers and her parents.

"We though we would try it out for a year, but I ended up really liking it and doing well." She then added that the court's ruling would force families back into public schools, something schools could not accommodate. Currently there are 166,000 families across the state that home school, according to reports.

Since the ruling, a frenzy of press releases On the other hand, he said, students have come from officials, including State Superintendent of Public Instruction Jack O'Connell and Gov. Schwarzenegger, who issued the following statement March 7:

"Every California child deserves a quality education and parents should have the right to decide what's best for their children. Parents should not be penalized for acting in the best interests of their children's education. This outrageous ruling must be overturned by the courts and, if the courts don't protect parents' rights, then as elected officials, we will."

O'Connell made a similar comment, "Every child in our state has a legal right to get an education, and I want every child to get an education that will prepare them for success in college and the world of work in the challenging global economy.'

El Cajon Assemblyman Joel Anderson called the court decision a misguided decision and an attack on home-schooling. He introduced Assembly Concurrent Resolution 115, calling upon the California



"I have a great deal of sadness and heartbreak that this has gone on for five years." Karen Hayes, Los Angeles.

"Five years and 4,000 U.S. dead... and how many hundreds of thousands of Iraqi's are dead? A \$3 trillion debt that my children and grandchildren will have to pay has got to stop." Ferne Hayes, Los Angeles.

"I am sick of this invasion and I wish that it could just end...it's sad, very sad and I'm just sick of it." Lupe Lujan, San Gabriel.

"The war concerns are no longer a minority. It's now a majority that is absolutely upset as we are about the expenditures. If we are going to rebuild our country for schools, we can't be building bombs." Catherine Buntin, Wilmette, IL.



Alverno's Villa Del Sol d'Oro, beautifully situated on thirteen acres at Michillinda and Highland in Sierra Madre hosts its share of photographic shoots, movies and television shows, while in another area of the expansive and heavily treed acreage, 282 young women attend the Catholic high school built there in the 1960's. The original owners, the Barlow's, sold the property to a group of Franciscan nuns in 1941, who started the school. Then in 1978, Alverno came under the auspices of the Immaculate Heart lay community, becoming an independent, all girl, Catholic high school, not under the organizational arm of the Los Angeles Archdiocesan schools.

According to Ann Gillick, Head of School, the rental the beautiful Villa and grounds helps keep tuition costs down for this private school, though these special uses are governed by a strict set of rules on times, filming, etc. in respect for the neighborhood

surrounding them.

What an opportunity for these young women to study amid this history! Cindy Mc Loughlin, Facilities Manager, commented that classes are often held in the historic Villa and amid the nature on the grounds. A great opportunity for creative writing and

photography students to soak up history and rev up the creative juices outside the four walls of a sterile classroom.

Today, the two uses of the property meld nearly seamlessly most of the time, with little impact on each other. The challenge for the school is that nowhere on the property is a facility large enough to have a regulation soccer or softball game for the school's teams, or drama productions or assemblies for the entire school. When one of those sports teams qualifies for playoffs, for instance, the games must be played offsite, as the fields don't fit the required regulation size. Alverno teams are repeat Horizon League champions in five out of six sports, and the Alverno Jaguars are 2004 CIF Division VI Softball Champions! Catholic Masses and other religious services are restricted as well, since the onsite chapel is miniscule, converted from a small outbuilding from the Villa's heyday. Even graduation must

take place outdoors, on the school terrace.
The school is proceeding with the long process of steps internally with a 5-year Master Plan, and with the city of Sierra Madre, to identify a plan that will allow building of a multi-purpose building on the site of the current tennis courts to house

the functions so important to the life and health of a vibrant school such as Alverno. Upgrades to the sports field are also being researched. Topographic and arborist consultants were contracted, and all the trees have been mapped and tagged, to best preserve the forested atmosphere of the historic site.

I asked Danny Osti, of Osti Tree Service, and longtime Sierra Madre resident, about his experiences with the 479 trees on these thirteen acres, during his extensive tree maintenance there. In this almost overwhelming task, he mused that few of the unusual, original trees planted on the site by the original owners remain, except a rare Chinese Stone Pine, as natural aging and weather take their yearly toll.

City officials have identified a low wall between the villa and the proposed soccer/softball field, which they feel needs to remain in place for historic value. In addition, proposed upgrades to the perimeter fencing would add more wrought iron, to better match the distinctive signature gates on Highland and Michillinda, and to deliver a more homogeneous and attractive face to the neighborhood.

When the plan is approved, the next step

will be to finance the improvements. Any Alverno alumna out there with a spare million or two or three?

NASA'S CASSINI SPACECRAFT performed a daring flyby of Saturn's moon Enceladus on Wed., March 12, flying about 15 kilometers per second (32,000 mph) through icy, water geyser-like jets. The spacecraft snatched up precious samples that might point to a water ocean or organics inside the little moon, which is small enough to fit between Los Angeles and San Francisco.

Scientists believe the geysers could provide evidence that liquid water is trapped under the icy crust of Enceladus. The geysers emanate from fractures running along the moon's south pole, spewing out water vapor at approximately 400 meters per second (800 mph).

The new data provide a much more detailed look at the fractures that modify the surface and will give a significantly improved comparison of the geologic histories of the moon's north pole and south pole.

New images show that compared to much of the southern hemisphere on Enceladus—the south polar region in particular—the north polar region is much older and pitted with craters of various sizes. These craters are captured at different stages of disruption and alteration by tectonic activity, and probably from past heating from below.

"These new images are showing us in great detail how the moon's north pole differs from the south, an important comparison for working out the moon's obviously complex geological history," said Carolyn Porco, Cassini imaging team leader,





A Special Women's History Month Series

Founder of AARP, Dr, Ethel Percy Andrus (1884-1967)

Both the National Retired Teachers' Association (NRTA) and American Association of Retired Persons (AARP) owe their existence to Dr. Ethel Percy Andrus. Her legacy lives on to the benefit of 39 million AARP members and some 275,000 NRTA members. A career educator, Dr. Andrus became the first female high school principal in California, when she was appointed to East Los Angeles High School in 1916. She spearheaded the process to have the name changed to Abraham Lincoln High School in hopes of inspiring an ethnically diverse student body. Her motto, "To serve, not to be served" was applied throughout her life on behalf of genera-

tions at both ends of the spectrum. To have been selected as the state's first female high school administrator is a testament to her special talents and the respect she demanded from her peers and superiors. This is particularly impressive, considering she was born into a world in 1884 where women weren't allowed to vote and had virtually no property rights. Decades of work during the women's suffrage movement finally resulted in the passage of the 19th Amendment on August 26, 1920, which granted the right to vote. It is likely that the climate of unrest among women activists had a profound influence on a young Ethel Percy Andrus, shaping and expanding her horizons about her future.

Her concern for individuals on both ends of the generational spectrum is reflected in her successes as a career educator working with youth, as well as her lasting contributions by founding two organizations that are currently the largest serving those of retirement age.

Inspirational quotes chosen by Dr. Andrus can still be seen throughout the Lincoln High

School campus to this day. Engraved into the exterior and interior of buildings, the quotes serve to carry on her call to excellence, cooperation and other virtues that she championed

for both students and staff. Her teaching careers also included a brief time as a faculty member at Chicago's Lewis Institute, the predecessor of Illinois Institute of Technology. During the latter part of her teaching career, she turned attention to improving the economic plight of retired teachers, which resulted in the founding of NRTA in 1947.

In response to learning that retired teachers were living on very small pensions, and typically without health insurance, she contacted more than thirty companies before finding one willing to provide coverage for retired teachers in 1956. Two years later, AARP was founded to accommodate membership expansion to include retirees from other occupations. AARP is the leading nonprofit, nonpartisan membership organization for people age 50 and over in the United States. Currently, the NRTA is still a division of AARP, serving its educator community.

Dr. Percy's work established standards for other retirement programs that have benefited millions of workers for more than half a century. Her efforts continue to be recognized and celebrated. The nation's oldest and largest professional school of Gerontology at USC is named after her, and she was inducted into the National Women's Hall of Fame in 1993.

It happened again. We were heading home on Foothill Blvd., engaged in some very enjoyable conversation, and all of a sudden, there it was on the south side of the road just before Costco - a CARWASH!!! Not just any carwash, it was one of THOSE carwashes, the kind that you put money in and you "do-ityourself." The kind that, at a moments notice, can turn a pleasurable summer day into a struggle for survival. The kind that can turn deadly to those not savvy enough to have a full understanding of just how these things operate.

Hilton Head Island, SC, 1979. This island had been a second home to me since I was 9. My family first went there in 1965. It was, as anticipated, a wonderful, funfilled vacation. Every night Kim Cr., my sister Karen, and I hit the discos and danced the night away, usually closing the place down and heading off to a private club until the wee hours of the morning. We would return home sometime between 2am and 4am and sleep until 11am or so, have lunch, and drag ourselves to the beach until, in the tropical tradition, the thunderstorms rolled in around 3 or 4 in the afternoon. We would then head home, shower, eat and start all over again. It was marvelous (when you are 23, that is).

One day on the way home from the beach, Kim Cr. and I decided to make an extra stop. Since I was still basking in the glow of new car ownership, I decided that I needed to make sure that the salt air was not taking its toll on my little yellow "Honey Bee", so I headed over to the car wash to scrub it down. What better time to take care of this than when we were in our swimsuits and in need of a bit of refreshment. We pulled into one of the bays and I got out the soap and sponge that I had purchased so that I would be sure to do a thorough job. Kim Cr. stood just outside of the stall to watch.

I closed the windows of the car, grabbed the hose that hung from a carousel mounted on the ceiling of the stall, and deposited my quarters. The water began to pump through the coiled hose. until tears streamed down our faces.

During my father's school days, a required mental discipline was poetry memorization, books and books of it. As an adult, he continued this mental memorization discipline every morning while shaving - we could hear him muttering to himself while the razor bzzzed. Naturally, his mind was like a steel trap and, whenever things would get tense he'd toss out a couple lines of poetry, or puns, or anything to break the tension.

In junior high, I too had to memorize and recite poetry. Naturally, most of what I learned, my father still knew. In an effort to "keep up", if not get ahead, I learned extra poetry, much of which I thought funny at the time. So did my English teacher, because she had me present one recitation to the whole school during assembly. Now, however, my sense of humor has undergone a sea shift, and to me, much of what was humorous is now

All Aboard the Time Tunnel...

Well, Major League Baseball circa 2008 is just about upon us. Optimism abounds. Every team is tied for first place. Dodger fans haven't started whining yet.

It's a glorious time of year.

So then how shall we commemorate these glorious rites of

I know. Remember that terrific old TV show The Time Tunnel? The one where these two scientists go back in time and are thrust into the front-row seats of History and have all sorts of exciting adventures? Well that's what I'd like to do. Go back in time and buy a ticket to three of the most fascinating baseball games in history. You know---'see the magic with mine own misty eyes. Let's do that now, shall we? All aboard for 1908....

September 23rd, 1908. "Merkle's Boner": Don't get excited. It doesn't mean what you think it means.

Here's the story. In 1908 the Giants and the Cubs were locked together in the first great pennant race in baseball history. Every game was as tense as a gunfight. On September 23rd the Giants were about to take control of the race, as Al Bridwell singled up the middle with two outs in the bottom of the 9th to score Moose McCormick from third for the winning run of a 2-1 thriller. Except for one minor detail. Fred Merkle, a 19year-old rookie who was on first base when Bridwell batted, failed to run the play out and touch second base, veering off toward the clubhouse showers the minute he saw Bridwell's hit fall safely. Cubs second baseman Johnny Evers alertly retrieved the ball from the outfield and stepped on second, claiming "force out" at the top of his lungs, inning over. He was right of course. Except for two things: the force-out rule had never before been so rigidly enforced at that early stage of the evolution of the game, and from the ensuing chaos there remains much lingering doubt that the ball Evers retrieved from the outfield was even the right ball! No matter. Umpire Hank O'Day ruled the game suspended until it could be reviewed, National League President Harry Pulliam ruled a few days later that Merkle was indeed forced out, the game was therefore declared a tie and not a Giants victory, they replayed the game a couple weeks later and the Cubs won, beating the great Christy Mathewson in the process, all en route to the National League Pennant and the World Series Championship. All because of what was immediately and for all time termed "Merkle's Boner" (sure, you can exhale now.). Poor pathetic luckless Fred Merkle was hounded and ridiculed for his error for the rest of his life.

Two things more: In July of 1909, Pulliam---the sad wages of ten ruthless, pressure-packed months of suffering the scorn and angry backlash from his decision---put a bullet through his head. He was 44. And the Cubs, the 1908 champs, are still looking for that next World Series title exactly 100 years later.

September 30th, 1927. "The Babe upstages the Big Train": Any baseball nut worth his salt (nuts and salt... I like it) can tell you that on September 30th, 1927, Babe Ruth smashed his epic, recordbreaking 60th home run of the '27 season in the 8th inning off of Washington Senators pitcher Tom Zachary. Naturally, it would be beyond great to time-travel back to Yankee Stadium for that game. But what you probably don't know is what additional treat we'd be in for, namely that we'd also get to see the last game---the very last appearance as a participant on a baseball diamond---of the legendary Walter Johnson, the Big Train himself, perhaps the greatest pitcher who ever hurled the horsehide. What are the odds of that? What are the odds of The Babe's 60th home run and Walter's last hurrah coming in the same game??? Ironically, the Big Train's farewell appearance wasn't even as a pitcher. One of the best hitting pitchers ever, he pinch-hit for Zachary in the 9th inning of that final game, yes the same Tom Zachary who had given up Ruth's 60th home run just one inning earlier. Amazingly it was Johnson's 110th lifetime pinch-hit appearance; he also pitched exactly 110 complete-game shutouts in his career, a record. And history also records that in his final big-league at-bat Walter Johnson flew out to right field, where the ball was caught by....wait for it....Babe Ruth. ('gives me goosebumps just typing the words)

September 29th, 1954. "The Catch": A no-brainer. We've now made it all the way back to the 1950s. Once again it's September, and we're still in New York City. And you are now looking at Willie Mays. My all-time favorite player. My baseball god. I did see him play a few times in the late 60s, but by then he was old and tired and slow and nothing like the whirlwind that burst upon the baseball scene in the 50s like a runaway bowlegged comet. Now close your eyes and see Willie go: Game One, '54 World Series, 8th inning, tie game, runners on 1st and 2nd, no one out....crack!....the Cleveland Indians' Vic Wertz, a burly left-handed lumberjack of a batsman, hammers a high line drive (or low fly ball, if you prefer) into the deepest recesses of center field of the New York Giants' cavernous home ballpark, the Polo Grounds. It's a sure triple and two runs in the bank for Cleveland, and a sure Game-One win....except that in center field is Mays. Mays, most skilled of outfielders, Mays, Mercury in cleats, Mays, the one man living or dead with the ability to spy, track, measure, outrun, and then gently gather in this 460-foot bullet before it one-hops the wall. Which he does, over the shoulder, his #24-clad back to home plate. Look at him! And look at that cannonlike throw back to the infield to keep the runners from scoring! Now then---aren't you glad you all came back to 1954 with me?

"The Catch" is generally considered not the greatest grab in baseball history, but rather, most certainly, the most famous, momentous, and monumental defensive play ever produced by a baseball player. The World Series tends to do that---it turns greatness into mythology. "The Catch" broke Cleveland's back. The Catch" was the whole series. The Giants swept the Indians four straight. And neither the Giants nor the Indians have won a World Series since.

How'd I do? Are you jazzed, psyched, ready for that first pitch? I thought so.

"Play ball!"






