City Clerk - City Treasurer Forum: Never a Dull Moment in Sierra Madre

Listing her occupation as a community volunteer City Clerk candidate Karma Bell gave incumbent Nancy Shollenberger a run for her money Tuesday during a candidate forum at the Kiwanis Club.

The same could not be said about the office of Treasurer as one candidate was a no show leaving George Enyedi once again without any challenge. Although unlike the last forum at city hall he was able to answer questions given by the public and have them recorded.

"From one candidate I did not get as much as an RSVP to my letter, to my phone calls, to my emails," said Kiwanis member Clem Bartolai after moderating the meeting. "Even up until the last day I did not receive any response whatsoever." The candidate he spoke of is Salvatore Tesoro, III who has not appeared at any of the public events.

Shollenberger, before saying anything about being reelected, apologized for an error on the sample ballots regarding Measure U the Utility User Tax.

"Before I say anything else I want you to know that I am sorry for the error in the sample ballots," She said. "I accept full responsibility for that error and have already addressed it with corrected ballots and a press release. I will reimburse the city for the cost to print the corrected ballots and postage totaling

She went on to say this type of error has not happened in all of her 24 years of service. After assuring it would never happen again she launched the first of a series of attacks on

Before her two minute opening statements were over Shollenberger had already criticized Bell a number of times including her association with former Councilmember Enyedispoke very little during the hour forum Bart Dole. Shollenberger made no apologies but long enough to explain what he would do for the fact that she was opinionated, saying as City Treasurer and his qualifications for she supported Measure V. she then again the job. He is a Certified Public Accountant criticized Bell for her stand against Measure and long time community volunteer.

Bell made a number of campaign promises that many in the audience agreed with, including conducting all city business in city hall. Shollenberger runs a secretarial service out of her house and said this gave her the opportunity to have more office hours although she did say that some of the forms such as the form 700 conflict of interest should be stored at city hall.

Bell also said she wanted to hire a deputy city clerk, so that if she ever, "got hit by a truck," she would not be irreplaceable something Shollenberger said would only cost the city monev.

Just this year Shollenberger resumed the task of taking the city council meeting minutes but at a cost of \$650 a month in addition to her \$250 stipend. A question was asked about Councilmember Kurt Zimmerman offering to give his \$200 stipend to Shollenberger although Shollenberger said she never received a dime. Zimmerman said at the time the city attorney and city manager would have to figure ut how to make that happen. In 2004 when the council refused to increase the funding for Shollenberger, she stopped taking minutes and the task was relegated to staff. On February 1, 2008 she resumed taking the council's minutes. Bell has indicated that she would do all of the duties required by law of the City Clerk for the same \$250 stipend as all other elected officials receive. Bell also said she would not charge the city an additional \$6,000 plus to run the elections.

At times Shollenberger, acting frustrated, demanded Bell answer questions in a particular way after she thought Bell was avoiding the questions. At one point Bell answered the same question three times.

By far the most ironic comment came from Shollenberger saying residents need change. Change is the focal point of Bell's campaign.

City Clerk Donates To Sierra Madre Police And Fire

In what appears to be a last minute effort to mitigate any damage done to her campaign for re-election, Sierra Madre City Clerk Nancy Shollenberger released copies of letters she sent on March 26, 2008. The two letters were addressed to the members of the Sierra Madre Police Officers Association and the Sierra Madre Volunteer Firefighters Association and promised each organization \$3,000.00. Combined that amount represents the approximate cost of the sample ballot reprinting caused by Shollenberger's admitted error.

The letters, which are identical, state, "As you know by now, I made an error in mislabeling the ballot propositions describing the "Arguments In Favor of Measure P".

"Recognizing the headaches and the financial cost, which my error may have caused, I offered to reimburse the City for all costs incurred in correcting this error. To my disappointment, the City Council felt it would set a precedent, and would not accept such a reimbursement." She goes on to talk about the amount of criticism she has received and suggests that a better way of dealing with this "unpleasantness" would be to donate \$3,000 to each group.

She ends the letters by saying, "While I don't expect to be exculpated from my mistake because of this act, I sincerely hope that you will accept my donation."

Shollenberger, who says this is the first mistake she has made in 24 years, has not only been under attack for the error, but also for what many have called "abandoning her duties' when she was not able to come to an agreement on compensation.

She has also been criticized during this campaign for her failure to file public notices for 8 Staff/MVO years from 1993 to 2001.

Sierra Madre Rotary Tours Methodist Hospital "Behind the Scenes" Photo and Story By Chris Bertrand

President-elect Carmen Thibault of Sierra Madre Rotary arranged a fascinating and reassuring "behind the scenes" tour of the ER, CAT-scan equipment and labs, Catheterization labs and more on March 4. Thibault called on her connections as a Methodist Hospital Foundation board member to expose these dedicated community volunteers from Rotary to the hospital's expanding services and staff. Methodist's Foundation Board started "Partners in Health" which facilitates community group tours of the hospital's amenities and services.

It was clear the staff was both proud and professional as they shared details about the advanced procedures possible with new equipment, as well as how to better utilize slower older equipment. Lab representative, Lance Yamanata demonstrated how the x-rays, CAT scans, etc. are available digitally from anywhere in the world, with a password, allowing seamless instantaneous results access for off site physicians and for second opinions. The digital system also provides access to the dictated pathologist report, for an immediate reading of the expert's impression. The patient can also request a CD to keep on file at home, or to carry to another facility, if needed. They will eventually be "hard copy free" with digital records of tests stored on servers. A back up system duplicates the archived records in case of server failure. The cost savings per record, reliability and accessibility of a digital system has made this a major step forward for Methodist.

Emergency Room charge nurse, Sue Walker, toured the Rotarians through the current ER, the nearly complete temporary ER, which will be up and running shortly, and described plans for the construction of new facilities increasing the ER from 17 to 28 beds (plus and 18-bed observation unit), and the procedures for the transition period since ingress to the ER will change. She pointed out that Methodist, like other active area hospitals have seen major increases in daily ER patient count, with the shutdown of Santa Teresita and other local hospitals and ER facilities. Just a couple of years ago, they saw under a hundred ER patients a day. Today, the count regularly hits 130. Specially certified ER staff use a radio system to juggle

response times in the area. In January, Methodist was certified as one of only 12 LA County, STEMI receiving center hospitals. When paramedics identify patients with heart attacks, these centers utilize strategies identified with a faster "door to "balloon" time, to fast track the interval from hospital arrival to opening of a blocked artery with an angioplasty balloon.

In a separate discussion about ER services and disaster preparedness, she stressed that Neighborhood Watch groups and personal responsibility are the key to coping in the first few days of a large disaster. She commented everyone needs to be prepared to care for themselves for at least a couple of days, as emergency personnel will likely be called to locations of dense population and epicenters in a disaster. She noted that her own Neighborhood Watch program includes resident's home, work and cell numbers, equipment location like large ladders and chainsaws and home floorplans.

Dennis Oxton, Director of imaging and diagnostic services, brought the group through the newest CAT scan facility, which records 64 slices instead of a single slice of the body at a time, significantly

reducing the patient's time on the table. The new equipment will record the entire heart in about nine seconds. Oxton's technician offered a software demonstration of a blood vessel in the brain, manipulated it to automatically remove surrounding bones and rotate the vessel with the clarity of a high definition television program, pointing out plaque. The next generation of this equipment will view over 300 slices at a time, though the cost will be several million dollars for this hoped-for future acquisition.

Marcus Acosta, RN in the Cath Lab, greeted the group in the series of labs used for installation of stents, and referred to the evolving saga of stent material usage, from stainless steel,

to chemically treated steel stents, back

to plain stainless, with anticipation of a degradable stent that will eventually dissolve after its useful life. He pointed out that while the newest and best equipment allows for quicker procedures, Methodist maintains the other equipment for less time-constrictive, less intricate procedures, such as


checking stent placement. Sierra Madre Rotary President, B. Durward Howes, presented the hospital with a donation, in appreciation of their efforts in providing our community with reliable, timely and professional


Our current City Clerk has not lived up to the Oath of Office or the Statutory Laws. She has:





MountainViews-Observer Troubled Future for the Gold Line Expansion

Racing a June deadline, a plethora of local elected officials gathered Wednesday at a future Azusa Gold Line station to urge the Metropolitan Transportation Authority Board to include the Gold Line extension in their Long Rang Transportation Plan

Although a decision to include the extension could come as soon as next month said Congresswoman Hilda Solis flanked by both Congressmen Adam Schiff and David Dreier. She said for ever \$1 spent on transpiration infrastructure, surrounding communities gain \$6 in jobs and economic development.

She also said combined, communities of, the Arcadia, Monrovia, Duarte, Irwindale, Azusa, Glendora, San Dimas, Verne, Pomona, Claremont and Montclair, have invested more than \$2 billion in development along the 24 mile proposed

Schiff said they had a choice, "either we take advantage of those resources to build the infrastructure in our region, to get people out of their cars and get them where they need to go, or we send those resources to anther part of the state that is more organized then we are."

He then stated that they

Villaraigosa and the MTA board to get behind the project, not just in theory, but in "dollars and cents."

He said the backing of Villaraigosa, which he thinks they have, could give them hundreds of millions in federal funds. He also said there was, most likely, a majority of support on the MTA

board. "We pay tax dollars like evervone else and we're not going to sit idly by and watch this project go fallow," Schiff explained.

Metro Gold Line Foothill Extension Construction Authority spokesperson Susan Hodor explained Friday that although they are not part of the MTA



the Federal Transportation Authority said they must have the backing of the MTA to operate the line. The FTA also said they must have matching MTA funds making it imperative that the project be put into the MTA long rang plan.

She added that because the project was not one of the MTA's own they are not quick to embrace it and that is why so many public officials have now come out to show support including, Covina Mayor John Keen, Duarte City Councilman and MTA Board Member John Fasana, Mayor of Azusa, Joseph Rocha and many others including President of Azusa Pacific University and the President of Citrus College.

Rocha suggested anyone that had not gone and seen Who to go do so.

"Because at the end the whole community has to come together and it is not until the last little boy makes his voice heard do they acknowledge their existence," Rocha said. "With so many distinguished visitors here we need to let the MTA know, we are here, that we exist, and this is a project that is much needed.

He then called on the MTA not to leave "Any of them standing at the station."

Dreier summed up his speech this way, message is a simple one, let's getter done."

Schiff also said the extension was ready to go and that no other project in L.A. County was as ready.

Looking at the city's future housing needs, residents packed a community room — across the street the embattled from Heritage Square Project— Tuesday night to discuss everything from homeless programs to preserving affordable housing to the production of more low income housing in other

parts of the city. During the two hour meeting public input was gathered by breaking the 100 or so people into four groups, production, Housing Housing affordability, Homelessness and rehab/ preservation. In some groups tensions ran high. Housing referred to both renters and homeowners

alike staff said. The city's next mixedhousing element will extend through 2014 they said. The housing element, part of the city's General Plan, is there to assess the need staff explained. In a very watered down explanation of the states housing mandates staff only said the city had to prove that affordable housing could be built. The city was in good shape they said as a number of people chuckled.

The city's Senior Planner Bill Trimble said after a number of people want to see rent control in the city although he also said the issues was something the city council did not support.
"There is a desire for rent

control in the city," he said.

"Control as a response keep up fast enough with to the rapid increases in ranges of rent for some people."

Trimble also said an idea was brought up giving assistance to landlords so that rents would not be raised.

"There might be a way to removing some of the financial pressures on the landlord side," he said to a follow up question earlier, "Rents are driven by the financial needs of maintaining and renovating buildings."

He said these were just two of many issues discussed on housing affordability. He also said that although the large amount of information gathered would be given to the city's planning commission there was no guarantee any of it would make it into a final report

to the city council. Residents also said the city needs more homeless prevention programs and transitional housing something Trimble said his group was also concerned about.

"There was interest in programs that support tenants now living independently but feeling somewhat at risk after recently being homeless," He said.

ConsultantMarkHoffman said his group saw a critical need to preserve affordable housing from a current redevelopment trend.

"The city is losing more affordable housing units to reinvestments and developers speculation," Hoffman said. "They can't the housing affordability minimums.

He also said the city should offer aggressive incentives so that nonprofits and private individuals could acquire and rehabilitate multifamily units, singlefamily homes and historic homes. He said grants should be available and funded though the city going so far as the city purchasing those properties to rehabilitate.

Inspections currently being done for section 8 housing every four years should be stepped up to once ever year bringing them inline with government code he said. There was also a need to spread affordable housing all over the city.

"Affordable housing is primarily concentrated in the northwest area," Hoffman said. "But there is a desire to expand beyond that into east Pasadena and to the south through an aggressive affordable housing effort."

Before the groups were formed city staff gave a short presentation where a number of maps showed a heavy concentration of low income and very low income housing in the city's northwest something not surprising to many who attended as they live in the area.

Consultant Karen Warner who led the housing production group said most people fell into two groups, one that wanted to stop down zoning and increase density building more affordable house and the others that did not

want big ugly buildings. She also said people wanted to see the parking requirement reduced in accordance with the green plan and speed up the permitting process for new construction. People also wanted to explore the idea of manufactured housing.

Councilmember Jacque Robinson said while the groups met that many residents think the issue of affordable housing is the most important factor in the selection of a new

city manager. "Well, I have seen looking at the comments coming through the city's website," she said regarding the selection of city manager. "One of them is what do you think the most important issue facing Pasadena is? It's right up there, if not number one."

Robinson was the only councilmember to attend the meeting and said that even she had a problem with the high cost of living in Pasadena.

"There really is no in between even for a young professional like myself," Robinson said. "I've even had to struggle... so I can't imagine what a family of four or five must go through."

Some asked about the status of Heritage Square. They were simply told that the city's housing division was soliciting proposals for a new mixed-use development on this site, the exact language used on the city's website. Heritage Square was scrapped after community outcry over the developer selection.



The first of several scheduled community forums regarding the reinvention of John Muir High School was held last Wednesday to a substantial crowd of supporters. Among those in attendance were parents, students, and staff of JMHS, along with a mixture of Pasadena Unified School District board members and a few representatives from other area schools.

Attendees congregated in the auditorium of the school. Then after a brief welcome by Interim Principal Sheryl Orange and PUSD Interim Principal Sheryl Orange and PUSD Superintendent Edwin Diaz, all progressed in to breakout sessions held throughout the campus to discuss the themes of the five new academies that will open at the school in September 2008. The "Freshman Success Academy" will be established for all incoming 9th graders, while 10th through 12th graders will be able to select one of the following: Arts, Media & Entertainment; Business & Entrepreneurship: Engineering Business & Entrepreneurship; Engineering keeping this effort for a very long time," he Climate".

Diaz shared that earlier in the day he was in Sacramento with Pasadena Mayor Bill Bogaard to take part in the "California Mayor's Education Roundtable". During that meeting data was presented about the drop-out rate in California and the achievement gaps.

"The suggestions that were identified as strategies to apply in order to close the achievement gap... were [actually along with] the designed principles that are being suggested for John Muir High School," said Diaz. "So, the whole idea of personalized smaller learning communities engaging smaller learning communities, engaging business careers to provide experience as part of the high school curriculum is really considered the best practice throughout the

According to Diaz, there have been many schools and school districts that have identified ideas very similar to Muir, only to see them not implemented. "It's all about

At this point the breakout groups went to their assigned classrooms to discuss the upcoming changes in the curriculum. Principal Orange's room was also mediated by Dr. Eddie Newman, a woman that once held the helms as the principal of Muir for seven years. The feedback from the participants recommended that in order for the academies to be successful teachers must "actually care and create a personal connection" with students. It was also brought up that there needs to be "greater parent involvement" and internships should be provided to apply "real world experience"

for the students.

"One of the things that will happen with the academies is that project-based learning is integrated," said Orange. "And as far as internships—we are in the process of bringing partners on board."

The next Muir Community Forum will be held on Thursday, April 24, 6:30 p.m. at Loma Alta Park. The topic will be "School

Eleven JMHS students competed against 50 Los Angeles-area high school teams to build a robot, compete in a series of matches and participate in interviews with competition judges. The JMHS team, which was co-sponsored by NASA, Neighbors Empowering Youth and Mustangs on the Move, won the "Rookie Inspiration Award"

"This was an eye-opening and mind-blowing adventure for the JMHS team," said David Brinza, a JMHS Team Mentor. "They enjoyed the high-energy atmosphere and developed an appreciation of the high standards to which FIRST teams are held.

The JMHS team successfully delivered a competition robot after a six-week "build season" ending in mid-February. Over the

past month, the students worked hard and gave up their evenings and weekends to further prepare for the competition. Preparation activities included designing t-shirts and promotional items, performing community service and practicing for interviews with competition judges.

The FIRST Robotics Competition is designed to help high-schoolaged young people discover the excitement and rewards of the engineering and technical professions. The FIRST Robotics Competition challenges teams of young people and their mentors to create the robot using a standard "kit of parts" and a common set of rules. Teams design and build robots with the support of volunteer engineers and other professionals. 

In fact, I will defend vigorously anyone's First Amendment right to express an opinion about a public official or a public matter whether or not I agree with it. But that doesn't mean public officials shouldn't respond to misstatements or misrepresentations. The following article is primarily taken from a Letter to the Editor I wrote in 2006 in response to an article that appeared in a local paper. Since these and other rumors still seem to be circulating, I

thought it might be worthwhile reprinting the

letter and addressing some new issues that have

surfaced.

The original article claimed that I had "hidden" my ownership of a "construction" business from the public. I have since been told by perfect strangers that I am a building contractor or, worse yet, a developer. Nothing could be further from the truth. Here is the response I wrote two

"Let's get the facts right.... My business was described in my campaign literature and in an article in the September 1-7, 2005 issue of the Sierra Madre Weekly. I am half owner of an environmental consulting and contracting business, Clean Fuel Connection, Inc. dba SolSource Energy, CA License # 770564. I am proud to be a small business owner in a field that has not traditionally employed many women.

As pointed out in the Weekly profile, our company sells and installs infrastructure for electric vehicles, natural gas vehicles and small wind energy. In the past two years we have expanded into photovoltaics (solar energy). As an environmentalist, I drive an electric car that uses no gasoline. I am not sure how that leads to the conclusion that I have a "bias toward development...'

As for the implication that my business interests affected my vote on 1 Carter, let's recall that I voted against the Maranatha High School project while on the Planning Commission. I voted for the 1 Carter housing project for the same reasons as three other council members--because I believe it onsibility as Council member to tightly control the development of housing that Maranatha is legally entitled to build rather than bankrupt the city in a futile court fight that we would ultimately lose. And as for advancing my business interests, I don't recall any requirements in the 1 Carter project conditions for EV chargers, natural gas refueling units or solar panels.

Do I want to see houses at 1 Carter? Of course not. But when elected to the Council I took an oath of office that included a commitment to uphold the law to the best of my ability. And that is what I believe I am doing."

These words ring as true today as they did 2 years ago. Since then the owner of the 1 Carter and Stonehouse properties have filed seven lawsuits against the city. In order to try to find some resolution to the seemingly endless litigation, the City Council and the property owner sought to craft a settlement agreement that would halt the lawsuits while the developer submitted a proposal through the normal Planning Commission review and recommendation. *Unlike settlement* negotiations in most cities, the entire process was done at public meetings with full community participation. But in February 2008, after months of discussions with the developer and residents on what might be acceptable to all parties, the Council unanimously turned down the Settlement Agreement as inadequate in addressing the concerns of neighboring residents. All parties are now back in court while we review our options.

Another issue that keeps resurfacing is the city's financial situation. Like many small cities around the state and the country, Sierra Madre is struggling to keep pace with rising costs for everything from salaries to employee retirement funds to the cost of construction. Interim City Manager Don Hopper (formerly long-time City Manager of Monrovia) put it best in his eloquent farewell to the City in June 2008.

"I made that comment when I first got here, that this is a remarkable City, that you do more with less than probably any city that I am aware of, but make no mistake, you are living off of your savings, and that is a very dangerous precedent to get comfortable with. You have no reliable ongoing revenue stream that can address your future expenditure levels and so you are going to have to do something?

That "something" was forming a citizens' Ad Hoc Finance Committee to review the city's Mayor

finances and recommend ways of generating additional funds for public safety. The 2007-2009 budget process was a wakeup call for the City. Our budget is heavily dependent on property tax revenue but the city receives only 16 cents of every property tax dollar paid by residents. The 1 percent of local sales tax revenue we receive from the State Board of Equalization amounts to only \$200,000 per year. Even without any increase in staffing levels or any cost of living salary increases, expenditures will continue to grow faster than revenue. By the end of this two year budget cycle, it will be difficult to maintain a balanced budget let alone fund police salary increases or paramedic service.

> The Ad Hoc Committee carefully scrutinized the city budget and agreed with Don Hopper's assessment. After several community input meetings and countless hours of discussion, the committee recommended that the Council put a

> Utility User's Tax increase on the ballot to secure a new source of funding for police salaries, paramedics and other essential services. The result is Measure U and UA on the April 8th ballot. Measure U would increase the utility users' tax from the current level of 6 percent to 8 percent in 2008-9, 10 percent in 2009-10 and 12 percent in 2010-11. If the increase is not re-approved by the voters at that time it will step back down over 3 year period. The Measure also modernizes the tax to include additional utilities and ensure continued collection of the tax on telephone service. Measure UA is an advisory measure to gauge the public's agreement with the proposed use of the funds.

> Rumors have surfaced of a budget that ballooned from \$6 million to \$18 million under the current City Council. The two numbers are correct but that is about all that is accurate in this statement. The 2007-8 General Fund budget will top \$6 million for the first time in the city's history. General Fund money is unrestricted money typically used for the day to day operation of the city such as police and other staff salaries, utility costs, supplies, mileage etc. When you add in the \$18 million of restricted funds such as the water infrastructure funds, the total grows to \$24

This number sounds great but hides the fact that the budget for day-to-day operations has been increasing about 2 to 3% per year, while costs have been going up around 5% per year. These costs are mostly outside of our control like health care or employee retirement. The increase in the restricted funds budget represents staff's hard work and staff's successful efforts in obtaining one-time grant funds for specific projects, usually equipment purchases or capital improvements such as the reconstruction of the Grove and Mira Monte reservoirs.. Once that money is spent on the project it is gone. It also does not create ongoing costs and in fact, often reduces the General Fund outlay for maintenance and repair of old equipment and infrastructure.

The status of the City's Audits has also been the subject of much discussion. In 2006, the City Council was informed that a number of reports including State reports and City audits had not been completed despite previous assertions that everything was being done properly and on time. The delinquent reports had resulted in thousands of dollars in fines which the Council was unaware Once uncovered, the problem was swiftly addressed. The City Manager and City Council took action to make personnel changes and bring in experts in municipal finance experience to bring all audits up to date and prevent similar occurrences in the future. The original problems dated back to well before the 2004 Council election and had only compounded over time. At no time were any funds missing. The errors ultimately turned out to be about how funds should be accounted for not the amount of money. None of the corrections made affected the city's financial position, but the absence of proper procedures and the length of time before the problem was discovered were inexcusable nonetheless.

My favorite rumor is that the current incumbentcandidates will not enforce Measure V. Regardless of who voted for Measure V and who did not, it is now part of the Municipal Code. As council members it is our duty and obligation to fully enforce Measure V. Measure V specifies height, number of stories and dwelling units for downtown, but does not address the design of buildings in downtown.

So as this campaign season draws to a close, let's continue the public debate over the important issues of public safety, the downtown and the city's financial condition. But let's continue it in a way that shows respect for the facts and for each other as volunteers committed to the preservation of Sierra Madre as a wonderful place to live.

I am Supporting Measure U and UA

On Tuesday, April 8th, I will be casting my vote in favor of Measure U and UA.

My reasons for supporting these measures are simple: 1) it raises funds that are necessary for critical public safety services (it will allow us to carry forward, fully funded, the newly implemented paramedic services and will help us retain and recruit excellent public safety officers); 2) the funds are raised locally and stay local (will not be subject to ever increasing "local funds" that are taken away by the State to balance its budget), and 3) it is a fair tax since it applies to renters and homeowners alike, except for those in our community that are of low income.



Explosion Visible To The Naked Eye From Halfway Across The Universe (On the Day Arthur C. Clarke Died)

A POWERFUL STELLAR EXPLOSION detected March 19 by NASA's Swift satellite has shattered the record for the most distant object that could be seen with the naked eye. Coincidentally, March 19 also marked the passing of famed science-fiction writer Arthur C. Clarke, co-creator (with Stanley Kubric) of the landmark space movie "2001: A Space Odyssey," who died in Sri

Lanka at the age of 90.

The stellar explosion was a gamma ray burst. Most gamma ray bursts occur when massive stars run out of nuclear fuel. Their cores collapse to form black holes or neutron stars, releasing an intense burst of high-energy gamma rays and ejecting particle jets that rip through space at nearly the speed of light like turbocharged cosmic blowtorches. When the jets plow into surrounding interstellar clouds, they heat the gas, often generating bright afterglows. Gamma ray bursts are the most luminous explosions in the

universe since the big bang.
"This burst was a whopper," said Swift principal investigator Neil Gehrels of NASA's Goddard Space Flight Center in Greenbelt, Md. "It blows away every gamma ray burst we've seen so far."

Swift's Burst Alert Telescope picked up the burst at 2:12 a.m. EDT, March 19, and pinpointed the coordinates in the constellation Bootes. Telescopes in space and on the ground quickly moved to observe the afterglow. The burst is named GRB 080319B, because it was the second gamma ray burst detected that day.

Swift's other two instruments, the X-ray Telescope and the Ultraviolet/Optical Telescope, also observed brilliant afterglows. Several groundbased telescopes saw the afterglow brighten to visual magnitudes between 5 and 6 in the logarithmic magnitude scale used by astronomers. The brighter an object is, the lower its magnitude number. From a dark location in the countryside, people with normal vision can see stars slightly fainter than magnitude 6. That means the afterglow would have been dim, but visible to the na-

Later that evening, the Very Large Telescope in Chile and the Hobby-Eberly Telescope in Texas measured the burst's redshift at 0.94. Redshift (a shifting of the star's light toward the red side of the spectrum, due to the motion of the object


away from the viewer) is a measure of the distance to an object. A redshift of 0.94 translates into a distance of 7.5 billion light years, meaning the explosion took place 7.5 billion years ago—a time when the universe was less than half its current age and Earth had yet to form. This is more

than halfway across the visible universe.
"No other known object or type of explosion could be seen by the naked eye at such an immense distance," said Swift science team member Stephen Holland of Goddard. "If someone just happened to be looking at the right place at the right time, they saw the most distant object ever seen by human eyes without optical aid."

GRB 080319B's optical afterglow was 2.5 million times more luminous than the most luminous supernova ever recorded, making it the most intrinsically bright object ever observed by humans in the universe. The most distant previous object that could have been seen by the naked eye is the nearby galaxy M33, a relatively short 2.9 million light-years from Earth.


Analysis of GRB 080319B is just getting underway, so astronomers don't know why this burst and its afterglow were so bright. One possibility is the burst was more energetic than others, perhaps because of the mass, spin, or magnetic field of the progenitor star or its jet. Or perhaps it concentrated its energy in a narrow jet that was aimed directly at Earth.

GRB 080319B was one of four bursts that Swift detected on March 19, a Swift record for one day. "Coincidentally, the passing of Arthur C. Clarke seems to have set the universe ablaze with gamma ray bursts," said Swift science team member Judith Racusin, of Penn State University in University Park, Pa.





Recipe of the Month: Ham & Potato Bake

~For that leftover Easter ham~

Butter, for pan 6 large eggs

1 ½ cups heavy cream

Coarse salt and ground pepper

2 baking potatoes (about 1 ¼ lbs), peeled 10 ounces leftover ham, thinly sliced

1 package (10 ounces) frozen broccoli or

spinach thawed - squeeze dry with paper towels ½ cup grated cheddar cheese (2 oz.)

1- Preheat oven to 350. Butter a 9-inch round cake pan (at least 2 inches deep). Line bottom of pan with a parchment paper round.

2- In a large bowl, whish together eggs and cream; season with 2 tsp. salt & ½ tsp. pepper. Thinly slice potatoes, drop into egg mixture.

3-Lifting potatoes out of egg mixture, arrange half the potatoes in pan. Layer with ham, broccoli (or spinach), cheese and remaining potatoes. Pour egg mixture over top. Press down firmly so that potatoes are fully submerged in egg mixture.

4- Cover with foil; bake until potatoes are tender, about 1 hour. Uncover, continue baking until golden and set. 30 to 45 5- Cool 15 to 20 minutes in pan. Run a knife around

edge, and carefully invert onto a plate. Peel off parchment. Reinvert, top side up. Slice with a serrated knife. *This dish* is basically a crustless quiche; serve it hot, cold or at room temperature. Serves 10.

Burning The Candle.....

"I burn my candle at both ends; Folk's say it is not right. But ah, my foes, and Oh, my friends, It makes a lovely light!"

Art of the Garden

The promise and hopefulness of early Spring will waterfall were erupt in exuberance and celebration at Creative added to the Arts Group's 14th annual Art of the Garden tour Sunday, April 13th. Black Bamboo and Gingkos variety of Palms provide shade and focal points are complemented with junipers, pines, daylilies, for beds of roses and other flowering plants.

The landscape surrounding a Wallace Neffincorporates formal garden elements such as a classic parterre garden into a very beautiful and natural setting at the foot of a terraced slope. Boxwood hedges add structure and symmetry while drifts of bulbs and vines soften garden walls. Meandering bluestone steps shaded by mature Elms lead down the hill past a large oval lawn designed to recapitulate the oval foyer at the

The gardens that encompass a three-story 1906 Arts and Craft home were redesigned and completed in 2006. The focus of the new "East Garden" is a stately river stone fireplace, vine arbor and an outdoor kitchen. The façade of the new pool house extension mirrors that of the 100-year-old main house and incorporates the original French doors recovered from an unused sunroom. In a gradual shift from a traditional English garden, the owners replaced many waterhungry plants with non-thirsty natives while keeping some of the former citrus and old-rose plantings.

Another baseball column. Two in a row. Yep, it's a back-to-back baseball bonanza this week and last for your ongoing amusement coffee-house reading pleasure.

Had to do it. With 2008 season underway the iust

circumstances warrant it, the calendar requires it, and the baseball gods demand it. And besides, my blood

Topic? Easy. Nothing gets a true baseball fan's blood boiling like a rousing discussion of the All-Time

Of course there's no such thing as one all-time team, everyone has their own, and that's just the point. My brothers, boyhood buds, and I used to argue and hash out our all-time teams every year, and it's amazing how

often they would change; however slightly.

I realize I have an advantage over most of you, you my loyal readers, fellow baseball fans, and all-time team aficionados. This is what I do. As a sportswriter, a sometimes sports novelist, baseball historian, former member of the Society for American Baseball Research and a lifelong baseball fanatic with no less than 80 or 90 books on baseball in his home library, this sort of thing falls right in my wheelhouse. You might not even have heard of some of my selections. And your own baseball knowledge might only go back thirty or forty years. But hey, that's okay, everyone's got an opinion, and everyone's opinions have value. Especially when those opinions serve to further and broaden a global understanding of baseball in particular and the American Experience in general. All opinions have value. Your opinions have value.

First base. In baseball history, truly a talent-rich position. Hank Greenberg, Jimmy Foxx, Willie Stargell, Harmon Killebrew, the list is like a separate Hall of Fame wing. Buck Leonard from the old Negro Leagues was often called "the black Lou Gehrig". But with apologies to Buck and the others, Lou Gehrig is still thee Lou Gehrig, and the discussion starts and ends with him. Seven seasons of 150 RBIs. A Triple Crown. A .340 lifetime batting average. An amazing 493 homers in only 14 full years. And of course he's the only victim of a disease ever to have had that disease bear his name. Sign him up.

Second base. Jackie Robinson is a popular choice, but baseball wasn't even his best sport. Joe Morgan had great all-around skills, including fine defensive credentials. But Rogers Hornsby, well, his offensive stats are just too good. In fact, his stats look like misprints! Two Triple Crowns? Three seasons over .400? Next....

Shortstop. Honus Wagner. Easiest selection on the list. I'm not even going to throw out an alternative name for comparison. Wagner is probably the only player ever who, in his prime, was the best hitter, best fielder, and best base runner in his league all at the same time. So if any of you out there want to argue that The Flying Dutchman is the greatest player of them all, at any position, you won't get an enthusiastic argument

Third Base. The weakest position in baseball history. Not that we haven't had a slew of talented third-sacker's. But on balance, we've had less of them than at any other position in the game's grand annals. Let's go with Mike Schmidt. At least he hit over 500 homers and won a bunch of Gold Gloves for his defense..

Outfield. The most talent-rich and star-studded category in baseball history. I mean the outfield must

be the position where the best players play, if athletic geniuses the like of Ted Williams, Stan Musial, Ty Cobb, Oscar Charleston, Roberto Clemente, Hank Aaron, Mickey Mantle and Joe DiMaggio can't crack the starting line-up. But Babe Ruth dwarfs them all. The Babe created the modern game and sculpted it in his image by making the home run sexy. His career slugging percentage was an otherworldly .690---That stat alone makes him, in my book, the greatest player of all time. (and we won't hold it against him that he never got a hit off a black, Latin, Korean, or Japanese pitcher, never saw a slider, and never played a game at night.)

Outfield. Willie Mays. To put it in another sport's terms, Mays is what you'd have in basketball if you were to combine Michael Jordan and Magic Johnson.

Outfield. Hard to leave Ty Cobb off any all-time list, but Barry Bonds is---or should I say was?---good enough to make it necessary. His resume might even be better than The Babe's. And we won't hold an overblown thing like steroids paranoia against him any more than we'd hold all Ruth's advantages against Ruth. There's no point in me trying to explain the significance of Bonds' Nintendolike numbers, that's a whole 'nuther column. Suffice to say that Bonds and Ruth are simply the two scariest guys to ever stand in a batter's box.

Catcher. The usual suspects are always Johnny Bench, Mickey Cochrane, Bill Dickey, Roy Campanella, and Yogi Berra. All good choices. But how can we leave off Josh Gibson? He was the closest thing the Negro Leagues had to Babe Ruth, and tenacious research tells us he hit even more home runs than his white counterpart, a lot more. Like over 800. Maybe 900. Sadly, when Jackie Robinson was selected over him to be the first black to break the color line in 1947, Gibson died at age 35 of a broken heart. So this column will not add insult to injury. Write him in.

Right-handed pitcher. Walter Perry Johnson, the prince of pitchers. He twirled 110 complete-game shutouts, a record that will stand forever. And he won 417 games for the Washington Senators, one of the worst teams over a long period of time to ever disgrace a baseball field. Walter was a sidearmer, and some say no one ever threw a ball faster. And in addition to his athletic accomplishments, by all accounts The Big Train was also the most upright and moral of men, and the most beloved athlete of his time. It's hard to believe

they never made a movie about this guy.... **Left-handed pitcher.** This was a tough one. The easy choice of course is Sandy Koufax; he's a Dodger, which means you've all heard of him, he's recent, he's classy, he's reportedly the nicest guy in the world, and even his name---Koufax---has that unique, mythological quality. But I can't do it. I've got to go with the man with the most lordly name of all: Robert Moses Grove. You might recognize him as "Lefty" Grove. He won a record nine ERA titles, and was the only 300-game winner between the World Wars, when hitting was king. He went 31-4 in 1931. So Grove over Koufax. Yes, this was my toughest call.

Reliever. Need three outs? Bring in Koufax. Okay, so he's technically not a relief pitcher. And I know the great relievers like Goose Gossage, Dennis Eckersley, and Rollie Fingers would be upset. But if the fate of the free world depended on it, could any of them say he'd be a better choice to get three guys out than Sandy Koufax? Anyway this is my team and I make the rules. **Off the bench:** Okay, I just created this category for Ty Cobb. When a guy hits .367 lifetime, steals 892 bases, and wins twelve batting titles, you have to get him ir
