



On The Ballot: Sierra Madre City Council

On the General Municipal Election ballot in April, Five candidates are running for City Council. Two of the candidates are incumbents, Enid Joffe and John Buchanan; One candidate, MaryAnn MacGillivary has previously served on the council. One candidate, Bill Tice, has waged several previous campaigns for a seat and Kevin Paschall, who is running for the first time.

Enid Joffe, currently the Mayor of Sierra Madre, is not seeking reelection because she doesn't have enough to do. After all, she does own her own company, has a son in college and a husband. However, she is seeking re-election because she cares about Sierra Madre's future. She wants to see the city retain its' village charm and character, and yet continue to provide the kinds of services to its' citizens that few other small towns are able to do.

"I'd like to see Sierra Madre become a gateway to the foothills, a day destination where visitors come to hike, dine, shop, stroll around, etc. I'd like to even see the Red Car back in Kersting Court."

Her vision for Sierra Madre does not ignore the realities of the challenges the city faces. In the four

years she has been in office, the city has been plagued with staffing issues, development challenges, and the aftermath of the divisive election over Measure V. Although she was not a supporter of the initiative, Joffe states that she is committed to make it work. And, says Joffe, it is because of all that she has already endured and accomplished that she wants to continue. "Why vote for promises when you can vote for results?", she proudly asks. During her first term on the council the long awaited paramedic services were implemented. As mayor, the police officers and the city came to their first agreement in years and she appointed a citizens Ad Hoc Finance Committee to find ways to fund the salary needs of all of our public safety programs. She also is proud to have led the city to its' designation as an "All American City". "The designation says on a national level that this city is special and it will in turn encourage more civic pride and volunteerism." Often accused of being a developer or in the pockets of realtors and developers, nothing could be further from the truth. "I will vigorously defend the city's right to set land use policy while seeking reasonable resolution on hillside development projects." She adds, "Measure V is the law and it is my job as a council member to make certain that the law is followed."

A Wistaria Time Of Year

Despite, rain, and low turnout numbers, those that did brave Sunday's Wistaria Festival said this year was one of the best ever. And, by mid afternoon the rain had stopped and the sun peeked out of dark threatening clouds as thousands packed Memorial Park, so many so, at times it was hard to walk.

Police Captain Larry Giannone said his department estimated by day's end that about 8,500 people had strolled past the 170 artisans/merchants

selling everything -ceramics/pottery, fine arts, jewelry, crafts, garden, textiles, culinary, glass and wood. Giannone said that attendance was

down from about 10,000 to 12,000 in years past although volunteers working at the site of the 112 year-old Wistaria vine said you would never know as thousands walked passed the 250 ton vine. Volunteers also said it was estimated that the vine spanning an archer over two private residents on North Hermosa Avenue more than 1 million lavender blossoms.

"As you can see by the numbers we still have about 250 people an hour," Lisa Spigai-Perez a volunteer said. Spigai-Perez sits on the Chamber's board of directors. This was her fist year volunteering at the festival.



They work closely with police. communications. Giannone said this year was uneventful - only one single report of a stolen purse and even that later on

was recovered. This year the chamber used a management company, LifeStyles Infocus to oversee the festival. Chamber VP Bill Coburn said brought in more vendors and streamlined the event process allowing more money to be made. He gave an example of improving the layout adding 15 to 20 vendors. He said that alone could bring an additional \$3,500 in revenue.

According to a press release LifeStyles Infocus cost the chamber \$10,000. Members of the Board of Directors said it was too early to decide if they would use the management company again.

Both the police department and city hall said they were unaware of the situation.

Residents Outraged Over Campaign Shenanigans Mysterious Committees, Misleading Mailers, Disappearing Yard Signs Cause Concern By Susan Henderson

To add fuel to the fire already smoldering during this campaign, a postcard from an unknown committee was delivered to residents of Sierra Madre on Wednesday and telephones all over town began to ring off the hook. The card, paid for by "Sierra Madre Citizens For Change" is full of misleading and false information.

More disturbing to residents who contacted the City Clerk's and City Manager's telephone lines with calls, was the fact that no one had heard of this alleged 'committee'. "Who are they" said one caller to this paper who was so upset she failed to identify herself.

In response to an inquiry by the MVO early in the day Nancy Shollenberger, the city clerk, said she did not know who this committee was and that none of the documents required by law for a political committee, "which were due by January 31st in order to participate in this election", had

However, the next morning, April 3rd, Shollenberger said she had learned the identity of the 'committee' and was told that the documents had been sent the evening before via U.S. mail .

Shollenberger identified the caller as "John Crawford" a person she said she did not know.

That afternoon Shollenberger filed a report dated 3/31/08 but stamped received by the city clerk on 4/3/08, the city manager.

On the form, the only name shown for the committee was John Crawford a blogger also known as 'Sir Eric', who is a former columnist for this paper. No other person was listed. One caller wanted to know if the 'committee' was the same one mentioned earlier this year at a council meeting by Faye Angus.

The postcard alleges, among other things, that the city has not filed audited financial numbers with the state controllers office since 2001-2002. A call to the controller's office indicated that Sierra Madre has indeed filed all reports due through 2007. According to Wayne Buck of the controllers office, "although reports from 2002, 2003 and 2004 were not filed on time and a fine was assessed, The city's web site has the budget's for all years we currently have all reports through 2007 and

2005, 2006 and 2007 were filed timely.' The postcard also implies that the city's general fund budget has increased significantly over the last 8 years. However, According to City Manager Elaine Aguilar the Sierra Madre General Fund budget in 2001 was \$6.424 million. The General Fund budget for the last five years has been less and the current general fund budget for fiscal year 2007-2008 is \$5.975 million dollars.



Grand Opening Of La Pintoresca Skate

Balloons hung over the entrance to La Pintoresca Skate Park Friday as Councilwoman Jacque Robinson cut a large ribbon, that not one of the 50 skaters lined up to get in cared about, officially opening the new skating area at a cost to the city of \$150,000.

Before Robinson was even out of the way, skaters young and old were kick flipping and grinding on the new equipment that included a mini half pipe, street ramps and a number of rails to grind on. With no big airs, most of the kids stuck to old school lip tricks although a skater did try to do a stylish front side ollie for the cameras.

The popular skate park has been resurfaced by the Pasadena Public Works Department with a three-color sporty custom design that provides a continual course of play with more grip and lower surface temperatures. Old equipment has been replaced with heavy-duty stainless steel equipment by Spohn Ranch.

City staff said the skate park, originally built in 2002, was the effort of local skaters petitioning the council to build it. The original stake park cost of \$30,000. They also said the new equipment should last 20 years as opposed to the five years the previous wooden ramps lasted. Staff said the wood had become splintered and was a safety hazard.

La Pintoresca Park, at the northeast corner

Tribute Honors Former Mayor

Many local dignitaries, friends, and family members came to All Saints Church to pay tribute to Kathryn "Katie" Nack last Saturday. Nack was a 66 year resident of Pasadena who passed away on March 16, at the age of 83. Locally, she is best remembered as a former mayor of the city and a Pasadena Unified School District board president.

Civically, her public service began with an appointment to the Pasadena Planning Commission in 1979. She was then elected to PUSD where she served three terms as board president. In 1987 she was elected to the Pasadena City Council and served as mayor in 1994. During these years she was a passionate advocate on issues concerning children and families in the community, while continuing to serve on various regional and statewide committees and commissions.

Born Kathryn Inez Tippit, the memorial brought up the fact that she grew up in Tyler, Texas, where she studied mathematics and dress design at Tyler Junior College. She was one of 100 math and science majors selected nationwide to study aeronautical engineering at the University of Texas, replacing the male engineers during World Jeff Tooker, speaking War II. According to on behalf of all of her attendee Marsha Rood, a well-known civic planner, "Nack was the intelligence that motivated 'Rosie the Riveter' in those times."

After the war she moved to Pasadena while also attending the UCLA School of Architecture. In that time she was one of the first women in the state to earn a license to practice architecture.

Reflections on the illustrious life Nack were first shared by her co-PUSD board member from the 1980's, Marge Wyatt. Wyatt disclosed

a humorous anecdote of the obstacles Nack faced in her election to the board. Apparently, a male member stated "She's a nice lady but we don't need another nice lady on the board." Nack turned lemons into lemonade by adopting that as her campaign slogan, "Another nice lady for Katie", which after decades many in attendance of the memorial were still sporting the campaign button.

"She was a nice lady...a tough nice lady" said Wyatt. "Picture Katie riding into Los Angeles on her Harley Davidson motorcycle, we remember that. She was not a hero; she was a shero."

Mayor Bill Bogaard then stepped forward to express that at most times when he is invited to speak at an occasion it is in a time of happiness. "When I first step up to a podium I state how delighted I am to be here. I am not happy to be here today," said Bogaard. "I am saddened by Katie's death and I want Katie to continue to be a part of Pasadena. She was regularly called into positions of leadership and she filled these responsibilities in a way that was truly impressive. Katie Nack has given Pasadena a good name for compassion and service."

The memorial was best summed up by grandson, grandchildren. Tooker spoke of all of the holidays spent in Pasadena and summers in Newport Beach.

"When we we're leaving...my brothers and I would look out the back window and start waving to my grandmother until we were out of each other's sight," said Tooker. "It was what we would call the waving game."

Tooker shared that Katie's grandchildren are now playing the waving game towards heaven.

Did You Know?
Street Sweepers Beneficial to the Environment of Sierra Madre and Beyond

With the election just days away conversations about the city's budget and possible cutbacks in services have elicited many questions about the real need for many city services.

One that was called into question was the need for the street sweeper. SMEAC knows how beneficial the street sweepers are, but wanted to hear directly from the man under whose purvue they fall. The following is from Sierra Madre's Director of Public Works,

"In short, street sweeping provides an aesthetic benefit (cleans up the mess) and a health benefit. Street sweeping assists in dissipating standing water in gutters, where drainage is inadequate, thus eliminating the potential for mosquito breeding. Street sweeping also eliminates the amount of trash that gets into the storm drain system. This is a critical means of meeting the State's Trash Total Maximum Daily Load (TMDL) requirements for the L.A. River. That is, all cities that drain to the L.A. River (including Sierra Madre, believe it or not) are required to meet a state requirement that there be zero trash in the LA River

by the year 2012.

"When I last studied the matter a couple of years back, most cities had their commercial their modern areas swent. zones (which generate the most litter) swept weekly and their residential areas swept monthly. In order to demonstrate a Sierra Madre good faith effort to the State, I doubled the LOŚ for Sierra Madre. The downtown is to be swept twice a week and residential areas


"Street sweeping intervals are greatly impacted by our severe windstorms due to the sheer amount of debris that has to be removed. It would be of great help if gardeners in Sierra Madre are instructed by their clients not to deposit plant litter in the gutters and to avoid leaving piles of debris in the street, as the street sweepers are not equipped to handle piles of plant litter."



It is my pleasure to share with you an overview of the Sierra Madre Police Department's accomplishments over the past two years. This is the first of a monthly column in which I will provide community information about crime, traffic, Department programs, and services.

I am pleased to report that overall crime has dropped in Sierra Madre. From 2005 through 2007, crime dropped 20%, or by 1,659 reported crimes in 2005 to 1,332 crimes in 2007. The most serious

crimes: murder, robbery, rape, aggravated assault, burglary, and larceny (Theft exceeding \$400.) dropped by 10% from 2006 to 2007. The greatest drop was in residential burglaries which declined from 65 in 2005 to 33 in 2007, nearly a 50% decrease. The only steadily increasing rise in a serious crime was in larceny. Most incidents involved thieves stealing valuables such as laptop computers, briefcases, purses, and jewelry left in plain view inside unlocked vehicles. This information is contained in the Police Department's 2007 Annual Report which is available on the Department's website or at the library.

The decrease in crime was coupled with a significant rise in officer productivity from 2006 to 2007, highlighted by a 51% increase in arrests, and a 59% increase in criminal cases filed at the District Attorney's Office.

In 2006 to 2007 the Police Department developed community partnerships to enhance public safety. These include the Police Volunteers, Neighborhood Watch, the Postal Carrier Alert Program, the Police Chaplains, and participation in Sierra Madre's first "National Night Out," a nationwide crime prevention effort.

The Police Department also focused on risk management to reduce city liability: Formal training for officers increased, Departmental policies and procedures and legal issues are regularly reviewed during daily briefings, and new equipment such as Taser guns, digital cameras, and video cameras are being used in the field.

Several residents have asked why arrests take place out of the city, in Pasadena or Arcadia. We encourage officers to investigate and enforce traffic and criminal violations originating in Sierra Madre when they see motorists commit them. For example, Michillinda and Baldwin Avenues are common speeding corridors. Officers will often use radar or pace the motorists, run the license plate before making the stop, and look for a safe place to stop the vehicle. In the past 20 months we have investigated at least eleven traffic collisions on Michillinda Ave. between Sierra Madre Blvd. and Orange Grove. If an officer suspects the motorist may be driving under the influence of drugs or alcohol, it is common practice for an officer to observe the driving for a sufficient distance to determine if it is indicative of an impaired driver. Arrestees are booked and housed at the Pasadena City Jail.

Recently, an officer booked a prisoner in Pasadena and as he was leaving the area, saw a motorist driving erratically. The officer followed the motorist to catch up with him and eventually stopped him at Colorado Blvd. and Hill Ave. The driver was under the influence of an alcoholic beverage and the officer arrested him. Though the officer was not in Sierra Madre at the time he saw the violations, it was reasonable for him to take the action that he did. Both this incident and the investigative stops originating in Sierra Madre are common and acceptable policing practices.



Yes to Karma Bell - Karma Bell wants to have the City Clerk's office in City Hall, and even store official City records at City Hall. What a novel concept. She wants to have regular hours (not hour) at City Hall, where people can actually connect with the City Clerk. Another novel concept.

At a time when the City is facing a major budget crisis, she wants to reduce the compensation to the City Clerk, to the tune of \$14,000 during election years.

She trusts the City administration, and wants the City Clerk's office to work with other members of staff as a team, for the good of the City.

She thinks the Election Officer of the City needs to be an impartial, unbiased steward of the Election.

Her opponent takes the opposite stance on all these issues. The main knock I've heard from anybody on Karma Bell is that she lacks experience, and has never managed a City election. Nancy Shollenberger lacked experience when she took office 24 years ago, and as Nancy herself admitted publicly that when she took office, she had never managed an election either. But there is one thing Karma can say today about herself that Nancy can't. She's never mismanaged an election.

No to Nancy Shollenberger -Nancy Shollenberger wants to have the City Clerk's office in her home. and keep City records there (on the hillside that is far more susceptible to fire than is City Hall). For that matter, once they've left City Hall, they could be stored in Bakersfield for all anybody knows. If something happened to Nancy, records stored away from City Hall could be lost. Nancy, until Feb. 1st, did not have regular hours at City Hall, and since then, she has only one hour per week making it difficult for people to actually connect with the

City Clerk. At a time when the City was facing a major budget crisis (2003), Nancy asked for more money, including asking for four times more than the Mayor makes.

Nancy doesn't trust the City administration, and kept it out of the loop on the Sample Ballot error, forcing the City Manager to ask a local reporter to provide her says otherwise. The evidence says otherwise.

Nancy thinks it's acceptable for the Election Officer of the City to be biased, and to publicly trumpet her bias, despite being the steward of the Election. Can a candidate for office really feel that their best interests will be served in an election when the City Clerk's office has signs endorsing that candidate's opponent?

Nancy messed up big time on this year's sample ballot, not only costing the City \$6,000, but putting the entire election at risk. If someone wants to challenge the results of the election regarding Measures P, U or UA, they have a reasonable chance of winning, and forcing another costly election.

Nancy refused to answer questions about the error for several days (actually, some questions never got answered, but I stopped asking when she acknowledged responsibility for the error), and... she sent the wrong information to me when I made a public records request about the issue.

LETTERS TO THE EDITOR

As a long time resident of Sierra Madre, I was dismayed to read the caustic "Letter to the Editor" written by Ron Longo about MaryAnn MacGillivray in the March 11-1626 edition of the MountainViews-Observer. He refers to the enactment of an ordinance that occurred over a decade ago. I was out of the country at that time and was not familiar with the situation he describes. So, as suggested in his letter I "visited the library" to read the articles and letters to the editor of the Mountain View News and the Star News. I viewed a recording of the September 23, 1997 meeting of the Sierra Madre City Council in which Ordinance 1136 was passed. I studied the language of Ordinance 1136 passed in 1997 and in 2001 and I listened to a tape recording of a radio show hosted by Bill Handel in 1997 in which he dedicated an entire segment to the subject of Ordinance 1136. Further, I spoke to Charles Martin, attorney for the City of Sierra Made in 1997, and as many of the council members who voted on Ordinance 1136 as I could get in contact with. I also reviewed the minutes of the pertinent meetings.

This is what I discovered.

The intent in supplementing the language of the state in the passage of Ordinance 1136 was to comply with government code section 12955L which made it unlawful to discriminate through land use policies based on race, religion, color, sex, familial status, 22, 2005. He asserts that the definition of disability, marital status, national origin or family was changed to be more inclusive and ancestry. The use of the term family, defined as appropriate. In fact, Ordinance 1234 relates "those related by blood, marriage or adoption living as a single housekeeping unit", was broadly used in the codes and ordinances of the city and had been since at least the early 1980's. The City Council broadened the language to include any alternate style of living arrangement into the definition of housekeeping unit of which family was a part therein. The new, inclusive language still allowed the city to regulate use of residences and thereby prevent undesirable and inappropriate uses such as half way houses for convicted pedophiles akin to what recently happened in Altadena. Since the language was defined by Charles Martin, the legal rationale argued by then councilmember Bart Doyle, and the ordinance passed by majority vote it does not appear to be the "brainchild" of MaryAnn

The "overflow crowds" referenced were primarily from out of town and members of or associates of a gay and lesbian organization called Catalyst.

In the 9/25/97 Mountain View News article written by Dan Oates there was no mention of MacGillivray opening the meeting with a prayer in violation of "the tenets of Separation of State and Church."

In viewing the tape of the Council Meeting, I saw no evidence of the meeting being tumultuous as described by Mr. Longo. I saw an orderly progression of folks expressing their viewpoints. The majority of speakers were members and associates of the aforementioned Catalyst with some Sierra Madre residents speaking pro and con.

There is no evidence of "overwhelming protests" by the residents of Sierra Madre. In De Alcorn the letters to the editor of the Mountain View News, there were approximately equal numbers

of pros and cons.

As for the reference to MacGillivray "embracing thinly veiled homophobia", MacGillivray asked several speakers what statements made by her were perceived to be anti-gay and no one came up with anything.

Due to an error made by city staff, Ordinance 1136 passed in 1997 was not properly advertised and so was declared void. Subsequently on October 8, 2001, Ordinance 1136 was passed unanimously by then mayor Glen Lambdin and councilmembers Doug Hayes, Bart Doyle, Kris Miller Fisher and Robert Stockly. The wording was identical and unchanged as compared to the ordinance passed in 1997. It was passed with no discussion or public comment indicated in the minutes of the meeting.

A discussion with Charles Martin, City attorney in 1997, indicated that he believed that MacGillivray was very capable and easy to work with - not "rigid and unwilling to compromise" as Mr. Longo asserts. Discussions with Doug Hayes indicated that he and MacGillivray always got along in a friendly and cordial manner even if they had differing opinions. Mr. Hayes further stated that he thought the whole thing was much ado about nothing because the ordinance had no discernable impact on anyone.

Mr. Longo is incorrect in his assessment of Ordinance 1234 which was passed November to review of planning commission decisions and contains thirteen different and various amendments, one of which removed the definition of family. There were no comments from the public or city staff in a public hearing held by the Planning Commission with regard to Ordinance 1234 on September 1, 2005 as evidenced by the minutes of the meeting. Nor did the minutes of the 11/22/2005 city council meeting indicate there was there any discussion of Ordinance 1234 on the "family definition"

Regarding the reference to the "virulently homophobic Dr. Laura Schlessinger," Tammy Bruce, a self described lesbian feminist, in her book The New Thought Police, thoroughly refutes the scurrilous vendetta that was brought against Schlessinger. She defends Schlessinger and writes in several places about the attack. One typical part that captures the truth is the quote, "as to being a gay-basher, quite the opposite is true. In fact, as noted earlier she (Schlessinger) has been personally involved for years with Parents and Friends of Lesbians and Gays (PFLAG), one of the more respected gay and lesbian organizations. PFLAG Los Angeles became a favorite charity of Schlessinger's and she got involved with the organization specifically because she recognized the importance of its mission to support families of gays and lesbians"

My investigation of the facts of this matter finds Mr. Ron Longo's letter replete with sophistry, innuendoes, distortions and untruths.

This vine also holds a place in the Guinness Book as the world's largest flowering plant.

Docents Amy and Glenn Putnam have been volunteering at the vine for at least ten years. Amy chuckles that she raised her hand years ago at a Friends of the Library meeting, when "vine docents" were sought. They've been here every year since. Visitor counts were somewhat low in the morning during the heavy rain, but those dedicated docents like the Putnams stuck it out. I heard more than one story of vendors and docents trekking home for hot showers in between shifts. Enthusiastic docent Georgette Dunlay, a former Sierra Madre Civic Club president, no longer lives in Sierra Madre, but continues her yearly purple clad docenting year in and year out.

The NASA/ESA Hubble Space Telescope has made the first detection ever of an organic molecule in a planet orbiting another star. This breakthrough is an important step in eventually identifying signs of life on a planet outside our Solar System.

The tell-tale signature of the molecule

methane in the atmosphere of the Jupitersized extrasolar planet HD 189733b has been found with the Hubble Space Telescope. Under the right circumstances methane can play a key role in prebiotic chemistry—the chemical reactions considered necessary to form life as we know it. Although methane has been detected on most of the planets in our Solar System, this is the first time it (or any other organic molecule) has been detect-

ed on a world orbiting another star.

This discovery proves that the Hubble and other space telescopes to be launched in the near future (including the NASA/ESA/CSA James Webb Space Telescope) can detect organic molecules on planets around other stars by using spectroscopy, which splits light into its components to reveal the "fingerprints" of various chemicals.

This is a crucial stepping stone to eventually characterizing prebiotic molecules on planets where life could exist," said JPL's Mark Swain, who led the team that made the discovery. Swain is lead author of a paper on this subject in the March 20 issue of the science journal Nature.

The discovery comes after extensive observations made in May 2007 with Hubble's Near-Infrared Camera and Multi-Object Spectrometer (NICMOS). It also confirms the existence of water molecules in the planet's atmosphere, a discovery made originally by NASA's Spitzer Space Telescope in 2007. "With this observation, there is no question whether there is water or not—water is pres-

The planet, known as HD 189733b, is located 63 light-years away in the constella-

ent," said Swain.

tion Vulpecula, "the little fox." HD 189733b, a "hot Jupiter" type extrasolar planet, is so close to its parent star that it takes just over two days to complete an orbit. "Hot Jupiters" are approximately the size of Jupiter, but they orbit closer to their stars than the tiny innermost planet Mercury in our Solar System. HD 189733b's atmosphere swelters at 900 degrees C, about the same temperature as the melting point of silver.

The observations were made as the planet passed in front of its parent star in what astronomers call a "transit." As the light from the star passed briefly through the atmosphere along the edge of the planet, the gases in the planet's atmosphere imprinted their unique signatures on the starlight.

According to the paper's co-author Giovanna Tinetti from the University College London and the European Space Agency, "Water alone could not explain all the spectral features observed. The additional contribution of methane is necessary to fit the Hubble data."


Methane, composed of carbon and hydrogen, is one of the main components of natural gas, a petroleum product. On Earth, methane is produced in a variety of ways—from natural sources such as the oceans and wetland environments, but also from livestock and manmade sources like waste landfills and as a by-product of energy generation.

Though the star-hugger planet is too hot for life as we know it, "this observation is proof that spectroscopy can eventually be done on a cooler and potentially habitable Earth-sized planet," Swain said.

The Mountain Clymer By Kim Clymer-Kelley The Call of the Wild

One of the terious and elusive creatures of our

local mountains is the ring tail, or ring-tailed, cat. Contrary to its name, it is not a cat of any kind, but rather a close relative of the raccoon. When I have mentioned my many encounters with them, my stories have been met with a raised eyebrow or two. It seems that many believed them to be extinct, at least locally. Many believed that the fire of 1953 destroyed the population and they never came back. When one of the cabin owners claimed to have one living in his cabin, he had to take photos to prove it. Those photos were made into a poster that was proudly displayed at the pack station for many years as proof that our canyon was inhabited once again by ringtails.

As the photos on the poster show quite well, the ringtail is an animal about the size of the small and similarly proportioned kit fox. They weigh about 2 ½ pounds, have a small round head with large cat-like ears, short legs, long body and a long, puffy, very distinctly banded tail. On the road to Chantry Flat, they are frequently seen at night running along the top of the rock wall that serves as a guard rail most of the length of the road. When they are caught in the headlights of a car they usually turn to look at the intruder with glowing eyes, then quickly slip over the wall. It is then that it is easily identifiable as the headlights hit the stripes on its tail as it disappears in to the

It was during the second summer that I lived in the mountains that I first remember hearing the cry of the ringtail, though I did not know what it was at the time. One night, not long after the weather had gotten warm, I was awakened by a loud noise coming through my open window. I was not aware at first of what it was that awoke me, only that it was a noise of some sort. It shook me from a deep sleep, so that when it sounded a second time, I was conscious enough to identify it as animal, and then, fully awakened, I laid quietly in bed listening for it to call again - fearing that it may have been a dog, cat, donkey or horse who was injured or in danger. After a couple minutes I heard it again. It was a sound like I had never heard before, a sharp and abbreviated noise kind of a cross between a bark, a snarl and a growl, and loud....very loud. Worried, and totally at a loss as to what it could be, I listened some more. There it was again, close. Somewhere on the hillside just below my bedroom. I got up and called for my dog Jack, who slept in the doghouse right outside the house. In a moment he appeared at the back door. Relieved that he was okay, I let him in for the rest of the night, got back in bed, and fell asleep as the

noise continued sporadically outside the house.

The next day I described the noise to a friend and even did a remarkable reproduction of it for him. "Oh," he proclaimed knowingly, "that is the sound that a baby bear makes when it is calling to its mother." Unaware that this friend was not the nature expert that he claimed to be, I accepted the information as fact, worrying a bit that perhaps there was an orphan bear out there who was searching nightly for his mom. The sound continued throughout the summer. It seemed that several times a week I would be wakened by the noise. Poor baby bear.

When the 4th of July came around that year, I invited my friend Al and his kids up to the station for a cookout and to go up to "the Ridge" to

view the fireworks. "The Ridge" is what we called the eastern end of Manzanita Ridge. It is the area near the top of the mountain that is visible from Santa Anita Avenue where there is a giant white board that looks like a drive in movie screen from below. You can hike there up a very steep fire-break that runs up the hillside from the heliport just above the station, or you can drive there on the San Olene Fire Road that starts at Chantry Flat and winds up the mountain for about 3 ½ miles. Once there you can see the entire L.A. basin and all of the firework displays going on. The closest ones at the Rose Bowl are partially obstructed by the layout of the mountains, but the high ones that explode over the ridge are glorious! Al's kids were about the same age as my boys. His son was about 19 and his daughter about 13 at the time. My oldest, Patrick, then 17 and my youngest, Ben,14, came along on our little adventure. We all piled into my minivan to go celebrate the Fourth.

About half way down the road, I noticed the car was handling a little funny. Subtle at first, and barely noticeable because of the bumpiness of the road, the problem got distinctly worse as we crept along.

"I hear that all the time," as I started to explain, the noise came again, this time closer, "My friend told

Baby Spinach Salad with Tuna

2 Tbs plain low-fat yogurt 1-2 Tbs Dijon mustard 1 Tbs fresh lemon juice

Course salt & ground pepper 3 ounces baby spinach (about 3 cups, loosely packed)

½ cup seedless red grapes, halved lengthwise ¼ cup thinly sliced red onion (optional) 1 can (3 oz.) chunk light tuna packed in water

Flatbreads for serving (optional)
1) In a small bowl whisk together yogurt, Dijon and lemon juice; Season with salt and pepper

2) Combine spinach, grapes and onion, if using in another bowl.
3) Just before serving, drain tuna, add to salad, and toss with dressing.

4) Serve with flatbreads, if desired.

Cheddar-Carrot Balls

In a medium bowl, with a wooden spoon, combine 4 oz. (½ a bar) cold cream cheese, 2 oz. yellow cheddar cheese, finely grated (1cup loosely packed), and one carrot, finely grated (1/2cup). 


The Big Sleep (1946)

Comfort Food

Seems like every day I am learning something new about food and cooking. When I think of comfort food here in the States, for me it consists of meatloaf, chili and mashed potatoes. Recently I made a visit to Teri & Yaki on N. Lake in Pasadena, and the menu says Asian Comfort Food. Another restaurant in Pasadena, Hurry Curry on S. Fair Oaks, has laid claim to the title of Japanese Comfort Food. So, come along with me while we explore two different kinds of Comfort Food, which sounds nice and relaxing to me.

What comes to mind when you think about Japanese food? If you're like me, Sushi and Tempura head the list. Probably, like me, you did not know that curry is actually "the" Comfort Food for

Hurry Curry of Tokyo, a great restaurant offering Japanese Comfort Food since 1989 in West LA, established its first franchise in 2003 in Jakarta, Indonesia. It opened at its Old Pasadena location in 2005, and has rapidly become one of my favorite restaurants. The reasons? It is clean, relatively inexpensive and the food quality is above average - all of this being coupled with memorable flavors.

Hurry Curry was given an impressive 9.3 by CitySearch.com, and it has become a favorite of Yelpers.

I don't quite know what it is, but there is nothing better for me than going into an ethnic restaurant and seeing that the people working there look like they have been in the area that the foods comes from, have taken in the air, smelled all the different smells and been a part of the history and preparation of these foods. It is one of those things that makes me love my job.

Okay enough of my Romanticizing. So, what to order at Hurry Curry? A must is the Fried Chicken (\$5.75). It's my absolute favorite, and is served with a chicken dressing on the side. I could eat this non-stop and, some days, I think I do!! Other recommendations are the Fried Shrimp Curry with Spinach (\$9.50), the Japanese staple-Chicken Curry (\$8.50), and the very colorful Tarako Ika (\$8.95). Also a must for the palate is the Lobster Bisque - one of the better soups that I have had anywhere; this one must come from the owners' origins in the seafood industry.

The restaurant has a happy hour from 3 PM to 6 PM, with \$2 Sake Martinis, \$2 appetizers and \$2 beer. If you are a beer drinker, as I am, that is a great reason to go in and of itself. They also offer curb-side "to go" service, a very unique service in Old Town.



Teri &Yaki opened recently on N. Lake in Pasadena with a very simple menu. The main entrees consist of chicken and beef with a few side dishes. It looks like they are catering to the health-conscience here, with skinless, boneless chicken and lean beef. All the meats are marinated for at least 24 hours and I really like the side dishes, which include Seasoned Spinach, Broccoli, Crispy Wontons and Sweetened Potatoes. All items are range around \$7 and you can double up on the meats for no more then \$10.95. I do prefer their chicken over their steak. I must warn you this is not Spago, but on a day when you aren't sure what you want to eat for lunch, this place hits the spot. If you are a soup fan, I can recommend the Spicy Noodle Soup (\$6.75). I never did find that loaf of white bread that I purchased... Could that have been what was in that flat-as-a-pancake blue and white plastic "thing' that I tossed?



Back Page Journal Aye, And A Grand Game I'tis

"Golf Issue". Which is a good thing. Golf is great theater. And this coming weekend is Masters weekend, which always gets my golf goat. The problem is how to turn that excitement into a thrilling "Back Page" column...a Masters retrospective? Too easy. A discussion surrounding the Masters' sad history of racial intolerance? Too difficult. Something on women's golf? Too boring. (Oh come on, ladies, you don't care about the LPGA either! I'll prove it---quick, who won last year's LPGA Jamie Farr Owens Corning Classic??? I rest my case.)

Anyway, since I have never been invited to play golf at the Masters course at Augusta National (it's a grotesquely private club---I swear those Georgia rednecks have machine guns mounted in their guard towers), I thought I would tell you about a course I have played that in many ways is even greater than Augusta. It's called Turnberry.

Turnberry is in southwest Scotland, in County Ayrshire. Just off wee Highway A719. While the course itself may not be quite as beautiful as the magnolia-dusted Augusta, the surrounding setting is way more spectacular; craggy coastal shores and spectacular 10 p.m. sunsets see to that. The Turnberry Hotel across the road is a 3-story white giant a couple hundred yards long, on a high mound, and since it's in the middle of nowhere it might as well be the house of God. Throw in the fact that the course is built upon the ruins of the castle of Scotland's greatest king, Robert the Bruce, and you've really got something special. And it's a tougher course than Augusta, which is to say it's even more unfair to the regular hack golfer. (The course record there is only seven under par. At Augusta it's nine under.)

Tom Watson, Greg Norman, and Nick Price all won the Open Championship at Turnberry. Each man was, at the time he won, already the reigning best player in the world, cementing not only their reputations but also Turnberry's position as one of the world's paramount golf courses. Watson, in his Open in 1977, shot a 65-65 on the weekend to defeat Jack Nicklaus in what is generally considered the greatest golf match of all time. 65-65.

Which, I am here to tell you, is impossible. That's the point of this column. When you play a course like Turnberry it tells you all you need to know about how ridiculously great pro golfers are. I played Turnberry twice in my life, in 1989 and again in 1996. And the thing that struck me about it both times---other than how spectacularly beautiful it is to play golf with the world's difficult the course is. For a regular hacker, it is virtually unplayable. Literally. You stand lassies, i'tis indeed. on the tee box on certain holes, and you look down the fairway and it's only about 30 yards wide with gorse on either side. Gorse are huge, prickly thorn bushes that acquire

nourishment by swallowing golf balls. Gorse bushes are also called "whin", not to be confused with "win", which is something you won't do if you hit it in the gorse. In an amazing coincidence, in both 1989 and 1996 I shot a round of exactly 105, with exactly 7 additional balls lost forever in those scratchy, arm-bloodying gorse bushes. That's 7 takeovers, or "Mulligans", if you prefer. So if you add stroke-and-distance for each lost ball, I actually shot a score of 119 in each round,

Please understand, it's not like I'm a crummy golfer. I may not be a two-handicapper, but I'm not a schlub either. For instance, at our two local courses, Altadena and Eaton Canyon, I'll usually shoot around 39 for 9 holes, which doubles up to a 78 for 18. At a tougher course like Santa Anita, I might card an 85. So for a decent self-respecting hacker to stagger around a golf course in 119 shots, twice, is humbling, and is an anthem to how difficult Turnberry is.

seven years apart. Same score.

But I loved it. I imagined I was Watson or Norman or Price carving out his victory in '86, or '94. I imagined I was the crusty old Scot who laid out the course a hundred years ago. I imagined I could actually play this damn game.

There was one hole in particular that told me---and should tell you---everything you need to know regarding the charm and magic and utter Heavenliness of Scottish links golf. It was 1989, and I was playing the 7th hole. A par-four. "Roon the Ben" they call it (All the golf holes at Turnberry have their own cute, Gaelic names...like "Tappie Toorie", "Blaw Wearie", and "Fin Me Oot".). It's a beautiful golf hole, smack up against the rocky shore, with only the Firth of Clyde separating Turnberry from the Atlantic Ocean and the New World.

Anyway, I was on the green in three, 30 feet from the cup, needing two putts for my bogey. Don't laugh! When you shoot a 119, bogeys are hard to come by, so I was excited, deadly focused, and motivated. But as I prepared to putt, I noticed a strange object halfway to the hole, right in my line. I squinted. What IS that thing? I asked myself. My vision was starting to wane in '89, I couldn't tell. It was silver and shiny, glistening and wet-looking. I walked up, bent over the mysterious object, and discovered that it was...in fact ... a fish

An 8-inch-long, wiggling, still-living silverfish. Poor thing. Some weary gull had obviously dropped it on the green, just to make my two-putt for bogey even more challenging than my innate lack of talent might make it. But never let it be said that I don't know golf protocol. I placed a coin behind the fish to mark its position, then I took my putter, measured one club length to the side, placed the fish there, two putted (brilliantly), recorded a bogey five on my most out-of-place hotel just to the East and scorecard, and---in case the gull should the Firth of Clyde lapping at the craggy come back later searching for his dinner---shore to your West---is how obscenely replaced the fish. PHS Golf Team Experiments...With Having Fun

"All men are created equal" in the Declaration of Independence. But all men AND women are equal on the Pasadena High School Varsity Golf Team.

Make that the Pasadena High School "Coed" Varsity Golf Team. It's the newest development on a team that's been around since 2006, when PHS resurrected a golf program that had been dormant for decades. "The school had a golf team way back in the fifties or sixties, maybe even into the early seventies, but that's about it," says golf coach Eli Harris. "A couple years ago we brought golf back to PHS. And we made it coed this year to make sure we got enough players."

Actually, of the seven players on the varsity squad only one, Christina Cunanan, is a female. But in any male-dominated sport one female is a lot more than zero, and that's the point.

"I love to play, but I've only been playing golf for about two years," says the 6th-seeded Christina, a 15-year-old sophomore. Her inexperience is shared by most of her teammates. Only 5th-seed Noah Venerable, a senior, has played varsity for all three seasons that the new team has been in existence. As a result, PHS won only three of its first nine Pacific League matches. But for the present, nobody is really concerned about wins and losses: "Most of these kids are doing something they never dreamed of doing, Coach Harris says through a huge ear-to-ear grin.

One player who does not suffer from inexperience is top-seeded Thomas Reese. The Bulldogs' #1 man

has been swinging a club since he was three years old. "He's a pretty good all-around athlete, so golf sort of comes naturally to him," explains Anthony Reese, Thomas's father, who also doubles as assistant coach. Thomas has even put his beloved basketball aside for the time being to concentrate on his golf game. "Our team practices five afternoons a week, but I play pretty much every day," the talented sophomore adds proudly.

The PHS team is a diverse squad made up of hard trying up-and-comers. Luis Ambriz, the #2 seed, is a short, powerfully built young man who delights in pounding drive after long drive down the middle of the range in practice. He's a right-handed sophomore. Conversely the #3 seed, senior Krikor Latchinian, is a tall lanky lefty. Fourth ranked junior Andrew Hantman and 7th-seeded Derek Williams (another left-hander) round out the squad.

Part of the purpose of this year's cobbled-together golf team is to advertise for more players. The whole coed experiment is a recruiting tool of sorts. "We didn't have enough boys for the varsity (you need seven) and we certainly didn't have enough girls for an all-girls team," Coach Reese explains. "We're hoping that other girls will see how much fun Christina is having on the varsity, so that by next year we'll draw enough players for a separate girls team, so that the girls can compete a lot more effectively."

In the meantime, the coed experiment is a rousing success. It's obvious that the other players have totally accepted Christina as one of their own. She fits right in. You can tell by the way they all laugh and joke with each other before a match that if they get beat it's not because of nerves...

"The most satisfying thing is the kids," sums up Coach Harris. "They're great kids, all of them. And with each passing week you can see how much fun they're having. You can see it in their faces that they all want to play."
