## Upside Down... Dorn-Platz Attorney Tells Court Projects Have More Debt Than Value

The attorney representing developer Dorn-Platz told a Los Angeles Superior Court Judge last week that both the One Carter and Stonehouse developments had more debt than they are worth. "The projects are upside down, so what are they foreclosing on?", asked Attorney John Schock. His comments were in reference to the initial objection of Sierra Madre Investors, LLC and Castlegrace Investors to the Preliminary Injunction filed by Dorn Platz. The request was filed to prevent the investors from foreclosing on both One Carter and Stonehouse properties. The judge granted Dorn-Platz's motion and scheduled a hearing for a more permanent injuntion in August. Dorn-Platz was required to post a \$50,000 bond with the court.

#### A Band Aid On A Hemorrhage

Although the court gave Dorn-Platz a temporary stay on the sale of the membership interests, at least one other foreclosure, and numerous defaults and lawsuits still wait in the wings.

Victor Sahn, attorney representing the investors seeking foreclosure, informed the court that later the same day, there would be a meeting between his clients, Dorn-Platz and Capital Source Funding in an attempt to protect not only the interest of the investors who have contributed more than \$4.4 million dollars to One Carter and Stonehouse, but also the interests of the finance company who has loaned a total of \$38 million dollars to the projects. In addition, the issue of management control of the projects was to be determined.

Last month, Sierra Madre Investors, LLC met to remove Greg Galletly and Dorn Platz as the project manager. According to agreements that Galletly says are no longer valid, the investors have the right to remove the designated manager. Sierra Madre Investors, LLC currently owns 62.8% of One Carter, LLC.

Further, on June 6, 2008, according to Attorney Richard Walsh, whose firm represents Capital Source Funding, one hundred percent of the membership interests in the projects will be sold at public auction. The original date for the sale was postponed from May 7th so that all could meet and discuss alternatives to foreclosure. The finance company is foreclosing because of defaults on interest payments in excess of \$400,000.

#### Sierra Madre Also Defaults One Carter Project

On April 28, 2008, City Attorney Sandra Levin filed a "Notice Of Default and Notice of Intent of the City to Cause the Forfeiture of Deferred Public Improvement Bonds", with yet another entity involved with the project, WL Sierra Madre Associates, and Bond Safeguard, Inc. Bond Safeguard issued performance bonds in excess of \$2.6 million to the City of Sierra Madre on behalf of Dorn-Platz. (See chart on page 3) The city required the bonds to cover costs of associated with the project that Sierra Madre would be liable for should the developer default.

In Levin's letter, she cites a long list of deficiencies created by the

developer on the One Carter project including:

1. The 'canceled' status of the corporate status of WL Sierra Madre Associates and its' right to transact business in California. She also noted that several other entities involved are classified by the California Secretary of State as having "ceased good standing" due to outstanding tax obligations. (WL Sierra Madre Associates assumed One Carter, LLC's interest in June, 2007.)

2. The grading and construction has been halted and the equipment has been removed.

3. No reliable or accurate construction or grading schedule has been submitted as required by the agreement.

4. The LA Regional Water Quality Control Board issued a Notice of Violation and calls to Dorn Platz by them have not been returned. The notice says that "The National Pollutant Discharge Elimination System General Permit For Storm Water Discharges Associated With Construction Activity", has been violated at the project.

5. The arborist required by the city to monitor grading has ceased to work has not be replaced.

6. At least two sub contractors/consultants have not been paid and are seeking recourse through the bonds.

7. The grading is partially completed and is damaged by rainfall and erosion. (cont. pg. 3)

agreement, however, dropped all charges except the Assault charge.

Most of the witnesses were minors ranging in age from 14 to 17 at the time of the attack. Their names, although often mentioned during the preliminary hearing and trial, will not appear in this paper.

Ryan Swender, whose family originally posted a \$1 million bond, was sentenced to 3 years in state prison. He will serve 336 actual days with credit for time served and good behavior. Richfield Chang was given the most severe sentence. He was sentenced to 3 years for the assault and an additional 3 years for a prior felony and an additional 5 years for habitual criminal behavior for a total of 11 years in state prison. Marvin Chang was sentenced to 4 years for the assault and an additional enhancement of 3 years for the personal infliction of great bodily harm. His total sentence is 7 years in state prison. Ironically, both Changs, who are not related, were recommended to participate in the state's fire line program.



### Mount Wilson Trail Race Celebrates its 100th Anniversary!

### Time & Place

Saturday, May 24, 2008 at 7:30 am sharp. Check-in time is from 6:00 am to 7:15 am. The race concludes at 10:30 am. The Trail Race begins and ends in the center of Sierra Madre, California, at Kersting Court, the corner of Sierra Madre Blvd and Baldwin Ave.

## Course

The 8.6 mile race starts on pavement, uphill, to a dirt path no more than 3 feet wide. It features an elevation gain of over 2,100 feet; approximately 4.3 miles to the turnaround point at Orchard Champ. Most of the race takes place on the Mount Wilson Trail, where some section have vertical drop-offs of several hundred feet. Emergency support is stationed at strategic points along the course to give any necessary aid. Boy and Cub Scout Troops provide water at two locations: the 2.3-mile marker and the turnaround point.

## History

The Mount Wilson Trail Race is the second oldest Trail Race in California; first held in 1908 when runners raced to Mount Wilson, rested 1/2 hour, then raced back down. Only a handful of intrepid runners dared to attempt such a grueling test. The race was held sporadically from the first year until the late 1940s and early 1950s when it was abandoned completely. In autumn of 1965 it was revived and has grown over the years to its present format. Organized by a volunteer committee, the current race is 8.6 miles in length. The exact course has changed by erosion, fires, and earthquakes. For this reason no official record is recognized. Since the revival in the 1960s, today's course is considered the most difficult.

The Plight Of the Honeybee

In the past two years, nearly one-third of America's honeybees have vanished. They started mysteriously abandoning their hives, never to return. Farmers—many of whom rely on the pollinator to help their crops grow—are understandably worried, as are scientists, who fear the honeybee may be a modern-day canary in a coal mine. Although the bee die-off, also known as colony collapse disorder, continues to alarm and puzzle scientists and beekeepers. Experts hypothesize that the likely culprits are pesticides, mites, dwindling food supply, and a new virus that appears to target the bees' immune system.



## 2008 LARA Environmental Awards Bestowed Upon Sierra Madre Schools, Businesses and Organizations

On Tuesday, May 6th, six Sierra Madre organizations were recognized at the San Gabriel Valley Environmental Awards, sponsored by the Los Angeles Regional Agency (LARA). According to James Carlson with SM Public Works Dept., the City is a member of LARA. The membership is paid for by Athens, who provides the City's waste disposal services. Carlson said that AB 939 requires all Cities to divert fifty percent of their solid fills from landfills. By virtue of its membership in LARA, the City is able to pool/ average its numbers so that if in some months they don't quite reach the required fifty percent, they won't incur penalties. Another benefit is shared funding to put on educational showcases and joint events, as well as an opportunity for City staffers to discuss and consult about ways to handle problems, or share success stories for possible implementation. There are sixteen member Cities in LARA, including four San Gabriel Valley cities, Pomona, Sierra Madre, Duarte and Rosemead.

In the education category, both Sierra Madre School and Sierra Madre Community Nursery School (SMCNS) were recognized. At Sierra Madre School, parent volunteer Susan Hoskins and the "Sierra Madre School's Green Team" have contributed to source reduction, recycling, and an enormous amount of education to our school age children in the topic of environmental stewardship. The "Green Team" has just scheduled the first "Waste Less" school dance, and has accomplished a Bottles & Cans recycling program, "Cancel Catalogs for Earth Day" drive, a zero-waste auction fundraiser, and hosted a free E-Waste collection event May 3rd and 4th.

SMCNS was recognized for its continuing effort to create a community of environmental stewards in pre-school children. It hosted a Los Angeles County composting workshop as well as a "Families Helping Families Go Green" workshop. Waste Less Living specializes in zero-waste party and composting services. Waste Less Living not only offers compostable tableware like plates, cups and utensils made from sugar and corn but also arranges for the pick-up and removal of the discarded waste items and food scraps generated from various types of events. Parent volunteers who were singled out at the awards were Lisa Lewis & Christine Lenches-Hinkel, Lewis for her work with composting, and Lenches-Hinkel, who is founder of Waste Less Living.

E. Waldo Ward and Son was recognized in the Commercial Manufacturing/Production category. Sierra Madre's oldest business is leading the way into the "Green" future by maintaining a policy of environmental stewardship. They have several large recycling containers which capture co-mingled recyclables derived from their site.

Fittingly, the award presented to each winner was made of recycled glass. Currently they are recycling at a 75% rate. A

majority of these recycled materials are glass, plastics, and paper, which has a substantial effect on diversion efforts.


In the Commercial / Non-Profit category, recognition was given to three Sierra Madre businesses/organizations: Café 322, Mailbox & Postal, and the Sierra Madre Environmental Action Council. According to LARA's Executive Director, Karen Coca, who hosted the awards luncheon, "Small businesses like Café 322 in Sierra Madre set the example for other small businesses to follow." Café 322 pays for a separate recycling dumpster, with pickup twice a week. The dumpster is filled with plastic, foil, bottles, cans, paper and cardboard, and the recycler processes the recyclables at a Materials Recovery Facility. Café 322 also contracts for a 50-gallon barrel so that they can recycle kitchen grease. The recycler collects the barrel every two months or so for a small fee.

Café 322 supports a citizen-based advocacy group called Environment California with a monthly donation of \$75.00 to promote environmental protection. They buy recycled paper, paper towels, and bathroom tissue, and they try to conserve water by offering water to guests, which they can either accept or deny.

Mailbox & Postal participates in the Green Earth recycling program designed to help reduce pollution and they also developed protocols to reduce excess bubble wrap and "peanuts" that are used in packaging. Through the efforts of owner Armen Khourdajian, residents and businesses are encouraged to bring their packaging materials to Mailbox and Postal for reuse.

The Sierra Madre Environmental Action Council (SMEAC) was formed in 1971. SMEAC has been very active in the community, educating the public on all topics concerning environmental stewardship with a newsletter and articles in local papers. The dedicated group of volunteers organizes clean-up days for the community's Bailey Canyon Park, ensuring that green waste is not disposed of in a landfill. Each year, SMEAC organizes and conducts, on one of the trails above Bailey Canyon Park, a nature awareness program for all third grade students in Sierra Madre.

Non-Sierra Madre organizations recognized at the luncheon included the Duarte Unified School District, Ganesha High School, and the Rosemead School District in the Education Category. In the Commercial / Manufacturing Production category, Halex Corporation, Royal Cabinets, Vertis, and Pregis Corporation were singled out. And in the Commercial / Non-Profit category, Beacon Property Management, Cal Poly Pomona, Panda Restaurant Group, Cal Poly Pomona, Lanterman Development Center, City of Hope, In-n-Out, and Pomona Valley Hospital received

\$38 Million Up In Smoke

With 65 percent of all electricity in Pasadena being coal generated city officials warned late last month that they need to act now before cost skyrocket in order to reduce emissions levels 25 percent by 2020 complying with Gov. Arnold Schwarzenegger's "Global Warming Solutions Act of 2006," known as AB

The law requires that by 2020 the state's greenhouse gas emissions be reduced to 1990 levels. New regulations would apply to all sectors of the economy including electricity generation and natural gas as well as Transpiration. It would also apply to

the construction industry.

The bill defines, "greenhouse gases" as, carbon dioxide (CO2), methane (CH4), nitrous oxide (N2O), hydrofluorocarbons (HFCs), perfluorocarbons (PFCs), and sulfur hexafluoride (SF6). These are the same used in the Kyoto Protocol where 137 counties have come together to combat climate change.

City staff said they would have to buy emission allowances if a "Cap and Trade" program were to take affect costing the city \$38 million a year something none of them said they were in favor of. Under that program the cities below the levels could sell credits to more polluting

Pasadena Water and Power Department General Manager Phyllis Currie said Northern cities in that state tend to have high uses of hydrothermal and geothermal where here in the south we tend to use coal she said. This would lead to the south trading with the north.

Mayor Bill Bogaard said although necessary, AB 32 was one of the most economically threading laws the city will see.

"All of this of course impacts 60,000 customers who are our constituents in the community," he said. "It's clear to me in the months and years ahead, number one, that we're going to be talking about these same issues 'a lot,' and number two, we're going to be discussing them with our constituents 'a lot' and it won't be with an excess of smiles."

He went on to say that people will soon realize, "that the world in changing it terms of the cost of these precious and absolutely necessary commodities."

Currie earlier gave a lengthy report on why and how the city could implement the goals. She said that although the bill mandates that the California Air Resource Board implement regulations by 2012, the rules by which those will apply will be decided this year, including "Cap and Trade."

Councilmember Steve Madison said he though the city could overcome this, "the outlook is challenging but we're pretty smart in this county when we put our minds to things." He then related the issue to child labor laws 100 years ago. "People were up in arms then saying it was going to ruin our economy and we couldn't do business," he said.

Madison said the issue needed to start with more legislative advocacy at both the state and federal level. "Even the President now accepts that there is climate change," he said smiling. He added that maybe there was a way to end coal contracts. The city of Pasadena is locked into buying coal from the Intermountain Power Project in Utah until 2036.

He also said the city needed to immediately embark on a program to

"We should be doing this anyway, before they make us, sort of like kicking a habit," he said. "If we reduce it a little bit every year it would be a lot easier than going cold turkey when they tell us legislative we have to."

Currie said the only other two options were natural gas and nuclear neither of which were viable. Both she said cost much more then coal adding that the city chose coal to save rate payers money, "it's historical," she said. Other council member asked about renewable and alternative energy sources which she said were even higher.

Currie also explained that reducing incrementally at the current rate would take until 2050. "We are looking for ever opportunity to reduce coal, but what I'm saying is we are still on the hook."

Madison also asked about selling coal or generating it themselves. "If we sold coal at a loss let's say, just to get rid of it, and yet we retained the responsibility for the emissions associated with what we sold, that would just aggravate our financial problems," Currie said. She also said the city had looked into generating its own power.

Councilmember Sid Tyler asked if the city's Environmental Advisory Commission had reviewed her report. Saying no Madison commented, "That needs to be done immediately."



The State of our Local Real Estate - Are home values on the way back up yet?

Shortly before the Santa Anita Fire, five local real estate experts agents who do a lot of transactions will be able to evaluate. sat down with me to chat about our local real estate market. It's on everyone's minds these days. It's certainly on the news day in and day

I put out an invitation to the first five respondents from a group of ten professionals whose real estate opinions I value. The idea was to bring them together, to bounce candid insights and perspectives on the current real estate market off one another. Appraiser Brenda Wendt, Realtors Irene Daly of Dilbeck, Jan Thornton from Coldwell Banker, Carmen Thibault from Sotheby's and Dilbeck Arcadia's branch manager, Harold Baerresen brought 84 years of experience to the

Unequivocally, they all agree on what we are NOT. Our local area, which I define as our newspaper's delivery area of Pasadena, Altadena, Sierra Madre, Arcadia and Monrovia, is NOT in the "Foreclosure Freefall" or whatever clever phraseology the 11 o'clock new uses in the sound bite advertising during "Dancing with the Stars." They all feel this is being overplayed into a frenzied generalization, which really applies to only some metro areas like San Bernardino and Riverside.

We are NOT in a newly developing area with large numbers of foreclosures. Do we have some? Yes, of course. When we talked late in April, the numbers were impressively small, however. Wendt identified only four in the 46 active listings in Sierra Madre as of April 18, though the 1 Carter and Stonehouse land parcels (no houses) were reported in foreclosure last week. In a community of 10,578, that is pretty darn stable. Our communities haven't seen the rows and rows of for sale signs with REO, bank-owned or foreclosure riders on them that the

television crews seem so eager to film over in the Inland Empire.

Irene Daly and Harold Baerresen from Dilbeck point out that we are even seeing some multiple offers on well-priced homes with the "right features"... For some, that's the highly rated school district Arcadia offers. For others, it's the energy and night life of Old Town Pasadena, the eclectic charm of Sierra Madre, or the Victorian and historical properties of Monrovia, all vibrant healthy communities. I myself observed an urgency in the buyers at local Sunday open houses recently.

Sales are being made. Active, good agents are selling homes, and the positive is that people in for the "fast buck" have been shaken from the roster. Daly put two Sierra Madre listings into escrow and wrote another Sierra Madre offer this week which is currently in multiple

Choosing a lender is really important, particularly in this post, subprime lending era. These agents have seen which lenders perform on time and which don't, so it's not completely about the rate that's offered. It's also the fees and the reliability of the lender. That's something

SOME ATTRACTIVE BUYS AROUND RIGHT NOW

With 46 single family home listings in Sierra Madre as of that date, the least expensive home in Sierra Madre, excluding the Canyon, is 38 W. Grandview at \$489,900. It is a foreclosure. According to Sierra Madre based appraiser Brenda Wendt, it's approaching what she refers to as land value. In fact, it's a property she mentioned to me a few weeks before, as a seemingly attractive buy within our city. There also happens to be a home on that land, with 924 square feet noted in the listing, plus additional interior square footage not accounted for in county records. It's in a stable neighborhood just outside the downtown area, with welltended homes around it. An easy, two block walk to Bean Town.

When I visited the property, I called the broker, but never received a call back. No return calls from the listing broker? Who knows? Maybe that's why it's still on the market. What I DID see was an active, interested family investigating the property with an agent. By the time

this prints, I certainly hope to see a sold sign there.
The property longest on the market is 700 Oak Crest Drive. A large property with 5051 square feet, it has seen 538 days on market. What some might see as bad news, can be good news. A price drop of \$500k over this period of time puts it at \$1,880,000 and will likely make this an attractive buy for someone looking for an elegant, sophisticated home with great views.

Some interesting marketing strategies have popped up in this market, including listing an Arcadia home on Forest at \$100k in the MLS, in anticipation of an auction, with a "buy it now" price of \$799,000, latching onto the E-Bay style.

The agents all had their own horror stories of trying to complete here they are in no particular order, just like foreclosure and short sale transactions, mostly in the peripheral counties. Jan Thornton commented that the misconception still remains that foreclosures are a great deal. She warns that by the time all the accumulated debts are paid, the price is often higher, not lower than buying from an owner-occupied homeowner who is a motivated seller. All the agents piped up with concerns and cautions about foreclosure deals, and Daly reiterated several times her problems with lender-owner addenda to the sales contracts.

There's a whole set of risks involved with buying a foreclosed home. When an owner walks away from a home in foreclosure, there's often anger and emotion involved. If the owner can take it with them, they likely do. The appliances disappear. The lighting and plumbing fixtures and the air conditioners disappear. Not necessarily neatly either. So buyer beware. Since money's obviously been an issue, there's often deferred maintenance. One commented that if the little items aren't maintained well, the bigger ticket home repair and maintenance items are likely deferred, too.

Carmen Thibault said she has had extensive trouble in getting timely contract responses from the lenders holding foreclosure listings. The banks are just not in the business of holding and selling homes. On a whole, they don't go out of their way to make it easy either. Slow responses on paperwork often follow insult with injury, with high penalties and fees if you don't close within their specified tight time frame. This just compounds the difficulties in dealing with a corporate entity rather than an in situ homeowner. Many banks have assigned processing companies to deal with their foreclosed properties, and some of these are particularly uncooperative. Again, they stressed that we're VERY lucky to be in such a stable area, with such a low percentage of homes with these sale issues.

ARE WE ON THE WAY BACK UP?

Baerresen chuckles that the only way to ascertain whether we're on the upswing for sure, is to check "the rear view mirror." Wendt commented that these past few months of flat sales prices usually signals that the bottom's been reached. 





### The Amendments

As a public service to our wonderful community of citizens, this newspaper is going to recap below the 27 Amendments to the constitution. You are enouraged to cut this column out and put it on your refrigerator. As your choices for political office start taking

stands on issues, you can compare, where applicable, how they relate to these amendments. Shall we begin?

#1. Freedom of religion, speech, press, petition and assembly.

#2. The right to keep and bear arms, and form a militia. #3. No quartering of soldiers in private houses during peacetime.

#4. Protection from unreasonable searches and seizures.

#5. Protection against self-incrimination and double jeopardy. #6. Fair, speedy, public trial by jury and the right to counsel.

#7. Right to trial by jury in civil cases. #8. No cruel and unusual punishment, or excessive fines. #9. Protection of rights not enumerated in the Constitution.

#10. All other powers reserved to the state or the people.

#11. Immunity of states to federal and foreign law suits. #12. Procedures for electing the President and Vice President. #13. Abolition of Slavery

#14. Guarantee of citizenship, equal protection and due process.

#15. Guarantees the right to vote regardless of race, color or previous servitude.

#16. Gives Congress the right to levy income taxes. #17. Direct election of U.S. Senators by the citizens

#18. Introduced Prohibition

#19.Guarantees women the right to vote

#20. Moved succession of office from March up to January.

#21. Repeal of Prohibition. #22. Limits Presidents to two terms in office.

#23. Gave D.C. residents a vote in Presidential elections. #24. Prohibits the charging of a poll tax in federal elections.

#25. Defines the succession to the presidency

#26. Standardized the voting age to 18. #27. Postpones Congressional pay raises until after a new election.

The last amendment was ratified in 1992. It was originally submitted to congress in 1789 meaning it took over 202 years to be ratified. In case you are interested six amendments proposed by Congress have failed to be ratified by the appropriate number of states. Four are still technically pending. They are:

A. The U.S. House of Representatives Apportionment Amendment (Big wow!) That was proposed in September of 1789.

B. The TONA Amendment was proposed in May of 1810. It restricts any citizen from accepting any title of nobility from some foreign country or ruler without the consent of Congress.

C. The Corwin Amendment was proposed in March of 1861. It would have prohibited Congress from banning slavery in those states whose state laws permitted it.

D. This amendment would give Congress power to regulate child labor. It was proposed June 2, 1924 and is still pending. The two proposed Amendments that have expired are:

Rights Amendment proposed in 1972 and expired in 1979.

F. an Amendment giving the District of Columbia the equivalency of statehood. It was proposed in 1978 and expired in 1985. So, what else do you want to know?

## From The Desk Of.... Glenn Lambdin

I believe it was Albert Einstein that said, "Insanity is doing the same thing over and over and expecting different results." Ahh, Sierra Madre, take note.

Sierra Madre has been an interesting study between what somehave called the Preservation ist vs. Property Rights People. I have never really liked these two labels because it implies that if you are a Property Rights Person then you are an Anti-Preservationist or vise versa. I believe you can be both preservationist and property rights advocate.

Over the past dozen or so years, Sierra Madre has been party to several public battles all in the name of preserving the character and historical fabric of our town. While nobody wants to see the character and charm of Sierra Madre changed, intense battle lines have been drawn. In each case, the intention to preserve was admirable but the method used resulted in costly adverse results.

What good is intention if a repeated methodology only erodes what we all desire? Why continue to employ a failed methodology expecting different results. Its insanity. And the method used, well, it has been an aggressive "in your face" to the property owners that attempts to force them to do what "we" say you are going to do.

To those that continue to employ this method, perhaps you should take a close look and take ownership of the results of your efforts. Look at what you're leaving our town and the price we end up paying. In each case, the cost has escalated and has become increasingly more destructive.

To illustrate, in 1995, Sierra Madre had a Cultural Heritage Commission (CHC) and a list of historical properties. To my knowledge, at that time, not one single homeowner objected to being listed. With meaningful intentions of preservation, the CHC embarked on an over zealous campaign that launched the town



into a battle that resulted in two costly initiatives and a landmark court case. When the dust settled, we were left with 29 fewer homes on our list of historical resources. In 1998, the Kraft Estate had only

one home on the property and the largest stand of oak trees in the city. The estate was sold to a doctor who wanted to build a second home on the property where he and his wife could raise their family, leaving the southern half of the property undeveloped. Again, with intentions of preservation and the same forceful and harassing approach, the method yielded opposite results. Tired and frustrated by the harassment, the good doctor subdivided the estate into five lots and sold them. Today, instead of two homes on the property, there are five. Too bad the lesson wasn't learned there.

Unfortunately, this same method is being used at One Carter and Stonehouse. It is history repeating itself and regardless of intention, we can already see grave results of enormous proportions. Is there anyone who is not saddened, if not sickened, by the sight of the hillside that has been butchered, raped and left abandoned?

It appears that One Carter and Stonehouse may soon be under new ownership or at least new control. Maybe, just maybe, this time the vocal opposition to these two projects can approach the new owners with a realistic sense of logic and reason and put an end to the repeated short-sighted method that renders adverse results. Maybe we can come out ahead this time undamaged. Hopefully, One Carter isn't beyond salvaging and the need to salvage will never even be a topic of discussion at Stonehouse.

In a 1953 short story titled "The Golden Apples of the Sun," author Ray Bradbury imagined a space expedition that would approach the Sun, reach out, and snatch a sample of its material—while the spacecraft's crew nearly perished from the intense heat.

Now, 55 years later, science-fact is catching up with science-fiction. NASA is about to send a spacecraft to the Sun that will duplicate, in some respects, Bradbury's perilous mission—except that this robotic craft will carry no crew to feel the sun's heat.

The Johns Hopkins University Applied Physics Laboratory (APL) is building a spacecraft to be sent closer to the sun than any probe has ever gone – and what it finds could revolutionize what we know about our star and the solar wind that influences everything in our solar

The ambitious Solar Probe mission will study the streams of charged particles the sun hurls into space from a vantage point within the sun's corona—its outer atmosphere—where the processes that heat the corona and produce solar wind occur. At closest approach, Solar Probe will zip past the sun at 125 miles per second, protected by a carbon-composite heat shield that must withstand up to 2,600 degrees Fahrenheit and survive

Experts in the U.S. and abroad have grappled with this mission concept for more than 30 years, running into seemingly insurmountable technology and budgetary limitations. February an APL-led team completed a Solar Probe engineering and mission design study at NASA's request, detailing just how the robotic mission could be accomplished. The study team used an APL-led 2005 study as its baseline, but then significantly altered the concept to meet NASA's challenging cost and technical requirements.

"We knew we were on the right track," says Andrew Dantzler, Solar Probe project manager at APL. "Now we've put it all together in an innovative package; the technology is within reach, the concept is feasible, and the entire mission can be done for less than \$750 million—about the cost of a medium-class planetary mission. NASA decided it was time."

APL will design and build the spacecraft, on a schedule to launch in 2015. The compact, solar-powered probe will weigh about 1,000 pounds; preliminary designs include a 9-footdiameter, 6-inch-thick, carbon-foamfilled solar shield atop the spacecraft body. Two sets of solar arrays will retract or extend as the spacecraft swings toward or away from the Sun during several loops around the inner solar system, making sure the panels stay

at proper temperatures and power levels. blasts of radiation and energized dust at At its closest approach to the Sun, the spacecraft must survive solar intensity more than 500 times what it experienced while orbiting Earth.

Solar Probe will use seven Venus flybys over nearly seven years to gradually shrink its orbit around the Sun, coming as close as 4.1 million miles (6.6 million kilometers) to the Sun, well within the orbit of Mercury and about eight times closer than any spacecraft has come

Solar Probe will employ a combination of in-place and remote measurements to achieve the mission's primary scientific goals: (1) determine the structure and dynamics of the magnetic fields at the sources of solar wind; (2) trace the flow of energy that heats the corona and accelerates the solar wind; (3) determine what mechanisms accelerate and transport energetic particles; and (4) explore dusty plasma near the sun and its influence on solar wind and energetic




## Rebuilding After Stress

Intense periods of stress whether they be long or short - leave their effects. Stories abound of people whose hair "turned white overnight," or turned white

weeks or months after an event. Sudden events can be "merely" stressful - which can sometimes be relatively to overcome, or majorly shocking, leaving one very different than before the event. Loss of spouse or career can result in serious health challenges one or two years afterwards as part of the body's healing response.

What some of us experienced during the fires was stressful - mildly for those who lived near Orange Grove, more seriously for those who live right next to our usually peaceful, protective and nurturing foothills. Within a few hours of the fire starting, 1,000 of our friends and neighbors were under mandatory evacuation from their homes. Others were advised of the fire's possible future path, and advised to be prepared to evacuate at any moment.

Whether we chose to move out, or stay, our amydala (survival brain) kicked in, activating adrenal glands to give us the energy to "fight or flight". Those two very small 1/2" x 3" orange colored glands that scrunched on top of each of our kidneys take a tremendous beating in today's world. The medulla, inside each gland, actually produces the adrenaline (epinephrine and norepinephrine), while the cortex, the outer layer, produces other hormones, such as cortisone and aldosterone, which help balance our body's fluids and electrolytes (salt).

For most of us, moments of stress come and go Darn! I burnt the toast! Aghh, I got a parking ticket. Whoops, I almost got hit by that car. Fleeting, irritating, scary. But when something goes on for a while - for a few hours, or days, or weeks, or months or, per Al Martinez' editorial in today's LA Times about the effects of war on our unprepared young men, the left-over effects can be much more serious.

After serious stress, can we regain our lives? How?

Our strength? How? What do we do?

Here in town, most of us said, "Good, I'm back home. Things are still here." But the 2 or 3 days of stress linger according to our own unique response. When it's serious enough, it gets fancy labels called post-traumatic stress disorder. We can get "stuck" inside with nerves that never settle down, with a hyperactive "alert" system that startles at everything, to interrupted sleep. Each of

these affects our nutritional reserves and strength. From my point of view, there needs to be a balanced, two-pronged re-stabilization process. One is physical, and the other is emotional.

For the physical, increase intake of quality foods, as many fresh (not cooked) vegetables and fruits as possible, easily digested sources of protein, more of the critically essential fatty acids. Take conscious time to chew foods more thoroughly for a while to help start the digestion right. Include additional digestive enzymes to more completely breakdown those carbs, fats and proteins so that more nutrients are available. Add some good whole-food supplements. The first vitamins to go are the B vitamins. Lack of B1 leads to shaking, lack of PABA and Pantothenic acid leads to white hair

When I was 27, fell off a balance beam while doing a backwards somersault, and accidentally pulled out a handful of my long hair - and discovered that there were 3" of white at the roots! I was appalled, to put it mildly! After three years on megavitamins, including at least 300 mg of mixed B vitamins every day, there wasn't a gray hair anywhere. I eventually phased out of supplements and, for the last umpty decades really haven't done much with them. And yes, I have some grey hairs now, but I'm betting if I again boosted my Bs, and the other things I know I've let slide, that they'd all

On the emotional side, what were the (hidden) fears? Financial? Loss of life? Choosing among touchstones? Treasures? Where would you go? What was most important? How do one's inner instinctive selections "square" with what one thinks other people's opinions would be? Was there a detachment process, when realizing that of everything you had acquired, you, yourself could only take a few things, at best? And, by yourself, not even the ones you prized most? Then to have the reprieve and release - nothing lost. But still, the effects of your inner process lingers ... until you finds a way to deal with it.

May I suggest taking care of yourself with patience for self and neighbors. Pay attention now, and recover more quickly - so that you're not blindsided several months from now when you see or experience something "new" and unexpected. Coming back from stress is another one of those "from the inside out" processes that only we can accomplish. Don't you just wish sometimes that you didn't' have to do it all? I know I do ...
