State Of Emergency: Part II Rain and Mudslides Add To Hillside Worries



For the second time in less than a month, Mayor Kurt Zimmerman declared a State Of Emergency for Sierra Madre. This time, the call was made in an effort to maintain the outside agency support originally received for last month's fire during the current rains and mudslides. According to City Manager Elaine Aguilar, it was unclear if the two week federal limit applied to the city's current situation. As a result, an emergency meeting was called at 1:00 pm Friday. All council members were present, with the exception of Councilman Joe Mosca who attended via telephone conferencing. Aguilar said most of the council members were called from work that morning for the council meeting that lasted no more than ten minutes. The meeting was so quick most of the local TV news stations covering the story missed it. After the council voted unanimously in favor, the Mayor gave a statement explaining the

Zimmerman, addressing reporters, said the council had an obligation to protect citizens and that is why the emergency. "I don't live in the canyon area although obviously I'm very distressed," Zimmerman said. "This is a perverse double whammy, first the fire and now unfortunately. the mudslides."

According to Aguilar, 90 crews from LA County, Arcadia, Monrovia, and other cities helped Thursday night including inmates from nearby jails wearing bight orange jumpsuits. On Friday, about 60 crews remained and were expected to work throughout the night. "We monitor the weather," she said. "They predict a 60 percent chance of rain later today and again 50 percent tomorrow [Saturday]."

A heavy tractor was brought in to clear mud on blocked streets including areas around Skyline Drive where voluntary evacuations were issued Thursday evening.

The U.S. Forest Service sent a geologist to survey the area right after the fire because of the steep slopes. That information was shared in a report with the city last week said Public Works Director, Bruce Inman. That report

helped the city anticipate the manpower requirements in the event of rain, which began Thursday afternoon.

Residents can get sand and sandbags at the City Yard and at Mary's Market. Sandbags can also be picked up at the SM Fire Station. Bailey Canyon and Mt. Wilson Trail will be closed through Sunday. The Mount Wilson Trail Race set for Saturday has been postponed. A new date will be determined this Tuesday according to the city manager. MVO

Volunteers Worked Diligently To Prepare Trail Race

Editors Note: The Mt. Wilson Trail Race was scheduled for Saturday, May 24th, however, due to recent rain and mudslikdes, it has been postponed. At press time, there no new date had been scheduled. Prior to the cancellation, voluteers worked very hard to prepare the trail in the aftermath of April's firestorm. This story tells of the volunteer efforts that prepared, and will probably prepare again, the trail for runners.

Though it is the 42nd running of the race, it is the 100 year anniversary of the first race, run by nine runners back in 1908. The men ran seven miles from Sierra Madre up to Mt. Wilson, rested half an hour, then came

From 1912 to 1929, there was no race, some say because the runners' interest was waning due to the popularity of the automobile. Half-way between Sierra Madre and Mt. Wilson

that soon became a public resort known as "Orchard Camp." In 1930, the trail race was started again to draw attention to Orchard Camp, and for the first time, the race was expanded to include women and young girls.

The race was held sporadically until the late 1940's when it was abandoned completely. It was revived in the autumn of 1965, and over the years evolved to its present format. In the spring of 1987, it was held in conjunction with Search and Rescue Days. It has been run annually ever since, but this year, the Centennial of the first race, it nearly wasn't. The Santa Anita Fire closed down the trail and did some major damage to the hillside on which the trail sits.

According to Pete Siberell, chairman of the Mt. Wilson Trail Race Committee, the work literally started while there were still fires on the mountain on Monday, April 28. A meeting of the Committee was Peter McNulty, Gary Hilliard, Mark Gage, John Grace, (cont. pg. 3)

held in Kersting Court, and the members resolved to get the trail ready in time to have the race go on as planned. "I received 15-20 calls and emails on that day from people who wanted to help," said Siberell. "The first step was assessing the damage, which we did in short order right after the trail was closed. The majority of damage occurred in a stretch less than a mile-long, between the fire road just above the trailhead and the switchbacks just short of First Water." While there is significant damage on the ridge to the east of the trail, the ridge on which the trail runs is relatively unscathed north of First Water up to Orchard Camp, 3.3 miles up from the foot of the Trail.

Charlie Bell, a long-time Trail Blazer who has tended the trail for many years, went up the trail numerous times with other colleagues to assess its condition and to start grooming the trail. His co-workers included





Sierra Madre Playhouse

Co-Founder Charles Andreese Passes
Charles Andrese died Friday, May 9. He co-founded the Sierra
Madre Playhouse in 1980 and has been its principal visionary



Initially, he was involved in acting in and directing playhouse

productions; later, (cont. page 3) along with Stan Zalas, he concentrated on the artistic and business management of the enterprise. The two set very high artistic standards, and, despite a perennial shortage of funds, the playhouse acquired a well-deserved reputation for excellence.

For many years, Charles was the persona of the playhouse, taking phone reservations, greeting patrons, serving cookies and punch at intermission, seeing patrons out after the play, and cleaning up once they had left. He seemed to know everyone personally, frequently reserving preferred seats for special patrons. (In those days, those in the know brought their own seat cushions to

protect themselves from protruding springs).

Andrese fell ill in 1995, and was able to attend his beloved "Masterpiece Theater" on only a few occasions since. However, he remained its Artistic Director, selecting plays and directors with an unerring eye for good, family entertainment. He corresponded frequently with his many friends and kept abreast of what was going on in the playhouse and the city.

The family has not released information on what memorials may be planned.

POLICE DECOY NABS PEDESTRIANS

On Wednesday, May 14, 2008, from 11:30 a.m. to 3:30 p.m. the Sierra Madre Police Department hosted a Pedestrian Decoy Awareness Program at the intersection of Sierra Madre Blvd. and Hermosa Ave. The Department has received many complaints from residents about flagrant crosswalk violations in the downtown area. Four Monterey Park Police Department motor officers and Jan's Towing assisted the Sierra Madre Police Department in the operation. The emphasis for this event was on driver awareness, education and enforcement.

A total of 2,244 vehicles passed through this intersection during the operation. Officers wrote 42 citations and towed 2 vehicles. The following is a breakdown of the violations issued during the 4-hour period:

- 31 drivers were cited for Vehicle Code Section (VC) 21950(a) Driver not Stopping for Pedestrian in a Crosswalk;
- 2 drivers were cited for V.C. 12500(a) Unlicensed Driver;
- 7 drivers were cited for V.C. 27315(d)(1) Driver not Wearing a Seatbelt;
- 2 drivers were cited for V.C. 27315(e) Passenger not Wearing a Seatbelt;
- 1 driver was cited for V.C. 26708(a)(1) Objects Blocking Window;

1 driver was cited for V.C. 12951(a) – Driver not in Possession of Driver License; and

1 driver was cited for V.C. 27007 - Loud Music Heard 50-feet or More from Vehicle.

We used a total of 8 hours of overtime for a SMPD sergeant and one officer. The costs were charged to a State grant fund, not to our General Fund. The other personnel were either on duty or volunteered. Police Chief Jones Moy of the Monterey Park PD graciously donated the services of the four motorcycle officers.

And Pete Siberell ran up and down the trail numerous times to make sure the trail was race ready. Upon hearing those recommendations, the city opened the trail the afternoon of May 9th and

agreed with Siberell the race would be run as scheduled, absent any mudslides occurring before then!

That doesn't mean the work is finished. Crews will continue going up to clear slough that will have fallen on the trail between now and race day. Heiner and Siberell will be going up the trail before race day to flag any spots still considered dangerous for runners,

MacGillivray Recused From 1 Carter ${ m Talks}$ -Residence Poses Possible Conflict Of Interest By

Sandra Levin Tuesday night advised council member Maryann MacGillivray not to participate in any discussion of the One Carter project because her home is within 500 feet of that property, the distance defined by the California Fair Political Practices Commission as creating a conflict of interest.

"She [Levin] said I've got to wait for my letter from the FPPC," MacGillivray said as she recused herself by walking out halfway through the closed session, a move that by law should have been done publicly before the meeting.

According to the FPPC, "If the decision is to take place during a closed session, the identification of the economic interest must be made during the public meeting prior to the closed session, but is limited to a declaration that the official has a conflict of interest. The official may not be present during consideration of the closed session item and may not obtain or review any non-public information regarding the decision." Councilmember Don Watts also recused himself, leaving only council members Joe Mosca, John Buchanan and Mayor Kurt Zimmerman to make all decisions, something Buchanan had said he thought was a bad idea.

Watts said "I don't want to put the city at risk," as he waited in the empty chambers. He also confirmed that MacGillivray was in the closed session before coming out.

The official must leave the dais to speak from the same area as the members of the public and may listen to the public discussion of the matter."

> With MacGillivry present, Levin gave a brief overview of the pending Stonehouse lawsuits advising that it would be January, at the earliest, before the lawsuits would go before a judge. She also said the city won one of the first cases, although the judgment was now up on appeal.

Did You Know After The Fire

By Pat Birdsall

Writing this during a heavy downpour of rain and hail is probably not the best time to impart this information. Although the following might be ingrained in the fiber of those living in Sierra Madre's fire/flood zone, it probably bears repeating.

* Never underestimate the power of storm water and debris flows.

* Try to direct storm water and debris flows away from any structures.

* Avoid altering any natural or existing drainage patterns in a way that might worsen conditions for you or your neighbors. * Avoid trying to control or confine flows more than is absolutely necessary;

Remember that the water and debris flows need to go somewhere. * Place protection devices in such a way so as to deflect debris: do not try to

create a dam or stop the flows in any way—this may cause flooding. * In extreme conditions, board up windows as necessary to prevent debris from entering structures.

* Protect your most valuable property first—your home. Minor structures, pools

and landscaping can be protected providing time and money are available. * Be prepared to sacrifice the use of portions of your property to achieve the

greatest amount of protection.

Don't take unnecessary risks. If your debris control problems appear to warrant solutions beyond the scope of this guide, consult an expert such as a civil or geotechnical engineer or a landscape architect for additional advice. sgcountyrecovery.com



Memorial Honors War Dead In Iraq

Symbolizing Americans that have died in Iraq, Students at Pasadena City College Thursday put thousands of stakes in the ground creating a sea of white ribbons in front of the school as a reminder this Memorial Day of the coats involved in fighting a war.

"We also have boots out here that were brought in by exveterans," said "Heather Martin, a student at PCC and organizer of the event. "They do a program with the boots and so they lent them to us for a day." Each pair of combat boots had military dog tags identify the soldier who wore them. Martin said. This was the forth year they had done the event through Students for Social Justice. "Basically it's to raise awareness about what's going on with the Iraqi war," she said. "And other issues surrounding the war, including economics."

A number of speakers from the group talked about either their own experiences or the experience of the children in Iraq now. Most were medics and one story in particular had the speaker graphically describing the day to day work of picking up body parts.

Well known conscientious objector to the war, Augustine Aguyo, said he spent eight months in a military prison in Germany after refusing to put his gun back together and joining his unit's second deployment to Iraq. "I was asked to return to Iraq for another tour of duty," he said. "I knew I couldn't do it, I knew that because of everything I knew I couldn't go forward. That's just not tolerated so I was court-

Aguyo, 30, said he has been on exit leave status pending the authorization of the punitive discharge. He has been lowered in rank as a medic going from an E4 specialist to E1. He also said many believed like him in the military although it is hard

to speech out. A senior he knew told him, "that for every door they kick in they make five new enemies."

Others said 30,329 soldiers had been wounded since March, 19 2003 the day the war started. According to the Department of Defense, as of Thursday 4,080 soldiers have been killed, 3,327 in combat.

Organizers of the event also said the war has cost \$522 billion, tax money that could be used for other things such as student loans and early education. "Were sending on average \$350 million a day," someone said, adding that the states total budget shortfall of \$4 billion is the same as four days of spending in Iraq.

Martin also said she was a Ron Paul supporter because all three

Classic Steinbeck With A Twist

When John Steinbeck wrote Of Mice and Men he most likely never envisioned that his classic tale of a migrant worker's plight could be twisted to apply to the fluctuating perception of laborers trying to make a living in the United States.

Currently, the Pasadena Playhouse is presenting and interpretation of the play which features a largely Latino cast including David Noroña as George and Al Espinosa as Lennie —

and is set in 1942 rather than the Depression.

The change in period places the Salinas Valley-rooted play in the time of the Bracero Treaty between U.S. and Mexico, which allowed Mexican farm laborers to work in the fertile region of California. The classic tale of two friends, who are manual workers, will run at the Pasadena Playhouse through June 8.

With this spin, the Interim Educational Director for the Pasadena Playhouse, Brian Davidson decided to organize the local Latin community in promoting a variety of topical issues that also displayed indigenous Latin artisan work focusing on the fair treatment and dignity of migrant workers, as opposed to the exploitation of cheap labor and the despair involved. Last Monday theater-goers were able to visit booths in the courtyard of the playhouse sponsored by Latino Heritage, El Central De Accion Social and the Los Angeles Latino Exhibit. The Majestical Roof and Ten Thousand Villages were also on hand to promote the ethical

treatment of workers | locally and globally. Davidson also has decided to provide educational experience for

students during the play's run.
"We are innovating something new at the

Playhouse involving students from area schools to take part in," said Davidson. "We have had an overwhelming response. It was first come; first serve and we already have

a waiting list from Pasadena Unified and L.A. Unified school

According to the Pasadena Playhouse synopsis, Steinbeck's powerful portrait of two men's quest for the American dream is given an astounding and provocative make-over by acclaimed director Paul Lazarus. In 1942, several years after Steinbeck's original setting for Of Mice and Men, a government sponsored program was put into place that would forever change the face of immigration in this country.

"It's about the experience of the migrant worker. The original was written in the 30's and focused on the Euro-American migrants that were coming into the country," said Roberta Martinez, of Latino Heitage. "What they've done is to set this when the Bracero Program took place and opened the door to thousands of Mexican immigrants who crossed the border in pursuit of dreams

for a better life for their families."

Foothill's Study Looks at New Rim of the Valley National Park Story and Photos By Dean Lee

Looking out over part of the San Fernando Valley in 100 degree heat last Friday, Congressman Adam Schiff told a local group of environmental supporters that the next step after President George Bush's signing of the Rim of the Valley Corridor Study legislation was to tell the federal government exactly what they wanted to

The legislation was included in the Consolidated Natural Resources Act of 2008 and signed by Bush May, 8,2008.

Schiff said was a seven year effort which began in 2001. The estimated \$500,000 study will take three years to complete.

Santa Monica Mountains Conservancy Director, Joseph Edmiston, called Bush's signing the first step toward a new National Park. He said it is not easy to get Bush to sign legislation toward any parkland calling the move a testimony to Schiff's dedication to the bill. Somewhat jokingly Assemblyman Anthony Portantino said this was evidence against term limits and added that it takes a while to get things done in Washington.

The bill includes part of the Santa Monica Mountains, the Santa Susanna Mountains, the San Gabriel Mountains, the Verdugo Mountains, the San Rafael Hills, and adjacent connector areas to the Los Padres and San Bernardino National Forests.

Schiff also said the study would itself define the complete area including as far east as Sierra Madre and the foothills of Altadena. He said there was no guarantee to be part of the study and advised residents in Sierra Madre and other nearby areas to pressure city officials into passing resolutions in support of the study.

There are currently 645,000 total acres contained within the Rim of the Valley Corridor," he said. "This includes 153,000 acres already in the Santa Monica Mountains National Recreation Area."

Caroline Brown President of the Sierra Madre Mountain Conservancy said she planned to do just that, having already sent all Sierra Madre city council members a letter explaining the study. She said it was Schiff's legislation that gave Sierra Madre a seat on the Advisory Board to the Santa Monica Mountains Conservancy although Schiff does not represent the city. Brown also said Sierra Madre has had a

longstanding relationship with Santa Monica Mountains Conservancy being part

"Happily, many cities in the region have sponsored council resolutions putting the cities on record in support of the study," Schiff said. "Now that the bill has been authorized I think it would be very valuable for the communities to organize and provide a lot of feedback to the Department of the Interior."

Opponents of the study called it a \$2 billion land grab. They argue expanding the Santa Monica Mountains National Recreation Area will hurt growth. Edmiston said the area was not going to solve the state's growth problem. Some claim this will also lead to eminent domain actions.


The study has no eminent domain power in it, that's simply wrong," Schiff said. "What will happen if the area is expanded to be part of the recreation area is we can draw on the resources of the federal government in terms of studying wildlife patterns, trail preservation, enhancing recreational opportunities and make sure the ecosystems are strong." He also added that the

federal government could buy land from willing sellers in area.

Schiff said the area was one of the most populated in the country with 1 in 10 people living here yet the area has one of the lowest ratios for park lands per 1,000 population anywhere in the country.

So this rapidly growing urban region is extremely underserved to terms of open space needs," he said. "unless action is taken soon this situation will only worsen as the region continues to grow."

He said the area was an example of the world's most endangered habitat, the Mediterranean Chaparral Ecosystem.

The City Council and PUSD jointly voted unanimously last Monday night to not only create a committee made up of senior staff from each organization led by interim city manager Bernard Melekian and Superintendent Edwin Diaz but to also prioritize goals starting with a truancy program, security rangers, and a career internship program

Diaz said they first used the budget to see how the two bodies could come together jointly. He also said they used district reorganization.

"As we looked at all of our functions, rolls and responsibilities and all over the services that we provide to schools, again we tried to identify areas that would be good areas that could potentially be common interest between the school district and the city of Pasadena," he said.

Diaz added the most important areas were, safety and security, dropout recovery, attendance improvement, truancy reduction, partnership in maintenance and grounds keeping and secondary reform, having all graduates well prepared for college and or work.

Melekian said, "We saw the creation of this committee as a significant step forward in a relationship between the city and school district."

PUSD Board member Bob Harrison said "Suppose we take this and the priority was on this whole truancy and attendance notion, is this something the committee would talk about then go outside and get information on how to really attack this in the frame of what's the cost is and then comes back to both bodies?" Melekian said that was exactly how it was envisioned.

Later PUSD Board member Bob Harrison said "if the city did financially pick up something like maintenance then that would free up money for other things not on the list and we could go forward meeting our goals." This said after a lengthy first discussion on school grounds and joint use of facilities.

Councilmember Victor Gordo suggested looking at artificial fields saying they could get 25 more hours then the current 30 to 40 hours now.

PUSD Board President Tom Selinske said field upgrades were part of their facilities master plan. Haderlein also said they were worried about joint partners for the fields being outside the city such as nonprofits, "they might want to take control of something that's for community use," he said echoing Gordo.

Haderlian added if they could both expand the truancy program and expand the security rangers programs and have them up and running for the September school year he would view that as a success. He added that the security rangers were part of school safety

Melekian said he wanted to move forward with a city staff career internship program. He said the idea would be that students move from high school to PCC and beyond into municipal work. He said students could earn units at PCC.

The members of the new committee would be established in the following days after the meeting Melekian said. The city and PUSD will report back to each board respectably Melekian.





Hey - Cheapskate - Do You Know About Tipping?

Am I talking to you? I hope not. We all know them, the people that just can't bring themselves to leave a decent tip. So, what is the current thinking behind tipping and what should be given, and when did it start in America? Tipping began to take hold in Sates in the late 19th Century after the Civil War. It was widely considered by many groups, including the intellectuals of the day, as an outright evil. Newspapers wrote vigorously against its vices. They reasoned that it established an aura of servitude, by offering a demeaning handout, or token. It implied a superiority of class and status that demeaned the lowly receiver of these offerings. There were groups such as bartenders that flatly refused tips, as they considered them far below their status to receive these patronizing gifts. Now when someone says, "those were the good old days," you may know what they mean. It many ways the objections did make sense at this time in America. Then America was the ideal of no separation of class

or status. Those attitudes are long forgotten, as the tide has changed dramatically. The tipper of today may now feel the servant of some codified law from Hammurabi, which they do not entirely understand. Tipping is, in theory, to insure good service and once completed, rewarded in scale. Today tipping is so copious that we encounter it at every turn.

What about the places where you have to tip in advance? This does not insure good service, does it? Only at a place like a Starbucks does this seem to make any sense. There are very few times that I have gone to a restaurant and actually tipped in advance. One instance was opening day at The Race Track at Del Mar. The reason? That day there were very few seats available for an overflow crowd. Thus, the maitre'd just takes the tip, which does not insure great service, but you may actually get a seat if the number on the bill is large enough. When determining a tip at a restaurant, what are you to consider before settling your bill and factoring a tip? At the

restaurant you are tipping on the speed, accuracy and usefulness of the servers, and not on the food. Is tipping at a fancy restaurant different than tipping at a coffee shop? Many people believe it is. I feel like I stepped in something when I hear that said. They are to be treated as the same. Here are my guidelines for tipping, but not necessarily the way I tip. I even give 10% for atrocious service. It seems with my picture in this paper, on my TV show "The Chef Knows," that I might get a bad reputation from the Server Syndicate, and be labeled a "bad tipper," which is a stigma that I carefully avoid. You on the other hand can wield far more influence


than is availed to this restaurant critic. Here are my suggestions from the Coffee house to Spago: Fair to medium service - 12 to 14 %, Good to Better than Average - 15 to 18%, Great Service - 20%. These should be applied to the food and beverage total, before tax. Can't figure the whole percentage on tipping? Just double the tax, which falls in the Good range.

Also, for parties of 8 or more, many times restaurants include the tip in the total, so check for that or ask if you are

Let's move on and head to the bar. How much should you leave for wine or a drink at the bar? Believe it or not, a full bottle of a \$10 wine takes as much energy to open as a bottle of Dom Perignon. If the bartender keeps my glass full and clean, and if the wine is kept cold, and he takes the time to pour it for me, I suggest 10 to 12%, with a minimum of \$3 for the bartender. Have Kids? Of course I do. Luckily mine is as clean and tidy as they make them, but not all are created like her. If your children make a mess, throw food and crayons on the floor, I always leave the busboy at least \$3 extra. If you

don't, well you could consider cleaning it yourself. Now let's leave the restaurant and move to the car - Valet Parking. If there is no charge and it's a tip only, I suggest at least \$5, again depending on speed of service. What if there is a \$5 fee? I will give at least \$1 extra and maybe even \$3 if my car is brought to me quickly.


level of energy was astounding, and people raved about the way I looked.

This is the basis of our Constitution and one principle that I have sworn an oath to defend. I take it very seriously.

Legally, couples are not required to be married to make babies, nor are they required to make babies if they are married. ONE CARTER, STONEHOUSE, HMZ, AND WILDFIRES

It has now been confirmed: One Carter and Stonehouse are to be put up for auction. This shouldn't come as a surprise to anyone who has been following the financial implosion of Dorn Platz, the Glendale-based development LLC. Last year they went belly up over a \$32.5 million development in Beaverton, Washington. This year they've closed shop on the Ambassador development in Pasadena. Now they are fighting with their partners from Dubai over the sale of One Carter and Stonehouse. In the meantime, both properties have been denuded of all vegetation by the recent Santa Anita Wildfire.

The hazard of wildfires has been with us since the city was incorporated in 1907. Wildfires are for the most part reoccurring natural phenomena. Brush grows, hot weather comes, humidity drops, and the hazard of forest fire rises accordingly. All that is needed is a spark, a puff of wind and a whole hillside goes up in flames. Is this what is meant by "sustainable growth"—burn down the hillsides every 15 years so developers can reap windfall profits building new homes to replace the ones that have been torched?

Does anyone remember the 1993 Altadena fire? I do. I was living on Michillinda then. I remember looking up the street at a wall of fire dangerously close to the mountainside homes. I also remember thinking how lucky we were. Had the wind direction changed the fire could have burned out the northern half of the city, say everything above Grandview—not a very reassuring thought.

The reality is that Sierra Madre is located smack dab in the middle of $\,$ what geographers call an "urban-wilderness interface zone". Simply put, we live next to a national forest that because of climate is highly prone to wildfires. Perhaps a better way to describe our predicament is that the more we build homes on our hillsides the more likely it is that at some future time we will experience a catastrophic fire. And this doesn't even begin to describe the long-term environmental impact, nor the permanent loss of habitat for a variety native plants and animals.

Last year the city adopted the Hillside Management Zone Ordinance. The express purpose of the HMZ is to protect our hillsides from the kind development that would negatively impact the natural environment and put the city at higher risk of fire. This is the good news. The bad news is that the development of One Carter and Stonehouse has continued unabated without regard to the intention, meaning or spirit of the HMZ.

Here are the main goals of the HMZ:

- Protect the natural environment of hillside areas from change by preserving and protecting the views to and from hillside areas in the city to maintain the identity, image and environmental quality of the city; and
- Maintain an environmental equilibrium consistent with the native vegetation, animal life, geology, slopes, and drainage patterns;
- Ensure that development in the hillside areas is located so as to result in the least environmental impact; and
- Encourage the planning, design, development and use of home sites which:
- Eliminate fire hazards, and
- В. Prevent exposure to geological hazards, and
- Prohibit development that will cause hazards to the public peace, health, welfare, and safety.'

Does anyone really believe the developers of One Carter and Stonehouse are acting in a way that complies with the purposes of HMZ? Is the spirit as well as the letter of the law being followed? And what about the environment, sustainable growth and the hazards of wildfires? Am I the only person in town who can see through the greed to the long-term negative effects? Is developing our watershed into another exclusive Southern California community for millionaires really the best and wisest use of the land? I don't think so.

The watershed developers so dearly covet has served us well in the past as our "firebreak" of last resort. We've dodged the bullet twice in the last 15 years—largely because of our watershed. Do we really want to tear down this protective shield between us and disaster? Fifteen years from now, when our children are adults, will they see our generation as wise or dangerously foolish? Will they enjoy a Sierra Madre whose unique beauty and character was safeguarded and preserved, or will revile their parents as short-sighted, selfish and self-centered in the extreme?

Recently, while walking out of my favorite discount department store, I qualified to perform any of these duties. 

As if things were not bad enough in Myanmar, as of the writing of this article, a second huge storm has set its sight on the same area as Cyclone Nargis hit on May 2. The Birds of Battle: A Memorial Day Tribute

In this modern world of technology it's hard to fathom the communication methods used in the battles of World War I and World War II. Radio communication was an unperfected technology and if a radio was damaged, the lines of communication were cut off with no other alternatives except...the carrier pigeon.

During World War I, 600 pigeons were specially trained to carry messages in the heat of battle. Many of the birds were trained for special missions. Some learned to fly to specific officers, others to fly at night (pigeons naturally only fly during daylight). Cher Ami was one of the 600. The offensive on the edge of the Argonne Forest was about as heated a battle as they came. Major Charles Whittlesey was the commander of the "Lost Battalion," the U.S. 77th infantry division. He and his men had been pinned against the side of a steep ravine for two days. The Germans were systematically picking them off. All communication was severed to other armored divisions, so Whittlesey ordered the pigeon brought to him. He scribbled a message: "We're along the road parallel 276.4. Our artillery is dropping a barrage directly on us. For heaven sakes, stop it!" He slipped it into a protective casing, clipped

it to the bird's leg, and sent the pigeon in flight. Almost immediately, Cher Ami was shot through the breastbone and leg by German fire. The bird paused for a moment on a tree branch as the Germans continued to try to fell him. But he took to the skies again through the onslaught and reached his destination. Receiving his message, the Americans halted their attack and rescued 197 men from sure death. Cher Ami was awarded the French Croix de Guerre with Palm for his heroic service. He survived the incident but died in 1919 as a result of his battle wounds. His body is on display at the National Museum of American History.

Some other Pigeon Awards of Valor: White Vision- (2nd

December 1943) Flew 60 miles against a 25 m.p.h. head wind to deliver

a message that aided the rescue of an aircrew that had ditched their plane in the Hebrides. Rescue operations were hindered by weather that made air search impossible. When her message was received, the search resumed, the aircraft sighted and the crewrescued. Scotch Lass-(March 1945) Brought 38 microphotographs across the North Sea, although injured, while serving with the RAF.GI Joe-


(August 1946) Credited with making the most outstanding flight by a U.S. Army Pigeon in World War II. Flew 20 miles in 20 minutes bearing a message that arrived in time to save at least 100 Allied soldiers from being bombed by their own Pigeons have won well-deserved tributes from many

nations. In the United States, Congress authorized the birds to receive citations for valor before the end of World War II. Previously, humans were the only life form to be awarded that honor. While there is a pigeon hall of fame, they are often overlooked in school texts, even though they played such a pivotal role in our countries independence. The pigeons are *truly* the unknown soldiers.







What Is Adrenal Fatigue?

The last couple weeks I've and shine its beam from the ear side of your eye towards

adrenals, those small orange strips of tissue scrunched to about walnut size at the top of each kidney - which provide us with the hormones that help us cope with the stresses in our lives. Catastrophic stress - being trapped in a building from an earthquake - for example, has got to head the list of personal stressors. Death after delayed rescue is a not uncommon reaction to such an overload of stress, even if the rest of the body seems "just fine."

What are some more common stressors? death of a loved one, toxins, acute or chronic infections, financial pressure, repetitive irritations, psychological and/or emotional stress, little relaxation, allergies, over-exertion, negative attitudes and beliefs, unwanted unemployment, smoking, lack of sleep, fear, coffee, caffeine, poor eating habits, sugar and white flour products, lack of exercise, marital stress, prescription and non-prescription drugs, and lack of good food - every single one of these demands adrenals coping capabilities.

Look at insurance companies' actuarial charts ... outside of true physical danger, the charts for each profession pretty much rate the risk to health in terms of adrenal stress. That's why physicians, on average, die approximately 10 years younger, have higher rates of alcoholism and several times the drug addition rates of the normal population. Just look at their lifestyles! By the time hopeful students have finished their years of medical school and hospital residency, they are incredibly overstressed. Over 67 percent of those who were married are divorced by the time their residency ends. Once in practice, they work long hours with little rest, picking up drugs or amphetamines to keep them going. Can you imagine having to give advice with potential life-ordeath consequences to someone after talking with them for only 3 to 10 minutes, hour after hour? Day after day? Year after year?

Yet, if you were to go to your doctor and say, "I think my adrenals are stressed," even if you did get a blood or saliva test, the adrenal test ranges are set so far out that the doctor could only advise you if you were at risk for Addison's disease (from too few adrenal hormones) or Cushing's disease (too many adrenal hormones). There's a lot of non-identifiable symptoms between those two extremes, which is why I'm writing. Where are you on the spectrum? And how can you find out?
How about checking your Iris / Pupil Dilation response?

Isn't it nice there's something you can "do at home?" You (with or without friend / spouse) can stand in a darkened room facing a mirror, with a flashlight. Let your eyes adjust to the dark. Notice how your pupils get really large to let in more light. Then turn on the flashlight

been writing about our bodies' reactions to stress. This week, I thought I'd focus on our most of your pupil, leaving only a small dark circle. With healthy adrenals, the iris continues to maintain that protection. If, however, your adrenals are over-stressed, in about 40 seconds the iris starts relaxing and the pupil area gets larger and larger. The iris may keep trying, but eventually a large pupil area will be "the standard". The adrenals just don't have the energy to fuel the iris' protections. tive response to the light any longer.

Do you have low blood pressure? If you don't think you do, how about trying this test? Spend 10 minutes lying down. Then quickly stand up. Do you (or did you ever) get light-headed? Feel slightly unbalanced? Dizzy? Do you "momentarily black out?" Chances are really good your adrenals are fatigued. While low blood pressure may have other causes, most medical professionals never even think to check for low adrenals as a major contributing factor.

If you don't get light headed, try again with a blood pressure cuff (available from drug store, medical supply house or internet). Lie down for about 10 minutes, put the cuff on, and measure your blood pressure. Then stand up and measure it again. Normally, it should rise 10-20mmHg (10 to 20 milligrams of mercury - scientific terms). If the pressure falls instead of rises, you either have low blood pressure or are dehydrated. And you can't just drink a glass of water and test it again ... it takes time for water to be absorbed throughout your system. If you're a meat-eater with blood pressure consistently over140/90 when you stand up ... it's past time to take stress off your poor adrenals. If you're a strict vegetarian, and you're outside the range of 95/65, chances are good you're dealing with adrenal fatigue. (Side note, as a confirmed carnivore, I was proud of the fact that my BP was often 80/50 ... given this info, I think I was living with the effects of adrenal fatigue for many years. (BTW, practically perfect blood pressure is supposed to be 113/90.)

It's your job to heal from the inside out - more clues to find those who can help you figure out what to do ...

For the 2008 La Salle High School Varsity Golf Team---in the words of Frank Sinatra---it was a very good year.




