Los Angeles County To Offer Decline In Value Tax Assessments From The Office Of Rick Auerback, Tax Assessor

It has been widely reported that the property values review. of single-family homes and condominiums throughout most of the State have been declining. While the declines in Los Angeles County have not been as dramatic as those in other parts of the State, property values have dropped in some areas of Los Angeles County.

How does this impact your property taxes? In 1978, California voters passed Proposition 8, a constitutional amendment that allows a temporary reduction in assessed value when a property suffers a "decline-in-value." A decline-in-value occurs when the current market value of your property is less than the assessed value as

2004 and June 30, 2007. We will look at sales of comparable properties that sold near the lien date, January 1, 2008. If the market value is less than the assessed value indicated on your 2007-08 tax bill, the assessed value will be reduced accordingly. An application will not be

We will complete this review by June 30, 2008 and will notify in writing those property owners who qualify for a reduction in the assessed value of their property. Applications will be accepted prior to June 30, 2008, but if you purchased your home between July 1, 2004 and June 30, 2007, we urge you to wait for notification from our office before filing. Should it be necessary, you will have until December 31, 2008 to file an application for

If the sale date of your property is not within the dates noted or is other than a single family home or condominium, it will not be included in the review. However, if you believe the assessed value of the property shown on the 2007-08 tax bill is more than the fair market value as of January 1, 2008, you may file an application at any time through December 31, 2008.



We will review the application and if a reduction is warranted, the taxable value will be reduced.

Tipster Sets Off False Alarm Over Hillside Property

Concern about "failure" of embankment on Carter Unwarranted

Hamilton on Special By Hail **Assignment**

Some residents returning home from work on Monday may have been confronted by yellow and black public works barricades at the island intersection of Carter and Lima. The barricades were placed in front and below the hillside home at 351 Carter.

Before sunset, rumors had spread throughout the neighborhood about the eminent "failure" of the embankment and the landslide that would follow. These rumors, perhaps born out of an overall fear of possible hillside mudslides, were untrue.

The owners of the property, Sam and Jane Rowland, said that the whole affair has been blown out of proportion. The Rowlands had the terrace, visible from the street, was constructed as a preventative measure as a result of the heavy rains earlier in the year. She said on January 5 they experienced a "minor shift in the hillside as a result of heavy rain." It was then that they had the terracing in question built. 
Fire Safe Council Meeting Addresses Issues By Bill Coburn

In front of a much smaller crowd than May's post-fire meeting (though still with a much larger turnout than any pre-fire meeting), the Fire Safe Council's featured speaker, Director of Public Works Bruce Inman, presented a slide show and some sobering figures about the anticipated debris flow from the recently burned hillsides, and the City's ability to prepare for and deal

Inman gave a fairly comprehensive presentation discussing each of the burn areas, their size, the percentage of the area that burned, the amount of debris that is anticipated from each area, the capacity of the debris basins into which they will flow, and in some cases, the lack of a basin or under-capacity of the basins into which the debris will slide in the event of a storm.

Estimates for debris were based on a ten-year storm, which is defined as a storm that the City is (cont. on pg. 4)



Planning Commission | A Sun-Powered Home In Sierra Madre story By Christopher Nyerges Passes First Hillside | Nyerges is the editor of Wilderness Way magazine, the author of "How to Survive magazine, the a Development Permit

At the June 5th meeting of the Sierra Madre Planning Commission, a recommendation was sent to the council for approval of the first Hillside Development Permit since the Hillside Management Zone Ordinance went into effect. The Permit was granted to allow a 1,182 square foot, twostory addition and conversion of a 161 square foot portion of a second story deck into a covered porch. The request was for the property at 891 E. Grand View Blvd. The property is currently 3,204 square feet. There was no opposition to the improvements and it was passed unanimously after a brief discussion among the commissioners.

There was also a request for a Conditional Use Permit for a downtown business that intend to relocate from 280 W Sierra Madre Blvd to 80 W. Sierra Madre Blvd. The CUP was necessary because the new location was previously an office and will require reconfiguration. Again, there was no objection and the recommendation for the issuance of the CUP was passed unanimously.

Danny Castro, Development Director for Sierra Madre, reported to the commission that the City Council had requested that they review a 'range of options' regarding the preservation of viewscapes when homeowners make improvements to their property. It was intially stated that the council wanted a report back at their July meeting. However, because the scope of the request was not clear, it was agreed the the commission would begin discussions at the next meeting, but wait until the joint council/commission meeting for further instructions.

Before the meeting adjourned, Jay Hill, a resident of Sierra Madre and former planner with the City of Sierra Madre, congratulated the commission for the work they have done in recent years. He thanked them for the respect shown him by members of the commission.

Hill also made comments directed towards the citizens of Sierra Madre and the current council. He reminded residents that at one time Sierra Madre had "..5 markets, 7 gas stations 12 hotels and a car dealership to support the town". He admonished residents to "start accepting that change is happening" and "things can't stay the same". He then went on to commend the Planning Commission for having a lot of foresight regarding the future of the city, and that "another body doesn't have the same opinion".

The next Planning Commission meeting will be on June 19th at 7:00 pm at City Hall. At that meeting, a new chair and vice chair will be selected. Bob Spear is the current Chair.

Tucked away near the foothills is the home of Renee Cossutta and Debbie Ross. While walking by one day, I noticed the array of solar panels on the carport outback. I boldly went up to the door, knocked, and began to ask questions.

Čossutta told me that she had been interested in conservation—and in localized production—for years, and had always made the effort to not overuse resources. She's also long wanted her own solar electrical system for over a decade. She had read about the adverse effects from our way of generating electricity, and wanted to be a part of the solution.

Some years ago, she contacted the folks at Real Goods in Hopland, California and asked what it would take to install a solar

system. After analyzing the situation, the company determined that it would not be cost-effective to install panels on the roof because there was not enough sunlight there to generate the amount of electricity that would make this costeffective.

Then, about 2 1/2 years ago, they realized that an area that had been used for parking received more sun. They once again consulted with the folks at Real Goods, and concluded they could create a solar electrical system that would work. An architect friend of theirs, Phillip Collins, designed a combination carport and grape arbor that would also support the solar modules. Tom Robinson from the Southern California branch of Real Goods came out, and once the structure was built, the folks from Real Goods installed the solar system.

"This was my first opportunity to do something like this," said Cossutta. "It took two days for Real Goods to install our system, and we were very impressed with them."

The system chosen for this household was grid-connected, meaning there were no batteries. There are 14 modules, manufactured by Sharp, each rated at 160 Watts. The inverter, measuring about 18" by 3 feet, is manufactured by Xantrex, connected to the net meter, sometimes also called a "time of use" meter.

During the day, this system feeds electricity into the grid when she and her partner are away at work. Their monthly electric bills shows how much power their system generates, and how much electricity they use.

Because the Edison Company places a higher value on the peakhour electricity from 10 a.m. to 5 p.m., they actually get paid more for each peak hour of their generated electricity than what they pay for their off-peak electrical usage.

'The size of our system was designed by Real Goods so it would provide us with as much electricity as we needed," explained

Cossutta.

The entire system, including installation, cost about \$12,000, and has not yet paid for itself. The system will pay for itself when it is about 10 years old, depending on cost of electricity. It may pay for itself even sooner if the price of electricity continues to rise.

They also received tax credits, and rebates from the Edison

Did having a solar electrical system change the way they did things? "Well, we produce our own electricity, and you'd think that we'd no longer worry or think about it. But it has been just the opposite of what I expected. We actually are more careful with our electrical usage now. It's like if you grow your own strawberries in the yard. Yes, you have food, and that's good, but you have to watch them to make sure they grow."

Cossutta says that there is just about no maintenance for this system, except that occasionally during the dry season, she gets up on the garage and hoses off accumulated dust. But otherwise, there is nothing that needs doing.

What advice would she offer to those wanting to get into the

"Every now and then, someone will come up to the house and ask about our solar panels," says Cossutta. "I tell them to look on-line and read about solar electricity. Find out what it means to have solar power. Learn how it pays for itself. Do plenty of research first so you know what you're getting into. Ten years ago, it wasn't so easy to find this information, but today there is a lot of information out there. Go and talk to anyone you know who has done this. And look at the Real Goods catalog, and check

Bailey Canyon hikers are likely familiar with the mirrored edifice of the glass and steel Pyramid House. It shines as it rises between foliage and canyon ridges, as one treks up and up on the trails. The property, located at 751 Oak Crest Drive, clearly boasts one of the best panoramic view lots in the entire region. If your wish is to seclude yourself high atop a knoll adjacent to the San Gabriel Mountains, this may be the property for you. It is tucked away, yet remains just a few moments' drive through this tight knit neighborhood, down to the amenities of quaint Sierra Madre.

Built in 1975, rumors abound as to the orientation and scale mimicking one of the Egyptian pyramids, though most of the solid facts have slipped away. Some are little mysteries, and others are simply quirks, like the full size Egyptian woman painted in the commode room of the subterranean master bath, complete with a walk or jump-in tub.

Mike Paris, the listing agent, hails from this small town and from Coldwell Banker's nearby Arcadia office. Thanks in part to the fortuitous, prominent placement of his LA Times ad, nearly eighty people wended their way up the switchback driveway to

Architectural buffs arrived pointing to guides listing this as one of the architectural "wonders" of the Southland. Other interested parties arrived from significant distances for a serious look.

The previous owner passed away, bequeathing ownership to a local charity, which has now offered the 1.02 acre parcel for sale at \$1,790,000. 3327 square foot, glass pyramid, the original four car carport converted to a guest house and one car garage is included.

The structures are definitely noteworthy to amazing, though the home needs considerable maintenance. The lower level sports cement block walls two feet thick, so the 100+ degrees outside dropped in the neighborhood of twenty degrees in the lower level's master suite.

Piecing together some of the Pyramid's design puzzles, Paris surmises that the original design utilized a water cooling system running down the outside of the pyramid from the thirty-two foot apex, into a trough/gutter near grade level, goes into a pump, then re-circulates back to the top. Some neighbors heard that the original owner wasn't able to complete this water cooling system. The outside was originally fully mirrored to reflect much of the heat back outside, though some of that reflectivity has dulled over thirty three years.

A lower level fireplace area seems large enough to spit grill a pig, and was once surrounded by indoor trees and foliage, and flanked by built-in seating. It leads to an amazing gateway to the outside. A round door rolls aside to open the man-sized porthole to a koi pond (sans fish these days) with stepping stones, bringing the enjoyment of the water, the fish and the views inside.

On the main level, mesmerizing views make the walls disappear, urging me to sit quietly, lest I disturb the awe I feel. A utilitarian kitchen forms a galley-style core to the pyramid, gathering light from a round pass through.

An antique iron staircase, said to be from Europe, leads to the upper level, somewhat visually arresting in its verdigris color and ornate styling, as it rises adjacent to the steel framework and walls of glass.

It's a home for someone who longs to live differently, uniquely, and above it all. A home for someone to restore and enhance. Alternatively, Paris has listed the property as 1.02 acres of land. He adds that the adjacent half-acre, owned by another party, has been subdivided and is also listed for sale on the MLS by the owner. If combined, the two lots could create an even more private homesite.



Looking Up With Bob Eklund An Echo from a Starry Night in 1572

While walking home on November 11, 1572, astronomer Tycho Brahe idly glanced at the sky. He was surprised to see a bright star in the constellation Cassiopeia that hadn't been there before. The new star, which we now know to be the result of a stellar explosion or supernova, grew brighter than Venus and was visible in daylight for about two weeks. It then slowly faded until vanishing in March 1574, 16 months after its discovery.

What type of star exploded? Previously, the only way for modern astronomers to answer that question was to sift through the ashes that were scattered into space as a supernova remnant. But now, they have spotted light echoing from the original explosion of the Tycho supernova.
"By studying these echoes," explains Armin


Rest of Harvard University, lead author of a paper being published in The Astrophysical Journal Letters, "astronomers can directly observe light from a supernova that exploded hundreds of

They are, in fact, seeing the same light that was observed by Tycho more than 400 years ago. "It's like finding a color photo of Napoleon. We suddenly get a chance to take a snapshot of an event very influential in the history of astronomy," Rest points out.

The kind of echo most people are familiar with occurs when sound is reflected off a hard surface and back to the listener. In a light echo, a bright pulse of light expanding outward through space reflects from intervening cosmic dust and into our line of sight. The extra travel time for the light to reach the dust, bounce off, and travel to us causes the light echo to arrive hundreds of years after the light that traveled directly to us (the light seen by Tycho).

As a result, this light echo offers astronomers a unique opportunity to study both the supernova itself and its aftermath (the expanding shell of debris from the explosion).

"We can see the 'before' and the 'after' simultaneously by studying the light echo and supernova remnant, respectively," says Rest. "Normally in astronomy, the time scale for events is so long that you can't watch a single object evolve. You can see a light pulse from a distant supernova, or you can study a nearby supernova remnant, but you can't study both the supernova explosion and the remnant for the same event. With light echoes, though, you can do both for



the same event."

"I think it is cool that I can look in the sky and still see the same light that Tycho did, at the time of his truly revolutionary discovery," adds Texas A&M University astronomer Nicholas Suntzeff, who collaborated with Rest on this international project. "Beyond that, I love the connection of astronomy to history, both in the arcane nomenclature we use in our science and the effect of astronomy on the course of human thought. Tycho was the astronomer who proved Aristotle wrong. Aristotle believed—and it was taught in all Catholic and Protestant schools for 1,500 years—that the Earth was at the center of the Universe, and that all things variable were between the Earth and Moon. This supernova proved that theory wrong, and quickly led to a reedom of thought in science—the idea that we can question any theory with observations which is central to the way science operates

THINKING ABOUT ECHOES reminds me of Albert Einstein's boyhood fantasy about what t would be like to ride on a beam of light. If you could look back with a powerful enough telescope to where you came from, what would you see? A scene frozen in time, never changing from the way it was when you left? Would that be, in fact, a way of stopping time?
Even though it took 436 more years to get

here, the reflected light of Tycho's supernova should still have all the properties of the direct light seen in 1572—and could, for example, be analyzed with a spectrograph now as easily as it could have been in Tycho's day, except that the spectrograph did not then exist. Wasn't it Alice in Wonderland who remarked that things are getting "curiouser and curiouser.

were provided as to the debris should the City experience a twenty-five year, fifty years, or longer

Inman has been working closely with the Los Angeles County Dept. of Public Works (LACDPW), the California Conservation Corps, the US Forest Service and the Angeles National Forest Service, and the Natural Resources Conservation service, and other agencies to assess the damage and prepare for the future. According to Inman, the County Preliminary map defines 16 areas that are likely to discharge mud and debris into Sierra Madre. Five of the areas drain into debris basins, with one of those five debris basins considered to very likely be inadequate for the anticipated debris flow. Eleven of the areas drain into public and private property.

Inman pointed out that his department consists of a staff of twelve, and that during emergencies, the staff goes into twelve hour shifts, meaning that at any given time, there are a total of six public works employees to deal with emergencies. Unspoken by Inman was the fact that he is currently not fully staffed, having only nine employees, meaning if an emergency were to occur right now, there would be five staffers or four, depending on what time of the day it is. Alex Jarvie, of LACDPW's flood control maintenance division, noted that he has double Sierra Madre's staff, or twenty-four employees, to deal with the entire county.

According to Inman, the County's map defines Area 3a, on private property at the top of Auburn Ave., as being 6 acres, with 83% burned, and an estimated 2,100 cubic yards of potential debris. To provide some perspective, Inman noted that each of the large 3-axles dump trucks seen hauling mud during the last emergency holds 10 cubic yards of debris.

Drainage area 3b, at One Carter, is 5 acres, and 100% burned, with a potential debris flow of 1,900 cubic yards.

Drainage area 3c, also at One Carter, is also 100% burned, with its 12 acre area potentially causing 12,000 cubic yards of debris flow. Drainage area 3d, also at One Carter, is 4 acres, 100% burned and a potential for 1,200 yards of debris flow. Between temporary debris basins created as part of the development of the property and the existing County maintained Carter Debris Basin, recently expanded to bring it into line with current County drainage criteria, and "We don't expect to see any problem with the majority of the mud flow off of that site."

Drainage area 4, up near Lotus Lane and Camillo, has 12 acres of 75% burned land. The potential debris flow is 4,500 cubic yards, however, the County's Sturtevant Debris Basin into which the debris is to flow has a capacity of only 1,500 cubic

Drainage area 4a, above Stonehouse Canyon, is

likely to see on average every ten years. No figures 67 acres, 67% burned. The potential for debris flow is 21,000 cubic yards. "There is no downstream protection on that property," said Inman. Drainage area 4b, Yucca Canyon, is 18 acres, 100% burned. Potential debris flow is 6,800 cubic yards. This is the area that produced the mud flow down into Woodland Lane during the last storm. Area 4d, an area that is high in the hills which drains into the area at Upper Brookside/Woodland, is 16 acres, 100% burned, with the potential for 6,000 cubic yards of debris. Drainage area 4e, above Skyland, is 19 acres, 89% burned, with a potential for 6,800 cubic yards of debris.

> Inman gave a total figure of 156,300 cubic yards potential for Drainage Area 1, and said that the Sierra Madre Dam into which Area 1 flows should handle all of that, though County workers will have to be clearing the area regularly. Drainage Area 2, Lannan Canyon, with 25,700 cubic yards potential, and Drainage Area 3 behind the Auburn Debris Basin has 26,700 cubic yard potential

> In total, Inman warned that there is a total potential, based on a ten-year storm only, of 292,550 cubic yards of debris deposits. The total debris expected to be captured by existing debris basins is 237,900 cubic yards. This leaves a total of 57,000+ cubic yards of uncontrolled outlet debris from a number of locations where there are no debris basins.


> According to Inman, much of the City and County's efforts will be geared toward trying to keep the mud and debris that will be flowing, on the streets, and off people's property.

> Inman warned that the City should anticipate a lot of truck traffic as the debris basins fill, as County trucks will have to move the debris from the basins to County yards, when it is safe for their employees to do so. Residents of the canyon in particular, as well as residents of other areas, should have a plan to get their vehicles down hill where they will not be trapped in the mud and accessible for them to evacuate, but off the streets so that emergency crews and trucks will be able to get up into the area to do their work.

Inman stated that he has already applied for three grants to help mitigate the debris flow, and/or to deal with the flow once it starts. Two of those grants were rejected, the third made it past the first of two parts, with the second part being far more extensive and demanding.

Chris Stone of LACDPW gave an overview of the County's situation, which was not specific to Sierra Madre, though it did touch on certain areas that Sierra Madre will encounter. Also speaking at the meeting were Lisa Northrop and Mike McIntyre of the Forestry Service and Caroline Brown and Mike Kinney of the Fire Safe Council.

Waterwise Plants By Pat Birdsall

Turf lawn requires approximately 60" of water a year. That's five feet! Save water by converting part of your lawn to California-friendly plants. The keys to successful firewise landscaping are plant selection, plant placement, and maintenance. First, consider using plants that are high in water content and low in available fuel. A "fuel ladder" is described as overlapping vegetation connecting ground level plants with shrub and tree canopies. A new AT&T internet/ television project, anticipated for the city, got shot down Monday night evenbeforerepresentatives from the company had a chance to respond to allegations from the council that above ground power cabinets would not be tolerated by residents.

Councilmember Victor Gordo asked why they could not underground the utilities and then refused to accept AT&T's answer that, "it's too expensive."

"In my opinion," Gordo said."Insteadofdeveloping the technology a little further, instead some of the communications companies, including AT&T, Charter and others have taken dollars, and instead of developing better technology, went and lobbied the state to take away our local authority."

Two AT&T spokespeople went on the defense saying that if the boxes were put in the right places they would disappear through landscaping and other means. They also said most were not satisfied with the cable services now.

They also said over the last five years, consumers were more satisfied with the IRS than their local cable company implying

that customers win when cable and copper wiring there is competition.

"To some people the only right place is underground where we don't have to look at it," Gordo said. "Where it isn't a problem for sightlines as people are walking down the street or driving down the street."

Gordo then bluntly told them, if this had not been an information only item, it would have no support. He said they should come back to them with a better plan for the infrastructure.

Before any discussion, both Mayor Bill Bogaard and Councilmember Sid Tyler reclused themselves saying they had stock holding in AT&T.

AT&T has not yet taken out any permits for the project although a spokesperson for the company said they would notify residents by mail when they did.

"We would also notify them 48 hours before any construction began," he

According to AT&T, the project, U-Verse (Light Speed) would consist of laying more fiber optic providers had been taken into account. In the past a cable provider had left unsightly green boxes in parts of the city after a failed plan to do a similar installation as AT&T.

The cable company Altrio went bankrupt in 2003 leaving aboveground concrete and steel vaults that would have provided power back-up, prompting outcries from residents who still see them as eyesores.

Martin Pastucha, of Public Director Works, said the city was limited to what it could do. He said a statewide franchise was developed the Digital through Video and Infrastructure Competition act of 2006. The law, he explained, establishes a statewide franchising procedure for video service providers to be administered by the California Public Utilities Commission.

"They are allowed to, install, construct, and maintain a network within the public righta-way within the same 'time, place and manor,' as the previous governing telephone corporations under state and federal law," He said.

Pastucha added that the city could only look at where the cabinets would be placed to insure they are not interfering with other cabinets or become a visual obstruction, safety hazard, and do not conflict with trees or fire hydrants AT&T would go through the city's "right-a-way"

permit process, he said.

Pasadena Employee Convicted Of Credit Card Fraud

A former City of Pasadena employee pled no contest May 30 to one count of credit card fraud among several charges including petty theft, identity theft and attempted grand theft.

Rhonesia Bass, 38, of Duarte was sentenced to three years of probation, 30 days of community service, restitution and credit for 18 days served in L.A. County Jail.

As a customer service representative Pasadena Water and Power, Bass obtained credit card numbers from six identified customers as she took their utility bill payment information over the telephone. She then used the credit card numbers to purchase personal items via the Internet from a major retailer. She also used one of the credit card numbers to pay a friend's water and power bill.

She was identified by an astute employee of the retailer in January who noticed some abnormalities in relation to the purchases made. The retail employee canceled the transaction and referred the victim to the Pasadena Police Department.

Bass was put on leave administrative immediately while investigation was

conducted Technology Crimes Unit of the Pasadena Police Department. She was arrested by Pasadena police on May 8.

According to Phyllis Currie, general manager of Pasadena Water and Power, the incident does not affect credit card transactions made directly through the automated systems, direct debit or the PWP website.

"Safeguards have been added to credit card transactions handled directly by customer service representatives with customers telephone," said Currié. "We take these issues very seriously. The protection of personal information of our 98,000 customers is our highest priority."

Pasadena Water and Power is reviewing the accounts of 27 other customers and contacting them directly to help determine if they are potential victims of fraud.

Any PWP customer who paid Pasadena utility bills directly through a customer service representative over the phone between September 2007 and December 2007 should review credit card statements thoroughly. If fraudulent charges are discovered, report them to the credit card company immediately and place a fraud hold on the account. Then report the matter to Pasadena Police Department by calling (626) 744-4501.

Community Partakes in Civic **Planning**

Many Pasadena residents took part in a public forum held at the Pasadena Presbyterian Church last Saturday as part of an ongoing dialogue regarding common visions and goals for the city. The discussion was initiated by local non-profit organizations, including "Open Space Now".

There was a previous forum held in April, allowing the community to voice concerns and give accolades to the current and future status of the city. Issues brought up at the prior meeting highlighted the fact that the city has a history of public participation and Pasadena is continually working at improvement of its neighborhoods, with individuals working for a better society.

According to documents provided at the most recent meeting, there were also some harsh accusations made against the city of Pasadena at the April gathering. Most notably, it was accused that "many staff members have left—and those that remain were not present to develop the approved city plans and regulations... they have little understanding of the community that created

these plans and hostility to learn about community desires and needs." It was also asserted that "city staff had a real lack of respect and a patronizing attitude toward community members and their views." The documents went on to state, "few at the meeting felt much trust in staff; some had examples of staff actually lying."

With the departure of Interim City Manager Melekian, Bernard community members seemed intent to fill the vacant position with the city's best interests in mind. The keynote speaker at the forum was Steven Preston, the Deputy City Manager of San Gabriel. Preston gave a presentation of "General Plan Best Practices". An introduction was given by Marsha Rood, a former city planner that paved the path to the renovation of Old Pasadena.

"A 'General Plan' is a people's plan just as an Attorney General means the people's attorney," said Rood. "This is a citizen effort [in bringing the

community together]." Prestondefineda"General Plan" as a Constitution for local development with a fundamental underpinning for land use planning in California. The best principles that guide city managers are that you have an obligation to ethics and an obligation to advocate. Just as your windows are the eyes of vour house, the general plan is a window into the soul of your community, he said.

Last year American Golf Corporation spent over \$850,000 million for irrigation, an amount they said this year could rise to over \$1 million.

"I know there are a lot of initiatives being talked about with water," Dunn said. "I know on some courses across the county, having water available for golf courses is a question. There may be a limit to how much water is available."

Last week Governor Arnold Schwarzenegger issued an Executive Order on drought conditions. Among other things the order will, help local water districts and agencies improve water efficiency and conservation, work with local water districts and agencies to improve local coordination and Coordinate with other state and federal agencies and departments to assist water suppliers. Dunn said water on golf courses in a problem up and down the state.

The course has already cut

back water voluntarily 10 percent but they said could be forced to go as high as cutting 30 percent.

Representatives from the golf course said they were about halfway through the \$8 million renovation Master Plan approved in 2002. The plan was estimated to take 10 years. The city has spent \$3.5 million to date on upgrades they said.

So far they have renovated the fairway bunkers, the tee boxes, the driving range and irrigation. Next was to re turf the fairways but because of current water issues they said was put on hold. The golf course management is now set to work with the city's

Department of Water and Power. Brookside has two PGA Tour courses totaling 36 holes staff said.

Dunn said, as a side note, that other amenities such as the golf pro shop and coffee house/restaurant have declined revenue also due to a drop in golfers. He said the internet was to blame. The contract with owner John Wells ends in 2011 and Dunn said they were in contact with him to see if he still planed to operate it. "It is the best fit," Dunn said. Five percent of Wells proceeds go to the city.

Dunn also said they were looking at everything including the Rose Bowl located next to it. An

updated revised Master Plan, with options, could go in front of the council in late summer. Using reclaimed water is one of those options they said.

The fee hike will increase non-resident weekend fees, for 18 holes, from \$50 to \$55. Resident fees would go from \$38 to \$40. Cart rental will also go up as well as twilight and super twilight rates. After a review American Golf has the option to increase non-resident rates to \$60.

According to the city's staff report, it is anticipated that the weekend fee increase, along with a cart fee increase, would result in an additional \$250,000 annually.





year, this group held a press conference and released a list of the names of 31,072 scientists who signed their petition. And what did the petition state?

We urge the United States government to reject the global warming agreement that was written in Kyoto, Japan in December 1997, and any other similar proposals. The proposed limits on greenhouse gases would harm the environment, hinder the advance of science and technology, and damage the health and welfare of mankind.

30 YEARS OF PROP 13



June 6, 2008 marks the 30th anniversary of California's Proposition 13, sometimes referred to as the "Jarvis's initiative" or the "People's Initiative to Limit Property Taxation." Prop. 13 amended the state's constitution so that real property tax rates could not exceed 1 percent of the property's market value and valuations couldn't grow by more than 2% per annum unless the property was sold. It also established an acquisition-value assessment system that provided that property is to be assessed at its value when acquired through a change of ownership.

Now I know there are many that claim that Prop.13 was the ruin of California and site it as the cause of everything from failed schools to the OJ Simpson Trial. Regardless of all of those arguments, I am a supporter of an acquisition-value assessment system and a Prop.13 fan. Besides, when it comes to tax revolts, I'm always onboard anyways.

More recently, I have been observing the negative effects of a property taxation system that does not utilize an acquisition-value assessment. Over the last few years, I've kept a curious eye on the Hawaiian real estate market. Hawaii does not recognize an acquisitionvalue assessment system and reassesses property every year. So, as property appreciates in value, the annual property tax will increase proportionately. Hawaiian realty has appreciated much along the same lines as property in Sierra Madre. What sold for \$350,000 in 2002 now sells for \$750,000. While it's been a great way to generate tax revenues, I've sadly watched it become a financial death blow to many retired Hawaiian families. An all too familiar story is the one of the retired couple who bought their home in the sixties, worked hard all of their lives to support their families, and are now on fixed incomes. The home they bought for \$12,000 in the sixties is now appraised at \$700,000. Annual property taxes can now account for the majority of their income. Many retired couples are being forced to sell their homes, the very homes where they raised their children and grandchildren. What a tragedy.

I shutter to think what that type of property tax system would do to the senior population in Sierra Madre. About 23% of Sierra Madre's population are seniors. Many are long time residents who raised their families here. These are the people that made this town what it is. Thank goodness the voters in 1978 passed Prop. 13. When it comes to property taxes, 13 is a lucky number. Happy 30th Anniversary.

Evidently we are looking at an approximately 15 billion dollar (plus or minus a billion or two).


To the Governor: What do you think that we could do to the Lottery that could double its net income (whether





* 4 skinless salmon fillets (6 oz.

Coarse salt and ground pepper * 1 Tbs. olive oil

* 2 bags (5oz. each) baby spinach ¹/₂ cup feta, crumbled (2 oz.)

* 1/3 cup pine nuts * 2 tsp. fresh lemon juice

1- Heat broiler, with rack set 4 inches from heat. Place salmon on a rimmed baking sheet; season with salt and pepper. Broil until opaque throughout, 5-7 minutes.

2- Meanwhile, in a large skillet, heat oil over medium. Add as much spinach as will fit; season with salt and pepper. Cook, tossing spinach and adding more to skillet as space becomes available, until tender, about 2 minutes. Remove from heat; drain off excess liquid. Stir in feta, pine nuts, and lemon juice. Serve salmon with spinach sauté. Serves 4

HEY, LADIES--WHÁT'S GOING

I say again: What's going on here??? First, Annika Sorenstam---arguably the greatest woman golfer of all time---abruptly retires from golf while still in her prime - a few days after she wins a tournament with #1-ranked Lorena Ochoa in the field - on the verge of eclipsing every important record in the book at the comparatively young age of 37. It was a shocker.

But then, just one day later, tennis star Justine Henin taught Sorenstam and the rest of the sports world what the word "abruptly" really means.

Henin, while still ranked Number One, retired from tennis, effective IMMEDIATELY! As in right away! At least Sorenstam is going to play till the end of the year. And consider this: the French Open came right on the heels of Henin's bombshell and is in fact just now wrapping up, meaning this prestigious clay-court tournament was not only without its defending women's champion, but also the player who had won the event each of the last three years. No, I'm not kidding. Henin was the 3-time defending champion in Paris, and had won the event four times overall.

Couldn't she have waited a couple measly weeks to see if she could win her fourth straight French title? Does burnout really sneak up on someone that fast? Scary.

Once the liquor wears off and we have time to think, we'll probably all agree it's easier to understand Sorenstam's decision. She's more accomplished in her sport than Henin is in hers. Her legacy is more secure. She's won the 4th most majors of all time, ten in all. She is the only woman to ever complete a round of golf in only 59 strokes. She has been ranked #1 at the end of seven different seasons. She is widely regarded as the best female golfer ever. She is 37 years old. She's getting married again. Her biological clock is ticking. I get it.

But Justine? She's only 25! Recently divorced, her biological clock is on holiday. And while Sorenstam---due to injuries, age, and general ennuihas recently relinquished her perennial #1 status to Ochoa---Henin, it must be repeated, WAS STILL THE NUMBER ONE RANKED TENNIS PLAYER IN THE WORLD. At least until a few weeks ago, when she all-of-a-sudden got bored, burnt, and bummed. And then quit. Talk about retiring on top. Male athletes generally do just the opposite, hanging on until they become figures of fun. Or just plain sad.

Some men do get it, though. Jim Brown retired from football in 1965 at the very top of his game. He was not only the best football player in the world on the day he hung up his cleats, but arguably the greatest football player of all time. Most guys from my generation would agree. Sandy Koufax retired from baseball in 1966, also at the top of his game, after a year in which he won 27 games and the Cy Young Award. At least Sandy had the injury excuse. His left elbow was shot. He even admitted he had been gulping gobs of drugs just to be able to manage the pain. Marvin Hagler retired from the ring while he was still nigh on invincible (did Sugar Ray Leonard really win Hagler's last fight? I'm still not sure.). And while Mr. Borg had surrendered his #1 spot to Mr. McEnroe by the time he quit tennis in 1981, at 26 years young he still had many more Majors left in him.

That said, for women's sports to lose two of its very best athletes while still in their primes, within 24 hours, is shocking. But does that automatically make it the wrong decision?

Let's see...Now that I think about it, the great Graf (as in Steffi) quit quite recently, still dominant, to go off and marry Andre Agassi and produce offspring. When she bailed she was only two major championships away from Margaret Court's record of 24 slams. Wrong decision? Well maybe, but as an athlete all we remember her for is winning and greatness, not losing and deterioration, and now she also gets credit for being one of the celebrity world's most loyal and devoted wives and mothers, one of the quintessentially well-rounded women of our time. Take the world of movies. Garbo retired at 36, and is all the more iconic and otherworldly for it. My personal all-time favorite actress, Jeanne Crain (who is she?, I can hear you thinking), retired in her 40s and went off and raised her seven children, leaving her 1950s fans (and a generation later, me) wanting more. Fans of both these actresses remember them as eternally beautiful and beguiling, not all beat-up looking and trampled over like the eternal hangers-on; Bette Davis, Faye Dunaway, Tuesday Weld, et al. So maybe there is something to be said for exiting the world stage before the final act.

Maybe women just do it better, this retirement business. Get out while your star shines brightest, leave the world remembering greatness, not greatness worn away.




