100th Trail Race Anniversary

Rises Out Of The Ashes
Last Saturday, June 7, the much anticipated Mount Wilson Trail Race
finally took place. This event, originally scheduled for Saturday, May 24th of Memorial Day Weekend, was postponed due to mudslides resulting from loose dirt after April's Santa Anita Fire. The race, sponsored by New Balance / Run With Us Pasadena, was the 100th anniversary of the first race in 1908 and started with a bang by Honorary Race Starter, John Robinson.

Event highlights included first place racer J.J. Timphony of Arcadia, CA finishing the race with a time of 1:01:53. The first overall woman was Pasadena resident Mireya Vargas, coming down the mountain in 1:21:53. Vargas completed the race 20th overall. The first overall finishers received goodie packets along with trophies donated by Judy Webb-Martin and Pam & Verland Kelly. Additionally, the youngest runner Max Heefner, 11-years old from Sierra Madre, CA finished 106th with a time of 1:45:33 and wasn't even tired. Medals and prizes donated by local merchants were given to the top three finishers in each of the eight categories and the top five Sierra Madreans male and female. New this year, were couples and family awards. The winning couple was Jim and Jill Liston and the winning family was Larry and

Other well known Sierra Madreans challenging the mountain included, Trail Race Chair Pete Siberell and his wife Marianne, City Council Member John Buchannan, along with Community Services Commission Chairperson Jim Liston and his wife, Jill, who had previously come in first overall for the women in years past. Planning Commissioner and Former Fire Chief Bob Spears, Carol Canterbury, former MWTR committee member and local volunteer, Dr. White, trail history enthusiast, Bill Coburn of sierramadrenews. net and Sierra Madre Chamber Boardmember, also ran along with Tim Osti, local tree volunteer.

The Mount Wilson Trail Race once again included a Kids Art Show depicting the Trail Race and the History of Mount Wilson. A special thanks to Community Arts Commissioner, Barbara Wamboldt, for all her assistance and volunteer James Faulkner. The show hung during the pre-event Pasta Feed the night before the race and throughout the Saturday morning event as well.

And always popular, the $3^{\rm rd}$ annual Kids Fun Run took place as a part of the Community Services Commission's Healthy Family Fun activities. Over 100 youngsters between the ages of 3 to 13 raced up Baldwin and back - finishing under the same finish line as the Trail

Sierra Madre Fire Department Academy: Class Number One Graduates

Lined up and ready to go, the Sierra Madre Fire Department Academy Class Number One were all sworn in last Saturday as family members, training personal and city staff honored the hard work the class went through.

"Today is a very special day in the history of the Sierra Madre Fire Department," said Greg Christmas, the Captain Academy Administrator. "Today you will witness the graduation of 16 trainees of the very first Sierra Madre Fire Academy, trained by the Sierra Madre Fire Department."

Christmas went on to say that they were also trained by specialized personal from around L.A. County in various areas of

Each of the trainees dedicated 18 weekends and over 300 hours, some of which included helping with the recent Santa Anita Wildfire that burned 584 acres, threatened nearby homes and took

Two Blair High School students were also honored as part of another program started in conjunction with the academy. This year the fire department started the Jr. Firefighting Emergency Medical Service Career Education Program, according to Christmas.

The Jr. program was taught by two of the city's new paramedics.

"These two students, over went, over 200 hours of instruction with various members of the Sierra Madre Fire department," one of the trainers said.

A number of people were honored for the creation of and recruitment for the academy, including Fire Marshal Rich Snyder and volunteer Miguel Hernandez, who Christmas called, "The backbone of the academy.

Two council members, Joe Mosca and John Buchanan, were also in the audience. The city council approved the creation of the academy last year along with the city's new paramedics program.


City Manager Elaine Aguilar thanked the entire volunteer fire department, saying they protect the city 24 hours a day seven days a week. She also talked about the trainees' involvement with the Santa Anita Fire.

"Talk about on-the-job training some of our recruits have had in the past 30 days," she said. "We've had fires, we've had mudflows, and with our volunteer fire department, and our firefighters in training, the city of Sierra Madre was saved in what could have been a disastrous situation for us."

Fire Chief Steve Heydorff likened the academy to the MTV world of extreme sports and extreme home makeovers, saying, "This was extreme volunteerism."



The Church of the Ascension will kick off the 4th of July festivities by holding Mass on the Grass on June 29th at 10:15 am.





THATFORECASTissotypical of June in Southern California that the weather service could almost photocopy it and use

it every day. Today, June 10, was typical: a cool, almost chilly, grey morning; sunshine from noon to about 5:00 P.M.; and a return of the low clouds in the evening. I miss being able to see satellites, moon, planets, and stars. But there remain a few things to delight the eyelike the jacaranda petals that fell like a purple rain-shower on a recent evening, when a breeze stirred the trees in our yard.

> So many petals Falling, that they fill the air: Jacaranda rain.

It was on just such a day of low clouds and fog, in the last week of June 1903, that George Ellery Hale first came up the Sierra Madre trail on horseback to see what Mt. Wilson had to offer as a site for astronomy. As he neared the summit he was surprised and delighted to break out of the clouds into brilliant sunshine. Deciding that whatever the weather below, Mt. Wilson's climate was ideal, Hale soon chose this as the place to locate his planned new observatory, where he could pursue his chief interest—the intensive study of the Sun. Exactly five years later, on June 25, 1908, using the high-resolution spectrograph of the newly completed 60-foot solar tower, Hale made a fundamental discovery—that the dark regions on the Sun called sunspots are produced by powerful magnetic fields. This demonstrated that the magnetic force was not unique to Earth.

Today, as we approach the centennial of that discovery, solar research continues at Mt. Wilson—still the scene of important advances in our knowledge about the Sun and stars. The Observatory grounds are open to the public 10:00 a.m. to 4:00 p.m., seven days a week, and guided walking tours are offered on Saturdays and Sundays at 1:00 p.m. The walking tours typically include a visit inside the 150-foot solar tower, giving visitors a view of the research in progress.

FOR THE LATEST NEWS ABOUT SOLAR ASTRONOMY, you're welcome to attend a free public lecture by James LoPresto of Edinboro University, Pennsylvania, to be given at the Altadena Public Library, 600 E. Mariposa St. in Altadena, Sunday, June 22, at 2:30 p.m. The talk—commemorating the 100th anniversary of the discovery of solar magnetism at Mount Wilson Observatory—is sponsored by the Mount Wilson Observatory Association, and refreshments will be served beginning at 2:00 p.m.

Another free public talk about the Sun and its magnetic effects, this one sponsored by JPL as part of its von Kármán lecture series, will be given this coming week by Edward J. Smith, Project Scientist for the solar-orbiting Ulysses mission. Based on 17 years of observations by the Ulysses satellite, Dr. Smith's talk will be presented at the following times and locations: Thursday, June 19, 7:00 p.m., at JPL's von Kármán Auditorium, 4800 Oak Grove Drive, Pasadena; and Friday, June 20, 7:00 p.m., at the Vosloh Forum, Pasadena City College, 1570 E. Colorado Blvd., Pasadena.

Fire Danger Level Being Raised on the Angeles National Forest on Friday, June 6, 2008

Arcadia, Calif. - The Fire Danger Level on the Angeles National Forest is being raised from "Moderate" to "High," effective June 6, 2008 as summer temperatures continue to dry out vegetation and the forest prepares for an increase in summer visitors. The "High" fire danger level is the third in a six-level, graduated fire danger rating system. A variety of factors determine the level, including the moisture in vegetation, weather conditions and firefighting equipment needs due to national fire activity. Despite the change, there are no new campfire restrictions: Open wood and charcoal fires will still be permitted in developed campgrounds and picnic areas only. Gas and propane powered stoves and grills are permitted in non-developed areas with a valid California Campfire Permit.

Spark arrestors (required year-round) should be checked to make sure they are in good working order on all off-road motorcycles, chain saws and other equipment with internal combustion engines. Travelers through the Forest should remain on designated roads and never park on dry brush or grass.

Visitors should also be reminded that some closures remain in effect. This includes areas affected by the Ranch Fire (west of I-5) and the Buckweed Fire (northwest of Hwy 14), including the popular Rowher Flat OHV area. In addition, approximately 1,000 acres in the vicinity of Cooper Canyon (north of the Angeles Crest Hwy) remain closed in order to protect critical habitat of the Mountain Yellow-Legged Frog, a federally endangered species. Williamson Rock, an area frequented by rock climbers, and a portion of the Pacific Crest Trail lie within the closed area. Hikers can take a detour around the area by departing the trail (northbound) at Eagles Roost and taking the highway to Cloudburst Summit, a distance of 4.5 miles.

California experienced a significant drought in 1977 the state's driest year in history that affected everyone. Since that drought there are ten million more people living in California. Per capita water consumption per person is up from 200 gallons per day to almost 230. The number of golf courses has grown from just under 300 in 1977 to a present day total of 912 (second only to Florida with 1073).

Last week Governor Schwarzenegger declared California in a drought. Drought is a scary word to owners of golf courses. They use thousands of gallons of water per day, and spend millions of dollars per year for it. Bob Thomas, Senior Director of Communications for the Southern California Golf Association, told reporter Tracie Savage in an interview on KFWB98 News on June 12th, that water is the single biggest issue facing golf courses in the next 10-20 years. There is much more pressure to find better ways to irrigate the fairways and to find grasses that don't use as much water. He said that people pay thousands of dollars to golf on fairways in Scotland and Ireland, yet their fairways are yellow rather than green which is how it should be. California golfers might have to get used to that concept. New courses such as Rio Grande own their own water treatment plant and that is something that should be required of all new courses.

The golfing industry, according to Thomas is a big business that employs thousands of people and millions of dollars are spent in all areas related to the sport....

When the time comes that there is no water to buy, how relevant will that be?

Sierra Madre Storm Watch 2008 From The Public Works Department

The June 6th issue of the Mountain Views-Observer carried an article recapping a presentation Public Works Director Bruce Inman made to the Fire Safe Council regarding the City's preparedness for mudslides that are likely to occur below the areas burned by the Santa Anita Fire. The purpose of the presentation was to strongly reiterate City staff's earlier advice to residents in threatened areas to act now to protect their homes.

The May rainstorm with it's slightly less than two inches of rain deposited an estimated 1,800 cubic yards of mud on the City's streets. This did little to reduce the threat of the County-estimated 57,000 cubic yards of debris that the burn areas could produce. It is not possible to know whether the debris will come in small amounts as it did in May, or in much larger quantities. The amount of mudflow will be determined largely by the timing and intensity of rainstorms. However, if the May storms did little else, they did underscore the need to get prepared now.

The City does not have the resources, in either manpower or finances, to enable the City to protect individual properties from potential mudflow events. Sierra Madre, like many other communities which have faced similar post-fire mudflow issues, must rely on individual property owners to protect their own properties. How then should residents deal with this sword of Damocles that is perched on the mountainside above them?

First and foremost, heed the advice provided to residents at no cost by engineers from Los Angeles County Public Works. These are professionals with experience of many fires behind them. The County engineers' sketches will assist residents in preparing their defenses to keep mud in the street and off their property; or, in some instances, the engineering advice will assist in channeling the mud safely across or through their properties into the street. Once the debris gets to the street, the City takes over, and will remove the debris as quickly as possible.

Remember, the goal is to keep the mess in the street. It takes only one property owner who doesn't prepare out of a whole neighborhood to cause a mess for themselves and everyone downstream of them. Work with your neighbors. In fact, make property protection a neighborhood effort.

Second, but equally important, be safe. If warned to evacuate, do so. Once evacuated, stay out of the area until the cleanup is completed. Cleanup activities are hampered by pedestrian and vehicular traffic and by interference from residents and non-residents alike who come to view the action. Be aware that a mudflow event may happen quickly, with little or no warning. I came across a photo taken during May's rainstorm of someone working down in the drainage channel at Brookside and Woodland. Very brave, very dangerous.

Speeding Ahead to Gain Local Control Pasadena to Host Musical Milestone

What essentially would boil down to simply changing a word in the state vehicle code could in fact give older cities like Pasadena the ability to set some speed limits locally the city's Department Transpiration told the Legislative Policy Committee last month.

Although it may sound simple, city staff said the process would require getting a state representative to author a bill, then rallying support from other cities, and lobbying as many people in Sacramento as possible to get the job done.

We are suggesting a language change in the vehicle code that would allow us the option to apply either the definition under the prima facie laws 'or' the option of doing an engineering and traffic speed survey should we chose to for monetary reasons." said Frederick Dock, Director for the city's Department of Transpiration.

Mayor Bill Bogaard, who sits on the committee along with Council Members, Sid Tyler and Margaret McAustin, said support would have to come from cities both in the northern and southern part of the state. Dock said there were a number of them had the same problem above San Francisco.

He explained that, Pasadena being an older city has a street network designed for slower speeds having narrow two-lane roads. Newer cities have



streets that are designed for speeds of 40 mph to 45 mph being much wider he

> The city is currently in the middle of looking at the possibility of having to raise speed limits on streets after they were found to be out of state compliance. The issue was first brought to the council last year.





Thinking About My Father

I never liked the manner in which some parents continue to treat their "children" long after they've grown up. I remember reading about a 90 year old father who still chided his 70 year old son as if he was still a boy.

As I grew older and lived apart from my parents, I wanted an enlightened relationship. Perhaps "friends" was too much to hope for, but I wanted to be treated as an equal, not spoken down to, but listened to. But how to slowly bring about such a change?

My mother was always easier to converse with, and she was much more willing to relinquish her reins of parenthood on her 30-something, and then 40-something, child. My father had much greater difficulty. He grew up in the Depression and lived his life in that mindset. He never fully trusted banks, didn't communicate much with his children but expected our obedience, and "taught" us what he could via yelling at us.

I have said, jokingly, that I learned everything from my father. His ideas were too often tinged with stubbornness and folklore, and I often took a contrary path to his advice. Mushrooms were messy and dangerous, so I took up mycology. Everything I needed to know about plants was in the grocery store, so I took up botany and ethnobotany. A computer was absolutely not needed, so I learned how to use a computer along with the rest of the world. Oil, high heat, and a teflon frying pan was all that you needed to know about cooking, so one of my brothers became a chef.

Still, he was my father. As the years rolled by in our separate adult existences, I made the effort to get to know my father as a person, to talk to him, to be a real friend. So I refused to go to the normal family holiday gatherings where there was too much food, a nonstop blaring TV, and loud simultaneous talking (and yelling) by everyone. Instead, I would visit the next day and sit and talk with my father and mother, sometimes with a pie or other home-made dish. He regarded it as odd that I'd rather do that holiday meeting the day after everyone else met, and he even once went so far as to call me a "bad son." But as time went on, I could tell he was touched by having us share a reading and small meal the day after. He no longer chided me for non-attendance at family events.

Once, when trying to dissolve the parent-child bonds, I called him and began a discussion.

"Can I call you Frank," I asked.

"Is something wrong?," he responded.
"No, nothing is wrong," I told him. "I'm just trying to have

a better relation with you.

"Do you need money? Are you in trouble?" he asked with worry in his voice.

Needless to say, that conversation did not go as planned, but was still a step in the right direction.

When he died (after a long illness), I got the word via an early morning phone call. In a daze, I walked into the moderate rain, crying, talking to Frank. I walked for hours, and I felt that I "reached" him, and he seemed to appreciate our continuing conversation.

I'd learned to love and appreciate him in his final years. He was by no means an ideal father. He was full of strengths, and weaknesses, talents, and flaws. He knew quite a bit of stuff that was not so. But I grew to admire and attempt to emulate his positive attributes, while also attempting to learn from his mistakes and avoid those patterns in my

In this way, I can say that my father taught me. I chose to no longer hold him in the mental bondage of "flawed father," just as I had demanded that he no longer hold me in the mental bondage of "deferential son." Rather than see him as a "flawed father," I saw that he was just another individual with his own life's challenges, trying to make sense of this life, flaws and all.

By trying to see his life through his experience, I found that I could simply accept who he was, my father, one-half of the formula for bringing me into this world. At long last, I felt at peace with my own father, and felt an unconditional love towards him, years after he died.

GRACE PERIOD OFFERED FOR BUSINESS LICENSE VIOLATORS

As a result of California Assembly Bill 63 (Local Government Sharing Program), the Franchise Tax Board discloses business-related income tax information to municipalities.

Those cities, including Pasadena, match records against business license databases to ensure that all businesses that pay related income taxes, but do not have licenses, are brought into compliance with local municipal codes.

A grace period has been established in Pasadena through July 31, 2008, for non-compliant business operators in commercial areas to submit all applicable business license forms to the Business License Section of the Pasadena Finance Department.

Business operators in residential areas will receive written notification with a due date. All applicants will be notified in writing of the amount due for their required business tax permits. If payments are mailed, only the U. S. Postal Service postmark will be accepted as proof of mail date.

Only the current year's license fees will be charged, and all penalties and interest will be waived during the grace period. Anyone who does not apply within this grace period will be charged prior years' license fees plus all related penalties and interest.

Applications are available at www.cityofpasadena.net (click on E-Government) and in the Municipal Services Office in Room N106 at Pasadena City Hall, 100 N. Garfield Ave.

The required forms for commercial businesses are a business license application, code compliance form and, if applicable, a health license permit application. Businesses located in residential areas must complete and submit a business license application, home occupation permit form and a business license questionnaire.

Fines for anyone who remains in noncompliance are 25 to 100 percent penalty per month on the original business tax fee, interest at 1.5 percent per month on the unpaid balance, and possible civil citations and noncompliance charges.

Café Beaujolias Eagle Rock

A French restaurant without pomp and circumstance? Come on! You know, I think they even like Americans at this place. Well, at least I know they have the snails; this I can confirm. Sure, Cafe Beaujolais has Escargot on the menu and this is a

good place to try it for the first time. To be honest, when I think of French dining, Eagle Rock is not the first place that comes to mind. Kiss this frog though and you may find a Prince. The food here will surpass the prices, so let's go visit this hidden diamond.

Everything plays the part here; food, waiters that appear to be just off the plane from France and, of course, the menu. The service can be slow here so enjoy your meal and relax, you are in France after all. Waiters in France are considered professionals, not like here where it is 'just another job' before becoming the next Brad Pitt. With a recommendation from my waiter we selected several dishes; the Truite Bretonne (\$19.95), Rainbow Trout pan fried in a lemon butter sauce topped with bay shrimps and mushrooms; next a Halibut, Le Fletan au champagne (\$22.95). I strongly recommend the meat dishes as they are well crafted - Magret de canard au mile et citron... Breast of Duck with a lemon sauce. My favorite this evening is the signature dish - Oven Baked Rack of Lamb (\$22.95), Carre d'agneau dans son jus. The runner up of the night is the Filet de Boeuf... Filet of Beef in a cognac cream sauce (\$23.95). Plus many rich and wonderful desserts, most of which are made right at the restaurant.

As for the snails, if you love them, you will be well rewarded here. For me, I resisted and abstained on this evening. Maybe that is why they call us dirty Americans, it may all come down to the snails? One of the well-recognized items about French food that gives it unique billing and stature are the extraordinary sauces. That is what truly separates this cuisine from all others. They have that well in hand at this restaurant.

My recommendation: I found the meat dishes superior to the fish items, but I will leave further investigation of this restaurant to you.



Studio 3: Artists' synergy blooms with shared workshop

Three women, two of them sisters, all of them parents of St. Rita schoolchildren, joined forces in May to create a unique workshop, studio and gallery for their work. Located in a brand new "green" building at 66 E. Montecito in Sierra Madre, Studio3 offers a wide array of creativity.

You can often enjoy the aroma of lavender soy-based candles wafting out to the driveway if the French doors are open. The collection of handmade candles has long been a favorite creation of Gloria Prins. The soy wax she uses is very clean burning, burns slower than paraffin wax, and is biodegradable as it is a vegetable based product. Accidental wax spills are also easier to remove from surfaces than paraffin wax. When she's not busy as a candle maker, her talents wend a completely different direction: designing jewelry. The delicate, wired, metal-smithed and stone detailed pieces are displayed here like beautiful pieces of a favorite lace.

Her sister, Elena Alonzo, is the handbag and clothing designer of the group, what she refers to as soft goods and novelties. Her passion is for fabric and pattern and color. "I make one of a kind purses and wallets and clothes." she laughs." I get bored pretty quickly so I always like to try new things." Alonzo creates fun appliquéd and embroidered fashions for babies and toddlers for her Sophia line, named after her oldest daughter. When the Sierra Madre Chamber mixer visited the space in early June, the moms and grandmothers in the crowd ooh'd and aah'd over her designs.

Moira Love, schooled at the Rhode Island

School of Design, speaks and lives in broader, wider strokes of the paintbrush. You can view her mural work at La Salle High School nearby, and at the Sierra Fitness building in Sierra Madre, and many public and private sites. Freelancing for 17 years, she's painted for clients all around the country, and has been featured at many showcase houses and on HGTV.

She will create a Trompe l'oeil painting or a faux finish on your walls or just about any surface you desire. She thinks and paints on smaller surfaces, as well, from acrylic painted canvasses to customized home accessories. Displayed on the open staircase to the upper office space they share with The Destination Group, is a triptych of three Bora Bora scenes depicting a favorite tropical beachfront. Love's humor and lightheartedness can make anyone smile when viewing her hand painted swings.

Prins comments that all three share the same love of creating, art and friendship. "Creating a piece of jewelry, a unique purse or a wall mural is such a thought process. You really have to think about it before you make it. And when it turns out the way you envisioned it feels really good, whether it's piece of art or this studio. Alonzo pipes in, "And now we want to share our new direction with other artists, featuring them and giving them a voice, as we've now been given a voice and platform in this new workshop. We're especially grateful to Tom Brady, whose company shares space with us, for helping coordinate this new direction in our artistic

The artists offer numerous classes and workshops on painting, jewelry making and more for children through adults. A "taste test" class for adults, offered to attendees at the recent Chamber mixer, used various wines and ports as a creative paint medium.

Studio3 is also organizing a Summer Writing Workshop for elementary age students, beginning June 17, utilizing teachers and professional writers to challenge and develop the creative writing capabilities of second through 8th graders. Cost is \$170 for the 10 week Session.







Westminster Gardens: Retirement Living in the

By Chris Bertrand Gardens Built with Missionaries' Seeds You may have seen a peek of Westminster Gardens in a drive down Huntington, as I first did, on the scenic route to the Azusa Costco. When I sent out an email recently, requesting column ideas, Arcadia resident Mary Cronin responded immediately with her suggestion. Together, we toured the vast gardens and home to about 150 residents with the Executive Director, Judy Thorndyke, and Director of Fund Development,

Rev. Douglas Edwards. Duarte's Westminster Gardens property was originally a ranch owned by a Dr. Morrison, who created a vast orange grove here. Since the land was "out in the country" they made a point of creating a recreation or dance hall to give their children and young people something special to do when visiting Morrison's rural outpost. That building, named "El Sueňo translates from Spanish to "The Dream." This magnificent remnant of a bygone era, complete with heavy beamed ceiling and fireplace, is used today as a gathering venue and Fellowship Hall for today's "young at heart" residents. The adjacent Morrison residence, lived in for just the last seven years of the Morrison's tenure there, is used for administration.

Nearly six decades ago, Presbyterian benefactor, Frank Shu, decided to express his gratitude for the ministry career in China of Presbyterian missionary, Rev. Booth, by donating \$1,000,000 to the Presbyterian Church. His philanthropy provided for the establishment of a retirement community for church workers. With this historic gift, Morrison Ranch was

purchased to become Westminster Gardens in 1950. In the decades from 1950-2001, 1112 missionaries from six continents and over thirty eight countries retired here. Many brought seeds or slips of plants from their assigned lo-cales to add to the rapidly expanding collection of exotic trees, shrubs, flowers and more. Other new retirees purchased or ordered seeds of favorite plants from their mission countries. To-day, the resident population includes both retired Presbyterian missionaries from around the world, as well as retirees from

other faiths and other walks of life.

The result of all that seed planting, all these years later, is a private arboretum, around which their 800-1300 square foot units are built. It is a "continuing care retirement community (CCRC) offering residential living, assisted living and access to a skilled nursing facility. Residential living consists of charming, roomy one and two-bedroom homes that offer various floor plans to choose from. Assisted Living here fills the niche between independent living and the need for 24-hour skilled nursing care," according to their website.

Every living unit is completely without stairs, so it is con-

sidered fully accessible. The key differentiating factor here is their determination to remain un-institutional. Edwards commented that so many retirement facilities build upwards into multi-story buildings, removing residents from contact with the land and the enjoyment of landscape surroundings. This magical landscape here is particularly beautiful, with miles of paved paths for easy walking or electric wheelchairs to ponder

fountains, ponds and the exceptional, varied plant life. How lucky they were to have a knowledgeable resident create a reference book describing the flora. Back in 1985, then 95 year old resident Dr. Ralph Stewart completed a three year project to catalog what he estimated to be more than 650 species, including 504 flowering plants, 23 gymnosperms, one Cycad and 10 ferns on the 32 acre property. He never stopped learning, continuing his love of plants with this study, after retiring from 50 years teaching college botany, and devoting another 21 to research at the University of Michigan. Stewart's book is available for review at the Gardens.

Under construction now are ten new manufactured home units. Assembled elsewhere, the buildings were then delivered in a very few pieces, and bolted to the prepared foundations. Completion will open up availability for 10-20 more residents in the year to come. The decision to use manufactured housing was weighed carefully, and chosen to minimize the noise and disruption to the current residents in relatively tight quarters. The foundations and grading, however, posed a recurring problem repeated in this area of Duarte.

Mountains of boulders flowed into these plains surrounding the San Gabriel River, once upon a time. Now, whenever you dig down a foot, five or ten feet, boulders must be sifted from the soil in monstrous versions of a flour sifter, for proper grading and compaction. They literally beg people to take the boulders away.

In a long running relationship with the Duarte Library (this site once held the old library), Westminster makes their private, Memorial Park available for a city-sponsored Author event each October. Also, coming soon is the conclusion of the third season of "Opera at the Gardens" featuring "La Traviata" on Saturday June 14 at 2 p.m. Tickets are \$25.

I've already made it known that when I grow up, I hope I can live in a place like Westminster Gardens!

Broiled Salmon with Spinach-and-Feta Sauté

- * 4 skinless salmon fillets (6 oz.

- ⁺ 1 Tbs. olive oil
- * 2 bags (5oz. each) baby spinach * ½ cup feta, crumbled (2 oz.)
- * 1/3 cup pine nuts * 2 tsp. fresh lemon juice

Man. When I think of the way I was looking forward to last weekend I feel like a fool.

Two of my most long-wished-for sports occurrences were finally going to come true. First, Big Brown was going to win the Belmont Stakes, becoming the first Triple Crown winner since 1978; which is just about the time I started drinking (occasionally), voting for president (even less often), and experimenting with different kinds of mustaches.

And then the next day, tennis superman Roger Federer was going to finally win the French Open at the expense or his arch rival, dirt rat Rafael Nadal, to give him the career Grand Slam and finally make him the GOAT (as in "Greatest Of All Time").

So what happens? Big Brown not only loses the Belmont, but turns in the worst performance ever by a horse trying to complete the Triple Crown, also the worst performance ever by an odds-on favorite in the entire 140 year history of this prestigious, classic race. He checked in dead last, easing to a walk before he even reached the wire. In other words, he

And Federer? He not only loses to Nadal for the 4th year in a row in Paris, but it is also the worst performance ever by a #1-ranked player in a Grand Slam event. He wins only 4 of 22 games. He loses the last nine games of the match. In other words, he gave up too. (The best analogy I can think of is that Nadal is the bully and Federer is the spoiled rich kid who routinely gets bitch-slapped in front of all his friends after school.) It was so bad that Nadal actually apologized to Federer in his post-match remarks: "Roger, I'm sorry for the final; so sorry," the soft-spoken Spaniard said sheepishly.

The only question is, which chicken laid the bigger egg??? Maybe the winner of that contest is Big Brown. Federer, though ranked #1, wasn't even favored versus Nadal. Nadal is the undisputed all-time master of the red clay, and almost every expert picked him to win, albeit in a close contest. But Big Brown was supposed to be a lock. A sure thing. A "foregone conclusion", as his own trainer put it. That trainer, Rick Dutrow, set new standards for ego and boorishness leading up to the race, declaring certain victory virtually every time he came within earshot of a mike or eyeshot of a TV camera. And so the racing gods paid him back, with that embarrassing, eased-up finish, helped out by a puzzlingly poor ride from his jockey, the classy, though luckless, Kent

Maybe Dutrow wanted it too much. Maybe he wished too hard. Maybe he dreamed too high, and the rarefied air affected his loose lips and foul mouth. Maybe Desormeaux tried too hard to do the right thing, which he thought was to yank back on the reins and conserve his horse's energy, which turned out to be the wrong thing, because Big Brown fought him angrily for the first quarter mile, throwing his head left and right, almost clipping heels, then bumping a horse or two as Kent swung him 5-wide around the first turn. The horse

resented not being put into the race right away, he was keen to go on, and the pace was slow so he could have made the lead easily and then been slowed down for a breather when the time was right. But when his jock refused to let him compete he sulked, gave no effort or response thereafter, and when the field came to get him he was pushed aside on the far turn like a gang of toughs pushes aside a 97-pound weakling. And then he was mercifully, though pathetically, eased to a stop.

Life is like that. You wish hard for things. You have dreams.

I used to dream of getting my books published and going on talk shows...well, that didn't happen (at least not yet). Later on I wished I had a big family, two or three regular kids, all of us living in a big two-story house somewhere in the Midwest... well, lately I've had to come to grips with settling for one great kid in lieu of three regular ones, and living alone with my dog in a one-story house in the San Gabriel Foothills. (Even the dog seems confused sometimes.) But things change. You do your best, and sometimes things just don't go the way you

One thing I always used to wish was for my beloved San Francisco Giants to win the World Series. I've been wishing and waiting for that sublime occurrence since about 1965. It almost happened against the Angels in 2002, finally, but I wished too hard and my Giants authored the biggest Game-Six collapse in World Series history. It was my fault. (Hey, you suppose Federer was watching highlights of that game

right before he stepped into the arena against Nadal???)
So yes, that brings us back to Federer. What did we learn from last weekend? What can we take from the twin holocausts of R-Fed and Big Brown? Perhaps it is simply this: In sports, as in Life, be careful what you wish for and how hard you wish it. Be it team, or player, or horse. If they win, great. But if they don't, it might feel---or seem---worse than it really is.

Better to broadcast a more casual rooting interest, I say. Or, better yet, feign ambivalence. That way, no matter what happens, you might feel pretty good about it in the end. Yes, I say don't wish too hard. Dream high, but don't dream too high. (And pick up a copy of my first novel if you want to read an additional 100,000 or so extra words on the subject.)

It makes me wonder, though...If instead of wishing for greatness I'd simply wished for Big Brown to just finish the race, do you suppose he would have won?

The Mountain Clymer Jack the Wonder Dog - Part 1

In my days at Adams' Pack Station, I was in my glory, surrounded by the intense beauty of the mountains, fun and adventure, my family and friends and by a myriad of animals, both wild and domestic. Some of these animals were well-established residents of the station when I got there. There were all of the working animals, of course, the donkeys and mules and horses, but there was also a

collection of barn cats that were left behind. The previous owner had taken all of the canine denizens, but the barn kitties belonged to the station, not to any one person or family - they would not have been happy anywhere else. The oldest of them was a calico named Gypsy. She had survived sixteen years as an outdoor cat in the mountains, a pretty remarkable feat. They were my companions in my Sierra Madre apartment, where it was required to declaw them, so they had to remain indoors. Over the years, we had other cats come and go - some were abandoned in the mountains, some we adopted and barn-raised, others were rescued from local shelters. I think the most that we had at one time was maybe eleven. Four of them moved off of the mountain with me, the rest remained at the station. Of the original cats, only Clem remains. She is the matriarch now at the ripe old age of fourteen. Also passed down to the new owners were Flower and Blossom, kittens from two separate litters that we barn-raised, Igmu (Iggy), a rescue from a local emergency vet facility, and Margaret, a kitten adopted from a Bean Town patron in Sierra Madre (I'm such a sucker for a fuzzy face).

Though the station came well stocked with felines and equines, I knew it would not be complete with out at least one canine. A couple weeks before I was scheduled to take over the Pack Station, in an effort to fill the vacant "trail dog" position, Xoxa and I made a trip to the Pasadena humane society to take applications. Cage after cage offered up one pleading face after another...this one looked too old... this one too small...the next one was part pit bull...and another was cowering in the corner...that one was barking way too much, and some I just plain did not connect with. Then there he was, sitting in the front corner of the cage so to be seen, but sitting calmly and quietly, seemingly shy, but not at all cowering. He was somewhere between puppyhood and adolescence, a bit more than knee high, with tawny but rather mottled coloring, a long, pointy, freckled nose, small ears that stood at the top of his head and then flopped forward and those eyes...sweet and loving as the night is long. The sign on his pen said "Male Australian Shepard mix, 3 months old, stray, available for adoption." I stopped and talked to him for a bit and went to find Xoxa. "I found him!" I exclaimed, as I dragged him from the aisle he was in and back to where the puppy waited. The pup was still sitting calmly, just as I had left him. We reached in through the chain link fence with our fingertips and petted him as best as we could on the nose. He stared gratefully at us through the cage. "Incredible," I thought, "such a humble, gentle and kind looking baby." We had the attendant remove him from his pen and bring him to the office where they allowed prospective adopters visitation time with the animals they are interested in rescuing. We spent a long time with him. He was a bit nervous at first, but in no time he was playing with a ball and interacting with us comfortably.

The decision was made - he was definitely the one. I picked my three boys up from school and took them back to the pound to meet the puppy. They adored him and together we went and filled out the necessary papers to adopt him. We had to wait a few days so that he could be examined and neutered, but he was ours! It was decided that he would be named Jack, which seemed appropriate since that is also the term used for a male donkey.

There was a two-week delay in the closing of the sale of the station. Dennis needed more time to move a lifetime's worth of stuff out of the house, the barn, the bunkhouse, and the loading dock. It had to have been a very hard thing for him to do, so we were glad to give him all the time he needed. I could not keep Jack in the apartment for that time, so my ex-husband was good enough to allow Jack to stay at our Arcadia home that he occupied. I visited him daily so that we could bond. Finally the day came for us to move into the station. After spending the day moving all of my stuff out of my apartment and into my new mountain home, we made one last trip to bring Jack up the hill. He sat nervously in the back huddled in my son Patrick's lap. He did not seem too fond of car rides, but that did not matter, he would not be doing much of that where he was going. As we traveled the winding mountain road to the station, Jack got increasingly restless and he began to pant. Suddenly he got to his feet and with one giant heave, dumped his entire lunch on poor Patrick's lap. Pandemonium broke out in the back seat, as the boys all tried to get as far as possible from poor carsick Jack. I pulled the car over, got everyone out and cleaned off, and we continued the trip to the top without further

Dennis was kind enough to leave behind a hand built doghouse that was painted hunter green and white to match our own home. On each side of the door leading into the house was a set of antlers, giving it a rustic mountain dog feel. There was an old sofa left behind in the bunkhouse that we were throwing away, and the cushions on it were the perfect size to line the doghouse floor. We moved the doghouse to a raised cement slab next to the house and under the cover of a large bay tree to keep him as close and as dry as possible. Once we got him accustomed to the area, this was to be Jack's new home.






