Eighty-seven years after the Sierra Madre Fire Department was founded, the 52-person group has been designated the 2008 Sierra Madre Fourth of July Parade Grand Marshals. The Parade is scheduled for Friday, July 4, 10 a.m. Matt Bosse, chairman

of the Fourth of July Committee,announced choice over the weekend.

Steve Heydorff, Fire Chief, said, "It's a great honor and we're pleased to lead this terrific annual Parade."

This is the sort of quality protection we have every day in Sierra Madre. Our Fire Department is the only volunteer Fire Department in Los Angeles County, and we're extremely proud of them."

Heydorff, who became fire chief four months ago, has implemented a Fire Department Academy to build the department. Over the past weekend 16 new firefighters graduated after an 18-week, 300-hour course.

Another opportunity to build the Fire Department 28-member new paramedic department, which is headed by Greg Christmas. Now, there are sleeping quarters in the department building and, according to Heydorff, newly added out-of-town firefighters have a place to sleep during their 24-hour shifts.

that soon drew six other departments besides Sierra Madre: the Forestry Service, Monrovia, Arcadia, San Marino, L.A. County and Pasadena. Later, departments came from as far away as 400 miles to assist. There were ultimately 1,055 firefighters the on the job. After four days there were 534 acres involved. There were 12 aircraft involved in the fire-fighting: five fixed wing and seven helicopters.

Heydorff said, "It shows Bosse said, "Our committee took into consideration the outstanding job our local that when you have fires like that which outgrow your capabilities, mutual aid departments join you because you all speak the same language."

He added, "June is the month for brush inspection, usually not fire suppression. Here we are, earlier than the usual fire season with no winds and yet we had this incident." Neither the total cost nor the cause of the fire is determined yet.

Heydorff explained that the Sierra Madre Firefighters Association, headed by Bill Messersmith, is the fundraising and philanthropical arm and is not associated with the City.

Messersmitih named some of the philanthropic and fundraising done by the Association: Children's Easter came with the inclusion of the egg hunt, Christmas Eve Santa visit; Christmas dance (their major fundraiser); pancake breakfast, summer programs at the library, sponsor of youth activities such as Fix the Field and Little League baseball, and many more.

RAY BRADBURY'S "FAHRENHEIT 451" AT FREMONT CENTRE THEATRE

But the human intellect and instinct for freedom can't be complete ly denied and a rebellious few will read books regardless of the consequences. One of the rebels is a fireman himself. But the fire department has a weapon

First published in 1953, Ray Bradbury's classic science fiction novel "Fahrenheit 451" is eerily prescient and is as wrenchingly relevant now as it was on the day it first appeared. It has previously been made into a film (by Truffaut), an opera, and a play (performed professionally in L.A. at the El Rey thirty-one years ago; a later version played at the Falcon in 2002). Now Ray Bradbury's masterpiece returns, opening at the Fremont Centre Theatre on April 19.

Best known as the world's most famous living writer of science fiction novels and short stories, Mr. Bradbury's output extends to different genres and media (his classic screenplay for John Huston's film of "Moby Dick"; his tales of Ireland in "Green Shadows, White Whale"; historical fiction in "A Medicine For Melancholy"; his stories on his TV series "Ray Bradbury Theater"; his screenplay for the feature film "The Wonderful Ice Cream Suit"; much more). He is a recipient of the National Medal of Arts (U.S., 2004), and a Commander of

Arts and Letters (France, 2007). Alan Neal Hubbs, resident director of Ray Bradbury's Pandemonium Theatre Company, helms the Pandemonium in this new production. John Edw. Blankenchip contributes production design. Lighting design: Peter Strauss. Costume design: Susanne Klein. Production stage manager: Elliott Woodruff.


dogs we have out

OFFICERS FILE GRIEVANCES AGAINST THE CITY

Although voters in Sierra Madre recently passed Measure U which levied a utility tax on residents in order to pay for public safety - police, fire, paramedics, there are still some unhappy campers among the Sierra Madre Police Department's rank and file. Several grievances have been filed against the city as management changes are implemented in order to reduce the cost of operating

According to Police Chief Marilyn Diaz, an effort is underway to "insure our department runs more efficiently and that we decrease overtime costs".

According to sources, many officers are upset with recent changes to schedules and assignments. In particular, changes in schedules from three 12 hour days to five 8 hour days is "making a hardship" on the rank and file. Other issues include the assignments of some officers.

Funds from the Utility Tax will not be available until sometime in July, and even then, as indicated during the campaign, they may not be sufficient to cover the costs of running the department. In addition, passage of Measure U did not eradicate other budget problems the city is facing. In his recent State Of The City Address, Mayor Kurt Zimmerman warned of tough decisions that will have

SMPD faces many of the same challenges as other departments in the area. Budget cuts are difficult to manage. And, even in a town as small as Sierra Madre, the Iraq war plays a role. Currently, there are at least two officers out on Military Leave, and that, according to Diaz, adds to the need to rearrange schedules.



Cynthia Bennett's company does it all... From architectural design to general contracting, to furnishings, to the artwork on the wall!

Those in the know often look to Cynthia Bennett and her company for leadership in cutting edge interior design, home remodeling and now, new construction. Since she was first licensed as a general contractor in 1983, Bennett quickly established herself in the forefront of all things residential and high end in LA. She believes it's through her rare ability to "see the jobs all the way through, from inception to the last bit of furniture and accessories... It turns out the way I envisioned

Early in her career, she was stunned when many of the jobs she designed weren't completed the way she had planned. A substitution here, a cost adjustment there, and pretty soon the original cohesive plan she had designed had been changed to something else. After beginning remodeling kitchens only, one thing led another, literally.

"A kitchen project led to converting a service porch. Since that went so well... how about adding a bedroom above the porch? Before we knew it, we were into all kinds of additions and remodels." She set her sights on becoming a complete, full service company, and in the ensuing 25 years, developed a company that plans a project, works through the building department, builds it, then decorates the property, down to the artwork and accessories. All in-house.

Bennett and her staff of fourteen architects, interior designers, construction managers and more work out of a vintage Craftsman bungalow in South Pasadena, where Fair Oaks meets the 110. From there they insert "an enormous amount of detail into our plans. Everything is specifically called out, down to the hardware and cabinets before we begin.'

To start, she asks her clients to complete a detailed, five page questionnaire about their lifestyles, including minutiae like, "Are you left or right handed? How tall are you? (To adjust counter height). How are you going to use this room?" These days, she comments, "More than just bathing takes place in the bath. We might want to install an espresso station in the master bath, if the client enjoys coffee while prepping in the bath. From that data, we take the client's ideas and make them work. We try to make all the decisions before we start construction. That eliminates the stress of last minute faucet decisions.

She featured a new, dual application product in her area in last year's ASID designer showcase at Descanso Gardens. Special bedroom and bath mirrors hid tv units. When they're off, they function like any other mirror. When the television is in use, it shines right through the mirror, minimizing the clutter and technology intrusion.

In that all-important pre-project questionnaire, there's a special section on the household's pets. 'We seem to have a lot of clientele whose cat or dogs are their 'children,' so it's fun customizing home details to accommodate these important members of the family." Special built-ins and pullouts, for instance, hide pet supplies in intricate pantry layouts, and custom pet food niches prevent trips and spills.

A whimsical feline cutout serves as the cat door at a Toluca Lake producer's home I had the opportunity to tour recently. The home's understated elegance features a traditional look in the living room, yet everywhere Bennett's inspiration brings beautiful materials together in unusual ways. For instance, an artisan papered the walls with thousands of sheets of torn paper, then Bennett had a color and iridescence applied. The seams at the corners of the room separate this great installer from a merely good one, particularly in the heavy papers used

The dining room repeats a circular motif in the table and custom lighting, for a refined, yet more contemporary flair within the traditional Georgian framework of the home. Gorgeous hardwood flooring, refinished by local contractors, Pasadena Wood Floors, was tinted to nearly black for a dramatic, yet neutral foundation. The goal was to retain enough translucence to allow the custom detailing, including the walnut border strip and metal corner inserts from yesteryear to shine through in a new way.

The layers above the floor include a Bennett signature combination of intricate millwork, leather bound panels, silk draperies in two patterns, European wallpaper, leading up to an inset ceiling of Venetian plaster showcased by indirect lighting.

The dramatic artwork chosen for the foyer was Bennett's pièce de resistance. She had the South American sculptor's work crated and sent over from a gallery on the Westside, fairly confident her long standing relationship and understanding of the client would translate into delight at his eight foot tall sculpture. It did. It stands there proudly today, blending tradition, contemporary and eclectic in just the right mix to match the client's ifestyle and personality.

Even before her professional training, Bennett had an eye for space planning and remodeling. While living in the Netherlands, she remodeled a 1670's era building from a bicycle shop back into a home with inspired style and panache, Eventually, the word around Amsterdam was, "Go see that American woman! She did a great job on her house!" Bennett saw from that experience, that she really enjoyed the process, and thinks she was 'supposed" to do this. She loves and thrives on

the constantly evolving changes in the design industry. Not many can wear so many hats so well.

Mountain Clymer Jack the Wander Dog (formerly known as "Jack the Wonder Dog") Part 2

It did not take long for Jack to become accustomed to his new home, though it took awhile to figure out some of the boundaries of his new acquaintances. One donkey, a rather round and shaggy fellow named "Slim", had a major issue with those of the canine persuasion. Jack, being instinctively a herding dog, felt that he had an obligation to assert some sort of control over the donkeys, though he had not quite figured out exactly what he was supposed to do or how to do it, he just knew that he was supposed to do something, and that something somehow involved chasing and barking. Slim quickly informed him of how he was NOT supposed to do things by chasing poor Jack around the lower corral with his head down, charging like an angry bull. When he had seemingly successfully chased Jack off, he turned and walked away with an air of great satisfaction at having put the poor pup in his place, but Jack did not quite get the message. Again he attempted to assert control over the ornery animal and followed him, barking and nipping at his heels. Without losing a step and with one flick of his rear leg, Slim launched his unsuspecting nemesis clear across pen. Though I am sure it hurt plenty, Jack did have a bit of a flair for the dramatic as a pup, he immediately began to scream at the top of his lungs and ran quickly to me for protection and sympathy. I held him and comforted him as he continued yelping. I examined him for evidence of serious injury and could find none but a small cut above his eye. When he finally stopped his fussing I let him go and he walked away as though nothing had happened. It would seem that a lesson as severe as that would have been well learned, but no one ever accused Jack of being a whiz kid.

Jack learned many lessons in proper procedure from Slim and from other sources over the next few months, mostly the hard way. He had to learn what his role was when we were on the trail. He had to learn about all of the dangers of the mountains and how to find his way around them, and he had to learn to listen to me when we were working. He also took it upon himself to figure out how to work the canyon and its many visitors. On the hillside, just outside the gates of the station, is a large shady picnic grove with picnic tables and barbeque grills. On the weekends, it was packed with picnickers. Jack was no dummy when it came to mooching. He mastered just the perfect touch for getting handouts, and would spend most weekend days when were not packing, working the picnic grove. Jack was always a slim and fit animal. In the dark his silhouette resembled that of a coyote - long legs, lean body, pointy nose. I think many thought from his appearance that he was a starving stray. That, coupled with his humble, sweet, and unthreatening demeanor, gained instant sympathy and food from unsuspecting guests. Little did they know they were dealing with the canine equivalent of Yogi the Bear. When we were on the trail pack-

ing, he put his talent to use by working the campgrounds as we passed through them. There is not a cub scout or boy scout alive that could resist his charms. Eventually he developed such a fan club, that the scouts would stop by the station and ask if they could take Jack with them on their campout. I would bag uj some food and give them his leash and he would happily spend the weekend with them playing and eating. There were times when he would leave with me on a pack and would slip away somewhere along the trip, deciding to stay with one of the cabin owners or at the campground with some campers. Other times, when we were at the station and the picnic grove was not yielding anything great, he would pack up and head off to one of the campgrounds to see what was cooking there. He would either wander home later in the evening, or be returned the next day by someone who had happily shared their meal and tent with him the night be-


fore. At first, I worried about him getting lost and not returning home, but I grew to realize that he had total command of the mountains. He was as much a part of them as any of the wild things there.

His journeys were not motivated just by food, sometimes he just went for the adventure or exercise, I think. On more than one occasion, early morning hikers parking in the station's lot got to have the pleasure of Jack's company on their long hike to Mt. Wilson. The trip to Wilson is a 7 ½

mile uphill journey that takes several hours, so a little companionship was usually greatly appreciated. On one such trip, Jack and his companion arrived at the top of Mt. Wilson just in time to bump into a troop of scouts who were headed out on a weekend hiking and camping trip to Henniger Flats, a campground about 7 miles further east on the trails that led from Wilson. Jack dumped his first companion for the scout troop, and followed them all the way to their destination. He spent the night with them and the next morning I got a call from the LA County fire fighters who were stationed there informing me that Jack was visiting and asking me to meet them at the bottom of the Mt. Wilson Toll Road to pick him up. On several other occasions I got calls from the residents at the top of Mt. Wilson telling me that Jack was up there playing in the snow. One such call came one evening as I was returning home from a pack and unloading the animals. I finished what I was doing and hopped in the car to make the hour long trip around to the back country and up to the top of Wilson. Once there, I tromped through the snow, combing the area and calling for Jack. There was no response and no sign of Jack anywhere. I returned home, a bit upset that I could not find him, but relatively confident that he would show up sooner or later. When I pulled into the lot at home, there he was. He had apparently arrived home at about the same time I arrived at the top of the mountain to search for him, which means that he covered the 7 ½ mile trail home in about an hour or an hour and a half...in the dark.

Jack mastered his job on the trail as well as he did the terrain of the mountains. When we hit the trails, he always assumed the lead, a position that he, and he alone, was allowed to hold. If another dog accompanied us on the trip, he was immediately informed that he was to maintain a position somewhere behind Jack, preferably behind the entire string of animals. They usually fell into position and stayed there. Jack knew what he was doing. He trotted ahead and kept a nice distance in front of the rest of us. If he encountered a snake on the trail he would stop, bark at it, and let it get out of the way, and in doing so, gave warning to me that I needed to stop as well. He would also stop if he heard mountain bikers coming. They would see him on the trail and slow down or stop giving all of us enough time and warning to avoid being startled or worse, to avoid a collision. I am sure that Jack new just what he was doing and just why he had to be out front. He was protecting the rest of us, and he understood that was his job and took it very seriously.

Jack was retired and moved from the station with me into Sierra Madre. Though I considered it, I could not bear leaving him behind. He has packed on a few pounds and is not in the shape that he was when he was a working dog, but he does get to return to his beloved mountain roots

once a week or so with his buddy "Canyon Dave" who now does the canyon patrol for the new owners of the station. Sometimes Jack accompanies me on local hikes up Mt. Wilson trail or up to the old foundation above Bailey Canyon. He is still recognized on the trail when he meets up with former hiking and camping buddies. They greet him as they would any long lost friend... with a warm smile and a hug.

PAYING THE PIPER

Environmental Commentary from Susan Henderson

pay (v): to requite according to what is deserved; The Piper (n): one that offers strong but delusive enticement

This week, as my head was already hurting from polluted air and I could hardly breathe from aggravated sinuses, when I heard of the President's desire to begin offshore drilling exploration again. My mind immediately focused on two things, almost simultaneously. First of all, I thought about why my head and sinuses were aggravated

and secondly, my thoughts turned to the crisis our family has been dealing with since November. Seven months ago my niece, age 47, was diagnosed with fourth stage multiple myeloma, an incurable form of cancer. It is really difficult watching this once vibrant young woman and her parents cope. The entire family has an overwhelming feeling of helplessness. And, while we understand that life is full of challenges, it was quite disturbing to hear Wanda's doctor say, "Multiple Myeloma? Oh that's definitely an 'environmental' disease."

An *environmental disease*¹ - meaning a malady caused by disease causing agents in our surroundings – an illness that could have totally been prevented?! Our family is just one of millions that is currently experiencing the backlash of nature for what we have done to this earth. If you are reading this anywhere in Los Angeles County, you too are a victim of our own doing - this air is killing us. Literally. And now the President wants to lift the ban on Offshore drilling – for what, more exposure to environmental diseases?

Unlike the ostrichesque² debate over Global Warming, there is a long list of indisputable illnesses that we have caused to rain down upon us including (partial listing): Allergies, Asthma, Autism, Birth Defects, Cancer, Dermatitis, Emphysema/Lung Diseases, Lupus, and Parkinson's Disease. That is not to say that we would not have any of these diseases without environmental pollutants, but their incidence has definitely increased as our society becomes more reckless. And, unlike some may say about global warming, most of us have easily identifiable, up close and personal experiences with these diseases.

Over the years, our society has been quick to embrace use of the agents that advance the progress of life altering illnesses simply because their use made 'our lives easier' or 'made it a whole lot cheaper' or displaced one pest with another. Most of us paid very little attention to the long term effects. Too many still don't pay attention. And for those who do pay attention, we have learned that we cannot rely on most politicians or big business to tell us the truth. So, because of our rush for a quick fix, we have been taken advantage of and it is our own fault.

Remember how convenient and cool we thought those styrofoam containers and nonbiodegradable cups were? Well, when we throw them away and trash is burned, even at the dump, what do we get? Dioxins! Dioxins are extremely dangerous compounds that form when items containing carbon and chlorine are burned. Dioxins have been linked to cancer, developmental and reproductive disorders, and birth defects. Dioxins can enter the food chain when airborne ashes settle on feed crops and bodies of water. These dioxins are then consumed by domestic meat and dairy animals, and accumulate in the fat of these animals. Dioxins then enter the human body when we consume these meat, fish, and dairy products where they may persist for months or years.

So do we still welcome the convenience?

Remember when we got rid of those glass bottles and found out we could use plastic for almost anything? Well, one of the 90 hazardous byproducts created from burning certain trash are Endocrine Disruptors - chemicals that may interfere with the body's endocrine system and produce adverse developmental, reproductive, neurological, and immune effects in both humans and wildlife. A wide range of substances are believed to cause endocrine disruption, including pharmaceuticals, DDT and other pesticides, and plasticizers such as bisphenol A. We can find these disrupters in many everyday products- plastic bottles, metal food cans, detergents, flame retardants, food, toys, cosmetics, and pesticides developmental, reproductive, neurological and immune effects. Do you think you might just prefer milk in a glass container now?

Cheaper, Cheaper, Cheaper -Pound Wise And Penny Foolish: We always go for cheap, mass production. We don't care what is used. Take for instance - lead. Although found in the earth's crust, because of its abundance this highly toxic, low cost, long lasting metal and its compounds are in paint, ceramics, pipes, solders, gasoline, batteries, and cosmetics we use today. Lead exposure is widespread: lead-based paint in older homes, contaminated soil, household dust, drinking water, lead crystal, and lead-glazed pottery. Extreme exposure can cause lack of muscular coordination, convulsions and coma. Lower lead levels have been connected to noticeable changes in children's mental development and behavior such as hyperactivity, deficient motor function, hand-eye coordination and reaction time, and lowered performance on intelligence tests. Chronic lead exposure in adults can result in increased blood pressure, decreased fertility, cataracts, nerve disorders, muscle and joint pain, and memory or concentration problems. So the question is, was cheaper better?

And, Oh to live a bug free life: Pesticides - A pesticide is any substance used to kill, repel, or control certain forms of plant or animal life that are considered to be pests and includes herbicides used for killing weeds. It also includes fungicides which are used to prevent the growth of molds and mildew, disinfectants for killing bacteria, and compounds used to control mice and rats. Because of their widespread use in food production, we are exposed to low levels of pesticide residues through our diets. According to most scientists, children are particularly susceptible to exposure from pesticides. We may also be exposed to pesticides used in a variety of settings including homes, schools, hospitals, and our places of business. Maybe the 'pests' weren't so bad after all.

But now back to the latest quick fix – offshore drilling, because these gas prices are killing us. So the President has decided that in order to deal with the price of oil, we need another quick fix. Let's lift the ban on offshore drilling exploration. People will like that. They have always gone for the 'okey doke'. Drilling operations, whether for exploratory gas or oil or developmental gas or oil, produce enormous quantities of waste. Hundreds of thousands of gallons of drilling muds discharge toxic metals such as lead, mercury and cadmium. The water they produce contains dangerous levels of carcinogens and radioactive materials such as benzene, toluene and arsenic³. So while it may reduce the price of gas (and many say it won't), the offsetting medical costs are no comparison.

Haven't we learned anything from our insatiable quest to have it all? To have the easiest, quickest, cheapest fix for any situation? A fly swatter would have been a hell of a lot better than any pesticide. A cat for the rats. A little elbow grease will kill the weeds with much better consequences. And I won't even start on the progression of the automobile in this society. We have enjoyed the ride until now. But now we should be able to see the light - albeit there is a 'haze' over it. We must certainly realize that it is time for responsible changes in the way we think and live.

This is not a political issue. Environmental diseases strike Democrats, Republicans and even Green Party members. There is no distinction in who suffers. We all do. We have paid a very high price for convenience and so-called efficiency. We can't turn the clock back, and we can't continue forward like we have been either. We simply have to take responsibility for our own lives and not let propaganda, greed, and apathy 'cloud' our thinking.

Please note, there is no suggestion that this author is any less a consumer of things not necessarily good for us than anyone else. My car is too big, it took me too long to get rid of the cheapest light bulbs and use CFL's. I am only Johnetta Come Lately regarding which pesticides are used for my lawn, etc., etc., etc. However, I have made quite a bit of progress in correcting the error of my ways. The problem for people like myself and actually, all of us, it may be a little too late.

So let's recognize that the Piper has collected enough from us. It's time to run him out of town...off the face of the earth so we can try to save it.

Around the state early June brought wildfires in the mountains east of Santa Cruz and three other areas in northern California. A freeway brush fire destroyed

morethan fifty homes in Stockton. Sierra Madre experienced it's first April wildfire. In May mud and debris flow came with a light spring rain not a winter deluge.

Last October and November when we were on Red Flag Alert throughout the southland, Sierra Madre was waiting for the fires to come to our foothills. The waiting was agonizing. California is experiencing year round fire season due to continuing drought. There is still a lot of hillside yet to burn above us and we still need to be cautious.

The hillsides above Sierra Madre consist on

average of 50 degree slopes. Mud and debris flow becomes the next natural disaster to be averted. Homes need to be protected from mud and debris flow by diversion measures onto the street and not onto neighboring properties. This is our Fire and Flood cycle we learn to live with.

Questions about replanting the burned areas have been asked and Mother Nature is answering: leave it be. You can look to the hillsides and see the recovery underway. Each burned stump is showing green at the base. The root systems are still in place and activated by the heat of the fire. The seed bank is not destroyed by the fire but ready to sprout when the moisture, at the right time, in the right amount is present.

After receiving a \$150,000 grant from Farmer's as Sierra Madre Fire Marshal Rich Snyder. Insurance last week, the California Fire Safe Council (CFSC) shared the wealth with two local Fire Safe Councils (FSC), the Sierra Madre Fire Safe Council and the Big Santa Anita Canyon Fire Safe Council, honoring them for their work during the Santa Anita Fire which started April 26th and was declared contained on May 2nd The fire burned more than 500 acres in the San Gabriel mountains behind Sierra Madre.

On hand for the presentation were Bruce

"It's a sad truth that wildfire seasons is now yearround," said Turbeville in a prepared statement. "Wildfires take a tremendous toll on people, neighborhoods, and the environment. effective prevention projects have made a huge impact in eliminating or reducing losses in numberous communities, and we want to find new ways to expand and improve these kinds of community-wide endeavors. For every dime you spend to prevent a fire, you'd spend more than a dollar to fight that fire. It makes good business sense to prevent losses before they happen."

Did You Know? An Unfairly Maligned Elder

Over 70 million years ago dinosaurs roamed the Earth. While they are now extinct, one animal who shared the same land with the dinosaurs still exists today...the opossum...The name "opossum" is derived from an Algonquin Indian word "apasum", meaning white animal.

Despite its appearance, the opossum is not related to the rat. In fact, the opossum is a marsupial, or "pouched" mammal, and is therefore related to other marsupials such as the kangaroo and the koala. Like kangaroos and koalas, infant opossums stay inside the mother's pouch to nurse and develop. The opossum holds the distinction of being North America's only marsupial.

Opossums are born after an 11-13 day gestation period. The pink, embryonic-looking infants are so small at birth that 20 could fit into a teaspoon. The infants continue to develop inside the pouch. As they grow and the pouch becomes full, the juveniles then ride on the mother's back until they are old enough to go out on their own. The opossum has an average lifespan of 1 to 2 years. This short lifespan is due in part to the presence of predators including dogs, cats and people.

The opossum has many interesting features. It has 50 teeth, more than any North American land mammal. Its hairless tail is prehensile and is used for grasping branches, balancing and carrying nesting material. The opossum does not hang upside down by the tail, a common misconception.

They also have opposable thumbs on their hind feet for holding onto branches.

Whether rural, residential or in the wilderness, opossums are a benefit to any area they inhabit. Their diet includes all types of bugs and insects including cockroaches, crickets and beetles. They love snails. They also eat mice and rats. These docile, non-aggressive and unfairly maligned animals have earned the title of "Nature's Little Sanitation Engineer."

When the time comes that there is no water to buy, how relevant will that be?



Water Rates Set Go Up in July

By Dean Lee

The city council unanimously approved increase water distribution and customer charges Monday night although not before first hearing complaints about the city's own water use and whether a recent campaign to conserve water is effective.

Mayor Bill Bogaard and councilmember Chris Holden were both absent.

Staff said the ordinance was necessary arguing the current rates had not been changed since 1995. The higher charges will cover operation and maintenance of the water distribution system, including metering, customer service, billing, the call center and collections. The rates are

set to go up July 1. According to a staff report, "The monthly bill impacts of the proposed ordinance vary by the size of a customer's meters. For example, the monthly bill impact to residential inside-city customers with a 5/8" or 314" meter using 12 billing units per month is an additional \$2.08, with the monthly bill rising from \$20.89 to \$22.97. The monthly bill impact to outside-city customers with the same meter size and usage is an additional \$2.81, with the bill rising from \$28.26 to \$3 1.07."

The higher rate will bring in an additional \$2.3 million annually. Last year the Water Fund Operating Budget was \$41.2 million and would go up to \$43.8 million.

Councilmember Marget McAston said she wanted to see a better way to notify customers of the hike other than mailing them a post card.

"The deck is really stacked when we notify people that way," she said. "I think we ought to notify people more clearly and more directly."

She then suggested putting directly on the water bill, or on the internet possibly through the city's website.

Councilmember Steve Madison said he would rather see a rate structure based on conservation. Staff said they were looking into although Phyliss Currie, the manager of Pasadena Water and Power said it would be a very involved conversation.

Madison also asked if the city's new campaign to save water worked? He said he thought the signs on bus stops were hard to read. He said the campaign should be more effective

The city's conservations budget is funded by the rate increases Currie said. A number of people asked what the city was doing to save water in area such as parks.



When Sebastian Viscaino sailed into what was to become the Channel of Santa Barbara on December 4, 1602, he gave it that name, because the 4th day of December is sacred to the memory of Saint Barbara, virgin and martyr. By 1901 the railroad was completed which connected Santa Barbara with San Francisco, making the Wells Fargo Stage Coach obsolete. Like the "gold rush" before, by 1910 Santa Barbara City's population would double over a short period of 9 years.

Just 100 miles north of Pasadena/Sierra Madre - Santa Barbara is home too many desirable restaurants and hotels, and on most days you will be greeted with some of the best weather anywhere in the country. On this visit I was to learn a lesson that I did not care to be taught, that all hotels are not created equally. We stayed at the Avania Hotel, formerly The Country Inn by the Sea. 

Looking Up With Bob Eklund Planets Galore, but Where Did Springtime Go?

"DOES EVERY SINGLE STAR HARBOR PLANETS, and, if yes, how many?" wonders planet hunter Michel Mayor from Geneva (Switzerland) Observatory. "We may not yet know the answer but we are making huge

progress toward it."

On June 16, at an international conference, a team of European astronomers announced a remarkable breakthrough in the field of extra-solar planets. Using the HARPS (High-Accuracy Radial Velocity Planet Search) spectrograph at the European Southern Observatory (ESO) at La Silla, Chile, they found a triple system of "super-Earths" around the star HD 40307—a rather normal star, slightly less massive than our Sun and located 42 light-years away toward the southern constellations of Doradus and Pictor.

Since the discovery in 1995 of a planet around the star 51 Pegasi by Mayor and Didier Queloz, more than 270 exoplanets have been found, mostly around solar-like stars. Most of these planets are giants, such as Jupiter or Saturn, and current statistics show that about 1 out of 14 stars harbors this kind of planet.

"We have made very precise measurements of the velocity of the star HD 40307 over the last five years, which clearly reveal the presence of three planets," says Mayor. The planets, having 4.2, 6.7, and 9.4 times the mass of the Earth, orbit the star with periods of 4.3, 9.6, and 20.4 days, respectively.

"The perturbations induced by the planets are really tiny—the mass of the smallest planets is one hundred thousand times smaller than that of the star—and only the high sensitivity of HARPS made it possible to detect them," says co-author Francois Bouchy, from the Institut d'Astrophysique in Paris.


Indeed, each planet induces a motion, or "wobble," of the star of only a few meters per

"Clearly these planets are only the tip of the iceberg," says Mayor. "The analysis of all the stars studied with HARPS shows that about one third of all solar-like stars have either super-Earth or Neptune-like planets with orbital periods shorter than 50 days."

Why the short (compared to that of the Earth) orbital periods? A planet in a tight, short-period orbit is indeed easier to find than one in a wide, long-period orbit. "It is most probable that there are many other planets present: not only super-Earths and Neptune-like planets with longer periods, but also Earth-like planets that we cannot detect yet. Add to this the Jupiter-like planets already known, and you may well arrive at the conclusion that planets are ubiquitous," concludes Stephane Udry, one of Mayor's colleagues.

FORTUNATELY FOR US, Planet Earth has an orbital period of 365 ¼ days. If our year had 50 days or less, as is the case with so many planets, we would have no time to properly enjoy a season before it was over. As it is, I was just getting to appreciate spring when I looked at the calendar and discovered that June 20 is the summer solstice—the end of spring, the beginning of summer, and the day with the most hours of daylight in the year (in the Northern Hemisphere, that is). Time rushes us on into new seasons, as Earth tumbles along nonstop at its 67,000 mph orbital speed. But for now, I'm going to take a "time out" to just go outside and enjoy a long, balmy summer evening. As Robert Frost said in one of his poems, "You come too!"




Healthy Child Healthy World

me that I've also said "Yes" to a couple requests that are proving much more challenging and costly expected, one of which I'm actively beginning to resent.



Mosquitoes can be dangérous!


