

Springing Into Action: Sierra Madre Fire Fund Created

It didn't take Sierra Madreans long to inquire about a "fire fund" to assist the City in paying for the Santa Anita Fire that ravaged our hills between April 27 and May 2, 2008

Elisa Weaver, Sierra Madre Deputy Director of Community and Personnel Services, had been sending eBlasts to the community and out-of-town press about the fire's impact.

"From the get-go, I knew that the

fire was going to cost the City a great deal of money. There had already been talk of who was going to be paying for the fire and how it was going to impact our resources," Elisa explained.

"When I received the e-mail from a resident stating how grateful they were for all the e-mails going out and for all the firefighters' efforts and success in keeping the fire from damaging their homes, I realized we needed

to set up a fund and publicize how residents could help the City

financially," Elisa said.

She thought of the Sierra
Madre Community Foundation,
remembering "what a wonderful
relationship we'd had with them
over the years." Elisa pointed to
the funds enabling the City to
provide specific programs and
services such as Goldberg Park
and participation in the AllAmerica City Civic Recognition

Awards.

"Knowing this, I was sure that through the Foundation we would have another successful partnership while we figured out how we were going to pay for a multimillion-dollar fire," Elisa explained.

She followed through, e-mailing City Manager Elaine Aguilar and Karin Schnaider, Director of Administration, both of whomindicatedenthusiasm for the fund.

Elisa contacted Benn Martin, treasurer of the Foundation, who sent a Donor Contribution Form, saying, "I'm sure the Board will approve." Mary Katherine Kelley, chair of the Foundation, responded affirmatively, and the wheels were in motion.

How much money are we

talking about?

City Manager Aguilar said we don't know yet but "probably the end cost will be over \$4 million." She added that the money ultimately will go into the General Fund.

As of Sunday, June 29, 41 donations equaling \$8,234.33 have been received, according to Treasurer Martin.

Foundation Treasurer Martin shared some of the notes to firefighters that accompanied donations:

"Thank you for saving my grandma's house."

"We were awed by the response... by all agencies, but especially our own good men and women of Sierra Madre."

"Many, many thanks for saving Gail's house!"

There were also donations from 15 Southern California Edison employees (plus one retiree), many of whom regularly hike in the Sierra Madre mountains.

Mary Katherine Kelley, chair of the Foundation, said, "One of the missions of the Sierra Madre Community Foundation is to help the community respond quickly in emergency situations. We were honored to be able to help set up this fund immediately to deal with the fire and its aftermath."







Sierra Madre City College Float Always a Highlight of Sierra Madre 4th of July Parade

People first started asking me about June 20th, "Do you know what the City College float is going to be this year?" The highly anticipated float entered in the parade by the mythical Sierra Madre City College is always the topic of conversation leading up to the parade, and for several days after, as a general rule. And inevitably, pre-parade talk turns to the subject of what each person's favorite float was. The float I heard brought up several times this year was the 1999 Float, themed "A Year in Review" in which the float lampooned several incidents that appeared in that year's headlines, from deer impaled on spiked fences, which called for a review of building regulations, to the proposed skateboard park, to citations over failure to clean up after pets at the City's dog park. Each year, the crew that builds the float puts together a float that has people talking, usually pokes fun at someone or something, and is also timely. Case in point, this year's float, dubbed All-America City College. The City of Sierra Madre was named an All-America City on June 8th, yet less than one month later, SMCC had a float that not only played off that award (a huge pedestal atop which sits a tiny trophy), but also took a shot at the recent national headlines regarding immigration policy, as City College "alumni" handed out pseudo-green cards that promised the bearer everything, while noting that it was not valid if you are a U.S. citizen.

Sierra Madre City College was founded by 10 zany madcaps from Sierra Madre. The late Hugh Warden, a local businessman and sometime character actor was president for several years, but these days leadership is as enigmatic as the college itself. According to one spokesperson "Nobody knows who's running the joint." But the joint is most definitely being run. Where is the college located? About a half block up, according to some, to others "It's upstairs over there at the vacant lot." While the college has no students, it still hands out degrees. Though the handsome. official looking degrees themselves cost nothing (SCC is tuition-free), the frame is \$20, and you can't get the one without the other. The familiar (to parade goers) bright yellow Sierra Madre City College t-shirts are on sale at the Bottle Shop, where you can also pick up SMCC license plate frames, \$5.99 for one, or \$9.99 per pair. There's also a golf tournament to raise funds annually. Does all the money raised help pay the teacher's salaries? Not one penny. It's all donated back to the community. Over the years, the City College has donated to the City's ambulance fund, and to Sierra Madre Search and Rescue. They donated a flagpole to St. Rita's School, and installed a concrete art patio for the Kindergarten students at Sierra Madre School. They've installed lighting at Sierra Vista and Mountain Trail parks, funded a patio on the east side of City Hall and the south side of the Senior Center. With Kiwanis, they helped fund the pergola area in Memorial Park, and they are also responsible for the covered barbecue area in Sierra Vista Park (a revenue generator for the City). They've also installed barbecue sets in Memorial and Sierra Vista Parks.

And while many people are aware of the contributions made by the College to the City, SMCC is probably best known for its Marching Band and float in each year's Fourth of July parade. The band is, of course, not actually a part of the music department, as there is no music department. But each year by arrangement, SMCC is represented in the parade by a marching band, playing such fun tunes as the Mickey Mouse song, and The Yellow Rose of Texas, The floats over the years have included a parody of Seabiscuit, the movie (with Gary Stevens, the Kentucky Derby winning jockey and one of the stars of the movie, marching alongside), satirical looks at the Michael Jackson trial and a former Sierra Madre police chief, a football vs futbol float during the World Cup year of 1994, and many more. When the City celebrated the Centennial of its founding in 1981, the College's Board decided that the City College would have a float that said that it was older than the City by one year. The school's actual founding has been reported variously in local papers (including the L.A. Times) as 1979 or 1980. As you can see in the accompanying float photo retrospective, the City College float was apparently enjoying "pre-school" years as far back as 1973.







Environmentally Speaking, Did You Know? 8 Safety Tips For

Barbecues and Grilling

a little cookout. The first thing you need is a fire extinguisher. Next you need to know your fire and know how to control it. Every year grills and smokers cause thousands of fires, hundreds of injuries, dozens of deaths and millions of dollars in damage. You need to know how to cut fuel supplies, extinguish fires and call the fire department. Always have one person in charge of the fire at all times. You should also know something about treating burns.

1. Fire- Fire is the most destructive force in the universe and you are inviting into your backyard for

- 2. Food Safety- Bacteria eats every kind of food you can think of. It grows at any temperature above freezing and stays alive until the temperature hits 165 degrees F. Every second you give it between these two temperatures it's multiplying and causing disease in your food. So, until it goes in your mouth or on the grill, it needs to be kept cool. After serving, it goes back in the refrigerator.
- 3. Instructions- Grills, gas or charcoal, and smokers have very specific ranges of operation. Don't assume that your new grill works just like the last one. If you can't find the manual itself, go to the
- 4. Location- Location is everything when it comes to placing your grill or smoker. Your manual will
- tell you the minimum distances around your unit that must be kept clear. 5. Gas Safety- The number one cause of gas grill fires is an obstruction in the path of the fuel. This largely takes place behind, underneath, or inside your grill where you do not look. This means you need to regularly inspect your gas grill for problems. At the first sign of a problem turn off your

control valves, turn off the fuel tank and disconnect everything. Gas grills produce a great deal of

- **6. Charcoal Safety** Charcoal grills are the cause of far more fires than a gas grill. The number one problem is lighting the charcoal. Lighter fluid causes all kinds of problems. It turns into a heavy gas at a relatively low temperature. While liquid lighter fluid burns, evaporated (gaseous) lighter fluid explodes. Follow the instructions exactly.
- 7. Grease- Bad enough that you are using flammable materials to do your cooking, but the food itself is creating more. Flare-ups are more than a nuisance, they are potentially lethal. Grease that collects in your grill builds up over time. A clean grill is a safer grill. This goes for smokers too.
- **8. Smoke** Smoke gets in your hair, clothes, eyes and lungs. Smoke from your grill or smoker contains carbon monoxide, Polycyclic Aromatic Hydrocarbons (PAH), and other dangerous substances. As much as we love the smell of the smoke from our outdoor cooking it's best to enjoy it from a

The Treasures of Sierra Madre

It's parade time again! Hooray! There is nothing in and when its the world like the Sierra Madre 4th of July Parade and

nothing more defining of the spirit of Sierra Madre. Comp When I first moved to California in 1994, what first the attracted me to this town was its uncanny physical likeness to the small New Jersey town I grew up in; and the layout of the downtown, the tree-lined streets, the architecture of the commercial part of town, and that small town feel. It all looked so much like the tiny little borough of my youth. Bernardsville, population 7368 (basically unchanged since I was a BHS student), is located in the rolling, wooded hills of the central the "canyon" part of northern New Jersey. The hills surrounding to the heated the quaint little downtown and the canyon to the heated the quaint little downtown and the canyon to the heated the quaint little downtown and the canyon to the heated the canyon the ca the quaint little downtown area are covered with political battles mansions separated by meandering stone walls, winding "mountain" roads (we call them mountains, but I think that the high point in Bernardsville is some 600 feet above sea level), meadows that are teaming with deer at dusk, weekend polo matches and fox hunts. Only the downtown has sidewalks. The people of the town are now all upper-middle class, though when I was growing up, there was also literally "the other side of the tracks" - a section we called "Little Italy." It consisted mostly of the descendants of the Italian craftsman and servants of the original wealthy estate owners. But even this section has been mostly renovated and spruced up since I was a kid and now is home to the lower-upper-middle class families of the town. Even in my day the town was very "white bread" and rather dull. "Little Italy" was about as interesting as the town got. Our only other local color was provided by Congresswoman Millicent Fenwick who, despite her huge wealth and power tooted around town in her VW Beetle, puffing on her cigar, with the her two giant schnauzers crammed in the back seat...and my favorite resident, "Lizzy". "Lizzy" was an older woman, no one knew quite how old she had been around town as long as anyone could remember and had always been old. She was either mentally handicapped or a little crazy...no one knew which. Rumor had it that "Lizzy" was actually quite wealthy and was the heir to a lot of money, but on any given day, you could see the short, stocky old woman walking the streets of Bernardsville in her frumpy sweats, white bobbed hair held back with a headband or to one side with a barrette or bow, revealing her liver-spotted, ruddy, pudgy face, head turned down, eyes focused at her feet, hands clasped behind her back holding onto the leash of her equally scruffy and frumpy wire-haired fox terrier, who she dragged along behind her as she shuffled down the sidewalks of town. If you happened to pass her on foot, she would mutter unhappily at you as you passed by. Everyone, including me, snickered at her and made fun of her behind her back, but as I got older, my view of her changed. I began to see her as a wonderful gift to our little "Pleasantville" - our intriguing, quirky,

little splash of color. Though what attracted me to Sierra Madre originally was its physical resemblance to my hometown, it was my first Sierra Madre 4th of July Parade, that made me fall in love with the town's spirit. I will never forget that parade and delighted in telling my friends back east about the experience. I relished every moment the spectacle from the beginning (the Sierra Madre City College Marching Band) to the end (the Sierra Madre City College Marching Band...again) and everything in between (the hysterically funny political floats, the "Stogey Men", the "Varmint Council", fiddling Uncle Sam, belly dancing Katralia, the old Honda Civics and the Deloreans, the Shriners, the rock bands on flatbed trucks, and the scouts and ball teams). It totally captured and defined the city and told me what the people and town of Sierra Madre was all about. It told me that I had indeed found a place I could call

Since moving to town after my divorce in 1999, leaving for 6 years to run the pack station and then returning to town once again, I have become familiar with all of the backstreet offerings of the town and have met many of the wonderful locals. I have heard many stories about what Sierra Madre was like in the distant and not so distant past, how it has changed, how it has stayed the same, what establishments used to occupy what building. The legendary and the notorious of the different eras. There is one thing I can say for sure, Sierra Madre is and always has been a unique and extraordinary place. From its roots as a sanitarium through its checkered past of brothels, and speakeasy, and on through the days of orchards

beautiful turn-of-the-century estates, huge stone and lazy days at Beantown of today, Sierra Madre (charbored many treasures. Those treasures can be found everywhere in its local traditions, personalities, businesses, atmosphere, scenic beauty,

juaintness and soul. Most locals can tell you about the treasures of Sierra Madre. We each have different things that we value here in town, things that have touched us and that remind us daily of what a special place this is. But for those of you who are spending your first 4th of July here and who are not so familiar with those treasures, I want to share with you my favorite things. Though all of the town is beautiful and the mountains are my soul, the "Canyon", with its twisty and somewhat confusing narrow streets lined with small peculiar little homes and inhabited by some of the towns more eccentric residents, is my favorite part of town. In the canyon is a secluded little historical business called Mary's Market. It has been around since the early 1900's and is a favorite hang out for canyonites. But my favorite attraction in the canyon is at the entrance to what is called the "lower canyon". There, at the corner of Woodland and Sturtevant is a stone wall. This wall is known by those familiar with it as the "Free Wall". It is where all of the canyon's residents bring their things that they no longer want or need so that others in the canyon can make use of them. The charitable and eco-conscious spirit of this wall speaks volumes of the community. Beantown is another of my favorites. Some have referred to it as "Sierra Madre's living room" I simply call it home. I have been a regular here (as usual, I am writing to you

from Beantown) since it was less than half the size it is now. Everyone I know in town I met here. Even with all of the changes over the last few years, it still remains a very special place to our community. Other local treasures include remnants of the past such as Lizzie's Trail Inn, the Richardson House, E. Waldo Wards, the Pinney House, our beloved wisteria vine, and the ruins of Bailey's old cabin at the top of Bailey

Canyon. Annual events such as Pioneer Days, The Huck Finn Fishing Contest, Wisteria Day, and Mt. Wilson Trail Race are also indicative of the character of our town. But what sets us apart from the rest of what I call "the soulless, cultural vacuum of Los Angeles" is our residents. We welcome with open arms, all of the Lizzys of the world. It is a refuge for the eccentric, the off-beat, and the different people of the world. It is a place where they can hide or where they can be open and accepted for who they are. I believe that this is partly because Sierra Madreans are generally a very accepting bunch, but mostly because there is a little Lizzy in nearly all of us here in Sierra Madre... and that is why it is such a special place...that is the true treasure of Sierra Madre.

So all of you have a wonderful 4th of July...enjoy the concerts, the "Beer Jail", the cookouts, the sack races and the egg tosses, the water fight (tip: if you don't want to get wet, roll up your windows) and most of all the Parade.



Police, Fire Team Up Fireworks Enforcement

Chunks of watermelon flew everywhere Tuesday during morning demonstration by city's police and fire departments showing just how unsafe illegal fireworks can be.

After lighting the fuse of a confiscated explosive buried within the large watermelon, the firefighter in charge ran but only got a few feet away before a large plume of smoke emerged, followed a loud bang.

Fire spokesperson Lisa Derderian said, "That's what it can do to flesh," as people then examined the scattered remains lying yards away.

Police said new this year will be check points set up to confiscate fireworks. Although police would not disclose all the locations they said the primary focus would be the Rose Bowl. They said about 15 000 people show about 15,000 people show up to see the fire works inside the Rose Bowl and

another 20,000 outside.

Pasadena Battalion Fire Chief Kevin Costa started the morning off explaining what safety precautions the city takes every year before the Rose Bowl fireworks show. He said they spray about 10,000 gallons of Phos-Chek around the bowl area.

Derderian said this year the fire retardant cost about \$4,000 more. She said the price had been going up but the this year was the highest. She also said the retardant is the same used in drops during

large forest fires. The only difference is added color so it can be seen from the air she said. Tuesday's retardant was clear.

Costa said last year there were over 200 calls for illegal fireworks resulting in over 1,000 pounds of explosives seized. Police said the enforcement period lasts 14 hours. He also said not to call 911 to report fire works unless there is a fire or someone is hurt. He said to call the local police at (626) 744-4501.

Costa also said sparklers

may seem innocent but can reach temperatures of 2,000 degrees.

When you put that into perspective, 2,000 degrees actually can melt copper and or aluminum," he said. "So you really have to ask, how safe, is the sparkler I'm handing off to my child?'

For the thousands of students Pasadena City College Tuesday's new cell phone law does not just mean having a phone "hands Free" while driving on local streets. PCC police said Wednesday thenewrestrictions

also extend to the school's parking lots as well.

A spokesperson for the PCC police said all traffic laws extend on campus because the school's funded by the state. "this is not private property as some may think."

It was also said they plan to enforce the law immediately although it was unclear if anyone on the campus has yet gotten a cell phone ticket.

It was also unclear if the school's Cadet Program will enforce the law. One Cadet said joking, "just another thing for us to

Cadets are assigned transportation, parking and general police department office assignments among other things.

A number of students said they were completely unaware they could be pulled over in the parking lots. One student said she thought the school should have warning signs. Another student also said it was unclear and that he would just text people instead, something the law still allows.

the cell phone legislation in September of 2006.

Amber alert signs along the 210 freeway have been warning drivers for the last week. Local reports say within the first few hours about 20 drivers around the San Gabriel Valley were issued tickets for taking without a headset by California Highway Patrol.

The only exception to the law is a medical or traffic emergency although tow truck drivers, emergency personnel and police may use two-way-radios the law states.

A second more stern law that also went into effect Tuesday bans anyone under 18 from the using a cell phone, pager, laptop or any other electronic communication or mobile device service while driving.

Both laws carry a minimum fine of \$20 for the first ticket and \$50 thereafter. Added court fees in Los Angeles County can range from \$90 for the first ticket to \$190 for the second according to televised news reports.

Heritage Square Museum of Homes... Literally!

I've often wondered about the unusual grouping of homes on the West side of the 110. You probably know what I mean... As you whiz by the Ávenue 43 exit in Highland Park, eight historic buildings plus a railroad car perch next to the freeway. The structures have been acquired since Heritage Square's inception in 1969. According to their website,

Chris Bertrand the buildings were moved here to create, "a sanctuary to preserve, restore and interpret the following buildings and Southern California's rich Your walk back through the architectural history of Los Angeles stretches


back to 18/6, and reflects an eclectic mix of architectural and construction styles that typify the buildings erected in Los Angeles since the Industrial Revolution and the railroad transformed American life. Efficient transportation helped precipitate the land boom of the 1880's, when the Los Ângeles area population doubled. New residents brought with them varied styles, and developed their own signature on those designs.

Volunteer docents, dressed in period clothing, offer insights into life inside the homes brought here to preserve our heritage. Rescued from demolition elsewhere, the process of restoration and maintenance is ongoing, and relies on fundraising and donations from the community. Donation in kind is often the case here, and once that led to unexpected traffic snarls and accidents on the 110.

A local paint company provided the materials to adorn the Hale House, a Queen Anne-Eastlake style built by land speculator and real estate developer, George W. Morgan in 1887. The colorful and intricate style for this era's home included many hues of paint. The donor company went all out, applying 99 colors to the home. Speeding traffic on the 110 came to a screeching halt, causing pileups, and requiring a more sedate re-painting of the home. The current exterior colors were carefully reproduced from chips in many shades of greens and pink, removed during the home's

During the tour, our knowledgeable docent called attention to the cost of the various components and structures that form the home. Expensive, hand carved wood detailing led later to machined, yet still intricate ornamentation. When stained glass was beyond reach, colored glass panels, like those on the Hale House were used. Some of the interiors have been furnished with appliances of the day, as well as furniture, and we all enjoyed a peek into the toaster of the era, dual light fixtures that could switch back to gas (more reliable) when the electricity went out, painted wood floors vs. the more expensive hardwood flooring, etc.

Faux is apparently not a new concept, as pointed out in the Hale House,

began restoration, and moved the home from its original location at 1315 Mount Pleasant Street from the Boyle Heights area. Colonial Dames then donated the house and furnishings to Heritage Square in 1995. At the

time of its construction, the home was probably the finest and most expensive home to be built in Los Angeles. The Perry Residence is currently being stripped of 130+ years of paint, in preparation for a refreshed exterior appearance. The Valley Knudsen Garden Residence, a working class Victorian

abode, was built with a Second Empire, French Mansard roof. Quite unusual for California. Napoleon II mandated this exterior appearance and roof style in 19th century Paris to provide a uniform appearance on the city's tree-lined boulevards.

Gleaned from the property where Huntington Hospital now stands, a barn in the Queen Anne Cottage style offers Gothic-influenced gables and rooflines. It was originally built to house horses and a carriage for Dr. Osborne, on staff at the hospital. Later, it was converted to an apartment and garage.

The Lincoln Avenue Methodist Church was sliced into six pieces in

1981, and moved to the site from Orange Grove and Lincoln Avenue in Pasadena. Unfortunately the stained glass windows were stolen prior to the move. Fundraisers hope to restore the windows someday, and the curator asks for photographs families might have of the church's interior.

The Ford House was a more simple structure, built by the Beaudry Brothers in downtown Los Angeles back in 1887. What makes this home so significant is the original wood carvings done by the owner, John Ford. His carvings were utilized in many famous locations, including the California State Capitol, the Iolani Palace in Hawaii and Leland Stanford's private rail car.

The tour group I joined, from Monrovia, found the Longfellow-Hastings Octagon House surprisingly efficient and well-endowed will closets and storage. Quite atypical for 1893. The clerestory windows and windows on all sides of the home provided excellent ventilation. The first and the final stops on the tour is the Palms Depot. Originally part of the Southern Pacific rail system, it was used for passenger and freight service until 1933, then became a "Big Red Car" stop until 1953. The Palms Depot can be seen in several movies, including Little Rascals and Laurel and Hardy films. The museum is open weekends, for special educational,





"Since that time, Simms has become an invaluable member of the Star Chefs committee, served for six years on the Board of Directors and, for the past seven years, has arranged for her colleagues at the bank to prepare special holiday gifts for the girls in one of our group homes. Simms a treasure, the best gift of all."

But, as Teramoto sees it, she is the one who benefits the most from her involvement at RCS. "Although it was a tremendous honor and very exciting to be recognized at Star Chefs, you get far more out of it than you could possibly know," she explained. "There are children in our community who are neglected, abused and abandoned. RCS gives those children a safe environment. To those of us who have never had anything but that, it seems basic. To the children at RCS, it means the world. And it means the world to me to be able to contribute."

Established in 1920, Rosemary Children's Services is one of the oldest West Coast charities that helps boys and girls of all ages who have suffered abuse, neglect and abandonment. Its programs include a Foster Family and Adoption Agency, which helps over 550 children, annually, throughout Los Angeles County and portions of San Bernardino, Riverside and Orange Counties; a Non-Public School providing specialized education in a small structured environment; a Mental Health Program to provide individual and group therapy and training in various life skills; and the Residential Program which includes Rosemary Cottage and four group homes.

Time is up - It's Mijares' Mexican Restaurant. I have to wonder why this itinerant restaurant critic does not spend more time at this place.


It is one of the jewels of Pasadena and a short enough drive that I can



SOUNDS OF EARTH—The first thing an alien race is likely to hear from Earth is chirps and whistles. In reality, these are the sounds that accompany

the aurora. Now ESA's Cluster mission is showing scientists how to understand this emission and, in the future, search for alien worlds by listening for their sounds.

Scientists call this radio emission the Auroral Kilometric Radiation (AKR). It is generated high above the Earth, by the same solar particles that cause an aurora to light the sky beneath.

'We can now determine exactly where the emission is coming from," says Robert Mutel, University of Iowa, who conducted the three-year study with colleagues. Consisting of four nearly identical spacecraft flying in formation, Cluster allows scientists to precisely time when the aurora's radio waves washed over each of the four satellites. Using this information, they can triangulate the points of origin of the radio emission, similar to the way GPS navigation works.

AKR was discovered by satellites in the early 1970s. It is blocked from reaching the ground by the ionosphere, the upper reaches of Earth's atmosphere. This is just as well, because otherwise it would overwhelm the transmissions from all our radio stations. It is 10,000 times more intense than even the strongest military radar signal. "Whenever you have aurora, you get AKR," says Mutel. That includes aurorae on other planets, too. Visiting spacecraft have seen aurorae and detected AKR on Jupiter and Saturn, the two largest gas giants in our Solar System.

approximately 5 minutes per oscillation. These "5-minute oscillations" are actually resonating sound waves, like notes trapped in an organ pipe (the music of the sun is far too low for human ears). Since 1984, USC Professor Ed Rhodes and colleagues have been studying 5-minute oscillations in minute detail at the Mount Wilson 60-foot tower telescope.

Following its construction 100 years ago by Mount Wilson Observatory founder George Ellery Hale, the 60-foot tower immediately became the world's prime focal point for solar physics when Hale discovered the Sun's magnetic field with it on June 25, 1908.

On the same date this year, the USC astronomers who now run the tower celebrated both the tower's 100 years of continuous observations and the 100th anniversary of Hale's breakthrough. "It was the first discovery of magnetic fields anywhere off the earth," said Rhodes.

Hale's discovery opened a whole field of solar research. His measurements revealed the magnetic origin of sunspot activity, which may have a significant influence on Earth's temperature.


Rhodes and his group now have photographs and maps for almost two complete 11-year sunspot cycles. No other telescope has such detailed information, Rhodes said, and his group is analyzing the mountains of data from one cycle with the help of a NASA grant.

The analysis will help future scientists understand the sunspot cycle and the extent of its effect on Earth's temperature.

Ladies of Liberty: The Women Who Shaped Our Nation by Cokie Roberts (2008)





American Revolution, it was their partnership that helped the American Victory,




The Summer of 1787: The Men Who Invented the Constitution by David O. Stewart (2007)
