## Arson Suspected In Hillside Fire 3 Teens Detained

Hundreds of firefighters, including the LA much closer than it really was. County camp crews, quickly contained a hillside blaze near the Pasadena - Sierra Madre border Friday. The fire started at approximately 3:00 p.m. and swift responses from the Pasadena Fire Department, Sierra Madre Fire Department, California Department of Forestry, and LA City & County Fire Departments had it under control in less than an hour. Two helicopters extinguished flames with water and drenched the 'hot spots' in the path of the flames.

According to Captain Conrad of the Sierra Madre Fire Department, approximately five acres burned. Although the point of origin was in Pasadena, just west of Michillinda, The fire at first appeared to be headed east. The SMVFD staged two engines at the Monastery at the top of Sunnyside and began setting up for "structure protection". "We wanted to be prepared to protect the homes even though the fire was more than a mile away", said Conrad. Conrad also said that the fire appeared to be

In another related development, late Friday evening, Lieutenant Faulkner, a spokesperson for the Pasadena Fire Department said that three teenagers, all 17, were taken into custody near the scene of the fire. They had fireworks in their possession.

Faulkner said that when the fire started, neighbors spotted three teens walking away from the point of origin. The helicopters that were making the water drops also saw the teens as they made their descent down the hill. They were all from Los Angeles. The Pasadena Police caught up with them as the walked away down Michillinda. They have been remanded into custody as juveniles. At press time, no formal charges had been filed.

Recent cooler temperatures and high humidity also contributed to the quick containment of the fire. Worried residents who were reminded of the anxiety of the Wildfire in April.

## The Feds Take Over Indymac Bank Depositors Worry Despite Assurances

Despite assurances that deposits under \$100,000 are insured by the FDIC, on Monday morning, hundreds of Indymac customers lined up to withdraw their money from the troubled institution.

At the Arcadia branch emotions ran high, especially those who live from paycheck to paycheck. Their inability to

withdraw cash over the weekend from the ATM was extremely difficult for some. Many sat in the sun for up to 3 hours before getting inside the bank.

At one point, an FDIC ventured regulator into the parking lot to help customers. By the end of the week, the situation had not improved much. Calls came into the paper indicating that extraordinary holds were being placed on checks issued by Indymac bank and certain stores had put up signs indicating that they would not accept any checks from Indymac for cashing. ## GARDENERS TARGETED - ATM'S HACKED

In a 48 hour period, numerous telephone calls and emails were received by this paper from residents who had become victim to a spate of crimes.


There were three incidents in which the lawn mowers and other equipment had been stolen from the back of a truck. In one case, as the owner was driving through the gate, the thief managed to creep onto the property and, without notice, remove an \$1,100 lawn mower from the gardener's truck. On the same block, the same day, another lawn mower and two leaf blowers were stolen.

Residents reported seeing two strange Caucasian men with a red 'van' in the area of each incident. Sierra Madre Police Chief Marilyn Diaz was unaware of the problem when contacted. In at least one instance, the gardener was refused to report the matter to police out of fear and language barriers. As always, the Chief cautioned residents to keep their homes locked and be aware of your surroundings.

The other troubling occurrences reported were the 'ripping off' of bank accounts via ATM machines. MVO Columnist Rich Johnson was among several people who indicated that in the last week, hundreds of dollars had been taken fraudulently from their accounts.

According to two of the victims, the transactions far exceeded their daily ATM withdrawal limit and appeared to originate at the same Citibank ATM on Rinaldi in Northridge or Granada Hills.

In one instance, the bank actually contacted the resident because of the suspicious activity. She had never used her ATM card. Another woman sent the following email: "I went into my local branch to ask what I could do to protect myself and they all acted like they had no idea what I was talking about. The scary thing is, I don't think they DID have any idea."

Between them, the legendary songwriting team of Richard Rodgers and Oscar Hammerstein earned 34 Tony Awards, 15 Oscars, 2 Grammys, 2 Emmy Awards and the Pulitzer Prize...twice. And, on July 26 and 27, the California Philharmonic will pay tribute to the enormously popular duo when it presents "Rodgers and Hammerstein," with help from yet another renowned duo - international opera star, mezzo-soprano Suzanna Guzmán, and Broadway headliner, baritone Kevin Earley.

Guzmán and Earley will join the orchestra in performing excerpts not only from Carousel but from such blockbuster hits as Oklahoma!, South Pacific, The Sound of Music, and The King and I. Earley, who will catch a red eye back to New York after his appearance with Cal Phil to return to rehearsals for A Tale of Two Cities, which will open on Broadway this September, echoes Vener's high praise for the songwriters.

"Rodgers and Hammerstein created a language and mood that was always individual to each show," explains Earley, who will play the role of Ernest Defarge in the upcoming musical adaptation of Dickens' novel. "They each sound so

unique and yet still from the some voice. I also love how the melodies and lyrics are effortless to sing. Nothing jumps out as being odd or out of place in any of their music."

Early in her career Guzmán appeared in the 4000th performance of The King and I with Yul Brynner – as Amazon #2. "Richard Rodgers must have been in love with a mezzo," she says with a smile. "Every show he has ever written has immortal melodies for that voice type." Evidence she cites includes "You'll Never Walk Alone" and "If I Loved You" from Carousel, "Climb Every Mountain" from The Sound of Music, and "Something Vonderful" from The King and I.

The mezzo-soprano equally enjoys working with Kevin Earley, whom she first met while performing at a gala for Center Theater Group. "I was so impressed not only by his talent and incredible voice but by the fact that you couldn't meet a nicer person," recounts Guzmán, who recently concluded a season as Cal Phil's Artist in Residence. "I immediately suggested that Maestro Vener spotlight Kevin, and he's become a favorite. Kevin's voice and stage persona are just plain star

This weekend of "Rodgers and Hammerstein" concerts marks the third time Guzmán and Earley will perform together with Cal Phil. "I have such a blast with Suzanna," Earley confides. "That's what it's all about. The music and the fun."

### Kiwanis Wants The Horn Back!

The following letter was sent to the City Council:

In order to justify our pending request to reactivate the 'fire horn' we thought it prudent to provide some background for those who are not familiar with the device.

The early signal for assembling the Sierra Madre Search and Rescue Team or Fire Department was the ringing of the bell in the belfry of the old 'North Church'. This was in addition to the phone system in which the telephone switchboard operator notified the firemen's home phone of the emergency. It is our understanding that the phone company, General Water and Telephone, (Drip and Tinkle) requested to be excluded because of liability. This system was replaced by the diaphragm horn that was placed in the 'hose tower' of the fire station after it was completed at 55 west Sierra Madre Blvd. in 1927. The horn was referred to as the '700 pound

This signal permitted a 'fire code' to be sounded in which a certain number of blows would indicate a particular cross section of streets from which the fire could be spotted by the firefighters. Every household had a chart inside their kitchen cabinet door, to satisfy their curiosity, and referred to it whenever the horn

There also were sirens mounted on the old city hall and one at -- Eric Olson, Sierra Madre the city yards basically for civil defense purposes.

Éven after the firemen were provided with Plectron radios the ISO (Insurance Service Organization) insisted that the horn continue in use to notify firemen, not at home, of the emergency. A blackboard was hung in front of the station by the first fireman to arrive, indicating the location of the fire. Later on, the firemen were issued personal pagers and the ISO suggested continued use of the horn as a backup. It was also tested every evening at 7 o'clock, along

with the radio system. Eventually it was changed to test at noon.

'Newbie' firefighters were conned by the older members to 'yank' the lanyard to turn the light on in the hose tower. In reality it was hooked to the horn and the chief would fine the 'newbie' at the next fire meeting \$5 for 'blowing the horn'.

The fire dispatcher controlled two buttons, one to open the fire house doors and one to operate the horn. Sometimes the dispatcher would neglect to hit the signal at the test time and her switchboard would light up. Members of the Kiwanis Club paid one of their members to put a time clock on the horn. He 'messed up' and crossed the wiring and every day at noon the fire doors would open and the dispatcher still had to operate the horn manually.

The horn was relocated to the North Baldwin parking lot at Montecito, after the new fire station was erected on West Sierra Madre Blvd. Its use was discontinued shortly thereafter but residents petitioned the city council to have the horn returned to use. 'Sierra Madre College' 'students' and 'graduates' wore t-shirts promoting its restoration. It is now disabled and tradition-lovers

David Conway, Monrovia, CA and 'old timers' hope to have this 75-year-plus tradition returned.

The horn has always been oriented to the north in order to have it ricochet off the mountains. When the horn was relocated, because the new fire station was across from a convalescent home, the tall building to the north didn't exist and it might be prudent to reorient the horn to the east or upward.

With a radio receiver that could be activated by the police dispatcher or OEC center, the horn could be used to notify the residents of an impending disaster by combining it with TV city channel 3. For instance: In case of extreme brush fire, with down slope, 'sundowners' or North winds, to warn of possible flying fire brands, notifying residents to close garage doors and openings; not to 'water down' more than 20 minutes before feeling the heat, as it evaporates and could needlessly overtax the water system. Also think about the remote, but possible, break in the MWD pipe line that runs down Liliano and across the length of Grandview, at elevation approximately 900, (Baldwin and Sierra Madre elevation 832), crisscrossed by fault lines.

Then there is a possible failure of the hillside panels (surplus airstrip landing mats from World War ll) installed many years ago by volunteer firefighter Tom Burris, Ambose Zarro (the 'Trailmaster'), and other volunteers, to retard mudflow, from portions of the Mt.

Wilson Trail and outcroppings. With the recent brushfire, this

could be a likely possibility with heavy rain.

Undoubtedly, years from now, scientists will be able to predict earthquakes with a few minutes warning and what an asset this system would be. The uses of the horn, combined with our city television channel, for emergency notification is almost endless.

At a recent meeting the local Kiwanis Club, which has been associated in the past with the horn, pledged funds to refurbish and reactivate this 75-year-plus tradition, if the city will put it back in service. It is an audible tribute to our volunteer firefighters, who in its 85 year history have never lost a house to a brush fire. Few cities that interface with brush lands can make this claim. Unfortunately we have not been as fortunate with mudflow.

## Environmentally Speaking, Did You Know? Fight The Bite by Pat Birdsall

(Being a human smorgasbord for mosquitoes, I was quite interested in a special report by Karen Ravn, which appeared in the L. A. Times this past Sunday.) She spoke with Jerry Butler, an entomologist at the University of Florida in Gainesville, about understanding how mosquitoes find us, what repellant to wear, and the mosquito myths and

Mosquitoes are lured by every breath you take. Or rather with every breath you let out. They track you down by the carbon dioxide you exhale. They also zone in on body heat. In a group of 10, there's one person on average who mosquitoes will prefer. There's also one person the mosquito will turn

Butler offers four ways to try to outsmart them. 1- Don't go out at dawn or dusk. Those are happy hours for mosquitoes. 2- Wear clothes that cover as much skin as possible. Clothes treated with permethrin, an insecticide sold at outdoor stores such as REI and Adventure 16, are especially useful. You can buy pre-treated clothes at www.magellans.com or www.llbean.com 3-Wear repellent. The standard has long been the chemical popularly known as DEET. The higher the concentration, the longer the product lasts, but the federal Centers for Disease Control and Prevention suggest using the lowest concentration that works for your needs—usually under 30%. Though DEET doesn't harm mosquitoes, some worry that it can harm people who use it. After a safety review in 1998, the EPA concluded that DEET does not pose a health risk to people as long as they follow label directions. The only natural repellent the CDC rates as effective as DEET is oil of lemon eucalyptus. Repel and Cutter make lemon eucalyptus sprays. Many other natural products—with active ingredients extracted from catnip, celery, geraniums, soy beans and tomatoes—are proven effective, though not always as long lasting. Exactly how these various compounds work isn't known. Perhaps because they are plant- based, mosquitoes think the wearer is a plant. 4- Take along one of those people mosquitoes go mad for. (No phone calls please).

Myths vs. Reality

Myth: Taking large doses of Vitamin B, B-1, B-6 or B-12 causes the skin to exude an odor that wards off mosquitoes. Reality-Uli Bernier, a research chemist in the Mosquito and Fly Research Unit of the USDA Agricultural Research Service in Gainesville, Fla., tested the vitamin B theory. "We dosed ourselves so high you could smell us, he says. Verdict: The mosquitoes still bit. Myth: Tying a sheet of Bounce fabric softener through a belt loop or rubbing one on your body keeps mosquitoes away. Reality: No such luck, Bernier says. "I walked around with sheets flapping from my arms," and the insects still bit. Myth: Eating lots of garlic or taking garlic supplements repels mosquitoes. Reality: Bernier found garlic had no effect, and as did a study at University of Connecticut Health Center. Myth: Mosquitoes can't bite through clothing. Reality: They can! According to Bernier who has developed repellent-treated clothing for the U.S. Army and Marine Corps, "It is quite evident that they can even bite through thick uniforms where there is insufficient or no repellent present." Clothing may, he concedes, make biting a little more difficult for them. Karen Ravn





## Pit Bull Ordinance Bites

Although an ordnance passed last March requiring all pit bulls and pit bull mixes in the city to be sterilized should have taken effect in May, the city council instead asked the Public Safety Committee to review whether it was feasible to extend the law to all dog rather than just one breed.

Tuesday night the committee could not agree. Council member Steve Madison made a motion in favor of expanding the ordnance but after a number of animal groups protested the idea Council member Jacque Robinson said she

would not support that. It needed three votes to pass. Council member Steve Haderlein had to leave early limiting the commission to just the three members

They moved the issue forward to the council without action.

Robinson said she had a pit bull living at her home and that the perception of them was wrong. She said they were not aggressive unless they were trained to be so. Madison disagreed saying they needed this law before someone got

are going to have a child or a senior or someone else killed by these dogs." He said.

Madison also said he has kept a file on all fatal dog attacks that he hears about in the state. Most he said were pit bulls.

Pasadena Humane Society & SPCA President Steven McNall simply said the shelter could not handle the load if the ordnance applied to al dogs.

"Low income sterilization is booked 10 weeks out, we can't handle the volume and our fear is that if an ordnance is enacted, whether it's one breed or all dogs, we will become so inundated that people won't want to be fined and dump their dogs on the street." He said adding that it would also "put undue pressure on us and the officers for enforcement,"

He said their policy now is to spay or neuter any pit bull that comes into the shelter.

To make matters worse he said more animals were showing up at the shelter now because of the sluggish economy. Humane Society spokesperson, Ricky Whitman said yesterday that they had 1,000 more animals form this time last year.

## IndyMac's Collapse Hits Close To Home

Uncertainties in local government, over the takeover recent Indymac Bank by the Federal Deposit Insurance Corp Friday, started immediately almost Monday night as a number council members voiced concern including Councilmember Chris Holden who said they may see a rise in homelessness.

'This could create a lot of impacts on the infrastructure of this government if it plays out in a very traumatic way," he said. "It looks like it might be going down that path. To that end, does it mean that our homeless population is going to grow even more? What do we do to address that,"

Passionate, he went on, "what are the resources that we start to identify, to be responsive, to this new place we find ourselves

Mayor Bill Bogaard said the city's 10 year plan to end homelessness had not been reviewed since it was adopted a few years ago.

"It seems quite appropriate for us to have a discussion about the challenge of homelessness particularly in relation to these uncertain economic circumstances." He said.

Others asked what economic impact it could on centralized have Pasadena businesses dependent on the income that will be lost due to the lay-offs of thousands employees. It had been reported that the bank's staff has been slashed down to 500. Last week over 3,500 jobs were cut and FDIC regulators said Monday those layoffs will

still take effect. "I remember just a couple of years ago when I was Vice Mayor I spoke at the opening of their new headquarters at Walnut and Lake," Council Member Steve Madison said. "I remember it was such an upbeat event and it was a bank and a company with so much promise, with 1,000 of employees. At it apex it had 32 billion in assets."

Madison went on to say the current situation reminded him of the old "run" on the bank. He said it was very unfortunate that the situation was associated with Pasadena.

"Customers and depositors trying to get their money out, all of the TV News vans were there, and this is a huge story all over the country and probably all over the world," he said. "And it's unfortunate every one of those story talks about Pasadena California based the situation.

IndyMac.

Madison also asked that city staff bring back a report on the city's roll, in what he called, "the feds takeover of the bank." He added that they needed to know what to do with, if at least, the building that now houses the bank. Holden asked that the whole thing be reviewed by a lower committee.

A press release from 2006 stated that IndyMac added 90,000 square feet leasing a total of 180,000 square feet in the completed IndyMac Bank Center on Walnut Street. At the same time EHarmony.com Inc. took 48,000 square feet bringing the building to nearly 100 percent occupied. A branch office of Crowell Weedon was also established on the site.

Two years ago EHarmony. com was the first to move out which had an impact.

Tom Tate and his wife Francie own On the Plaza Café in the Gateway Plaza, located ironically in the same spot EHarmony vacated. Since departure of EHarmony and the current economic slump occupancy of the Gateway building has stagnated and Tate's business has been affected by the loss of sales.

"When EHarmony moved out of our building they had over 200 employees, so that certainly was felt by us," said Tate. "That decreased our customer count by a great percentage and it definitely hurt our sales."

Tate speculates that the Ralph's Grocery store across from IndyMac will be the most affected by the layoffs. As it is in his building, many employees have been flocking to the newly remodeled store to do shopping during their breaks.

"I certainly know that Ralph's got a lot of business from them," said Tate. "They have the deli and all the other items for people to take home, so they will definitely feel the difference from the empty spaces that IndyMac once occupied in those two buildings."

A security guard that chose to be unnamed works at a neighboring parking structure. He shared that what was once an overflow from the IndyMac parking will now create an economic void to the surrounding structures that once facilitated and relied on IndyMac to fill their lots.

Interim City Manager Bernard Melekian said after the meeting the city had no financial connections to the bank. During the meeting he said he would bring back a timeline for a review if

With a modified Mercedes Benz running on used vegetable oil, Larry Redalia and his wife, Debra Lynn, set off Monday driving back from Pasadena to Florida after looking around at the city's housing market for a new home. One is that government regulations require fuel sellers to be licensed although the couple said the oil they get is used and free from restaurants that would otherwise have to pay to dispose of it.

"I have a couple of restaurants that I go eat lunch and they give me the oil, its great," Redalia

said." Regulations have led some skeptics to argue used vegetable oil could never be used as an alternate fuel to diesel.

vehicles on public roads use fuel that has been taxed and laws also require a permit to transport waste materials, which makes this fuel source, difficult to transport in large quantities.

"We have only hear that there might be some taxes that might need to be paid," Dadd said as Redalia quickly explained, "We don't refine the fuel we just put the oil through a system like I have over here which is essentially a pillow case and a bucket. Ît's very low-tech."

He continued saying that no toxic chemicals are used whatsoever. They also said they plan to abide by all laws.

In other states drivers using vegetable oil have been threatened with fines and even jail. Last year an Illinois couple made news when they were asked by the states Department of Revenue to post a \$2,500 bond and threatened with felony charges. They also had to apply for a license as a "special fuel supplier"

Dadd said the problem really is also that more people don't know about it. She also said they plan to fully research California laws for using alternative fuels. California is known as a biofuel-friendly state with the AQMD pumping millions of dollars into research.

"It burns clean," Dadd said. "So it's tremendously cutting down on emissions. So it is an environmental recycling thing but it's also a health issue and helps keep the air clean."

The couple said they will make stops in Las Vegas, Nevada; Boulder, Colorado; Topeka, Kansas; St. Louis and Kansas City, Missouri; Nashville and Chattanooga, Tennessee; and Atlanta, Georgia.

At each stop Dadd said they plan to hold a press conference to bring awareness alternative fuels. She said they have already made arrangements with a number of local television stations wanting to air their story.

## PUSD Adopts Board Protocol Proposal By Teresa Baxter

The Pasadena Unified School District held a special meeting last week to move forward in formulating a specific guide-line of protocols for board members to fol-

line of protocols for board members to follow. It was shared that recently an outside consultant participated in a brainstorming session to document key issues that would be designated as protocols.

Key topics and principles included board member interaction with the public at board meetings. The board agreed that their meetings are to be held in public, but they are not "town hall meetings" where the elected officials and community engage each other in an unstructured manner. Therefore, public input into the business of the board will be structured in a manner that balances the public's "right" to adner that balances the public's "right" to address the board and the boards "right" to conduct the meeting in a productive and efficient manner.

Protocol specifically stated that the board needs to allot a maximum of 30 minutes per agenda item and cumulatively for all non-agenda items. Each speaker will be allotted a maximum of three min-utes. Previously, the allotted time of three minutes was not adhered to due to the fact that many of the audience would sign-up

for public comment and then defer their time to a single speaker, who would then talk for up to fifteen minutes, said board member Ed Honowitz.

"New protocol will make it the responsibility of the current president to manage the public comment period in a fashion that ensures an open and inclusive forum conducted within accepted meeting deco-rum standards," said Tom Selinske, president of the board.

The protocol document went on to state that the board president, sensing the "will of the board" may at his or her discretion, exceed the 30 minute allotment; or make other modifications of the public comment period and process to accommodate special circumstances consistent with the board's stated principles.

"My interest is to make sure that everyone is heard and that we are able to conduct our business as a meeting in pub-

lic—not a public meeting," said Selinske.

Other topics that are being incorporated into protocol standards include board deliberation, the role of the board president, and board member response to community complaints.



## Shall We Laugh or Cry?

laugh (v): to find amusement or pleasure in something; cry (transitive verb) to express deep sorrow usually by shedding tears

Well, I think I have finally cured myself from working with the television

on in the background. Earlier this week, as I was putting this paper together, POTUS (President Of The United States), George W. Bush, held a press conference. And, contrary to the wise lady that sits on my shoulder and guides me, I decided to listen. BIG MISTAKE. By the time the speech was over, I didn't know whether to laugh, cry, send him a Berlitz tape on English, send him a chronology of events over the last seven years, arrange a face to face talk with a few of the people who are suffering because of his policies, move to France or stick my head in the sand like so many other Americans! POTUS: What about them -- do I think they're investing capital to find more reserves with the price at \$140 a barrel? Absolutely.



A buddy of mine said, well, what about the reefs? So I'm concerned about the reefs. I'm a fisherman, I like to fish, reefs are important for fisheries. But the technology is such that you can protect the reefs. You don't have to drill on top of a reef. You can drill away from a reef and then have a horizontal hole to help you explore a reservoir.

It's like in Alaska. You know, in the old days, you would have had to have -- if you ever go out to West Texas, you'll see, there's like a rig every 20 acres, depending upon the formation. A team from Texas State University has revised the date of Julius Caesar's invasion of Britain in 55 BC-a transformational event in world history. "Despite what most history books state, Caesar could not have landed on August 26–27—the English Channel was flowing the wrong way," says team leader Donald W. Olson, a tide expert.

He and fellow professor Russell Doescher, aided by astronomy honors students Kellie Beicker and Amanda Gregory, reached this conclusion during an expedition to England's southern coast last summer. Earlier, Olson had identified August 2007 as a rare opportunity to settle the longstanding dispute among history scholars and scientists concerning Caesar's landing. During that month, complex tidal factors involving the Moon and Sun would unfold in a near-perfect replay of those in August of 55 BC.

"We realized we could go out in a boat and observe the current for ourselves," Olson explains. "The year 1901 would have been just as good for this experiment, but no one noticed."

According to Olson's team, Caesar's invasion fleet must have arrived four days earlier—August 22–23 in 55 BC—to have acquired a suitable northeastward current. The revised date reconciles an ancient record of a "falling tide" with Caesar's own description of the coastline topography as he moved his fleet along the white cliffs of Dover. The Texas researchers present their findings in the August 2008 Sky & Telescope magazine.

When his 100 warships carrying two Roman legions (perhaps 10,000 men) approached the white cliffs, Caesar noticed a multitude of javelin-wielding Celtic warriors lined up along the ridge and decided to look for a better landing spot. He ordered his fleet to move along the coast, and after about seven miles they came to "an open and flat shore."






Sometimes the best places are right in our own backyard. The grass isn't especially greener elsewhere - it is only the elsewhere

Recently, Teresa and I wanted a place to sit and talk and just be together. We enjoy the restaurants and coffee houses of Sierra Madre - you know, 323, Italian food, pizza, Mexican food, Bean Town, etc. But we wanted to be somewhere where we wouldn't have to leave at a certain time, and where we could talk without the chatter of the urban mob right

It was still light when we walked up to the flat large expanse of the monastery, which seemed like a good place to be. We walked around looking for a spot to sit. From a distance, the large expanse seemed like a lush lawn, but in fact, it was very dry, full of gopher or ground squirrel holes, and grown over with a low layer of mustard, turkey mullein, and bristly sticky thistles. We walked a bit, looking for the "just right" spot - out of the way, with a view, private but not isolated. We walked towards the large ficus tree and decided that would be the ideal spot. I laid down a tarp and we sat there in the cool of the early evening. There were no lights yet in the distant city, but little by little they came

The atmosphere under the ficus tree was magical, because ripe "figs" dropped at a rate of one every 10 to 30 seconds, a slow rainfall of ripe fruits, landing loudly onto the groundcover of dry leaves. We tasted one - these were tiny fruits and not very sweet.

We hadn't seen one another for a few days and there was much to talk about. But it seemed that a certain calmness and peacefulness descended upon us there in the mantle of the monastery. We talked, but softly, about

issues and challenges in each of our lives. We were observers of the great movie screen of the panoramic city below us, as little by little lights went on. But while still light enough to see well, we noted a teenager enter the field and do something around the

Mary statue out in the lower field. We figured he was probably looking for change that other people left there as an offering. Why else would he use a flashlight? What else would he be looking for? He suddenly seemed to notice us, and he looked in our direction for a long time, probably studying the view under the tree to determine if there actually were two people observing him. Then he turned away, searched around the statue more with his flashlight, and then turned off his flashlight as he walked away.

'What a loser," said Teresa.

Darkness slowly descended. We noted some large flashes of light, way to the southwest, and wondered if they were post-Fourth fireworks. We later learned they were lightning flashes.

We sat there sharing dried persimmons and bottled water, our discussion switching between trying to identify a distant object, to some point about what we did the previous week.

In an hour and a half since we arrived, it was completely dark and we noted a slow figure to our north. We remained motionless and watched as a deer grazed remarkably close to us, and then another. It seemed to know we were there, for we didn't stop talking or alter our volume. Maybe they were used to people. Maybe the reward of all the fallen ficus fruits was too attractive. They wandered off, and then back again, seemingly unconcerned about our presence.

The deer's motions were slow yet thoughtful, even though we could only make out its form in the dark. It was very different from the motion of the coyotes who surrounded us on our last visit in the dark, who ran around us in erratic, excited circles until I jumped up and stomped towards them as they disap-

peared into the darkness. After a little longer, dried persimmons all gone, we packed up and headed home. It was an enjoyable evening, where we could slow down and listen to ourselves as people were meant to do. I have had less calm times in the mountains and wilderness, and so it was refreshing to remind myself that it is not where we go that matters, but what we do, and how we do it.

The Dog Days of Summer:

Recipe of the Month: Simple Crostini 1 baguette (8 to 10 ounces)

¾ cup olive oil- (For an extra layer of flavor, use a garlic or herb infused oil) coarse salt and ground pepper. 1-Preheat oven to 350. Arrange baguette slices on two large rimmed baking sheets: brush both sides with oil,

and season with salt and pepper.

2- Bake until golden, 15 to 20 minutes, rotating sheets halfway through (If undersides are not browning, turn crostini over once during baking.) Let cool on baking sheets. (To store, keep at room temperature in a resealable plastic bag, up to one week.) Top crostini with desired toppings and serve.

A Trio of Toppings: White-Bean and Caper

In a bowl, combine one 15 ounce can cannellini beans, rinsed and drained, with  $\frac{1}{4}$  small red onion, minced, 1 Tbs. capers, rinsed, 1 Tbs. olive oil, and 1 Tbs. whitewine vinegar. Mix, mashing beans slightly; season with coarse salt and ground pepper.

In a bowl, combine 1 pint chopped grape or cherry tomatoes with ½ cup chopped fresh basil leaves, i Tbs. olive oil and 1 tsp. red-wine vinegar; season with coarse salt and ground pepper.

In a bowl, combine two 14-ounce cans artichoke hearts in water, rinsed, squeezed to remove excess liquid, and chopped, with 1/3 cup light mayonnaise, 2 Tbs. fresh lemon juice, and 2 Tbs. chopped fresh dill; season with coarse salt and ground pepper. Each recipe yields enough to top 30 crostini. Feel free

to mix and match! (everydayfoodmag.com)






