# Eight+ Hour Standoff Ends Peacefully By Bill Coburn

According to Police Chief Marilyn Diaz, "primarily, what drew us to the location was that we had physical evidence linking him to a car theft here in Sierra Madre...So the officers went up to do a very casual door knock.... to see if he would come out and they could make a relatively low-key arrest." At 11:50 a.m., two Sierra Madre Police officers arrived at 39 Windsor Lane but the suspect, 36-year old Roberto "Pancho" Funston, walked out the back door to his home, and upon seeing an SMPD detective out back, went back in and barricaded himself, refusing to come out.

Despite requests heard blocks wanted to find away from the public address a system of a Pasadena Police Dept. helicopter that he come outside and talk to the police, Funston stayed inside, barricaded with two pit bulls. According to Chief Marilyn Diaz, the home belongs to his mother, and Funston has been living there off and on during the last year.

Chief Diaz said Funston had a prior criminal record, but she declined to state his record citing

Asked about rumors that had been heard downtown during the day that the reason for the length of the standoff was that Funston would have, if convicted of either the narcotics or grand theft charges, been facing a "third strike" conviction and sentenced to life in prison under California law, Chief Diaz said that "in checking the suspect's criminal history, there was nothing in there to suggest he was a second or third striker."

"As we spoke to witnesses, we learned that he had made some adding that finally the serious threats that could have jeopardized the lives of public inside the location and safety officers as well as the public, the suspect came out so it left us with little choice but to move in and take the steps we did, by enlisting the assistance of the LA County Sheriff's Dept. to SMPD, which took Special Enforcement Bureau him to LA County Jail. success, the tactical operations were turned over to the LA County Sheriff's SEB. This was done sometime around 5:30 - 6pm, said Diaz. ### Suspect Has Long History Of Run-Ins With The Law

Since at least 1992. Roberto Funston, 36, has been in and out of jail. Funston has no less than nine other arrests and/ or convictions with the most recent being December, 2007. charges range from Possession of a Pipe and Drug Paraphernalia, to Receiving Stolen Property, Carrying a Concealed Weapon, Possession of Narcotics for Sale; and Battery on a Spouse.

Earlier this year he was convicted on yet another drug charge and was scheduled to be sentenced in the early part of May. He failed to return to court and a warrant was issued for his arrest on Thursday.





# **ORDINANCE NO. 1278**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SIERRA MADRE AMENDING ARTICLE 5 OF THE SIERRA MADRE MUNICIPAL CODE BY ADDING CHAPTER 5.34 REGARDING STATE VIDEO FRANCHISES OPERATING WITHIN THE CITY

WHEREAS, the Legislature of the State of California (the "State") has adopted the Digital Infrastructure and Video Competition Act of 2006 ("DIVCA");

WHEREAS, the DIVCA became effective on January 1, 2007;

WHEREAS, the DIVCA establishes a regulatory structure for the State to issue franchises to video service providers;

WHEREAS, the DIVCA establishes that local entities, such as the City Sierra Madre (the "City"), are responsible for administration and implementation of certain provisions of DIVCA;

WHEREAS, the DIVCA requires that the City establish, by ordinance, financial support provisions for Public, Educational and Governmental ("PEG") channel facilities; and

WHEREAS, the DIVCA requires that the City adopt, by ordinance or resolution, a schedule of penalties for any material breach by a State video franchise holder for violation of customer service and protection standards that the City is permitted to enforce.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIERRA MADRE DOES ORDAIN AS FOLLOWS:

Article 5 of the City of Sierra Madre Municipal code is hereby amended to add a new Chapter 5.34 Section 1 as set forth in Exhibit A to this Ordinance.

Severability. Should any provision of this Ordinance or its application to any person or property be found by a court of competent jurisdiction to be invalid or unenforceable, the remaining provisions hereof shall be enforceable according to their terms and to that end the provisions of this ordinance are severable.

<u>Section 3</u>. Construction. To the extent the provisions of the Sierra Madre Municipal Code as amended by this ordinance are substantially the same as previous provisions of that Code, those provisions shall be construed as continuations of those previous provisions and not as new enactments.

Section 4. Publication. The City Clerk shall cause this Ordinance to be published or posted in accordance with California Government Code Section 36933, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the City Council.

**EXHIBIT A** 

Sierra Madre Municipal Code Article 5 Regulation of Businesses and Franchises

Chapter 5.34 State Video Franchises

#### 5.34.10 Purpose and Application of this Chapter

This Chapter is designed to regulate video service providers holding state video franchises and operating within the City of Sierra Madre. On January 1, 2007, the state of California became the sole authority with power to grant state video franchises pursuant to the Digital Infrastructure and Video Competition Act of 2006 ("DIVCA"). Pursuant to DIVCA, the City of Sierra Madre shall receive a franchise fee from all state franchisees. In addition, the City shall receive from all state franchisees fees to support public, educational, and government access channel facilities. DIVCA confirmed that the City may establish and enforce penalties, consistent with state law, against all state video franchise holders operating within the City for violations of customer service standards. DIVCA precludes the City from adopting its own standards and grants all authority to adopt customer service standards to the state. DIVCA leaves unchanged the City's authority to regulate the City's current cable franchises and any City cable franchise(s) issued on or before January 1, 2008, until the

### 5.34.20 State Video Franchise Fees and Fees for Public, Educational and Governmental (PEG) Access

- A. Any state video franchise holder operating within the boundaries of the City shall pay a fee to the City equal to five percent (5%) of the gross revenues of that state video franchise holder.
- B. Effective the first date on which state franchisees begin operating within the boundaries of the City, each state franchisee shall pay a fee to the City equal to one percent (1%) of gross revenues ("PEG Access Facilities Fee") of that state video franchise holder to support public, education, and governmental (PEG) access channel facilities within the
- C. The PEG Access Facilities Fee shall be paid quarterly no later than the sixty (60) days following the quarter for which the payment is due. The PEG Access Facilities Fee is in addition to the franchise fee to be paid to the City by the
- Gross revenue, for the purposes of subsections A and B of this section, shall have the definition set forth in California Public Utilities Code Section 5860.

## 5.34.30 Audit Authority

Not more than once annually, the City Manager or his designee may examine and perform an audit of the business records of a holder of a state video franchise to ensure compliance with Section 5.34.20.

## **Customer Service Penalties**

- Any holder of a State video service franchise shall comply with all applicable state and federal customer service and protection standards pertaining to the provision of video service.
- The City will provide any holder of a State video franchise written notice of any material breach of applicable customer service and protection standards, and will allow the franchise holder at least thirty (30) calendar days from the receipt of the notice to remedy the specified material breach. A material breach that is not remedied by the State video franchise holder within the remedy period shall subject the State video franchise holder to the following penalties to be
- For the first occurrence of a material breach, a penalty of not more than five hundred dollars (\$500) for each day of each material breach, not to exceed one thousand five hundred dollars (\$1,500) for each occurrence of a material breach.
- 2. For the second violation of the same nature within twelve (12) months, a penalty of one thousand dollars (\$1,000) for each day of each material breach, not to exceed three thousand dollars (\$3,000) for each occurrence of the
- 3. For a third or further violation of the same nature within twelve (12) months, a penalty of two thousand five hundred dollars (\$2,500) for each day of each material breach, not to exceed seven thousand five hundred dollars (\$7,500) for each occurrence of the material breach.
- Any notice and any penalty may be issued or imposed by the City Manager, or the City Manager's designee. Any notice shall be in writing. Notices shall be transmitted by United States Postal Service certified or registered mail, return receipt requested and postage prepaid, or by private commercial delivery or courier service for same day or next business day delivery with delivery and receipt signature required.
- D. The State video service franchise holder may appeal any finding of material breach or imposition of penalties to the City Council. Any appeal must be made within thirty (30) calendar days of receipt by the State video service franchise holder of the finding of material breach or the imposition of penalties, and must be submitted in writing to the City Clerk and the City Manager in order to be placed on a City Council agenda for consideration. Any appeal must contain a detailed explanation of why the applicant believes that the finding of material breach or the imposition of penalties was inconsistent with statutory requirements.
- The City and any State video service franchise holder may mutually agree to extend the time periods specified herein. Any such agreement shall be in writing and executed by the City Manager, or the City Manager's designee, and an authorized representative of the State video franchise holder.
- F. Any penalty imposed on the State video franchise holder shall be paid to the City. As provided for in Section 5900(g) of the California Public Utilities Code, the City shall submit one-half of all penalties received from a State video franchise holder to the Digital Divide Account established in Section 280.5 of the California Public Utilities Code.

## 5.34.50 Procedures for Appeal of Denial of an Encroachment Permit

- As provided for in Section 5885 of the California Public Utilities Code, the City shall either approve or deny an application from a State video service franchise holder for an encroachment permit within sixty (60) days of receiving a completed application.
- An "encroachment permit" means any permit issued by the City relating to construction or operation of facilities relating to the provision of video service under a State video service franchise.
- C. An application for an encroachment permit is considered complete when the applicant has complied with all statutory requirements, including the California Environmental Quality Act (CEQA) of the Public Resources Code.
- D. Any City denial of an application for an encroachment permit shall be in writing and shall contain a detailed explanation of the reason for the denial.
- E. An applicant whose application for an encroachment permit has been denied may appeal the denial to the City Council. Any appeal must be made within fourteen (14) calendar days of receipt by the State video service franchise holder of the denial, and must be submitted in writing to the City Clerk and the City Manager in order to be placed on the City Council agenda for consideration. Any appeal must contain a detailed explanation of why the applicant believes that the denial was inconsistent with statutory requirements.

### Environmentally Speaking, Did You Know? By Pat Birdsall

Having a three-year-old grandson lving in Philadelphia, I make frequent trips to the Post Office to mail him things that he absolutely doesn't need. I like to keep the receipt handy until I know the package has gotten to its destination safely. On this particular day, something on the receipt caught my eye... It was a promo for a new recycling program

started by the Post Office. I went to their website and found the following information: March 17, 2008-- Washington, DC-Free and green. Those are the goals of a pilot program launched today by the U. S. Postal Service that allows customers to recycle small electronics and

inkjet cartridges by mailing them free of charge. The "Mail Back" program helps consumers make more environmentally friendly choices, making it easier for customers to discard used or obsolete small electronics in an environmentally responsible way. Customers use free envelopes found in 1,500 Post Offices (including Sierra Madre), to mail back

inkjet cartridges, PDAs, Blackberries, digital cameras, iPods and MP3 players without having to pay postage. Postage is paid for by Clover Technologies Group, a nationally recognized company that recycles, remanufactures and remarkets inkjet cartridges, laser cartridges and small electronics. If the

electronic item or cartridges cannot be refurbished and resold, its component parts are reused to refurbish other items, or the parts are broken down further and the materials are recycled. Clover Technologies Group has a "zero waste to landfill" policy. There is no limit to the number of envelopes customers may take. The pilot is set for 10 areas across

the country, but could become a national program this fall if the pilot program proves successful. The Postal Service recycles 1 million tons of paper, plastic and other materials annually. Last year, USPS generated more than \$7.5million in savings through recycling and waste prevention programs. The nation's environmental watchdog, the Environmental Protection Agency (EPA) has awarded the

Postal Service eight WasteWise Partner of the Year awards, the agency's top honor. The Mail Back program is another example of the Postal Service's commitment to sustainability. More than half a billion packages and envelopes provided by the Postal Service annually are nearly 100 percent recyclable and are produced with the least harmful materials. Based on the recycled content of these envelopes and packages, more than 15,000 metric tons of carbon equivalent

emissions (climate change gases) now are prevented annually.
So, stop in to get your envelopes at the Sierra Madre Post Office and say hello to Liz and the other friendly and knowledgeable employees.





# Parking Enforcement Gregory Sawyer a representative of SEIU alleged Inter-Con has a history of sexual harragement. He said that Spite of Complaints

Inter-Con Security Systems Inc emerged victorious from Monday night's city council meeting with a one year contract extension for parking enforcement but not before a number of council members questioned dubious business practices including giving spurious tickets.

Last month the council was set to enter into a contract with Serco, Inc. for the enforcement services ending a 13 year one with Inter-con. They instead reset the bidding process. Councilmember Margaret McAustin asked for a much shorter extension than 12 months after hearing numerous about the completes company.

"I just think a year's too long," she said. "I think it's sending the wrong message to the community and to the applicants." She asked for only a six month extension while they searched for a new provider. Councilmember Victor Gordo agreed.

Interim City Manager Bernard Melekian said he was worried about a gap in enforcement. City Attorney Michele Bagneris said the Inter-Con contract had already ended June 30.

He said they needed at least a year to make any smooth transition to a new company. He explained the bidding process would take nine months and then they needed another three months to get the new company ready.

Fred Dock, Director of Transportation for the city, said there had been a large number of citations issued in error. He said one officer, in two separate occasions, was issuing tickets erroneously. Inter-Con said the person had been fired although numerous other residents also complained.

One resident said a guest she had over last Thanksgiving was given a ticket for street sweeping,

"You don't clean the streets on holidays, do you?" she asked. City staff said no. Mayor Bill Bogaard said this concerned him.

Another resident said he was given a ticket in a two hour parking zone although he was there no longer than 10 minutes. He also said it was impossible to contest the ticket.

Overnight parking was another problem. Residents said they had been given tickets even though they had overnight parking passes.

A number of people said at night there is no one to call about parking. There had been in the past and city staff, recognizing the problem, said they would make that part of any new contract.

Councilmember Steve Madison argued saying that Inter-Con was not all to blame.

"This Business is located in my district," he said. "We have their attention, and in the course of getting their attention we've discovered that we could sort of reorganize our own house."

Vice president of Inter-Con, Catherine Ross, defended all allegations saying the company was trying to better its image.

During the meeting a number of people referenced news reports saying the company paid \$4 million to 15,000 employees earlier this year for back pay. They also paid out \$2.5 million for claims that workers were not being given adequate

"We settled a couple of these class action charges that were brought to us," she said. "With no guilt on the company's part."

Ross also said Inter-Con was being illegally targeted by the Service Employees International Union (SEIU).

"We filed an injection against them [SEIU] for this illegal campaign," she said. "The National Labor Relations Board agreed with us and said in fact what they were doing was

harassment. He said the company had been sued 22 times in the last eight years He said they are a repeat offender of state wages and hourly laws. He said the lawsuits ranged from discrimination to wrongful termination.

Ross also made note that Councilmember Jacque Robinson removed herself from the conversation being affiliated with the SEIU. Ross said most of the negativity surrounding the company steamed from them.

She also said the company was 100 percent "minority owed" and that they do not discriminate. She added that 70 percent of their employees were also "minorities."

The company's Vice President of Operations also told the council Intercon had no quota for giving tickets. Councilmember McAustin Margaret had asked if they did repeatedly and Mayor Bill Bogaard wanted an answer as to why they had written so many tickets in the last year.

"So the question is, are they more violations, are there more employees on the streets? Bogaard asked.

The company blamed the city saying they had streamlined the process. A representative said by installing multi meters they were able to issue many tickets at a single terminal, "as a citizen that would be unfortunate, if you're on the receiving

He said the city should educate people on the multi meters.

The same representative also said earlier, "The concerns of the citizens are the concerns of myself, I have gotten citations parked in the city, and they don't make me happy."

Towards the end of the meeting Melekian said he thought the city should step up parking enforcement not the other way around.

"There is a case to be made that we could be far more aggressive than we are," he said adding that parking citation revenue this year will be close to \$6 million.





She also noted that RBF Consulting had been paid in excess of \$300,000 for work on the DSP including the draft EIR and said she wanted to see what we paid for. Ok, maybe that is sufficient, but I think it should have been handled more like we rear our children. Yes, after all of your other work is done, you can do this. In other words, after we take care of the things that have an immediate impact on the city right now, we will have time to look into this if you so desire. But not now, we have too many other relevant, important matters that need attention.

Without question, the issue of 'trust' is at the forefront of everyone's mind, regardless of what side of the issue they are on.

John Gillison, former City Manager, along with then City Attorney Michael Coluntuono were notorious for policies that sitting councilman, had not been privy to the document (although Gillison did tell Zimmerman that he could drive down to RBF and look at it if he really wanted to see it). The high handed manner in which the city was run at that time, certainly made one wonder what the real story was behind the scenes. Sometimes it is a good thing to know when you have won. It is clear that the new majority on the council is in control. Measure V passed. Those who championed the release of the draft EIR wanted change. They got it. So why waste precious time rehashing yesterday's mistakes?

# Republicans Finally Have A Winning **Issue -** But will they make

the most of it? By Hail Hamilton

I know a winning argument when I see one and Democrats have given Republicans a huge one, an issue that could succeed this November. It starts with the high price of gasoline, the single most infuriating issue with voters these days.

Democrats are not being blamed for causing the price of gasoline to exceed \$4 a gallon. Rather they have failed in their campaign to persuade the public that the American oil industry is the chief culprit. A Gallop/ CNN poll in May found only 20 percent of potential voters still blame the oil companies for gouging, down from 34 per cent a year ago.

Democrats are especially because vulnerable promised a "common sense" program in the 2006 campaign to curb gas prices. They have yet to produce one, and the price per gallon has risen by more than \$2 since Democrats took control of Congress in January 2007.

Democrats have also insisted on pushing a global warming bill that if enacted will further boost the price of gas and rake in trillions of dollars in revenue. Encouraging Americans to conserve gas and develop alternative fuels might have made sense a year ago, but not now with the public anger

over \$4 plus a gallon gasoline.

Republicans, on the other hand, have succeeded selling their solution for the high price of gas is drilling offshore and on protected federal lands, areas now off limits. Support for drilling in precisely these areas jumped from 41 percent in 2007 to 57 percent in May.

As a result, an amazing role reversal has occurred on Capitol Hill. Republicans, once fearful of the climate change issue, are now demanding more debate in Congress on global warming legislation. Democrats, who had earlier promoted the legislation as a top priority, have turned squeamish and have dropped the issue before it could do serious political harm.

Both House speaker Nancy Pelosi and Senate majority leader Harry Reid have portrayed global warming as the greatest threat facing America today. In fact, Pelosi was so concerned that, shortly after taking charge of the House, she vowed to bring

warming bill the floor July

2007. Now, though, she's unlikely to schedule it for debate and a vote in 2008.

Spotting the opening, House Republican leader John Boehner has made Pelosi his chief target on gas prices. He has needled her week after week since January, calling her global warming bill "Pelosi's premium." -- the portion of the gas price increase which he attributes to her inaction.

It's not only Democrats who are on the defensive. Environmentalist have also been taking a beating lately in Washington and, for the moment at least, have emerged as a potential liability for the Democrats. Their opposition to any effort to slash gasoline prices or begin drilling on federal lands make environmentalists an unattractive ally.

On gas prices, Republicans have been the beneficiary of a political windfall. The question is whether they can make the most of it. The answer is uncertain and the reason is John McCain. McCain vehemently opposes drilling for oil in the Alaskan National Wildlife Preserve (ANWR), though he has come around on increased domestic production in other areas (except off the coast of Florida). Flipping on ANWR may be too much for McCain, though doing so would be consistent with his national security argument against U.S. dependence on Middle East oil.

There's a broader issue than gas prices and oil production. The public's main complaint, identified in poll after poll, about a Democratic Congress is INACTION! Congress has ABSOLUTELY NOTHING!

Energy is just one of the huge issues facing the nation on which Democrats have failed to act. There's also the economy, immigration, education, health insurance, Social Security, Medicare, Medicaid, home foreclosures, tax reform, and the

war in Iraq, just to name a few.

Will high gas prices work for

An updated Housing Element is necessary that provides housing options, including identification of opportunity sites for new housing and creative solutions to providing all housing types in Sierra Madre, especially affordable housing. # TABLE FOR TWO By Peter Dills Summer BBQ Tips

Summertemperatures almost

vour barbecue should be hot. I hope you got a kick out of my bicycle story last week. If you missed it you can go to archives on the Observers web site.

The weather has been fantastic of late. Make sure you get outside on these cool evenings and fill the air with some smoke and some aromas that your neighbors can appreciate. Since the invention of the gas grill there has been a well established debate over the superiority of charcoal or gas. The debate can create such a fervor in some circles that you may think you are at a McCain - Obama debate, fighting over the principles of your country. As for myself, well I enjoy using charcoal (does that put me in the McCain or Obama camp I wonder). I am certain that my love for charcoal cooking stems from my pure love of food, and similar to a great symphony, my enjoyment increases with each moment until the finale when everyone is eating. If you are in the charcoal camp like myself, you need to be a patient person. After lighting the grill, I recommend that you give it 45 minutes before applying any food. Self lighting charcoal also works, and will be ready in about 30 minutes, but do note, they do not last as long, and they are not recommend if you want to slow cook an item.

Briquettes are adequate but they can be difficult to light and will leave a residue in the base of your grill. Lumpwood charcoal and a firelighter is my recommendation and with this you will notice a distinct difference in the flavor of your meal. It is probably something that does not come to mind for most people, but always use fresh charcoal. If you've kept it over the winter it absorbs moisture and will not reach the correct cooking temperature. Fresh charcoal will give your meal a clean, pure flavor and allow for a higher cooking temperature which is needed for many dishes. If for whatever reason the coals do not light well, do not be tempted to add additional lighter fluid, or blow on the coals. If you do, you're risking your own health and safety and those around you. You are holding an explosive device in that lighter fluid, use it wisely. Some of you may be saying, this is too much effort Peter, as I do work too and I don't need a second job. Your solution is easy – go with the gas barbecue! I still recommend getting that second job though for those unconquerable flavors which only charcoal can deliver.

Let's get down to the meat of the situation and the grilling. When grilling, some of the barbecues flavor is derived from the fat in the food dripping onto the coals and creating smoke, whether those coals are charcoal or lava is irrelevant. Use some the chefknows@yahoo.com management skills as things cook at different rates and will need to be applied to the


grill at different times. You have heard me mention Wolfgang Puck on occasion. One of his great talents is the Oscars, where he is able to place warm meals on the table for hundreds of people in a short period of time, aside from the great food, he has the process perfected of when each item goes on. You need to do the same thing, think about what needs to be ready and when. A good indication when the coals are ready is when no black is showing and there is an orange glow. Another tip is if you can put your hands over the coals for more then five seconds the coals are ready. Maybe that one is for the highly skilled cook though, as I do not want emails from burnt paws telling me about the idiotic testing method I recommended – use care, use your brain!

Meat is cooked from the heat, not from the flames. Many BBQ experts like the low and slow method. To avoid the flames I always have a water spray bottle handy. Cooking Hamburgers this summer – of course you are? A few people like their burgers medium rare, stick an ice cube right into the middle of the patty and that will keep the middle red and moist. When cooking steak, look for the better cuts of beef if you don't want to have to arm wrestle the steak. I prefer choice and prime cuts and some smaller markets carry both, the larger supermarkets usually carry a select and a choice cut.

When to season and add the sauce to the meats you are thinking? You can season your meats at any time, but as far as the sauces go, don't add until you are absolutely ready to take off the meat off the grill. In fact I would say for steaks don't use sauce at all, or at least just have it in the side for dipping. Corn on the cob taste great and can be left in the husk when cooking. It usually takes about 15 minutes to cook. Once you pull it off the grill and remove the husk, get a paper towel and remove any items left under the husk. I usually give it a warm rinse of water and all that is left is the butter.

tales" wisdom seemed well, an "old wife's tale". Who cared? And an

internet search echoes that sentiment. Why? Maybe because we think that "feeding a cold" means to pile in more "food".

Gotta tell you, I changed my mind after learning about Harold Foster, Ph.D, British hydrologist, University of Victoria, British a "sea / see change" in treating viral infections / invasions around the world. Why?

Seems that Senegal, Africa's west coast, has only a .8 to 1% HIV infection rate, compared to the 11% to 26% in other African countries. Sociologists and politicians attribute this to the openness of regulated prostitution, sex education and widespread use of condoms in this predominantly Muslim country, but Foster looks deeper.

The two elements that stood out for Foster were the excellent cleanliness and much higher levels of selenium and other dissolved minerals in Senegal's ground waters, versus the ground waters of the countries with higher rates of AIDS. It's almost a 1:1 ratio.

In researching ever more deeply, Foster learned from other, more focused researchers, that HIV-1 and HIV-2 absolutely require selenium in order to replicate. Ah ha, one might think. Then let's eliminate selenium from the diet. Can't do that ... us humans absolutely require ample supplies of selenium for our own life-energy enzyme processes. Selenium is an essential component of the human glutathione peroxidase enzyme (I know, more big words, sigh!), and that enzyme requires the non-essential protein amino acids of cysteine, glutathione, and tryptophan. Humm ... minerals and protein equals "food" to me ...

And why should populations anywhere in the world be deficient in minerals? - after all, that's what the world is made of - rock - which is mineral. Well, looking at "Foster's orthomolecular model, it explains the link between viral diffusion and falling soil and dietary selenium levels. During the past century, acid rain, petrochemical based fertilizer use and animal husbandry have combined to virtually deplete many global soils of this essential trace mineral, setting the scene for several viral pandemics, including those of HIV/AIDS and Hepatitis B and C."(1) The increasing bio-non-availability of selenium (not to mention magnesium and others) is creating human (and other mammalian and animal populations and generations) with sharply weaker immune

But to get back to the HIV virus. In increasingly large human studies in Africa (see Dr. Foster's website for citations and free personal copies of his books in pdf format) are verifying that a course of 400 mcg selenium with dessicated liver tablets (and other trace minerals) over a onemonth period of time has been sufficient to return up to 87% of group participants Columbia. Harold Foster's comparison of from so weak they can barely eat, let alone world-wide ground water quality against walk, to "back to work" within a month. local population health statistics, are creating At that point, selenium capsules alone are provided ... individuals seem to do well for several months, and then, once again, they start feeling "weak" and another month of nutrient supplementation returns them to full functionality. The selenium-bound enzyme requires the "non-essential" protein amino acids cysteine, glutathione and tryptophan as partners in their operations.

Think about it. If we ensure that we get the trace minerals our bodies need to keep our own personal enzyme levels high (enzymes are our body's personal labor force that converts food / nutrient / elements from one to the other to meet many of our foodbased life-force energy needs), we don't need to worry, for example, about picking up a "viral infection" from a shopping cart handle. The real infection is our enormous ignorance about what we need, and what the all-pervasive viral invaders require, for our joint life processes. We are not alone. The alien invaders are already within us - so now we need to deal with them. If we don't keep our own nutrient levels up, to meet both viral and personal needs, it's our bodies that become short of energy, it's our immune systems that don't have what they need to do the jobs, and it's our bodies that "go down for

So, "Feed a cold?" Absolutely! But be smart .. forget the dairy, gluten and sugars. Feed that cold virus with what it needs and as fast as possible rebuild our own stores of nutrients so that our own immune system stays healthy. Humans have broad general requirements, but each of us has ancestral / environmental requirements for specific nutrients that may be separate from the others in our families or neighborhoods. Don't let yourself be frightened into succumbing to the "vaccinate" against infection" pressure. Keep yourself healthy from the inside out with - here it comes again - Fresh Fruits and Veggies, Dark Green Leafy Greens, Whole Grains Seeds and Nuts ... at least until next week!

The International Astronomical Union (IAU) has given the name Makemake to the newest member of the family of dwarf planets, after the Polynesian creator of humanity and the god of

Makemake (pronounced MAH-keh MAH-keh) is one of the largest objects known in the outer Solar System and is just slightly smaller and dimmer than Pluto, its fellow plutoid. The dwarf planet is reddish in color, and astronomers believe the surface is covered by a layer of frozen methane.

Like other plutoids, Makemake is located in a region

beyond Neptune that is populated with small Solar System bodies (often referred to as the transneptunian region). The object was discovered in 2005 by a team from the California Institute of Technology led by Mike Brown, and was previously known as 2005 FY9 (or unofficially "Easterbunny").

The discoverer of a Solar System object has the privilege of suggesting a name to the IAU, which then judges its suitability. Mike Brown says: "We consider the naming of objects in the Solar System very carefully. Makemake's surface is covered with large amounts of almost pure methane ice, which is scientifically fascinating, but really not easily relatable to terrestrial mythology. Suddenly, it dawned on me: the island of Rapa Nui (Easter Island). Why hadn't I thought of this before? I wasn't familiar with the mythology of the island so I had to look it up, and I found Makemake, their chief god, the creator of humanity and the god of fertility. I am partial to fertility gods. Eris, Makemake, and 2003 EL61 were all discovered as my wife was 3-6 months pregnant with our daughter. I have the distinct memory of feeling this fertile abundance pouring out of the entire Universe. Makemake was part of that."

Makemake holds an important place in the Solar System because it, along with Eris and 2003 EL61, was one of the objects whose discovery prompted the IAU to reconsider the definition of a planet and to create the new group of dwarf planets. Visually, it is the second brightest transneptunian object, following after Pluto, and is bright enough to be seen through a high-end amateur telescope (it has a peak magnitude of roughly 16.5). Mike Brown explains: "The orbit is not particularly strange, but the object itself is big—probably about 2/3 the size of Pluto."

The other three dwarf planets are Ceres, Pluto and Eris. However, Ceres is not a member of the distinctive plutoid group because its orbit is smaller than Neptune's (Ceres is located in the asteroid belt between Mars and Jupiter).


The word Makemake is Polynesian in origin

and is the name of the creator of humanity and the god of fertility in the mythology of Easter Island. He was the chief god of the Tangata manu bird-man cult and was worshiped in the form of sea birds, which were his incarnation. His material symbol was a man with a bird's head.







### Recipe of the Month:

Simple Crostini 1 baguette (8 to 10 ounces)

¾ cup olive oil- (For an extra layer of flavor, use a garlic or herb infused oil) coarse salt and ground pepper. 1-Preheat oven to 350. Arrange baguette slices on two large rimmed baking sheets: brush both sides with oil,

and season with salt and pepper.

2- Bake until golden, 15 to 20 minutes, rotating sheets halfway through (If undersides are not browning, turn crostini over once during baking.) Let cool on baking sheets. (To store, keep at room temperature in a resealable plastic bag, up to one week.) Top crostini with desired toppings and serve. A Trio of Toppings:

White-Bean and Caper

In a bowl, combine one 15 ounce can cannellini beans, rinsed and drained, with 1/4 small red onion, minced, 1 Tbs. capers, rinsed, 1 Tbs. olive oil, and 1 Tbs. whitewine vinegar. Mix, mashing beans slightly; season with coarse salt and ground pepper.

In a bowl, combine 1 pint chopped grape or cherry tomatoes with ½ cup chopped fresh basil leaves, 1 This, olive oil and 1 tsp. red-wine vinegar; season with coarse salt and ground pepper. Artichoke-Dill

In a bowl, combine two 14-ounce cans artichoke hearts in water, rinsed, squeezed to remove excess liquid, and chopped, with 1/3 cup light mayonnaise, 2 Tbs. fresh lemon juice, and 2 Tbs. chopped fresh dill; season with coarse salt and ground pepper. Each recipe yields enough to top 30 crostini. Feel free

to mix and match! (everydayfoodmag.com)



# WILD CLAY from the Hills of Sierra Madre

Some of the best wild clay that I've ever found is located in the hills above Sierra Madre. Not that I've searched the globe for clay - I haven't. But I have searched out and found lots of local clays in river bottoms and erosion cuts in hillsides. I have found clay that is white, pink, green, blue, grey, and red.

Among the many classes I teach, I show students how to take locally-found clay, how to process it, and how to make useful items, like water vessels, cooking pots, oil lamps, plates, tools, pipes, and countless useful and decorative items. This is a skill that everyone in the past simply took for granted.

The clay above Sierra Madre is a fine red adobe clay.

If you enroll in a "ceramics" class at any local high school or college, you'll learn what it takes to make useful and ornamental objects that won't explode or crack when they are fired. You'll learn how to use a wheel, how to keep the walls of your pot thin, how to glaze, how to add color and ornamentation to the objects,

But you don't usually learn how to find and prepare the clay yourself, or how to fire the object using primitive methods.

I was once one of those people who said "there can't be any good clay anywhere near my home." But then again, I wasn't

Once I began looking for clay, I realized that clay was abundant.

was abundant, but not necessarily "good clay."

Here is a good rule-of-thumb test to see if your found clay is good quality. Assuming it is already moist, roll a little in your palm until it is as thin as a pencil. Does it stay together? If it contains too many impurities, or if your sample has too little clay content, you won't even be able to form a pencil shape.

Next, test the flexibility of the pencilshaped clay. Good quality clay will hold together well, and will have a high degree of flexibility.

Though you may find a good batch of clay, chances are that you'll have to refine what you find and add temper to it.

> Though I read a lot about how to process clay from the wild, it was mostly by talking with Phil Cornelius that I learned some of these basics. Cornelius is a master potter who has taught at Pasadena City College for decades. After I called him with lots of questions, he invited me to his class at

I had questions about processing clay, and making pinch pots, and doing primitive firing. I arrived one evening with a bucket of the raw red clay that dug from the foothills of Sierra Madre. He answered all my questions about making pinch pots, and about primitive firing. He then looked at the clay I brought, and we added water to my bucket so it was all very soupy. One of his students then took a paint mixer attached to an electric drill, and mixed up my raw clay until it was homogenous. Then we poured it through a sieve to remove any large material and foreign material. He said that when I got home, I should pour the sifted material


onto a sheet that I lay on the ground. The liquid would strain through and I'd soon have a good quality clay material.

This is how I have processed clay ever since. I blend the clay and water mix with a paint mixer on a drill, strain it through a fine metal sieve, and then pour it onto a sheet on the ground. It may take a day or more, but when the liquid is gone, I have a good workable clay. Sometimes, I simply crush the dry clay and shake it through a sieve, and then moisten and use it.

Years earlier, after looking for clay at many locations, I took a sample of this red clay to artist and master potter Doyle Lane. Hard to believe, but Lane lived in a hilly and rural-seeming part of Los Angeles, south of my home at the time. He was up on a hill, and had a kiln out in his yard. I gave Lane a sample of the red clay, and he asked me, "What cone did you fire this at?" "Cone" refers to a measurement of heat when firing pottery in a kiln. "I didn't fire it at all," I told Lane, who was surprised and declared it some really fine clay.

This red clay is the main clay that I collect and process and use when teaching this

It is very enjoyable and even therapeutic to collect and process clay, and to sit making an object from your own hands that you can then use.







