Dorn Platz Maintains Control Of One Carter And Stonehouse

Work To Resume; Lawsuits Drag On

It has been said that Greg Galletly and Dorn Platz are like a cat with nine lives. Despite the severity of the financial problems with investors and creditors, the month of July came and went without Dorn Platz and developer Greg Galletly loosing control. To the dismay of many residents, agreements were reached that postponed and/or canceled the scheduled foreclosure sales of One Carter and Stopehouse properties. New financing has been retained Stonehouse properties. New financing has been retained by the developer and the One Carter project is scheduled to resume construction any day. All sub-contractors with outstanding liens against the property and the City of Sierra Madre were paid as a result of the new financial arrangement. However, the seven lawsuits involving the City of Sierra Madre and Dorn Platz, et al, have not been settled. The next scheduled court date is after January 1,

With the immediate threat of financial collapse behind them, the company has committed to begin the necessary infrastructure improvements in an effort to divert mud

slides and floods during the rainy season.
City Manager Elaine Aguilar indicated that the anticipated completion date for those items is mid-October, 2008.
At press time, she was expecting a complete timetable on when the equipment would be brought back in and a complete schedule for the work completed. Dorn Platz and the County of Los Angeles will be constructing a temporary debris basin as well as erecting a timber and rail structure to prevent flooding and mud slides. Says Aguilar, "if milestones are not met, the city will not hesitate to step in."

Historical Designation Hearing

In other related matters, on Thursday, August 7, 2008, the Sierra Madre Planning Commission will hold a public hearing on the designation of the Willis Residence as an Historical Landmark. The Willis Residence sits on the One Carter property and an historical designation of the house was one of the conditions required by the city in order for the project to proceed. For months, concerns have been directed towards City Hall, inquiring why the designation had not been completed.

The hearing will be held in the City Council Chambers at 7:00 p.m. There is some question as to whether or not the commission will have a querum as there are currently.

commission will have a quorum, as there are currently three openings that must be filled. Two are for existing members seeking reappointment. One is filling the vacancy left by former commissioner John Hutt.

Mid Week Quake Shakes Things Up

What has now been downgraded to 5.4 magnitude earthquake severely nook the Foothills cities—and the in world-wide standards. In general, a 5.4 magnitude earthquake severely shook the Foothills cities—and the entire population—on Tuesday. Citizens took to the streets with many expressing uncertainty as to what needs to be done during a potential

The quake struck at 11:42 a.m. and was initially estimated at 5.8 by the U.S. Geological Survey. Dr. Kate Hutton, staff seismologist at the California Institute of Technology, quickly held a press conference for media outlets to help alleviate fears concerning what to expect in the days following the quake.

"The earthquake was felt all over the L.A. Basin and the Inland Empire, with the epicenter located at two miles southwest of Chino Hills," said Hutton. "We know it was a thrust fault and the largest aftershock so far

At the news conference Hutton stated that there had been at least stated that there had been at least 27 aftershocks documented in the one hour following the quake. A map displayed in color coding was provided to designate the severity of the quake in the surrounding areas.

"Basically, anything that is yellow on the map was a scary earthquake," she said. "The areas that are green and blue...people probably felt it but didn't notice it as being particularly alarming."

Hutton estimated the depth of the

if the quake is much deeper it is not felt as strongly at the surface. The 5.9 Whittier Narrows quake in 1987 was used as a comparison of a quake most like the one felt this week.

"One of the most interesting things about this earthquake is that it's the first one we've had in a populated area in quite a long time," she said. "So, we should probably look at it as an earthquake drill for the big one that will be coming someday."

Governor Arnold Schwarzenegger held a press conference later in the afternoon to affirm

afternoon to affirm that he has reached out to local agencies to make sure that all of the levees, bridges and other critical infrastructures inspected before being declared safe.

This earthquake reminds us once again that in California we have to be prepared for anything and everything," he said.
"Luckily, we have a great Office for Emergency Services that acts very quickly. We will continue to monitor the situation very closely."

Just A Reminder of Things To Come


Although the probability is low, Seismologists at Caltech (above) said Wednesday they will be watching larger fault systems in the area for activity, including the Sierra Madre Fault Zoneand the Whittier and Chino faults

According to the scientists, any activity would most likely happen within a few days of Tuesday's 5.4 main shock, located in between the Whittier and Chino faults on an unknown fault near Diamond Bar. There have been over 90 aftershocks in that area.

The motion of Tuesday's Chino Hills quake was interesting, they said, showing a mixture of both thrust and left-lateral strike-slip faulting consistant with the Upland earthquakes (about 10 miles north) that occurred in early 1990, which also had left-lateral

strike-slip motion. The Chino Hills earthquake was also similar to the 1987 magnitude 5.9 Whittier Narrows earthquake, which was pure thrust faulting and also similar to the devastating 6.7 magnitude 1994 Northridge quake that caused an estimated \$12.5 billion in damage.

To geologists, slip motion shows the type of fault. It is determined by standing on one side of a fault and recording the relative motion of the other side. Strikeslip faults move laterally where other

fault types, such as normal, reverse and thrust, move up or down.

which goes through the city, is reverse faulting in which the motion is up. Thrust faults are reverse faults with less than a 45 degree angle. (See FAULT Page 12)

JANE FULLER: Sierra Madre Singer and Guitarist

Maybe you were having dinner at 322 restaurant, maybe you were at Sierra Madre Books. You might have heard the guitar and singing of Jane Fuller, local Sierra Madre resident and musician. "I think that people go to musical performances for something more than just the music," she explains. "People want a sense of community. They want to be a part of something," and Fuller hopes that those who come to 322 can interact with others. "Of course, you can't just come and sit there," says Fuller. "You have to interact with other people there. Sierra Madre business owners can pass out their cards, and local residents can learn about all the other businesses that they can patronize," she says.

"One of the girls at school showed me a few chords, and I had to learn quickly," she says. Fuller explains that she had a strict nun in 5th grade who pushed her into leadership positions in stage, and in organizing the music for Mass. ORDINANCE NO. 1278

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SIERRA MADRE AMENDING ARTICLE 5 OF THE SIERRA MADRE MUNICIPAL CODE BY ADDING CHAPTER 5.34 REGARDING STATE VIDEO FRANCHISES OPERATING WITHIN THE CITY

WHEREAS, the Legislature of the State of California (the "State") has adopted the Digital Infrastructure and Video Competition Act of 2006 ("DIVCA");

WHEREAS, the DIVCA became effective on January 1, 2007;

WHEREAS, the DIVCA establishes a regulatory structure for the State to issue franchises to video service providers;

WHEREAS, the DIVCA establishes that local entities, such as the City Sierra Madre (the "City"), are responsible for administration and implementation of certain provisions of DIVCA;

WHEREAS, the DIVCA requires that the City establish, by ordinance, financial support provisions for Public, Educational and Governmental ("PEG") channel facilities; and

WHEREAS, the DIVCA requires that the City adopt, by ordinance or resolution, a schedule of penalties for any material breach by a State video franchise holder for violation of customer service and protection standards that the City is

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIERRA MADRE DOES ORDAIN AS FOLLOWS:

Article 5 of the City of Sierra Madre Municipal code is hereby amended to add a new Chapter 5.34 as set forth in Exhibit A to this Ordinance.

<u>Section 2</u>. Severability. Should any provision of this Ordinance or its application to any person or property be found by a court of competent jurisdiction to be invalid or unenforceable, the remaining provisions hereof shall be enforceable according to their terms and to that end the provisions of this ordinance are severable.

<u>Section 3.</u> Construction. To the extent the provisions of the Sierra Madre Municipal Code as amended by this ordinance are substantially the same as previous provisions of that Code, those provisions shall be construed as continuations of those previous provisions and not as new enactments.

Section 4. Publication. The City Clerk shall cause this Ordinance to be published or posted in accordance with California Government Code Section 36933, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the City Council.

Sierra Madre Municipal Code

Article 5 Regulation of Businesses and Franchises

Chapter 5.34 State Video Franchises

5.34.10 Purpose and Application of this Chapter

This Chapter is designed to regulate video service providers holding state video franchises and operating within the City of Sierra Madre. On January 1, 2007, the state of California became the sole authority with power to grant state video franchises pursuant to the Digital Infrastructure and Video Competition Act of 2006 ("DIVCA"). Pursuant to DIVCA, the City of Sierra Madre shall receive a franchise fee from all state franchisees. In addition, the City shall receive from all state franchisees fees to support public, educational, and government access channel facilities. DIVCA confirmed that the City may establish and enforce penalties, consistent with state law, against all state video franchise holders operating within the City for violations of customer service standards. DIVCA precludes the City from adopting its own standards and grants all authority to adopt customer service standards to the state. DIVCA leaves unchanged the City's authority to regulate the City's current cable franchises and any City cable franchise(s) issued on or before January 1, 2008, until the expiration of any such franchise(s).

5.34.20 State Video Franchise Fees and Fees for Public, Educational and Governmental (PEG) Access

- A. Any state video franchise holder operating within the boundaries of the City shall pay a fee to the City equal to five percent (5%) of the gross revenues of that state video franchise holder.
- B. Effective the first date on which state franchisees begin operating within the boundaries of the City, each state franchisee shall pay a fee to the City equal to one percent (1%) of gross revenues ("PEG Access Facilities Fee") of that state video franchise holder to support public, education, and governmental (PEG) access channel facilities within the
- C. The PEG Access Facilities Fee shall be paid quarterly no later than the sixty (60) days following the quarter for which the payment is due. The PEG Access Facilities Fee is in addition to the franchise fee to be paid to the City by the
- D. Gross revenue, for the purposes of subsections A and B of this section, shall have the definition set forth in California Public Utilities Code Section 5860.

5.34.30 Audit Authority

Not more than once annually, the City Manager or his designee may examine and perform an audit of the business records of a holder of a state video franchise to ensure compliance with Section 5.34.20.

5.34.40 Customer Service Penalties

- Any holder of a State video service franchise shall comply with all applicable state and federal customer service and protection standards pertaining to the provision of video service.
- B. The City will provide any holder of a State video franchise written notice of any material breach of applicable customer service and protection standards, and will allow the franchise holder at least thirty (30) calendar days from the receipt of the notice to remedy the specified material breach. A material breach that is not remedied by the State video franchise holder within the remedy period shall subject the State video franchise holder to the following penalties to be
- 1. For the first occurrence of a material breach, a penalty of not more than five hundred dollars (\$500) for each day of each material breach, not to exceed one thousand five hundred dollars (\$1,500) for each occurrence of a material
- 2. For the second violation of the same nature within twelve (12) months, a penalty of one thousand dollars (\$1,000) for each day of each material breach, not to exceed three thousand dollars (\$3,000) for each occurrence of the
- For a third or further violation of the same nature within twelve (12) months, a penalty of two thousand five hundred dollars (\$2,500) for each day of each material breach, not to exceed seven thousand five hundred dollars (\$7,500) for each occurrence of the material breach.
- C. Any notice and any penalty may be issued or imposed by the City Manager, or the City Manager's designee. Any notice shall be in writing. Notices shall be transmitted by United States Postal Service certified or registered mail, return receipt requested and postage prepaid, or by private commercial delivery or courier service for same day or next business day delivery with delivery and receipt signature required.
- The State video service franchise holder may appeal any finding of material breach or imposition of penalties to the City Council. Any appeal must be made within thirty (30) calendar days of receipt by the State video service franchise holder of the finding of material breach or the imposition of penalties, and must be submitted in writing to the City Clerk and the City Manager in order to be placed on a City Council agenda for consideration. Any appeal must contain a detailed explanation of why the applicant believes that the finding of material breach or the imposition of penalties was incorporate thirty that the state of the made within thirty (30) calendar days of receipt by the State video service franchise holder of the finding of material breach or the imposition of penalties was inconsistent with statutory requirements.
- E. The City and any State video service franchise holder may mutually agree to extend the time periods specified herein. Any such agreement shall be in writing and executed by the City Manager, or the City Manager's designee, and an authorized representative of the State video franchise holder.
- F. Any penalty imposed on the State video franchise holder shall be paid to the City. As provided for in Section 5900(g) of the California Public Utilities Code, the City shall submit one-half of all penalties received from a State video franchise holder to the Digital Divide Account established in Section 280.5 of the California Public Utilities Code.

5.34.50 Procedures for Appeal of Denial of an Encroachment Permit

- A. As provided for in Section 5885 of the California Public Utilities Code, the City shall either approve or deny an application from a State video service franchise holder for an encroachment permit within sixty (60) days of receiving a
- An "encroachment permit" means any permit issued by the City relating to construction or operation of facilities relating to the provision of video service under a State video service franchise
- C. An application for an encroachment permit is considered complete when the applicant has complied with all statutory requirements, including the California Environmental Quality Act (CEQA) of the Public Resources Code.
- Any City denial of an application for an encroachment permit shall be in writing and shall contain a detailed explanation of the reason for the denial
- An applicant whose application for an encroachment permit has been denied may appeal the denial to the City Council. Any appeal must be made within fourteen (14) calendar days of receipt by the State video service franchise holder of the denial, and must be submitted in writing to the City Clerk and the City Manager in order to be placed on the City Council agenda for consideration. Any appeal must contain a detailed explanation of why the applicant believes that the denial was inconsistent with statutory requirements.

Used Battery Collection Program is Back!

The City of Sierra Madre Public Works department, in partnership with the Sierra Madre Environmental Action Council (SMEAC) and the County of Los Angeles Public Works department is pleased to announce that a used battery collection container will be available for residents to deposit their used batteries responsibly and safely. The container will be located near the front desk at City Hall beginning July 28th.

Sierra Madre was selected to participate in a pilot program being developed by the Los Angeles County Public Works Department. Selected locations within the county will collect used batteries

and the county will accept them at no cost to the participants.

The program will accept "Dry cell" batteries which are the common disposable AAA, AA, A B, C, and D sized batteries. Also accepted are "Rechargeable" batteries such as those found in cell phones

and "Button-Cell" batteries that are used in hearing aids, watches and cameras.

The sponsoring agencies urge all residents to take personal responsibility to ensure that batteries are not entered into our landfills. Many common household batteries are comprised of heavy metals and other elements including nickel cadmium, alkaline, mercury, nickel metal hydride and lead acid. It is these elements that can threaten our environment if not properly discarded. The agencies would also like to recommend that residents consider using rechargeable batteries for their future needs.

Staying put could safely be proceeded by a deliberate move to a secure place in your immediate surrounding: on the floor, near a large piece of furniture or a wall.



Audit Says Parsons and Pentagon Wasted Millions of U.S. Tax Dollars

A new round of audits confirmed Pasadena based Parsons Corp failed to complete numerous projects in Iraq that would have amounted to \$900 million. Instead the audit points to wasted funds on substandard construction only completing 34% of all jobs that included, among other things, police stations, border control stations, fire stations, courthouses and prisons.

The contract for security and justice work in Iraq was awarded in 2004 for two years with three oneyear options. The report said Parsons received \$333 million for individual jobs and task orders. It also said 66 percent of the jobs were canceled leaving \$142 million unaccounted for. The contract was canceled in August 2006.

"The evidence of Parsons' failures is the reasons presented for not making sufficient progress on the project." A termination letter to the company read. "Parsons' has endangered completion both continued schedule slips and by incurring massive cost overruns that cannot be sustained by the government..."

A report released Monday by the Special Inspector General for Iraq Reconstruction also criticized the Pentagon for wasted tax money as well. Parsons is no stranger to audits for its work in Iraq. According to Bloomberg, other audits by the Special Inspector General showed



management of its Iraqi subcontractors, including \$186 million that went to build public health clinics. A \$72.5 million police academy in Baghdad was also investigated as well as a \$3 million renovation to the Iraqi Security Forces Civil Defense headquarters they reported.

Last year the independent media source AlterNet reported that both Parsons and Houston based Halliburton Inc. were investigated for the failure to repair oil meters on Iraqi pipelines. The Meters were responsible for calculating the flow of billions of dollars of crude

According to AlterNet, "the Bush administration contracted Halliburton to fix southern Iraq's oil fields and with to be supervised by yet so grave that several

another contractor, New Jersey-based Foster Wheeler."

They also said the contract was part of the infamous, "secret no-bid contract issued to Halliburton before the invasion of Iraq."

The latest report dated July 25 addresses the current status of the Kahn Bani Sa'ad Correctional Facility abandoned by Parsons. Control of the facility was given to Iraq last year. The reports states Iraq has no plans to use it prompting Inspector General Stuart Bowen to say all the money spent was a waste.

According to the audit the prison had cracking concrete and poor placement. Some walls were also unreinforced and concretion beams were dangerously joined. northern fields. The two and health conditions in companies were supposed the existing prison were

inmates had died in the overcrowded facility."

Parsons spokeswoman Erin Kuhlman responded in a statement, circulating on the Internet, saying "the company did the best it could under difficult conditions."

Her statement also says a Parsons' subcontractors was shot and killed in Iraq. Parsons also claimed that subcontractors were threatened daily to shut down.

The report disagreed, "For every violent incident that led to a schedule delay request, Parsons sustained an increase in personnel immediately following the incident. In some cases, Parsons had a record setting number of employees return to work. City Opposes Solar and Clean Energy Initiative

She said increasing the State's Renewable Portfolio Standards (RPS) requirements to 20 percent by 2010 could cost ratepayers 40 percent more even though the Proposition caps ratepayer costs at 3 percent above the market price of power. Currie said Pasadena is its own utility and all cost would go straight to the ratepayer, "There is no one else, that's part of the

The Initiative would also require 40 percent by 2020 and 50 percent by 2025 and fine any "retail seller" not meeting the goals. It would also require sellers to offer a minimum 20year contract to renewable projects among other

Councilmember Margaret McAustin said Prop. 7 would undermine the city's Integrated Resource

Plan now underway to have 10 percent renewable by 2010 and 20 percent by 2017. She said the initiative would take away the city's right to enforce its own Renewable Portfolio Standard.

The menu here offers a very wide selection for those days when you are finicky and cannot determine the proper course to plot. The menu offers tacos, salads, fish, chicken and steak, to name a few items. I must say this place is modest to a fault, as their menu is very understated in their description of the dishes. The dishes are well constructed and elegant in presentation and delightful in taste. On a recent visit we ordered the Dixie Pan-Fried Chicken, which indeed is crispy white meat just as described on the menu (\$18). It comes with mashed potatoes and, are you ready for this? A fresh baked Cinnamon roll, ala Rosco Chicken and Waffles. Hmmmm. Very creative and I was not expecting that great surprise! Also, we shared the chicken spinach salad (\$11); it was nice but I should have listened to my server, Nicole, and got the Brussels Sprout Salad. For some reason I just couldn't bring myself to do it, as it reminded me of lunch time at my Mom's house. For fish lovers, you will feel like you pulled in the prize fish when they slide the Ahi Tuna Tacos beneath your eyes. They are made to order and come with fresh corn tortillas, black beans and rice, plus a small side of guacamole (\$15). There are deviled eggs on the menu for \$6, I just may try them next trip. Additionally, the restaurant also offers many other happy hour specials.

So are we all aboard now, as my hour session is up for this week? For complete prices and menu items please check out the website www.lgostationcafe.com.

Local Knowledge: The restaurant is imaginatively divided into three dining areas. An outside patio dining, a main dinner hall, and South Side Bar. Kids eat for free between 5 PM and 7 PM and dishes include Mac and Cheese and a grilled cheese sandwich. Service seems on top of things; however they did know who I



Robotic Moon Excavation Teams Compete For NASA Technology Prize

NASA's REGOLITH EXCAVATION CHALLENGE is scheduled for Aug. 2-3 on the campus of the California Polytechnic State University in San Luis Obispo. The competition requires teams to build a roving excavator that can autonomously navigate, excavate, and transfer approximately 330 pounds of simulated lunar regolith, or lunar soil, into a collector bin within 30 minutes. The total prize purse is \$750,000 with a first prize of \$500,000.

NASA is looking for new ideas for excavation techniques that do not require excessively heavy machines or large amounts of power. Excavating lunar regolith will be an important part of any construction projects or processing of natural resources on the moon.

The California Space Education and Workforce Institute in Santa Maria, Calif., manages this challenge.

Twenty-five teams have registered for the event. Most of the teams are from the private sector, including some from the toy and information technology industries. Four of the teams are affiliated with universities.

The prize program, known as Centennial Challenges, began in 2005 in recognition of the centennial of powered flight. In keeping with the spirit of the Wright Brothers and other American innovators, the Centennial Challenge prizes are offered to independent inventors who work without government support, including small businesses, student groups and individuals.

SPEAKING OF CHALLENGES, taking a trip in a totally unfamiliar rented car may not seem like much of one, but it can have its harrowing moments. For a trip up the California coast this past weekend, Laura and I decided to rent the very hi-tech Prius hybrid—just a bit of a shock, at first, for us owners of "vintage" cars. But after we got the hang of how to start and shut off the car and lock the doors with its "smart key," it ended up being a very satisfying driving experience. And by choosing the hybrid over other cars available from Hertz, we not only did our bit to help the planet but may have ended up saving money—we averaged 50 mpg on the 450-mile trip.

The occasion was a working weekend—a "retreat" for Laura's workgroup at Loyola Marymount University—in the Central California beach town of Cayucos, a half-hour's drive north of San Luis Obispo. While Laura attended all-afternoon meetings on Friday and Saturday, I ended up happily settling into the restful ambiance of our lodge on the beach, the Shoreline Inn. For me, it was occupation enough just to listen to the long, drawn-out pulse of the sea-swells as they rolled in.

On Saturday evening, some of us from the group ended up sitting around a campfire on the sand, eating "smores" (roasted marshmallows and pieces of chocolate sandwiched between two graham crackers) while the summer stars came out. At our Cayucos location (roughly 200 miles northwest of L.A.), the end of the evening twilight was noticeably later than at home, but soon after 9:00 our old friends in the sky appeared—Scorpius, the scorpion, lurking low in the southwest; bright Jupiter rising in the east; and the Big Dipper, faithfully pointing the way to the North Star.

Summer Fresh, Real Foods

I fell in love! Oh, wow! I tingled all over. What a rush! And don't you just love to be "in love?" The spirit soars, aches and pains are ignored, hope in the future blooms and

So who or what triggered this? Wednesday's Farmer's Market! I womaned the Chamber of Commerce table for a couple hours on my own behalf whilst also supporting the Chamber. And thus, instead of my "casual drift" through the market, I had time (and I'm one who needs "time" for things to sink in) to observe what was going on around me. What was really "new" to me was right across from me - a booth with Korean pickled vegetables - usually noted for their "heat.". Well, I like a bit of "tang", but I'm not one to have my taste buds go out in a roar of flames. However, the vendor was proving to be a real character, so I wandered over.

He handed me a toothpick with something on it and - oh my goodness - it was delicious! And a taste from another variety. Oh, my! And another, and another. I didn't bother with the jarred stuff - that I definitely knew was too hot, but I returned to the CoC booth with five containers of fermented foods that lifted heart and spirit into free flight.

Next morning, as I made a meal from the (admittedly much hotter) treasures than the ones I tasted the night before, I thought nostalgically of the fermented cabbage (sauerkraut) in the basement crock, and filled with naturally occurring healthy enzymes. Fresh. Not canned. Not irradiated. Not micro-waved. Not bleached, boraxed or brightened. Real food.

What other beloved fresh, unpasteurized (i.e., not heated) healthy enzyme fermented foods do we enjoy? Although I'm not doing cow dairy these days (although a bit of goat or sheep cheese occasionally sneaks in) some of the most well known fermented dairy products are yogurts and natural cheeses. In addition to fresh apple cider, before it ferments into the "hard stuff" and then into vinegar, there are fermented grape juices (wines); and fermented grains (beers). And then there are the pickled vegetables ... cucumbers, piccililly, watermelon rinds ... When fresh and unpasteurized, all of the above they contain the healthy enzymes and bacteria (probiotics and more) on which our bodies thrive and which are too much missing these days.

Anything else? Well - there's Tofu and Tempeh. A vegetarian lives on this kind of stuff, which is almost never on my menu because, a) I'm a carnivore and b) I'm soy sensitive. Maybe

the sensitivity is because most soy has been so genetically modified in the last 40+ years, so it can grow with the petrochemical "Roundup" and thus no longer has the 38% complete protein it used to have, plus other changes. Maybe it's because I lived and worked a couple years in Bangladesh, and for about 9 months most of my dinners were basically a lentil stew. Why? Here I was, after all, blessed with a gourmet cook. But since I was pouring all my creativity into "doing my job" 18 hours a day, and he banned from the kitchen, and I could not just wander through the street markets because of the shocked disapproval and "gawking" of the men in the markets ("their territory") I had nothing to spark my food creativity. Thus, when asked what I wanted for dinner, I barely had the energy to say, "lentil stew." Poor Mr. Kazi; I was such a boring person ... except the few times company came when his creativity surpassed anything I could possibly have requested. Oh, memories of bliss!

Where was I? Oh yes, soy. So, when I was handed taste tidbits that I found out were BBQ's tofu and a brown-rice-and-soy tempeh, I was really cautious. But, oh my - once again a taste of heaven. Teriyakied lotus root? Absolutely not to be missed.

And then there was the fresh peach booth just behind us. What a bargain! Those \$1/lb. peaches were fresh and truly tree-ripe. Yeah, they weren't too lovely to look at with large had soft spots on the surface. The vendors haven't yet mastered the art of protecting truly tree-ripe peaches from smooshing a bit against each other during transportation from farm to market. But at \$1 per pound for those biggies? I gritted my teeth, stomped on my stomach and gingerly picked out 4# of them. After coming home, I washed them, removed the unsightly 1/4" deep bruised areas to the fresh, fragrant, delicious peach below. Skins on, I cut them into pieces, dropped them into the food processor, added some frozen lemonade concentrate, some frozen orange juice concentrate, 1 Tbsp sugar and 1/4 tsp ginger; made a puree and poured into a glass lasagna dish and slipped into the freezer - with occasional stirrings as it froze I now have the most delicious fresh peach granite / sorbet ... tree ripened flavor, still fresh and real enzymes ... Real Food.

There's no substitute for fresh, real foods. So, give your insides a healthy boost - add some fresh food-based probiotics from sources other than yogurt and your body will bless you from the inside out. And come visit our own Farmer's Market while summer bounty lasts!




Favorite Tales from Mitford Books by Jan Karon and Martha McIntosh (2004)



Design Your Ideal Retirement

Much of the focus retirement e m p h a s i z e s finances. But of equal importance is the decision to actually retire and how and where you'll spend your

their book, The New Retirement, The Ultimate Guide to the Rest of Your Life, Jan Cullinane and Cathy Fitzgerald quote Lee Iacocca, who says, "Everybody says you've got to get ready financially. No, no, you've got to get ready psychologically."

-If you're moving to a destination for a specific activity perhaps skiing-what will you do if you can no longer

-What's the ideal living environment for the shortterm and long-term? Do you want to live exclusively

among those in your own age group and with similar backgrounds? Or do you want a multi-generational and multi-cultural housing situation?

-How will you manage your changing needs as you age? Is there an option of assisted living?

-What are the what-ifs and contingency plans to consider? How will your cost of living compare in a new city? Perform a quick calculation at http://www. bankrate.com/brm/movecalc.asp?a=

-What support systems will be in place, should you fall ill at your retirement destination?

-Does travel figure into your plans? If your destinations are international, how easy are the connections from your retirement city?

-How do family and friends factor into your plans? How easy would it be for guests to visit, and do you want accommodations for overnight guests?

-If your plan includes continuing education, what are local educational options and costs? Have you considered online learning http://www.elearners.com/

-Is volunteering important to you? To assess the choices in a given spot, visit http://www.

volunteermatch.com. It can match you with volunteering opportunities according to your interests and location. Active Adult Living

If your retirement design includes owning a home within an active adult community—those typically restricted to residents aged 55 and older—your choices are vast. After all, builders have expanded such housing options in recent years, and locations of active adult communities have grown beyond the Sunbelt states. Compare communities based on how they cater to your interests, desired lifestyle, and economic needs. Nearly all provide some transportation and are close to medical facilities. Here are some basic considerations: Lifestyle: If you want the sense of a perpetual vacation, a large planned community that delivers an array of amenities, such as golf, tennis, and fitness, might be ideal. But if lifelong learning is your focus, maybe you'd



Lotusland: Garden Wonders by Appointment Only





Exactly 100 miles from my home, hidden behind massive gates in the tony estate area of Montecito, the wonders of Lotusland unfold. Only if you have an appointment. The address isn't even given in the website, so you can't just show up. The good news, though, is that the yearly limit of 5,000 visitors was recently relaxed, so you no longer require nearly a year's advance planning! The pricey \$35 tickets were well worth the two hour personal tour for our group of four.

When I asked for inspiration for this column nearly six months ago, friend Rosie Gorman suggested the trip and made all the reservations and arrangements, thank goodness! As the first to arrive, we waited on the short driveway outside the gate until they silently opened on the dot of the hour

when we were expected.
Think Disneyland for gardeners. Lotusland originally began as a plant nursery until

Madame Ganna Walska bought the 37 acre property in 1941. Early on, she intended the enclave as a retreat for Tibetan monks, christening it Tibet Land. Immigration problems ensued and no monks ever resided there. She then "found" gardening and focused her boundless energy, artistry and finances to create a fantasy of gardens, enlisting some of the top landscape architects of the

Until her death in 1984, it slowly became the plant playground for this plantswoman extraordinaire. Originally from Poland, this opera singer wound her way through quite a few husbands, inheritances, divorce settlements and other financial negotiations, seemingly always coming out

Walska lived large. When visiting a plant source or nursery, just a tap of her cane on a plant meant she wished to purchase a hundred of that variety. Three taps: three hundred. Five taps: five hundred. This resulted in an incredible display of mass plantings for the evolving gardens. Eventually, the estate boasted fern, cycad (often mistaken for palms or ferns), Japanese, orchard, succulent, cacti, topiary, tropical, rose, Parterre formal gardens plus several water gardens.

One water garden was fashioned from the estate's original swimming pool. Separated

areas feature the namesake lotus from India and water lilies from around the world in pink to white. The deep purple of water hyacinth and agapanthus surrounds the water, punctuated by vivid coral cannas. A whimsical water feature is a kidney-shaped pool surrounded by a necklace of abalone shells, their arrangement reminiscent of the shell necklaces from Hawaii... on steroids.

The most recently developed cactus garden was bequeathed to Lotusland by Merritt Dunlap. He collected nearly 300 species and notable specimens for nearly 80 years. When the time came to move, the cacti were carefully transported here by truck from the North San Diego County location for weeks on end. Then each cactus was planted in its original orientation to

A blue garden featuring silvery to blue-gray Blue Atlas Cedar, Mexican blue palm, bunya-bunya and blue fescue is delineated

by leftover glass from production at a nearby bottle plant. The fist to softball size chunks look like uncut emeralds lining the walkways.

One might think that this texture and color oriented landscape might be "boring" without fields of flowers (other than the roses). Yet nothing could be farther from the truth. I spent two hours picking my jaw off the ground and uttering "Amazing" over and over to my fact, story and history-filled docent, Bill Malis. Amazing garden. Amazing woman!

Walska created a foundation **Chris Bertrand** to help fund and maintain the garden, but today's caretakers welcome membership (which provides priority access to the limited schedule), volunteers and donations. According to their website, Lotusland Foundation "is dedicated to preserving her garden, to sharing it with visitors as she requested, and to increasing its value to the public by plant propagation, by the preservation of rare species and by presenting educational programs and classes." I found the condition and the pricing of their unusual plants to be quite reasonable, compared to the Huntington or the Arboretum, and almost worth the trip in itself! Yes, I filled my trunk with plant treasures!

LAWNLESS LAWNS IN SIERRA MADRE - A trend? A movement? *It is more attractive and saves water*

During occasional walks through the neighborhoods of Sierra Madre, I began to note what I regarded as a good sign. I don't yet know if it's a trend, or a movement, but it is definitely more noticeable than it was 15 to 20 years ago. People are choosing to forego the front yard for various sorts of gardens. It is a good trend because the lawn is one of those holdovers from another era that has outlived its usefulness, and I'm not sure what its "usefulness" ever was. In most cases, the lawn requires lots of work, water, fertilizer, and other herbicides and chemicals merely to "have a good lawn" or to impress our neighbors.

True, the lawn isn't entirely useless, and it is certainly better than having Astroturf artificialness, because a real grass lawn is several degrees cooler than a phony lawn. But still, the pretty lawn, for most folks, is an exercise in waste, futility, and

In the cases where homeowners have chosen something else, we've seen quite a spectrum of alternatives. Some lawns spaces are like mini-deserts, full of cactus and agave and other plants that represent the true no-water "lawn."

In other cases, I have observed what once was a lawn now covered in nasturtiums, wild garlic, herbs, and a wild splash of useful plants and colorful flowers - a far more appealing use of that space than simply grass. Furthermore, such a lawn attracts bees, butterflies, ladybugs, insects - it supports the whole host of animals that is the ecosystem. It also produces a lovely fragrance, which is more than we can say for a typical lawn, with its occasional application of cow manure, and the fumes from the power mower.

Other lawn spaces were full of vines, rosemary, lavendar, prickly pear cactus, basil, fennel, etc., with wood chips as a

These are all good alternatives and it proves that we can all grow even just a little of our food while barely trying. It is unclear why this trend is here, but I assume that more and more of us are getting the message that an ordinary lawn makes no sense, and that the herbal, wild, fruity garden makes abundant practical sense.

One day, when I was at the park, I walked over the community garden next to City Hall. I enjoyed just looking at the bounty of everyone's vegetables and herbs, adorned with the protective scarecrow and other accoutrements of the backyard garden. It made me happy to see that gardening and home food production is becoming a normal mainstream idea, and that we do not need to have the pressures of a war or economic depression to stimulate us to garden.

Also, in some of the places I have lived, I have been able to divert drain water from the bathtub, kitchen sink, and laundry to the front lawn area or garden area. I used that water to irrigate my garden, rather than send all the water down the drain to elsewhere ("elsewhere" in our case means the Pacific Ocean). Once you realize that we live here in a coastal desert plain, you'll understand why it is good to keep as much water as possible on our local lawns and gardens, helping to keep our local

For those who absolutely must have a conventional lawn, there is a trend towards lawnish non-lawns where the area is covered with edible, fragrant, and herbal ground covers such as chamomille and pineapple weed, various thymes and

mints, low-growing vines, New Zealand spinach, etc. Such lawns can be sorta mowed, and although they may look unkempt to some eyes, they do provide a lawn appearance that requires less water and maintenance, and still provide tea, food, medicine, and fragrance.





The Sierra Madre fault zone is often divided into five main segments, since it is about 47 miles long. The Clamshell - Sawpit Canyon fault, which produced the Sierra Madre earthquake of 1991, angles northeast off from the fault zone. The Sierra Madre fault zone is estimated to be capable of a 6.0 - 7.0 magnitude quake. For those who remember it, the 1991 earthquake was "just" a magnitude 5.8.



The U.S. Federal Emergency Management Agency has provided recommendations for finding safe places—indoors and outdoors—during an earthquake. These include seeking refuge under sturdy furniture, such as a heavy desk or table, preferably against a wall; stay away from where glass could shatter around windows, mirrors, pictures, or where heavy bookcases of furniture could fall over. And finally, when outdoors stay in the open, away from buildings, trees, telephone and electrical lines, overpasses, or elevated expressways.







