A Rash Of Burglaries In Sierra Madre

Since May residential burglaries have gradually increased. The crimes have occurred in the following

500 blk. N. Michillinda Ave 600 blk. Fairview Ave. 300 blk. E. Alegria Ave. 400 blk. E. Grandview Ave. 200 blk. S. Mountain Trail Ave. 200 blk. E. Orange Grove Ave.

In most burglaries the suspect(s) entered the homes by breaking a rear sliding glass door or window to gain entry. The burglarized homes had foliage that obscured the front or back yards from the neighbors' view. In all but two of the incidents the residents were on vacation. One victim had left to go out to dinner, and the other

victim was at work when their burglaries occurred. The loss has been jewelry, a DVD player, a computer hard drive, and other easy-to-carry items. The thieves used pillowcases to carry away the loot. The suspect is described as a Hispanic man, slim, short

dark hair, about 20 years old. He was seen driving a white 2003-era Toyota Scion, square back, with black

Be alert to the presence of anyone matching the description of the suspect and vehicle and do not hesitate to call police. To prevent crime, consider the following:

None of the homes had burglar alarms; None of the victims who were on vacation had notified the police to ask for a vacation check. To ask for a vacation check, call the Police Department at 355-141. Officers will regularly check your home and property while you are away.

Most of the victims had not participated in a Neighborhood Watch program. Call 355-1414 and ask for Off. John Ford or any supervisor to set up a Neighborhood Watch presentation. You may also email Off. Ford at iford@ci.sierra-madre.ca.us

Most of the burglarized homes were on or adjacent to major streets leading in and out of the city: Michillinda, Grandview, Orange Grove.

Call the police whenever you see suspicious people and vehicles. Sometimes burglars will case a neighborhood by asking for work, offering to sell a service or product, seeking a fictitious neighbor or address, or young kids asking to retrieve a ball or pet in the back yard.

Officers are vigilant in looking for suspicious people and circumstances; however, we must rely on the public to share our responsibility. Keep Sierra Madre safe by calling the Police Department any time you see someone or something suspicious.

That Sound You Hear...The Horn Is Back!

If you were in town last Tuesday afternoon, you may have gotten a real blast! The City of Sierra Madre's emergency Horn was tested and could be heard city wide.

Later in the evening, the City Council unanimously approved using the bell again to notify residents in emergencies only of dangerous events such as floods, mudslides, earthquakes and fires.

The horn (and its' predecessors) have lived and worked all over town, assisting the police and fire departments.

It is currently housed at the city's public parking lot on East Montecito.

There are still details to be worked out regarding when best to test it so that it does not disturb local businesses. Hopefully we will never have to use it for an emergency. However, if you ever hear it being tested, you won't forget that sound!

RESCUE TEAMS SAVES MAN IN MINE SHAFT

A 34 year old resident of Sonora California fell down a 100 foot mine shaft on Friday in a remote area of Northern California. He was exploring the abandoned mine near his father's property when he tumbled down a vertical hole in the floor, which had a 45 degree slope half way down. This slowed his fall before he plunged an additional 50 feet straight down to the bottom of a second shaft. His landing was softened by a pool of water at the bottom of the dark shaft. He remained in total darkness, by himself, until the next day.

His friend, who accompanied him to the opening before leaving, reported him overdue. The Tuolumne County Sheriff rescue team found him but realized that they did not have the expertise to rescue him safely considering the rock-fall danger from above. Dry clothing, a helmet, and light were provided for the victim while he

waited for extraction from the hole. After provided medical treatment, and remained calling for help though the State Office of Emergency Services, eleven rescuers from the Sierra Madre Search and Rescue Team, Montrose Mountain Rescue, and Antelope Valley Search and Rescue Team responded. All three teams have personnel with mine rescue training, which would be used for this rescue. They were flown to the rescue site some 330 miles north by the L.A. County Sheriff's rescue helicopter.

Madre and organized the extraction crew at the lip of the shaft. Using tripods from the Montrose and Antelope Valley teams, Fortini and his crew had to use a rope raising system that allowed for the unusual configuration of mine shafts. The Montrose team coordinated the overall situation under the leadership of Bruce Parker.

Sierra Madre team member, Eric Triplett, and Cindy Shute from the Antelope Valley team went to the bottom of the shaft,

with the victim until he was hoisted up to safety. After 30 hours in the mine, the victim was transported to a local hospital for treatment, where he was treated and released with only minor injuries. Interestingly enough, the victim made it safely home to his family before the Sierra Madre Search and Rescue Team was able to get back to town.

Art Fortini, of the Sierra Madre team said Art Fortini led the contingent from Sierra that the Team is cross trained with a number of different rescue skill-sets that include mine rescue operations, medical training, as well as mountain search and rescue. This all-volunteer team is versatile and is often called to other parts of California to assist in search and rescue operations.

Kevin Paschall Appointed To Planning Commission

After a two month stalemate Paschall's garage. over how to pick new planning commissioners, the city council Tuesday Paschall was a candidate in the April city council elections.

The council was divided over the matter of how to select commissioners, two motions failed which dealt with the selection process. Mayor Kurt Zimmerman finally suggested

Don Watts seconded the motion. And, after a pause, Mayor Pro Tem Maryann Macgillivray voted Paschall was appointed with a 3-2 vote. After the vote a number of council members were still confused over what what they just did. City Clerk Nancy Shollenberger then read them back her notes.

Councilmember Joe Mosca was the first to oppose Paschall saying they did not know his qualifications. During the April elections a number of residents questioned Paschall over renovations to his garage, Associate Planner Jae Hill





Gotta Dance!

SAN MARINO, Calif. The California Philharmonic will celebrate the end of yet another extraordinarily successful summer season at The Arboretum in Arcadia, where each of the orchestra's past five concerts has averaged over 4000 in attendance, with "Gotta Dance!" on Saturday, September 6, at 7:30 p.m.

"After all, what's a celebration without dancing?" asks Cal Phil founder and Music Director Victor Vener. "Part of the fun of a concert under the stars is being able to move to the beat in whatever way the music sways you - whether that means doing the twist or dancing a waltz."

As audiences at Cal Phil have come to expect after a season that included works by composers ranging from Rodgers and Hammerstein, Andrew Lloyd Webber and John Williams to Puccini, Beethoven and Ravel, "Gotta Dance!" will showcase an eclectic array of 'dance tunes.' On the program are Johann Strauss II's The Blue Danube, Igor Stravinsky's The Firebird, Anitra's Dance from Edvard Grieg's Peer Gynt and Four Dance Episodes from Aaron Copland's Rodeo, plus hits by Glenn Miller, The Mamas and Papas and The Beatles.

"It's all great music," Vener explains. "For instance, who doesn't recognize The Blue Danube instantly? It's one of the most consistently popular works in the classical music repertoire. In fact, legend has it that when Strauss' wife asked the composer Johannes Brahms for his autograph, Brahms wrote down the opening bars of The Blue Danube, followed by the words, "Unfortunately not by Brahms."

Stravinsky's The Firebird - commissioned in 1910 by the world famous impresario Sergei Diaghilev for his new ballet based on Russian folk tales describing a magical glowing 'firebird'- was equally popular, adds the conductor. "Stravinsky became so linked in the public's mind with The Firebird that he was once addressed, quite seriously by an admirer, as 'Mr. Fireberg,' "says Vener.

Gotta Dance! will also travel to the American Old West when it presents Four Dances Episodes from Copland's score for the ballet Rodeo. "Close your eyes while the music is playing and you'll see cowboys and cowgirls square dancing," Vener promises. "And you'll really want to kick up your heels during the Hoe-Down."

When it comes to kicking up ones heels, no one was more of a master at it than Peer Gynt, the hapless adventurer in Henrik Ibsen's play Peer Gynt.

Gotta Dance! will present Anitra's Dance from Grieg's incidental music for

the drama, composed at the request of the playwright. Peer has journeyed to North Africa, where he is the guest of an Arab chieftain, whose daughter, Anitra, beguiles him at once with her

"Peer Gynt was a collaboration between the two greatest Norwegian superstars of the time," explains Vener. "For Anitra's Dance, Grieg composed a score as sensuous and enticing as you'd expect a belly dance to be. Cal Phil's audience will be equally beguiled as well. The melody's so entrancing and exotic, it's impossible not to be."

Meanwhile, those enamored of 1960s pop music will not leave the performance disappointed. "Gotta Dance!" will present such chart topping hits as California Dreaming and Monday, Monday by the Mamas and Papas as well as Symphonic Sketches of Four Beatles Songs by local musician Tom Pedrini.

"The Sketches include Norwegian Wood, For No One, Penny Lane and Eleanor Rigby by John Lennon and Paul McCartney," says Cal Phil composer in residence, Roger Allen Ward, whose Symphony No. 1 will receive its world premiere in 2009. "You'll recognize that these are indeed Beatles songs but, as you'll learn from the opening note, they're glorious works for the orchestra as well."

Since, for many, an evening of orchestral dance music would not be complete without the Big Band sound of Glenn Miller, Cal Phil will also present two of the band leader's most iconic hits: String of Pearls and In The

"If Cal Phil had to select one song to describe its mission, it just might be In The Mood," muses Vener. "We're always in the mood for great music --



played by Wilson in Pio Pico ascendancy to the Governership of California, the last Governor under Mexican rule. would later serve as a pallbearer at Wilson's funeral. Wilson also lead the American troops in the first Southern California battle of the Mexican/American War. Captain Wilson was captured and was a POW. After the war ended, he sold Riverside, and bought land in downtown Los Angeles, 12 acres in what is now Union Station. He served as the original County Clerk of Los Angeles County and so he established the first American government in Los Angeles. He was on the first City Council of Los Angeles, and served as its second mayor and bought land that eventually became San Marino, Beverly Hills, Westwood, Culver City, Santa Monica, Venice and much more. While serving as a supervisor, he oversaw a territory that included what now includes Los Angeles, Orange, San Bernardino and Kern Counties. As a state Senator, Wilson represented a district which today is represented by twentysix different senators.

Wilson was president of the first railroad in Los Angeles, and the Big Four railroad companies of the time wanted to build a railroad from San Francisco to San Diego by way of Colton, to avoid having to build through the Tehachapis. According to Read, Wilson, at his own expense, traveled to Washington to lobby "to have five words put into the Big Four's authorization, and those five words were by way of Los Angeles. And he got those five words put in..." Wilson paid a major role in making San Pedro into what is today the world's largest artificial harbor in the world.

Read touched briefly on Wilson's family, including three marriageable daughters and a neer-do-well" son who died at an early age, noting that an entire chapter is dedicated to Wilson's second wife. Wilson was also the grandfather of Gen. George Patton.

Economic **Future Not** So Bright

IndyMac Announces New Program

According to a panel led discussion Congressman Adam Schiff (D-ČA) on Wednesday, the economic forecast regarding the country in the upcoming months is one of gloom. Held at the Pasadena Senior Center and moderated by Frank Motteck of KNX 1070 Newsradio, the panel included John Bovenzi,

the Motteck, host of "KNX 1070 Business Hour" and an award-winning journalist. Motteck announced the panelists prior to giving the microphone to Bovenzi of IndyMac for a special announcement.

"Today the FDIC announced a program to modify loans to make them more affordable for people who are having difficulties making their mortgage payments," said Bovenzi. "When we talk about the market—one housing of the problems is that more and more people are not being able to make payments as rates go higher and more homes are

Chief Operating Officer (FDIC) and Interim Director of IndyMac Federal Bank and experts in housing, the stock market

and energy issues. "There's a level of economic insecurity in the country that we haven't seen in years, maybe in decades," said Schiff. "One of its major roots was in the housing market where banks responding to the demands of Wall Street investors—greatly expanded the use of 'no document' loans and mortgages."

During the two-hour discussion, about 50 people vented frustration in what should have been a question and answer period. Almost all of the comments fell into two categories, either IndyMac Bank or the

country's energy policy.
Wearing a T-shirt that read, "shut up and drill," one person said that the cost of oil had gone down in the last few weeks with the speculation of drilling, "Can you imagine how far it would go down if we did?", he said. Another person said paying \$5 a gallon was a reality that people understand. Schiff said that no matter how much we drilled, we could not escape the fact the U.S. only produces three percent of the world's oil but uses 25 percent. He said the only way out was to reduce our dependency on foreign oil.

Others asked specific question to Bovenzi about IndyMac Bank. Most of the questions were deferred to his staff. One person thanked him for standing outside the bank the day it was taken over by the FDIC, assuring everyone they would get their money.

Prior to the Q &A Schiff had pointed out that one of the other major sources of economic instability is in the field of energy, due to the world's increasing demand and finite supply. Schiff then gave the spotlight to

going into foreclosure. It's important to stop the rate of foreclosure so we can stabilize the housing market and get it to eventually turn

The rest of the panel included Alberto G. Alvarado, Director, Los Angeles District Office of the U.S. Small Business Administration; Raphael Bostic, Professor, USC Lusk Center for Real Estate; Judy Dugan, Research Director, Consumer Watchdog; Dr. Lawrence Harris, Professor, Finance and Business Economy, USC Marshall School of Business; Marc Jones, Rehab Construction Pasadena Manager, Neighborhood Housing Services; and Martha Lucey, CEO & Executive Director, ByDesign Financial Solutions.

'These are challenging timesandthere's no question that businesses are being impacted," said Alvarado, on behalf of the Small Business Administration. "It is certainly the case that often a slow down in the economy like we're experiencing affects small business owners in many ways."

The final person to speak was Dr. Raphael Bostic, a housing market expert and professor the USC Lusk Center for Real Estate. Bostic seemed to put a more positive spin on the current economic crisis by looking to the future.

"It's going to take a little while to work through these problems from my point of view," he said. "I think that legislation that Congress is talking about is helpful but it will take a lot of steps to turn math around and stabilize the situation."

With so many people wanting to speak, the discussion went over a half hour. To make sure everyone got a chance, Motteck cut off those that were long winded. He was also watchful for redundant questions.

Youth Summit Hosts Pro Skateboarder

As a way to provide safe and healthy activities for youth, Pasadena nonprofit, Day One, held their annual Youth Summit Wednesday, with over 250 teens —many who got to meet first hand the legendary 1970s skateboarder Dennis Martinez.

Martinez told his life story as the number one "old school" skater and how he fell from being the best to a thug over the use of drugs and alcohol, something he said ran rampant through the early days of skateboarding. Covered in tattoos, Martinez said the "dope" life is far from glamorous.

"The message from me is, I was part of the problem and now I want to be part of the solution," he said, adding that he has now been free of drugs for more than a decade.

"We're attacking this drug world," he said. "I'm tired of hearing the schools saying, 'we have an epidemic, what can we do about it?' I have heard that from the DEA, the parole [board, and] in prisons. 80 percent of America is locked up because of being under the influence."

Martinez is currently a volunteer pastor at a California maximum security prison, telling his story. Recently he made the movie "D.O.P.E" about his life, and that of other skaters such as Jay Adams, Christian Hosoi, and Bruce Logan, all of whom also fell because of drugs he said.

The movie was shown at Wednesday's summit held at Pasadena City College Education Center. Many of the teens also signed a petition urging the city to build a better skate park and improving the existing one at La Pintoresca Park. As a converted tennis court, the skating area has ranked low among local skaters, who said they go to Bonita Skate Park in Arcadia.

"They want something like that here," Day One Executive Director, Christy Zamani, said of Bonita, which has cement banks, staircases, rails and spines reminiscent of the skate parks from 1980.

Martinez answered questions about skateboarding from the 1980s, an era during which many attending were not yet born. He said part of his fame came from inventing the "front side air," one of five basic tricks from which all skateboarding is derived. Others include tricks like "backside airs," "grinds," "rock-in-rolls" and "ollies."

Most of the questions were about skateboarding tricks, although Martinez said he hoped they didn't follow what he did as far as crime.

"You're a lot smarter than my generation, the generation I came from," he said. "I look out there

because there are a lot of people here that aren't going to do what I did and I see success waiting to happen."

He also said he thought drug prevention should start at age five, adding that skateboarding was only his story but could substituted with anything such as rap music or tagging. D.O.P.E he said stood for "Death or Prison Eventually."

Martinez said the movie was about him because Jay Adams and Christian Hosoi both just came out with documentaries. Adams is still in rehab after serving four years in prison for drugs, he said. Los Angeles Probation Commissioner Josof Sanchez said they planned to have Adams speak but this even was too soon.

Sanchez said he had juveniles that came to hear the message because they like skateboarding. He said one teen was brilliant in math but caught up in the gang lifestyle and another that got kicked out of school for bringing a gun onto a school campus. "They were all jazzed up just to come here and hear them speak, I got them out of jail and now they're in a program because of Day

Zamani explained the summit was aimed at youth 13 10 18, "It's going through a name change and next year it will be called, The Teen Summit," she said.

She also said the goal was to provide workshops around the main interest of kids. They pick what they want, she said, also explaining that this year drew the largest crowd. "I'm not sure it was totally skateboarding,

but you could see how engaged they were throughout this whole movie," she said. "Adults like this one ,so you could only imagine what they thought."


Zamani also said they also had a number of other actives including hip hop music.

Mulching: Nature's Composting Secret

Mulching is nature's recycling system. Nature spreads thin layers of organic materials evenly over the surface of the soil. Year after year, season upon season, leaves and blades of grass mature, die and fall to the ground. Soil organisms begin the process of decomposition. First molds, then bacteria, later earthworms and beetles all come to return organic matter back to the soil from which it came. In this process of natural mulching, topsoil is gradually created over time. Rich layers of humus—decomposed organic matter in the soil—are formed that give the soil its dark color and good rich-earth smell.

You may find it surprising that the first bit of advice is to avoid composting as much as possible by learning how to mulch various organic materials, especially grass clippings. Mulching simply refers to any technique where organic matter is spread in thin layers on the surface of the ground and left to decompose naturally so that the soil organisms can convert to humus.

Decorative bark layered around shrubbery is a popular mulch. Wood chips are often spread around trees and landscaping to hold moisture. Grass clippings, leaves and compost can be placed around garden vegetables, flowers and in soil beds to keep down weeds. Leaving blades of grass on the lawn is the most common mulching technique. All mulches help retain water in the soil. Mulch keeps the soil cool in the summer and warm in the winter. In fact, mulch is a form of drought insurance. Mulching is the easiest way to avoid generating organic waste in the first place. Earth911.org

History is bound to repeat itself and why not if it was a good thing then why not now?

A column previously asked where you were at 11:41 a.m. July 29, 2008.

If you were trying to use your cell phone the day of the Chino Hills earthquake, you were nowhere. The system didn't fail, the human usage was the problem--too many people, all at once, and most likely asking their family and friends "... did you feel the earthquake?"

So, how does Sierra Madre's history help us out here. There is a horn, a very loud horn, for emergency alerts that was essential in the past. It could be heard all over town as it needed to be heard all over town. Technology changes and the horn to alert the volunteer fire fighters and police no longer needed the system of blasts to tell them what and where.

What is the plan for the horn now? How can we use it to our advantage?

Back to the cell phone overload. If there is an emergency it is planned that the horn can send out blasts in series of three: Three of anything signals an emergency and you don't have to remember any longs or shorts that you might have studied for you scouting badge. Then

Well, for certain DO NOT CALL the police,

fire or paramedics unless you have a police, fire or paramedic emergency. The three blasts of the horn will mean that unless you have an emergency you should turn on TV Channel 3

> or go to the city web site. If the electricity is off and none of that works, or you do not have TV Channel 3 or a computer, what is planned when all of this is back in place (the details are being worked out now with citizen input and support of the City Council, the Kiwanis Club and the Sierra Madre Fire Safe Council) you would use the battery radio in your earthquake kit or in your car and turn to the local Emergency Radio broadcast.

> This is the plan. It is in the design stages. Your input is important to the safety of all Sierra Madre.

> The next Fire Safe Council meeting will be September 8, at 7 p.m. in the City Council There will be a presentation from the Sierra Madre Police Department on the Neighborhood Watch program. 

Mosquito Troubles: Don't Forget About The West Nile Virus!



The California Department of Public Health and the Greater Los Angeles Vector Control District recently detected WNV in nine new dead birds and eleven mosquito pools in Los Angeles County. The infected birds were found in the eastern region of Los Angeles County near the San Gabriel Valley area; WNV-infected mosquito pools, however, were found mainly in the San Fernando Valley.

'West Nile Virus can appear anywhere in Los Angeles County or around the state. Our warm weather encourages mosquito breeding, but the weather is also an invitation for individuals to spend more time outdoors. When they do, residents should take precautions to avoid mosquitoes bites," said Jonathan Fielding, M.D., M.P.H., Director of Public Health and County Health Officer. "People should make sure pools of stagnant water are removed from around their homes and to wear insect repellant containing DEET or picaridin, when outdoors in mosquito prone areas, especially close to dawn

Approximately 80% of people infected with WNV do not exhibit symptoms. Some 20% or 1 in 5 infected persons may develop West Nile Fever, with symptoms such as high fever, headache, body aches, nausea, vomiting, and sometimes a skin rash on the chest, stomach and back. Symptoms can last anywhere from a few days to several weeks. Other WNV symptoms include stiff neck, stupor, disorientation, coma, muscle weakness, and paralysis.

The elderly and immune-compromised individuals, i.e., those with HIV/AIDS, diabetes, or hypertension, are at greatest risk for serious

People can decrease their risk of infection by following these recommendations:

- Check for and remove all sources of standing

- Change the water in wading pools, birdbaths and pet bowls twice weekly.

- Place mosquito-eating fish in ornamental ponds and water gardens.

Make sure that doors and windows have tight fitting screens. - Repair or replace screens that have tears or

- Avoid mosquito-infested areas at dawn and



- Where it is necessary to be outdoors during these times, wear long pants, long-sleeved shirts and other protective clothing.

- Use repellants containing DEET, picaridin, or oil of lemon eucalyptus, according to label







The Mountain Clymer On The Road Again

I had waited all summer to get out of town and finally, last Monday, it happened. With all of the work at last completed on my friend Charlie's motor home, we were hitting the road once again. It was on the way home last year that things started to go wrong, first there was the strange light that came on warning about

something being wrong with the brakes, then there was the transmission struggling on the hills, and then, with just an hour or so left in our week long trip, a tire blew out. DAN ROTEN - MUSIC AT SIERRA MADRE'S BEAN TOWN

It's Thursday night in Sierra Madre. There's a lively crowd at Bean Town on Baldwin Avenue and Singer/Songwriter Dan Roten is singing his stories to the crowd. Some are there just to listen to him, others are there to work on their laptops or to socialize, and their heads pop up when they hear a noteworthy phrase.

I take a seat with Teresa and we listen to the stories about his life. Of love lost and found again, and lessons learned from heartbreak, pain and joy that comes out of surviving it. We're waiting to hear our favorite song, which he usually plays towards the end of the night – his tribute to Bean Town, the folksy Coffeehouse which artist Steve Hardy calls "the nexus of Sierra Madre."

During a break, I get a chance to sit down with Roten and learn a little more about this Thursday night Bean Town "regular."

Roten, who was born and raised in Los Angeles, spent a couple of years in Nashville, and has lived in Sierra Madre for the past 4 years. When asked to describe his style of music, he says it's a combination of adult contemporary/crossover country/folk/rock. I don't know what that means, but I nod as if I do. His voice and songwriting style have been compared to Bob Seger, Marc Cohn, Jim Croce, Stephen Stills, and Phil Collins. But of course, Dan Roten is an original.

Roten has been interested in music all his

life, but never picked up a guitar or written a song until his midtwenties.

"My life had reached a point where the choices I was making weren't working for me anymore. I had to make some chang-es and face the feelings and issues I had been suppressing and running from most of my life. I learned a few chords out of a Roll-

ing Stone's songbook and saw that almost every song had the same 3 or 4 chords. I was able to put my feelings on paper and eventually learned a few more chords and discovered that you don't have to know how to read music in order to be able to write it," explains Roten.

Roten went through many jobs trying to figure out where he fit in, trying to heed his father's advice that "you need to find a good job with security and benefits." His mother had always told him "find something you love doing and would do for fun and for free, and everything else will work out."

It wasn't until his father's suicide right before Christmas in 1993, just a month before his retirement, that he felt that his mother was right.

Security and benefits don't mean that much if you're not doing something that makes you

happy. My father's death freed me -- I decided to quit my job as a plumber, which paid well and had great security and benefits. I wanted to be able to live with the fact that I had at least made an attempt to pursue the music, even though I had no clue of how to go about doing it". Roten ended up re-

cording a CD his songs and used it as a sort of business card, which

opened the doors for many musical performance jobs. He began playing at small coffeehouses, put together a band, and his list of gigs began to grow. He played for a couple of years at Gladstone's and The Upstart Crow Bookstore at Universal City Walk, and then found a booking agent who got him corporate work with Starbucks, outdoor malls, street festivals, local restaurants, and the Sierra Madre Concert in the Park Series.

Every Thursday for the past year he plays at Bean Town. He currently has two CDs of his original music available. In performance, "I tend to do more obscure cover songs by artists who have influenced me," he says. "I stay away from the

Hotel Californias, Free Birds and Margaritavilles because I don't want to feel like a human jukebox. The songs I have written have come when I was finally willing to let go of any expectations or frustrations. The songs kind of drop out of the sky when they're ready. I just have to be awake and have the awareness when they do. I'm still amazed every time it happens and then wonder if it will ever happen again," says Roten with a smile.

My songs are all stories that I have lived," says Roten. "When I first heard Bob Dylan's 'Blood On The Tracks' album, I was touched by his honesty and vulnerability. I know if I'm singing about my life, people will connect the song to their own experiences. I learned when I lived in Nashville that most of the Songwriters there write songs about what they think people want to hear. I try to focus on writing songs about the things I need to hear. That pain, struggle, loss and disappointment are part of growing up. To appreciate those special defining moments and know they may never come again, and that it's never too late to learn how to give and receive love. I try to appreciate that I'm doing what I love to do for a living, that even through the noise of babies crying, blenders and breaking glass, there is always someone out there listening."



FIRST-EVER IMAGE OF A SINGLE PARTICLE of Martian dust is the latest achievement of NASA's Phoenix Mars Lander, using its atomicforce microscope.

The particle—observed at higher magnification than anything ever seen from another world—is about one micrometer, or one millionth of a meter, across. It is a speck of the dust that cloaks Mars. Such dust particles color the Martian sky pink, feed storms that regularly envelop the planet, and produce Mars' distinctive red soil.

"This is the first picture of a clay-sized particle on Mars, and the size agrees with predictions from the colors seen in sunsets on the Red Planet," says Phoenix co-investigator Urs Staufer of the University of Neuchâtel, Switzerland, who leads a Swiss consortium that made the microscope.

It took a very long time, roughly a dozen years, to develop this device, which is operating in a polar region on a planet now about 220 million miles from Earth.

The atomic force microscope maps the shape of particles in three dimensions by scanning them with a sharp tip at the end of a spring. During the scan, invisibly fine particles are held by a series of pits etched into a substrate microfabricated from

a silicon wafer.

shapes of particles as small as about 100 nanometers, roughly one one-thousandth the width of a human hair. That is about 100 times greater magnification than seen with Phoenix's optical microscope, which made its first images of Martian soil about two months ago. Until now, Phoenix's optical microscope held the record for producing the most highly magnified images to come from another planet.

"I'm delighted that this microscope is producing images that will help us understand Mars at the highest detail ever," Staufer says. "This is proof of the microscope's potential. We are now ready to start doing scientific experiments that will add a new dimension to measurements being made by other Phoenix lander instruments."

FOR ME, THE ABOVE REFERENCE TO THE UNIVERSITY OF NEUCHÂTEL awakened fond memories, as I once spent a student year in that lovely French-speaking Swiss town, with a view of the Bernese Alps eastward from my bedroom window. The news that my former school was involved in anything as futuristic as a microscope on Mars took me quite by surprise. I recall Neuchâtel as the habitat of eccentric French professors happily immersed in the past—more conversant with the likes of Moliere, Voltaire, and Jean-Jacques Rousseau than with the Space The atomic force microscope can detail the Age (which, in any case, had not begun yet).



down Route 66 with me. This week at the Chef Knows we are going "Old School". How about a place with some red leather seats and a great drink for under (\$10.00)? Maybe a lady named Marge to serve us? So if I am dreaming, please don't wake me.

This past week I booked a reservation at Twin Palms Restaurant in Old Pasadena for my wonderful Mother's Birthday. The meal itself was unbelievably forgettable and the magic of Kevin Costner appears to have moved to a different theater. I ordered an Ice Wedge lettuce salad (\$7.95). I just felt my wallet shrink with that order. Not much to this plate but a 1/6 head of lettuce and some Blue Cheese dressing as a gesture. Where were the crumbles or the bacon bits? I look forward to going here again with little more enthusiasm than my dentist, but at least he takes insurance. This isn't "Old School", heck this isn't even the Old Twin Palms. We've got to get out

I know the place with a simple appetizer and a lot more - it's Taylor's in La Canada. Taylor's originally started on 8th St. in downtown Los Angeles. Tex Taylor started his clubby namesake restaurant over 40 years ago. The downtown location is still going strong. His son, Bruce Taylor has since taken over the reins and opened a second location in La Canada. Red leather booths, full bar and veteran servers like Marge, just like the good old days. That's what I want.

Look there, a nice bone in Porterhouse; now I truly am in heaven. An angel must have made this Molly Salad, because it is amazing. I have to believe that no matter what a restaurant owner tells you, all the beef comes from essentially the same purveyor. Newport Meat Company seems to be the top choice. Some owners may brag that they buy the top 2% of the cow. So going on my theory, I rank Taylor's right up there with the best of them. Prices, even with the recent increases, are still very reasonable. It is accepted, now that the entrees are a la carte at the high end steakhouses. Taylor's is nostalgic and still offers a dinner salad with each entrée. Go for the Molly Salad - it's a wedge of lettuce with tomatoes, onions and blue Cheese dressing, and I am sure it is the best in town. Yes, I said the best in town! Is the radio too loud for you?

She incorporated 40% ash into her concrete patio for increased durability while diverting the ash from its landfill destination. A 12x12 gazebo by Envision Solar, with solar electricity service is going up. Her formaldehyde-free kitchen cabinetry is custom made to her green specs. The "out there" feature I hadn't previously heard of was applying American clay to the walls, as a finish like plaster. This clay then emits negative ions, purportedly counteracting the positive ions of our high tech environments. Visit www.AmericanClay.com for more information.

Three additional designers applied their design savvy. Mario Savarino took on a 6000 square foot Altadena estate built in 1910, preserving the period feel while offering the modern conveniences of 21st century life. Marlene Oliphant remodeled and updated a cramped and dark, 1932 Spanish bungalow in Glendale. The centerpiece around which the rest revolves are vivid, handmade Malibu tiles. 


