OneCarter/Stonehouse Legal Woes Continue

Court Grants Creditor Injunction -Projects Are In Receivership

Earlier this month, Capital Source Funding, the lender who advanced \$38 million to the developers of One Carter and Stonehouse, filed suit in Los Angeles Superior Court asking for a Judicial Foreclosure of the Trust Deed and the appointment of a Receiver. The court temporarily granted the request, issuing orders and appointing a Receiver. A hearing for a permanent injunction is scheduled for September 8, 2008.

The primary reasons stated in the lawsuit, which also names additional Dorn-Platz affiliated entities, was the failure of One Carter LLC to perform as stated in the loan agreement executed in 2005. The borrowers defaulted on the loan, which advanced \$27,495 million to the One Carter project and \$9 million to the Stonehouse project. Specifically, they failed to:

Pay the interest on the loan since March 1, 2008; Sell the One Carter property prior to June 30, 2007; Settle the lawsuits with the City of Sierra Madre and Stonehouse;

Gain approval and provide proof of the Vesting Tentative Tract Map for the Stonehouse property;

Arrange for the final hearing with the Sierra Madre Planning Commission and get the Commission's recommendation to the council to certify the Environmental Impact report;

Arrange for the City Council to certify the final environmental impact report prior to Mat 31, 2008 and

Enter into a purchase/sale agreement for the sale of Phase 2 by July 1, 2008.

In May of this year, one of the original investment groups attempted to foreclose and/or sell their interest in the properties, but a ninth hour agreement with all parties took that sale off the table.

The receivership bars the developers "from interfering with the receiver in the performance of his duties." The Receiver will see to it that the necessary infrastructure work required by the city is completed before the rainy season. In addition, the Receiver will attempt to settle the lawsuits with the City and, if permanent orders are issued, they will proceed with the development of the project.

To the delight of many residents, the control of One Carter and Stonehouse by Dorn-Platz appears to be over.



MT. WILSON TOLL ROAD TO OPEN

The Mt. Wilson Toll Road has been closed since a second major slide occurred in February 2005. This slide was the second within two months resulting from heavy rainstorms. It is so massive that many questioned whether or not it could be opened. The slide is just uphill from the Eaton Canyon Bridge. This road has been essential for fire-fighting access to the Forestry Station at Henninger Flats, which helps protect the mountains above Altadena and Pasadena. With this fire road closed it has been necessary to travel over an hour in the Angeles National Forest to get to

This month the Los Angeles County Board of Supervisors approved funds to open this famous road. Work to clear the road is scheduled to start in October 2008 and be completed by April 2009.

The road was first opened in 1891 as a passage to Mt. Wilson. It was closed in 1936 when it was turned over to the Forest Service. The Toll Road is known to hikers for its' pleasant 2.7 mile route to Henninger Flats and beyond. Until the slide occurred, the road provided spectacular

views of the city most of the way. The narrow path currently visible across the slide is considered very dangerous and should not be

Central Arroyo Stream Restoration team

Although Wednesday was the official dedication ceremony for the Central Arroyo Stream Restoration Program, Arroyo Seco Foundation Director Tim Brick explained later what else could to be done to improve the waterway including his wish to remove as much concrete as possible.

The \$2.5 million project started in January and is scheduled to complete this week.

According to project the "best leaders, management practices project" included water quality islands to filter oil and grease runoff in the Brookside Park parking lot, removal of invasive plant species, planting native California reconfiguring trees, the streambed to foster reintroduction of the native Arroyo Chub fish and installation of more than 400 trash capture screens to prevent litter and debris from entering the Arroyo Seco stream.


"We're putting native fish back into the stream," Brick said. "It seems to me that is such a transformative thing to do... when you all of a sudden put the Arroyo Chub back in the stream, I think it changes everyone's concept of what the Arroyo Seco is."

Brick explained that good conditions for the Arroyo Chub, a small minnow like fish not more than four inches, is an indicator of the heath of the stream.

"If we can get the conditions right, and we think we have so far, for the Arroyo Chub we will have gone a long way to restoring better conditions for other species," he said. The next project, in Bricks eyes, would be to remove a miles long cement channel connecting the upper Arroyo and the lower Arroyo. Although also optimistic, CDM Principal Engineer, Ted Johnson said in order to do that, part of Arroyo Boulevard would have to be moved. The channel was built in the 1930s.

"What would be more likely would be to make it, soft bottom," he said. "It could be more natural, with trails along it for people to walk."

Brick and Johnson discussed many other ideas for improvements along the Arroyo as they led a group of about 10 residents down to the stream after the ceremony. Brick suggested terracing the area for runoff. He also suggested fixing abandoned staircases, making nice walkways, that once housed a raised water pumping station, "That could make a good

of trash was still visible, to divert water. Brick said that was nothing like what it was. He said hundreds of volunteers had helped with clean up. They also improved the existing trails he said.

Brick said one day he would like to see trout, which were once plenty, re-established to the area

Pasadena Given DNC **Spotlight on CNN**

The days leading up to Barack Obama's acceptance televised of the Democratic Party's nomination for presidential office were exciting times for the Pasadena Area United Democratic Headquarters. June the organization started planning a local celebration to coincide with what was to be considered momentous moment in history when Obama would become the first black American to win a major party presidential nomination.

With everything in order, the group posted the event on Obama's official website—hoping to fill the 1200 seats to capacity.

Elliott Cuite became the Technical Director, with the responsibility

synchronizing of and providing broadcast feed would simultaneously broadcast along with Obama's speech from the Democratic National Convention, taking place in Denver. Mike Lee chose to be the Field Director—his task was to coordinate the ushers, volunteers and the merchandising at the event.

"I think Obama sees



us as what we could be and where we should be, rather than where we are and that's why I'm here" said Lee. "I think Obama doesn't think in the box about all the politics, or who gets credit. He wants a better America for his kids and everybody's kids and I think in his head he sees the dream."

A publicity committee was formed to get the word out to local press, which quickly got the attention of local media.

newspapers promoted the event and local network news started showing up at the headquarters. The committee hoped that this would spark public interest. Then on the morning of the event Jon Fuhrman, one of the campaign managers of the UDH, received a phone call from CNN.

"CNN had been paging through Obama's website event listings looking for some local color—or something interesting to do—when they stumbled upon ours and thought this occasion really stands out," said Fuhrman. "So they called me and said that this is CNN National News and we're interested in what you're doing."

Suddenly, by midafternoon CNN was at Blair High School setting up equipment for Pasadena's moment in the spotlight. But no one knew to what extent the coverage would be until the crowds started filling the seats to capacity, in anticipation of Obama's speecĥ.

"We didn't know what they would cover, or how much coverage we would get," said Fuhrman. "I think the quality and the excitement of the crowd visually made it so interesting that we got some serious airtime."

Fuhrman credited the success of the event to the volunteer efforts that came together to make it happen.

We had a fantastic crew of people handling ushers, merchandise, parking and the press," he said. "There were volunteers all over the place and by and large people went with the flow and it all clicked."

Leaf Blowers: A Double Environmental Assault By Pat Birdsall

Emissions from gasoline powered leaf blowers include particulate materials; carbon monoxide, nitrogen oxides and hydrocarbons (CO, NOx and HC). The dangerous dust they stir up includes airborne feces, allergens, molds and pollens. Materials or toxins found in street dust as examined by the Los Angeles chapter of the American Lung Association include traces of arsenic, cadmium, chromium, nickel and mercury. The study produced research that illustrates that leaf blowers generate as much pollution in one hour as a car driven for 100 miles produces.

One of the more disturbing features of leaf blowers is the major contribution that they make to

One of the more disturbing features of leaf blowers is the major contribution that they make to noise pollution. Leaf blower use at one residence impacts eight to fourteen neighbors. Excessive noise pollution is associated with increased blood pressure, headaches, ringing ears and a lower

Leaf blowers are used mainly in residential neighborhoods where many types of residents are exposed to their pollutants and noise. This population includes homemakers, retirees, day sleepers, young toddlers, the ill or disabled, and pets.

The leaf blower is a familiar nuisance that deserves greater public awareness and concern.



Children's Charity Alumni Reunion

(PASADENA, CA)--After five institutional placements, repeating two twice, and two foster home placements, Brenda H.* made Hillsides, a Pasadena foster care charity, her last residential placement in 1953. For Brenda, now 68 and who visited the charity during the 95th anniversary alumni reunion, Hillsides was "of all the places the best."

Born to a teenage mother who wanted to place her in an orphanage, Brenda recalls learning that her grandmother wouldn't let her daughter do that. Instead, Brenda found herself at the age of the four going in and out of children's residential placements. Having experienced numerous failed placements, Brenda believed she was qualified to assess the following home she would enter.

"Hillsides was a joyful place compared to other placements. Not only did they provide nourishment, clean clothes, food, and bedding, Hillsides gave us warmth and love," she told fellow alumni. "All of us that came to Hillsides shared something in common—our lives had

been disruptive and broken before we came here."

Brenda, a Pasadena resident, recalled the structure and security the home offered. When she looks back at her favorite childhood recollection, Hillsides comes to the forefront of her mind. Referring to the home as heaven, she remembers performances in holiday pageants and the wonderful home it was for all the children who stayed at Hillsides.

Other alumni also recounted their stories of the children's charity. After their parent's divorce, Gerry, Larry, and Terry Luckham stayed at Hillsides in1952 for four years. Twenty years ago Larry Luckham began looking for other children he grew up, searching numerous phone books and with luck hitting the jackpot one of 3,000 phone calls.

He contacted John Hitchcock, Hillsides executive director, and initiated the first reunion in 1987, when the charity

celebrated its 75th anniversary.

Reminiscing through old photographs, viewing a previous reunion, touring the expanded campus, and sharing stories brought back memories of the love they felt, birthday parties, camping, and household chores.

For the most part, difficult family circumstances such as disease, divorce, desertion, and death brought children to the charity in the early decades. Nowadays, countless social issues, from severe physical abuse and neglect, to severe emo-tional disturbances, bring children to the charity's doors to receive needed treatment that has allowed them to live nor-

More than 35,000 children have passed through Hillsides' doors in its 95 years. Most alumni remember Hillsides as the Episcopal orphanage called the Church Home for Children, later, as Hillsides Home for Children, a private, nonprofit, and nondenominational charity. Regardless of the name at the time, Hillsides has become well known as a haven for children who suffer from crises that occur in their early childhood. Today, the charity provides quality care, therapeutic mental

health treatment, and education for severely mistreated children.

"I am so glad to know that the home has continued in the tradition of emphasizing the children's needs," said Brenda. Other alumni agreed that the charity has always advocated for the children and is evident while touring the children's campus.

"Our mission has never changed throughout the years," said Hitchcock. "Hillsides continues to create safe places for children and their

With her feelings for Hillsides running very deep, Brenda' heart has always been and will remain with Hillsides—for only a child truly knows when she is loved, Brenda added.

Real Cost of the War in Iraq

Every day we hear about US casualties in Iraq; we hear about the young men and women killed and wounded fighting for freedom in Iraq. But we are not told the real cost of the war; we are not told of the tradeoffs, opportunity costs, and the long term consequences of diverting billions of taxpayer dollars overseas in what appears to be a war without end.

The following is my attempt to connect the dots with what is happening in Iraq with what is not happening here at home. The figures I have used come from antiwar.com—a source I have found to be both accurate and concise.

Opportunity Cost to Local Government

So far the United States has spent more than \$545 billion on the war in Iraq. What does that figure mean in taxpayer tradeoffs? What does that figure mean to opportunities lost and long term consequences? I looked for Sierra Madre, but I guess we're too small to be listed. However, our much larger neighbor, Pasadena, is listed. Pasadena has a population of approximately 145,000. The population of Sierra Madre is just under 11,000.

The Mountain Clymer On The Road Again (Part II) Shangri-Jalama

After spending two nights at Emma Woods State Beach and one night at Gaviotta State Beach, we awoke on the third morning of our adventure at the crack of dawn, had breakfast, and once again headed north on the PCH. During a previous trip we had sought out and visited the magical, mythical Jalama Beach, a Santa Barbara County Park just south of the Vandenberg Air Force Base. It was so lovely that we decided to see if it was possible to get a spot there for the last night of this trip. A man that we had run into at Gaviotta had been there the day before and told us that we needed to get there early if we wanted a spot. He had

been #70 on the list the day before and did not get one. We exited the highway onto Rte. 1 and took it north for a bit until we found the sign for winding drive through some incredibly beautiful country. The entire area comprises the sprawling Cojo-Jalama Ranch and the campground ranch is breathtaking... rolling hills covered with a patchwork of dark green forests of massive oaks and golden grasslands with cattle and shady, singing streams meandering through its many valleys eventually finding their way through the coast's steep cliffs to reach the ocean. The two ranches, Cojo and Jalama, were rehuge 25,000 acre ranch (about 40 square miles).

Jalama Beach. From the turn-off it is a 14-mile is nestled in a cove on its northern shore. The cently sold (for about \$140,000,000) and were combined to make one The ride out to Jalama is as much a treat as the visit there.

We reached the

campground about 8:00 am and were added to the waiting list. We were #28 (17 of which were carried over from the previous day.) We parked the motor home in the day use area and planned our day so we could get as much exploring in as possible in case we did not get a spot for the night. We decided to head north on the beach, return for lunch and then hike south just far enough to be back for "camp call" at 3 pm. That is when we would find out if we were one of the lucky winners of a campsite.

The beach at Jalama has a certain mystique about it. It has for years been a Mecca for surfers and wind surfers. Because of the way the coast lies at this point, the winds usually blow either offshore or parallel to the shore creating a stretch of beach that provides ideal conditions for both sports. Though much of this stretch is only accessible by water or through the private property of the Cojo-Jalama Ranch, the public Jalama Beach offers surf enthusiasts access to the exhilarating surf. This lure keeps the campground in demand yearround and filled with an eclectic and often somewhat bohemian clientele. The combination of the energies of the land, the ocean, and the community creates a spot filled with a very unique spirit all its

Our walk north on the beach ended at an area where the beach became impassable and the surf pounded up against the base of one of the cliffs that line the shore. It was also about as far as you could go without crossing over the boundary into Vandenburg...a mistake that Charlie and a companion once made many years ago and he did not care to repeat. On that occasion, he was abruptly turned around when a jeep carrying armed guards swooped down from their hilltop lookout and menacingly detained and questioned them before sending them off with a terse warning. We returned to the camp-ground, with pockets full of rocks gathered from the interestingly

constructed cliffs that were crumbling onto the beach. At the quaint little general store and grill that serves the community we had a "World Famous Jalama Burger" for lunch before exploring the beach south of the campground. The southern beach was much different than the one to the north. It was more populated with fisherman, surfers, shells and clumps of gooey tar. Up on one of the most precipitous cliffs was a large cross that appeared to be accessible from a steep canyon that emptied out onto the beach. Though there appeared to be a placard on the cross that might have told us the story behind it, we were short on time and energy, so we were left with our own imaginations to provide us with the narrative.

Returning to the campground, once again pockets brimming with souvenirs, we joined the crowd that was gathering for "camp call". There were about 15 camp sites available for the 40 or more people waiting to get one. We were #28. We eagerly waited and watched the ensuing suspense-filled process and one by one we inched our way up the list as those above us no-showed or dropped out of the competition (usually because they were unhappy with the site selection that was available). With one spot remaining, #27 decided that they did not like the remaining spot and entered their name on the waiting list for the next day. Charlie went to make a quick check to see if the motor home would fit in the available spot...it would...we were staying the night!!!

We settled in, had a much needed shower (and de-tarring), relaxed a bit and had dinner. After dinner we set up our chairs around a nice campfire and watched the sun sink low over the dunes. When it finally got too low to see from our campsite we climbed the dune

and laid in the sand to watch a magnificent sunset. As we watched the clouds of the western sky turn glorious shades of gold, pink, and purple Charlie turned his eyes to the east and noticed that over the rolling hills behind us, the full moon was rising. Sunset and moonrise at the beach...how exquisite.

After the show was over we sat fireside for a bit longer before retiring for the evening. Somewhere around 4:30 am we awoke to the second show of Mother Nature's spectacular double feature...thunder and lightning. We quickly dressed and headed out to the dune again. The campground was still and we had the whole beach to ourselves. We climbed the dune to see that the full moon was itself now setting over the water, and hung as a huge orange ball over the horizon. To the east, just on the other side of the hills, the lightning show continued. We watched in awe as bolts of lightning shot from the storm's center (about 15 miles away) directly over our heads and well out to sea...sometimes as one continuous bolt and sometimes flickering and flashing as it jumped from cloud to cloud, forking as it went. When the source of the lightning jags got a little too close for comfort, we retreated to the camper, just in time to keep from getting wet. A memorable finale to an extraordinary trip.

Now, before you start thinking I've gone bananas, I'd better explain that we're speaking Dutch. Hanny is Hanny Van Arkel, a 25-year-old Dutch schoolteacher,

and Voorwerp is the Dutch word for "object."

Ms. Van Arkel, who lives in Heerlen, The Netherlands, told BBC News that she has no background in astronomy. She said that her interest in music led her to the book Bang! The Complete History of the Universe, co-written by guitarist Brian May and BBC "Sky at Night" presenters Sir Patrick Moore and Chris Lintott.

The book led her to become involved with the webbased Galaxy Zoo project (www.galaxyzoo.org), which allows the public to take part in astronomy research online. While she was using this website to help classify galaxies in telescope images, she came across a strange gaseous blob. After failing to match the object to any galaxy types described in the Galaxy Zoo tutorial, she e-mailed the site's webmaster. This alerted astronomers, who subsequently observed the object using the Isaac Newton Group of telescopes in La Palma, Spain, as well as the Swift Space Telescope, and confirmed that the object is one-of-a-kind.

Researchers think this green blob got its energy from light emitted by a quasar (a powerful radiation source powered by supermassive black hole) that has since gone dim and become invisible. The gaseous blob, or "Voorwerp," is so far from the quasar producing the light that it would have takes tens of thousands of years for the light to reach the blob.

Seniors: How To Manage Prescription Drug Costs

(NAPS)—Medicare's Part D prescription drug program is giving seniors much-needed help in paying for outpatient medications. The year after the program was implemented, American Medical News reported that seniors who did not

have prescription drug coverage before enrolling in Part D were able to fill nearly twice as many prescriptions and cut their out-of-pocket costs nearly in half after enrolling.

Prescription drug costs, however, continue to rise. According to a Kaiser Foundation Family report, retail prescription increased prices average of 7.5 percent a year from 1994 to 2006,

almost triple the average annual inflation rate of 2.6 percent.

Rising costs, coupled with Part D's deductible and "Donut Hole" (a coverage gap), can still put seniors living on fixed incomes in a tough spot.

"All seniors need to know how Medicare prescription drug coverage can help them," said Scott Perry, president of Bankers Life and Casualty Company, a national life and health insurer serving the retirement market. "They also need to be aware that there are many resources available to them

and simple steps they can take to keep their out-of-pocket costs in check."


First, don't overlook the importance of smart shopping when it comes to choosing your prescription drug coverage. The federal government's Medicare Web site (http://www.medicare.gov/) has a listing of available plans and lets you submit a list of your current medications to see what plans

will cover them, in addition to comparing rates, policy benefits and limitations.

Next, check with your state's department on aging for programs that cover costs not included in Part D. These programs can substantially reduce out-of-pocket costs for eligible seniors. You can find a listing of them Medicare's State Pharmaceutical Assistance Program Web site at http:// www.medicare.gov/spap.asp.

It's also useful to periodically review your medications with your doctor. Are there any that your doctor feels you no longer need to take? Can any be replaced with a generic or a less expensive alternative, such as an over-the-counter drug?

Consider comparison shopping, too. The National Center for Policy Analysis (NCPA) says that drug prices vary considerably from store to store. A survey cited in one of its studies found that prudent shopping saved consumers almost 10 percent on brandname drugs and 81 percent on generics.



Even if you didn't stow away on a steamship in the 1920s at age 13, your personal history can be fascinating to your family, friends and others. Think about it: we have seen movies about past wars, hard times, or the depression and the years following it. But what a difference it is to hear about the actual experience of it from one who was there. With a little effort and a willing audience you can bring to life, this time for a younger person who only sees the movie versions. You say, but I'd sooner forget that time" or "it's past now and this is a different age". True, but what of the lessons learned from that time. History must be learned as a tool for dealing with present issues. Your family needs to appreciate the events of your life, your struggles, and your achievements.

All it takes to create your personal history is a tape recorder and a remembering spirit, to share what life was like for you 50, 60 or more years ago; told when the mood strikes, hopefully with a loved one nearby to ask questions and prompt your recollections. You might pick a time of year, like Christmases or Hanukkahs you remember celebrating as a child. Or a theme -- the pets you enjoyed, your first attempts at cooking or your first job. Perhaps you recall significant news headlines, and can describe what was happening in your life at the time and how the events affected you. Tell as many details as possible, so your listeners can see the pictures you are painting with your words.

At some later date, your stories might even be transcribed and collected, to share or document or teach. The most important thing is that your voice, spirit and legacy of living will have a way of being heard by your grandchildren, nephews, nieces and others for generations to come.

I recently listened . . . really listened, to my father telling of his life. He wanted to share the story of his 83 years. I was amazed at the accounting of his youth, his loves and disappointments, and of his "hitting the beach" at Iwo Jima as a young Marine. This ordinary man is anything but ordinary. I got to know the man who is my father. All I could say is . . . "I never knew." It meant so much to me that he shared his life with me.

You may not think you have dramatic experiences to recount, but many will treasure your description of ordinary life as it was years ago, because it is no longer "ordinary" today. Give it a try ... share the adventure with someone special.


If you suspect that you are being duped, tell the caller that you will find the telephone number for the agency yourself, and then contact your local Police Department for advice on how to proceed.

When Architecture Becomes Sculpture and Landmark - Architect Gougeon Speaks on St. Rita Church Design

St. Rita Church in Sierra Madre had its 10 minutes of national fame as the edifice became the face of the Sierra Madre fire back in April. Photos of flames behind the church flashed on CNN as I tuned in for fire news from my son's home in New York City. St. Rita Pastor, Richard Krekelberg, bought prints of one of those mesmerizing shots from an entrepreneuring photographer named only Amador, who hawked them in the church parking lot while the flames still licked up the hillsides.

That 72 foot high Campanile tower rises above the trees and other buildings of Sierra Madre, and becomes an easy orientation landmark when viewing the area from a distance. On the times we muster the courage to park at the jam-packed Santa Anita Mall, we nearly always end up on top. The only good thing about that is the opportunity to enjoy the panoramic view of Sierra Madre and its mountain backdrop, with

St. Rita Church visible like a beacon, benefiting from its steep

This summer, as part of a year of events celebrating the Centennial of the parish, the church invited their architect to give a seminar on the history of their church's unusual design and construction. John Andre Gougeon, a noted Pasadena architect, was only 33 when then pastor O'Malley appeared

one day at the construction site of Gougeon's own home on Carter, just a few blocks away. O'Malley asked him to consider building the new St. Rita Church, planned for an expanded hillside site at Baldwin and Grandview.

Now 77, Gougeon's architectural practice is still active, as is his spirit, enthusiasm and passion for his profession. Bringing photos from the construction, he first spoke about the concept of the church's design. As is often the case, the tug between art and budget reared here as well. Proponents of a "simple" box design campaigned against Gougeon's "church as sculpture" ideas. Gougeon chuckled that then Cardinal Mc Intyre didn't understand how a 33 year old architect could design a church. O'Malley stood firm, supporting Gougeon's design with Catholic Archdiocesan officials, saying he would "turn in his badge if this version of the church wasn't built." Gougeon's groundbreaking church was constructed. Dedicated 38 years go in 1970; it became the fourth iteration in the parish's 100 year history.

One of Gougeon's first comments took me aback. "Almost nothing is vertical here." Something I never noticed in over 100 Sunday services

here in the two years we've attended this church. He then went on to say he built the church, not as

a piece of architecture, but as a piece of spiritual sculpture.

The floor plan is bell shaped, with the altar at the top of the bell. The 19 rows of pews holding 840

persons radiate from the Sanctuary. The concrete reinforced church combines clean modern lines with Spanish Mission and Aztec influences, blending the sweeping changes underway in Catholic services with tradition and history. A Swedish "slip forming" process, a new method in the 60's,

was used to erect the Campanile, requiring 55 continuous hours of nerve-wracking, work. Some walls were poured in place; others were pre-cast elsewhere, then tilted up. The rest were formed using the gunite process, similar to pool building.

Slight angles and arches form the walls, and even the wrought iron, travertine altar and the custom furniture have few right angles.

An apse roof, described in Encarta as a semicircular projecting part of a building, especially the east end of a church, which contains the altar. High clerestory lighting illuminates the altar, the massive, intricate relief wall and the multi-metal sculpture of the Resurrection.

A former parishioner, Joseph Maes, designed the sculpture and tear-drop stained glass windows

representing the Stations of the Cross. Gougeon indicated he and Maes actually constructed the relief wall together. Gougeon proudly commented that the building came in at budget, though in the end, the pews were culled from the old church, refinished and installed forgoing pews designed to closer fulfill the design intent of the architect. Several pieces from the previous church were

incorporated into the new building, including the crucifix, which now hangs in the balcony,

and several saints' statues.

During his presentation, Gougeon referred to the functional design of the clerestories and their opening mechanisms, which current staff were unaware of. Opening these windows will help lower energy costs with natural cross-ventilation, and allowing hot air trapped near the ceiling to escape. Now to get them working again after years of disuse! He also called out the original color of Cabot stain used for the woodwork, so that the integral nature of the church's design, colors and materials can remain true to his vision.

Gougeon's daughter, Marie Mauer, described

him as her "Renaissance man", well versed and facile in numerous areas. He grew up in carpentry, following in his father's footsteps. This experience cross-trained him well when he became an architect, bringing an intimate understanding of what is needed in that part of the construction business. "In fact," he chuckles, "I actually built that home on

Carter with my own hands."

After this first church, Gougeon went on to design numerous other local churches, including the Pasadena Presbyterian Church on Colorado in downtown Pasadena, St. Luke's Episcopal in Monrovia, United 1st Methodist in Pasadena, First Christian in North Hollywood, St. Mark's Episcopal in Altadena and the interior of La Caňada Presbyterian.

When asked if he was part of the recent Catholic Cathedral project in downtown LA, he answered that Cardinal Mahony approached him about the project, but felt "I simply didn't have another Cathedral in me, having just completed a grueling six year Episcopal Cathedral project in the Echo

Park area of Los Angeles. That might be so, but the passion and enthusiasm for beautiful architecture still emanates from this

as quickly as the Dodgers' chance of making the playoffs. We have visited some fantastic restaurants in the San Gabriel Valley during these days of sunshine. I have noticed some common threads in my favorite spots of late: Beckham Grill, LA Grand Orange, JJ Steakhouse, Il Fornaio and Ruth's Chris Steakhouse. "What is that thread?", you ask this adroit Restaurant PI. Bargains, bargains, bargains!!! Your idea and my idea of a great bargain may be different; after all, some of us could never bring ourselves to spend (\$40) on a steak. I know

your pain!

Last weekend I was in the spirit to spend (\$40) on a Steak, so I went to Ruth's Chris Steakhouse on Colorado. It is a little like going to Vegas, in that you have to throw some money around to enjoy yourself, only here you won't leave with that empty feeling. I was comforted to see that the restaurant is in the steady and guiding hands of Jimmy (formerly of Il Fornaio) and Eddie (formerly of the Ritz Carlton). I was given a beautiful booth in the bar area. Again, let me set the stage. I was fully ready to throw that credit card to the wolves and accept the consequences at the end. I was given the Wine List and finally realized I had sat down at the big bet table and took a large swallow as I debated the prices and the wolves. The wine prices are high, not a little but rather a full challenge to your senses. Costco was running through my mind as I considered my economic utopia with deeper admiration. I wanted the Vueve Cliquot but opted instead for the "J" Champagne.

Now it is time to save some money. Unbelievable as it may sound, you can do that here. It appears that the powers to be at Ruth's Chris realize that many people are going out less, so they have put together a Summer Celebration package for (\$89). Get off the floor Herb, yes (\$89) for two people!!! This is a three-course meal for two, with five entrée choices.


The first course selection is; Caesar Salad, Steak House Salad or a Louisiana Seafood Gumbo; my choice is the House Salad. Entrée selections; again one per guest, Petite Filet, Mixed Grill, Chef's Fresh Fish, Barbecued Shrimp or the Chicken Breast. Go for the Petite and you'll be smiling. Considering the amount of food in the other courses, this is the perfect size for this course. The sides include; Broccoli, Mushrooms, Tomatoes, Potatoes and Juliene Potatoes. For dessert they offer six choices and I recommend The Breaded Pudding with Whisky sauce.

My guest had to get the Crab Legs; she was taunting me though, as if we didn't have enough food already. She thoroughly enjoyed them. An item to note when ordering these, the crabs are cut to the claw; what that means is that the meat doesn't all come out at once like a Crab Leg would. If you order the Crab, ask for the legs. Did I get my money's worth? I made the right choice and once I pay that balance off I will be out on the town again – see you in a couple months. My server Sara was top shelf and she was all business. I must admit that I do appreciate that when I am spending big bucks for food.

There is no option but to valet park in front, the valet charge can be added to your bill. The restaurant is a little dark, but very clean and the bathrooms are spotless!!!




