Safety Precaution: Sierra Madre To Tow Vehicles On High Alert Days

In anticipation of this year's rainy season the city council unanimously approved Tuesday night restrictions on parking in the canyons, which includes towing cars, on yellow and red flag alert days.

The affected streets are: Mount Wilson Trail, Churchill Rd., Skyland Dr., Fern Glen, Fern Dr., Idlehour Ln., Canyon Crest Dr., Orange Dr., Woodland Dr., Brookside Lane, Sunnyside Lane, Yucca Trail, and Holly Trail.

The move came as part of a new city evacuation campaign, "Ready Set Go" a part of which sets up the green, yellow and red flag system.

"A yellow flag is put up when there is a phase two alert," Police Chief Marilyn Diaz explained. "When it's predicted that a light localized forecast of small isolated debris flow may happen."

She continued, "Red flags can go up for a phase two or three —phase two means there is a moderate level of debris or mudflow expected in a widespread area. And a phase three, the most serious, is the significant potential debris or mudflow over a widespread and specific area."

Diaz also said that a green flag is when weather forecast predicts 80 percent to 100 percent precipitation in the local area. She also said the warning is activated in conjunction with the Los Angeles County alert system.

Councilmember Joe Mosca first raised concerns over how residents would be notified of the system.

"We'll be producing a monthly mud newsletter that will be mail to everyone," City Manager Elaine Aguilar explained. "As the chief mentioned we have an e-blast system... we are also putting notices in the local paper. We're also notifying through neighborhood watch, we will be having additional community meetings, every way we can think of to get the word out."

Aguilar encouraged everyone to sign up for the e-blast, by giving the city an email, through the city's website: cityofsierramadre.com. She said residents would then be sent the e-blast notification on important events in the city.

She also said police will be placing notices on cars in the affected areas on days before the towing.

Mosca than asked if the city was at risk by allowing residents to stay during what are called "mandatory" evacuations, while having the ability to take residents vehicles.

"Are we getting ourselves into any legal issue... we can't force them to leave their home?" He asked later saying "when they do decide to leave [if] their car is gone [thus] putting them in a dangerous situation."

City Attorney Sandra Levin said the city's obligation was to protect the community as a whole, although she suggested using Mosca's arguments to show the danger in both saying in a home after an evacuation and leaving a car on the street blocking emergency vehicles. She suggested putting it in the mud newsletter.

"People need to understand that they have an obligation, both to themselves, to protect themselves, and get out of harms way, because we can't be in the position of trying to rescue everyone," Levin said, adding that residents also have that obligation to the community as a

Councilmember John Buchanan asked if a physical flag needed to be raised before cars are towed, something Aguilar said they might not have time to do.

"If we get a freak storm like we did in May, we won't have time to post any flags," she said. "We are going to do it if we can."

Aguilar said flag were symbolic of the alert, but not necessary for enforcement. Levin said the flag status would always be posted on the city's website. Levin also said there would be permanent signs "no parking on yellow and red flag days," in the areas. Diaz also said they would put up electronic messaging signs visible to people entering the

The potential for debris flows resulted after the Santa Anita fire in April left the hills above the city barren. Aguilar said the debris flows in May, caused by the fire, that affected Marlborough Terrace and the lower canyon, were created by only .5 inch of rain.

Sierra Madre Police Officers Association Files Suit Against City

After the city council upheld the actions of Police Chief Marilyn Diaz regarding hours of work for Dispatchers and Patrol Officers, the Sierra Madre Police Officers Association filed a lawsuit on October 8, 2008.

Represented by the law firm of Lackie, Dammeir and McGill, APC, This is the same firm that represented the Association during contract negotiations in the past.

The lawsuit alleges, among other things, that the city and Chief Diaz in particular, did not have the authority to change the hours earlier this year. The changes were made, as reported in a previous edition of this paper, in an effort

to have the department operate more efficiently and address budget challenges facing the department.

Diaz changed the hours of dispatchers and patrol officers from three 12 hour days to 5 eight hour days, in an effort to reduce overtime and enhance officer performance without the excessive use of sick time.

The Association contends that the Chief did not have the authority to do so based upon the agreement reached by the city in December, 2007.

Currently, the case is scheduled for a case management conference on March 9, 2009.

Controversial Sierra Madre Downtown Overlay Zone Revisited

After a rather mellow 40 minute discussion Tuesday night that included the embattled Measure V passed by voters last year and the now defunct Downtown Specific Plan, the Sierra Madre City Council decided that the Planning Commission should once again review the Downtown Overlay Zone to see if its original intent is still valid.

The Downtown Overlay Zone, adopted as an emergency ordinance in 2005, was established as a guide for types of business permitted in the downtown area until the DSP was completed. The intent was to direct and limit what businesses could be built at both the Howie's (Taylor's) Market site and the vacated Skilled Nursing Center.

The overlay zone came under fire from local business owners and the Chamber of Commerce, who say it is costly and unnecessary. It prohibits some existing business owners from moving their shops to other locations in the downtown area, they said.

Others, such as Councilmember Don Watts, said it could be used to attract certain types of businesses, thus generating more tax money for the-cash

strapped city. Councilmember John

Buchanan suggested a few other ideas. "Perhaps distinguishing

between construction and existing business, so if someone wants to move to an existing building and it's a permitted use, why somebody should pay \$3,000 for that privilege may not make a lot of sense," he said. "However, if someone wants to build a brand new building to house them, then that's a whole other review process."

Buchanan went on to suggest a more limited Conditional Use Permit process for interior remodels than that which would apply to underdeveloped parcels of land, such as Howie's and the Skilled Nursing Center.

He also suggested they go back and look at some of the community input from the 2005 Downtown Specific Plan Study Sessions. Mayor Kurt Zimmerman said he was a little nervous when he hears "vision plan" and "Downtown Specific Plan administrative review." Zimmerman was an outspoken proponent for Measure V, opposing the DSP.

Ron Brandley, President of the Chamber of Commerce and a former Planning Commissioner, said they should scrap the whole thing because of the failed DSP.

"I happened to be on the Planning Commission when we did this overlay," he said. "I think that if you were to go back to the planning commissioners that voted for this, they would be against it now."

Brandley agreed with others





HEAL THE BAY FOUNDER DOROTHY GREEN

Dorothy Green, a California environmental activist best known as the founder of the influential water-quality group Heal the Bay, passed away at her home Monday in Los Angeles after a long battle with melanoma. She was 79 years

A onetime stay-at-home mom, Green would later embark on a journey of handson activism and self education, becoming one of the state's most respected authorities on water quality issues. Spurred by the social disruptions of the early 1970s, she would serve as a mentor to generations of volunteers, scientists and public policy makers throughout her

Initially gathering a few concerned colleagues in her living room in 1985, Green grew Santa Monica-based Heal the Bay into one of the state's most powerful environmental organizations. The science-driven group now has some 15,000 members and wields considerable influence on water-quality throughout the state.

Under her watch, the organization's first major victory was successfully advocating for the upgrade of Los Angeles Hyperion and Carson sewage treatment plants to comply with the federal Clean Water Act. The group also devised the trademarked Beach Report Card, which provides water quality grades to the general public for more than 500 beaches statewide.

Green would later help found the California Water Impact Network, a nonprofit group that advocates for the equitable and environmentally

sensitive use of all the state's water resources. She also helped establish the Los Angeles and San Gabriel Rivers Watershed

remained its president emeriti for the rest her life.

Dorothy Green was simply the most influential water quality activist in California for the last 30 years, said Mark Gold, her protégé and

current president of Heal the Bay. What made Dorothy most extraordinary was her ability to attract talented volunteers of all skills and turn them into tireless activists who feel privileged to protect the environment.

Green's zealous determination and innate intelligence, coupled with a warm personality, enabled her to build consensus among diverse

stakeholders. Her genuine manner defused confrontation and won her admiration and respect from all interested parties on

environmental issues. Behind the scenes always supporting her was her husband, Jack Green, who died in 2005.

Born in 1929 in Detroit, Green came to California to enroll at UCLA as a music

major and played the cello in the school orchestra. She would later start a family and enjoy life raising three children.

She became swept up in the activism of the early 1970s, beginning her career as a water quality advocate in 1972 by working on the campaign to pass Proposition 20, the ballot initiative that established the California Coastal Commission. She then became president of the Los Angeles League of Conservation Voters, which marked her introduction to the issues surrounding sewage treatment and its disposal.

 $She also served as a Los Angeles \, Department$ of Water and Power commissioner for three and a half years, and chaired the most important water policy conference in the state, the California Water Policy (POWER) Conference, for the past 17

The U.S. government honored Green's three decades of leadership in 2006, bestowing her with the prestigious President's Volunteer Service Award. In the fall of 2007, the University of California Press published her book Managing Water: Avoiding Crisis in California.

Green is survived by three sons, Joshua, Avrom and Herschel, and three granddaughters, Jessica, Katherine and

San Gabriel Post Office To Be Named For Former Mayor Chi Mui

Post Office May be First in the Nation Named After Chinese-American

This week, Rep. Adam Schiff announced that the San GabrielPost Office will be named after former San Gabriel Mayor, Chi Mui at adedication ceremony at the post office on Saturday, October 25, 2008.Rep. Schiff authored the legislation (H.R. 5477) to pay tribute to former Mayor Mui by naming the post office after him, and it was signed into law by the President in August. A search by the Congressional Research Service indicates this may be the first post office in the nation named for a Chinese American.

"Chi Mui was a well-respected and dedicated leader in San Gabriel and I am excited to take part in this dedication ceremony," said Schiff. "October 25th will be a proud day for former Mayor Mui's family and the entire San Gabriel community."

SM Chamber Endorses Measure TT

The Sierra Madre Chamber of Commerce, after polling its members, has announced that it will endorse Measure TT, the Pasadena, Altadena and Sierra Madre School Improvement Bond. Measure TT is a proposed \$350 million bond that the Pasadena Unified School District (PUSD) placed on the November 2008 ballot. It will make the district eligible for an additional \$115 million in funding from outside sources, bringing the total allocation of Measure TT related funds for PUSD schools to \$465 million.

According to the PUSD, funds will be used first to improve safety and health concerns, i.e., seismic and code upgrades, etc. Second use of funds will

be for facilities upgrades such as repairing leaky roofs and fixing plumbing. Third priority use of funds will be for program equity, such as building or upgrading science and computer labs. Fourth priority will be for other modernizations such as improved efficiency in energy use, refurbishing recreation areas, etc.

At its September Board meeting, the Chamber Board voted to make information about Measure TT available to its members, and to poll them as to whether or not the Chamber should endorse it. DOWNTOWN (from page 1) overlay zone was predicated on the DSP. "We were moving towards a direction of providing something for the downtown and then, of course, it never saw the light of day." He said. "This emergency ordinance stayed in its place and we've heard a couple of horror stories already."

Brandley also clarified why the Planning Commission had excluded hair salons and barbershops, something that had puzzled the council earlier.

"If I remember correctly, we specifically prohibited hair salons and barbershops because generally they do not provide any kind of sales tax," he said. The council had just amended the overlay zone to allow hair and nail salons after a number of complaints.

There were also a number of missed opportunities, such as

putting in wine bars, Brandley said, adding that wine bars generate sales tax and have become somewhat popular.

A number of residents also came out to support Highlander Liquor. It was said that the store had stopped selling alcohol for a short time and could now not get a license because of the overlay zone.

Brandley also suggested that they let the guidelines of Measure V dictate what goes into the downtown. "To try to itemize every business that we want in this community, it doesn't work because you're going to miss one," he said. "You missed the wine bar because, five years ago, wine bars weren't such a big deal."

Measure V set downtown development limits to two stories, 30 feet, and 13 units per acre. Watts cautioned that it's important to remember that

Measure V was about building parameters and the overlay zone was about use.


Before Brandley spoke, Watts also said they should look at it from an economic perspective.

'What economic incentives can we give to sales tax producing business, as opposed to services business that don't collect sales tax, or residential, or what ever don't create that tax base?" he questioned, although he also agreed the issues needed to be looked at by the Planning Commission.

Council members Joe Mosca and Mayor Pro Tem Maryann MacGillvray said very little about the overlay zone. Mosca agreed to the Planning Commission review. MacGillvray asked if the overlay zone could be used to prohibit adult business, something Buchanan said was beyond their control.

The city added to its Renewable Energy Portfolio Monday night a 20-year Power Purchase Agreement with Ameresco for the energy output of the Skunk Creek Landfill Gas Project —reducing green house gas emissions by approximately 16,500 tons per year.

The project will generate an estimated 30,000 megawatt hour (MWh) per year representing roughly 2.4 percent of Pasadena Water and Power's forecast fiscal year 2011 retail sales according to city staff.

The Skunk Creek Landfill is located in Phoenix Arizona.

The contract is scheduled to start transferring energy on or before through an agreement with the (APS) for the delivery of the power to Pasadena. It would first be delivered to the Westwing Substation in Pasadena then fed into the city's existing transmission entitlements.

The Project's delivered energy cost is expected to be approximately \$550,000 per year more than nonrenewable market energy sources according to forecasts provided by Ventyx Energy LLC. This brings the city's delivered cost to \$100 MWh in the first year staff estimated.

The rate would be passed on to customers system-wide though an almost unnoticeable four hundredths of one penny per kwh increase staff said.

Councilmember Chris Holden asked about the associated risks saying in the past the city had got itself stuck with long term contracts when the markets changed.

Staff said the contract is based strictly on the delivered energy. "If Ameresco delivers one MWh we pay them for one MWh," they said. "There is no further commitment to pay them. The only risk would be entering into the Arizona Public Service Company's tariff they

Congressional **Election Forum Held**

Last Saturday the Senior Advocacy Council of Pasadena, the American Association of Retired Persons and the Villa Gardens Advocacy Group staged a forum-held at the Pasadena Senior Center—to let the public hear the platforms of the 29th District candidates running for a congressional seat.

California's 29th congressional district covers part of Los Angeles County and takes in Alhambra, San Gabriel, Burbank, Glendale, South Pasadena, Glendale, Temple City, Monterey Park, and Pasadena.

Current Representative Adam Schiff (D-CA) shared the spotlight with Republican candidate Charles Hahn and Alan Pyeatt, of the Libertarian Party. Each candidate was allowed equal time to present their campaign promises. Afterwards, attendees were able to ask questions pertinent to the political climate and how it may influence their

First up was Charles Hahn, who promised to get rid of inheritance taxes, lower health care costs, while also supporting the Social Security Fairness Act. He also proposed to give a \$250 tax credit to anyone who rescues an animal from a pound and gives it a loving home." Hahn was the first to express disdain about the rewarding the Wall Street "Fat Cats" and the current economic bailout plan.

Pyeatt stayed on topic his Libertarian message, while always referring to the leaflet provided at the forum, to reinforce the message of the Libertarian Party.

He said that Libertarians believe that they should control their own lives, and should not be to the dictates of others.

"We don't need our government to tell us where to live, who to marry, whether to smoke, how to think or pray or eat fast food," said Pyeatt. "We can decide those things for ourselves. We also don't need government to redistribute our income, overthrow our foreign governments, or take money from productive wage-earners to bail out failing businesses."

While the first two candidates brought up their agendas and personal platforms, Schiff opted to use his time to stoically speak specifically about the economy. In fact, Schiff opposed the first economic package, stating on his blog, "The House voted on a 700 billion dollar bailout of financial institutions whose books ravaged by the ownership of trillions of dollars mortgage-backed of securities of questionable value. I believe the plan proposed by Treasury Secretary Paulson was not sufficiently protective of taxpayer dollars, and I opposed it." Schiff eventually voted for the second economic package.

"I'm going to forego talking about myself and focus on the economic challenges. Manyofyou I'm sure, have been watching with great dismay...and what we're seeing is a crisis in confidence," he said. "We're in uncharted territory and I can't give you an answer—with certainty—whether we can plod ahead, but I hope that we can."

Environmentally Speaking, Did You Know? Composting Part III By Pat Birdsall

Applying Compost- To determine how much compost is needed for garden beds, multiply the square footage of the area to be treated by the thickness that will be applied. A 3-4-inch layer of finished compost can be worked into the tops of garden soil before planting in spring or late fall, or a handful can be transplanted into the hole before planting annuals and perennials. A halfinch of compost can also be applied as a top dressing for shrubs and plants several times a year.

For a flower bed containing existing perennials, estimate the area that those plants occupy when determining how much compost is needed. If half the area is already covered with plants, you'll need half as much compost. Mix one part finished compost with two parts soil for a nutritious potting mix for houseplants. When planting seeds, use less compost and more soil to allow roots to

The plant derived nitrogen and phosphorous in homemade compost is more easily absorbed than the concentrated synthetic varieties found in bagged fertilizer, and, loaded with micronutrients, compost improves soil structure and provides valuable nutrition to foster plant growth.



From The Desk Of.. Glenn Lambdin Behind the Smokescreen of **Proposition 8**

Several months back, I wrote a piece on why I supported samesex marriages. As I stated then, I am a supporter of the American ideal that mandates equality for all Americans, all the time, and without exception. I believe this to be the foundation of American democracy and the basis for my support of same-sex marriages.

In our upcoming election, Proposition 8 is attempting to add a constitutional amendment to deny same-sex marriages and overturn the current State Supreme Court decision that allows same-sex marriages. For those of us that are opposed to Prop. 8, and are in favor of same-sex marriages, it's a simple matter of equality for all Californians. Unfortunately, the proponents of Proposition 8, those that are against same-sex marriages, are promoting their cause via careful wordsmithing and by misdirecting your attention away from their true core values. To reveal their honest feelings towards same-sex marriages would force them to admit publicly that they are not interested in equality, but rather are determined to force their religious dogma on the entire state. The proponents are doing everything they can to side-step the fact that their cause is really nothing more than your garden-

variety discrimination and homophobia rooted in religious doctrine. Starting with the legal name of Prop. 8, its easy to see how the proponents are side-stepping and throwing smoke screens. The Official Voter Information Guide that was sent to every registered voter in California lists the legal name of Prop. 8 as, "Eliminates Right of Same -Sex Couples to Marry. Initiative Constitutional Amendment." Now that's pretty clear. It "eliminates" a "right" of a specific class of Californians. The proponents, wishing to create a diversionary smoke screen, refuse to call the initiative by its legal and rightful name and instead call Prop. 8 the "Protect Marriage Amendment." Not a bad tactic but I have to ask them, "Protect marriage from what?" How can continuing to allow same-sex couples their current constitutional right to marry possibly harm a single existing marriage or a future marriage? It can't, and again, it's a simple case of discrimination and homophobia.

Protectmarriage.com is the mouthpiece for the proponents and lists many supporters, links, and arguments. Several of their statements caught my attention. For example, this one. "... Californians will be forced to not just be tolerant of gay lifestyles, but face mandatory compliance regardless of their personal beliefs." And I have to ask them, " As opposed to what? To be allowed to be intolerant of gay lifestyles?" And since when should personal beliefs supercede fundamental rights of equality and constitutional law? Or, how about this statement from protectmarriage.com. "The California Supreme Court's ruling that created same-sex "marriage" is a threat to every family." Well, let me say with all certainty that it didn't pose a single threat to my family. Of course, the proponents of such an outrageous statement fail to demonstrate how one single family was "threatened" by the Court's ruling. Cut through the smokescreen and all that is left is homophobia.

So who are these proponents and from where are they really basing their claims? Protectmarriage. com lists the proponents mainly as religious organizations. Religious organizations that justify their homophobic doctrine in part by a biblical scripture found in 1 Corinthians 6:9-10: (New International Version) "Do you not know that the wicked will not inherit the kingdom of God? Neither the sexually immoral nor idolaters nor adulterers nor male prostitutes nor homosexual offenders nor thieves nor the greedy nor drunkards nor slanderers nor swindlers will inherit the kingdom of God."

What I find even sadder is that the biblical text found in 1 Corinthians was not even the words of Jesus but rather the words of Paul the Apostle, a Roman, the founder of Christianity as we know it today, and a man who never even met Jesus yet claimed to be Jesus' spokesman. Two thousand years later, Paul's words still evoke discrimination and bigotry.

Cut through the smokescreens of Proposition 8, and the real question is, "Does discrimination belong in our State Constitution?"

for most of us, it is busted, broken and in many circumstances, inaccessible. The number of uninsured in the U.S. has increased over 6 years in a row to the extent we now have over 47 million Americans for whom, in the main, health insurance does not

exist even in the most fundamental sense. In 2000 the CDC determined that our senior citizen population would double from 35 million to 71 million by 2030. The chronic diseases associated with aging will mean increased burdens on our medical and social systems. The United States has one of the worst infant mortality rates in the developed world. In 1960 the U.S. was ranked as

12th but is now ranked as 29th compared to other countries. According to a United Nations report, even Cuba has fewer children dying before the

age of one than does the U.S. The United Nations and Save the Children place part of the blame on a U.S. healthcare system that is not accessible to all. When confronted with these kinds of current and impending crises the need for an effective and universally accessible health system becomes clear and apparent. Barack Obama's health plan will serve to mitigate many of the problems cited above. Below are but a few elements of Obama's health plan that would serve to assist in the resolution of some of the healthcare problems that currently confront us as well as those we shall have to deal with in the future.

Obama's plan gets more for your money, spending far less per capita for coverage of the uninsured.

Obama's plan makes a bigger dent in covering the uninsured. Over a 10 year period, the Obama plan covers over 47% of the uninsured, while the McCain plan covers less than 5%

(Over a 10 year period, McCain's plan spends roughly seven times more (per capita) than Obama's to cover each of the forecasted uninsured)

Obama's plan builds upon the existing system of employer-sponsored insurance and expands the government's role in providing insurance for those without access through

Healthcare

For someone running as the agent of change, Barak Obama continues to show us just how little change he's

actually willing to tolerate in critical areas such as healthcare and education. Admittedly life is full of ironies, but who would have guessed that John McCain would be the real radical agent of change.

Under our existing healthcare system, the vast majority of Americans get their health

Gregory J. Welborn insurance from their employer. The employer pays the premium and takes the tax deduction. Now the employee is receiving a benefit, but he or she really doesn't have much control. Healthcare plans are designed to

benefit the employer so choice is limited, selection of doctors restricted and coverage terminated if the employee leaves. Meanwhile, the government has continuously mandated more and more services be covered forcing costs to go up. If individuals try to buy insurance on their own, they get no tax break and end up paying higher prices.

McCain offers real change to this clearly broken system. He wants to put individuals on the same footing as employers, allowing them to use tax free dollars to buy the coverage they actually want. With real competition injected into the system, costs will come down, employer plans will open

up, and people will always be able to choose their doctors and -most importantly - keep their coverage when they change or lose jobs.

Obama wants to continue the same system of government control and to expand it even more by replacing private insurance with a public insurance system. The government would of necessity start making more and more medical decisions for patients, costs would skyrocket, taxes would increase and personal control over doctor selection and level of care would evaporate.

In short, McCain wants to move to a better quality, lower cost and more flexible system. Obama wants to adopt the Canadian system, which hasn't done very well. In Canada, dogs get hip replacement surgery in under a week, but it takes humans up to 3 years.

Time and again, it's been proven that when the government takes over and pays for something, political calculation interferes, quality deteriorates and costs balloon.

The candidates take the same positions in the arena of education. Americans are primarily educated in a public system controlled and financed by government. Recent international education tests showed that U.S. students ranked 24th out of 29 industrial countries whose students took the test. We did worse than Poland, Iceland and Korea.

Lest one think we're just being stingy with education budgets, these test scores have been falling even as we've increased education spending by 40+% over the last 10 years. We spend almost two times more per student than the average among industrial countries.

So why does quality go down when spending goes up? Parents and students don't exercise any real control in the education system. There's no real choice of schools, except for those wealthy enough to move to better districts or pay for private schools. Obama wants to pump more money into this failing system and give teachers' unions more power to stymie

McCain's solution is to really change the system. His "novel" idea is to simply give parents a choice of where to send their kids to school and allow them to take a government voucher to pay for it. Instead of the government telling you where to send your child and then sending a check to that school, McCain's plan would allow the parents to select any accredited school and to take the check along with them to that school.

We all know what competition does to improve service and reduce costs. Everywhere school choice has been tried, it has been a resounding success, especially among minority and low-income families. In inner-city Los Angeles, minorities flocked to choice schools when allowed, and their academic achievement trounced the local public school system's. McCain is the candidate who offers minorities real hope and will change the broken system that holds them captive.

In a country where we're almost obsessively concerned about civil rights, you'd think that having the right to control your own healthcare and choose where our kids will be educated would be a winning election issue. Then again, on November 4th, it may very well be. Vote your brain, vote McCain.

My husband, Bruce, and I are longtime residents of Sierra Madre. We are both teachers serving children in local public school districts. Bruce has two adopted children of his own and is a wonderful father, and we both understand the importance of being good parents and good citizens. As a family, we are deeply disturbed by the threat Prop 8 poses to us and to thousands of other families across California. I would like to share with you a letter on this issue I just sent to my family and friends.

Dear Friends and Family:

Greetings! How are you? Bruce and I hope you are well. To be blunt, I'm writing to ask for your help.

As you know, Bruce and I married more than 3 1/2 years ago in Vancouver, B.C. We strongly wanted to make this level of commitment to each other, and the only way we could legally do it was to go to our friendly Northern Neighbor, where same-sex marriage is legal. 

Train Wrecks Of The Angeles (Part 3)



hectic day. It was what could be a typical fall day in the mountains...cold and drizzly...a nice change of pace from the summer heat, as long as it did not actually rain...packing in the rain is never very pleasant and not a good idea at all. The Contra dance group was due to arrive in the morning for their hike into Sturtevant. This meant rising extra early to feed the animals so that they would be saddled and ready when the group arrived. I would be taking the entire string of 6 pack animals... the mule, Shonto, and 5 donkeys Bonnie (the mammoth donkey), Bill, Slim, Gus, and Cisco...as well as my horse, Jake. Since there were 40 people coming in, each guest was limited to 10 pounds of luggage. The small donkeys could carry 125 pounds per load (though I kept it to around 100 for the long trip to Sturtevant Camp), Bonnie could carry about 200 (150 for longer trips) and Shonto could carry about 300 (though there was seldom a call for that big of a load). Luggage has a tendency to be bulky, but not too heavy, so that was more of an issue than weight with this type of trip. While the 10 pound limit would only total 400 pounds (maybe as much as 500 pounds if some cheated) spread over 6 animals...a manageable amount of weight, but it could be very difficult to snuggly load 40 bulky duffle bags plus other assorted items such as sleep-ing bags and musical instruments in 12 saddle bags...that is where it gets tricky. I already had a few smaller groups under my belt, but this one was going to be a challenge...especially since I could barely walk on my knee that I had injured the day before. But being the eternal optimist, I figured that I had used up all of my bad luck the day before, and that since Friday, October 6th, 2000 was my 44th birthday, and I was protected by the birthday fairies...nothing could possibly go wrong... fate would never be so cruel.

One by one the cars arrived with the group's members. As each arrived, I weighed their luggage, labeled it with a weight tag, and instructed each party to leave the tag in place and to keep the weight the same for the pack out of camp on Sunday. It was important to know the exact weight of each packed bag, not only for billing purposes, but because the load on one side of the animal had to weigh the same as the load on the opposite side. An unbalanced load would always end up causing the saddle to tilt and, if not immediately corrected, fall off...certain disaster on the narrow, steep and brushy trails. Some of the group decided to head into camp as soon as they were checked in, others waited for friends to arrive so that they could hike together. I continued to greet each car, weigh in stuff, and run back Shonto cleared the turn, I allowed Jake to take and forth from the "loading dock" to the a few steps to give Bonnie room, then Bonstore to mind the store and parking end of the nie cleared. I allowed Jake to take a few more business. This was very difficult to do since I could not straighten my knee and looked a bit like Quasimodo as I limped around the station grounds...it was still very painful. When the last of the baggage had arrived, I carefully loaded it onto the animals. When I was finished balancing and securing the load tightly to each animal, I did one final check of the cinch straps to make sure that the saddles were all snuggly attached. The load was quite a sight to see. Not only was each of the donkey's saddlebags bulging to capacity, but the back of each animal was also piled high. This could be a potential problem because anything piled on the top could shift the majority of its weight to one side or the other with the natural sway of the animals when they move. Eventually this would cause the saddle to list

Friday, October 6, 2000 was going to be a and then fall off. It was important that the load could not move or work its way free.

> We left the station before the last of the group had arrived (some had sent their gear ahead to the station with others). While many had gone ahead, there was a large group that waited for the last few to arrive before hiking in. I led the animals down the ¾ mile fire road and then another ¾ mile out the main trail to the Fern Lodge Junction where I left the main trail and climbed up the stock trail that ran some 50-100 feet above the canyon bottom. I followed that trail about a mile past where the lower trail joined it at Falling Sign Junction and then another half mile to where it dropped back down to the stream bed and crossed the water at Cascade Picnic Grove, where I had the mishap the day before. I was grateful to have made it there without a single hitch. I stopped and rested the animals for a few minutes and let them have a sip of water from the stream as we passed through. The weather was good for the animals...it had been so hot on other trips out to camp...the drizzle continued, though lightly, but a quick check of the cargo showed that it was for the most part, being kept dry by the plastic bags that covered the top items on each side...so far so good.

> After leaving the picnic grove, we started off over the last mile to camp. About 1/4 mile past the grove was the first of two switchbacks that we had to negotiate. I had experienced firsthand the problems that a switchback can cause. Dennis had warned me of their danger and of exactly what could happen to even the most experienced packers if the turn is taken too quickly or if an animal missteps or dawdles. On a previous trip, at the second of these two switchbacks, Bonnie rounded the corner, but the next animal in line, Bill, stopped for a second to grab a bite and missed the turn. With his lead rope tied to Bonnie's saddle and now stretched across the corner with her above and him below, he had no choice but to try to climb the steep hill between them or to pull her down to his level...he opted for door number two, causing her to slide sideways down the hill on top of him. It was a near disaster, quite a scare, and quite a mess to untangle. The first switchback which we were now approaching had two turns. The first was a hairpin turn that crossed over a cement slab at the base of a check dam. It served as a bridge over a small culvert. On the other side of this turn the trail got extremely narrow (15 inches wide) and climbed steeply above the relatively shallow ravine to the second turn. I guided Jake over the concrete and started up the hill very slowly watching each animal as they made the turn. steps so that Bill could have room. Bill cleared. I repeated this for Slim and Gus and finally it was Cisco's turn. Cisco was 25 years old and very slow...a major dawdler. For some reason he hesitated. Although I was not moving, the other animals continued to close ranks, pulling Cisco's lead rope across the ditch at the corner. He was not budging. Gus, being a somewhat nervous animal, stepped quickly forward crowding Slim in an effort to pull Cisco around the bend. I watched as Cisco planted his front feet, extended his neck, and leaned back onto his haunches pulling back even harder. Gus, losing the tug-of-war, was pulled to the edge of the narrow trail which collapsed under his weight and he toppled into the gully...continued next week.



Exotic Weather on Distant Worlds

IF YOU THINK OUR SANTA ANA WINDS are a bit much, consider what you might find on an exoplanet. Computer simulation of the atmospheric circulation on one Jupiterplanetary temperature, show winds heated to thousands of degrees Fahrenheit blowing at supersonic speeds.

Approximately 300 planets have been discovered around other stars, and for most of those planets, scientists know little more than the mass and orbital properties of the planet. However, for a handful of the brightest planets, temperatures have been inferred from observations carried out with space-based platforms such as NASA's Spitzer Space Telescope. Those observations, and the computer simulations used to explain them, hint at weather patterns truly alien to our Earth-based experience.

Adam Showman of the University of Arizona led a study explaining how a global atmospheric circulation driven by the dayside heating and nightside cooling can drive weather on the socalled "hot Jupiters"—Jupiter-like gaseous giant planets that orbit extremely close to their stars.

These planets are 20 times closer to their star than Earth is to the Sun, and so they are truly blasted by starlight," Showman says. Their dayside temperatures reach 2,000 or even 3,000 degrees Fahrenheit, much hotter than any planet in our Solar System.

stars, we think they're tidally locked, with one side permanently in starlight and the other temperature patterns and suggest that, to carry side permanently in darkness," adds Showman. "So, if there were no winds, the dayside would like planet, based on actual observations of be extremely hot and the nightside would be extremely cold."

Observations conducted last year with the Spitzer Space Telescope showed, however, that for at least one such planet, called HD 189733b, the nightside temperature exceeds 1,300 degrees Fahrenheit—much warmer than expected for a wind-free planet. This shows that winds carry heat from the dayside to the nightside, keeping the nightside warm. Until now, however, no computer models had successfully explained this process in detail.


Showman and colleagues performed stateof-the-art 3D computer simulations that, for the first time, coupled the weather motions to a realistic representation for how starlight

the heat, the planet must have jet streams with speeds reaching a hefty two miles per second or 7,000 miles per hour.

So what's the weather forecast for these planets? "Hot Jupiters are pretty crazy places," says Showman. "Expect supersonic winds and dayside temperatures hot enough to melt lead and rocks. If you tried to visit, you'd be fried to a crisp before you could enjoy the view."

DESPITE THE HOT WINDS, THERE ARE STILL A FEW COOL PLACES LEFT, and one of them is Antarctica. That's where UCLA professor David Saltzberg recently went to conduct research on neutrinos, subatomic particles raining in from space that are extremely hard to detect. Dr. Saltzberg used a balloon-mounted antenna, floating over the Antarctic ice, to pick up radio waves given off by neutrinos striking the ice. He'll tell about what he found, and how he found it, at a public lecture Sunday, October 26, 2:30 p.m. at the Altadena Public Library, 600 E. Mariposa St. in Altadena. The Mount Wilson Observatory Association (MWOA), a volunteer group helping the Observatory on public outreach, is sponsoring this free event. Come at 2:00 and enjoy refreshments before the talk.








From the Inside Out: Let There Be "Light"





A Rare Pasadena Event: Estates Pasadena New neighborhood under construction in East Pasadena

A complete new neighborhood under construction is a rare event in Pasadena these days, according to Estates Pasadena agent, Yvonne Chien. Certainly, there are lots of midrise condos going up in the city center, but single family home communities in this established, century plus city are few and far between in this

If you drive Sierra Madre Boulevard just east of Sierra Madre Villa, you've likely noticed the red flags. Twenty-eight new homes from 2900 to 3500 square feet will fill this area soon. Two developers, Ying Enterprises, Inc and Pacific Rim Communities Builder have joined forces to build the project. LCRA, a local, award winning architectural firm from Pasadena was awarded the design, and has focused on its intimate knowledge of Pasadena neighborhoods to ground the project to its local roots.

In fact, one buyer had her heart set on the first model home, and agreed to buy and close escrow on the home, renting it back to the developer. The eight homes currently offered in the current phases offer generous homesites, with 7217 to 8628 square foot lots, some with mountain

The models I saw are in tune with what I

see buyers seeking for today's SoCal lifestyle, with flexibility in bedroom configurations, to accommodate a dual master in one home, and an office or upstairs bonus room instead of a bedroom. A pantry is convertible to a wine cellar. Another floorplan tucks an optional wine chiller under the open staircase in the dining room. A kitchen desk area off the kitchen allows for homework to be done within an adult's earshot, yet out of the commotion of the kitchen. Something that appeals to me... the desk can remain a bit messy, and not show in the kitchen!




