

Alverno Master Plan Scrutinized

A number of both Pasadena and Sierra Madre residents voiced concerns Wednesday night during a public input meeting hosted by the City of Sierra Madre regarding Alverno High School's plans to expand and modernize its' campus. The plans include, among other things, the construction of a new "multi-use" building and a soccer

Most of the 75 people in attendance were fearful of the proposed plans, concerns ranging from traffic congestion to noise and the destruction of the tranquility that currently surrounds the area. They also expressed concerned about Alverno's outside activities, which include movie shoots, weddings and the possibility of a new soccer field being used by outside agencies. The school maintains that a new field would not be used by The American Youth Soccer Organization AYSO or adult soccer of any kind.

Not everyone in attendance was against the expansion, however. "These kids have a right to same experiences as all of you did in high school," said a resident defending the plan to overwhelming opposition. Other residents maintained the expansion was not entirely for students but to allow the school to hold more weddings and more movie filming. Head of School Ann Gillick, denied the allegations in a follow up telephone interview.

Gillick said all school functions come before anything else. "We only schedule weddings on Saturday's after we plan all our school events," she said. The statement disputed claims that the school had, all but four weekends booked through 2008 for non school events.

Many also claimed the school's current Conditional Use Permit does not allow weddings, saying the school is out of compliance. Some demanded the weddings stop immediately.

City Manager Elaine Aguilar said she was unaware of possible code violations but also said the weddings had been taking place long before she worked for the city. "I'm relatively new, I've been here a little over a year, she said. "Let us look into this and we will come back with an answer."

Gillick said the weddings have been taking place since the 1970s. "The money is used mostly for grounds keeping," she said also, explaining that some of it goes for student scholarships among other things such as tuition. (cont. page 3)

A community coalition has now called on the FBI to investigate developer Dorn Platz over the possibility that the real estate company inflated assets to receive large bank loans and federal revitalization money for the Lincoln Crossing project to improve West Altadena.

According to sources, an organized group of frustrated Altadena residents filed a complaint calling for an investigation with the FBI field office in Los Angeles two weeks ago.

Fraudulently claming a cash flow that you don't have in order to secure a bank loan could be considered to some people to be a crime," said former Town Councilman Steve Lamb. He also said they could be charged under the US Federal Racketeer Influenced and Corrupt Organizations Act (RICO).

Lamb said they were asking for the investigation after finding out the California Department of Real Estate had asked Donald Platz one of the founders of Dorn Platz & Co to surrender his broker's license. He had been under investigation for allegedly moving money around to make it look as though the company had more money than they did.

Laura Eimiller A spokesperson for the FBI said they do not deny or confirm investigations. "That's pretty much a policy," she said.

Eimiller explained that investigations usually do not become public unless there has been an arrest or a search warrant has been issued. "Unless it becomes a case of public safety," she said.

She added that if someone does call them or complains with allegations that a federal law has been broken, it is reviewed by the appropriate personnel.

"We have various employees that specialize, whether it's fraud, bank robbery, terrorism or whatever that would fall under our perview," she said.

Lamb also said they wanted to look at the whole company and not just the Lincoln Crossing Project. Dorn-Platz President Greg Galletly does not have a current broker's license according to California Department of Real Estate.

Galletly was unavailable for

comment Thursday. "There seems to be a pattern," Lamb said. "If you look at their projects in Glendale, if you look at the project in Oregon, Arcadia or here they seem to follow a pattern of securing financing and not completely paying contractors."

He also said they found a pattern of behavior in projects where Dorn Platz would just put up the walls, floors, plumbing and electrical and then move in local businesses, only to replace them with larger chain stores.

"Local businesses that participate with them end up doing a large amount of the tenant improvements, which in this case [Lincoln Crossing] seems to be completing the

buildings," he added.

Dorn Platz which has lost control of its two Sierra Madre projects, One Carter and Stonehouse, has been plaqued with financial problems and lawsuits. The company was also sued in June in Oregon over nonpayment of contractors on a city project, the Round, in Beaverton. According to reports, the judgment was to collect \$857,082.53 in past due heating and cooling payments. Dorn Platz is also facing foreclosure for undeveloped parcels at The Round.





Learning a New Lingo

This semester, I am taking Spanish 1a at my high school. I've found that Spanish really isn't a complicated language; that knowing English alone can help you get the gist of what is being said. PUSD Focuses On Student Fitness By Teresa Baxter

The Pasadena Unified School District the standard of falling in the "fitness must continue in physical education is moving forward with measures to help students lead healthier lifestyles by promoting and setting goals regarding physical health. Recently, the Governing Board was given the latest results of a fitness test—called FITNESSGRAM—in a presentation by Ann Rector, the health programs coordinator for the district.

"FITNESSGRAM is a comprehensive fitness assessment battery that includes a variety of health related physical fitness tests designed to assess cardiovascular health, muscle strength, muscular endurance, flexibility and body composition," said Rector. "Criterion referenced standards associated with good health have been established for children and youth for each of the health and fitness related components."

Upon completion of the program each participant is given a report card that summarizes their performance on each component of health related fitness. Scores are then tabulated as meeting exercise that option and

zone", or not meeting the standard.

"Students can use FITNESSGRAM in planning their personal fitness program, while teachers can use it to determine student needs and help guide students in program planning," she said. "Parents can use it to help them understand their child's needs and plan

a program of activity." In 2008 fitness tests were administered to students in the 5th, 7th, and 9th grade with the goal of having all students passing at least five of the six standards of the assessment. Students in 9th grade who meet the standards may invoke the two year exemption which allows them to take their second year of physical education in any grade.

the standard may not

courses until the standard is met. Last year only 36 percent of 9th graders

met the standards while this year's results reflected all grades, and showed an overall increase of 46 percent of PUSD students passing five of six of the standards.

Just The Facts

The internet has been the breeding ground for spreading false information during thielection cycle. For your edification, here are a few examples of the type of information that is clouding voter's judgment today. From www.factcheck.org on all the candidates.

How many times did Obama vote 'present' as a state senator? He did so 129 times, which represents a little more than 3 percent of his total votes.

Did Sarah Palin make rape victims pay for their own rape kits? Palin's police chief in Wasilla did that. Whether Palin supported this is not certain.

What's the full story on the Bridge to Nowhere? Palin supported it even after McCain denounced it, then blamed "inaccurate portrayals" when she canceled it for lack of money. Obama and Biden voted for the big transportation bill that contained it. McCain's vote was one of four against.

Is Joe Biden refusing to pay a \$150,000 campaign debt? Contrary to a claim in a chain e-mail, public records show Biden paid his debt to an air charter company in full, well before Obama tapped him for vice president. The accountant who wrote the e-mail now says it's "no...

Is McCain unable to use a computer because of war injuries? He can type. But using a keyboard for long periods is uncomfortable for him. He says he's been an "illiterate" on a computer. But he says now he's learning to use the Internet.

Did Sarah Palin sell the Alaska governor's jet on eBay? The jet was placed on eBay for sale, but it wasn't purchased from the site. The plane was eventually sold through an aircraft broker to businessman Larry Reynolds for less than the asking price and the original cost.

Does McCain want to ban "all" abortions? He has said he favors a Constitutional amendment that would outlaw abortion. He would allow exceptions in cases of rape, incest or when the life of the mother is at stake.

Did John McCain cheat on his first wife? He courted his current wife, Cindy, for months before divorcing Carol Shepp in 1980. He recently called the breakup of his first marriage "my greatest moral failure." But Shepp has been quoted as saying "we are still friends.

Did a Billy Graham team member say Obama should be defeated "to save America"? No. The Billy Graham Evangelistic Association says a widely quoted anti-Obama screed wasn't written by anyone associated with the organization.

In a surprise announcement just a few days prior to the scheduled election, Presidential candidate Senator John McCain unveiled another unprecedented surprise. The Candidates' On War and Terrorism The War! Remember? War And Terrorism

Amid the deafening din and clamor about the elections, the nasty, disgusting campaign tactics of John McCain et al, the roar of laughter and guffaws heard round' the world over Sarah Palin's unremitting displays of vacuity, we are inclined to forget this country is engaged in war. Even though the reasons given for the invasion and occupation of Iraq were based on a campaign of lies and subterfuge this administration

is, in fact, locked in a grisly struggle for the control of the Middle East and its vast reserves of oil. This self-appointed right wing suzerainty produced a little known document known as PNAC (Project for the New American Century). PNAC promotes, American "hegemony", imperialism and "full-spectrum" dominance, including the control of outer space for militaristic purposes (Google "Rods from God").
On September 20, 2001 (nine days after the September 11, 2001 attacks), the PNAC sent

a letter to President Bush, advocating "a determined effort to remove Saddam Hussein

from power in Iraq," or regime change: ... even if evidence does not link Iraq directly to the attack, any strategy aiming at the eradication of terrorism and its sponsors must include a determined effort to remove Saddam Hussein from power in Iraq. Failure to undertake such an effort will constitute an early and perhaps decisive surrender in the war on international terrorism". Basically, the 9/11 attack provided the neocons the stuff they needed to carry out the precepts of PNAC. 9/11 was, in effect, a windfall for the neocons. One could easily reason that if the search for Bin Laden were ceased, it would be because had he been captured; then this administration and its cortege of warmongers could not sustain their reasons for being in Iraq. Because of these and other activities, over 4,000 U.S. Soldiers have died, over 50,000 U.S. soldiers are wounded in ways to gruesome to describe, over a million Iraqis are dead or also wounded in ways to gruesome to describe, the United States is barreling towards a 10 trillion dollar debt with no end in sight, we are the laughing stock of the world and probably the most hated country in the world. We have become the apocalypse, we have become death. We must elect someone who can change that. Barack Obama is the only choice.

"Barack Obama and Joe Biden believe we must be as careful getting out of Iraq as we were careless getting in. Barack Obama and Joe Biden believe that the U.S. must apply pressure on the Iraqi government to work toward real political accommodation. There is no military solution to Iraq's political differences, but the Bush Administration's blank check approach has failed to press Iraq's leaders to take responsibility for their future or to substantially spend their oil revenues on their own reconstruction." War And Terrorism: A Study In Contrasts

Perhaps no other area offers as significant a contrast between McCain and Obama as the Iraq war and the war on terrorism. The very fact that McCain sees each as part and parcel of the other while Obama sees them as competing distractions sets the two candidates' positions

diametrically apart. Sadly, the stakes here couldn't be greater, and if we do not recognize the wisdom and experience in John McCain's approach, we will suffer the tragedy of Barak Obama's naivety and wishful thinking.

Throughout the entire campaign, Obama's message has been clear and consistent. He continues to assert Gregory J. Welborn

that the Iraq war was a mistake, from the beginning through the surge and up to the present day, and that it is at best an irrelevant

distraction from the "true" war on terror being fought in Afghanistan.

McCain, on the other hand, has learned well from history and personal experience that it is best to take one's adversaries at their word when they proclaim their intentions to formant war and terror. Osama Bin Laden told us he would attack us on our own soil to bring the great Satan to his knees, and so he did. Post 9-11, Osama Bin Laden has designated Iraq the "central front" in his continuing war against the United States specifically and Western Civilization in general, and he should be taken seriously.

The reason thousands of foreign jihadists have made their grizzly pilgrimage to the streets of Iraq has nothing to do with boredom or lack of economic opportunities and everything to do with the mobilization, logistical and financial support efforts of al Qaeda designed to create in Iraq another safe haven from which to continue the fight against the West.

History is full of examples in which the enemies of democracy fought on multiple fronts simultaneously, a fact which Barak Obama appears to be too young to

understand. Hitler allied himself with Japan and Italy, forcing Roosevelt - a Democrat with a strong command of history and military strategy - to fight in Europe, Africa and the Pacific. The old Soviet Union launched proxy wars all over the globe, forcing Kennedy - another Democrat with a strong command of history and strategy - to defend liberty in South America, Europe and Southeast

What Obama under estimates is Bin Laden's and other terrorist's commitment to destroy us. John McCain gets it. He realizes that negotiations - let alone talks without any preconditions - are dangerous when the enemy seeks only your destruction. McCain, like any reasonable statesman, realizes that negotiations have their place, but they are best conducted from a position of strength, not weakness, and certainly never after your opponent has driven airplanes into buildings to kill thousands, exploded nail bombs in crowded marketplaces to maim thousands or slit the throats of aid workers to frighten thousands more. Those are acts of war and must be dealt with as such. Obama naively assumes that evil can be convinced to become good.

Whatever the reasons for going to war, the strategies for the conduct of the war also showcase the differences between the two candidates. Simply put, McCain had the foresight to advocate for a surge when it was wildly unpopular and the judgment to realize its success. Obama predicted its failure and still sees it as inconsequential to the dramatically improving results we are witnessing today. When military success became evident, Obama claimed that only political success in Iraq counted. As political success is now imminent, Obama remains silent. There is simply no comparison between the temperament and wisdom, or lack thereof, in these two candidates.

Lastly, and probably most importantly, McCain has a firm grasp of what retreat from Iraq would look like while Obama would remove troops precipitously. If Iraq is allowed to slip into anarchy and al Qaeda domination, Iran will advance to nuclear-armed domination of the Middle East, emboldened jihadists will swarm into Afghanistan to deliver a similar knock out punch to democratic aspirations, Hezbollah will resume its war against Israel, Russia will claim more of Georgia, Ukraine and it provinces of old, and China will seek to control the Pacific. A weekend United States emboldens dictators.

These are dangerous times on the world stage. It is certainly no time for inexperience or on-thejob training of a well spoken, but nonetheless naïve, orator. The great irony here is that it is John McCain, the Republican candidate, who best embodies the last great Democratic president John Kennedy's commitment to pay any price and bear any burden to assure the survival of liberty. It is John McCain who realizes that the war on terror must be fought on the streets of Bagdad and Kabul or it will be fought on Main Street.

AN ORDINANCE OF THE CITY OF SIERRA MADRE, CALIFORNIA AMENDING SECTION 10.24.04 AND ADDING CHAPTER 10.52 TO TITLE 10 ("VEHICLES AND TRAFFIC") OF THE SIERRA MADRE MUNICIPAL CODE PROHIBITING ON-STREET PARKING ON CERTAIN STREETS ON YELLOW AND RED FLAG ALERT DAYS AND **DECLARING AN URGENCY THEREOF**

WHEREAS, the April 2008 fires above Sierra Madre burned an extensive hillside and mountain area, eroding the natural vegetation;

WHEREAS, this has left the adjacent hillside residential areas especially vulnerable in the event of mud and debris slides during the rainy season;

WHEREAS, to ensure that public safety and public works vehicles can access those neighborhoods in a debris-related emergency, the City Council wishes to enact an ordinance to prohibit parking on designated streets during the activation of a yellow and red flag emergency notification system;

WHEREAS, the purpose of this ordinance is to protect the health, safety and welfare of the citizens of Sierra Madre through the regulation of on-street parking on certain City streets during days of extreme precipitation; and

WHEREAS, The City Council declares an Urgency pursuant to Section 36937 of the California Government Code which would permit this Ordinance to take effect immediately after a single reading for the immediate preservation of the public peace, health and safety as described herein.

THE CITY COUNCIL OF THE CITY OF SIERRA MADRE DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Chapter 10.52 is hereby added to Title 10 of the Sierra Made Municipal Code to read as follows:

CHAPTER 10.52 PARKING PROHIBITIONS ON YELLOW AND RED FLAG ALERT DAYS

10.52.010 PURPOSE OF THIS CHAPTER.

The purpose of this Chapter is to protect the health, safety and general welfare of the citizens of Sierra Madre through the regulation of on-street parking on certain City streets during days of extreme precipitation which pose a risk of debris and mudflows.

10.52.020 DEFINITIONS.

The words, terms, phrases, and their derivations set forth in this Chapter have the meanings set forth below:

On-Street Parking is defined as the stopping, standing or parking of any vehicle on any of the City streets designated in Section 10.52.030.

10.52.030 PARKING PROHIBITIONS.

Whenever the Fire Department determines that on-street parking on any City street designated in subdivision (B) of this Section would create a hazard to life or property by interfering with emergency vehicle access and resident evacuation during any event of mud and debris flow, the Fire Department is hereby authorized to install and maintain at that place signs giving notice that onstreet parking is prohibited on a Yellow Flag Alert Day or a Red Flag Alert Day. The Fire Department is further authorized to include notice, on any sign that prohibits on-street parking on Yellow Flag Alert Days or Red Flag Alert Days, that vehicles parked in violation of the sign may be removed at the owner's expense.

During a Yellow Flag Alert Day or a Red Flag Alert Day, it shall be unlawful, when authorized signs are in place giving notice, to park any vehicle on any of the following streets or portions thereof in violation of those posted signs:

Mount Wilson Trail; Churchill Road; Skyland Drive;

(4) Fern Glen; (5) Fern Drive:

Idle Hour; Canyon Crest Drive;

(8) Orange Drive; Woodland Drive; Brookside Lane;

(11)Sunnyside Lane; (12)Yucca Trail; and

Holly Trail. 10.52.040 VIOLATIONS/PENALTIES.

A vehicle which is parked in violation of this Chapter may be removed by the City. Any person or entity who parks his car in violation of this Chapter is liable for the expense of removing his vehicle. Any such expense shall be charged against that person or entity and this charge shall constitute a debt and will be collectable by the City.

Any person or entity that violates this Chapter is guilty of a misdemeanor which shall be punishable pursuant to the procedures set forth in Chapter 1.12 of the Sierra Madre Municipal Code.

SECTION 2. Section 10.24.040 ("No Parking Areas") of the Sierra Madre Municipal Code is hereby amended to add Subdivision I. to read as follows:

On certain city streets during Yellow and Red Flag Alert Days as set forth in Chapter 10.52."

SECTION 3. The City Council declares an Urgency pursuant to Section 36937 of the California Government Code. This Ordinance shall take effect immediately after a single reading because its passage is required for the immediate preservation of the public peace, health and safety. The facts constituting this urgency are that: (i) there is an immediate need to protect the citizens in the hillside areas left vulnerable to mud and debris slides due to the April 2008 fires; (ii) precipitation is more likely to occur during the Fall and Winter months which make mud and debris slides more imminent in the residential hillside areas; and (iii) immediate enactment and enforcement of this Ordinance would ensure that public safety and public works vehicles have access to the neighborhoods in debris-related emergencies by prohibiting parking on certain City streets when a yellow or red flag alert is declared by the Fire Department. Accordingly, it is necessary this Ordinance be effective immediately upon its

SECTION 4. The City Council intends this Ordinance to supplement, not to duplicate or contradict, applicable state and federal law and this Ordinance shall be construed in light of that intent.

SECTION 5. If any sections, subsections, subdivisions, paragraph, sentence, clause or phrase of this Ordinance or any part hereof or exhibit hereto is for any reason held to be invalid, such invalidity shall not effect the validity of the remaining portions of this Ordinance or any part thereof or exhibit thereto. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that anyone or more sections, subsections, subdivisions, paragraph, sentences, clauses or phrases be declared invalid.

SECTION 6. The City Clerk shall cause this Ordinance to be published or posted in accordance with California Government Code Section 36933, shall certify to the adoption of this Ordinance and his/her certification, together with proof of the publication, to be entered in the book of Ordinances of the City Council.

SECTION 7. This Ordinance is adopted by a 4/5 vote of the City Council and shall take effect mmediately upon adoption as provided by Government Code Section 36937





The spark provided the energy for the molecules to see if modern equipment could discover chemicals that could not be detected with

and university researchers. The NASAfunded result is the subject of a paper in Science appearing October 16.

"Historically, you don't get many experiments that might be more famous than these; they re-defined our thoughts on the origin of life and showed unequivocally that the fundamental building blocks of life could be derived from natural processes," said lead author Adam Johnson, a graduate student with the NASA Astrobiology Institute team at Indiana University, Bloomington, Ind.

From 1953 to 1954, Professor Stanley Miller, then at the University of Chicago, performed a series of experiments with a system of closed flasks containing water and a gas of simple molecules. At the time, the molecules used in the experiment (hydrogen, methane, and ammonia) were thought to be common in Earth's ancient atmosphere.

The gas was zapped with an electric spark. After running the experiment for a few weeks, the water turned brown. When Miller analyzed the water, he found it contained amino acids, which are the building blocks of proteins-life's toolkit-used in everything from structures like hair and

how simple molecules could be assembled into the more complex molecules necessary for life by natural processes, like lightning in Earth's primordial atmosphere.


Miller actually ran three slightly different experiments, one of which injected steam into the gas to simulate conditions in the cloud of an erupting volcano. "We found that in comparison to Miller's classic design everyone is familiar with from textbooks, samples from the volcanic apparatus produced a wider variety of compounds," said Bada.

We discovered 22 amino acids, 10 of which have never been found in any other experiment like this," said Glavin.

4) The caller insists that you send your payment by a private courier or wire money. Legitimate companies don't try to keep people from checking the deal out and changing their minds.

5) The company asks for cash. Legitimate companies don't ask for cash.

6) The caller asks for your social security number. Legitimate companies don't ask for that unless you are applying for credit and they need to check your credit report.

7) The caller asks for your credit card number, bank account number, or other financial information when you aren't buying anything or paying with those accounts. Legitimate companies only ask for financial information to bill you or debit your account

for purchases you've agreed to make.

8) Gift cards on display for sale at stores can be the target of fraud. Since the numbers can be viewed by anyone and written down, they may be used up for on line purchases after you buy them and before your special person has a chance to use them. 1896 was a very good year! Venerable Pasadena estate offered for the first time in decades You can feel that this is a comfortable family home as well as a majestic residence. Just off Orange Grove's "millionaire's row" this stately home offers a breathtaking bridge from elegant

yesteryear to today's 21st century living.

Lovingly restored and maintained, the home offers a floorplan for grand entertaining, while maintaining the feeling of a real home. Family members can kick off their shoes and watch the big screen flat panel in the family room or or totally sit down and read or study in the vintage. actually sit down and read or study in the vintage designed library with one of the three fireplaces. Beautiful disappearing pocket doors allow the floorplan to be open and flow for a gathering of 200, or create privacy by closing off a section of the main floor.

Everything in the home is tastefully done, harmonious with the original period, yet very functional for today's lifestyle. I hesitate to use the word Victorian, because the home doesn't feel segmented into individual, non-integrated rooms the way many other Victorians do, making them a tough transition for homeowners who want historic architecture AND internet connections at the kitchen planning desk.

Originally designed by architect H.L. Smith for Mrs. Emily Macy in 1896, this was just ten years after Pasadena incorporated as a city, and years before they even began to issue building permits. A large addition and extensive alterations were accomplished in 1929 by Marston and Maybury. A 640 square foot "den" was added in 1972, though all appear seamless. Along the way, a three car garage was built in 1983, and new HVAC system

from the original intercom system. A three car garage and a long side drive provide ample off street parking for the owners and guests.

The landscape was redesigned in 1983 (remember that was after the house was already 96 years old!) by well known landscape architect

Michael Schmidt. The grand scaled back yard includes a beautiful pool and spa, paddle tennis and basketball court surrounded by expansive, lush lawns. I can just imagine a beautiful garden wedding here!
