

Future of Historic Sierra Madre Church Still Uncertain By Dean Lee

Caught in a dilemma, the Sierra Madre City Council, recently postponed adding 186 W. Highland Avenue to the city's register of landmark properties and any future development options on the property. Many proposals have been discussed for the historic project, including everything from low income housing to a possible children's library. The issue will come back to the council in both open and closed sessions.

No one could argue with longtime resident Glenn Lamdbin's case that the once Christian Science Church had a history that can be traced back to Nathaniel C. Carter, considered the founder of the city. It was Lamdbin who filed for historic designation. City Attorney Sandra Levin cautioned that doing so could get in the way of meeting the Department of Housing and Community Development's (HCD) housing element. This was the second time Lamdbin nominated the property. The first failed in October 1998 because it would have lowered the property's value he said. "It was denied 3-2," Lamdbin explained. "The reason was because financial concerns... it makes it less desirable for a developer to want to come in and try and work in those parameters. Restrictions can also make something less saleable or decrease value."

In a brief history of the site Lamdbin said, architecturally, it's the only neighborhood church of its kind in Sierra Madre. It also has ties to social reform going on in the late 1800s. Mary Baker Eddy, founder of Christian Science, was recently honored in the National Women's Hall of Fame. The Carter's were also once followers of her teachings and attended the church.

Mosca said, with its history, the building was worth saving and asked that the city's Planning Commission take a look at it. He also said he wanted to look at uses that would preserve it.

"One of the factors HCD looks at in determining whether or not to agree with a city and assign credit to a site that has been selected low/moderate housing is how many constraints have been placed on the development of the site," she said adding that historic designation could be a constant.

Levin also said that because the city owns the property through the Community Redevelopment Agency they could put restrictions on the site similar to California's Secretary of Interior's Standards For Rehabilitation. However, if the city used the site for something other than low income housing they may have to find another way to meet the housing element. "I guess my advice is that before you get too far down the road towards designating this as historical, you should also consider whether you want to try and get credit for it in the housing element process," she explained. The council decided to revisit historic designation after they had gotten credit from HCD. Councilwoman MacGillvray moved to direct staff to discuss the options for this property with our housing development consultant and explore the pros and cons of the opportunities presented to us this evening and to schedule a closed session for negotiations. The motion was seconded by Joe Mosca and the motion passed.

A number of residents did ask if the property was up for sale. "I wanted to ask the council if they would entertain the lease or sale of the property to the public," resident Elise Carson asked. "I think the property would be wonderful site for a childcare/daycare center, after school care... I would love to start a daycare and that would be a great place for it.

Resident Fred Crocket said he would also like the opportunity to rehabilitate the building. New Planning Commissioner, Kevin Paschall suggested using it as





The Sequence

Theatre may still be among the best mediums to teach matters of social import while entertaining. Real life topics, like the race to sequence the human genome, usually get brief mentions on TV news, or in an article printed in a section of the newspaper that the majority of readers might miss. If we're lucky, we might find a TV program on the subject. But, what if you're one of those people who don't like watching TV, or reading the newspaper, or believe that a science topic is too complicated to grasp? The Sequence dramatizes the question "who and what am /are I, you, we?" via the actual intellectual combativeness of two scientists, and one reporter. This was brilliantly written, by playwright Paul Mullin, and superbly directed by John Langs.

It is always curious how a sincere desire to research into life mysteries may oft become transformed --even corrupted-- into the age-old paradigm called competition. Then, it becomes the competition (not the research desire) that qualifies what perspective and course such competition will take. Competition implies there are at least two opposing views, or ideas, which become the driving force behind the "success" (proving) or "failure" (disproving), rather than following the initial sincere desire to know. In addition, opposing views are susceptible to attracting possibly unbalanced - and therefore "dangerous" - thoughts that support their respective perspective. Then, the competitive drive becomes the means and the ends. At one point, scientist Craig Venter (played by Hugo Armstrong) was clearly headlined as being the "Dark Prince" in the race, which illustrated how Venter's underlying drive was totally about gaining fame, notoriety, and monetary wealth; while scientist, Francis Collins (played by William Salyers) claimed to be fully concerned with the moral issues of such research. As depicted in the play, the respective competitive thoughts of each scientist then "colored" the scientific process, as well as the projected outcome(s); each exposing the limitations, biases, and ultimately the baseness of their thoughts (and subsequent actions). Their interpersonal competition then turned into an internal struggle to reconnect with the original meaning and purpose of their research. As in all finely written and executed plays, the paradigm of dark vs. light gets "played out" very well and on various levels in "The Sequence". It was also evident that reporter Kellie Silverstein (played by Karri Krause) was caught in her own battle between science and morality, and between fame and personal welfare, as she followed the progress of both scientists. The Sequence is a multilayered story of dualistic phenomena.

The Sequence should hopefully get everyone thinking (it did me) about "who and what am I"; and inspire us to do our own thinking and feeling and delving into the patterns we each have found are to be repeated in life. From a philosophical perspective, it has been stated that all our true battles stem from an internal conflict, and that external conflicts are a reflection of the internal ones. When the pure search for truth collides with the competitive politicking thoughts (that also pervade one's thinking process), it distorts what one is seeking. If, through our work and interrelationships, thoughts are expressed, then where did those thoughts originally come from? Could thoughts (in the form of unconscious mistakes, habits, familial character traits) emanate out from what is encoded in our genes (because such predispositions were passed down through our ancestors)? Methinks the answers to such questions all get traced back to the phrase "Know Thy Self" - a Socratic as well as Taoist concept - which has more to do with the disciplined search for internal mindful integration, rather than unraveling the spirals cast within physical existence.

Mudflow Awareness Update

The City of Sierra Madre held another meeting Thursday night informing residents what to do this rainy season in anticipation of possible debris flows and mudflows after The Santa Anita Fire in April stripped the hillside from vegetation. The new Incident Evacuation Plan that divides the hillsides and canyons into four areas was presented by City Manager Elaine Aguilar and Public Works Director

First however, Inman explained the importance of cooperation by the residents. He pointed out that residents needed to understand the city's Public Works department had only 12 employees and that they could not assist them if they decide not to evacuate in an emergency. "The way it works, half the staff goes home in an emergency and we work half on half off," he said. "You do the math, that's six

Inman informed the crowd that people needed to prepare their homes against mud and debris. Aguilar focused attention on the city's preparedness programs, including "Ready, Set, Go" a new flag alert system and "Ready for 7", a program on what to do after a disaster. Aguilar reminded the 20 or so residents that during a yellow flag alert, any car left on the street in the canyon would be towed, which is part of the new flag program. Mike Kinney of the Fire Safe Council asked if there was somewhere outside the canyon they could set aside to park. Aguilar said the city would look into it. She also said overnight parking restrictions would be null during an alert.

According to the city manager, more information can be found at the city's website: www. cityofsierramadre.com. She encouraged everyone to sign up for alerts and also said when rain was forecast the red, yellow or green flags would be posted on the front of the website. Physical flags would also go up and the city horn will be used to notify residents.

Sierra Madre has also setup four different incident evacuation plans and Aguilar went over them in detail. Area One is Santa Anita - Lotus Lane. Area Two is the Lower Canyon - Alta Vista -Woodland, Area Three is the Upper Canyon – Skyland – Canyon Crest, and Area Four is Mountain Trail -Auburn. Each area has a designated evacuation route that does not conflict with the Fire, Police and Public Works Incident Traffic Plan.

Fire Chief Steve Heydorff handed out copies of the four plans including maps and the locations of the information centers for evacuees. Aguilar said both the Sierra Madre School Upper campus and Lower campus would be open during an emergency for this purpose.

In related news, Aguilar said the city council is set to approve a bid by contractors to install K-rail along roads in areas prone to debris flows. K-rail is a type of concrete barricade used especially as highway dividers. In this case the city will use them to stop mud from reaching homes. The cost to the city could range from \$500,000 to \$1.5 million.



When a citizen lodges a complaint against the department or a particular officer, certain situations call for the matter to be turned over to an outside agency. By so doing, the city is attempting to give citizens a fair and unbiased investigation into the charges and to protect the city from expensive claims that often result in multi-million dollar judgments. Community complaints are not limited to complaints from citizens of Sierra

Madre, but are often from citizens that our officers have stopped and/or arrested that do not live in the city. Whether or not they go to the outside agency depends on the seriousness and complexity of the matter.

Sierra Madre is no different from any other police department and complaints or allegations of theft by officers.

Diaz did comment on the claim that the two day retreat was an unnecessary expense to the city. South Lake **Optimistic**

In every neighborhood of Pasadena there is evidence of national chain stores going out of business. Recently the city has witnessed the loss of the Pasadena Ford dealership, Linen's and Things, and the upcoming closure of Shoe Pavilion on South Lake

Despite the indications that reflect our country's economic tailspin, several local entrepreneurs are venturing into business by setting up shop in the South Lake Business District.

Gina Tleel, the executive director of the South Lake Business Association remains optimistic and continues to move forward with projects that will enhance the shopping experience as the economy recovers. Currently, the South Lake Streetscape Improvement construction project is underway, which consists of street median upgrades. According to Tleel, new landscaping, high-tech irrigation and electrical systems will also be part of the renovations.

'We're thinking of the future when it comes to water conservation. California has been campaigning to get communities to do their part and we're setting the example," said Tleel. "The cool thing about the construction—that will be completed by Macy's re-opening—is that the holiday lights will also be in place adding to the vibrancy of the district.

Macy's chose to close in the month of May to revamp the interior of the store while also undergoing significant seismic upgrades. Their re-opening will be taking place on Saturday, Nov. 22, prior to what is known as "Black Friday", which is the Friday after Thanksgiving that symbolizes the beginning of the traditional Christmas shopping season.

One of the new tenants in the shopping district is J Beverly Hills Salon, located at 820 I Green Street. The salon was established by Yuriy Garayan, who moved here from Russia, and his wife Acsanna. Yuriy decided to branch out on his own after earning a reputable following during his decade of service at Juan Juan Salon, an upscale hair salon located in Beverly Hills. The couple feels that they have embodied the "American Dream" with their new store location.





Police in Middle Schools Arqued

Passions, on both sides, ran high Monday night as the city council weighed in on possibly expanding the police department's operation Safe School placing armed uniformed officers at both Wilson and Washington 6-8 grade middle schools.

Police Chief Bernard Melekian said the Pasadena Unified School district was looking to make official a situation that was already occurring. It also said the issue was to be heard by the PUSD.

"I would argue that we are formalizing a situation that already exists," he said further adding, "It is actually a formalization of a reality of the relationship between the city and the school district that has existed since September 2006."

McAustin said she thought the council was not being given power to oversee the program something other council members expressed concern about.

Wednesday night the PUSD tabled the issue during a special meeting after numerous civil rights groups showed up, including the ACLU. The city had anticipated asking the school board if they wanted to expand the program permanently to all middle schools.

Board Member Renatta Cooper said before the issue was put off, "I think the whole issue of having officers on the campus is so students will be interrogated without being advised of their rights, without the presence of parent or guardian. We have numerous anecdotal examples of just that happening. Not only that but parents and guardians not being given the record

think that the community is quite right not to trust us when we allow that as fairly standard practice."

According to Melekian, Safe School Team officers now daily interact with middle school students attending Marshall and Blair High Schools as well as students at Wilson, Washington, McKinley and Norma Coombs.

He said, "This is done with great success." The idea would be that officers are stationed at the schools.

Melekian explained that no additional personnel would be hired although the council did ask what it would take to do that. "Taking this to the next level," Councilmember Victor Gordo questioned.

'We have talked about expanding the number of officers," Melekian said. "My belief is based on staffing projections, scheduled graduations academy and scheduled training

He did not give the number officers needed only saying it would depend on how many schools they covered.

Councilmember Steve Madison said they needed to immediately look for ways to fund it and move forward. He said it was one of the best ways they could support the PUSD.

"We want our men and women officers in these schools," he said. "Interacting with kids that are making decisions that are affecting which ways their lives are going to turn out."

He also said the police are positive roll models and that there was nothing negative about that. He added that crimes were being committed at younger ages.

Speaking for both himself and councilmember Jacque Robinson, councilmember Chris Holden asked about oversight and their roll as a council.

"I know she had some concern about parents and the parents participation involvement and having an opportunity to understand how shifting to the middle school would work if its about addressing the issue if its about preventive type of enforcement," he said on behalf of Robinson."

He also suggested they have a discussion about all the policies. Melekian said the PUSD had already had two meeting with the public. There was concern that police were in the schools just to

Speaking on behalf of the ACLU Michele White said they needed to provide more information on what instigates an arrest. She also said kids were being tricked into giving statements something councilmember Steve Haderlein asked proof of.

"What kinds of rights are being given to parents and children before an arrest is made?" White asked. "What kinds of questions happen prior to an arrest?

She also said they had complaints that statements given to police by children were later being used to make arrests.

"The parents need to know much sooner and be involved much earlier," she said. "The kids need to know they have the right to remain silent, if what they say is going to wind them up in some kind of incarceration or expulsion

from school." Melekian had said during 2006-2007 they responded to 3,700 calls for services in the high schools of which 798 were resolved with no paperwork. A total of 158 calls were referred to for mediation and less than 100 arrests were made he said. Only 30 were for serious felonies he added. In late 2007 and 2008 that number dropped to 2,300 with only 40 arrests according to him.

Others were concerned about the cost of putting officers in the schools something they said could be done much cheaper. Melekian later said that schools still had security officers in schools as well as police.

The Quiet Revolution

By that I mean the world has wrapped its arms around Barack

Obama and he has wrapped his arms around the world. This has been the most stunning of victories and for many of us, including myself, the election of an African American to the Presidency of the United States of America

myself, the election of an African American to the Presidency of the United States of America is something we never thought we'd see in our lifetimes.

I am 75 years old, African American and have seen and experienced things most of you cannot imagine or understand. I cannot help confess that I have been very angry, for many, many years, about the debilitating, dispiriting and sometimes fatal aspects of the racism that has gripped this

country since its inception and exists even now as we celebrate this historic election.

I grew up in Washington, D.C., one of the most segregated cities in the south where the only newspaper that spoke about black activities, achievements etc. was the 'Afro American' which was published in Baltimore, Maryland. Unfortunately but necessarily, the Afro American newspaper also reported all the horrible things happening to Negroes (which we were called at that time) around the country. Because of this necessary journalism I, as a kid, was exposed too frequently, sometimes as often as three or four times a month, to pictures of Negro men who'd been lynched, (hanged) mutilated and / or burned

alive in Mississippi, Alabama, Georgia or some other place simply for being black or for refusing to step off the curb when a white was walking in the opposite direction, or for not saying yes sir or yes ma'am when addressing a white man or woman or for staring at a white woman or for refusing to give up their wives or daughters to slave holders. What usually happened was that the Negro male was whipped, lashed and sometimes shot or lynched. Quite often these lynching's were held in a carnival atmosphere of family picnics wherein white families were encouraged to attend the lynching's and to bring their kids and picnic baskets. On many occasions the children attending these murderous and insensate gatherings were encouraged to stab the hanging Negro with their picnic forks and knives. Families often had their pictures taken standing next to the hanging (sometimes charred) Negro much like one does when one has shot a deer or hauled in a large fish of some sort.

Once, in 1952, while on liberty when I was stationed at the Jacksonville, Florida Naval Air Base, I rode the bus to town and saw, for the first time, a sign that said "Negroes in the back". When I refused to sit in the back of the bus after several orders by the bus driver, he called the police and I, uniform, wings and all, was physically slammed into the back of the bus by three motorcycle cops who threatened to kill me if I didn't stay put. Once, while on liberty, I returned to Washington, D.C., in uniform with wings and all, to look for an apartment for my intended bride and myself and was greeted by an Asian woman speaking broken English who told me they did not rent to Negroes. Once, late at night, on the way to a social in Atlanta with a friend of mine we were accosted by the police that told us "n......s are supposed to be off the streets after 10 p.m." These are but a few of many such tales I and many other Blacks could tell if prompted.

I've mentioned all these things to highlight what the election of Barack Obama means to me. It means that in order to comfortably accommodate this social and cultural milestone I shall have to tuck away the horrible and lurid crimes of the past and begin to embrace a vision for a future in which the acts of those I've mentioned in this column will no longer be contemplated or possible. I have a mental box in which I've tucked away these memories and which I've sealed with my tears from memories of the past as well as those I've shed in the felicity of this moment of social triumph.

Conflict between different tribes, religious sects and races has always existed, frequently escalated to violence, but

only in America been vanquished to the point where a minority member can be elected as leader. And in the process, we've witnessed the acceptance of our second female Vice-presidential candidate and the record-breaking participation of voters across all demographic categories. Only in America!!!

This unprecedented unity of white and black, male and female, and young and old will undoubtedly be the focus of innumerable studies in the future, in the course of which we will learn so much more about our greatness and the responsibilities that come with that. But there are practical and philosophical issues that have been raised and settled in this election that warrant our attention as well.

Many have claimed that Barak Obama's past voting record demonstrates that he is a hard left Liberal, and that accordingly his election evidences a left turn in our national demeanor. While the premise may or may not be correct, the conclusion is steadfastly wrong.

Barak Obama won this election by enunciating a number of moderate positions, not the least of which were his call to bipartisanship and emphasis on hope and optimism. I am finding it very difficult to tear myself away hearts. Plainly put, from the television tonight to fulfill my weekly obligation to write this column. The enormity of what has happened on this election night is overwhelming. It has been, perhaps, one of the most proud moments in our nation's history, and one that I am thrilled in which to have played a part. I, and a record number of other citizens, spoke loud and clear with our votes, and for the first time in my life, I feel empowered by that right.

I was terribly patriotic as a child... the national anthem always made me cry...I remember the pride I felt when it was my turn to carry the flag for my Brownie troop in our Memorial Day parade. But as the Viet Nam War years dragged on, I was surrounded by the anger and frustration of the anti-war movement, and though I was too young to have a say in our governmental policies, I had very strong feelings against the war and our government. But it was not until I left the country and traveled abroad to Germany that I saw how the rest of the world viewed my homeland. It was 1971. I was only 14, but I had begun to see the hate and resentment that other countries had for the U.S. and its policies. I remember driving through a section of Nuremburg with the family with whom I was staying and seeing the words "Ami go home" scrawled on a cement wall. Uschi, my German friend, apologized to me and told me that not everyone felt like that. "Sorry for what?" I asked feeling rather naive, "What does that mean? Amigo home?...Friend home?'

"Not AMIGO," she corrected, "It's AMI go home. Ami is what we call Americans...and they don't hate all of you...mostly just the army that is here." I was suddenly embarrassed to be an American...I felt like the ugly girl at the party sitting in the corner all alone...thousands of mile from my family, friends and country and totally let down by the nation that I had been raised to believe was beloved and envied by all...the powers that be at the time had apparently alienated us from the rest of the world.

It's difficult to define patriotism ... it has a different meaning for everyone. Some feel that it needs to be flaunted (kind of like those football fans that strip down and paint their bodies with their team colors) ... some simply hold it quietly near their

particular country, and like any other kind of pride, it can be a good

thing, as long as it does not blind one to truth. In recent years ... the last eight to be exact ... the truth for me has been that there has not been much that I have been very proud of when it comes to our country ... my patriotism has been at an all time low. The direction that our country has been heading in has been discouraging to me, to say the least. I have seen a nation filled with hate and fear. I have seen a nation of self-centered, self-serving, compassionless people, obsessed with wealth and material things. I have seen a hateful, intolerant, judgmental and hypocritical religious right that bends and shapes the teachings of their scriptures to justify their transgressions toward others. I have seen corporate greed dictating our government's policies. I have seen the development of an apathetic and (often willfully) ignorant population. I have seen the family structure fall apart, taking with it the most important values of a good education, hard work, honesty, integrity, and compassion. All have been sold out to the importance of acquiring more personal wealth. This is the America I have been seeing. This is what most of the rest of the world has been seeing, too. It was not until this evening that it became clear just how many Americans had been seeing the same and had grown disheartened enough to do something about it.

When I heard the news anchors call the race for Obama tonight, like many other Americans I'm sure, I cried. I cried for all of the people who sacrificed their lives so that our country could reach this point. I cried for all of those of color who have waited so long to feel that they truly have a voice in this land. I cried for the hope that Mr. Obama has inspired in so many in this country ... hope that this election can mark a change in the way that we treat one another and the rest of the world ... hope that it can mark a change in the way that the rest of the world views our country ... hope that we all have learned that our voices can be heard if we speak as loud and clear as we did today. And I cried from the pride and patriotism that filled my heart once again...once again it feels good to be an American.

Looking Up With Bob Eklund Phoenix Lander Enters Safe Mode As Martian Weather Chills Down


IN CASE YOU'RE SHIVERING at the thought of the approaching Southern California winter season, just be glad you're not up in the Martian arctic with NASA's Phoenix Mars Lander, where overnight temperatures have fallen to 141 degrees below zero Fahrenheit. The long-lived spacecraft now in the fifth month of a mission intended to last 90 days—entered "safe mode" last week in response

to a low-power fault brought on by deteriorating weather conditions. During safe mode, the lander stops noncritical activities and awaits further instructions from the mission team.

Weather conditions at the landing site in the north polar region of Mars have deteriorated in recent days, with overnight temperatures falling to -141F and daytime temperatures only as high as -50F, the lowest temperatures experienced so far in the mission. A mild dust storm blowing through the area, along with water-ice clouds, further complicated the situation by reducing the amount of sunlight reaching the lander's solar arrays. Low temperatures caused the lander's battery heaters to turn on for the first time, creating another drain on precious power supplies.

"This is a precarious time for Phoenix," said Phoenix Project Manager Barry Goldstein of JPL. "We're in the bonus round of the extended mission, and we're aware that the end could come at any time. The engineering team is doing all it can to keep the spacecraft alive, but at this point survivability depends on some factors out of our control."

The ability to communicate with the spacecraft has not been impacted. However, the team decided to cancel communication sessions last week in order to conserve spacecraft power. By turning



off selected heaters, the mission hopes to preserve power and prolong the use of the lander's camera and meteorological instruments.

Originally scheduled to last 90 days, Phoenix has completed a fifth month of exploration in the Martian arctic. As the Martian northern hemisphere shifts from summer to autumn, the lander was expected to generate less power due to fewer hours of sunlight reaching its solar panels. "It could be a matter of days, or weeks, before the daily power generated by Phoenix is less than needed to operate the spacecraft," said JPL mission manager Chris Lewicki. "We have only a few options left to reduce the energy usage."

THE WINDS OF CHANGE. Here in sunny Southern California, summer is also shifting to autumn, and the change is most noticeable when a cold front blows through as it did the past few days. Last night I happened to be parked at the top of the Bel-Air hills. A meeting I had been attending there had finished up just as the final election results were coming in, and before I turned on the car radio to hear President-elect Obama's acceptance speech I paused a few moments to listen to the rising wind following our early autumn storm. The air was filled with a never-ending variety of notes and pitches and tones, as gusts passed over the hilltop and touched branches of pine or oak or cottonwood. It was a night of many new voices, a night to long remember.

Sounds of the fall wind, High among the Bel-Air hills... A change of season.



The Good Life



Many baby boomers within 10 years of retirement age are facing this fact: they may not be able to afford the lifestyle they want later in life. If you are one of them, take heart. Experts agree that it is possible to make up for lost time. While specific recommendations vary, there is general consensus on the basic steps.

'First, get a handle on your financial situation," advises William L. Anthes, Ph.D., president of the National Endowment for Financial Education. "Take an objective look at your current status and your long-term financial needs, and calculate the shortfall. Determine your status.

Start by knowing your retirement costs. Incorporate likely spending fluctuations; allow for adequate health insurance, including coverage for long-

Next, list all your retirement assets, including your home, and the amount you will receive in pensions and Social Security payments. Ask former employers for a Pension Benefit Estimate as necessary, and contact the Social Security Administration or refer to your latest Social Security Retirement Benefit Estimate statement.

Subtract your retirement assets from the estimated goal amount; the difference is your savings goal.

Take full advantage of existing options.

Contribute as much as possible to workplace retirement programs, such as 401(k) or 403(b) plans. Be sure to save enough to re-

ceive the maximum employer match.

Capitalize on tax breaks for older workers. The 2001 federal tax law, which expires in 2010, includes special catch-up provisions for people born in 1952 or earlier; changes affect Individual Retirement Accounts (IRAs) and

Roth IRAs, as well as workplace programs. Allowable contributions began increasing in 2002 and continue to climb.

Shift your priorities.

Cut your expenses; pay down debt and save more. Arrange for automatic deductions from your account to savings. This is to both help you avoid the temptation of available cash and to ensure that money is invested at regular intervals. Each year, save an increasing percentage of your income. Diversify; spread your investments to balance risk.

Preserve your home equity.

Avoid continually refinancing your home to preserve your growing equity. Work on additional principle reduction with that extra little bit added to each payment. It adds up. As your home increases in value and your balance drops you will be more prepared to take advantage of a Reverse Equity Mortgage at age 62. licensed to accommodate 41 residents. They can enjoy the four and a half manicured acres, in five home-like cottages. Each cottage has a common living room, a full kitchen and laundry facilities for residents' use. Three, family style meals are offered each day at the communal dining room, with menus planned a month ahead by a dietician consultant and foods committee. I can attest to the delicious food and their warm hospitality, as I enjoyed a wonderful lunch with many of these active, engaged seniors. Many stopped by, inviting me to their rooms to visit.

Ambulatory seniors over 65 can move in as independent living residents for approximately \$2500 a month. Administrator, Jill Levredge points out that this amount covers three meals a day, transportation to local medical appointments, medication management, and basically everything except medical related expenses, personal items and extras like a private phone or upgraded cable service to their private suites, which include a full bath. Current residents who find they need additional care can elect to move within the British Home to the

assisted living cottage. Audrey Mc Ilwrath, President of the Resident's Council, points out that residents here don't just sit back and watch life pass them by. She, for instance, continues to offer her skills in training

the Rose Parade's princess each year with her public speaking skills. Beryl Burridge, another resident, is very active in the volunteer program at Methodist Hospital. The British Home is a freestanding residential care facility for the elderly, (RCFE) founded by the Daughters of the British Empire. There are three other British homes across the US, in

Brookfield, IL, Ossining, NY, Houston, TX. The DBE fund raising and volunteer efforts originally established these homes for senior of the British Commonwealth who needed or wanted to stay stateside, some after years of service as nurses or nannies. Residents come from many British influenced locations, including England, Ireland, Scotland, Australia and Canada, often because relatives live locally. Today, the home is open to seniors of all nationalities and faiths, though the personality of the British Home remains definitely,

Several British magazines are stacked in the various reception rooms, also known in California as living rooms. Framed pictures of the British royalty abound, including one of the Queen visiting this very home in 1983. Steak and kidney pie, plus liver and onions are occasionally served, although an alternative main dish is available for those who might not wish to eat so traditionally British that day. The silver tea service always remains polished and on display at the antique buffet in the dining room.

Everywhere, DBE volunteers leave their stamp and loving impressions on the place. Rhona Jorgenson, retired from Fox television, comes regularly to visit and volunteer with the Home's mascot dog, a black lab named Cotton. A picture of this rescue dog is even framed in the guest suite. Rhona was busy planting and gardening during my visit, but took a bit of time to join me for lunch.

The residents and staff are proud of the MBE status of current DBE board president, Marlena Smith,

received two years ago. Many of the past presidents have also received this honor. MBE, Most Excellent Order of the British Empire, is an honor bestowed by the Queen on exceptional persons dedicated to

Even Jill Levredge, administrator for the past five years, was first a DBE volunteer here. Her mother was a DBE volunteer, too.

According to the British Home website, "Their vision of a place where elderly people could be cared for in a warm and kind environment continues to this day." This is clearly evident everywhere. All the areas are geared to feel homelike, including the assisted living cottage, with elegant furnishings, carpeting and hardwood-style floors favored over laminated flooring, granite counters and modern kitchens in process, and easy to use walk-in showers in the private baths. A hair salon is staffed regularly. A podiatrist comes onsite once a month and a CNA is onsite 24/7.

Every room opens to the interior common areas, and also to the outside, allowing easy inside to outside access. Everything is on one level, easy for those with walkers, and a covered walkway protects residents from the elements when walking to and from the communal buildings.

DBE ensures that the home is kept meticulously maintained, free from odors and regularly updated. Though traditional, elegant furnishings are throughout the cottages; their current fundraising has allowed them to modernize the kitchens and baths. Painting and building care is always ongoing, so the place always looks manicured.

A unique feature at the British home helps ensure that a move here is the right choice. After a potential resident applies, they are welcomed for a two week, complimentary trial stay, to see if they are comfortable making this monumental move. Another caring feature is for those in the independent living cottages. If a cold or other illness doesn't respond quickly to rest and in- room attention from staff, they are invited to move to a respite room, to receive closer monitoring during an illness. "Our primary concern is to prevent pneumonia," Levredge comments, "and this respite system works very well."
