#### A MESSAGE FROM THE CHIEF:

With the close of 2008, we can review community safety and crime rates. The good news is that in 2008 there were no murders, robberies, or rapes reported in Sierra Madre. Crime decreased in several categories. Larceny (thefts over \$400.00) dropped 37%, from 132 incidents in 2007 to 83 incidents in 2008. The greatest decrease was in thefts from unlocked vehicles. Auto theft dropped slightly from 9 incidents in 2007 to 8 in 2008, an 11% decrease. Vandalism dropped 26%, from 120 incidents in 2007 to 83 in 2008. Crime increased in two major categories—assaults and burglaries.

Felonious assaults increased from 26 in 2007 to 29 in 2008, up 11%. About 75% of the incidents involved domestic violence against a spouse, cohabitant, or child. The remaining incidents occurred at parties, in bars, on the roadway, and at a school. The greatest crime increase was in burglary, up 47% from 34 incidents in 2007 to 50 incidents in 2008. At least 8-10 of the burglaries were believed to have been committed by the same suspects who were arrested in mid-2008. Some of our burglary victims' stolen property was recovered after search warrants were served on the suspects' homes.

It is important to acknowledge that crime statistics frequently change as cases are reclassified. For example, an officer may incorrectly classify a crime report and it may not be corrected in time to reflect accurate data reporting. This problem is common to nearly all police departments and accounts for some inconsistency in

In 2008 the Police Department increased its Neighborhood Watch programs, creating closer bonds within the community and providing tools to prevent and report crimes, especially burglaries. Each time a Neighborhood Watch presentation takes place, an officer identifies a block captain who is willing to be responsible for sharing crime information and reaching neighbors in an emergency. Several past participants in Neighborhood Watch presentations have subsequently called police to report events which have resulted in arrests.

During the rainy weather in November and December 2008 the City went to

"Yellow Flag Alerts" in anticipation of debris and mud flows on the burned hillsides above the Canyon neighborhoods. The block captains were an invaluable resource. One of the methods City officials used to convey emergency information to the public was through the neighborhood block captains. This was especially effective in the Marlborough Terrace neighborhood where Kim Vollstedt, Catherine Adde, and Ted Saraf did an excellent job in reaching out to their neighbors.

Starting in January the Police Department will have a Citizen's Service Portal on the City website. This is an online reporting system for your convenience. You will be able to access a link on the City's website to reach the portal. Initially we will reserve this for reporting minor crimes and incidents that generally do not require follow up investigation, such as a lost property report. More information will be forthcoming.

The Sierra Madre Police Department welcomes your involvement in our crime prevention efforts. I encourage you to participate in a Neighborhood Watch program. You may call Sgt. Ruben Enriquez or Off. John Ford at 355-1414 for further information. I also invite any resident or business employer or employee to come on a ride along with an officer. We will try to accommodate you whenever possible. Just call 355-1414 and ask for the watch commander. #### **Christmas Tree Recycling**


**Sierra Madre** • Athens will pick up your Christmas Tree for recycling from December 26, 2008 until January 17, 2008. Please put your tree at your curb side or next to your bin on your pickup day. Please be sure all ornaments, stands, tinsel, popcorn etc. are removed leaving only the tree. (Plastic trees may be placed within recyclable containers.) **Pasadena** • City of Pasadena residents have several options for disposing of their holiday trees, compliments of the Department of Public Works. Participants are asked to remove all stands, ornaments and lights so that the trunks and branches may be recycled as compost. Residents may drop off their holiday trees for recycling Monday, Dec. 29 through Saturday, Jan. 3, at: \*Eaton Blanche Park, 3100 E. Del Mar Blvd., parking lot on Millicent Way; or \*Robinson Park, 1081 N. Fair Oaks Ave., parking lot on Morton Street. Residents with trash pickup services from city of Pasadena may place their trees curbside, to be picked up on their regular trash pickup day. Trees will be picked up January 5 through 16. **Arcadia** - Single-family Residential: Holiday tree recycling begins December 26 and ends January 12, 2009. Trees should be placed at the curb on your regularly scheduled trash collection day. Waste Management will pick up the old trees and recycle them in an environmentally sensitive manner. All tinsel, ornaments, stands, and nails must be removed. A separate truck will collect holiday trees, so please do not place your holiday tree in front of your regular refuse/recyclable carts. *Multi-family Residential*: Please call Waste Management Customer Service at (800) 266-7551 to arrange for your holiday tree to be picked-up and recycled.

**Monrovia** • The City of Monrovia has franchised residential waste hauling to Athens Services. Athens may be reached at (626) 336-3636.

**Duarte** \*Collection from Dec. 26 to Jan. 17 The City of Duarte through its franchised trash hauler, Burrtec Waste, will provide a Christmas tree collection service for residential customers in conjunction with the Los Angeles County Sanitation District's annual Christmas Tree Recycling program. The trees will be ground up for composting or used for the County Sanitation Districts' landfill Cover Project. Christmas trees will be collected on regular trash collection days. 

#### Cashing In On Waste

A group of local High School students knew what the right thing to do is when you have 20 to 30 tons of trash left from a parade that drew close to 700,000 people - recycle. And that's exactly what they did.

Wearing t-shirts that read, "Ask Me Why I'm Recycling," student in small groups from Gabrielino High School waked up and down the parade route Thursday picking up bottles, cans and plastic containers. The students said all the money they make will go to providing water purifiers in impoverished counties.

They also said they wanted to bring awareness to recycling which was clearly not on the minds of many parade goers. It was hard to estimate how much they were collecting but each of them had large trash bags filled with stuff.

The city Department of Transpiration, responsible for cleaning up the streets in the aftermath, said by 6 a.m. Friday it would be hard to tell there was ever a parade. One worker said they first go through picking big items, everything from sofas to cardboard to blankets, (left after keeping someone warm overnight). Then wash the street with power hoses.

Other treasure hunters, every year, also comb the ruble looking for TVs, radios and other valuables

Martian Pastucha said last year about 35 tons of waste was left after a 24 hour period. He said at the time it was hard to estimate, "I hate to give a number because it varies year to year." Fire officials estimated more people came out this year than last.

The Governor's Trophy for the best depiction of life in California went to the city of Roseville for their entree "Entertaining Dreams for a Century." This was a first for the city. The 55 foot long float portrayed an almost lifesized replica of a 1909 Union Pacific engine that made the Roseville-to-Sacramento run, pulling two Pullman cars. The train was a crowd-pleaser as smoke poured from the stack and as the wheels rotated. There was also a load roar as the real train whistle blew.

Although all of the floats were judged Wednesday, builders of another crowd pleaser did not find out they had won an award until Friday morning when "Seaside Amusement" was announced KTLA's Viewer's Choice Award. Built by students at Cal Poly in San Luis Obispo and California Polytechnic State University Pomona, the float received 3,219 votes news anchor Wendy Burch reported. "The parade has gone interactive ladies and gentleman," she said about the newly added category that let people vote online.

Conzonire was on hand to present the award.

An official press release was sent out Wednesday by the school urging people to vote online, complete with a link. It was not immediately known how many of submitted came from, city of Huntington Beach and university friends. Burch was unavailable Friday afternoon for comment.

#### New Year's Resolutions That Are Doable

1- Look for Recycling Opportunities: With 2.8 million water bottles alone going into the trash each day in California, every container you recycle makes a difference. There aren't enough recycling bins in California and you can help change that. If your gas station or convenience store doesn't have a recycling bin, ask for one. If you ask for recycling opportunities, you'll get them (it's easier than you think). Visit <a href="https://www.bottlesandcans.com">www.bottlesandcans.com</a> to learn more.

2- At the Office: Start an office-wide recycling campaign, or put a bin next to your trash can for beverage containers and paper. The CRV funds collected from most beverage containers can help your company reduce costs. Call 1-800-RECYCLE for information.

3- Reduce and Reuse: Help lessen the amount of waste by buying items that use little or no packaging, or "buy in bulk," which reduces unnecessary and excessive packaging. Also, find ways to use items

over and over again, such as refilling a water bottle.

4- Buy Products Made from Recycled Materials: Resolve to "buy green" by purchasing at least one recycled-content product on a regular basis, such as computer paper. Look for the recycling symbol or ("made from post-consumer material") on a wide range of products. There is a growing array of new products made from recycled beverage containers including backyard planter boxes and fleece clothing.

5- Make Your Home a Toxic-Free Environment: Keep your home healthy by reducing unnecessary toxic chemicals. Paints, solvents and other chemicals should be disposed of safely, not flushed down the toilet or poured down the drain. Baking soda and vinegar substitute as great all-purpose cleaners. Clorox has a new natural all-purpose cleaner called "Green Works." I just bought some, and like it very much. Cut down on pesticides and fertilizers in your garden and you'll limit what gets washed into the ocean.

6- Get Out of the car One Day a Week: Carpool, use public transportation or bicycle. Using alternative transportation a day or two a week is manageable, and getting out from behind the wheel can be

7-Start a Compost Pile to Feed Your Garden: Convert yard clippings, vegetable peelings and even coffee grounds into nature's fertilizer for your garden. Home composters can be found at most home and garden centers. Visit <u>www.ciwmb.ca.gov/organics/homecompost</u> to learn about composting at

8- Go Local: Resolve to improve your hometown environment. Sign up for the local clean-up day, tree-planting effort or community garden. Volunteer at a local park. Adopt your own space and turn

turn our attention back to the social and political debates which framed the 2008 election and which remain with us today. Barak Obama has promised to bring about change and, in doing so, to re-unite America. While I will grant him the sincerity Gregory J. Wellborn

of his desire to move beyond the Red America vs. Blue America division, I think he misunderstands the causes of that divide and will find his goal of somehow uniting America in pursuing a common vision elusive at best, if not actually impossible to achieve. There are significant issues which divide conservatives and liberals, and they have not disappeared with the passage of the November election.

Those who believe, as Barak Obama does, that America can be easily united right now are making the assumption that the left and right both want the same thing for America and that the only difference between them is a difference of opinion on how to attain this shared vision. Unfortunately, the problem is not that policies are different. The policy differences stem from distinctly different visions, which can't possibly

At the most basic level, the left wants America to have a secular government and to become a secular society. They want religion to be banished from the public square and practiced only in the privacy of individual homes or houses of prayer. The right, on the other hand, wants America to continue being the distinctly Judeo-Christian nation it has always been and to have a secular government which acknowledges and supports the moral grounding of our political debates and decisions. The left sees the increasing secularization of the U.S. as a good thing; the right sees it as an unfolding disaster.

The left-right divide over religion's place in society heavily influences each side's view of America's place in the world. The right acknowledges America's sins but also sees America as the greatest force for good in the world. The right self-identifies as being American, is proud of U.S. efforts to help the oppressed around the world, and believes the U.N. impedes these efforts more than it has ever helped. The left self-identifies as being world citizens, is hostile to any belief that America is exceptional in the world, and see the U.N. as the foremost arbiter of right and wrong.

The left elevates equality over most other social values, while the right elevates liberty. In pursuit of this, the left sees nothing wrong with and in fact fully embraces – taking away in taxes more than 50% of somebody's income in and USA Today. With the holidays of opportunity and believes that people of behind us, it's time to different skills, intelligence and drive will and should attain different levels of achievement. The right believes that punishing achievement through confiscatory taxation depresses overall economic vitality. When the gifted and motivated are allowed to become rich, society at large reaps the benefits.

The taxing of income is a proxy for the size and role of government where there are also keen differences. The left desires a large, strong and invasive federal government in order to enforce its vision for secularization and equalization. The right desires a much smaller government as the only way to guard individual freedom and protect against tyranny. The left believes that income inequality has been the greatest cause of war. The right believes that the tyrannical desires of strong dictators of powerful governments have caused these wars and forced the U.S. to free various parts of the world on multiple occasions.

Lastly, the left sees race as one of the most important issues of our time. The right views race as insignificant and, oddly enough, fully embraces Martin Luther King's vision of a colorblind society. The right sees America as the east racist nation on earth with the best record, hands down, of assimilating foreigners of all races, religions and creeds. The left sees racism behind every social problem besetting inner city minorities. There is no sense of personal responsibility in the leftist view, only a sense of victimhood. The right believes that anyone can succeed in America if they want to do so badly enough and are willing to work hard enough.

Most of these views are irreconcilable. That doesn't mean that people can't be reconciled. We Americans do a pretty good job of coming together to help one another in tragedy and in such pedestrian pursuits as maintaining friendly relations with our neighbors and coworkers whatever their political beliefs may be. That is the great strength of America. But the political debate isn't going away any time soon, nor should it be swept under the rug in some false pursuit of cosmetic unity. Each side believes passionately in its vision for America. It is naïve to expect that either side will simply roll over and give up. If President Obama seeks to stifle the debate to achieve an appearance of unity, he will only fuel the fires of discord. If he is wise, he will encourage the debate and allow us to work out our problems in the loud, raucous, unpredictable, and almost always successful way we have been doing for more than 200 years. That also is the great strength

#### A Responsible, Phased Withdrawal

What is the role of the Canyon Zone Advisory Regulations pertaining to the development of a Canyon Zone have been discussed and studied in the past, but have never been finalized. The formation of a 5-member Committee will assist City staff in reviewing the draft zoning provisions that were previously developed, review the goals and objectives for the Residential Canyon

Services staff and legal counsel. Developing zoning guidelines will require review of residential development standards, technical in nature, such as building massing, height, setbacks, building square feet, lot coverage, parking, design, and landscaping. Also topics such as allowable deviations or exceptions from standards, permit process, and preservation and design relating to the unique residential setting and rural character of the Canyon areas, may also be reviewed by this Committee. The Committee will also provide input to the General Plan Steering Committee in their review of the Residential Canyon land use designation of the General Plan. The Committee's role is solely advisory. Final approval of the new guidelines can only be granted by the City Council acting upon

The recommendation of draft zoning guidelines could take approximately 6 to 8 months. Partici-pation on the Committee will require a commitment to attending monthly meetings during this period. Initially, in order to gain as much public input from Canyon area residents, a public workshop may be held. Attendance at a Planning Commission and at a City Council meeting to report on progress and to recommend zoning guidelines will also be expected. All regular Committee meetings will occur at pre-set meeting dates and times (pursuant to Brown Act requirements), and would be expected to last ap-

## Looking Up With Bob Eklund THE WORLD LOOKS UP IN 2009



With 2009 upon us, stargazers around the world are celebrating the International Year of Astronomy, which marks the 400th anniversary of Galileo's first astronomical observation through a telescope. Some 135 nations are collaborating in the year's activities.

The International Year of Astronomy 2009 (IYA2009) has been launched by the International Astronomical Union (IAU) and the United Nations Educational,

Scientific and Cultural Organization (UNESCO) under the theme "The Universe, yours to discover."

The official IYA2009 Opening Ceremony will take place in Paris on January 15 and 16. It will feature keynote speakers, including Nobel Laureates, and live video feeds to scientists working in remote locations.

The Cosmic Diary is an example of a global activity occurring during 2009. The project concerns the daily lives of full-time astronomers. More than 50 bloggers—professionals from over 35 countries employed by organizations such as ESO, NASA, ESA and JAXA have already begun producing content, writing about their lives, the work they conduct, and the challenges they face. The public can see what being an astronomer is really like, and how groundbreaking research is conducted.

Another project, 365 Days of Astronomy, will publish one podcast per day over the entire year. The episodes will be written, recorded and produced by people around the world.

100 Hours of Astronomy, another IYA2009 Cornerstone Project, is a worldwide event taking place from April 2-5, with a wide range of public outreach activities including live webcasts, observing events and more. One of the key goals of 100 Hours of Astronomy is to have as many people as possible look through a telescope, just as Galileo did for the first time 400 years ago.

The From Earth to the Universe (FETTU) Cornerstone Project is an exhibition arranged by IYA2009 that will bring large-scale astronomical images to a wide public audience in non-traditional venues such as public parks and gardens, art museums, shopping malls and metro stations.

The World at Night is an IYA2009 Special Project that is producing and bringing to the public a collection of stunning photographs and time-lapse videos of the world's landmarks with the sky in the background. The World at Night is preparing more than 30 exhibitions and educational events around the world.

During 2009, the sky will provide some exciting events, including the longest total solar eclipse of the 21st century, occurring July 22 and lasting 6 minutes 39 seconds over a narrow corridor through countries including India, Bangladesh, and China. A strong shower of Leonid meteors is expected in mid-November, with forecasters predicting upwards of an incredible 500 shooting stars per hour. In mid-October in the northern hemisphere, Jupiter will be visible at dusk, a perfect time to show the public the giant planet and its moons. This is an impressive sight through even a small amateur telescope.



## An Invitation: Tuesday, January 13, 2009 Please Join In The Fun

There is another structure of Sierra Madre volunteerism that many aren't that aware of or participate in, and that's the Meals-on-Wheels program. You've heard of it? But do you know what these volunteers really do on a daily or weekly -- or even monthly -- basis?

Susan Clifton, Sierra Madre Senior Coordinator, suggests that those whose interest is piqued should come to a coffee at 10 a.m. on Tuesday, Jan. 13, at the Hart Park House (Senior Center). And absolutely everyone is invited to attend the coffee and enjoy the camaraderie.

"Here's an opportunity to be involved as much or as little as you'd like," Susan said. "It's an opportunity for you to provide a much-needed service to Sierra Madre in no more than an hour at a time. A week, a month, whatever your schedule permits. It's the Meals-on-Wheels program," Susan explained. What exactly do these volunteers do? Someone is needed only on Monday through Friday

to drive around a specific route in Sierra Madre for about an hour to deliver meals to the permanently homebound citizens. Susan stated that it's also a service for those who have recently had surgery or an accident and need meals brought in for a short period of time. There are about 13 homebound in Sierra Madre now.

Helpers are needed for approximately an hour, beginning at about 11:45 a.m. Darlene Traxler is the volunteer Meals-on-Wheels coordinator, who schedules a monthly log of those who are able to assist in this program. The routes are planned to expedite the job. Darlene can be reached at 355-6220 or 355-0256 for more information.

Susan Clifton, senior coordinator, explained, "We contract the meals through YWCA Intervale Senior Services out of Covina. It's because of our volunteers that we're able to continue this very important service."

She described the program: "Volunteers drop off food once a day, weekdays only, which is the main daily hot meal for the homebound. Once a week on Wednesday two frozen meals are delivered so the recipients have meals for the weekend. There are two routes: northeast and southwest sections of town."

Susan said that two faithful volunteers -- Loyal Camacho and Nellie Haynes -- come in early to receive the food from the caterer and package each meal for the volunteer drivers.

Civic Club volunteers also provide tray decorations plus table favors for the senior center. They have available 70 favors monthly.

Susan said, "The Meals-on-Wheels program is very important in Sierra Madre. The size of the town makes it possible to offer this service. For some individuals it's not only a hot meal but also warm greetings, as well as an opportunity to check on your neighbors."

Susan concluded, "Here's an opportunity to encourage volunteers to participate in an already thriving program."

#### General Plan Steering Committee (GPSC)

The GPSC is a five-member committee, appointed by the City Council. A City Councilmember and a Planning Commissioner will attend meetings to act as liaisons to report the progress of the GPSC to their Council and Commission. The GPSC will be staffed by the Development Services Director and legal counsel.

#### What is the role of the GPSC?

The role of the GPSC is to meet on a regular basis to review the work products of City staff and consultant, provide input on those products, and provide the policy direction necessary to advance the update process. As initial tasks, the GPSC will be asked to provide staff direction as to the overall vision for Sierra Madre, priorities for development within the community, and more specific land use policies on which the GPSC will focus its efforts. The GPSC's role is solely advisory. Final approval of the updated General Plan can only be granted by the City Council acting upon the GPSC's and Planning Commission's recommendations.

#### How much time is involved?

The General Plan Update process is expected to take approximately 18 to 24 months to complete. Participation on the GPSC will require a commitment to attending monthly meetings for an approximately two-year period. If necessary, there may be occasions when the GPSC meets twice per month. There will also be occasions when GPSC members are expected to attend public workshops on Saturdays. All regular GPSC meetings will occur at pre-set meeting dates and times (pursuant to Brown Act requirements), and would be expected to last approximately two hours.

You can unfold your napkin at a five star restaurant or a hole in the wall and find uneven results for each

with this dish. It begins and ends with freshness and without it even the greatest chef will not be able to raise Lazarus. Fortunately Fu Shing has a large turnover of seafood so your chances are exceptional that you will encounter a shellfish that was recently displaced from its home.



Argiri Bratakos has realized her dream and mission in life, recently opening "The Carter Place" assisted living. Located adjacent to Bailey Canyon Park, at 400 E. Carter in Sierra Madre, the home was redesigned and remodeled to accommodate up to six

seniors requiring assisted living.

Though young in years, only 34, Bratakos has accumulated experience in several areas to prepare herself for this venture, which she perceives as a calling. She got her CNA nursing certification, and has worked as a behavioral therapist, a case worker and as a private caregiver, giving her critical, handson working experience in the various aspects of senior care and administration. Yet with all the experience in hand, it's Bratakos' warm and outgoing, yet serene countenance that forms the glue that binds this new offering together. "I want this to feel like a family living experience, not a clinical environment."

Her own grandmother, Kiriaka Babala, has lived with her for many years. When Babala moved here from Greece, and in with Bratakos, she was minimally responsive, undernourished and walking little. After a few months with Bratakos, her grandmother climbed many steps out of her retreat into Alzheimer's and dementia, and interacts well again with Bratakos, conversing in their native Greek. Bratakos attributes

Grandmother Kiki's success and comfort to the attentive ministrations and stimulation of the loving environment here. Through her experience with her grandmother, Bratakos felt called to offer her help to others in the community by opening an assisted living home here.

Her toddler, Phaedon, brings joy to all around him, and a life force only a young child can offer; very important to engender interaction and adding to the family atmosphere at The Carter Place. Bratakos' own family lives in a second house on the property, offering additional twenty-four hour care to the residents.

The single level home gives the feeling of a mountain lodge, with high wood ceilings with exposed beams and a massive, dual facing fireplace in the two living areas. The living spaces look out to the trees of Bailey Canyon Park, with peaks of the mountains

behind, allowing those less mobile to enjoy the change of seasons, light and weather The home has been extensively remodeled accommodate senior living with two large living spaces, easily accommodating wheelchairs. A whole new section was added to the home, with private and semi-private bedroom suites with private baths. All the baths are handicapable, with easy walk-in showers. Motion sensors and a call system alert the 24/7 staff to a resident's movement and needs during the night, and the yard has been gated, and a ramp installed, for easy, safe outdoor ventures.

Bratakos can furnish the resident's room or they can move in their own furniture, to feel more comfortable, familiar and home-like.

The first resident to this newly completed facility is already "part of the family," with another scheduled for move in soon, after a hospital stay. Bratakos now brings her residents for senior activities and exercise at Sierra Madre's Hart House located in Memorial Park. This keeps her residents connected to peers and the outside world. Bratakos has incorporated two special features



The Carter Place at 400 Carter - Sierra Madre






