



# FREE Curbside "Chipper Day" Brush Removal Assistance Program

You may have received a flyer to your doorstep outlining this program. Not everyone received one but you may still be eligible to participate. From the street front not all homes were obvious in need of this program--you have to decide.

On Monday, February 2, the particulars of the program will be discussed. Sierra Madre Fire Safe Council received a grant of \$48,000.00 for this "chipper program." We have emphasized CURBSIDE as the homeowner will have to bring the plant material that they want to have chipped and removed to the CURB. In other areas where "chipper days" have been held by Fire Safe Councils, the chipper truck was able to come onto the properties (rural areas with large acreages) do the chipping and then the property owner would spread the chips under their trees or in horse corals, etc.

We are going to be the first urban area to provide this program to the homeowners in Very High Fire Hazard Severity Zones and hope you will participate to make our neighborhoods

# Test Drilling for 710 Tunnel Already Underway

What appeared to be simple information given to the city council on the technical study for the proposed 710 freeway tunnel project, turned ugly Monday night when a city representative confronted the group of mostly engineers angry over not being informed of their presentation.

"I actually don't like it very much when you guys are doing this kind of thing without reaching out to me," said David Worrell a member of  $the\,710\,Steering\,and\,Technical$ **Advisory Committee.** 

Representatives of the State **Department of Transportation** District 7 had said they put out a calendar of public outreach something Worrell said he was unsatisfied with.

"I don't want a calendar of public outreach," he said. "I want you guys to say, we're going to make a presentation to the city council and we want to make sure you know that we are there.'

Mayor Bill Bogaard was also concerned over what seemed a lack of notification. He confronted the group over the fact that drilling had already starting in Pasadena without much public outreach although Project Manager Rebecca Barrantes had said outreach was something they were aggressively pursuing.

"As you can see we have been in the cities of Alhambra, parts of Los Angeles and we have started one boring in Pasadena, Barrantes said. "What we do is go out and talk to people, handing out the notices, the bulletins that tell them the where, what, why



when and for how long, and who they can call.'

She said they had talked to 490 people, none of which she indicated lived in Pasadena. Of those she said 42 had asked to be signed up to receive email, a very low number some residents later said.

No one spoke during public comment another oddity for an issue known for packing past meetings with protesters. Bogaard later asked about the drilling in Pasadena to which Supervising Project Manger Abdi Saghafi said he simply "I think I also overlooked. heard the drilling has begun in Pasadena?" Bogaard asked rhetorically. Saghafi quickly responded, "Let me qualify that your honor, basically what is happening is that within one location, which within Caltrans right-away; which is just south of Del Mar, we didn't need a permit [to dill] for that one." Saghafi also said drilling would take place at Pasadena Ave and Bellefontaine Street

without needing city permits. Geotechnical Engineer Yoga Chandran said drilling, they hoped, would start in the next few weeks.

Six other unnamed areas are also planned for drilling in what Chandran called small diameter boring, "which are about four to six inches in diameter that extends about 200 to 500 feet," he explained. All of the locations are subject to approval by city permits. They hope to drill by March

he also said. Councilmember Steve Madison asked if they required an environmental impact report, Chandran said no, but explained they were subject to city zoning requirements. He later said the reason they were giving the presentation was to obtain the permits. He said each boring would take from seven to 12 days to complete and block an area 12 feet by 60 feet. All work would be done during the day 7 a.m. to 5 p.m. and on public streets. Two other locations will also

be tested he said although using seismic flections, "these are nondestructive we use surface waves, through some vibrations source, that reflects the seismic waves," no drilling he also explained.

A line of sensors are setup and then a small shockwave is sent through the ground. The work would be done at night he said to minimize unwanted sound such as trucks and other vehicles that might dive by. Each test would take one night to complete. The process in similar to medical ultrasounds.

Councilmember Steve Haderlein asked the locations and times saying he wanted to reduce the number of complaints they might get.

Chandran said one would be at Edmonson Alley between east Fillmore and west Glenarm Street, and the other, south Grand Ave. between Madeline Dr. and Hermosa Street.

Saghafi said the reason for the study is to look at all practical routes for the extension of the 710 freeway although Worrell said it would probably a long time, "if ever," than saw any

What they are looking for is faulting, fault rupturing, displacement Saghafi said. He added that prior to this study the deepest drilling was only 50 feet. He said they plan to dig at lest 250 feet. They will also be looking for adverse drilling conditions, geologic material as well as groundwater condition and hazardous materials. "At this depth we hope to find out how the faults behave," he said.

# The Putnams -- Together They Serve



Reading Amy and Glenn Putnam's volunteer resume is like following the progression of two entities: libraries and gardens.

The Putnams have lived in Sierra Madre for 16 years and they've been involved heavily in the local Garden Club and Friends of the Sierra Madre Library during those years. Amy is also active in Sierra Madre Civic Club and Glenn is an enthusiastic participant in the Tournament of Roses in Pasadena.

Here is a rundown of what these two local people do in their spare time:

AMY: Friends of the Library President, Vice-President; Archives Chair, Chair of Wine Tasting, and member of the Friends of the Sierra Madre Library Board. Member of Civic Club, having served as Chair of the Education Awards Committee,

Treasurer, Parliamentarian.

GLENN: President of Sierra Madre Garden Club, and working through five Tournament of Roses Committees: Post Parade, Formation, Parade Operations, Decorating Places, Press Photo Trophy. "The Rose Parade committee varies from committee to committee...The Tournament always gives you the opportunity to volunteer for as much extra duty as you can handle...I work between 50 and 100 hours per year as well as hours before, during and after the Parade," Glenn explained.

Both Glenn and Amy are Members-at-Large of the Historical Preservation Society Board, and they volunteer together in the following entities: Garden docents at the Pasadena Showcase House of Design, docents for the Creative Arts Group Home & Garden Tour, ushers at the Pacific Rose Society annual competition, volunteers at the L.A. Garden Show, docents at the Wistaria Festival.

They volunteer together due to their mutual interests but often in different parts of an organization.

Amy said, "Our major purpose in volunteering is to give back to the community so that we all can continue to enjoy the wonderful environment in which we live. In addition, it's a fantastic way to meet new people, who are good people. Also, we like to cycle off of major responsibilities after several years in order to give other volunteers the opportunity to work these areas. Encouraging new volunteers is very important to us."

Glenn grew up in New Mexico. He has his MBA in business and has worked at JPL for five years.

"As Master Scheduler for JPL, I work with JPL's engineering teams to determine how best to fabricate and test spacecraft. With this information a schedule is produced for fabrication and testing spacecraft through JPL's facilities to prepare them for launch. This involves setting up fabrication locations with the proper cleanliness requirements, fabrication processess and procedures, tooling and assembly personnel. Testing involves providing test environments that the spacecraft will encounter during launch (vibration and acoustics noise pressure), separation from the launch vehicle or cruise stage (pyro shock) and operating temperatures in space or Mars (Thermal Vacuum). Each spacecraft is a highly complex, unique structure requiring coordination of multiple sub-assemblies into a final integrated spacecraft," Glenn explained.

"It is the Master Scheduler's responsibility to coordinate, facilitate, set priorities for the overall fabrication and testing of all spacecraft projects being built in JPL's spacecraft assembly and testing facilities." There you have it -- lots of responsibility for our Sierra Madrean.

Amy was raised in the Midwest and went to the University of New Mexico. As fate would have it, she and Glenn met there, and they were married in Houston, Tex. in 1976. Amy is an accountant and taught at Cal Poly Pomona and the University of Southern California. She has completed all of her course work for a Ph.D. except the dissertation.

Amy has had a debilitating digestive problem that has kept her home for a few months, but she is emerging with more vigor \_\_\_\_\_

than ever and is eager to proceed with her many volunteer activities.

The Putnams concluded that they volunteer only for the benefit to the community and the fact that it makes them feel good. "And

sometimes it even keeps us out of trouble."



#### Olbermann Calls for the Prosecution of Bush & Company

January 19, with Martin Luther King, Jr. day almost over and in anticipation of the inauguration the next day, I turned on MSNBC to watch "Countdown with Keith Olbermann". It's one of favorite news shows.

Olbermann adds controversy and humor to the otherwise brain numbing nightly national news broadcasts. In a word he is entertaining.

Olbermann is also fearless. He's taken on the Bush Administration, the War in Iraq and a variety of other touchy subjects. And he does so with his facts in order. Some may accuse of being biased and unfair, but no one can accuse him of being incorrect. The few times he has made a mistake in his reporting, he has quickly set the record straight, in person and on the air. He has integrity.

But Olbermann is not the subject of what I have to say. It is what he said in his 'Special Comment" segment of his show that Monday evening.

Olbermann began his piece by reminding his viewer that we were "tortures". That as citizens in a free democratic republic of the people, by the people, and for the people we are responsible for the torture of prisoners committed in our name by our elected officials and those that worked for them. In other words, George Bush, Dick Cheney, Condoleezza Rice, Donald Rumsfeld, and others acting on our behalf committed war crimes.

Olbermann reminds us that what we did as a nation was in violation of at least four international treaties, as well as federal laws prohibiting the use of torture both domestically and overseas, regardless of the rationale behind it. Torture is wrong, pure and simple. It is counterproductive, produces unreliable intelligence, and aids in the recruitment of new terrorists. Worse, it lowers the moral stature of the United States and puts American lives, both military and civilian, at risk abroad.

I mean, how we can preach to other nations that torture is wrong when we condone it ourselves. As Olbermann makes clear, it is irrelevant that our elected officials acted illegally and without our knowledge, we are still complicit because they were our officials.

Olbermann uses a variety of examples when we didn't remedy our national wrongs. He cites the Declaration of Independence (and I would add the Constitution) violated our national ideals by condoning slavery, only to have it return four score and seven years later as a basis for the Civil War. He gives other example from the Kaiser to Hitler, to McCarthyism to Watergate when those who ordered or committed their crimes we not held accountable, and how this desire to move forward led to even worse war crimes in the future.

I would also add Vietnam where we dropped more tons of bombs than in all the theaters of the Second World War. Not to mention Iran-Controgate, the violent over throw of democratically elected governments in Guatemala, Iran, Chili, Brazil, and a variety of countries around the world.

Olbermann's point is that to move forward as a nation we must first clean up the wreckage of our past. He argues that only by the Obama Administration investigating and trying those responsible for the war crimes committed by the Bush Administration can we as a nation, and as individuals, begin to heal.

Moving forward is one thing; not remedying our past wrong is another. It has been said by someone much wiser than me that history is prologue, and that those who don't learn from their past mistakes are doomed to repeat them in

Worst of all, by not addressing our war crimes we will be setting a terrible precedent for our future leaders--that they are above the law, and show the rest of the world that all our talk of freedom and democracy is pure rhetoric and not to be believed.



> Readers of this column will remember a little tutorial on the whole premise that government spending can actually help an economy. The theory is that each \$1 of government spending will yield 1.5 times that amount in greater economic output. This is called "the multiplier". There's little evidence to support this theory, but we need look no further than  $\dot{\text{common}}$  sense to thoroughly debunk it. Every dollar of government spending has to come from taxing or borrowing \$1 away from a citizen. That's \$1 less the citizen has to spend himself. So, if there is a positive multiplier when the government spends \$1, why isn't there an offsetting negative multiplier when a citizen spends \$1 less? If the multiplier really worked this way, why would we stop at a \$1 trillion "stimulus" bill? Why not spend \$15 trillion and make everyone in America that much better off economically?

> As we close the coffin and lay to rest true bipartisanship, let us remember that its brief 7 day life did illustrate that significant debate about national policy remains. Whether the topic is economics, social issues, military preparedness or foreign policy, conservatives and liberals have dramatically different views. Our founding fathers envisioned a system where these differences could be worked out through vigorous debate. They did not envision a system which stifled that debate in the name of unity or bipartisanship.

> Liberals didn't give up when George Bush won (twice), and I don't think conservatives should give up now. I expect conservatives and liberals alike to argue persuasively for their principles and positions. I expected President Obama to encourage the debate, not demand surrender simply because he won the last election.



What is the role of the Canyon Zone Advisory Committee? Regulations pertaining to the development of a Canyon Zone have been discussed and studied in the past, but have never been finalized. The formation of a 5-member Committee will assist City staff in reviewing the draft zoning provisions that were previously developed, review the goals and objectives for the Residential Canyon land use designation, analyze its relevance, and provide input in to the process of developing new zoning guidelines for the Canyons. The Committee will be staffed by the Development

Services staff and legal counsel.

recommendations.

How much time is involved?

Developing zoning guidelines will require review of residential development standards, technical in nature, such as building massing, height, set-backs, building square feet, lot coverage, parking, design, and landscaping. Also topics such as allowable deviations or exceptions from standards, permit process, and preservation and design relating to the unique residential setting and rural character of the Canyon areas, may also be reviewed by this Committee. The Committee will also provide input to the General Plan Steering Committee in their review of the Resi-Canyon land use designation of the General Plan. The Committee's role is solely advisory. Final approval of the new guidelines can only be granted by the City Council acting upon the Committee's and Planning Commission'



# Discovery of Methane Reveals Mars Is Not a Dead Planet

of methane in the atmosphere of Mars. This discovery indicates the planet is either biologically or geologically active.

The team found methane (the "natural gas" we burn in our gas stoves) in the Martian atmosphere by carefully observing the planet throughout several Mars years with NASA's Infrared Telescope Facility and the W.M. Keck telescope, both at Mauna Kea, Hawaii.

Methane is quickly destroyed in the Martian atmosphere in a variety of ways, so our discovery of substantial plumes of methane in the northern hemisphere of Mars in 2003 indicates some ongoing process is releasing the gas," said Michael Mumma of NASA's Goddard Space Flight Center in Greenbelt, Md. "At northern midsummer, methane is released at a rate comparable to that of the massive hydrocarbon seep at Coal Oil Point in Santa Barbara, Calif."

Astrobiologists are interested in this finding because living organisms release much of Earth's methane as they digest nutrients. However, methane does not necessarily prove the existence of life on Mars because other purely geological processes, like oxidation of iron, can also produce it.

Right now, we do not have enough information to tell whether biology or geology—or both—is producing the methane on Mars," Mumma said. "But it does tell us the planet is still alive, at least in a geologic sense. It is as if Mars is challenging us, saying, 'Hey, find out what this means.' "

If microscopic Martian life is producing the methane, it likely resides far below the surface, where it is warm enough for liquid water to exist. Liquid water is necessary for all known forms of life, Martian methane. as are energy sources and a supply of carbon.

On Earth, microorganisms thrive about 1.2 to 1.9 miles beneath the Witwatersrand basin of South Africa, where natural radioactivity splits water molecules into molecular hydrogen and oxygen,"

In a January 15 announcement, a team of NASA and university scientists revealed that they have achieved the first definitive detection It might be possible for similar organisms to survive for billions of years below the permafrost layer on Mars, where water is liquid, radiation supplies energy, and carbon dioxide provides carbon. Gases, like methane, accumulated in such underground zones might be released into the atmosphere if pores or fissures open during the warm seasons, connecting the deep zones to the atmosphere at crater walls or canyons."

> It is also possible that a geologic process produced the Martian methane, either now or eons ago. On Earth, the conversion of iron oxide into the serpentine group of minerals creates methane, and on Mars this process could proceed using water, carbon dioxide and the planet's internal heat. Although there is no evidence of active volcanism on Mars today, ancient methane trapped in ice cages called clathrates might be released now.

> One method to test whether life produced this methane is by measuring isotope ratios. Isotopes of an element have slightly different chemical properties, and life prefers to use the lighter isotopes. A chemical called deuterium is a heavier version of hydrogen. Methane and water released on Mars





Security Automatic Updates service, Windows Defender, have and Windows Error Reporting. It then connects to a server, where it receives further orders to propagate, gather personal information, and downloads and installs additional malware onto the victim's computer. The worm also launches a brute-force dictionary attack in order to guess the administrator password for the infected machine

in order to spread itself through network shares.

This nasty little feature is common to most with the latest security updates for their operating malicious codes that are identified as computer worms. The dictionary used in these aftacks usually contain variations on hundreds, maybe even thousands, of easily-guessed passwords (for example 123, ABC, QWERTY, combinations and variations of the logged on username, etc.). Given the computing power and speed of the average home computer, this can translate into hundreds of guesses per second. If a user has a weak password this can make the potential damage done all that much more devastating.

Even though the majority of the computer security headlines seem to deal with anti-spyware issues, no one should be under the impression that anti-virus protection issues are not equally as important, as demonstrated by this latest new threat from the bad guys. Users of the affected OS's (Windows XP, Windows 2000, Windows Vista) should make sure that their machines have been patched with MS08-067 available from the Microsoft website and that they have a functioning and updated anti-virus software solution installed on their machines.

# TABLE FOR TWO By Peter Dills Spitfire Saloon

One restaurant, where I never tire of dining in Pasadena, is The Arroyo Chop House. They have steaks so exquisitely prepared at this restaurant, that the cows make reservations. I love their King Crab Cocktail, too, and I don't mind spending (\$40) for a steak here, that is for sure. I do wish the Smith Brothers would pick up the tab once in awhile though, but that wouldn't make for a fair and balanced review now would it? I would take the chance if they will. Just kidding, I

abide by the strictest Restaurant Critics Code. Fortunately, that leaves me a wide berth.

The Smith Brothers have just opened up the Spitfire Saloon in the old Club De Lacey location. If you are familiar with the space I can tell you it hasn't changed much, and that's fine with me as I was always enamored with its looks. While curious to know where the 'saloon' piece of the name fits, I will just let that pass. The savory lunch fragrances attract some of Pasadena's finest business inhabitants, and my understanding is that the bar is even busy on weekday nights. No happy hour here. The GM, Christian, explains, "We pour a stiff drink and we don't see a need to discount". There is sound reasoning in that response.

This is my second foray at Spitfire. Well, it's either getting better, or I am getting better at ordering. I just need to order what they do best. I went to Spitfire with another fellow BBQ aficionado, and we both ordered their BBQ. The Chef came over, and immediately inquired, "Why are you ordering BBQ, we do other dishes so well?" Well, I thought it was a BBQ joint; you know, the sign says, BBQ and Saloon. She told me that the restaurant initially thought it was going to be a BBQ restaurant too. Anyway since they never fully got off that train of thought, they smoke their meats using hickory wood for the fire. I was disappointed though; too much sauce just about ruins a good piece of meat. True BBQ; well let me be gracious, Good BBQ doesn't need sauce. Just a light salt rub and the smoke should do an amazing trick. Anyway, I had the Smoked Tomato Soup (\$5.95), which was excellent, a lobster deviled egg that was great and my table shared the Ale battered Onion Rings (4.95), a large portion, but overdone on the batter.

Of the entrees we ordered, the Brisket (\$15.95) and the Ribs Sampler (\$21.95) seemed to hold the best smoked flavor. The Louisiana Spare Ribs were good, but I would ask for them to be dry next time and be able to use the sauce at my discretion. The menu offers over five different Salads. On my next visit, I will be sampling the "41" salad, which is a Caesar salad with Shaved Sonoma Jack Cheese.

The Wine list has many wines by the glass; I do enjoy a wide open selection such as this. The wines are on the high side, but this is some fancy Real Estate.

OK, I will come back with out my BBQ bib on next visit.

The verdict on the restaurant is \*\*\* stars.







Now published four times a year, this glossy periodical features insightful tidbits to photo essays to major in-depth articles. The topics range from restoration, accessories, history, furnishings, events, Arts and Crafts and upgrading, to philosophy, gardens and landscaping. My own American bungalow experience previously checkered and affected my perception and appreciation of the style and lifestyle. I grew up in a real "bungalów heaven" in Chicago where street after street and mile and mile of homes were of the bungalow ilk. My parents owned one early on; my grandmother, aunts and in-laws owned variations of bungalows. It was like eating Cheerios every day for breakfast. Bungalows were a given.

After leaving Chicago and my immersion in bungalows everywhere, I yearned for something different in my own abode. Recently, my interest and appreciation was rekindled, when I moved here to one of the epicenters of Craftsman and Bungalow life, the San Gabriel Valley. In particular, my tour of the Greene and Greene exhibit at the Huntington became my personal Craftsman epiphany.

The magazine's editor, John Luke, husband of Ann Luke from our Mountain Views Observer sales staff, took time recently to offer some insight into the development of the magazine and some of its features. Early on, they saw a need to put do-it-yourselfers and professional restorers in touch with good resources for materials, craftsmen and period as well as reproduction products.


