Winning the oldest community recognition program in the country was only the beginning for Sierra Madre volunteers. The celebrations are next. Their hard work

volunteers. The celebrations are next. Their hard work landed the city one of 10 spots to be called a 2007 All-America City, an honor which will be incorporated into the city's centennial celebration.

"It is weird to think on its 100 birthday, the city will forever be known as a 2007 All-America winner," said, Elisa Weaver, Deputy Director of Community and Personnel Services. "The thrill is indescribable, the pride you have for the city, just being American."

Weaver said the city's presentation Friday night was short lasting only 10 minutes with about 30 residents

A total of 60 sierra Madre residents went to the National Civic League's All-America City competition.

at odds and led to Measure V being put on the ballot. In January, the committee's application chair Josh Moran, outlined the reasons the League rejected Sierra Madre in 2006. This year, among other things, the All-America City Awards Steering Committee highlighted a study showing a drop in teen delinquency in direct relationship to the opening of the YAC in the mid 1990s.

The Mayor thanked all of the volunteers and staff who worked on the AACA and allowed audience members to speak about the award. Then Joffe got down to business. "We have numerous challenges facing us", "The city's long term financial condition; the lack of consensus on teh long range economic and physical development of the city; another possible initiative battle - the Police Initiative; and a potential recall battle." "We have a real need for dialogue in this city but we need to do it in a constructive manner"

The Mayor's presentation included the newly approved budget and a warning that we will have to make tough choices in the future. Nevertheless, "We're on the mend"

The meeting was conducted in the same manner as a closed session would have been with the addition of the opportunity for the public to hear and comment on the matter at hand.

Levin began with an historical overview of the key points that prompted

the lawsuits. Namely, 35 applications for new homes in the hillsides were denied because the developer did not comply with (continued pg. 6)

4:00 pm Eaton's Water. This is a 30 minute dramatized account of Benjamin Eaton's successful efforts to bring a dependable water supply to the Indiana Colony (later named Pasadena). The script was written by Michele Zack, author of the forthcoming Sierra Madre Centennial History. She will be here to introduce the

5:00 pm - Last Drop of Water. This 13 minute film was 5:00 pm - Last Drop of Water. This 13 minute film was made in 1911 at a time when pioneer movie producer, D.W. Griffith was filming in Sierra Madre. Though very brief, it contains a tale of unrequited love, a wagon train saga, an attack by hostile Indians, a desperate search for water, an unexpected but noble act by a bad guy, and cavalry to the rescue. It contains some photography that, even now, is startling in its novelty and beauty. Though filmed in this area, it contains no landmarks at all recognizable to us. landmarks at all recognizable to us.

5:30 pm - The Search for Billy. This 45 minute documentary was made in the 1960's. A CBS crew accompanied the Search and Rescue Team during a frustrating but successful search for a boy named Billy who had become separated from his Boy Scout Troop and was lost for several days in rugged terrain in Ventura County. It is a well told story and a fitting tribute to the work of the Sierra Madre Search and

6:30 pm - This Was Pacific Electric. This or documentary tells the story of the rise and fall of the world's greatest electric railway. It begins in 1872 with L.A's first horse car line and continues through to the last red car in 1961. The story was pieced together with rare film footage, hundreds of photographs and extensive interview

3:00 p.m. - The Family Plot (121 minutes) This 1976 cinema is Alfred Hitchock's last. It was filmed in part in Sierra Madre. The plot of this thriller is a witty and complex combination of comedy and drama. In it, a zany cabbie pairs up with a phony psychic in trying to find and exploit the long lost Rainbird family fortune.

5:30 p.m. - Invasion of the Body Snatchers (80 mins) This 1956 movie, filmed in Sierra Madre, is locally famous and has attained an almost cult status. In the small town of Santa Mira, a local physician named Dr. Binnell becomes concerned by increasing visits from townsfolk complaining that their nearest and dearest are simply not themselves. As a sense of alarm gradually spreads, Binnells investigations reveal that the complaints are not mere delusion, but that the previously peaceful town is being taken over by an alien force – dopplgangers who resemble their earthly counterparts in almost every way, save for lack of human emotion.

Tickets will be on sale at City Hall on Saturday beginning at 2 pm and Sunday beginning at noon. The cost of a ticket is \$5. Children admitted free. danger conditions. Along with this goes a declaration of Red Flag fire conditions that are announced on television news reports when the arrow is in the red.



District 6 Quarterly Town Hall Meeting: Housing Caps, Road Construction, Fire Prevention, Big Issues with Area Residents

Just hours before catching an airline fight to Cape Canaveral in Florida to watch last weeks shuttle launch as a personal guest of Congressman Adam Shiff, City Councilman Steve Madison held a town hall meeting with a solid turnout. Madison said nothing about the trip to Florida until the meeting was almost over although he had plenty to say when he got back.

"It was great but I want to make sure it's

city. I paid for the whole thing myself."
Madison also said that the two of them

were given a tour of the space center, met former astronauts, and were briefed about the 11-day mission that added solar

met former astronauts, and were briefed about the II-day mission that added solar power arrays and a new truss segment to the International Space Station. The 4:38 p.m. (est) launch of Shuttle Atlantis was flawless, "You could not have asked for better weather," he said.

The meeting started with Pasadena Fire Chief Dennis Downs saying the city was looking into a traffic signal preemption program as a way to deal with a rise in traffic congestion and adding response times. He also said the city was considering "Tow Away Zones" for high risk narrow canyon areas, most of which are in Madison's district, on red flag days. "When a fire engine or ambulance turns on their red-lights there's an emitter in that light bar capturing a receiver turning all the lights green for half a mile," he said. "You can set it however far you want so the traffic can clear in front of you." Downs also said this year's Americafest, 4th of July celebration, at the Rose Bowl would go on but said bis department.

4th of July celebration, at the Rose Bowl 4th of July Celebration, at the Rose Bowl would go on, but said, his department along with Pasadena police would be stepping up enforcement. "In the past we have only warned people caught with fireworks; with few arrests," he said. "This year anyone having fireworks will be arrested so even if you just hear them do arrested, so even if you just hear them do not hesitate to call 911."

In an effort not to cut the town hall meeting short, Madison took questions right up to the point where city staff ushered him out the door with a choice, - he go or miss his flight. The crowd then followed him outside still asking questions reminiscent of a high profile lawyer withholding legal information. The councilman had said earlier he was a former federal prosecutor

so the scene was fitting. Although the meeting was billed as a town hall style, most of what was said came in the form of city updates. Residents did however, speak out opposing plans for a new cell phone tower in their district. They also demanded answers to the slow progress of repaving Avenue 64 to which they got the exact response they sought: the overdue project was ahead of schedule. Most accepted the absurdly

confusing response.

According to most, the \$2.3 million project for street lighting, electric system undergrounding [sic], and street

improvements was originally scheduled to be finished in 2003.

The city also got \$6 million in highway and bridge reconstruction money from the federal government, Public Works Director, Martin Pastucha said. He described the funds as "extremely hard to get" and said "on top of that, we were asking for the monies for Historical reconstruction and seismic retrofitting of reconstruction and seismic retrofitting of

asking for the moints for insortical reconstruction and seismic retrofitting of the Laloma Bridge.

"This wasn't the cheapest way to go," Madison said. "But it was the right thing to do and I'm glad the other members were on board with this. At first I wasn't so sure that was going to happen."

Planning and Development Director Richard Bruckner said a cap, put into the city's General Plan 15 years ago, of just over 5,000 new housing units for the "core downtown area," was only 400 units away. The council had considered relaxing the caps, something Madison said he did not support. Bruckner said staff recommended that the caps stay in place.

The city also voted last month to place a citywide moratorium on construction of all new cell towers Madison said. The first reading of that ordnance was done Monday night. The applicant of the controversial new tower in District 6 has now put everything off until next year Madison said. "They are not happy," he

Nothing was said at the meeting about Nothing was said at the meeting about a new citywide WiFi agreement with Earthlink. That plan will place wireless receivers throughout Pasadena on ever light pole in the city with an estimated cost of \$5.8 million over seven years to provide the city's 133,936 residents with services although Madison said Monday the two plans were very different. "This ban would not have affected that," he said. "The wireless communication signal requires only a small box. These cell

signal requires only a small box. These cell towers are very large. They have to cover a much larger area,"

PCC Stabbing Suspect Sought in Brutal Attack of Police Cadet

At press time, Pasadena police investigators were still looking for a suspect in connection with a stabbing Sunday at Pasadena City College that left a police dispatcher with a collapsed lung and multiple stab wounds to his hands.

According to the police, PCC police cadet Ralph Humphrey was attacked from behind with a knife shortly before 4:22 p.m. in the school's police dispatch office located in the T Building. The call came to PPD from the school's own officers, spokesperson Janet Pope Givens said.

Humphrey was immediately transported to Huntington Hospital and was in stable condition. Givens also said investigators still had no suspect description or a motive.

PCC police put up alert flyers on doors around the school's main buildings and other high traffer area selving for mublic

other high traffic areas asking for public help. They are describing a 5 foot 10 inch tall male Hispanic with a possible tattoo on his elbow.

"Because the cadet was attacked from behind he could not give us a description," Givens said. "We are asking anyone that might have seen someone running from the school Sunday to call our investigators at 626-744-4522. We don't know what he might have locked like." have looked like"

said it is not uncommon to get multiple

No More Cell Phone Towers or Massage Parlors For Pasadena, Council Says

The Pasadena City Council extended a 45-day moratorium Monday night during a very short meeting. The action, first taken in April, is on new massage parlors in the city. The decision was made to extend the ban after city staff said they needed more time to research legal matters surrounding a more permanent ban.

In April former Council Member Paul Little called for a complete ban on new massage parlors saying that the council should also impose requirements that limit any parlors operations to at least 500 feet from any residential neighborhoods and be at least quarter mile from a similar operation unless it is in the central business district. He also said that background checks should be done on operators and technicians prior to hearing a conditional use permit application. Little requested a change in the city's zoning codes after reading a local newspaper article on what he referred to as, "illegal massages." The council then agreed. In May Little stepped down giving up his seat to Robinson after being on the council for 11 years. Little was appointed Monday by the council to The Rose Bowl Operating Company. "Your suggesting this is a way of getting back at Paul Little!", Bogaard asked jokingly referring to Little's leaving before they voted on massage parlors.

During the meeting all present voted for banning ground mounted cell phone towers and put in place another ordinance that would reduce residential impact fees for new elderly residential care facilities. Not present for either vote were council members Jacque Robinson and Chris Holden,

placement of a wireless antenna on an existing city light poll. That motion led to the city's decision regarding a current ban.

City Attorney, Michele Bagneris said any moratorium could open up the city to lengthy litigation although the new ban now does not apply to antennas such as the one proposed by T-Mobile.

Before the meeting closed Bogaard asked for a moment of silence in memory of former Pasadena Public Health Director Wilma Allen who passed away June 6. She retired in March after 17 wears of service to the city.

The Rose Bowl Operating Company approved, during a special meeting June 7, recommendations that the City Council direct city staff to work with the Pasadena Police Department in preparing a City Ordinance prohibiting bicyclists from riding more than 2 abreast on any public street. A city permit would now have to be issued for an event or activity that involved cycling according to the RBOC. This will include the area around the Rose Bowl the Board said.

The proposal came after complaints of injuries to pedestrians and cars as cyclists swarm around the Bowl four and five deep. For sanctioned events, police would monitor the activity.





Atlantean Voyage

On Friday, June 8, the Space Shuttle Atlantis began an 11-day mission that is vital to completing the International Space Station (ISS). As of this writing, the Atlantis had successfully docked with the ISS and was preparing to install a set of 240-foot-long solar panels on the Space Station. When the ISS receives a final set of solar panels and batteries about a year from proof it will be

Iss receives a man set or solar panets and batteries about a year from now, it will be equipped to support a crew of six instead of the present three.

The new solar panels need to be unfolded in space like a huge road map. They will be attached to an end of the Space Station's girder-like backbone via a huge "truss" expent weighing 18 tons:



with the datastrict of the life of the Station's girder-like backbone via a huge "truss" segment weighing 18 tons. Atlantis (STS-117) had been scheduled to launch in March, but a severe thunderstorm in February had moved across the launch site at the Kennedy Space Center in Florida, pelting it with golfball-sized hailstones that damaged foam insulation at the top of the fuel tank. The delay allowed NASA to use this flight to exchange U.S. Space Station crew members ahead of schedule. Flight engineer Sunita Williams, who set a record for space walks by a female and became the first astronaut to run the Boston Marathon (on a treadmill) in space, will be replaced by another American, Clayton Anderson.

This mission is the 118th Space Shuttle flight, the 28th flight for Atlantis, and the 21^a U.S. flight to the ISS. The launch of STS-117 marks the 250th orbital human spaceflight. The end of this mission will leave thirteen flights remaining in the Greec Shuttle of the Space State of the Space State of the Space Spa

leave thirteen flights remaining in the Space Shuttle program until completion of the Space Station in 2010. This timetable brings the sad recognition that the remaining shuttles—Atlantis, Endeavor, and Discovery—are approaching their collective curtain call. Completion of the Space Station will mean an end to the Shuttle program, according to present plans. "It's a little bit like taking your old car that you really have enjoyed, and trading it in on a new one," said Wayne Hale, the Shuttle's Program Manager. Future plans call for a new set of rockets and capsules—the Constellation program—designed to send astronauts to the Moon and perhaps to Mars.

 ${f Q}$: How important is a cover letter? I've been told that most recruiters do not bothen to look at these.

A: A cover letter is very important and they certainly are read. The purpose of the letter is to introduce yourself. Compare your cover letter to an appetizer and your résumé to the main course.

A résumé by itself is impersonal whereas in a letter you can be more descriptive and give yourself a "human face." For example, you might want to say that your background of 12 years in customer service has enabled you to tactfully handle irate clients and remain calm in stressful situations. If you are in marketing, you might want to emphasize your outgoing personality as well as your persuasive communication skills and how these have resulted in many new clients and cross-

selling to existing clients.

The cover letter also serves the purpose of explaining specific circumstances such as perhaps your interest in changing careers or your absence from the workforce for a number of years.

Q: I recently had an interview and am a bit concerned about the outcome. I feel I answered the interviewer's questions appropriately, but when I finished with my answers there seemed to be long periods of uncomfortable silence. Do you think the interviewer was waiting for me to add more information?



The Two Lives of The Blinn House: Architectural Legacy and Dynamic Home to Pasadena's Women's City **Club**

On a turn of the 20th century visit, On a turn of the 20th century visit, Pasadena entranced Chicago lumber magnate, Edmund Blinn, with its mild climate and the invigorating cultural opportunities. As a result, the industrialist commissioned popular Chicago architect, George W. Maher to create an estate in the elite Ford Place, a four block square enclave of prestigious Pasadena estates. Located in the heart of today's downtown Pasadena, much of the surrounding neighborhood now of today's downtown Pasadena, much of the surrounding neighborhood now encompasses the Fuller Theological Seminary campus. The 9800 square foot, three story Blinn House is California's only example of Maher's work. As a contemporary of Frank Lloyd Wright, both of their designs embodied a uniquely American architecture, the Prairie style. This early 1900's architectural philosophy discarded the ornate fussiness of the Beaux Arts style, employing more simple rectangular employing more simple rectangular lines combined with impressive arched entries, and bringing nature into the

anode. Two signature architectural themes recur throughout this building. The broken pediment, an artistically interrupted arch is repeated throughout the home. The front door, cut to this

shape and surrounded by the same pattern, makes the initial design statement; the oak staircase again traces the elegant pattern, as do the doorways, stained glass windows, pergola lanterns and more

and more. The wisteria (they choose the traditional The wisteria (they choose the traditional spelling) vine motif naturally and intentionally begins outside with vine covered pillars, then moves inside to intricate stained glass windows and light fixtures. The piece d'resistance, a magnificent gold glass tile, floor to ceiling mural wraps around the fireplace in the living room. Originally believed to be a Tiffany work, historians now believe the Chicago glass artist, Orlando Gianinni created this magnificent piece of permanent art. Interesting how of permanent art. Interesting how styles do come around again, glass tile

is once again in vogue, as seen in May's Showcase House at Descanso Gardens. The Blinn House foundation, which took over the support, preservation and loving, meticulous maintenance of this property in 2003, welcomes donations and volunteers in preserving this Pasadena legacy. In July, they will undertake a \$1 million capital campaign to upgrade the infrastructure, preserve and maintain the home. Designated in both a National Register of Historic Places and the California Register, their informational flyer eloquently states, "This architectural treasure cannot be replicated, and once gone, cannot be replicated, and once gone, cannot be replaced."



Mastering All: Nolan Shaheed

When he's not putting up record times on the track, he's playing the trumpet for some of the luminaries of modern music.

modern music.

Any way you look at it, Pasadena resident Nolan Shaheed has exceptional wind power.

"My running makes me a better trumpet player and my trumpet playing makes me a better runner," said Shadeed, who recently was named USA Track and Field Masters Athlete of the Year for 2007.

He will go to Orono, Maine, the first week of August to receive his award. It's his second such title. He received his first n 2001. For the past few years, Shaheed, who will turn 58 on July 18, has ranked among the top 50-and-older competitiors in the world at 800 meters, 1500 meters and a mile. He also takes part in numerous 5,000-meter and 10,000-meter races and trains six days a week—often running the 3-plus miles around the Rose Bowl. Bowl.

He is the current world record-holder for men over 50 in the 800 (1:56.65), the mile (4:26.75) and the 3000 (8:54.73).

"I'd rather run than play trumpet, but I can't make the same money," laughed Shaheed, a slender 5-foot-9, 122-pound man, who regularly steps into music studios to accompany Stevie Wonder and Electric Light Orchestra and whose work has been heard behind the vocals of the

accompany Stevie Wonder and Electric Light Orchestra and whose work has been heard behind the vocals of the late Marvin Gaye.

"The Pasadena Jazz Institute is one of my favorite places to play," he said. "I'm there often with my five-piece orchestra. The acoustics there are great." Shaheed practices the trumpet six or seven hours a day and runs three hours a day. "The running I do helps me hit the higher notes easier and helps me sustain notes longer," he pointed out. "I often wonder why more people who play a brass instrument don't run. It really builds up your lungs."

Shaheed, who briefly ran track at Muir High School, didn't get back into the sport until he was 27.

"I was heavily involved in my music, playing with Count Basie and traveling all over," he recalled.

Shaheed's boyhood musical idol was Louis Armstrong, generally considered the greatest trumpet player of all time. "I was all set to meet him years ago, but then I heard a report that he had just died," he said. "That was a real disappointment."

Shaheed's wife, Sharon, with whom he has three daughters, also has a combined musical and athletic

expertise. She runs a piano studio anu noius a oacacini taekwondo.

He is proud that he weighs now what he weighed in the start "Racides all the running, I watch what I eat," high school. "Besides all the running, I watch what I eat," he said. "I don't eat anything that's white. That usually means it's processed. I eat brown rice and the bread I eat is



not just because he's overcome the handicap of being blind, but he's never sold out never sold out and done trashy music. The only problem I have with him is that sometimes he'll get me out of bed at two o'clock in

the morning and tell me to come down to the studio!"

tell me to come down to the studio!" Shaheed's next competitive race will be at USC in early July. He intends to compete in several 400-meter races this year but has no interest in attempting the marathon distance of 26 miles, 385 yards.
"That's too much running," he laughed. "The longest I ever ran at one time was 18 miles and that was by accident.
"I was in Portland, Maine, with Diana Ross and I went out for a 10-mile run. But I got lost out on the reads and

out for a 10-mile run. But I got lost out on the roads and by the time I got back I'd run 18 miles!"
