SIERRA MADRE NEWS FIRE DEPARTMENT AND CHIEF GET **BOOST IN PAY**

City and Union reached an agreement for cost-of-living increases and incentives. By Kevin McGuire

City Council, at its' last meeting before | The Fire Chief's salary range is the lowest summer break, approved two resolutions adopting the Sierra Madre Professional Firefighters Association (SMPFA) Memorandums of Understanding (MOU) and approving the amending of the Classification Plan and Salary Matrix.

In a presentation on Tuesday, July 11, 2023, Assistant City Manager Miguel Hernandez discussed the results of several meetings with SMPFA, including a proposed cost-of-living increase, paramedic license incentives, and a request to remove language to include Fire Captains in the fiscal year 2024-25 salary adjustment which was previously negotiated. City Council adopted this through Resolution 23-53.

In addition, city staff was seeking ap proval to amend the Classification Plan and Salary Matrix to adjust Range 39 to be the same as Range 43 and add the creation of the part-time Emergency Services Coordinator and EMS Coordinator positions. City Council passed Resolution 23-54 to address these issues.

The cost-of-living increase will be a 20% increase in salary for all association members going into effect retroactively to June 4, 2023. Sworn personnel holding a position of Firefighter/Para-medic who currently maintain a valid paramedic license shall receive a 15% salary adjustment. Sworn personnel holding a position ranking higher than a firefighter/paramedic (Fire Engineer or Fire Captain) who currently maintain a valid paramedic license shall receive a 10% salary adjustment, according to the

presentation by Hernandez. Hernandez applauded these increases stating the city "closed the gap considerably" between other area Fire Department salaries in the area, such as San Marino (within 15%) and South Pasadena (within 5%). "It will bring us close to market and be competitive as well," Hernandez said.

This incentive is set to promote retention and provide greater benefit to having out-of-rank fire personnel maintain their paramedic license and implement a value to attract prospective applicants when vacancies occur. Hernandez stated that these incentives have already helped improve morale at the Fire Department and helped retain current personnel and obtain qualified applications for open positions. The proposed para-medic incentives will be retroactive to July 2, 2023.

Lastly, the city staff is recommending approving the change in the salary range for the Fire Chief position.

of the Executive Management positions. To stay within the market for similar Fire Chief positions, it is encouraged to move the salary range to match that of the Police Chief's salary range.

New Positions Filled

Assistant City Manager Hernandez announced that the following two part-time positions have been filled within the Fire Department.

• Émergency Services Coordinator

The Emergency Services Coordinator will be vital to the City and community, ensuring the City is better prepared to respond to natural, manufactured, and technological disasters. In this role, the new Emergency Services Coordinator will coordinate the plans and operational readiness of the various components of the emergency management system-fire, police, emergency medical services, public works, parks and recreation, volunteers, and other groups contributing to managing emergencies. • EMS Coordinator

The Emergency Medical Services (EMS) Coordinator will analyze, plan, design, budget, implement, and administer EMS programs and other department- and community-oriented programs. The coordinator researches and analyzes current and future medical and EMS issues and trends to ensure quality medical services; and represents Sierra Madre Fire Department (SMFD) at Regional, Statewide, and regulatory agency/committee meetings. EMS Coordinators accomplish overall goals through program management, provider and system evaluation, and quality assurance.

Hernandez also noted that interviews are underway to fill the open Assistant Fire Chief position, which has been vacant for some time.

Mayor Pro Tem Kelly Kriebs praised the hard work and effort made to complete this deal. "I really want to congratulate the city and the union for really jumping on this. The work done on both sides is really to be commended," she said.

Mayor Edward Garcia stated how well-deserved these incentives are for motivation and to keep an experienced staff in place. 'Public safety is a priority, and we are representatives of the public. And, job number one is to keep them safe," Garcia said.

The Council agreed that this is a good deal for the Fire Department but also voiced concern over the possibility of budget woes in the future. But that discussion is for another time, Garcia noted.

REMEMBRANCE **ROBERT HATFIELD**

On July 4, 2023, Robert Hatfield of Sierra Madre, California, passed away. He was 95 years old and passed away peacefully surrounded by his loving family. Rob-ert, known to many as Bob, was an icon in the community as the owner of Ar-nold's Hardware, the local hardware store, known today as Arnold's Frontier Hardware. He would always go the extra mile for any customer.

He was born in Electra, Texas on August 6, 1927. At the young age of 12 his first job was delivering newspapers on his bi-cycle. Before his 18th birthday he joined the Merchant Marines, which took him to many places around the world. As Helmsman, he navigated his ship through the Panama Canal.

After leaving the Merchant Marines he attended Trinity University in San Antonio, Texas, where he earned his Bachelor of Science degree in Chemistry with minors in Physics and Mathematics. He then joined the U.S. Air Force in January 1951. He was trained as a fighter pilot, flying F86 and F100 jets. His squadron was the first to test the performance of the F100, breaking the speed of sound while flying level. Oh, the stories he would tell! He was called to duty during the Korean War however his squadron received word, while en route, that the conflict was ceasing and they were able to return home.



In 1956 he met the love of his life, Jean Marie Arnold. After only 7 dates they were married on July 8, 1956 in Palos Verdes Estates. They spent their honeymoon driving to Bob's first assignment at Foster Air Force Base in Victoria, Texas, where he started his new job as a Technical Representative for North American Aviation. From there they moved to Eglin Air Force Base in Fort Walton Beach, Florida, where their first child, Susan, was born. A year later he was transferred to the headquarters of North American and they lived in Manhattan Beach for 2 years, at which time their son, Bobby, was born.

A year later, Jean's father, Mr. Arnold, invited his son, Perry Arnold, and Bob to become partners in Arnold's Hardware, at which time they moved to Sierra Madre, where their daughter, Jenny, was born. He eventually took over the store in Sierra Madre and was there until he retired in 2003.

He loved serving the community and was a President and past member of the Sierra Madre Kiwanis Club.

Bob started studying the Bible with Jehovah's Witnesses in 1973 and thereafter he enjoyed helping others learn the Bible truths. He loved visiting patients and their families, giving comfort and encouragement from the scriptures. For years he went to Arcadia Methodist Hospital on a weekly basis, where even the hospital staff looked forward to his welcoming smile and kindness.

He is survived by his loving wife, Jean Hatfield, his children, Robert (Bobby), Susan, Virginia (Jenny), their spouses, Diane, Mitch, and Todd, his granddaughter Breanna, and her husband Mitch, grandson Nick, his wife Jennifer, and their son Mason. He is preceded in death by his parents and five older siblings.

HUG VS. HARM: SIERRA **MADREANS SPLIT OVER** HOW TO HANDLE BLACK **BEAR BOOM**

Daniela Anino has generally been happy with her cozy home at the border of Sierra Madre, a tiny sub-urb in the lush foothills of the San Gabriel Mountains. But lately, one of her neighbors has been exhibiting some boundary issues.

First, he started stopping by uninvited for dinner. Then she'd find him hanging around in her drive-way at odd hours. Most recently, he's been breaking into her backyard to swim in her pool without permission.

He's entitled, pushy, and also weighs about 400 pounds and sports a thick coat of fur — because he is a black bear.

"This guy, I see him every day now," says Anino. "The younger bears come more during the day, they're more curious, they're not so respectful of the rules." Over the five years she's lived here, Anino says she's seen more and more bears wandering the neighborhood, and their behaviors have been getting bolder. Human encounters with black bears are booming all over LA's foothill communities — and that's left state and local officials at a loss over how to handle the ursine explosion.

"You have those that want you to harm the bear. And then you have those community members that want you to hug a bear. That's the reality of it," says Sierra Madre Police Chief Gustavo Barrientos.

In 2022 alone, police in Sierra Madre say they received 130 calls about bears — up from just over 100 in 2020. And last year, 17 of those incidents involved bears breaking into cars, homes, or swimming pools. 'We've tripled - almost 300% - of incidents where the bear enters a residence or causes property dam age," says Barrientos.

But while cops will respond to these calls, there's really not much they can do. Unless the animal is acting aggressive — which black bears almost never do - police policy is mainly to warn other people a bear is around, and to avoid making it angry.

"I think our citizens are under the impression that we go and, number one, we're going to shoot a bear, number two, start using some sort of force to move it northward. We don't do that. I think there's more harm with doing it than good," says Barrientos.

Some locals, like Anino, are fine with this live-andlet-live policy. She says the bears haven't caused her any real problems aside from sometimes dragging trash into her yard: "At least in my experience, I've been able to coexist with them peacefully.

In her eyes, bears have as much right to be here as people. And with so many cars around, she's more worried about the animals' health than her own. She just keeps her kids far away, and her garbage bins locked.

But other Sierra Madre residents don't feel so warm and fuzzy about the ani-mals. Cynthia Compton keeps a stun gun on hand to scare the bears away cause she's tired of them repeatedly raiding her bird feeder and trash bins. She says she fears for her safety. "I don't like it. It's nerve-wracking. I've seen him right there by my living room window. And I'm pounding on the window: 'Go bear, go, get out of here,' and pull out the stun gun," says Compton. She says officials need to be doing more - if she had it her way, she would have all the bears shipped away. "I would like to see them be taken back to Yosemite where they came from. They don't belong here. This is not their native territory, they weren't here be-fore humans," she says. "They're getting too comfortable around people and around people's houses and coming into people's houses." Compton is right that the black bears now roaming the San Gabriel foothills are not native to the area. In the 1930s, bears were a big attraction in Yosemi-te National Park, where rangers created special "bear pits" filled with trash to attract them for spectators entertainment. Unsurprisingly, those bears acquired a taste for human food. Once they start-ed breaking into coolers and cabins, they transformed from a novelty to a nui-sance.

a full day's meal just by visiting all the bird feeders in the neighborhood, or all the garbage cans in the neighborhood," says Rebecca Barboza, a biologist for the Department of Fish and Wildlife.

As LA's foothill communities have crept closer to the mountains, climate change-related issues like fire and drought have made the forest less hospita-ble for bears, pushing more of them to make the commute to LA.

And that's paid off in terms of population growth. The animals that are living in these urban areas are doing so well that they're able to reproduce more, and those offspring are able to survive to adulthood," says Barboza. "So we've got an unnaturally dense population, we believe, within the urban zone."

In Sierra Madre, officials say they've tried everything from banning the feeding of wildlife to implementing a program to distribute bear-proof trash cans to quell the problem — but the creatures just keep coming.

So, they're asking for backup from the state. In April, the Sierra Madre City Council passed a resolution to declare bears a public safety threat in the city. Less a policy shift and more a plea for help, it urged the state Department of Fish and Wildlife to beef up its bear-prevention efforts in the region.

Officials say the state helped create this problem to begin with — and they have a lot more resources to deal with it, too.

"We're very small, we're 11,000 people, we don't even have a traffic light in town. So you can imagine we don't have professionals. We don't have biolo-gists," says James Carlson, a management analyst for Sierra Madre.

But Barboza from Fish and Wildlife says this isn't just a Sierra Madre problem — the number of black bears has tripled statewide over the past four decades, which makes figuring out a long-term solution tough.

"If we try relocation, if we try captivity, if we try euthanasia, there's still so many bears in the area. If one leaves, there's going to be another one that's going to start doing the same behaviors," she says.

These descendents still haven't lost their taste for human food — which is part of why they're showing up more often in these urban areas.

Last year, the Department of Fish and Wildlife revamped its bear policy and created a whole team of human-wildlife conflict specialists who deal with bears on a case-by-case basis. Depending on the animals' behavior, the de-partment might relocate or even put down an animal. But Barboza says at the end of the day, public education is still the best tactic they've got. "If people are still leaving doors open, if they're

still leaving garbage available, if they're still leaving food out for the bears, then nothing is really going to work."

She is, however, feeling hopeful about a new "trap, tag, haze" program the department is rolling out, which they have piloted in Lake Tahoe to mixed community response.

Under the program, state officials will capture the bears one by one, and tag them so they can track their movement. They say this will help them learn more about bear behavior, and give them a better sense of how many there actually are.

The final step is to haze the creatures with loud noises and beanbag projec-tiles, which they hope will drive the bears back into the woods for good. But, it remains to be seen how effective that will be - in Lake Tahoe, it's worked on some bears, while others have headed right back to the trash buffet.

So for now, Anino will probably continue getting visits from her furry neighbor. She doesn't mind – in fact, she says she'd miss the creatures if they were gone: "They are really cute. And when they come with the babies, their cubs, boy is it a beautiful sight.

PPD Officers Disciplined for Drinking On-duty

Pasadena Police Chief Eugene Harris confirmed Wednesday the discipline of multiple officers after video surfaced Monday showing them drinking alcohol on-duty at a party.

According to Eugene Harris in late March, the Police Department received a complaint from former Pasadena Police Officer Omar Elhosseiny about on-duty PPD Officers consuming alcohol at a birthday party he hosted at his home back in January. The event was for his wife, a current PPD officer, and a teammate to the officers present.

An extensive internal affairs investigation was initiated, culminating in June. The outcome confirmed five on-duty personnel including a supervisor were present, three of which, the investigation confirmed, took a drink of alcohol in violation of Department Policy. Each has subsequently received discipline imposed by Harris.

"The policies are very clear as are the expectations of professional conduct, "The Harris said, "The imposition of discipline, in this case, is indicative of expected conduct and sound Department culture moving forward." He continued, "I'm very disappointed in the officers' conduct and have made expectations clear, as a matter of course."

Recent Happenings

The San Marino Fire Department participated in multiple training exercises during the week of July 17. On Monday, Wednesday, and Friday, Engine 91 participated in a multicompany exercise with the Sierra Madre Fire Department. Engine 91 reviewed the City of Sierra Madre's pre-planned deployment zones that are designated as high risk for wildfire and toured the City's wildland-urban interface. The tour included the City's canyon area as well as new development projects located in the City's hillsides. Familiarization with these areas will enable San Marino Firefighters to effectively respond in the event of a wildfire requiring mutual aid response.

Engine 91 and RA 91 also participated in a multi-company Rapid Intervention Crew (RIC)/Fire Ground Survival drill hosted by the Pasadena Fire Department. The drill was also attended by resources from the South Pasadena, Arcadia, and Sierra Madre Fire Departments. The scenario was built off of Project Mayday statistics surrounding the fact that the majority of fireground fatalities occur in the first 7-10 minutes of an incident, frequently involve collapse or rapid-fire progression, and frequently involve more than one firefighter requiring assistance.

On Friday, July 21 the San Marino Fire Department conducted a night drill at the San Gabriel Valley Medical Center's parking structure. Firefighters who participated in the drill learned multiple methods to get a hose line in operation in a multi-level structure.

Annual Sidewalk Replacement Program to Begin

The City will begin the construction phase of the Annual Sidewalk Replacement Program next week. Each year, this program replaces approximately 1 mile of sidewalk at various locations throughout the City. The work includes replacement of sidewalk, driveway approaches, curb ramps, and curb and gutter. Residents on impacted streets will be receiving notices from the City's hired contractor, CJ Concrete, with additional details about the project timeline, what residents can expect during the project, and what the project's impact to the neighborhood will be. The City appreciates resident cooperation, as the sidewalk program helps improve the City's infrastructure and resident safety.

NASA Awards \$14 Million to Universities for **Supportive STEM Efforts**

Part of that effort includes the MUREP Curriculum Awards, which are being managed by NASA's Jet Propulsion Laboratory.

NASA is investing more than \$14 million in 19 U.S. colleges and universities to grow their STEM capacity to participate in critical spaceflight research and prepare a new generation of diverse students for careers in the nation's science, technology, engineering, and math workforce.

"These awards help NASA reach students and institutions that traditionally have had fewer opportunities in cuttingedge spaceflight research," said Shahra Lambert, NASA's senior advisor for engagement. "We want the Artemis Generation to feel excited and prepared to join us in tackling the scientific and technological challenges of space exploration."

The new MUREP (Minority University Research and Education Project) Curriculum Award was established this year to help Minority-Serving Institutions strengthen their STEM academic offerings.



Yes, the Mountain Views News Family is PhotoBombing (or Word Bombing) Peter's Column to wish him a very, very Happy Birthday.

When I first stepped foot in Pasadena in the early 1970's there were just a handful of restaurants, and fewer steakhouses. If memory serves, there was the Western, Steer and Stein, Monty's, and of course Sizzler on Arroyo Parkway (yes, some considered that a

steakhouse). Fast forward to 2021 and my, how times have changed! I sometimes think that Pasadena is the new Mecca for the beloved Cow!! There's not enough space in this article to name all the steakhouses, but some are better than others. I often wonder, as I am sure you do, is the meat coming from the same source, what is the best 2%, and if it's so special how come it's everyone's claim to fame? Grass Fed? Corn fed? Bone in? Boneless? For me, the way to go is dry aged. One of the best steaks I ever made at home was from a supermarket 50% off section.

So, what is the best steak house in Pasadena? Well, it might not be a "traditional" steakhouse that serves clam chowder or gives you a bread basket! Alexander's Steakhouse makes its home at the old McCormick and Schmicks location on North Los Robles – it has the same floor plan (picture a 60's James Bond Movie Geisha set with a Nuevo Art deco feel). Getting to the meat of the matter, a steak can run as much three digits, but before you think I've lost my touch with the everyday working class, I've said time and time again if you enjoy a meal it's worth it. Alexander's is a special occasion restaurant, but I am not just talking anniversaries or birthdays; I am talking about life. You deserve to give it a try.

The menu is divided into six sections starting with "For the table" (appetizers) and ending with Steaks - quite straightforward, I would say. I posted a few pictures on Facebook and a few comments there suggested Japanese Fusion. I've never been to Japan, but if that helps describe the menu let's use that term. Daughter Lauren and I loved the restaurant from start to finish. We started off with Hamachi Shots and dry aged tataki (explaining the ingredients and the menu descriptions would just be confusing, so just enjoy the ride like we did). Like any great restaurant the menu is seasonal (my suggestion is to accept the bread service and put it on some bread, it's quite good). I think the hit of the night was the little gem salad with romaine, let's call it a close cousin of the Caesar with some kick to it. I am coming back just for this salad; it was that good. For you seafood lovers there are a few items again seasonal. However, we are land lovers and that what makes Alexander's stand high above the crowd. I have seen Wagyu steaks on menus at LA restaurants that are US-raised, but at Alexander's they have the real deal. All Wagyu is imported from Japan except for the Imperial Wagyu; Japanese Wagyu is graded A5 - ask your server for the definition. Whether it's chicken, pork, or steak I think the bone gives you the most tenderness, and the 18 oz. T-bone steak is a winner. Grilled in their open kitchen, it was so good I see-sawed about whether to finish it or take it home. My decision came easily since we also tried a variety of pre-main-course suggestions. The sides are traditional in name only; we had the blue lake green beans. The restaurant has a full bar with extensive wine list, and is only open for dinner. If you are a foodie, steak lover, or just want a special night out, I gave it two thumbs up.

What Else You need to Know

I actually started this review a few months ago just before our second shut down, so some items might have changed.



CHRISTOPHER Nyerges [www.SchoolofSelf-Reliance.com] **Review of "TWILIGHT OF AMERICAN CULTURE"**

> Written in 2000, Morris 1. Berman's book is an insightful look at American culture, and perhaps where we are going as a culture. His title word, "twilight,"

by Morris Berman

suggests we're on the decline. Berman takes great pains to define everything along the way so the reader knows precisely what he's thinking. He says that this is not some sort of academic exercise, rather, this is an effort to get at the most critical questions about who we are as Americans today, and where we are going as a culture.

Do you think we're in decline?

He quotes Neil Postman, author of "Amusing Ourselves to Death," in his introduction: "When a population becomes distracted by trivia, when cultural life is redefined as a per-petual round of entertainments, when serious public conversation becomes a form of baby-talk, when, in short, a people become an audience and their public business a vaudeville act, then a nation finds itself at risk; culture-death is a clear possibility."

Does that sound like us?

Berman covers a lot of territory in his book, and often makes references to the fall of the Roman Empire. He quotes many other authors who look at what's happening in the U.S., just so that we can all agree on the facts and not kid ourselves that things are really OK. Some examples of this decline are the crumbling school system and widespread func-tional illiteracy, violent crime, gross economic inequity, apathy, cynicism, and what he terms "spiritual death."

Either coincidentally or by design, Berman observes that the U.S. is evolving into a corporate oligarchy that merely wears the trappings of a democracy. (I wonder what Berman has to say about a candidate for president who brags about wanting to move the Presidency closer to a dictator, with his followers greatly approving?)

So Berman explains a little about the Roman Empire, and every state that has ever existed. He tells us that declines is inevitable and comes to each and every civilization, and it is only our arrogance to think that we can avoid this decline. Berman quotes Joseph Tainter, from his book "The Collapse of Complex Societies," pointing out that the combination of hierarchy, specialization, and bureaucracy takes more and more resources, and the trend is always towards the more complex, along with increasing class differences, greater costs, and more technology. Collapse is inevitable, according to Berman and the many authors he cites.

As societies weaken and decline, according not know exactly how it will play out. Still, to Berman, "The strong savage the weak, and there is no longer any higher goal than survival. Literacy may be lost entirely, or decline so dramatically that a dark age is inevitable.' He points out that when resources got scarce in past smaller societies, they simply moved on. But today everyone wants to stay where they are. He explains that the solution – short term at least, is to "go vertical, that is generate another level of hierarchal control to solver your problems - a process that never ends. The whole thing is cumula-tive. Taxes rarely go down; information processing gets denser. Standing armies get larger, not smaller, and bureaucracies grow rather than shrink. Elites want - and get - more and more of the pie..."

Accelerating social and economic inequality.

2. Declining marginal returns with regard to investing in organizational solutions to social-economic problems;

3. Rapidly dropping levels of literacy, critical understanding, and general intellectual awareness;

4. Spiritual death – that is, Spengler's classicism: the emptying out of cultural content and the freezing (or repackaging) of it in formulas – kitsch, in short.

Berman devotes many pages to backing up these factors with specific details, such as the great gap of income between CEOs and ordinary workers, how the upper top 1% income earners own more and more, problems with Social Security staying solvent, and many more examples.

He spends considerable time demonstrating these four aspects of cultural decline, so that his thesis is not simply a matter of opinion.

There are many parallels to the Roman Empire, as well, so the entire book makes a lively discussion about where we are today as a country. Berman is somewhat of an optimist, and you realize that a culture in decline doesn't necessary speed downhill, but that there can be many twists and turns along the way, what Berman calls transformations.

In the end, he tells us that cultural decline has happened to all cultures throughout history and that there is nothing we can do to stop that decline. But he does provide positive ideas for things that each of us can do, daily, in our own lives.

Berman suggests that in our daily choices we eschew such TV shows that are silly entertainment, and rather choose to view quality education instead. He suggests that we get more involved in things that truly make a difference, such as small town radio, the arts, local periodicals. In truth, Berman is short on the details, but does provide many examples of those people who he feels are doing the right thing as the culture declines.

His main thesis is that people who persisted with quality actions in bad times set the stage for a future renaissance, even if that renaissance is hundreds of years in the future. He cites the Irish monasteries that persevered literacy after the fall of the Roman Empire, and set the stage for the renaissance in a few hundred years. He calls such people New Mo-nastic Individuals, the root of the solution to a country in decline.

Berman is not optimistic that the decline can be reversed, but he is very sure that we do

HOW DOES MEDICARE COVER PREVENTATIVE **HEALTH SERVICES**

Dear Savvy Senior:

How does Medicare cover preventive health screen-ings? I'm due to get a physical and a colonoscopy this year, but I want to find out what I'll have to pay for before I go in. Just Turned 65

Dear Just Turned: You'll be happy to know that Medicare covers a wide array of preventive and screening services to help you stay healthy, but not all services are com-pletely covered. Here's what you should know.

Free Preventive Benefits

Most of Medicare's preventive services are avail-able to all beneficiaries (through Part B) completely free with no copays or deductibles, as long as you meet basic eligibility standards. Mammograms; colonoscopies; shots against flu, pneumo-nia, CO-VID-19 and hepatitis B; screenings for diabetes, depression, osteoporosis, HIV, various cancers and cardiovascular disease; and counseling to combat obe-sity, alcohol abuse, and smoking are just some of Medicare's lengthy list of cov-ered services. But to get these services for free, you need to go to a doctor who accepts Medicare "on assignment," which means he or she has agreed to accept the Medicare approved rate as full payment.

Also, the tests are free only if they're used at specified intervals. For example, cardiovascular screening blood tests once every 5 years; or colonoscopy, once every 10 years, or every two years if you're at high risk.

Medicare also offers a free "Welcome to Medicare" exam with your doctor in your first year, along with annual "Wellness" visits thereafter. But don't con-fuse these with full physical examinations. These are prevention-focused visits that provide only an overview of your health and medical risk factors and serve as a baseline for future care.

Cost Sharing Services

There are, however, a few Medicare preventive services that do require some out-of-pocket cost sharing. With these tests, you'll have to pay 20 percent of the cost of the service after you've met your \$226 Part B yearly deductible. The services that fall under this category include glaucoma tests, diabetes



self-management trainings, barium enemas to detect colon cancer, and digital rectal exams to detect prostate cancer.

For a complete list of services along with their eligibility requirements, vis-it Medicare.gov/coverage/ preventive-screening-services.

If you're enrolled in a Medicare Advantage (Part C) plan, your plan is also re-quired to cover the same preventive services as original Medicare as long as you see in-network providers.

Hidden Costs

You also need to know that while most of the previously listed Medicare services are free, you can be charged for certain diagnostic services or additional tests or procedures related to the preventive service. For example, if your doctor finds and removes a polyp during your preventive care colonoscopy screening, you will pay 15 percent of the doctor's service fee. Or, if during your annual wellness visit, your doctor needs to investigate or treat a new or existing problem, you will probably be charged here too.

You may also have to pay a facility fee depending on where you receive the ser-vice. Certain hospitals, for example, will often charge separate facilities fees when you are receiving a preventive service. And you can also be charged for a doctor's visit if you meet with a physician before or after the service.

To eliminate billing surprises, talk to your doctor before any preventive service procedure to find out if you may be subject to a charge and what it would be.

Unless your business generates significant revenue-and will continue to do so upon your deaththat income might not be enough to support the ongoing operation and financially provide for your family. 

A/C HASN'T ONLY MADE LIFE COOLER By Tom Purcell

As a heat wave hits America from coast to coast, it's hot outside but cool inside, thanks to the triumph of air conditioning. For most of human history, there

was little people could do to avoid heat.

During the day, it drove people outside of their homes to enjoy the shade of a tree or to take a refreshing dip in a lake or river.

At night, folks in cities slept outside on their porches, roofs and even fire escapes.

When I was a kid in the suburbs of Pittsburgh, few homes had air condi-tioning.

Our windows were always open with several fans bringing in the cool night air, as we drifted off to sleep comforted by their wobbling sound.

Air conditioning changed everything.

Homes used to have big windows, high ceilings, cross ventilation and large hallways to dissipate heat. This is no longer necessary, and most homes are sealed shut all summer long.

Commercial buildings used to have windows that opened but that isn't necessary, either.

Today's glass-plated buildings are designed to keep the light and air

out, so that we are oblivious to whatever season it may be. AC dramatically changed our

politics. Before air conditioning, Washington D.C. was so hot, the halls of Congress were empty from mid-June to September.

Now they can spend lots more time working on — as former New York Times columnist Russell Baker put it — "... the promulgation of more laws, the depredations of lobbyists, the hatching of new schemes for federal expansion and, of course, the cost of maintaining a government running at full blast."

Without A/C, heat was the great equalizer. The rich suffered just as much as the poor. All of that changed a little over 100

All of that changed a little over 100 years ago when Willis Haviland

Carri-er invented air conditioning. Department stores and movie houses were among the first to install A/C. Regrettably, the federal government soon followed.

It wasn't until the 1920s that A/C began making its way into residential homes.

Today, 90% of American homes have air conditioning, which is why tens of millions of young and old folks have been able to safely migrate to steamy places like Florida and the baking deserts of the Southwest.

A/C can literally be a life saver. Europe's unbearable 2003 heat wave killed more than 30,000 people. That's unconscionable at a time when a window A/C unit costs a hundred bucks at any bigbox store.

The good news, according to Scientific American, is that by "2050, re-searchers expect the number of room air conditioners on Earth to quad-ruple to 4.5 billion, becoming at least as ubiquitous as cell phones are to-day."

Here's even better news: Technology innovation is making A/C units more efficient, less costly and less impactful on the environment.

Consider: A/C requires hydrofluorocarbons (HFCs) to cool the air. HFC refrigerants are very effective at cooling the air inside our homes, but they are potent greenhouse gases that, as they leak from aging units, are bad for the environment. An intense competition is under way among A/C manufacturers to replace HFCs with eco-friendly refrigerants and advanced filtration systems.

To further aid this effort, a global coalition of partners has joined hands to launch the Global Cooling Prize, a first-of-its-kind challenge to spur inno-vation in the A/C industry.

Meanwhile, A/C continues to be one of the greatest inventions to better the lives of millions — maybe the coolest American invention ever.

The first Republican presidential primary debate is less than a month away and the GOP is hell-bent on making the same mistake it made in 2015.

Today, most of those 2016 dreamers have disappeared from the scene, become answers to trivia questions or appear on Fox News every 20 minutes doing commercials for pain relief or sleep aids.

Those over-crowded Republican debates in 2015 were a waste of time and energy that did the party, the candidates and the country no good. Plus, except for the entertaining Trump Factor, like most debates they were boring and unenlightening.

Apparently, the GOP's thinking about primary debates this year was, "Hey, let's make the same mistake again."

So far, seven of the 11 Republican candidates who've announced for the 2024 presidency have qualified for the Aug. 23 debate in Milwaukee.


They are North Dakota Gov. Doug Burgum, former New Jersey Gov. Chris Christie, Florida Gov. Ron DeSantis, former South Carolina Gov. Nikki Haley, entrepreneur Vivek Ramaswamy, South Carolina Sen. Tim Scott and some rude former president named Donald Trump. Former Arkansas Gov. Asa Hutchinson and former

Former Arkansas Gov. Asa Hutchinson and former Vice President Mike Pence are still trying to meet all the polling and fundraising requirements they need to be included.

Ditto for former Texas congressman Will Herd and Miami Mayor Francis Suarez. Did I actually say the mayor of Miami? Really?

Other than Mayor Suarez, the Republican slate for 2024 is pretty impres-sive.

It's a deep, diverse and accomplished lineup of current and former public servants who should be

In a perfect world, they also would be conducted by unbiased, skeptical journalists and would allow plenty of time for candidates to answer im-portant policy questions and challenge each other.

Unfortunately, we live in the real world. Which is why we're going to con-tinue to get overcrowded debates, poorly constructed debates or no de-bates at all from the major parties and the major media.

The GOP's upcoming string of presidential primary debates will be anoth-er waste of time and energy. They will just be a series of TV tryouts to see who has the brains and guts to be Trump's vice president pick – which makes Pence's candidacy make even less sense.

I respect Pence, but he's never going to be nominated for president by a MAGA Republican Party. He'd have 75 million votes against him on Elec-tion Day. And anyway, he shouldn't be in the primary debates because he's already been Trump's VP.

We should not get hurt trying to "get in shape." In organized sports there should be a trainer getting the kids ready physically and mentally. If your kids are not athletes, it makes no difference. Studies show that we perform better at anything if we are physically fit.

Might be a message to all of us. Adults, kids, grandparents, aunties and uncles. If we don't care about ourselves, no one else will. And we can be an example of how to prepare for and continue on with our lives. Keep ourselves tuned up, maintained, repaired and looking and feeling good. And for all you younger people and those taking care of youngsters... I am still coaching you up. Just think about this... we are putting some steel in the foundation.

Other California statutes and legal authority may affect your rights as a creditor. You may want to consult with an attorney knowledgeable in California law.

YOU MAY EXAMINE the file kept by the court. If you are a person interested in the estate, you may file with the court a Request for Special Notice (form DE-154) of the filing of an inventory and appraisal of estate assets or of any petition or ac-count as provided in Probate Code section 1250.
