HOMETOWN HERO JOHN

SHEAR PASSES AWAY

Beloved Sierra Madrean John Shear passed away on December 12th of natural causes. He was 102. His family posted news of his death on social media, "*He had that smile and happiness 'til the end*,"..... "John had a remarkable life with love for family and dedication to work that made such a positive impact on so many. He will forever be in our hearts."



John will best be remembered for his heroic act at age 90, when he risked his own life to save the life of a 5 year old girl at Santa Anita Race Track. He threw himself in front of a horse in order to save the little girl's and as a result he was badly injured. His bravery was praised around the world and earned him numerous honors.

A former jockey, he was a gaurd in the paddock at Santa Anita and at one time Hollywood Park since 1962. Afteer recovering from his injuries, he went back to the work that he loved so well until his retirement. At Santa Anita, they named a race after him on his 100th birthday and also honored him by renaming the Santana Mile to the John Shear Mile.

In Sierra Madre he was the city's HomeTown Hero. For his 100th birthday in 2021 family, friends and well wishers gave him a 'drive by birthday party in front of his home. He stood outside waving and smiling to all who passed by.

John is survived by his wife Diane and son Michael. As posted by the family, services will be private.

The City Council met before a modest crowd on Tuesday, December 12, for the last meeting of 2023. As part of the final agenda item for the night, Mayor Edward Garcia presented Mayor Pro Tem Kelly Kriebs with a "Recognition of Service" plaque featuring a small gavel. "I appreciate you supporting my role over the past year," Mayor Garcia said. "The City of Sierra Madre is immensely fortunate to have you sitting on this Council. I feel we made a good team this year."

Garcia and Kriebs received Certificates of Recognition honoring their "outstanding and dedicated service to the City of Sierra Madre" on behalf of Assemblymember Chris Holden of the 41st California Assembly District. REMEMBRANCE: AMOS WASHINGTON BROUGHTON, JR.,

Amos Washington Broughton, Jr., age 96, passed peace-fully into the presence of his Lord and Savior, Jesus Christ, on Wednesday, November 22, 2023.

Amos was born in Medford, MA on February 11, 1927; however, he was raised in the province of Nova Scotia, Canada. Hav-ing dual citizenship, he enlisted in the U.S. Navy during WWII three days before his 18th birthday, serving as a Radioman Third Class and was honorably discharged in August 1946.

He enrolled in Northeastern University in Boston, MA, and graduated with a degree in Chemical Engineering.

During his college years, he met

his wife, Patricia Greene, from Melrose, MA, and they married on December 30, 1949. They lived in several cities in Massachusetts, New Jersey, and New Hampshire over the next 12 years and while in New Jersey purchased property and built their 2-story home.

In 1961, with their then five children, they made a month-long camping road trek across southern Canada and down the US west coast to Southern California, settling in Temple City, CA where they had their sixth child.

In his late 30's, Amos and Patricia both made the life-changing decision to follow and live for Jesus, a commitment which ultimately led to all 6 of their children choosing the same life path.

In 1971 Amos started his own company, Action Engineering, Inc. representing various firms and their product lines in the industrial equipment field.

He was very active in volunteer Christian missions work, using his professional and building skills through many visits at hospitals and orphanages in Mexico and África installing clean water systems, at a Christian retreat center in France repairing dormitories and buildings, as well as other projects in the US.

He was found in weekly attendance at and participation in the ministries of both San Gabriel Union Church, San Gabriel, while raising his family and later at Sierra Madre Congregational Church in Sierra Madre. In his last few mobile years, he could be found on Sundays at Victory In Jesus Church in Temple City.

He was dedicated to leading Bible studies teaching others about Jesus' love, especially to those who were



often forgotten - in nursing homes, orphanages, and juvenile jail facilities.

When serving at the LA Central Juvenile Jail he found that their 42 hardwood chapel pews were neglected and completely carved with graffiti. Loading them up in his little truck two at a time over a couple of years, he completely restored them, sanding out the graffiti carvings and staining them to their original beauty.

He was a licensed small plane pilot, renting planes from the El Monte Airport to travel to other airport locations in Southern California, often just to enjoy breakfast at their restaurants.

He was an inventor and secured several US patents focused on industrial facility problems including waste-water treatment methods.

He took classes to learn how to repair and upholster furniture and for many years could be found on his large back porch with his used professional sewing machine, transforming a discarded upholstered chair or couch into something beautiful and comfortable.

After the passing of his wife, Patricia, in 2009, he continued to live in his Temple City home until 2019 when health issues required him to move into assisted living.

Amos lived his life with drive and gusto, a deep love of family, and dedication to living out his faith daily. He is survived by four of his five daughters, one son, 10 grandchildren, and 13 great-grandchildren. We, his family, are eternally grateful to God to have been loved by Amos and influenced by his life.

This will be the first time Mayor Kriebs and Mayor Pro Tem Parkhurst will serve in these roles. Edward Garcia, Gene Goss, and Kristine Lowe will return as Council Members.

Though the appointments made by the City Council are mainly ceremonial as part of the traditional annual rotation, the roles are essential to this small town. For example, these appointments will immediately affect the City's liaison appointment to the Los Angeles County Sanitation District and County Board of Supervisors.

The primary voting delegate for these agencies is the Mayor, with the Mayor Pro Tem serving as the alternate. And, of course, the Mayor signs contracts, resolutions, and ordinances after they receive the necessary approval of the City Council. If the Mayor is unavailable, these tasks become the responsibility of the Mayor Pro Tem.

The term for the two positions runs from December 12, 2023, until December 10, 2024.

Officers File Racial Claims against the Pasadena Police Dept.

Speaking though an attorney, three Pasadena police officers announced Wednesday that they are all in the process of filing lawsuits against the city for racial discrimination and harassment among other allegations such as retaliation for speaking up.

All three are still active in the department said attorney Brad Gage during a press conference in front of the Pasadena Police Department.


All three are African American.

One of the officers, Taisyn Crutchfield, alleges that she was put in danger after officers did not respond to her call for backup when she responded to a call to a

man with a gun. Both officers, Jarvis Shelby and Milton White are claiming there were harassed and assaulted by a

commanding officer. Gage said, "If Black police officers are threatened or physically assaulted what does that mean for members of the community."

City officials also released a statement to the media, "There are at least two sides to every story, and complainants and their lawyers are free to take their side to the media. The City of Pasadena cannot respond in a public debate regarding the claims, as they involve personnel matters, which are confidential under California law. With that said, personnel complaints against any Pasadena police officers are investigated thoroughly and fairly, and all personnel throughout our ranks are always held accountable for their actions."

PWP rebates for new plug-in EVs will end December 31.

New electric vehicle ("EV") chargin stations are now

PWP rebates for new plug-in EVs will end December 31. This change is part of a planned program update consistent with regional utilities and state programs. Please note that the \$250 rebate for qualifying used EVs will continue. Customers can receive an additional \$250 bonus rebate if they purchase a used EV from a Pasadena auto dealer. An additional \$1,000 is available for customers currently participating in PWP's incomequalifying programs. Eligible customers can also take advantage of upcoming changes to the Federal Tax Credit. Starting January 2024, buyers can transfer the tax credit to the car dealer at the point of sale, which will reduce the vehicle's up-front purchase price. Residential electric customers are also eligible for a \$600 rebate when they install a qualifying "Wi-Fi enabled" or "Internet Connected" EV charger at their home. Residential electric customers are eligible for a \$200 rebate when they install a standard (Non-Wi-Fi/ Non-Connected) EV Internet charger. Charger incentives are also available to commercial customers. If an electric panel upgrade is needed to add an EV charger in your home, PWP can help. A \$1,000 rebate is available for a permitted panel upgrade if it coincides with an EV charger install with associated wiring circuit. Phasing out new EV rebates helps PWP expand opportunities to address barriers to EVs for low-income residents, as well as additional benefits for citywide charging infrastructure. It features 12 Tesla V3 Superchargers, and eight PWP-branded Tritium 150-kW DC Fast-Chargers. The depot provides destination charging for consumers, and additional options for residents and visitors seeking to extend electric range.

PWP continues to expand transportation electrification infrastructure, and currently offers over 100 publicly accessible EV charging stations throughout the City. Robinson Park is under construction to add five DC Fast Chargers, and 20 Level 2 chargers. Victory Park is also under construction to add four DC Fast Chargers, and 21 Level 2 chargers. Both projects are expected to be complete and operational in early 2024. Four new Level 2 chargers are currently operational at Playhouse Village Park with an expansion project of 20 additional Level 2 chargers currently in the design process. A 37-charger expansion project at the Del Mar Station Garage is also operational.

Fire & Police Departments **Issue Parade Safety Tips**



As the 135th Rose Parade presented by Honda approaches on Monday, Jan. 1, 2024, Pasadena's fire and police departments are issuing the following safety tips for the thousands of overnight campers who will line the route on Sunday, Dec. 31, 2023. The Rose Parade route will be a safer place if everyone follows the rules and regulations listed below. What You Can Do:

Overnight camping is permitted only on the night of Sunday, December 31, 2023.

A position on the sidewalk may be maintained along the parade route beginning at noon, Dec. 31, 2023. All persons and property, such as blankets, chairs and personal items, must remain on the curb until 11 p.m. At that time, spectators may move out to the blue "Honor Line" but not past it.

Small, professionally-manufactured barbecues elevated at least 1 foot off the ground are allowed on the parade route as long as they are 25 feet from buildings and other combustibles. A fire extinguisher must be readily available. Minors under the age of 18 may be on the parade route from 10 p.m. to 5 a.m. only if they are supervised by an adult.

Dress for cold weather! Children and seniors may need extra layers of clothing to avoid hypothermia. Remember hats and gloves.

Drink healthy fluids and consume nourishing meals to avoid dehydration.

"If You See Something, Say Something"." Report suspicious activities and packages to emergency authorities along the parade route.

In case of emergency, call 9-1-1 and know the cross streets from where you are calling. For non-emergencies, call (626) 744-4241.

What You Can't Do:

Appearance in the parade is prohibited for any entries/ marchers who have not been approved by the Pasadena Tournament of Roses[®]. Stay off the street and do not pass the blue "Honor Line."

Tents, sofas, and boxes of any type that can be used as stools or seats are prohibited along the route.

Unoccupied chairs are not allowed and will be removed from the parade route.

Bonfires are strictly prohibited and considered "illegal burns." ALL fireworks are prohibited except as part of official scheduled events.

No items may be sold along the parade route without a City permit.

Selling space along the parade route, other than grandstand seating, is illegal.

It is illegal to buy, sell or give away horns on the parade route. No public areas—sidewalks, curbs, gutters, streets or ramps may be blocked or roped off.

No ladders or scaffolding may be used as elevation for viewing the activities.

Pets are not recommended along the parade; keep them safe

Do not overload electrical outlets

Use battery-operated candles, avoid any open flames Check decorations for a certification label Keep combustibles at least three feet away from heat sources

Never leave a source of fire or heat on unattended Never use charcoal or gasoline-fueled devices indoors Water your tree daily

Turn off, unplug and extinguish all decorations when leaving the house or going to sleep

Stay in the kitchen when cooking

Close your doors when sleeping

Make sure that the flue and chimney is clean before lighting a fire in your fireplace. Use a fire screen to prevent embers from escaping. Make sure all embers are fully extinguished before going to bed.

"We are not going to let a coward violate the safety and security of our city," Pasadena Mayor Victor Gordo said. "We owe it to the family to find the person(s) responsible. Ι thank Supervisor Barger for never forgetting our local families who deserve closure."

Throwing any object into the parade—or at passing vehicles or pedestrians the night before the parade-is dangerous and prohibited. Violators will be cited, and their property will be seized.

Unauthorized vehicles obstructing emergency travel lanes or parked in restricted areas will be towed at owners' expense. No exceptions.

Open containers of alcohol are illegal on public streets, sidewalks and all other public areas. Violators will be cited or arrested.

The throwing of any objects into the roadway or parade route, including seemingly harmless items as tortillas, marshmallows, or flowers, is prohibited.

A Temporary Flight Restriction (TFR) will be in place for both the parade and Rose Bowl Game . Anyone who attempts to fly a drone will be subject to fine, arrest and/or imprisonment. Information about the TFR and all federal drone regulations can be found on the Federal Aviation Administration (FAA) website: www.faa.gov

Pasadena Fire Department responds to more than twice the number of calls on parade day than any other day. These calls include reports of hypothermia, illegal burning, miscellaneous medical issues, assaults and alcohol-related incidents. Be safe and smart!

For your safety and for the safety of others, please remember the City's no-smoking policies [Pasadena Municipal Code section 8.78.071 (A) 4] prohibit smoking in outdoor public gathering events/special events/parades/fairs. This policy includes the use of cannabis and vaping devices (aka e-cigarettes). The public is advised to NOT use any vaping products.

Enhanced security measures will be in effect on the parade route. Pasadena police officers will resolve problems quickly and remove anyone from the scene who violates the law or disturbs the peace. Police canine teams will also be patrolling Colorado Boulevard. "If You See Something, Say Something"

Colorado Boulevard will once again close to motor vehicles earlier than in prior years for the staging of the Rose Parade. Colorado Boulevard will close beginning at 10 p.m. on Sunday, December 31, and will remain closed through the conclusion of the staging and clean-up following the parade. If you plan to host a New Year's Eve event, viewing party, or anticipate vendor deliveries, and your property's access is via Colorado Boulevard, please let your guests and vendors know that they must arrive before 10 p.m. or park in areas without restricted parking and walk in. HOLIDAY BUBBLES NEVER TOO EARLY

Is it me or did we start Christmas Holiday early this year, I've already been to two parties and another for this weekend.


Fiction is sometimes better told then fact. The wine industry is no exception. I am told German draftdodger Jacob Schram made camp in Calistoga in 1860 looking for a place to plant his vines. One hundred sixty years later "Schramsberg" is producing some of my all time favorite sparkling wines to this very day. Is it good enough for me? It certainly was for Richard Nixon. In 1972, Barbara Walters hosted then-President Nixon and China's premier Zhou Enlai with it, and Schramsberg sparkling wine has been served at state functions by every president (and yes, in the Dills household) since the mid-eighties.

Sparkling wines are all blends and can be vintage, although the Schramsberg Blanc de Noir is a composition of grapes and regional combination. Blanc de Noir (meaning "white from black") is 85% pinot noir and 15% chardonnay - thus the blend title - and that is just fine with this writer. With any "bubbles" yeast plays an important role in the fermentation role of the wine's richness and body, making the wine crisp and low in tannins (The Monks found this out by accident). Many readers ask me about sparkling wine or

champagne storage. I buy champagne to drink right away, but if you are able to purchase a six-pack to save a few dollars, that's fine. This Schramsberg, if stored properly, in a nice cool place bottle on it's side, it will be good for years to come, but why let it sit all alone when it should be enjoyed?

Yes, the holidays are here, and my research tells me that consumption of bubbles goes way up during the holidays. This is not a picnic sparkling wine - this is one of my favorites and I savor every zesty sip. Enjoy with a special friend, dinner, or a nice soft cheese.

He looked straight into my dad's eyes, took my dad's hand in both of his, squeezed tightly onto the \$20 bill, and with his lip quivering and a tear streaming down his cheek, he replied; "Thank you, thank you, sir. This really means a lot to me and my family."

My father and I went back to our car and drove home. The \$20 that my dad gave away is what we were going to buy our own tickets with. Although we didn't get to see the circus that night, we both felt a joy inside us that was far greater than seeing the circus could ever provide.

That day I learnt the value to Give. The Giver is bigger than the Receiver. If you want to be large, larger than life, learn to Give. Love has nothing to do with what you are expecting to get, only with what you are expecting to give, which is everything.

The importance of giving can never be over emphasized because there's always joy in giving. Learn to make someone happy by acts of giving."

WHO IS SANTA CLAUS?

On a recent radio talk show, a woman complained that Santa Claus has gained a more prominent role during the Christmas season than the Jesus child. She argued that this was a sign that "we" have allowed secularism – and maybe even paganism – to creep into the Christmas tradition. Really?

She obviously didn't know that there really is a Santa Claus, that is, an actual historical figure upon which the modern "San-ta Claus" is based.

Nikolas of Myra was an historical 4th century Bishop in the Catholic church of Asia Minor (modern-day Demre, Turkey). Yes, he was a member of the still young and developing Catholic church, and he was a priest! He was born on March 15, 270, in Pataya, Lycia, in Asia Minor, now Turkey. At that time, howev-er, the area was culturally Greek, and was politically a part of the Roman diocese of Asia. He was the only child of wealthy Greek parents, who both died in an epidemic when Nikolas was young. Nikolas (also spelled "Nicholas") inherited a fortune from his parents, and was then raised by his uncle (also named Nikolas), who was a Bishop of Patara, and who trained young Nikolas into priesthood.

Nikolas was said to be religious from an early age, and he al-ways fasted on Wednesdays and Fridays.

Because of his outspoken beliefs, he was persecuted by the Romans and was imprisoned during the persecution of Diocle-tian.

In case you never heard of the "persecution of Diocletian" (I hadn't – I was probably playing hookie that day and missed that history lesson), it was the most severe of the Roman Em-pire's persecutions against Christians, simply because they were Christians. It was also known as the "Great Persecution." In 303, four emperors issued a series of dictatorial laws which essentially did away with any legal rights of Christians. The edicts demanded that the Christians comply with traditional Roman "religious" practices, meaning, giving sacrifices to the various Roman gods. This persecution was severe, but weakest in the British colonies where the Empire had the least sway. It was the most severe in the Eastern provinces, where Nikolas lived.

Nikolas refused to worship the Roman gods, so he was tossed into a prison, where he was reportedly hungry and cold for about 5 years. With the rise of Constantine, the persecutions came to an end in 313. Constantine is known for "Christianiz-ing" the Roman Empire, and re-naming all the Mythraic and so-called "pagan" holidays so they could all now be regarded as Christian holidays. With Constantine in power, Nikolas was re-leased. Shortly after his return to his homeland in 317 A.D., Nikolas be-came the Bishop of Myra.

He was later invited to attend the First Council of Nicaea in 325, the famous council where much of the modern dogma of the Catholic church was determined. Nikolas of Myra was one of many bishops to participate in the Council at Constantine's re-quest. He is listed as the 151st attendee at the Council. There, Nikolas was a staunch anti-Arian. Arius, from Alexandria, held the belief that the "Son of God" did not always exist, but was created by the Father. Of course, no one could "prove" either point, but those are the sorts of things they all debated. Nikolas disagreed with Arius, and defended the then-developing orthodox Christian viewpoint. According to stories told, Nikolas got so angry at Arius that he punched him in the face! Really? Pro-to-Santa Claus punches a fellow man of the cloth? Wow! That would make an awesome video!

Back in his homeland, Nikolas became known as the generous bishop. Remember, he inherited wealth from his parents, and he would sometimes give gold and other valuables to those that he learned were in need. In one case, it is said that Nikolas tossed a bag of gold coins into a needy family's yard, anony-mously. He was said to be humble, and didn't want to be seen giving money to people, so he did it secretly. He was so famous for giving such gifts in private when he traveled the country-side, children were told to go to sleep quickly or Nikolas would not come with gifts. This, apparently, is the origin of telling children to go to sleep or that Santa will not come.

In one story, he apparently snuck into the home of a family where the three daughters of a poor man were about to get married. Nikolas put some gold into the stockings which the girls left by the fire to dry. This, apparently, is the origin of hanging up stockings on Christman Gue

He was also well known for the gifts that he gave to newly mar-ried couples during the already-established Christmas season.


Nikolas was a complex man, part of the new Catholic tradition which celebrated the birth of Jesus on the already-observed winter solstice. (Early Judeo-Christians did not celebrate the birth of Jesus, a date that has been lost to history, but historian know that Jesus was definitely not born on December 25).

Nikolas died on December 6, 343, which is to this day known as "Saint Nicholas Day." Upon his death, he was buried in the ca-thedral of Myra. He is revered as a saint in most versions of Christianity and is especially honored in Eastern Orthodox Christianity.

By the year 450, churches in Greece and Asia Minor were being named in honor of Nikolas. He was officially honored as a saint by the Eastern Catholic Church in 800. December 6 began to be celebrated as Bishop Nicholas Day in France by the 1200s.

As time went on, when ever someone received a mysterious gift, it would be attributed to Saint Nicholas!


The Dutch called Saint Nicholas "Sinterklass," which is the most likely manner in which the name Saint Nicholas gradually evolved into "Santa Claus." Along the way, Saint Nicholas was given some of the attributes of Odin, the Norse God, who could travel through the sky and who had a secret home somewhere around the north pole. Come to think of it, even the Superman story borrowed from Odin. Remember how Superman some-



times went to a secret cavern in the Northern coldlands and conversed with his ancestors via ice crystals?



TIPS ON CARING FOR AN AGING PARENT

Dear Savvy Senior: Where can I turn to for caregiving help? I help take care of my 80-year-old father and work too, and it's wearing me out. Worn Out Wendy

Dear Wendy: Taking care of an aging parent over a period of time - especially when juggling work and other family obligations - can be exhausting. But help and resources are available. Here's what you should know.

Identify Your Needs

To help you determine and prioritize the kinds of help you need, a good first step is to make a detailed list of everything you do as your dad's caregiver and the amount of time each task takes. Identify the times when you need help the most and which tasks others might be able to do for you.

Then list the types of care needed, such as simple companionship or doing active chores, like shopping or running errands. Once you determine this, here are some tips and places you can reach out to for help.

Care Helpers

If you have siblings or other loved ones close by start by asking them if they could come and help with specific tasks. And see if friends, neighbors or faith group members could help too. You also need to check into local resources that

may be available. Many communities offer a range of free or subsidized services that help seniors and caregivers with basic needs such as home delivered meals, transportation, senior companion services and respite services, which offers short-term care so you can take an occasional break. Call your nearby Area Aging Agency (800-677-1116) for referrals to services.

There are also a bevy of online services you can use to help you save time on certain chores. For example, online grocery shopping and home deliv-eries, and online pharmacy medication refills and deliveries. You can also order meal-kits or pre-made meals online through numerous meal service delivery companies and arrange needed transportation with ride sharing services like Lyft or Uber.

Or, if you can afford it, you may want to consider hiring someone a few hours a week to help with things like cooking, housekeeping or even personal care. Costs can run anywhere from \$12 up to \$25 per hour. Care.com or CareLinx.com are two good websites to help you find someone, or you can work

with a local home care agency.

Financial Aids

If you're handling your dad's financial chores, make things easier by arranging for direct deposit for his income sources, and set up automatic payments for his utilities and other routine bills. You may also want to set up your dad's online banking service, so you can pay bills and monitor his account anytime. Or, if you need help, consider hiring a bill pay-ing service like Silver Bills (SilverBills.com), which charges a flat fee of \$150 per month.

BenefitsCheckup.org is another excellent tool to look for financial assistance programs that may help your dad, particularly if he's lower income.

Technology Solutions

To help you keep tabs on your dad when you are away at work or if he lives alone, there are affordable technology devices that can help. For example, there are medical alert systems and smart speakers that help with communication and allow him to call for help if needed. Home video cameras with twoway speakers that allow you to monitor and talk to him when you're away. Electronic pill boxes that can notify you if he has taken his medications. And to help you coordinate his care with other members of his care team there are websites like LotsAHelping-Hands.com.

Other Resources

There are also a number of other organizations you can draw on for additional information like the Family Care Alliance (Caregiver.org), which provides a state-by-state listing of caregiving programs and services; the Alzheimer's Association (ALZ. org/help-support/caregiving) that provides information unique to the challenges of dementia caregivers; and the U.S. Department of Veterans Affairs (Caregiver.va.gov), which offers caregiver support services to veterans and spouses.

soul, I must confess here, I have not been successful at everything in my life. Oh yes, there are a few things I have

been successful at, which I won't mention right now. But many things I have failed to succeed at. One thing I have failed to succeed at, even though I have tried all my life, is listening. My ears work, and I can hear many things, but it's listening when I fail.

My first experience in this area of listening was when I met The Gracious Mistress of the Parsonage. At that time, we were students at a Bible Institute studying for the ministry.

We met in September, and we had become a couple by January. One night, we were traveling with a group, and she casually asked, "Wouldn't it be nice to get married?" 

Afterwards, when I put my son to bed, he looked up at me and smiled, "Mommy, now I can go to sleep because you don't have to be punished."




was born and raised in Sierra Madre, in the heart
