

Holiday Closures & **Reminders**

Pasadena residents and businesses are reminded that City Hall and most City services will be closed for the Christmas and New Year's holidays, Monday and Monday, Jan. 1. Specific closures, exceptions and reminders are noted below.

Pasadena residents and businesses with any power emergencies on Dec. 25 and Jan. 1 should call Pasadena's Water and Power (PWP) Department at (626) 744-4673. For water-related emergencies, call (626) 744-4138. Customers can access their accounts and make payments through the automated phone system at (626) 744-4005 or online at PWPweb.com.

The City's Citizen Service Center (CSC) will also be closed Monday and Monday, Jan. 1. You can contact the CSC via the web or mobile app, or by calling (626) 744-7311. Requests submitted over the weekends will be monitored. City trash collection will have a oneday delay of trash collection during both Christmas and New Year's week.

Residents can drop off their Christmas trees Tuesday through Tuesday, Jan. 2, for recycling at Eaton Blanche Park (3100 E. Del Mar Blvd.) or Robinson Park (1081 N. Fair Oaks Ave.) between the hours of 7 a.m. and 2 p.m. Please remove all stands, ornaments and lights prior to drop-off. Curbside Christmas tree pickup will take place Jan. 2 through Jan. 16 on residents' regular pickup day.

Pasadena Transit and Pasadena Dial-A-Ride will not operate on Christmas Day or New Year's Day.

All parking meters are free and parking time limits will not be enforced on Christmas Day and New Year's Day. Also, overnight parking restrictions will not be enforced from today through Jan. 3, and will resume at 2 a.m. on Jan. 4. Violations for red curb/ no parking zones, driveway blocks and blocking fire hydrants will continue to be issued at all times.

All Pasadena Public Library branch sites will close today at 5 p.m. and will reopen on Tuesday. Library branches will again close on Saturday, Dec. 30, at 5 p.m., and will reopen on Tuesday, Jan. 2.

The City's Permit Center will be closed Monday and Monday, Jan 1.

All parks will be open for picnics, fun and play; however, no site reservations are being accepted for the holidays.

IT'S TIME FOR DESSERT

Dessert before dinner? Why not? I have said many times in our teachings here that if you like it, buy it. Over the holidays I hosted a wine seminar at the Whole Foods in East Pasadena. Our list of wines included champagne, sangria, chardonnay, and a petite sirah, with price points ranging from \$10 to \$50 (yes, that was the Taittinger Champagne). To my pleasant surprise the hit of the tastings was a Petite Sirah from San Simeon Winery.

If you recall a previous article on "fruit forward" and "jammy", a petite sirah is often a perfect starter wine for those just learning about wines, or those who might want an alternative to cabernet. Prices can range from \$8 to \$30 for a bottle. At \$18 for the San Simeon Sirah, this Orange County Fair gold medal winner is a great value in my book. It is indeed a bit jammy, but that is perfectly acceptable with grapes that are aged well. Petite sirah grapes were first introduced in France in the 1800's, but really never caught on partly due to the high humidity in Rhone. Here in California we have a drier climate so, much like the chardonnay grape, the petite sirah has thrived.

Originally, petite sirah was paired with zinfandel grapes to tone down that "jammy" effect. Winemaker Anthony Riboli explains that they were able to capitalize on the small grapes' high skin-to-juice ratio and make an exceptional wine on it's own merit without needing to be blended. This critic agrees - I think that this San Simeon treasure is especially appreciated during the winter and will go great with a beef stew or a spicy bowl of chili with or without beans.

This weeks wine term: Tannins. Think of tannins as how the wine lies on or grips your tongue. Smooth? Rough? Neutral? Bitter? In layman's terms, it's "pucker power". Let's hope it's not the last one, bitter, that wouldn't be good.





A CHRISTMAS MEMORY

Yes, we all want happy memories, but life isn't always "happy." This is one of those holiday memories that I wish I didn't have, but I do.

It was early December after Dolores died, and I was withdrawn and depressed. The weather turned wet and cold, and I was asked to help tarp the roof the tall building next door which housed the non-profit I worked

I climbed up the steep ladders onto the highest part of the roof. I actually enjoyed being up so high, though I was not there for the view.

My job was to open up at least two very large plastic tarps, position them where they would stop the leaks, and then secure the tarps in place, somehow. It was not easy task putting large tarps on a steep roof as rain began. I had to constantly work to keep my balance.

The roof had been under re-construction so there were many problem areas where water leaked inside. The idea was to cover the whole roof and then to fix the many leaks sometime after the rainy season. I had to secure the tarp in place, no easy task.

Once the tarp was spread, and more or less secured, I had to get down, and this was also challenging to walk on top of wet plastic. I slipped on the wet tarp as I was trying to get down, and in an effort to secure myself, my right hand slapped hard to support myself, but my hand hit onto some piece of exposed metal that was part of the roof construction. It was a bad cut to the palm of my hand, and I was able to quickly get off the roof, wrap my hand, and asked a friend – Prudence – if she would drive me to the nearby hospital for stitches.

Oddly, I began to feel better once the stitching was done. I was soon dry and I realized that I had friends I could call up on at a moment's notice for assistance. But I was still depressed, withdrawn, and now my hand needed ginger care during the healing process, which was at least two or more weeks. I was not upset that others could do the emergency roofing work since I now had an excellent excuse with my damaged hand.

A few weeks later, I went back to the non-profit building to help two other members fix another problem on of the roof. I was not a happy camper.

We set up some tall ladders along the east side so we could reach the problem area – as I recall, we were attempting to adjust the very tall TV antennae and its complicated wiring.

It wasn't raining at the time, and we figured it would be an easy fix. The long ladders were close to the east overhang, and I was up on one ladder, sweeping abundant leaves off the low overhang.

Prudence set up her ladder and started up to the top of the ladder. Julie was there working too, and I think she was on the ground when Prudence went up her ladder. Prudence neared the top and then everything seemed like a dream.

We heard a yell and what appeared to be a scene from a comic book played out: The ladder was slowly falling backward and Prudence was being propelled off the top of the ladder, as if she were a cannonball that had been catapulted outward. She later told us that she instinctively rolled her body into a ball for protection when she realized she was falling.

It only lasted a few seconds, but I'll never forget the sight of Prudence flying outward in space. Julie reported that those few seconds were the most distressing – seeing Prudence flying through the air like a cannonball and not knowing what would happen.

Prudence fell onto the ground as the tumbling ladder noisily fell to the side. The ground was a patchwork of bricks, plants, trees, lumber for projects, river rock, cement planters—lots of stuff. Julie and I rushed to Prudence who seemed to have miraculously landed in the only relatively safe spot, though she had a cut on her forehead. One of the cement planters was very near her head, but she only hit the rocks with her shoulder.

Prudence lay there for the longest time and we talked to her. She never passed out. She said that nothing was broken, just damaged. Needless to say, we quit work for that day. We tended to Prudence's wound, and talked about how we'd do it different the next time, presumably by not having a ladder so steep, or by securing it with rope.

Though the sight of a human body being propelled through the air was startling, almost funny, I realized that Prudence could have died that day if she hit some object the wrong way. I'm sure that experience made me a bit more weary of heights, and made me even more keenly aware to avoid dangerous situations. It also made me feel more acutely aware of the preciousness of life, both mine and everyone around me. Slowly, because of this and other experiences, I found myself become more and more concerned about the

health and safety of those around me, which is a good thing.

I recall Prudence's natural hesitation to ever go up on that roof again, and the roof gradually, bit by bit, got repaired, though it took much longer than it should have.

HOW TO CLOSE SOCIAL MEDIA **ACCOUNTS OF A DECEASED**

Dear Savvy Senior:

How do I go about canceling a person's social media accounts when they die? My wife passed away a few months ago and her social media accounts are still active. Sad Spouse

I'm very sorry for your loss, but this is a smart move on your behalf and one that often gets overlooked. Social media is part of many people's daily lives, but when a person passes away their dormant accounts can become vulnerable to scammers who can hack into them and even steal your deceased loved one's identity.

Here's a run-down of how you can cancel or change many different social media accounts after a loved

Facebook: If your wife used Facebook, you can either "memorialize" or "delete" her account.

A memorialized account serves as a place where family and friends can share memories to celebrate the deceased person's life, with the word "Remembering" shown next to the deceased person's name. Once an account is memorialized, content the person shared is still visible on Facebook to the audience it was originally shared with, however, the user's profile will not show up in public spaces such as people you may know, ads or birthday reminders.

To memorialize your wife's profile simply go to Facebook.com/help/contact/234739086860192. Or, if you'd rather have her account removed, go to Facebook.com/help/contact/228813257197480.

To memorialize her account requires proof of death (via death certificate, obituary or memorial card), but if you wish to delete the account, you'll also need to verify that you're an immediate family member, legal representative or executor, unless you're the legacy contact on her account.

Instagram: The policy on a deceased users' Instagram account is the similar to Facebook's, which owns Instagram. You can either memorialize or remove the account at Help.Instagram.com/264154560391256. But just like with Facebook, you'll need to provide | Savvy Senior" book.

LinkedIn: To remove a deceased person's LinkedIn profile, submit a request at LinkedIn.com/help/ linkedin/ask/ts-rdmlp. You'll need to provide the name and URL to the profile; the relationship you have to the deceased; the email address; date of passing; and link to an obituary.

Snapchat: To delete this account, simply login to the account and click "Delete My Account" and follow the prompts.

Tumblr: Send an email to Support@tumblr.com requesting to remove the account of the deceased person with their Tumblr username, proof

of their death, and proof of your relationship to the deceased.

If your wife had social media through a company not listed here, go to that company's website for information on how to delete the account.

STUART TOLCHIN **PUT THE LIGHTS ON** A DIFFERENT DAY



Last night I learned that I will have to undergo some medical procedures and surgeries which although not life threatening, are definitely frightening. I worried myself to sleep but when I awoke was very appreciative of the warmth of my blankets, the comfort of my mattress and the calming presence of my dog Dreamy next to me. Finally, with great reluctance, I pushed off the covers entered the bathroom and confronted myself in the

mirror. It was raining outside so golf was out, similarly the rain made it cleat that Dreamy would not allow himself to accompany me on our customary morning walk around the canyon circle.

For a moment I was lost. I did not want to be left alone with my thoughts and fears. Of course there it was right next to me, the tub and shower. I was very much aware of how much I enjoyed the shower and thought of my father's time growing up in the Ukraine when a hot bath was the greatest pleasure for he and his brothers.

Next with this enjoyment I recollected how my father always wanted me to accompany hlm 'to a "shevitz bod" (roughly hot bath in Yiddish) which was located somewhere outside of the San Fernando Valley where we lived. I can recall my mother "Why would you want to take him to such a dirty place?" I have been reading three books, the book Determined A Science of Life Without Free Will by Robert M. Sapolsky together with the Untethered Soul by Michael A. Singer and A Confederacy of Dunces by John Kennedy Toole.

As I stood in the shower enjoying its warming comfort I also thought of these three books. (It's true I must have stayed in the shower for quite a long time). The Sapolsky book emphasized that there is no time for praise or regrets. There is no Free Will and whatever happens must happen as the next step, the consequence of all the other influences within the cosmos that have happened before. My mother had no choice to say what she did as she was not an immigrant like my father and his brothers. She did not know the joys of the shevitz bod to kids growing up in the deprived circumstances of the Ukraine where they lived in fear every day. She grew up living with her family in Chicago and driving to some unknown place for a hot bath seemed ridiculous and unnecessary to her.

Next Untethered Soul entered my mind. The author there cautions the reader not to be ruled by the continuing inner voice that is forever making judgments. One is told simply to hear that voice and observe it but is mandated to realize that this annoying voice is just one part of a larger self, whatever that is, and to experience the freedom of not being tethered to that voice, One is asked to realize that there are a lot of things going on at the same time and the freedom of living come from the ability to observe and be aware of all of these possibilities and not be stuck in any one place.

As I thought of not being stuck I thought of A Confederacy Of Dunces by John Kennedy Toole. This hysterical Pulitzer Prize winning book was written by a very troubled young man who committed suicide at the age of thirty three. He was stuck in a very troubled place and made the most if it composing a remarkable novel and must have felt pretty good about that accomplishment. Not good enough to stay alive but as Sapolsky helps to explain he really had no choice but to do as he did and that is the truth for all of us.


Truth be told, the past year was not one of the easiest for me or my family.






