





I am delighted to have been a part of this wonderful newspaper almost since the beginning.

Susan Henderson persuaded me to try writing a column and it became a regular thing around 2012. This is probably the best thing I get to do, to share my life and my family with you dear friends and neighbors. Sierra

Madre is simply the best and most beautiful place to live. John and I came to live here in 1967. We raised our family here in the 100-year-old mansion at 86 E. Alegria, next to wonderful neighbors, celebrated Halloween and cleaned up after wind storms together. The Mountain Views News has given us the news and so many incredible, awesome pictures through the years and I am proud to be a part of this community and this newspaper.

The special section in last week's News was so inspirational. Volunteering is not only a good and useful thing to do, but one meets really neat people wherever one volunteers. My husband, John, now volunteering in heaven, I'm sure, volunteered through our church to do Church in the Park on Sundays down in the park across from the Pasadena Library. They served chili, grits, burritos and whatever else could be gathered together to feed these hungry, mostly homeless folks. John served grits and hope. Grits and encouragement. Grits and love. He met people he wept over, people he prayed for, people he brought books for. Being a volunteer changed his life.

For several years I volunteered at the Red Cross blood collection center across from Huntington Hospital. I interviewed people at the front desk and met delightful folks ready to give a pint of their precious blood. I also got the best spinach quiche recipe from one of the nurses which I will share with you soon.

Monday is Martin Luther King Day; a school holiday and I'm hoping Monday will be a pleasant day for all the celebrations and parades that will go on to honor this remarkable man. No, he was far from perfect but he wanted all people to have good lives.

You probably already know this, but just to refresh your memory, here are a few facts from Wikipedia: Dr. King was born in 1929 and was assassinated on April 4, 1968. He was a Baptist Minister and one of the most prominent leaders in the civil rights movement. Inspired by his Christian beliefs and the nonviolent activism of Mahatma Gandhi, he led nonviolent marches for the right to vote, desegregation, labor rights and so much more. He made many unforgettable statements that are still widely quoted today:

> "Never, never be afraid to do what's right!" "Darkness cannot drive out darkness; only light can do that. Hate cannot drive out hate; only love can do that." "Be the peace you wish to see in the world."





Martin Luther King Jr. Day Closures and **Reminders**

Pasadena residents and businesses are reminded that City Hall and many City services will be closed Monday in observance of Martin Luther King Jr. Day.

City Council will not meet on Martin Luther King Jr. Day. City Council is scheduled to meet the following Monday, Jan. 22.

Pasadena residents and businesses with power emergencies should call Pasadena Water and Power (PWP) at (626) 744-4673. For water-related emergencies, call (626) 744-4138. PWP's Customer Service Call Center will be closed, but customers can access their accounts and make payments by phone at (626) 744-4005 or online at PWPweb.com.

The Municipal Services Payment Center, Citizen Service Center, and Parking Office will be closed. The City of Pasadena WILL collect trash, recycling and yard waste on Monday. Collection will occur on customers' regular pickup day the entire week.

All parking meters will be free, and parking time limits will not be enforced; however, violations for overnight parking, red curb parking, "No Parking" zones, and blocking fire hydrants will be enforced. All regular enforcement resumes Tuesday.

The Permit Center will also be closed; however, some services will be available via Permit Center Online, where subtrade permits can be obtained and plans for commercial tenant improvements (new submittals) and accessory dwelling units can be submitted. In-person operations will resume Tuesday.

Pasadena Transit and Dial-A-Ride buses will operate on regular weekday schedules on Monday.

Pasadena Public Library sites will be closed Sunday and Monday and will reopen Tuesday.

All parks will be open for picnics, fun and play; however, no site reservations are being accepted for the holiday. Community and recreation centers will also be closed to the public.

The Pasadena Public Department Health (PPHD) will be closed Monday and will resume operations on Tuesday. PPHD reminds you to take measures to protect yourself from respiratory viruses, including masking indoors, getting vaccinated, and staying home when

County to Help City Fight Copper Wire Theft

The Los Angeles County Board of Supervisors unanimously approved a motion Tuesday read-in by Supervisor Kathryn Barger that will now offer a \$10,000 reward to help Pasadena city officials identify individuals stealing copper from street lights, city stock yards and other public sites.

Firearm Bill Passes Senate **Public Safety Committee**

Senate Bill 53, authored by Senator Anthony Portantino, passed the Senate Public Safety Committee Tuesday. The bill expands existing firearm safe storage laws by creating barriers to suicide, unintentional shootings, and theft. Senator Portantino was the author of California's landmark safe storage law in

"Safely storing your firearm is commonsense public safety policy and should not be partisan. Safe storage is proven to reduce firearm injuries and I'm pleased to bé tightening California's existing law," stated Senator Portantino. "SB 53 does not infringe upon an individual's Second Amendment right in the home. Rather, it ensures that a firearm is stored in a manner that will prevent unintentional firearm injuries and protect Californians in the home and deter violence in public. It will unequivocally save lives."

Death by firearm is the number one cause of death for children in the United States. States that have safe storage laws have seen a 78 percent drop in unintentional committed by children compared to states that do not have safe storage laws in place. Additionally, firearms are the most lethal method used in suicide deaths, with a fatality rate of approximately 90%. As mentioned above, Senator Portantino authored SB 172 - California's original safe storage law in 2019. SB 53 builds on that effort and will make Californians even more safe. President Biden has called for a national safe storage law as well.

SB 53 prohibits a person from keeping or storing a firearm in a residence unless the firearm is stored in a DOJapproved locked box or safe. Under this bill, a violation results in an infraction for the first offense and a misdemeanor for a second and subsequent offense and possession of a firearm.

Statement on SB 2 Gun Safety Bill Court Ruling

Senator Anthony J released the following statement Wednesday on SB 2 and sensitive places: "It is unfortunate that some sensitive places outlined in SB 2 are being challenged. However, many of them remain in effect - including schools and childcare facilities, executive and legislative branch buildings, courthouses, local government buildings, jails, higher education facilities, airport and passenger

vessel facilities, nuclear facilities, law enforcement facilities, and polling places. The age limit, permit criteria, and training requirements are also in effect.

I strongly support Attorney General Bonta's appeal of the court decision, as the purpose of SB 2 is to enhance the public safety of Californians under the guidelines of the Supreme Court Bruen decision. I am optimistic that California will prevail in upholding this responsible and necessary law."

SIR THERE IS A TWIST OFF ON MY BOTTLE OF WINE

There was a wonderful eatery in Old Pasadena called "Pop", and they'd specialize in (drum roll) sparkling wines and champagnes. They seemed to do quite well with "mouse*" crowd. The story here was: sometime back, under different ownership, they were open Wednesday through Sunday. I asked the then bartender/sommelier Raphael what they did with the opened bottles of sparkling wine after closing on Sunday? He said they poured it all out in the sink. Having grown up in a waste-not-want-not household, I shook and quivered at such a thought. We made a deal on the spot that I could come in on any Sunday night and for \$15 (friends included) drink what otherwise would be thrown away.

As mentioned, Pop has long out of business, but it got me to think about the wine that is sitting in your favorite restaurant's refrigerator: how long has it been sitting there? As far as sparkling wines go (remember, it can only be called champagne if the grapes were grown in the region of Champagne, France), there should still be a "pop" when your server takes off the stopper. If you aren't sure, simply grab a utensil and see if you can stir up some bubbles. White wines and red will stay fresh a day or two longer, but here is my tried and true suggestion (and not once have I had a "no" or a roll of the eyes). Simply ask the server when the bottle was opened, and if they aren't sure, ask for a fresh bottle. The mark-up on wines by the glass is in the restaurants favor; all you are doing is evening the odds. There are a handful of restaurants that sell splits of sparkling wines which gives you about a glass and a half from a split. I don't recommend splits of sparkling wine, though, as they come with screw tops instead of corks. Sparkling wine with a screw top? Dom Perignon would turn over in his grave. If you're looking for wine by the glass, check out the Plate 38 on Colorado or Taylor's up in La Canada I promise that there will be no eye rolling and they do rotate their wines by the glass program often. Check out my latest video reel on Youtube I talk about the difference between corks and screw tops!!



NEW CALIFORNIA LAWS IN 2024 (partial listing)

Workers

New protections for those who use or have used cannabis off the clock: SB 700 prohibits an employer from requesting information from an applicant's prior cannabis use. AB 2188 prohibits employers from discriminating against a worker or applicant based on their use of cannabis off the job and away from the workplace.

Minimum wage increases: California's minimum wage overall will increase to \$16 dollars an hour when the new year begins because of a state law that requires the minimum wage to adjust for inflation. Later this year, other job sectors will see even bigger bumps. In April, AB 1228 will go into effect to raise the minimum wage of fast-food workers to \$20 an hour. In June, because of SB 525, some health care workers will begin seeing increases to their minimum wage depending on the type of facility they work in, to eventually reach a \$25 minimum wage for the entire industry by 2033.

New limits for gun buyers and carriers: Lawmakers and the governor this year passed two laws in response to mass shootings nationwide. SB 2 places new limits on concealed carry firearm permit holders, while AB 28 imposes an 11% tax on firearms and ammunition to help fund violence prevention programs.

SB 14 - Defines child sex trafficking as a serious felony under California law, meaning repeat offenders of this crime and other serious offenses could face up to life in prison

AB 701 - Enhances jail time for those trafficking more than a kilo of fentanyl.
AB 452 - Eliminates the statute of limitations, or time limit for the recovery of damages, for

victims of childhood sexual assault that occurs on or after January 1.

AB 2282 - Enhances criminal penalties for those who use swastikas, nooses, desecrated crosses and other hate symbols on schools, cemeteries, religious institutions, businesses and other private and public spaces.

Housing AB 12 - Starting in July, prohibits landlords from charging more than one month's rent for a security deposit.

SB 4 - Allows places of worship or independent higher education institutions to build a housing development project on their property "by right."

Health

Abortion and reproductive protections have been a priority for lawmakers and the governor since the Supreme Court of the United States struck down Roe v. Wade. With that, they passed SB 345, which sets legal protections for healthcare providers who mail abortion pills or gender-affirming prescriptions out of state.

SB 385 allows physician's assistants to do surgical abortions without the direct supervision of a doctor. For those mourning a reproductive loss.

SB 848 requires employers to provide five days of time off for workers who went through the loss, including a miscarriage, stillbirth, or unsuccessful embryo transfer, insemination or adoption.

 $SB\ 43$ - Makes it easier for counties to put those with severe mental illness into medical treatment or temporary psychiatric holds. The law expands who can be put into an involuntary hold to include those who are addicted to drugs or alcohol or who are unable to keep themselves safe.

Consumer

AB 1084 - Requires retailers to have a gender-neutral toy section.

SB 244 - The Right to Repair Act, which will require manufacturers of devices that cost more than \$50 to provide consumers and repair shops with parts, tools, or instructions to repair the device.

SB 478 - Hidden fees no longer. Starting in July, this will require websites to show the actual cost of a service or item upfront. This includes hotel or short-term rental stays, event tickets and food delivery services.

Miscellaneous

ONLINE PROTECTIONS: AB 587 requires social media companies to disclose how they ate speech and disinformation Tech companies are expected to provide reports to the state attorney general on how they address violations of user terms.

DAYLIGHTING CROSSWALKS: AB 413 prohibits stopping or parking a vehicle within 20 feet of an intersection or crosswalk clear of parked vehicles.

KEEP CRUISING: AB 436 keeps cities and counties from imposing cruising bans on city

JEWISH COMMUNITY AND THE CITY OF PASADENA TO HOLD EVERY PERSON HAS A NAME, A 25-HOUR HOLOCAUST VIGIL TO COMMEMORATE UN INTERNATIONAL HOLOCAUST REMEMBRANCE DAY

On Saturday, January 27 at 7 p.m. through Sunday, January 22 at 8 p.m., the Jewish Federation of the Greater San Gabriel and Pomona Valleys, in partnership with the City of Pasadena, will be holding its annual Every Person Has a Name, a 25-hour Holocaust vigil to commemorate UN International Holocaust Remembrance Day, on the steps of Pasadena City Hall.

"With the rise of antisemitic and hate incidents we have seen as of late, an event like this is crucial to serving both as a reminder of what can happen when hate goes unchecked and also to remember the people who were murdered because of the same hatred... the hatred for the other," explains Jason Moss, Jewish Federation's Executive Director. "By bringing the community together, we remember that each person killed was someone who lived and whose life was cut short. They are not just part of the six million lives lost but had their own story and their own individual experience. While our readers and those who listen may not know the people they are reading the names for, they are remembered by saying their names aloud. With every passing day, survivors are dying, and with them go their stories. My concern is that the memories will be dying as well."

This year's event will begin with a commemoration ceremony featuring local elected officials and other dignitaries. Then, it will continue with a 24-hour vigil of name reading. And there will also be an exhibition entitled The Righteous Among the Nations, made available to be shown by Yad Vashem, Israel's National Holocaust Museum. The exhibition shares the stories of over 30 people who willingly sacrificed their own freedom, and sometimes their own lives, to save Jews during the Holocaust.

By participating in events like this, we help ensure that the importance of the Holocaust is not forgotten, no matter how many years pass, as memories are passed on to the next generation. We hope that community members will take this opportunity to help safeguard the memory of the Holocaust, promote tolerance, and protect the society in which we live.

The event is open to the public. We are currently looking for volunteers to read names, in-person or virtually, during 30-minute blocks. People can sign up by visiting the Jewish Federation's website (www.jewishsgpv.org) or calling 626.445.0810.

Those who do not feel like reading can attend the commemoration ceremony, sit and listen as the names are read, and help spread the word about the event. Being present and showing support is part of the power of the event.

ASSEMBLYMEMBER HOLDEN'S DUAL ENROLLMENT **BILL PASSES COMMITTEE**

Sacramento, CA - Today, Assemblymember Chris Holden's bill, AB 359 passed the Assembly Committee on Higher Education with bipartisan support. This bill would remove existing barriers for Local Education Agencies and Community Colleges by providing technical assistance to create partnerships and increase the students' ability to access necessary resources and additional courses.


Dual and concurrent enrollment provides high school students access to college-level coursework. In some cases, students earn both high school and college credit for the same course depending on approval from local school and community college governing boards. Assemblymember Holden first established the College and Career Access Pathways program in 2015 (AB 288) and has since passed numerous bills to increase and expand dual enrollment opportunities through these

"I have spent the last nine years championing these efforts by providing aspiring students across the state, irrespective of socioeconomic status, the opportunity to excel without the heavy burden of college debt," said Assemblymember Holden.

As the quality of dual enrollment programs throughout the state widely varies, many students express that they feel disengaged from school, or that they are constantly repeating material that they have already covered. Increasing educational opportunities, such as dual enrollment, provides a turning point for students that can lead to academic success and future employment.

In 2022, Holden authored, AB 102, which was signed into law and increased access to dual enrollment opportunities for students in juvenile court schools as well as eliminated the 2027 sunset date for the College and Career Access Pathways (CCAP) partnerships, indefinitely.

"Two years ago, we were able to ensure that education has no sunset, and with this new bill we hope to focus on the long-term success and sustainability of dual enrollment by providing necessary dual enrollment reform that benefits all key stakeholders," said Holden.



A LITTLE FIELD OF DREAMS

I was living in a small cinder-block house set on one acre of wild property, located at the end of cul de sac. I often felt like I was in a universe far, far

While I lived there, I practiced recycling of household wastes, did composting, water recycling, animal raising, and lots of gardening.

My garden never seemed highly productive but I had a few of the tall red amaranth plants, some squash, a corn patch, some greens, and wild foods. It was probably my first successful corn patch. I didn't plant the rows of corn that you see so often in gardens and on farms. Rather, in my approximately 10 by 20 foot corn patch, I had corn more of less evenly spaced. I had wanted to try the so-called Three Sisters of the native Southwest, of corn, beans, and

In the arid soil of the Southwest, the corn was planted first, and once it arose, beans were planted at the base of the each corn. The beans' roots fix nitrogen and this acts as a fertilizer to the corn. Squash was then planted as a sprawling ground cover to retain the valuable scant moisture of the desert.

I planted my corn in what had been my wood chip patch, three seeds per hole about two feet apart. Corn came up, and then I planted bean seeds. Beans are usually an easy crop to grow, but not that many came up. Who knows, maybe my ducks ate them. I planted squash too. Not a desert squash but ordinary zucchini which did a good job as a ground cover and food producer. I loved the little garden, and at night when I sat at my plywood desk with my typewriter, I'd look out my window through the several feet tall corn patch to see the lights of the city below. During the day, little birds would flock to the corn patch and eat bugs. I enjoyed the fact that this little garden that I created with my simple efforts was now teeming with wildlife. It felt good just to look at it. It provided some food for my body, food for wildlife, and food for my soul.

Not long after I started this patch – it was near Thanksgiving – my friend David Ashley came by for a visit. David had already moved into the neighborhood from wherever else he'd been living. He came up to the top of the hill where I was a squatter to pay a visit. My housing status didn't cause David to lower his regard for me.

I took David out into my garden, and we stood there talking about the mysteries and meanings of life. I pulled off a ripe ear of corn and handed it to him and picked one for myself.

"What's this for?" asked David.

"To eat," I responded as I began to peel off the leaves and hairs on my average size ear of corn. He took a bite of the sweet kernels.

"I didn't know you could eat corn raw," said David in a surprised voice.

"Yep, you can," I told him as I chewed on my sweet tender kernels from my fresh-picked cob.

David began to peel his and take some

"Wow, that's really good!" said David, chewing on more kernels. We stood there for a few moments, eating our corn, looking at the outside world through the stalks of corn that were taller than us. It was a quiet, special moment. We didn't say a whole lot more, just stood there eating every last kernel, and looking down at the vast city of Los Angeles as if it were Emerald



WHAT YOU NEED TO KNOW ABOUT MEDICARE SPOUSE COVERAGE

Dear Savvy Senior:

Are spouses who have not worked outside the home eligible for Medicare benefits? I have worked most of my adult life, but my wife has been a mother and homemaker since we got married and hasn't held an income-producing job since she was in college. Will she be eligible for Medicare? Searching Spouse

Dear Searching:

There are many couples in your situation when it comes to applying for Medicare. The answer generally is yes, your spouse can qualify for Medicare on your work record. Here's how it works.

Medicare Requirements

Medicare, the government health insurance program for older adults, covers around 60 million Americans age 65 and older, as well as those younger that have a qualifying disability or have End-Stage Renal Disease.

To be eligible, you must have worked and paid Medicare taxes for at least 10 years to qualify for premium-free Medicare Part A hospital coverage when you turn 65. If you qualify, then your nonworking spouse will qualify too, based on your work record when she turns 65.

Divorced spouses are also eligible if they were married at least 10 years and are single, as are surviving spouses who are single and who were married for at least nine months before their spouse

In addition to Part A, both you and your spouse would also qualify for Medicare Part B, which covers doctor's visits and other outpatient services, but requires a monthly premium. The premium for Part B beneficiaries in 2024 is \$174.70 per month per person. Couples filing jointly with incomes over \$206,000 per year pay even more.

There are also a number of other caveats you should know about depending on your wife's age.

Older Spouses

If your wife is older than you, she can qualify for Medicare on your work record at age 65, even if you're not getting Medicare yourself, but you must be at least 62 years old. You also must have been married for at least one year for your wife to apply for Medicare on your work record.

First, don't think you have to run the event. Many

you are still working and your wife is covered by your employer's health insurance, she may want to enroll only in the premium-free Medicare Part A until you retire, or your employer coverage ends. Part B – along with its premium – can be added later without penalty as long as your employer's group health plan is your "primary coverage." Check with your employers' human resources department to find out about this. (Note: If your wife is funding a health savings account, she may not want to take Part A because she can't make contributions after she enrolls).

Younger Spouses


If your wife is younger than you, she will need health insurance until she turns 65 and becomes eligible for Medicare. This may be through the Health Insurance Marketplace (see healthcare.gov), or if you're still working, through COBRA (see dol. gov/general/topic/health-plans/cobra).

Other Medicare Choices

In addition to Medicare Part A and B, when you and your wife become Medicare eligible, each of you will also need to enroll in a Part D prescription drug plan if you don't have credible drug coverage from your employer or union. And, you may want to purchase a Medicare supplemental (Medigap) policy too, to help pay for things that aren't covered by Medicare like copayments, coinsurance and deductibles. Or, you may want to consider an all-in-one Medicare Advantage plan.

For more information on Medicare choices and enrollment rules visit Medicare.gov or call 800-633-4227. You can also get help through your State Health Insurance Assistance Program (see shiphelp. org), which provides free Medicare counseling.






