

Sierra Madre News Briefs

GAS LEAK CLOSES STREETS -3 HOMES EVACUATED

On Friday, the Sierra Madre Police Department and Fire Departments responded to calls of a gas leak on North Lima. Three homes were evacuated as a precaution and the Gas Company and Edison were dispatched to the scene.

Lima was closed between Sierra Madre Blvd. and Highland. until the leak was repaired. The Gas Company cut off the gas lines and repaired the leak.

The leak was confined to a specific area and did not pose a threat to the rest of the city. Electronic alerts were sent to residents via Nixle.

At press time, there were no reported injuries. The streets were closed from approximately 12:40 pm until 3:47 pm when they were reopened, evacuation orders were lifted and the gas leak was no longer a threat.

TRASH RATES HAVE GONE UP, AND SO HAS THE CONFUSION

Athens compacts it all down - from new rates to new ways to sort your trash

Residents of Sierra Madre have certainly noticed a hike in their trash pickup rates over the last few years. The most recent one occurred on January 1, 2024, with a shocking 56% increase in the disposal rate. In addition to the hike, there are new rules for sorting food waste, which now goes in with green waste. But why is there such a big jump in my Athens' bill? And what about the bears? What is Senate Bill 1383, and why does it concern me?

Christian Warner, Senior Vice President of Compliance at Athens Services, presented before the City Council on February 13 to help answer these questions and more.

Why are my rates so high?

According to Warner's slide presentation, the rate adjustment is broken down into three components: Service, Disposal, and Extraordinary.

The Service Component of the trash rates is based on the trash Consumer Price Index (CPI). Between 2010 and 2021, the average rate increase for Athens' services was a consistent 2.15%, but in the last three years, that number jumped to 6.45% due to high inflation rates. Remember those gas prices last year?


The Disposal Component refers to the rate for disposing of the trash in the Scholl Canyon Landfill. The Gate Rate, or price per ton, averaged a low 0.09% increase from 2010 to 2021. This rate jumped 5% in 2022, 8% in 2023, and a whopping 56% in the last three years. The previous big hike is said to have brought the Scholl Canyon Landfill disposal rates up to the market rate comparable to surrounding cities. Warner noted that he was unsure why Scholl Canyon kept their rates low for so long.

Unfortunately, because the new gate rates aren't posted until the end of the year, this gave little to no time to properly inform Athens' customers of this price hike. "It was very last minute that any of us knew what was going on,"

City Council members expressed concern at the poorly communicated whopper increase, which also caught them by surprise. "We could have all done a better job of communicating that this was going to happen," said Councilmember Kristine Lowe, noting that residents had just been hit with a rate increase in January.

In 2010, the rate formula was based on Sierra Madre waste going down to Scholl Canyon Landfill. But, due to changes in industry standards over the last decade, that's no longer the case. Now, the waste goes to the Material Recovery Facility (MRF), organics facility, and Construction and Demolition Debris Recycling Facility (C & D) in Los Angeles.

Warner stated that he approached the City Manager and Public Works Director around five years ago because the Scholl Canyon Landfill is a county sanitation facility, and Sierra Madre had no control over their disposal rates. According to Warner, a proposal was made to change to an MRF gate rate, or SBC Waste Management gate rate, or have the entire rate adjusted by the CPI. But, the decision at the time was for Sierra Madre to stay with the current gate rate because it remained low, which was advantageous to the city. However, this was not advantageous to Athens, (continued on page 3)



which was incurring the costs of shipping the waste to different facilities.

The Extraordinary Component refers to Senate Bill 1383, the new California State Law, which "aims to keep food and other compostable materials known as organic waste out of landfills to reduce greenhouse gas emissions that contribute to climate change." This is an unfunded state mandate requiring all cities to comply. Several "costly" programs had to be implemented by Athens to meet these new requirements, and they are the following:

- Source-separated organics collection and transport to organics facility
- Conduct Annual site visits to all
- commercial accounts Perform route audits or lid flipping
- Perform quarterly waste characterizations
- Send out education and outreach materials Procure 18,000 gallons of renewable natural gas, or 500 tons of compost, or 850
- tons of mulch Edible food waste recovery program New reporting requirements

According to Warner, these costs have started to "trickle down" to Sierra Madre residents, with about a 9% rate adjustment in 2023 and the remaining 9% hitting customers on January 1, 2024.

Organics Services

What are organics? Organic waste includes grass clippings, leaves (green waste), and all your food waste. Organics are sent to a facility and turned into compost. With this change comes the risk of bears invading green waste bins. Athens has provided new bear-resistant organics barrels to all single-family homes and multi-family complexes with four or fewer units as part of the Athens Advantage at no cost to the residents or the city. According to Councilmember Edward Garcia, some misinformation floating around social media connected to high rate increases in these new bear-resistant containers, but that's not the case. However, some residents were mistakenly charged and refunded by Athens.

Commercial accounts and apartments with five or more units must also source separate their organics. Organic barrels have also been provided, and services have been performed according to the report. There is no barrel charge for these locations. Residents and business owners can ask Athens about using these organic barrels. After an inquiry from Councilmember Garcia about landlords being responsible for what renters put in their bins, Warner clarified that the apartment bins would go to an MRF facility where they sort the waste in-house.

Warner also said that Athens won't automatically fine commercial businesses for getting it wrong a few times and stated that Athens will work with them to help them get used to the process and improve over time.

The Canyon Residential Area

The Canyon Residential Areas have always been challenging service areas for Athens to get to. There are narrow and curvy roads, limited parking, low trees, and wires to be concerned with. As a result, Athens received an exemption from Cal Recycle to provide service with 1-pass (one truck) instead of 3-pass (three separate trucks), as long as the collected materials go to an MFR plant for processing. This will result in less truck traffic and a carbon footprint in that area.

Athens will provide extra blue and green barrels to the Canyon or pick up unused barrels at no extra

Special Services

Athens does provide additional special services to be aware of. These services include:

Household Hazardous Waste and E-Waste Drop-Off Event once a year. This year, it will take place on Saturday, March 16th, from 8 a.m. to noon in the rear lot at City Hall.

- Compost Giveaway Event 2 per year
- Bulky item pick-up. Four free per year for each single-family residential unit, two free per year for each unit at a multi-family complex with six or fewer units, and bulky item charges for commercial
- and multi-family over six units

 Sharps Collection Program. Athens provides a "sharps and needles" mail-in disposal kit for a fee. Senate Bill 212 offers free in-person or mail-in disposal kits.
- Medical Waste Disposal. Athens Website (athensservices.com) provides information on preparation and disposal. SB212 provides free inperson or mail-in disposal kits.
- There are also guides for various types of waste on the website, such as athensservices.com/ recycling-guide.

Warner stated that he was willing to work on some of the concerns addressed by the City Council, including better communication, more accessible website navigation to topics such as recycling and medicine and pill disposal, and paying more attention to low-income resident concerns.

Mayor Kelly Kriebs thanked Warner for his time and noted they are on the same team. "We really are partners in this, and I do appreciate all that you do and all the transparency you are providing," Kriebs said.

> 1/3 cup butter ¼ cup sugar 1 cup flour

Using your electric mixer, beat the butter on medium to high speed for 30 seconds. Add the sugar, beat till combined, add the flour and beat till mixture is crumbly. Press mixture into the bottom of a lightly greased 8-inch square baking pan. Bake at 350 degrees for 15-18 minutes until just golden. While that's baking, make your filling:

34 cup sugar 2 TB flour


2 TB finely shredded lemon zest (more is good. Lots more is better) 3 TB lemon juice

1/4 tsp baking powder

Whip eggs in same bowl you used for the crust, add other ingredients. Beat 2 minutes. Pour over baked layer. Bake 20 minutes or until lightly browned around the edges and center is set. Dust with powdered sugar after it has cooled.

RESIDENTIAL FOOD SCRAP COLLECTION

Athens Services is partnering with your city to implement food scrap collection for single-family home residents and multifamily complexes. Per Senate Bill 1383, single-family home residents and multifamily complexes across California will be required to place into their green waste container ALL of their landscaping waste, food scraps, and food-soiled paper (100% fiber-based).

WHAT'S CHANGING? You will be able to use your green organics container for the collection of landscaping waste, food scraps, and 100% fiber-based, food-soiled paper.

DID YOU SAY FOOD SCRAPS? Yes, Athens will accept all types of food scraps, Our American Organics compost facility converts organics waste into nutrient-rich soil amendment. The resulting compost is used by commercial farmers, city projects, garden shops, landscapers, and residents.

HOW DO I PARTICIPATE? To collect your kitchen food scraps, you can choose to use a portable, reusable pail-like container with a tight fitting lid. It could be plastic, metal, or ceramic. Pail options can be purchased or consider reusing a coffee canister, large yogurt or margarine tub, or juice pitcher. Storage ideas can include the kitchen counter, under the sink, in the freezer, or wherever you feel is best.

WHY ORGANICS RECYCLING? Landfills are the third largest source of methane in California. Organics waste emits 20% of the state's methane. By diverting organics from the landfill, you are part of the solution in helping to protect the environment and future generations.

ARE BAGS ACCEPTED? Liners are optional. Plastic and bioplastic "compostable" bags are accepted in the organics container, but must be CLEAR or translucent-green, and bag contents must be visible. Acceptable organics will be processed, but the bags will not be recycled or composted.

WHERE CAN I GET MORE INFORMATION? Athens is here to support the community with this new program and will provide resources and training to help you get started. 





The charter amendments, if approved by the majority of voters, will enable the city to update outdated codes and language, adapt to changes, eliminate limits and community.

According to city officials, measures also do not increase utility rates; in fact, Measure R maintains a 4 percent reduction in the utility transfer approved by voters in 2020 they said. For financial transparency and public accountability, it will require updating the Pasadena accounting method to align with Generally Accepted Accounting Principles (GAAP). The proposed update to the method accounting lead to improved financial management and the ability to allocate resources to essential

The Measure S amendment will require the City Council to set limits by ordinance for contracts, purchases, and claim approvals. It will maintain oversight, improve city response, and enhance efficiency in executing contracts. Measure S streamlines the procurement process and eliminates a burdensome process for a burdensome contractor/business owner and the city, allowing for more ensure that resources are used efficient handling of contracts effectively, ultimately saving to save time and money. The money and benefitting the amendments will help identify inefficiencies, unnecessary expenses, and potential waste, these measures are not a new tax ensuring that public funds are and do not increase taxes. The used wisely and projects are

executed within budget. Measure T is an amendment to the Charter that will allow the city to create alternative contract selection methods that can be more efficient, transparent, and accountable for bidding and delivering public improvements. The amendment will attract a broader range of vendors and contractors, fostering increased competition, leading to betterquality services and innovative solutions, and ensuring the best value for its investments.

Under Measure T, the alternative project delivery method is designed to expedite the project, resulting in significant time savings. It allows the city to adapt to industry best practices that lead to practical and modern approaches to project management and contract selection while complying with rules and regulations. Additionally, allowing for additional contract selection methods, particularly those that improve the chances of hiring local businesses, contributing to the community's economic development, creating job opportunities, and stimulating our local economy.

Measures R, S, and T maintain accountability provisions, such as public disclosure of all spending and annual financial audits, while updating outdated language and codes.

In 1886, Pasadena was officially incorporated. By 1901, Pasadena had evolved into a Charter City with an elected Mayor through a vote of the people. In the following years, the City saw significant improvements with the installation of amenities such as sewers, paved streets, and electric street lighting. Over the decades, amendments to the Charter helped modernize and improve city governance as times changed and advancements were made.

Assemblymember Holden's 2023-24 Legislative Package

Assemblymember Chris Holden finalizes his 2023-24 legislative package Friday and enters his last term in the California State Assembly with measures to address health care, education, public safety and the environment.

"My goal is always to serve my community above all else," said Assemblymember Chris Holden.

The 41st Assembly District stretches from Pasadena in the West to Upland in the East and includes the communities of Altadena, Monrovia, Claremont, San Dimas, La Verne, La Cañada Flintridge, Sierra Madre, San Pasqual, Bradbury, Rancho Cucamonga, Phelan, Oak Hills, Piñon Hills, Wrightwood, San Antonio Heights, Hesperia, and Lytle

Holden was first elected to the California State Assembly in 2012, and was overwhelmingly re-elected in 2014, 2016, 2018, 2020 and 2022. With more than 150 pieces of legislation signed into law, Holden brings to the Legislature a lifetime of experience in public service and business garnered during his many years on the Pasadena City Council and in the State Legislature. Holden served as Assembly Majority Floor Leader from 2014 to 2016, Chair of the California Legislative Black Caucus from 2016 to 2018, Chair of the Assembly Committee on Utilities and Energy from 2018 to 2022 and Chair of the Assembly Appropriations Committee from 2022

"After being in the State Assembly for almost twelve years, I believe these bills exemplify my due diligence in achieving that goal, by creating solutions to solve key issues, developing roadmaps for new innovations and improved functionality, and generating a pathway for equal opportunity," said Holden. 2023-2024 Legislative Package:

AB 236 would require health care service plans to annually verify and delete inaccurate listings from its provider directories, known as "ghost directories."

AB 252 would establish the College Athlete Protection (CAP) Act for purposes of providing various rights, benefits, and

protections to college athletes. AB 280 would prohibit holding an individual in segregated confinement for more than 15 consecutive days.

AB 359 would amend existing law around College and Career Access Pathway Program (CCAP) partnerships to align with best practices from other dual enrollment programs and would streamline access to dual enrollment for K-12 students throughout the state.

AB 610 would exempt additional restaurants from the definition of "fast food restaurant," including such restaurants in airports, hotels, event centers, theme parks, museums, and certain other locations, as prescribed.

AB 1017 would create the Striking Worker Emergency Homelessness Prevention (SWEHP) program to prevent workers suffering strike-related hardship by making zerointerest loans available to eligible striking workers to assist them in paying their housing costs. AB 1826 would revise the Digital Infrastructure and Video

Competition Act of 2006 to authorize the commission to exercise the authority, jurisdiction, and powers authorized by a franchise authority.

AB 1851 would require the Superintendent of Public Instruction to contract with a nonprofit technical assistance organization to sample all potable water system outlets for high-need schools.

AB 2089 would require a city or county, when collecting demographic data as to the ancestry or ethnic origin of persons, to include the additional collection categories and tabulations for specified Black or African American groups. AB 2193 would create a civil liability for a public or private institution of higher education by a person harmed by hazing. AB 2330 would help expedite permits for fuel management activities to ensure public safety is in alignment with environmental law.

On February 19 and 20 from 8:00 a.m. to 2:00 p.m., the Los Angeles County Fire Department (LACoFD) Forestry Division will be performing a pile burn in Spinks Canyon. A pile burn is a type of prescribed fire where firefighters pile and burn forest debris to reduce an area's wildfire risk. Spinks Canyon is located in the Bradbury foothills, east of Monrovia. As such, smoke may be visible this Monday and Tuesday, but at no harm to you.

Did you know:

- Prescribed fires are an efficient, safe, and cost-effective way to reduce fuels (e.g. dry, fallen leaves that further "fuel" a wildfire) contributing to wildfire risk.
- Piles are only ignited on "burn days" established by the local air pollution control district and under specific conditions.
- Proper fire tools, water, and personnel are always on site during a prescribed fire.
- Bare mineral soil is cleared with a 10-foot minimum radius from each pile before burning.

STORM-RELATED TAX RELIEF **AVAILABLE FOR PROPERTY OWNERS** FILING A MISFORTUNE & CALAMITY CLAIM JUMPSTARTS THE PROCESS

LOS ANGELES, CA - Los Angeles County Assessor Jeff Prang is reminding property owners that property tax relief is available for those suffering damage from the recent torrent of storms.

For property owners who have experienced damage or destruction from these storms, they can apply to have the assessed value of their property – the value upon which their property taxes are based - reduced to reflect the damage. This property tax relief program is called the Misfortune & Calamity (M&C) program.

"It's understandable that those affected by these storms would not be thinking about their property taxes at this difficult time," Assessor Prang said. "However, I did want to remind them there is property tax relief available in the event of damage to their property resulting from these types of natural disasters."

By filing a claim for M&C relief within one year of the incident, properties that have sustained a minimum of \$10,000 in damage of current market value may be eligible for a refund of taxes already paid as well as lower annual tax bills until the property is repaired or rebuilt. Assessor Prang's office is working proactively to identify the properties affected and move the process forward.

This property tax relief is available to owners of homes, business equipment and fixtures, orchards or other agricultural groves, and to owners of aircraft, boats, and certain manufactured homes. It is not available to property that is not assessable, such as state licensed manufactured homes or household furnishings.

If granted, the assessed value of the property will be reduced, effective the date the damage occurred, until the damaged structures are rebuilt or repaired, the property undergoes a change in ownership, or a base year value transfer is recorded.

"My dedicated team is ready to offer assistance at a moment's notice," Assessor Prang said. "We will be available to guide property owners through the claim process." These types of reassessments have led to millions of dollars in property tax relief during significant events including the massive Woolsey Fire a few years back as well as victims of the Rolling Hills Estates landslides where homes were red-tagged as uninhabitable when the ground collapsed underneath their foundations, reducing homes to rubble.

The M&C claim forms - known as the Application for Reassessment: Property Damaged or Destroyed by Misfortune or Calamity - can be obtained online at https://assessor.lacounty.gov/tax-relief/disaster-relief or by phone at (213) 974-8658.

- •Cook pasta according to package directions. Meanwhile, crumble beef and sausage into a large skillet; add onion. Cook and stir over medium heat until meat is no longer pink. Add garlic; cook 1 minute longer. Drain. Stir in the tomatoes, tomato paste and seasonings. Bring to a boil. Reduce heat; simmer, uncovered, for 5 minutes.
- Drain pasta; stir in meat mixture and pepperoni. Transfer half of the pasta mixture to a 2-qt. baking dish coated with cooking spray. Sprinkle with half of the cheese; repeat layers.
- Cover and bake at 350° for 20-25 minutes or until bubbly.

I'm Gustavo Lira, Tasting Room Manager and Wine Buyer at The Bottle Shop in Sierra Madre with another wine and spirits selection. Do you like red wine blends? You're not alone.

The 2023 Silicon Valley Bank State of the U.S. Wine Industry report stated that Red blends are the second most popular red wine type consumed in the U.S. after Cabernet Sauvignon. What's the difference between a Red Blend and a single varietal wine such as Cabernet Sauvignon? To be labelled a single varietal wine in the United States, the wine must contain at least 75% of a specific varietal. If a winemaker decides to have 75% Cabernet Sauvignon and 25% Merlot in the wine, the wine can be labelled as Cabernet Sauvignon. Anything less than 75% of a single varietal, and the wine is considered a blend.



Some of the world's most classic wines are red blends – Bordeaux and Rhone Valley are prime examples. Here in the U.S., The Prisoner Red Wine is one of the most popular Red Blends sold. In 2000 when it first started production it was a very good wine. Now, with production at 250,000 cases, it's too sweet for my taste and seems to follow a formulaic recipe with the other wines they produce. For \$50 a bottle I expect more from wine. Here's a much better Red Blend alternative - Maldonado Proprietary Red Wine Napa Valley 2018.

Hugo Maldonado is the winemaker and owner. Hugo holds a degree in Enology & Viticulture from U.C. Davis. His father Lupe came to the U.S. in 1962 and became an exceptional vineyard manager. Hugo and his father founded the winery in 2007. Total production for Madonado is 6,000 cases – making this a wine that is family run and small production – attributes that tend to lead to excellent wines.

The wine is a blend of 70% Cabernet Sauvignon, 20% Merlot and 10% Syrah and was aged for 20 months in French oak barrels. It is bold with gorgeous fruit that is balanced and not over ripe. There are layers of spice, chocolate, leather, and dark fruit. The tannins are well integrated and there's enough acidity to lift the wine to a lengthy and

The Bottle Shop has the Maldonado Red Blend Napa Valley 2018 at an extraordinary price of \$29.99. Don't pay \$20 more for a mediocre wine, get this one instead. I know vou'll love it!



ENCOURAGING YOU TO VOTE

Years ago, I was very active in the neighborhood during election times, encouraging people to vote. My wife and I, and members of the non-profit we worked with, organized a few "voter discussion" meetings. We began

by making a flier for such an event, and then we walked to every house in our immediate neighborhood to give them the flier. This also gave us the opportunity to talk with neighbors as well. Our neighborhood already had some sense of organization because we conducted periodic Neighborhood Watch meetings, and several of the neighbors had expressed an interest in a voter discussion.

We told everyone to read the voter information booklet that they received in the mail before the meeting. As some of you might know, those booklets have the pros and cons for each proposition, and a little about each candidate for the various offices.

When the evening came, we all gathered in the living room of one of the neighbors with information booklet, and most had not. I guess I was not surprised. They came to the meeting because they didn't want to take the time to read all the details of that booklet. I had actually read most of the booklet, and, as the conductor of the meeting, I made it clear that we were in no way going to try to influence anyone's vote. We began with the president, and we didn't spend much time there because most people had already made up their mind regarding that office. I only shared a few obvious points and then we moved onto other offices.

My goal was just to help our neighbors be informed, and the propositions and the local judges and local offices generally has a far greater effect on each of our lives than does the president. Yet, everyone focuses on the president and not the more down-to-earth issues and people.

When I had read the booklet before our meeting, I took the time to mark key points on each of the propositions, things that I felt were the essence of each proposition. What actually results would occur if that proposition passed? How much would it cost? Who would pay for it? Were there other laws or agencies that were already in existence that could be doing the same work? These are the ways we tried to pick apart each proposition. It wasn't easy and we didn't all agree. But each of us had a better idea of what the proposition was all about than when we started.

And then there is the issue about the cost of administration of some of the propositions, and whether or not it would have any chance of fixing the problem if it passed.

Our voting meetings were always very civil, and we had many of them. A few were conducted by our non-profit in the local library, where members of the community joined in. We always emphasized that we were not there to argue, but to try and shed light on all the diverse issues that we had to vote upon.

Voting is a sacred right to be taken seriously, and I really hope that each of you can find the time to do something similar with your friends, family, and neighbors.

One year, after the election, a neighbor (who did not attend the meetings), said to me, "Well, are you happy with who you elected into office?" He then went on to tell me the bad things about a few new elected officials. I told him that I did not yote for those people, but I did vote. This neighbor told me that he rarely votes because "nothing changes." I was about to read him the riot act, but I was tired that night, and merely explained that you don't always get what you want, but if you don't even take the time to vote, you have forfeited your right to complain. I told him that many Americans were like him, and that I felt the average turnout in the U.S. for elections is pathetic. Those who chose not to vote

could have completely altered the outcome. I also mentioned how many countries do not have the right to vote. In some cases, when they finally got that right, nearly 90% of the eligible voters took the time to vote for their leaders. I told my neighbor that he should not take his right to vote for granted.

To read a little more about the sacred aspect of the vote, read "Democracy is Self-Government" by H.W. Percival. Then, if you want to be shocked into voting, read "On Tyranny" by Timothy Snyder.







At the push of a button, an electric toothbrush will do everything but shake, rattle and roll to do the cleaning for you, and most come with a wide, slightly weighted handle and rubberized grip that make them easier and more comfortable to hold on to.

How to Choose

With dozens of different electric toothbrushes on the market today, here are several points to consider to help you choose:

Cost: The cost of electric toothbrushes will range from \$10 for a model with replaceable AA batteries to more than \$200 for some models with rechargeable lithium-ion batteries, multiple brushing modes, smartphone integrations, and other features. How much are you willing to spend?

Brushing action: Brush heads tend to be either "spinning" (they rotate very fast in one direction, then the other, and bristles may pulsate in and out) or "sonic" (they vibrate side to side). Both methods are effective and a matter of personal preference.

Electric versus battery: Choose a brush with a built-in rechargeable battery and an electric charging station. They're much more convenient and cost effective than toothbrushes that use replaceable

Brushing timer: Since most dentists recommend brushing for two minutes (most adults average about 45 seconds), get an electric toothbrush with a built-in brushing timer - most have them. Some brushes will even split the two minutes onto four 30-second intervals and will notify you when it's time to switch to a different quadrant of your mouth.

Extra features: Most higher-priced electric brushes come with extra features like cleaning modes, pressure sensors, a charge-level display and more. There are even "smart" toothbrushes that connect to a smartphone or tablet via Bluetooth to track brushing habits. What extra features do you want?

Best Electric Toothbrushes

According to Consumer Reports - an independent, nonprofit product testing and research organization – the top electric toothbrushes for 2024 are the Oral-BiO 7 Series (\$150); Oral B Genius X 10000 (\$200); Bruush Electric Toothbrushes (\$95); and the Philips Sonicare ProtectiveClean 6100 (\$120). And the top rated low-cost electric toothbrush is the Brightline 86700 (\$30).

The New York Times Wirecutter, another popular product reviewing service, rates the Oral-B Pro 1000 (\$40) as the best electric toothbrush followed by the Philips Sonicare 4100 (\$40).

Easier Flossing Tools

If flossing has become challenging too, a good alternative to traditional string floss are floss picks. These are disposable plastic-handle tools that have floss threaded onto them, which makes them easier to hold and use. DenTek, Oral-B and others sell packages for a few dollars or check out the Listerine UltraClean Access Flosser, which comes with a toothbrush-like handle for a better reach.

Some other flossing products to consider that are easy on the hands are the WaterPik Power Flosser (\$15), which gently vibrates to dislodge embedded food particles between your teeth. Or consider a water flosser, which use high-pressured pulsating water to remove food particles and plaque and will stimulate your gums in the process. WaterPik offers a variety of water flossing products at prices ranging between \$40 and \$140, as does Oral Breeze, which offers the Shower Breeze and Quick Breeze water flossers (around \$40) that connects directly to your faucet or shower head.

All of these dental care products can also be found at your local pharmacy or retailer that sells

personal care items or online.





Eisenhower was considered old at the time of his re-election – he was only 65 and had just suffered a heart attack. The point was that as Americans we could trust the political parties to only nominate individuals who could handle the job and would be surrounded by a staff of able people.

We could trust then; we believed the news that was broadcast to us. We weren't afraid of being lied to by all the networks and by everyone else. Yesterday, if the news can be believed, the Republican party refused to support the compromise proposal that would have met the need for immigration reform at the Southern Border together with supplying needed funds for military support to Ukraine and Israel.

Of course, now everything seems ridiculous. The whole Republican party seems like a very bad joke. The Republican platform is to get that 77-year-old man re-elected because he represents a return to the good old days of racism, anti-gay, anti-abortion, anti-books, anti-history, anti-women, and the return of white skin privilege. 

FRUITS AND VEGGIES: ARE YOU GETTING **ENOUGH?**

Sure we all know that fruits and vegetables are good for health but just how many of us actually consume an amount known to offer health benefits? The answer is....about 10%. That's right only 1 in 10 people actually eat enough fruits and vegetables to benefit from them.

If you're part of the 90% who don't eat enough, there are simple ways to improve. You don't have to go from zero to maximum consumption either. Swap something high calorie that you usually eat everyday for a smoothie. Make your own smoothie with whatever fruits and vegetables you like or have on hand. Even a protein powder drink can have a few fruits blended in

to boost nutrient content. Enhance your breakfasts. Cereal and oatmeal can easily be topped with fresh berries, banana or other fruits.

Sauteed vegetables can be mixed into hashbrowns/potatoes or scrambles. Who doesn't like avocado toast? Switch up snacks. Keep fruit out where you can see it, you're more likely to grab and able or banana if it's in plain sight. Cut up some of your favorite vegetables like carrots, red peppers, cucumbers, etc. and have them ready for a quick dip into hummus, salsa or other low calorie dip.

Dried fruit counts. Instead of snacking on nuts and chips, replace some of them with a handful of dried fruit, whichever kind you like.

Don't forget soup. Soup can fill you up quick. A pot of fresh vegetable or minestrone is jam packed with nutrients. Whatever your favorite soup is, toss in another vegetable or two.

Dessert counts too. A baked apple or pear with cinnamon can become a healthy dessert when you're craving something sweet. Grill or roast vegetables. A tasty side to any meal is the addition of roasted vegetables. All it takes is a tiny bit

of olive oil, a hot oven/grill and 20 minutes to bring out the flavor of a variety of tastes. If you have leftovers, toss them into plain pasta with a small amount of olive oil or in a salad if you prefer your vegetables cooked. Herbs and spices add a nice twist. Experiment with your favorite seasonings and see how much you can really

enjoy a variety of different vegetables, especially when they're fresh. Keep a few canned or frozen selections on hand for when you're running low on food or short on time. Frozen

vegetables are just as nutritious as fresh. Frozen fruit allow you to enjoy your favorite fruit even when it isn't in season. Save money, reduce food waste and save time by always having canned/frozen backups.

And why should you try? Plenty of reasons. First, these foods lower the risk of chronic diseases like heart disease, stroke, cancers and eye issues like macular degeneration. They also contain fiber which helps control blood sugar levels. Plus fiber aids in weight management because it contributes to a feeling of fullness and satiety. Fiber is great for the heart by helping lower blood pressure, reduce cholesterol and improve the heart's overall function. It also helps with digestive issues.

The antioxidants in fruits and vegetables neutralize the harmful free radicals in the body and slow down aging. High water content helps keep you hydrated. Being well hydrated is instrumental in regulating your temperature and transporting

nutrients. Fruits and vegetables are rich in various vitamins, minerals and antioxidants. Specifically vitamin C and zinc help keep the immune system strong and ready to defend against infections. The same vitamins and antioxidants also promote skin health, protect against sun damage and help you look as young as possible.

One easy way to tell if you're getting enough is to look at your plate at each meal. Is it filled with colorful foods? It should look more like a rainbow of colors instead of pale beige, brown and golden fried foods. If you're looking at the amount of food, aim for 50 percent of your plate containing fruits and vegetables. Variety is key here so be adventurous and try new foods or revisit old favorites.
